DESCRIPTION

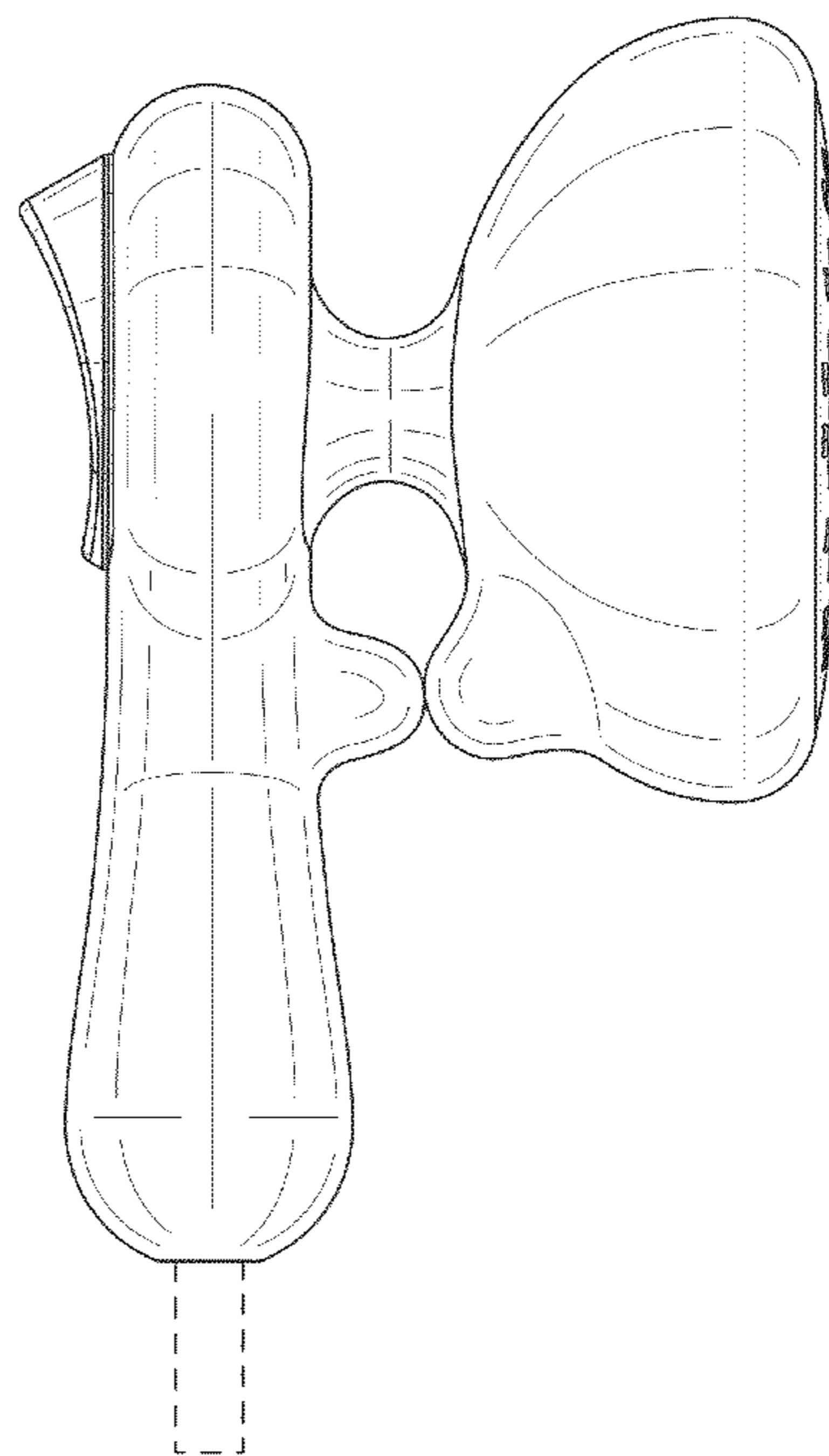
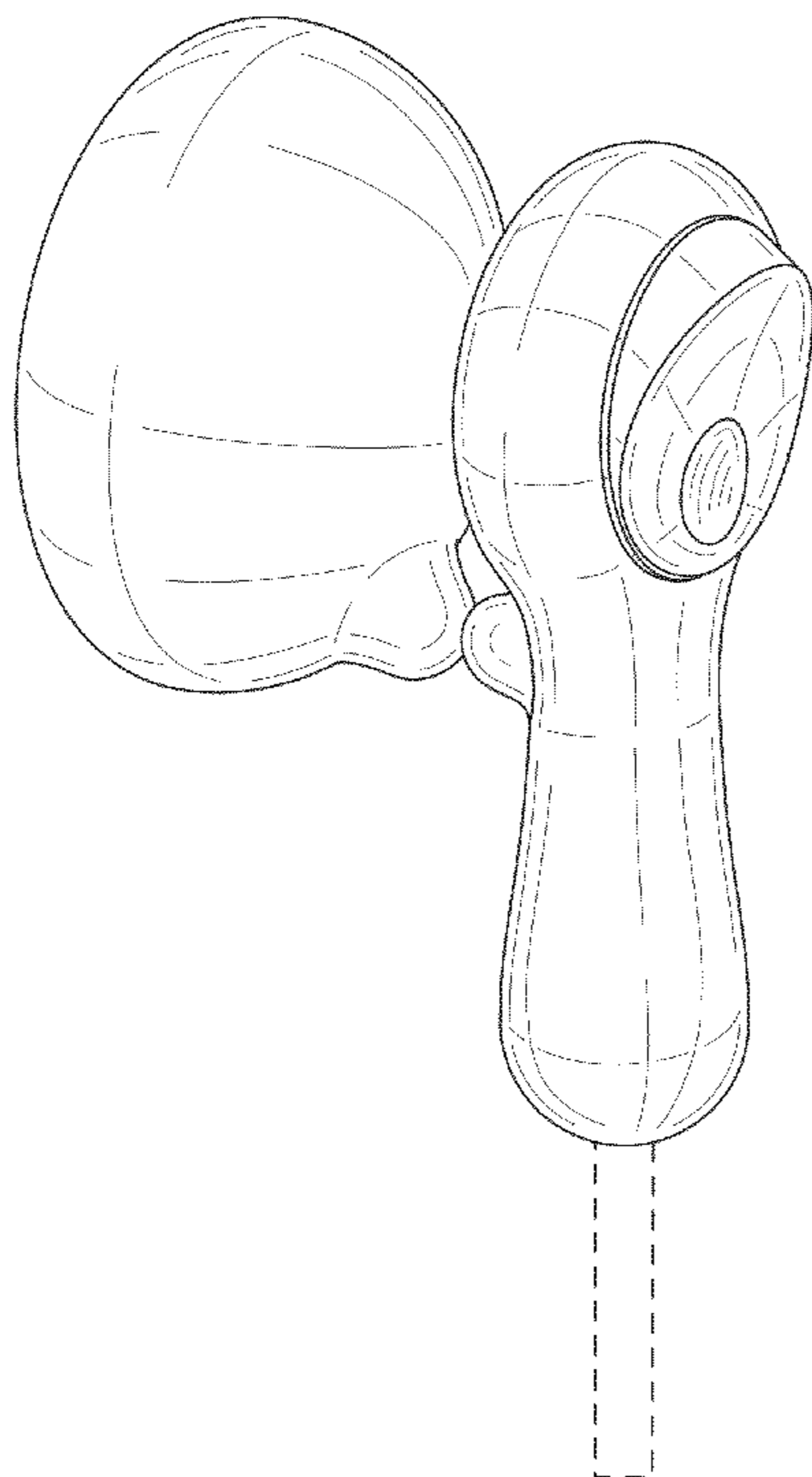

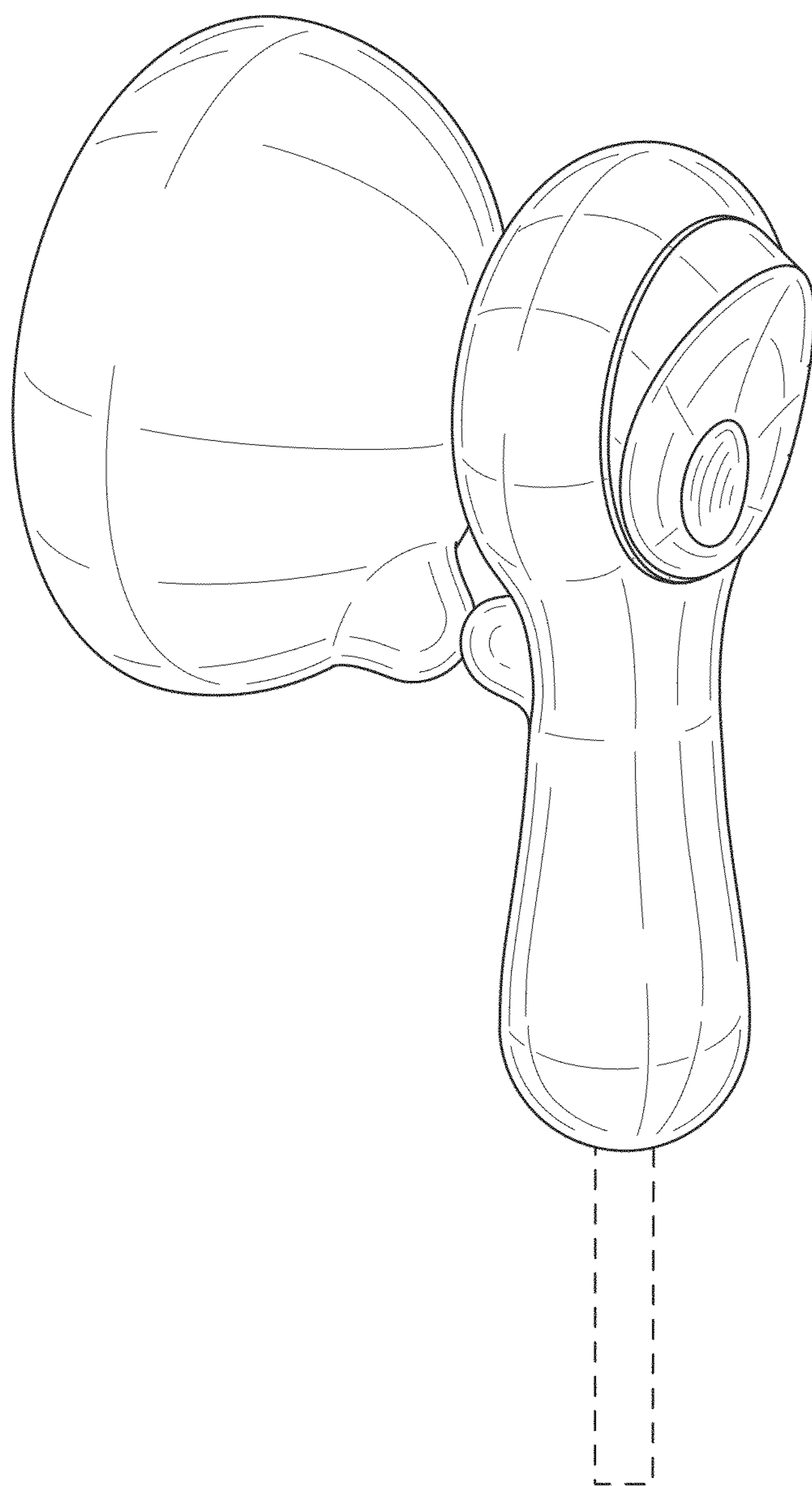

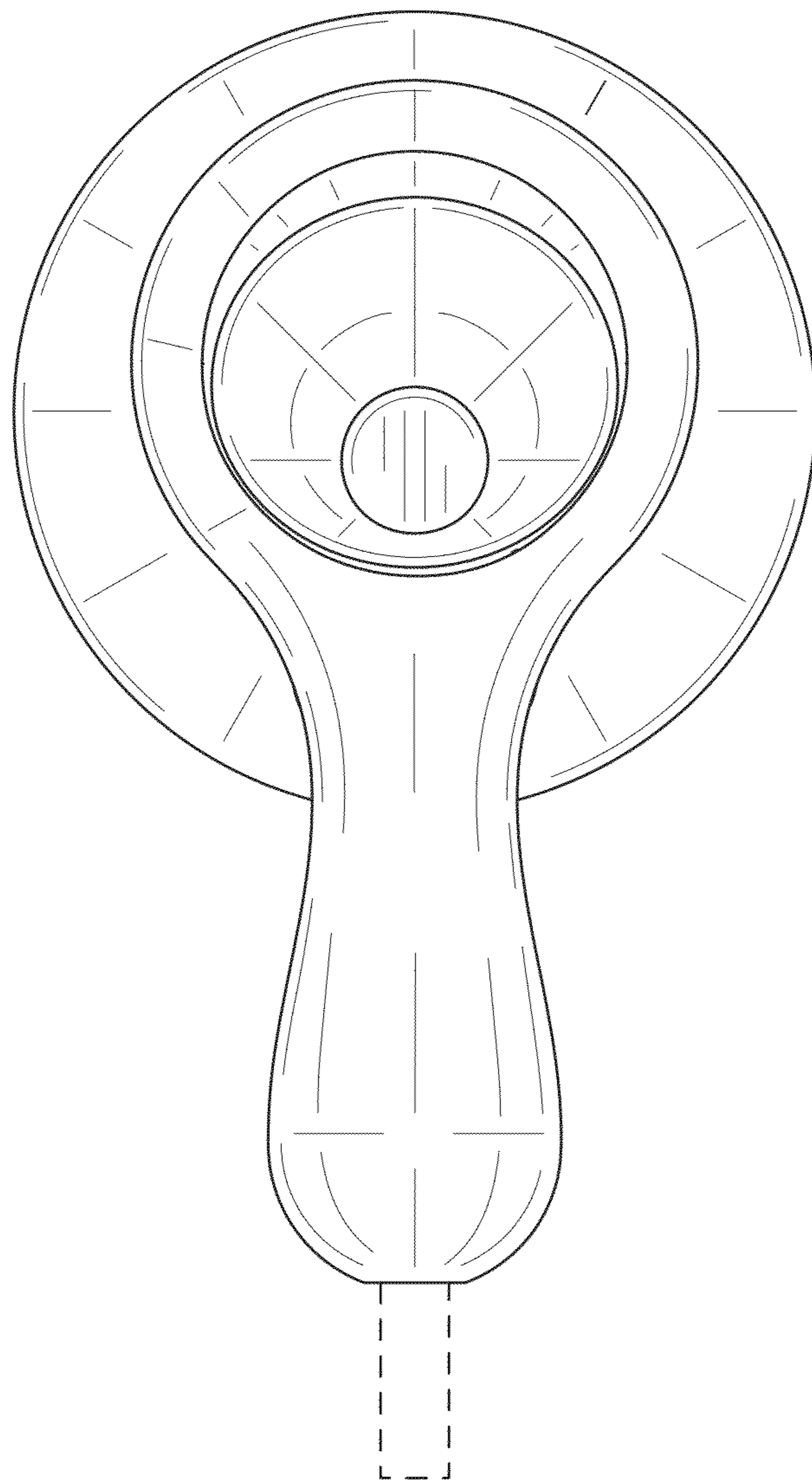

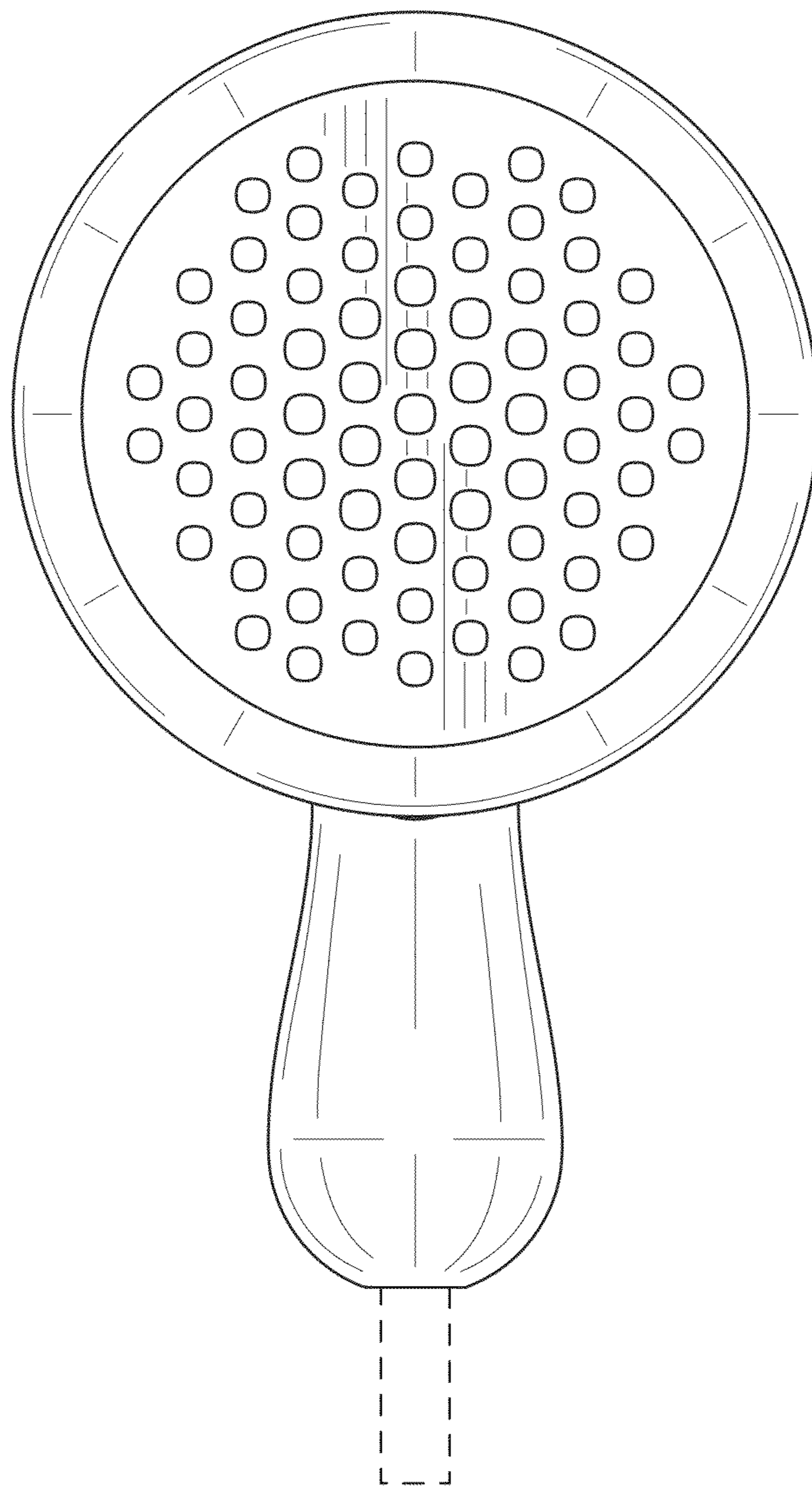

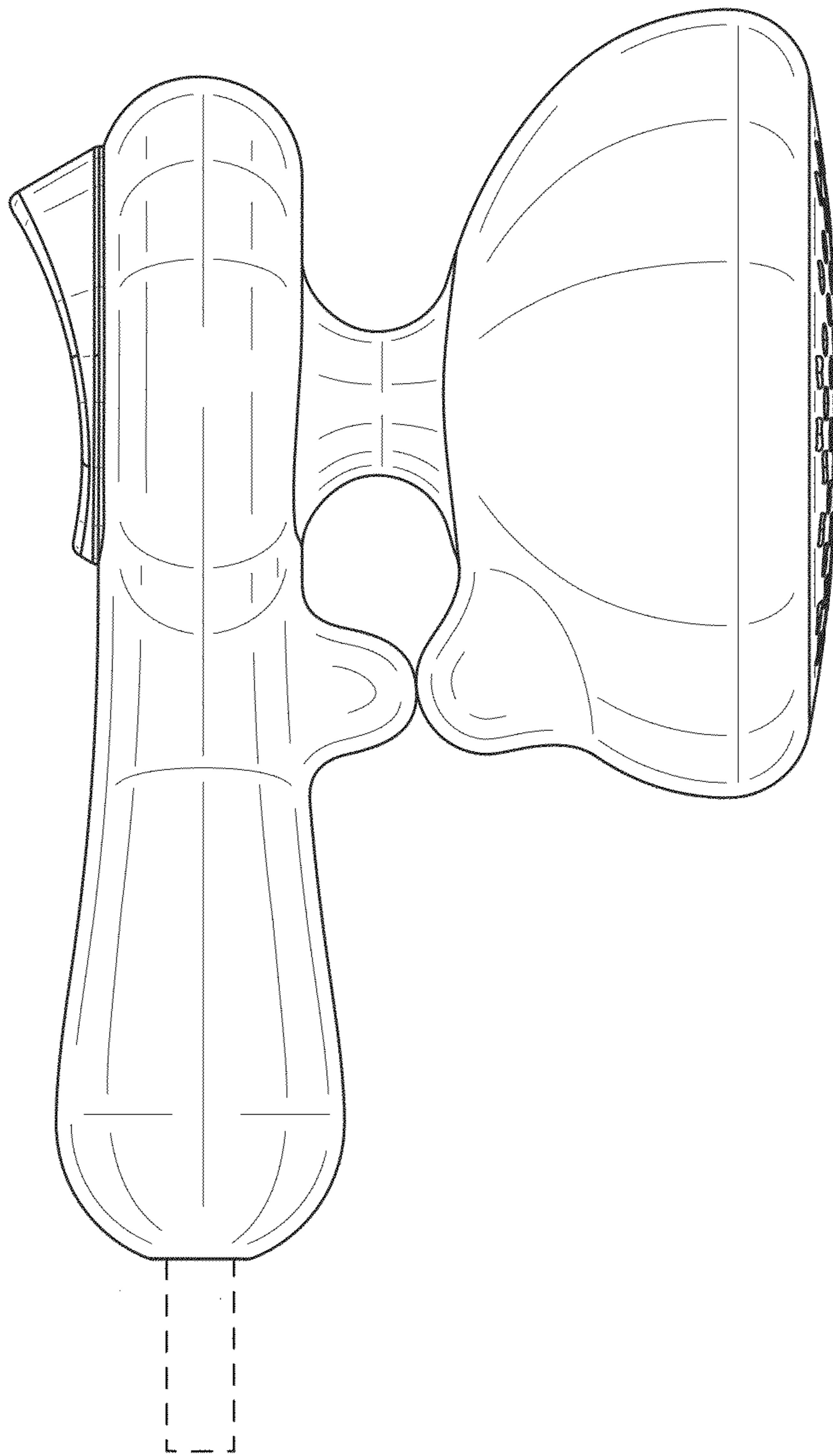

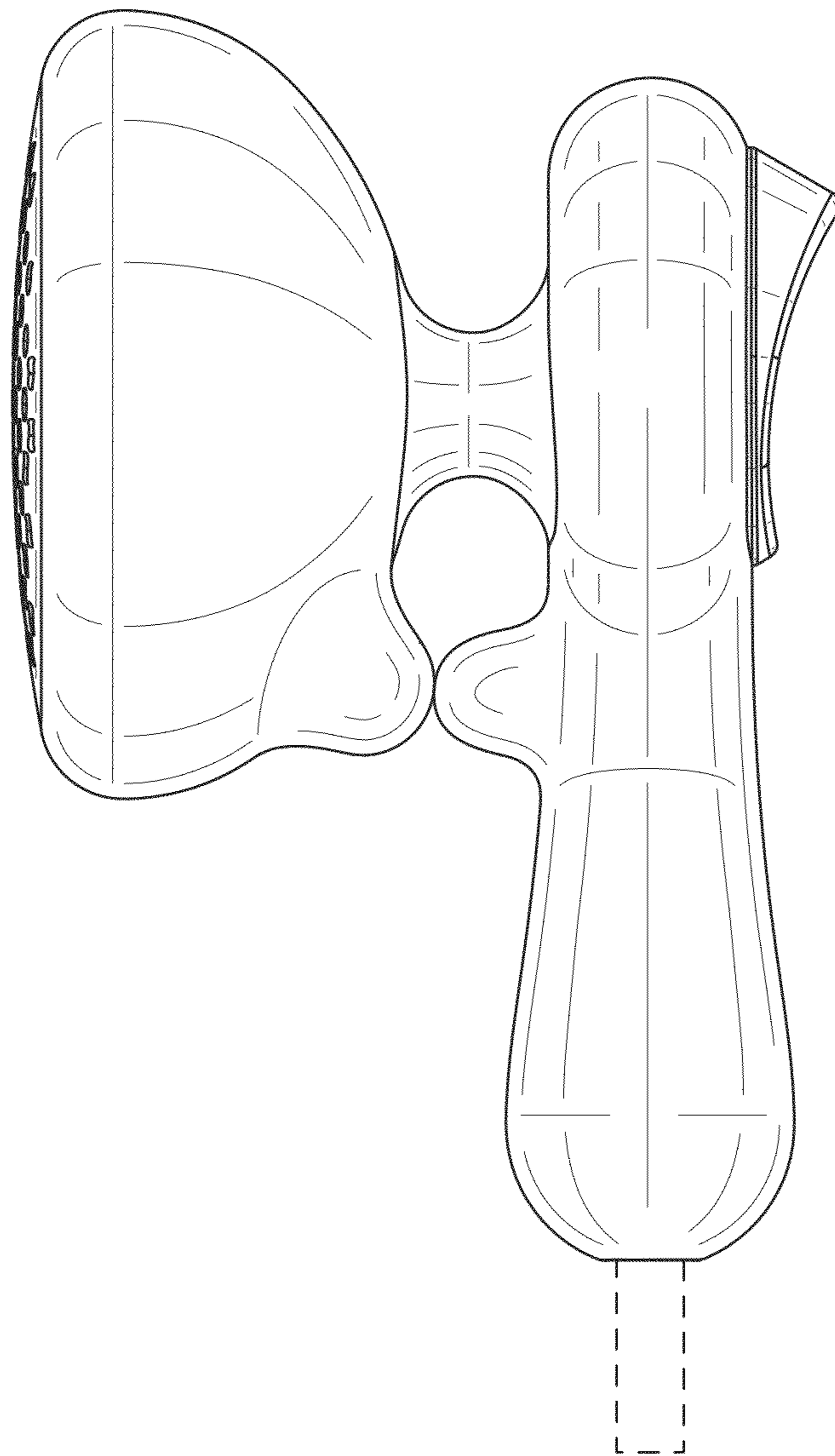

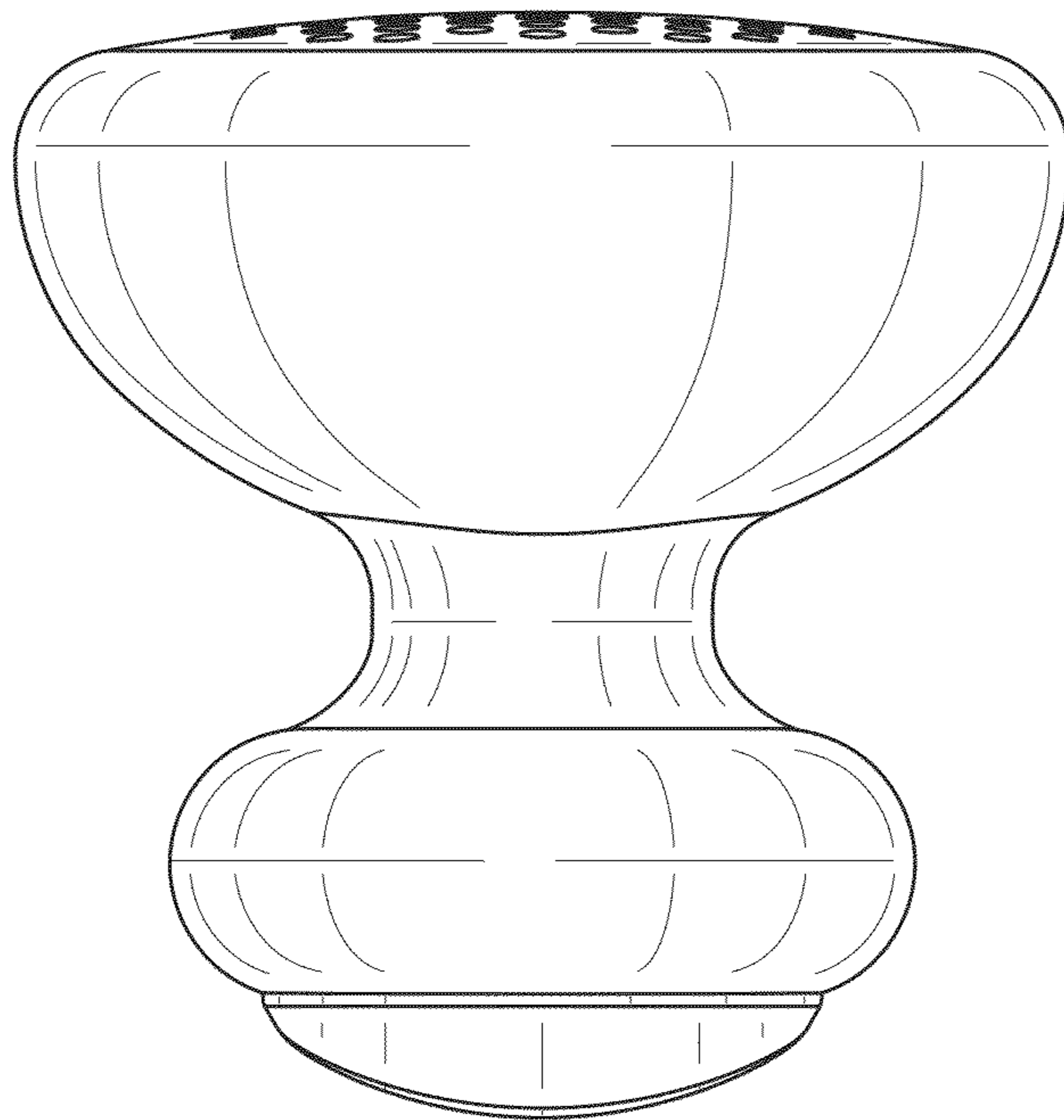
