DESCRIPTION

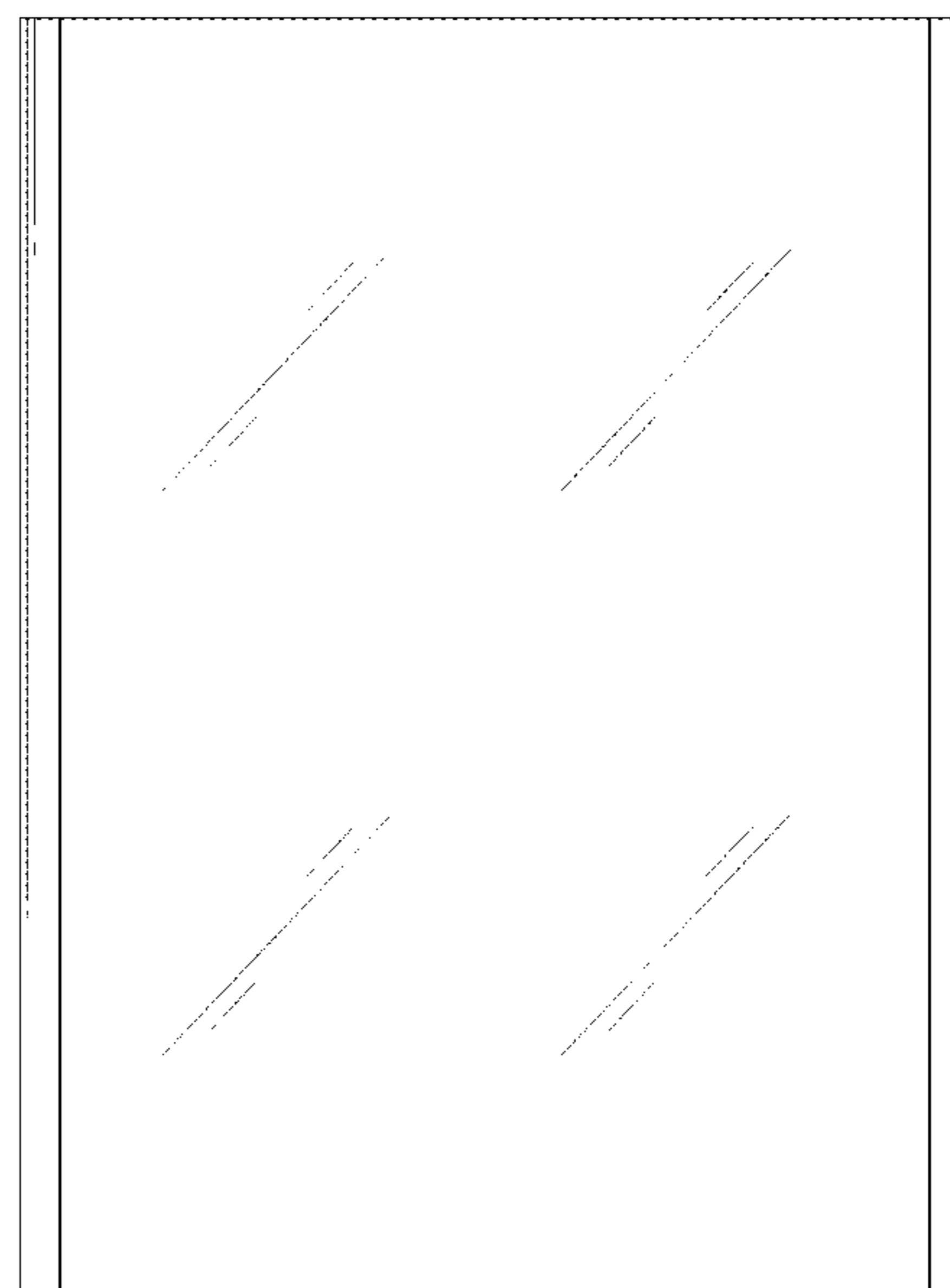
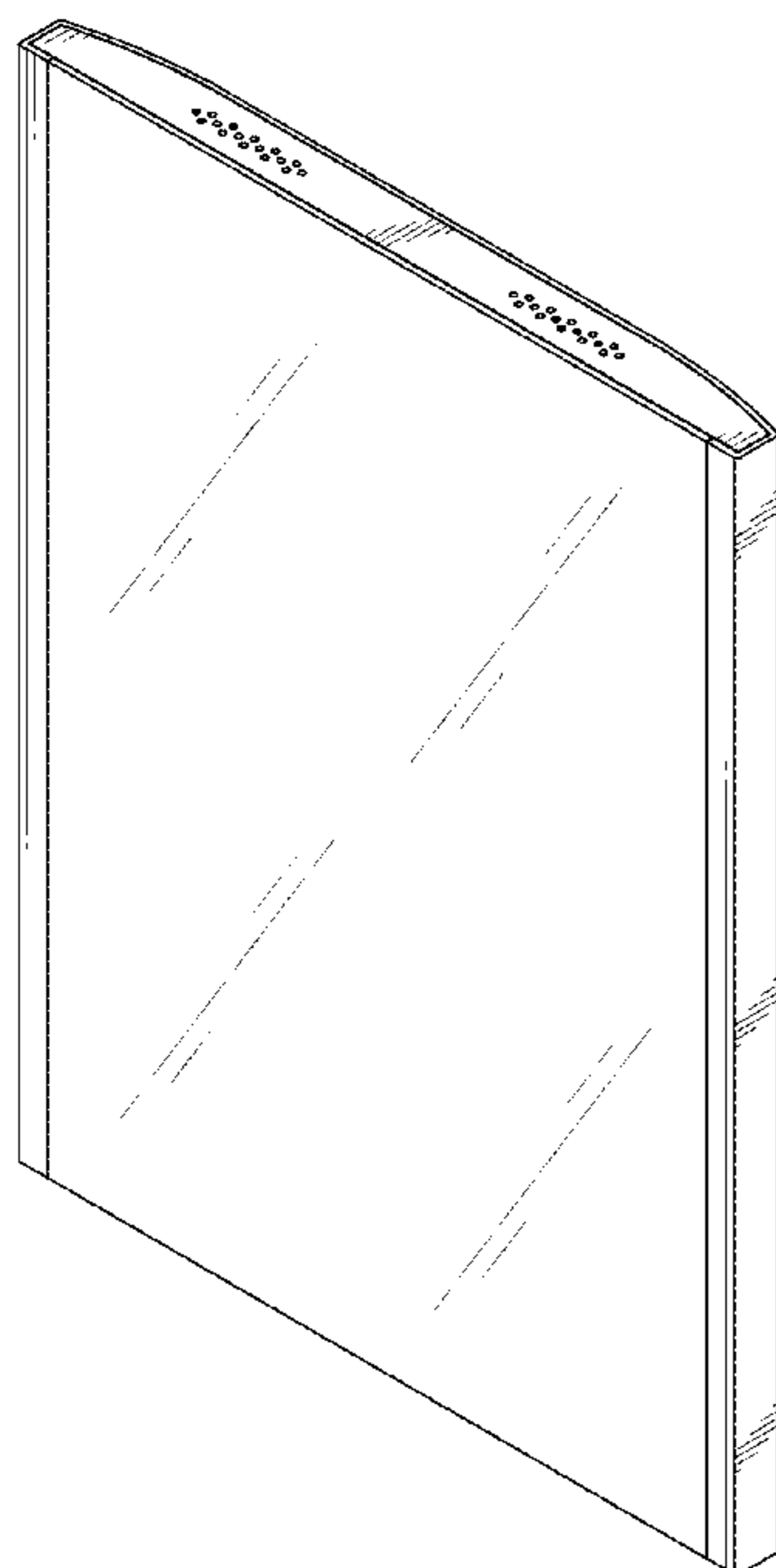
FIG. 1 is a perspective view of a tablet personal computer, showing our design.

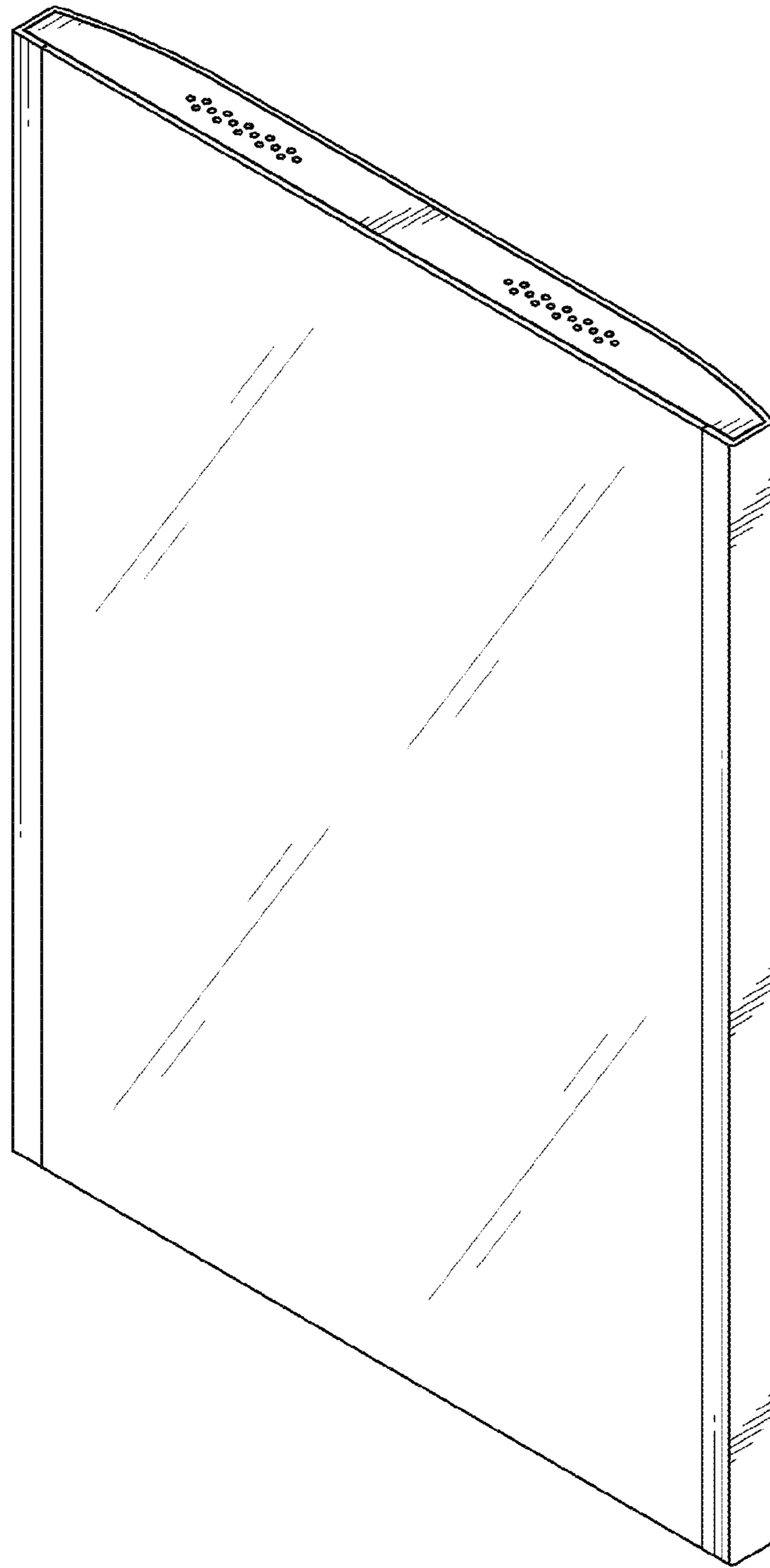

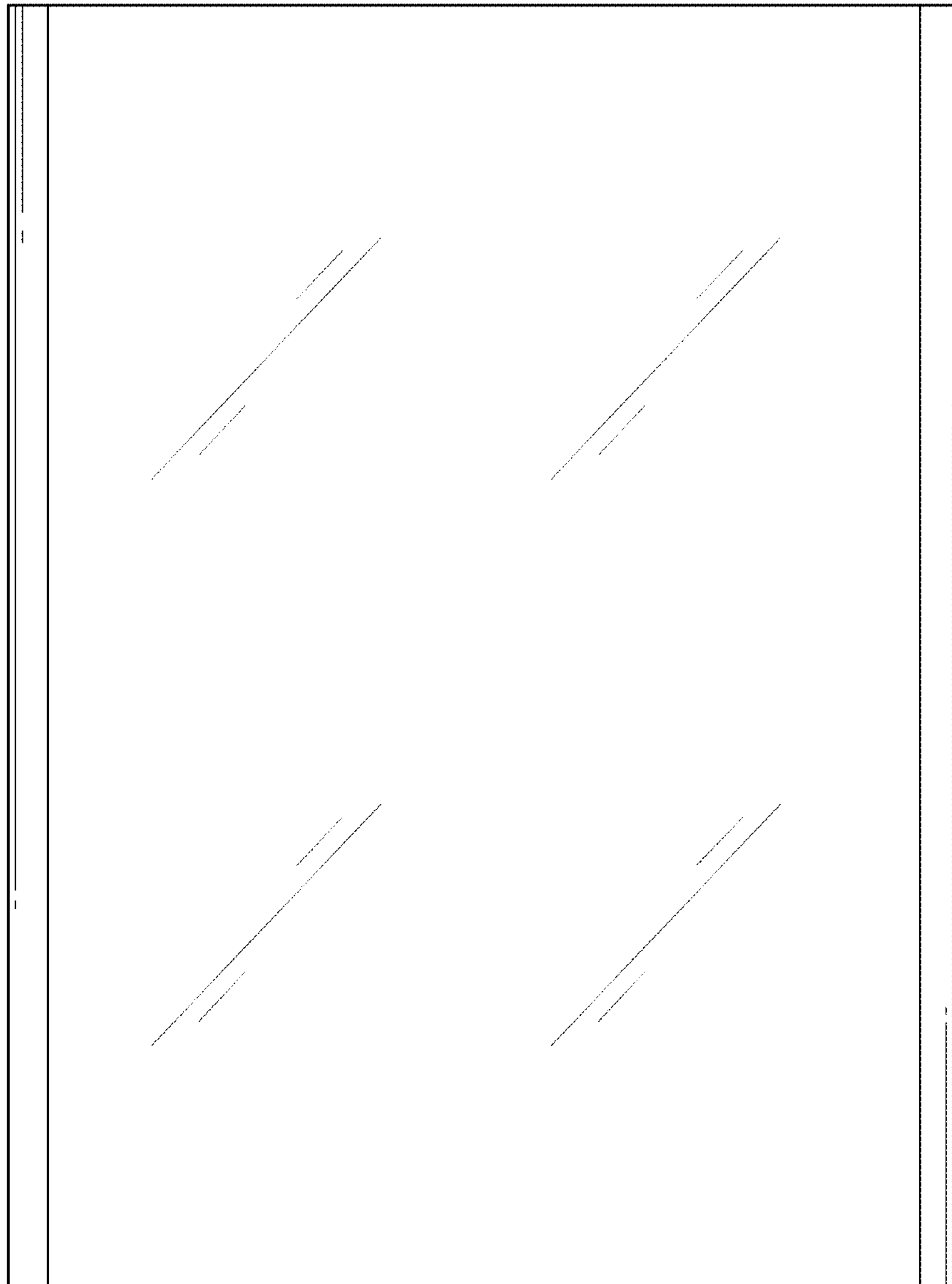

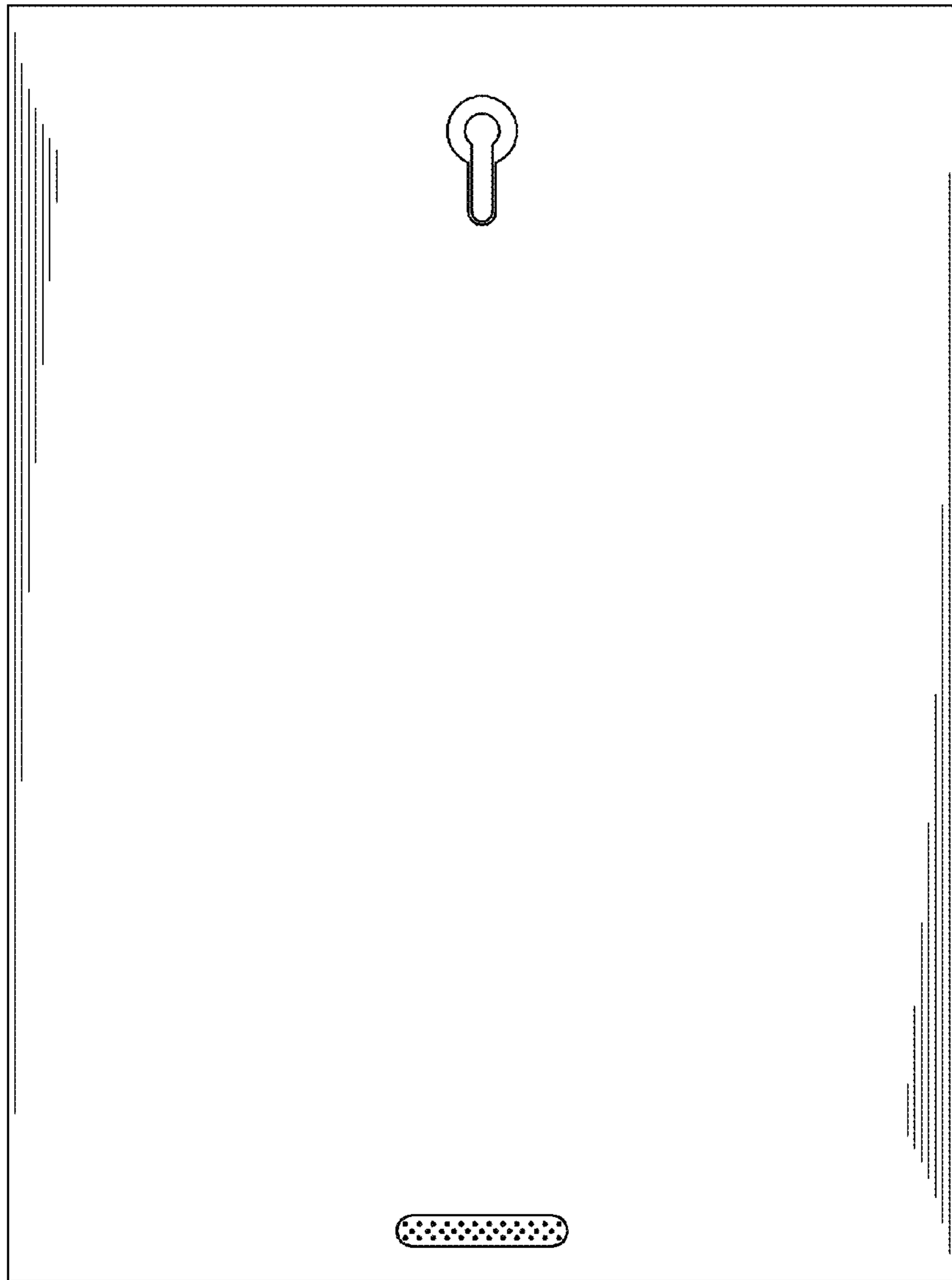

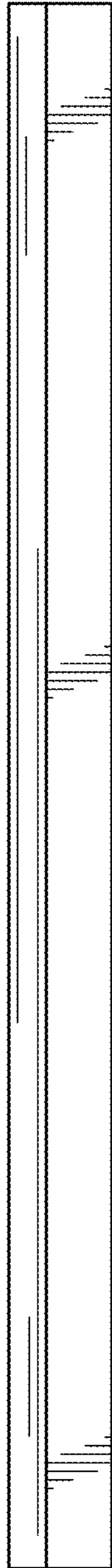

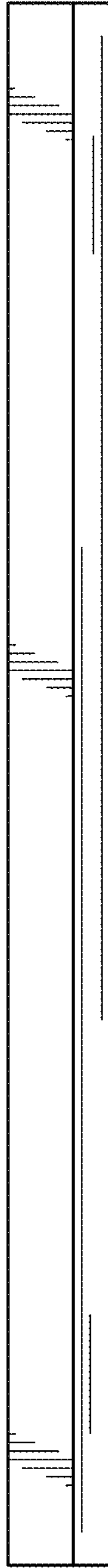

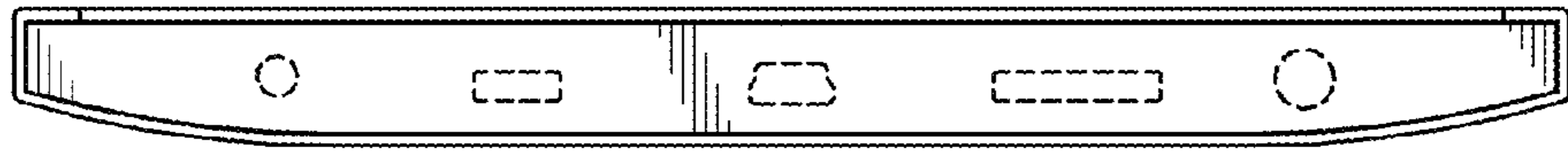
