The ornamental design for a display screen with animated graphical user interface, as shown and described.

FIG. 6 is the sixth image thereof;

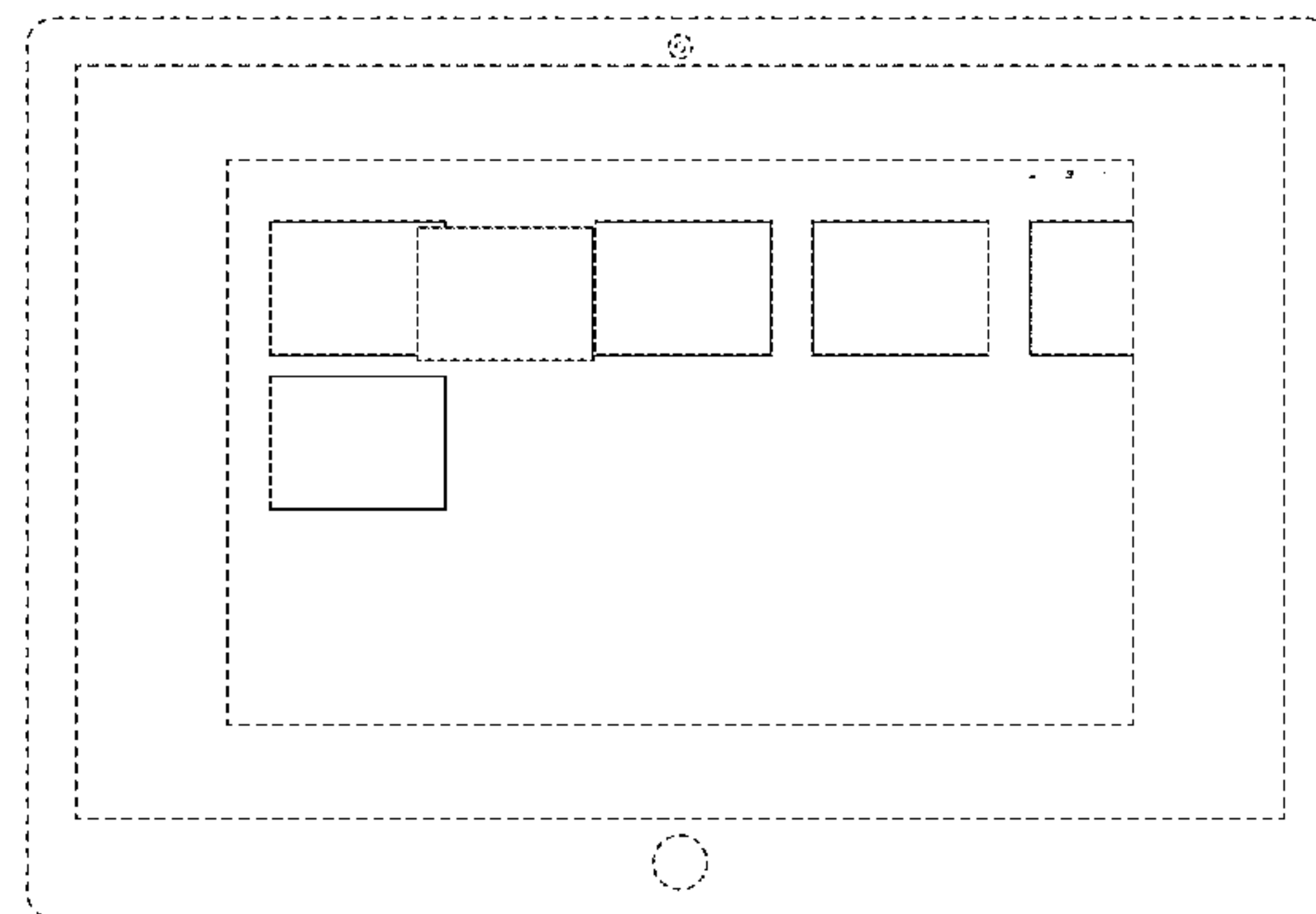
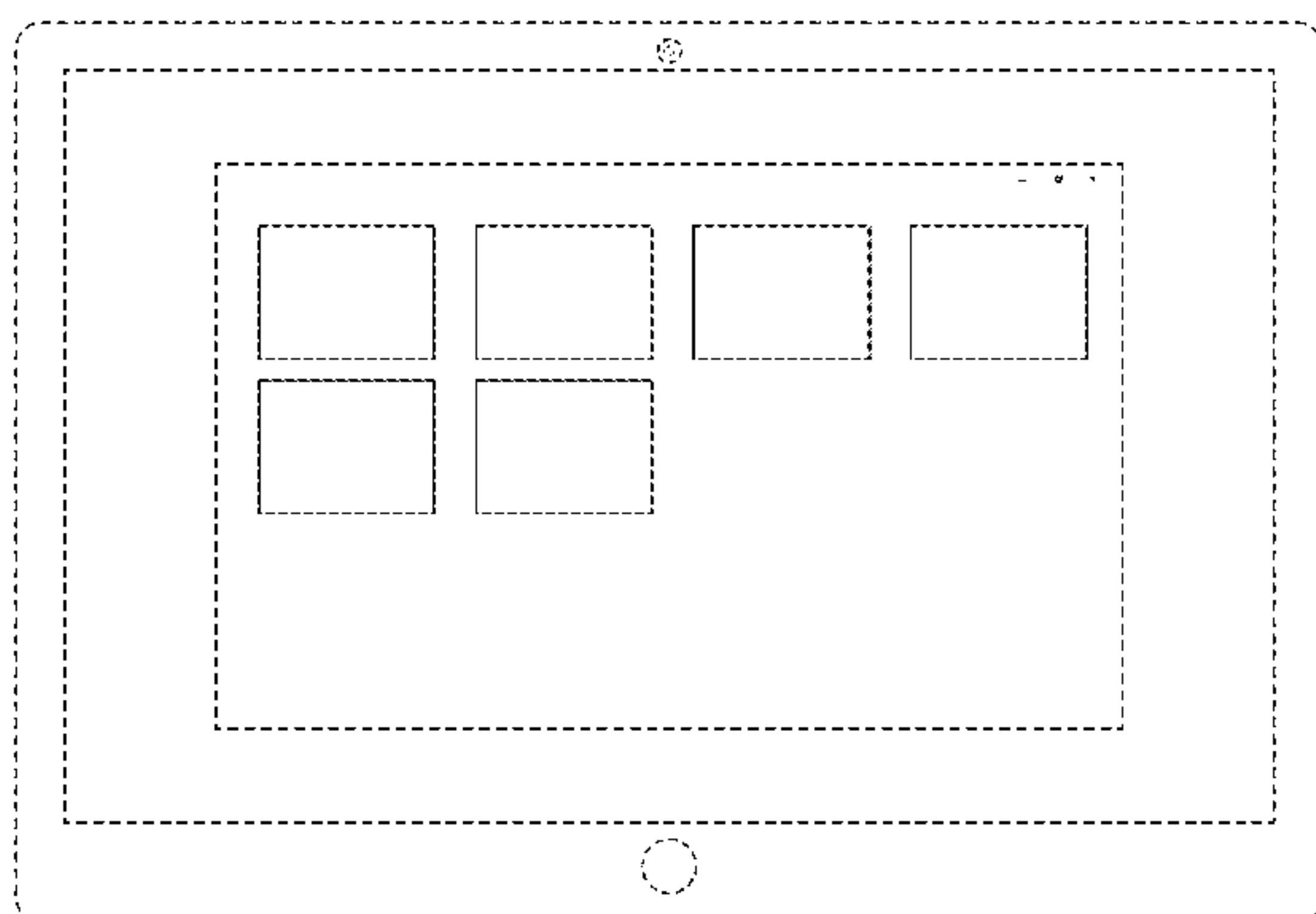
FIG. 7 is the seventh image thereof; and,

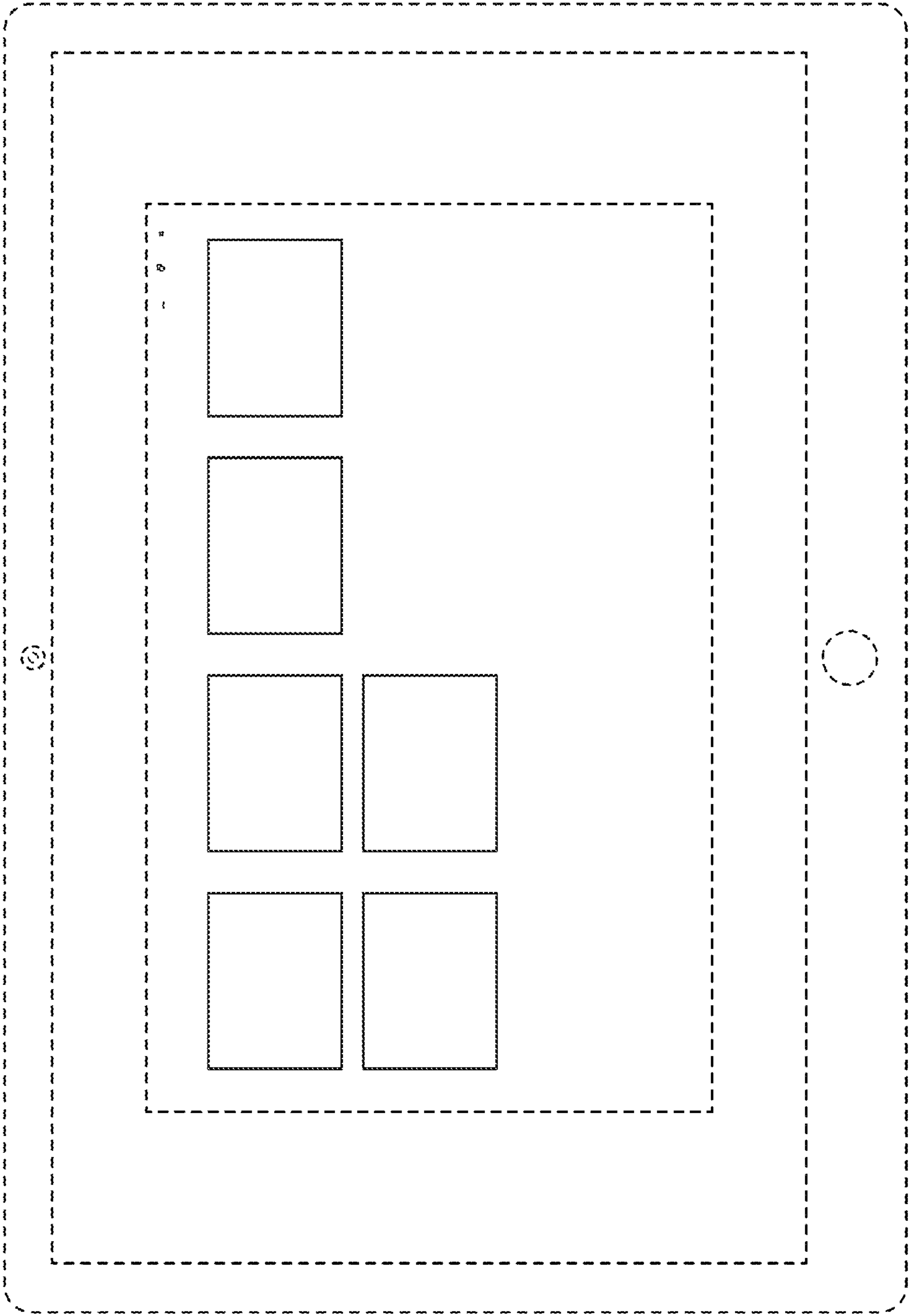
FIGS. 8-14 show the sequence from FIGS. 1-7 with additional disclaimed environment.

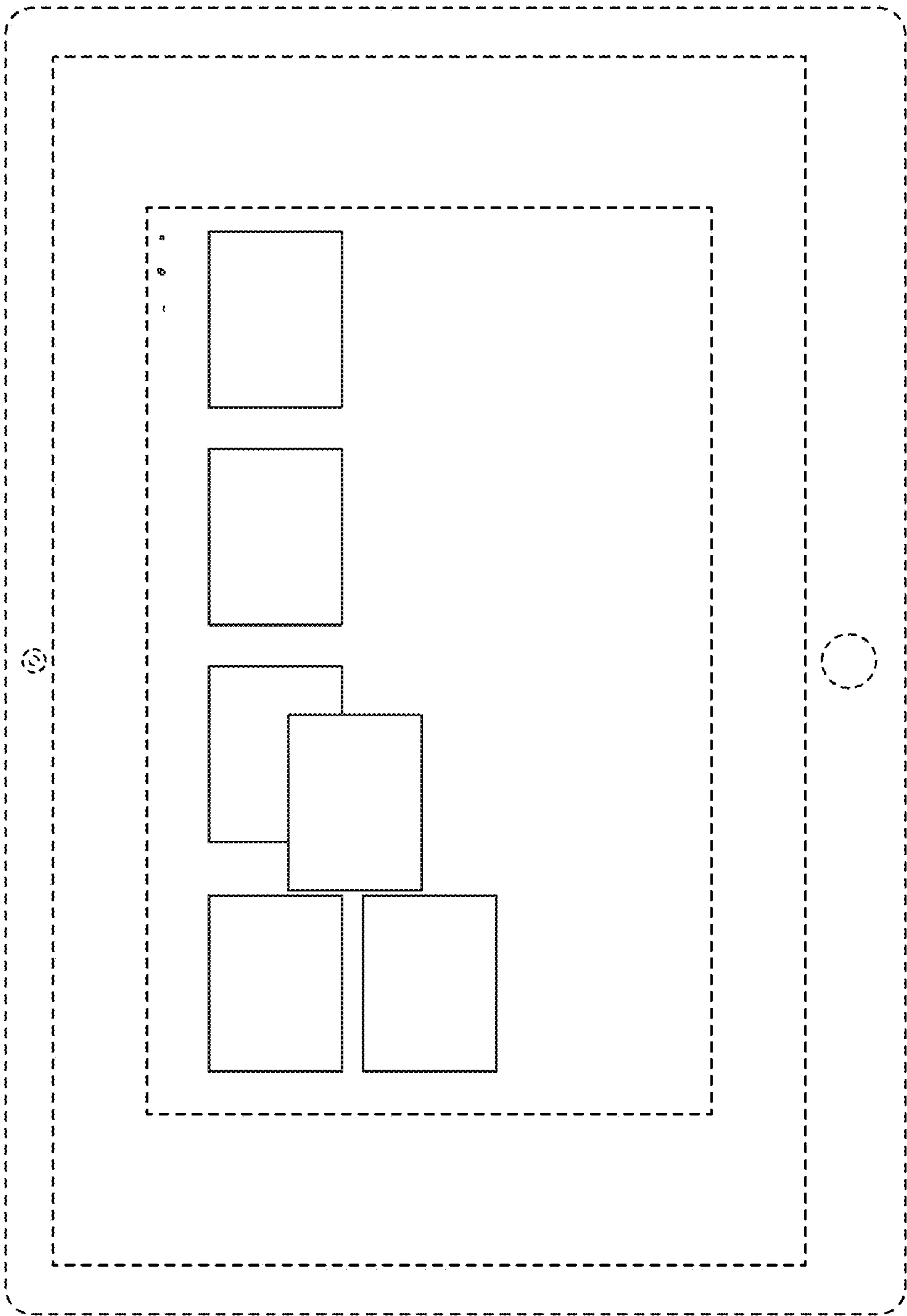
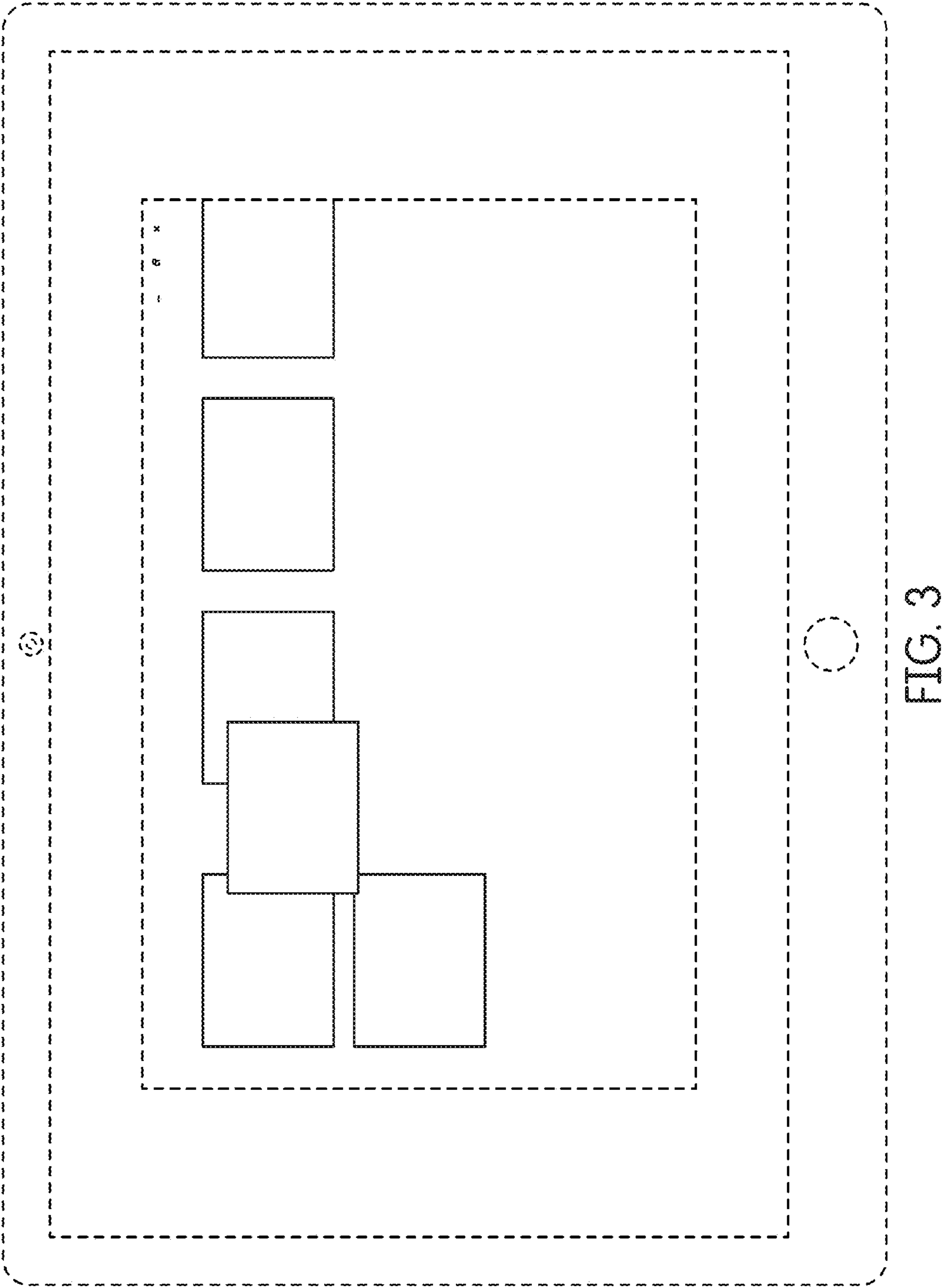

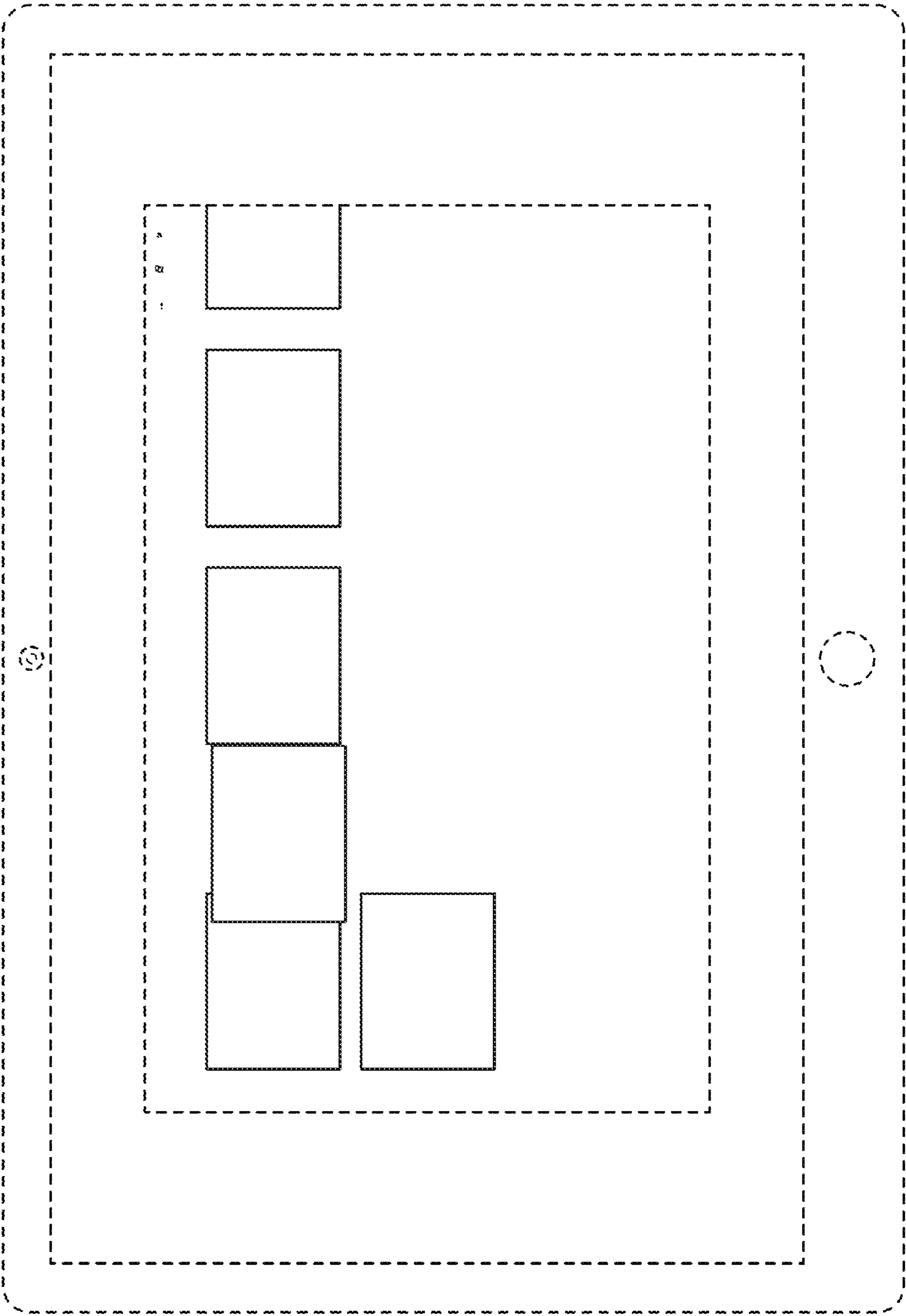
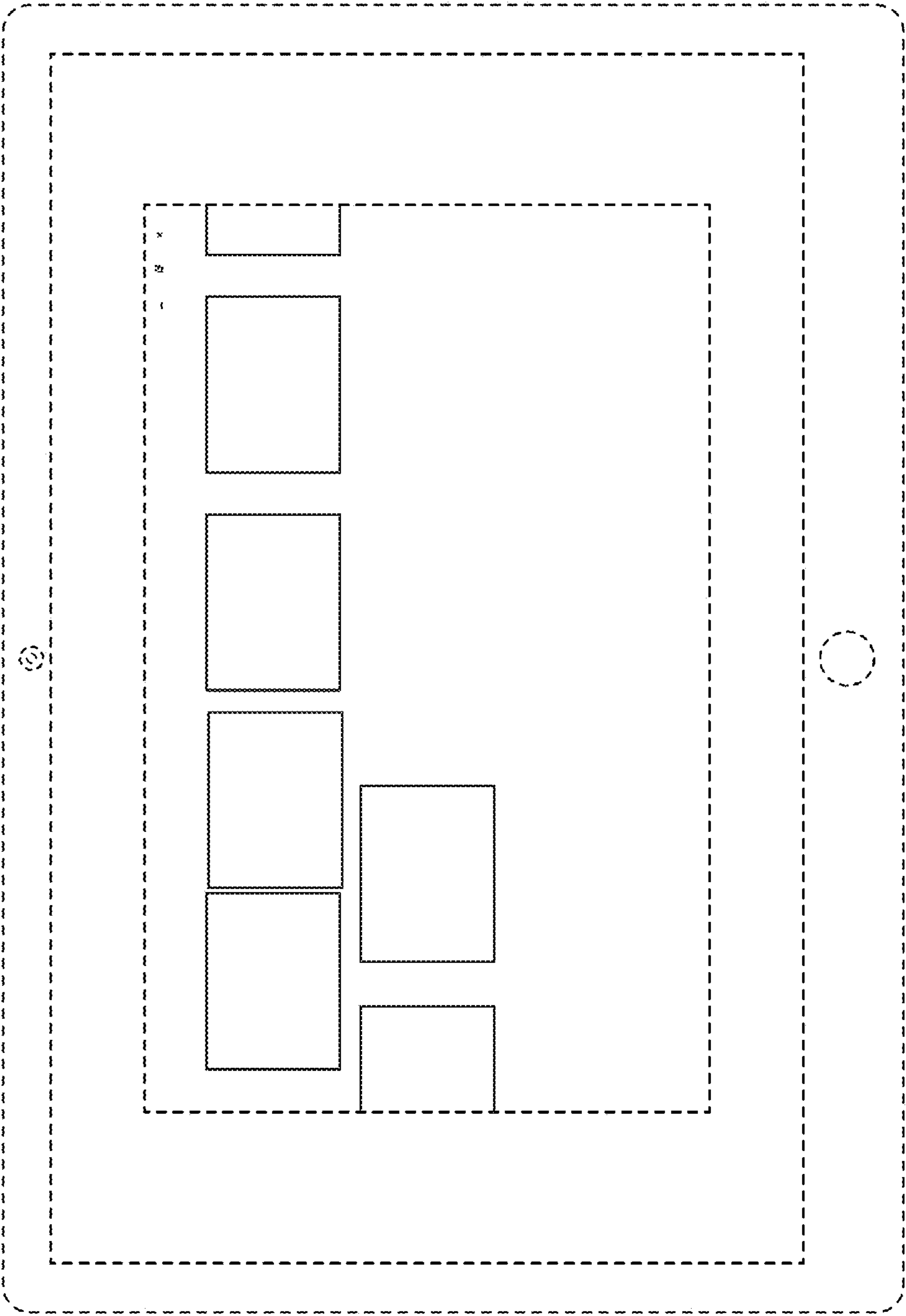
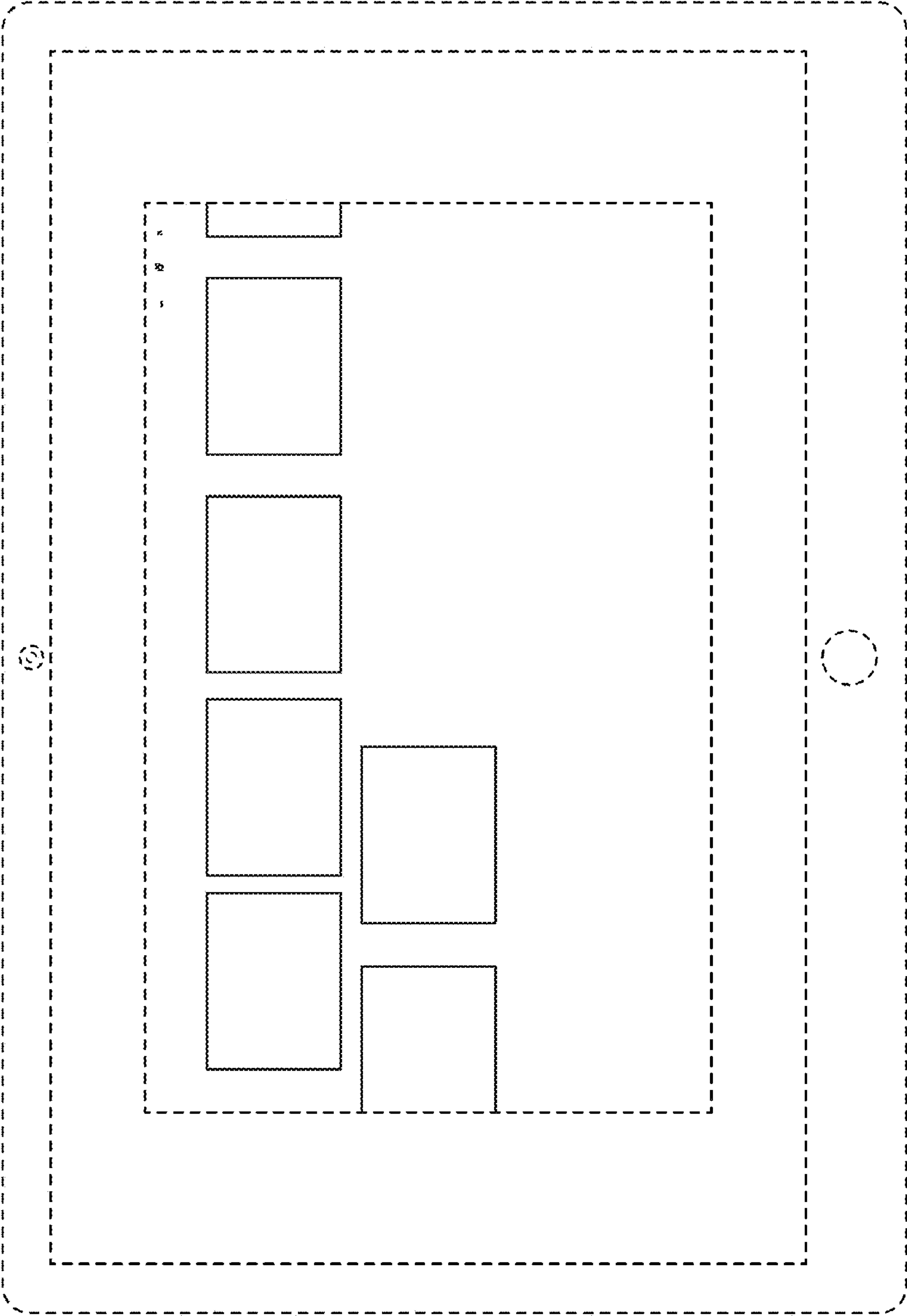

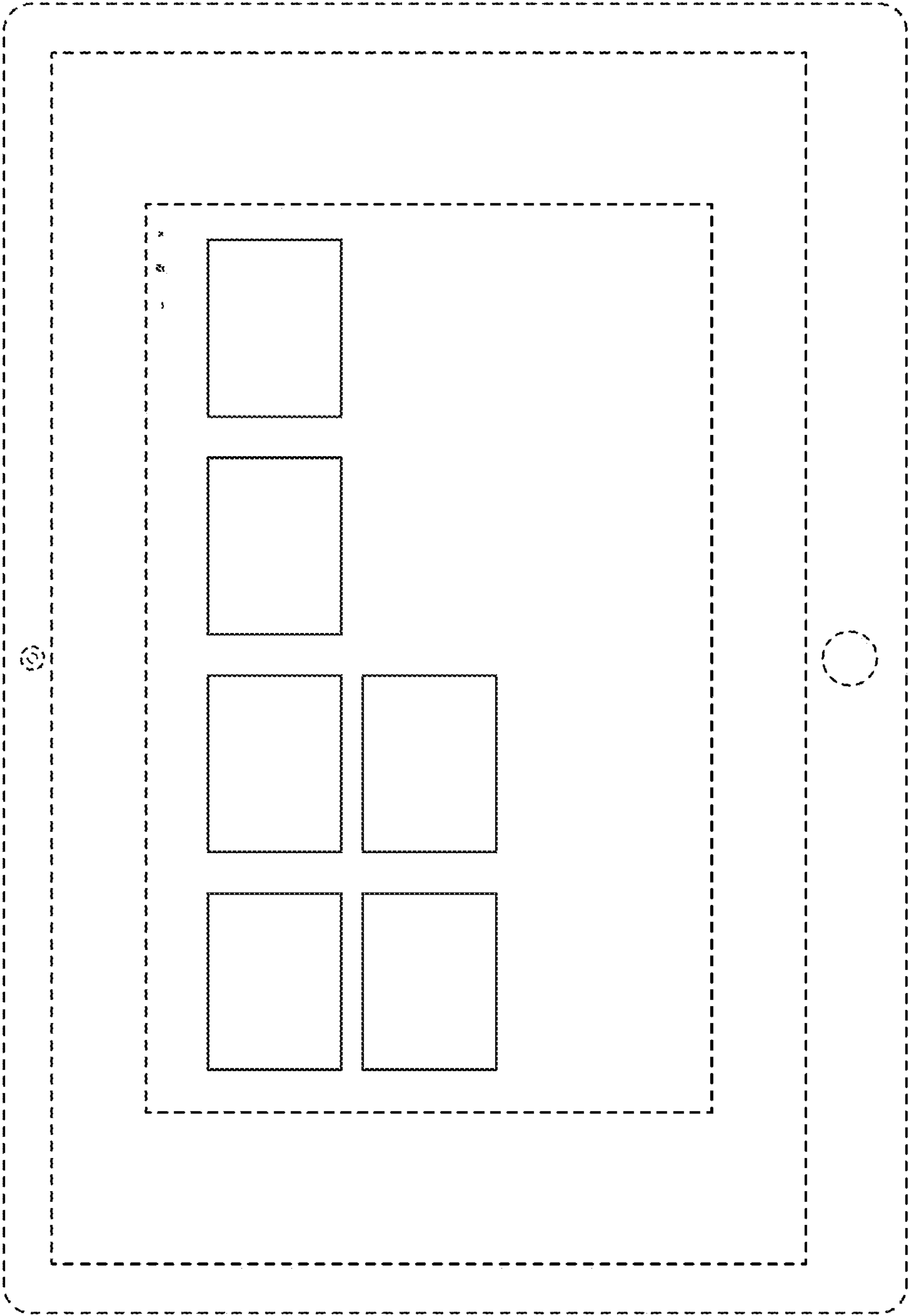
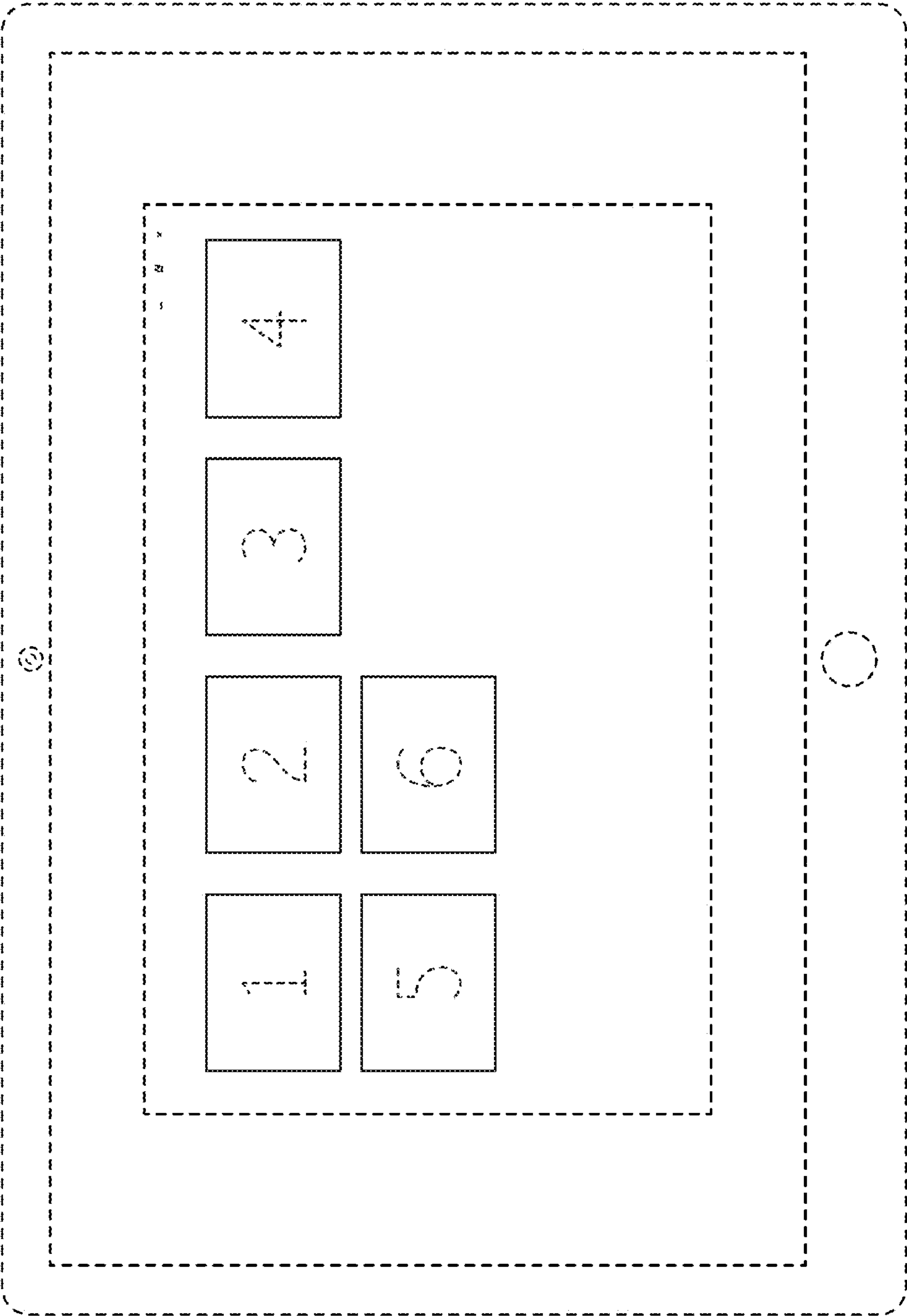

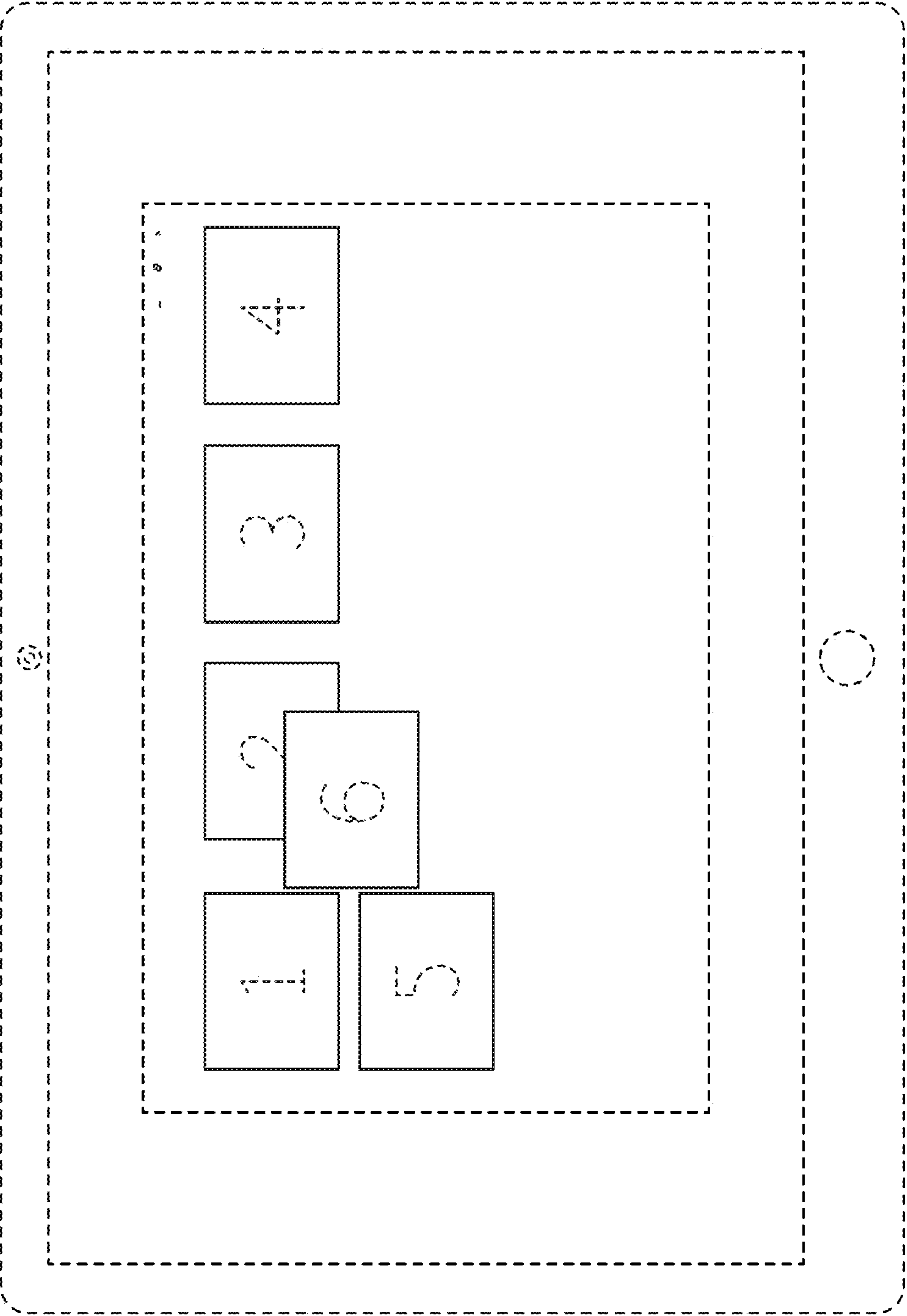
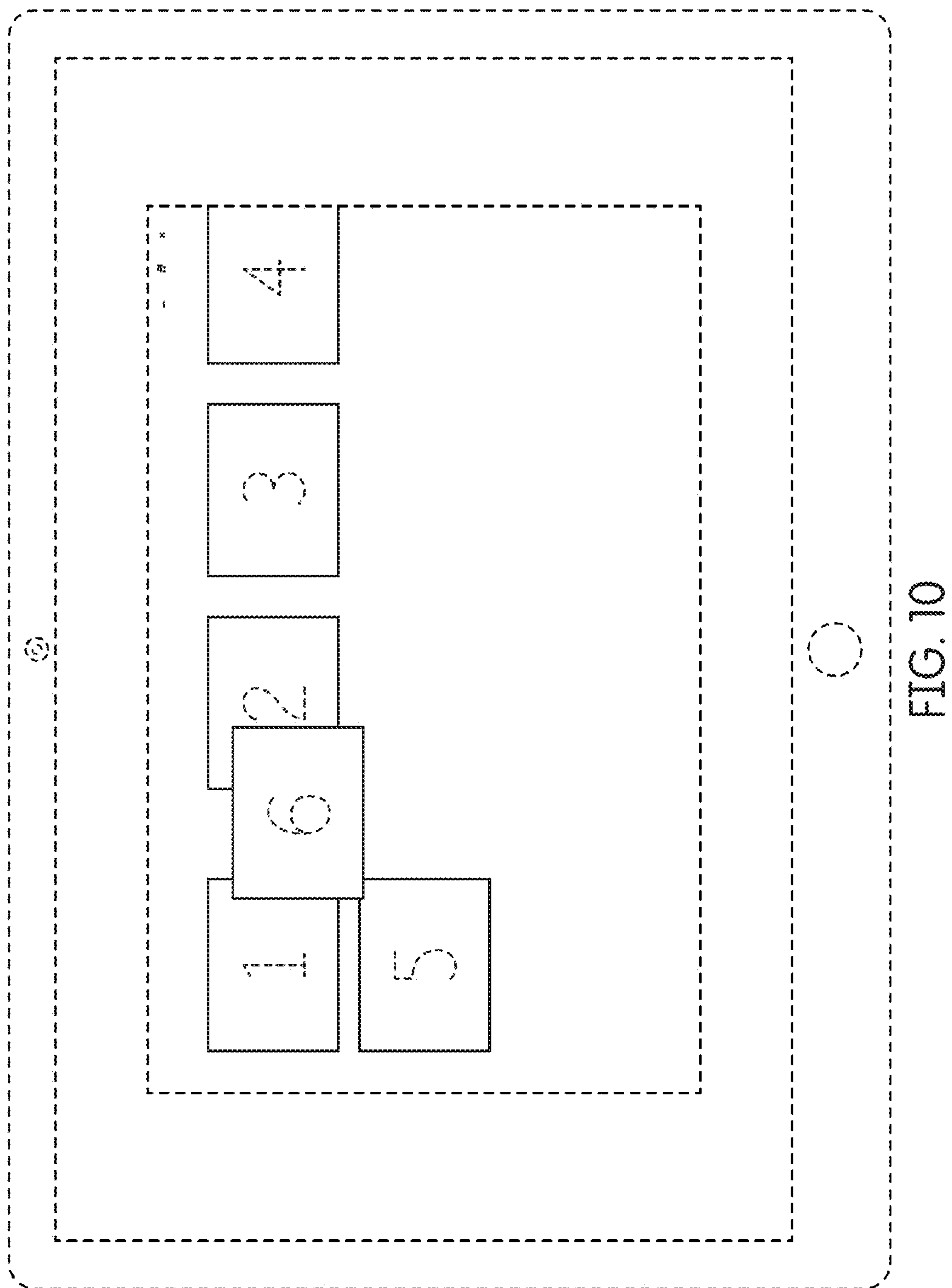
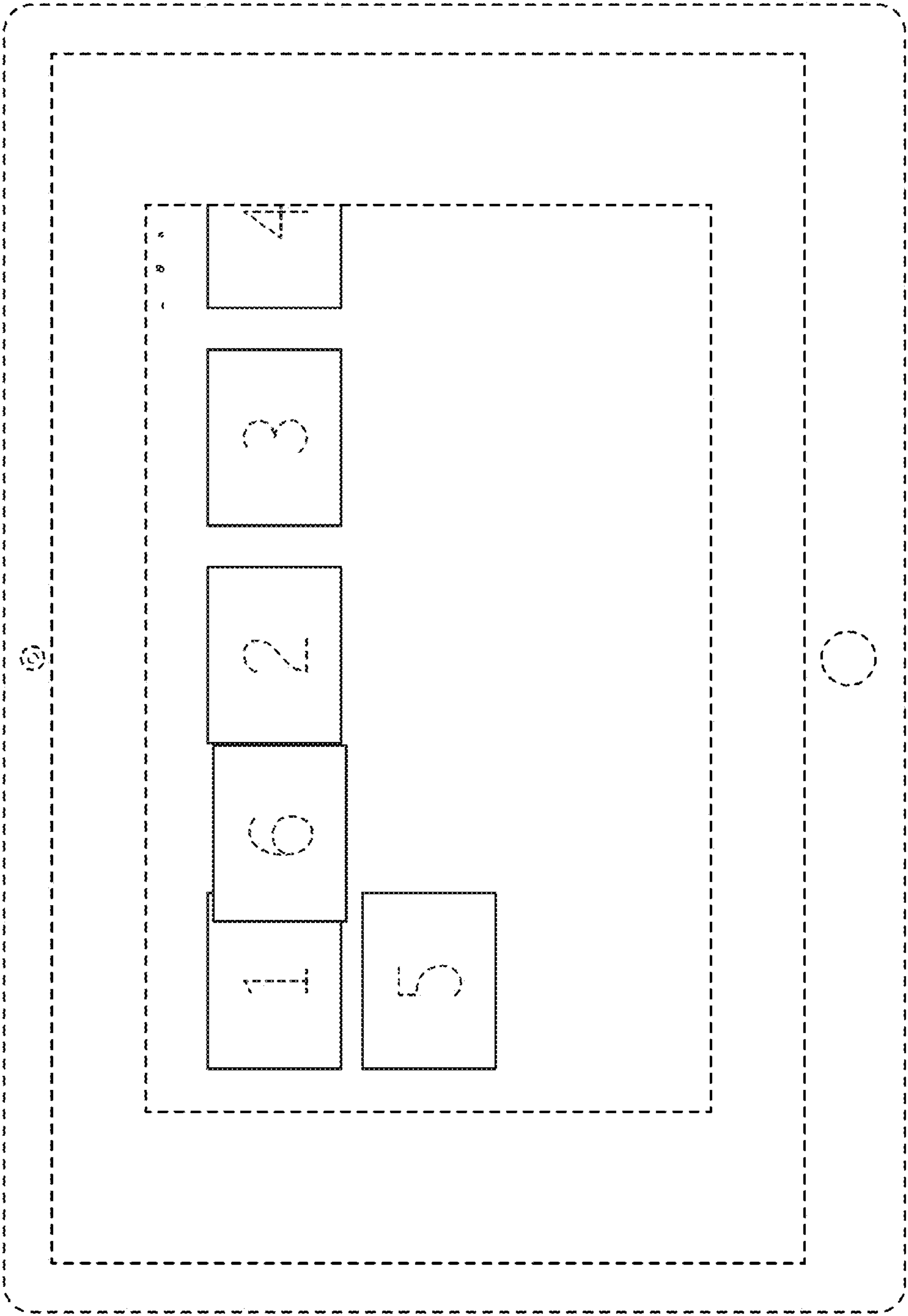

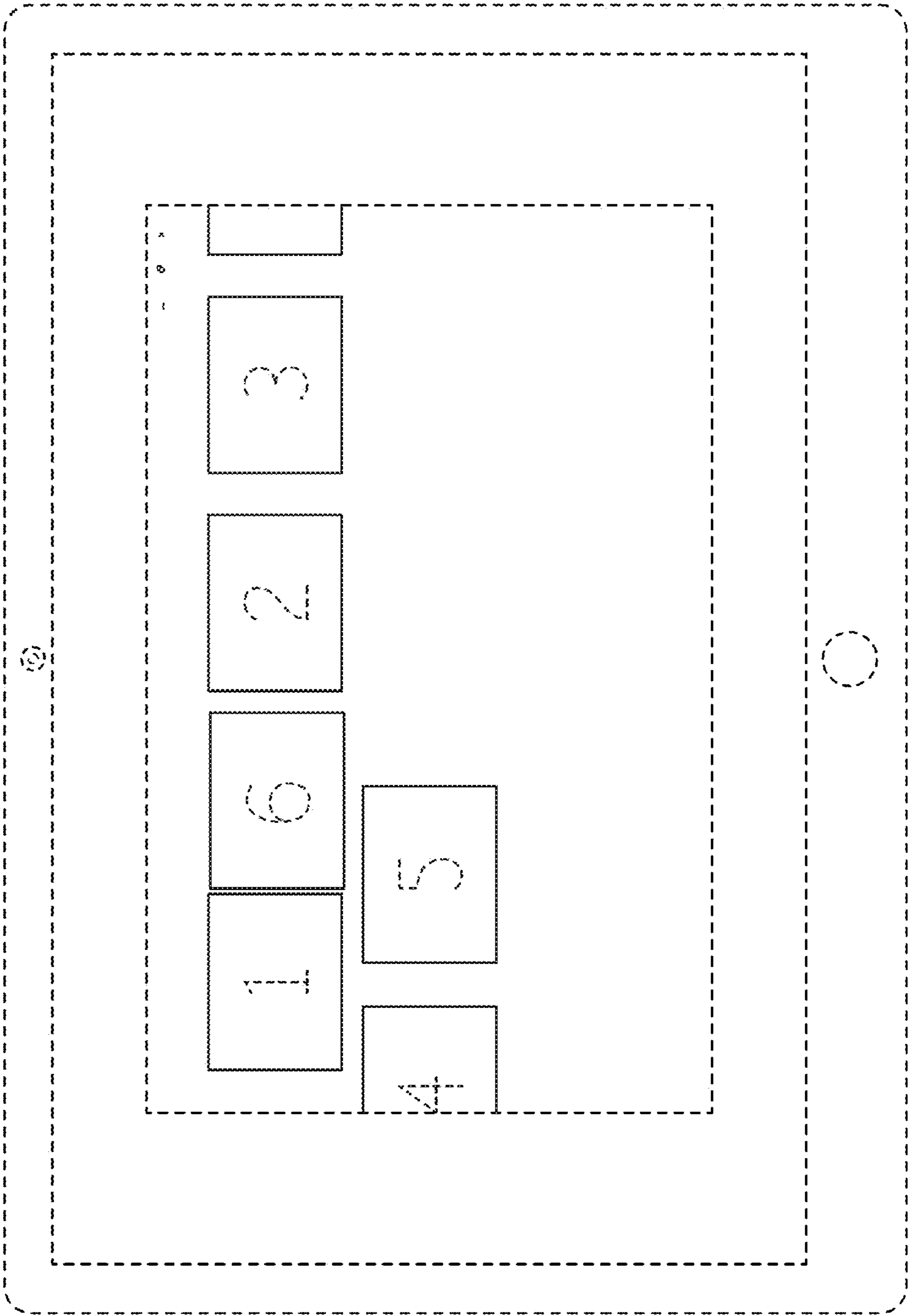

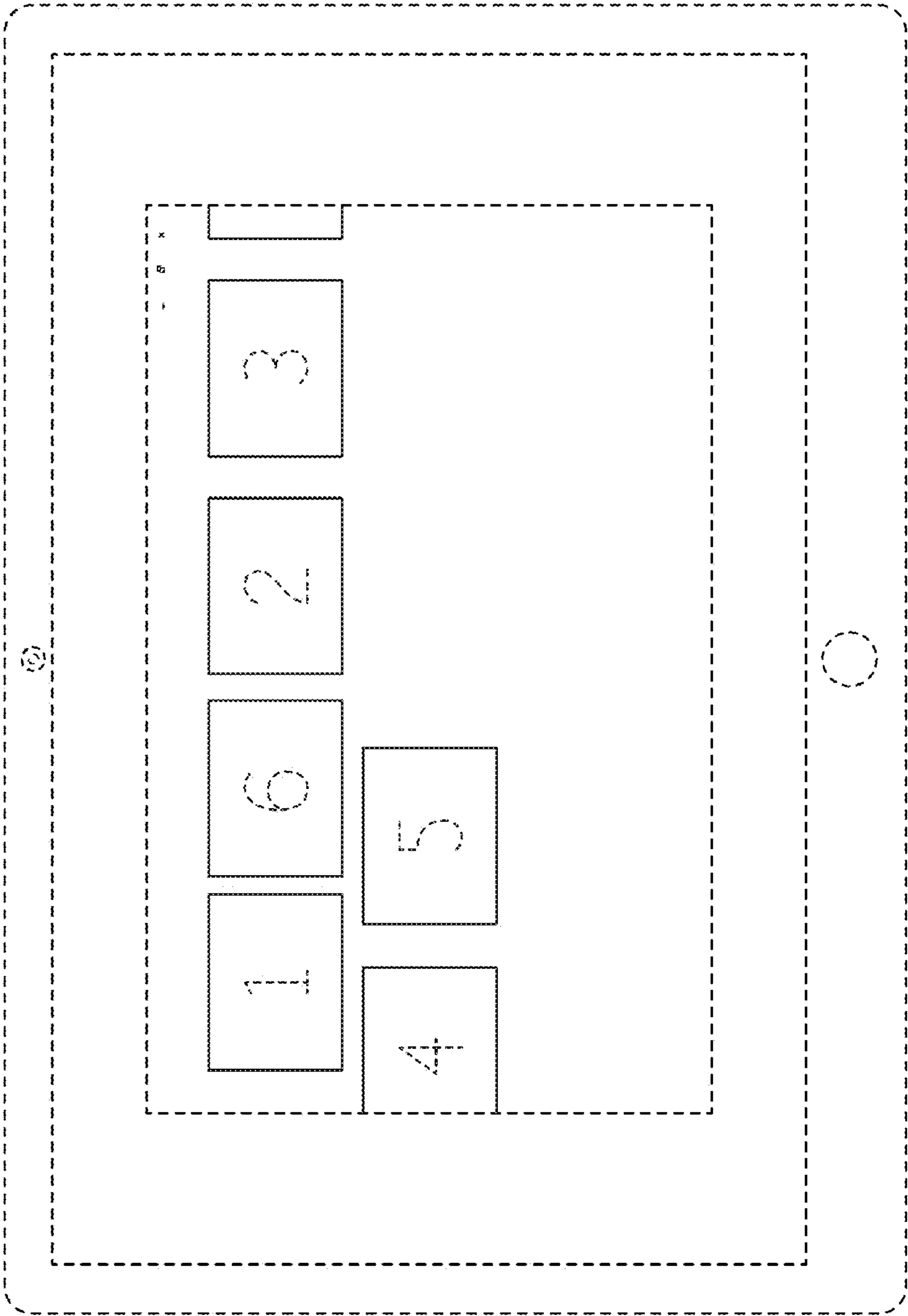
