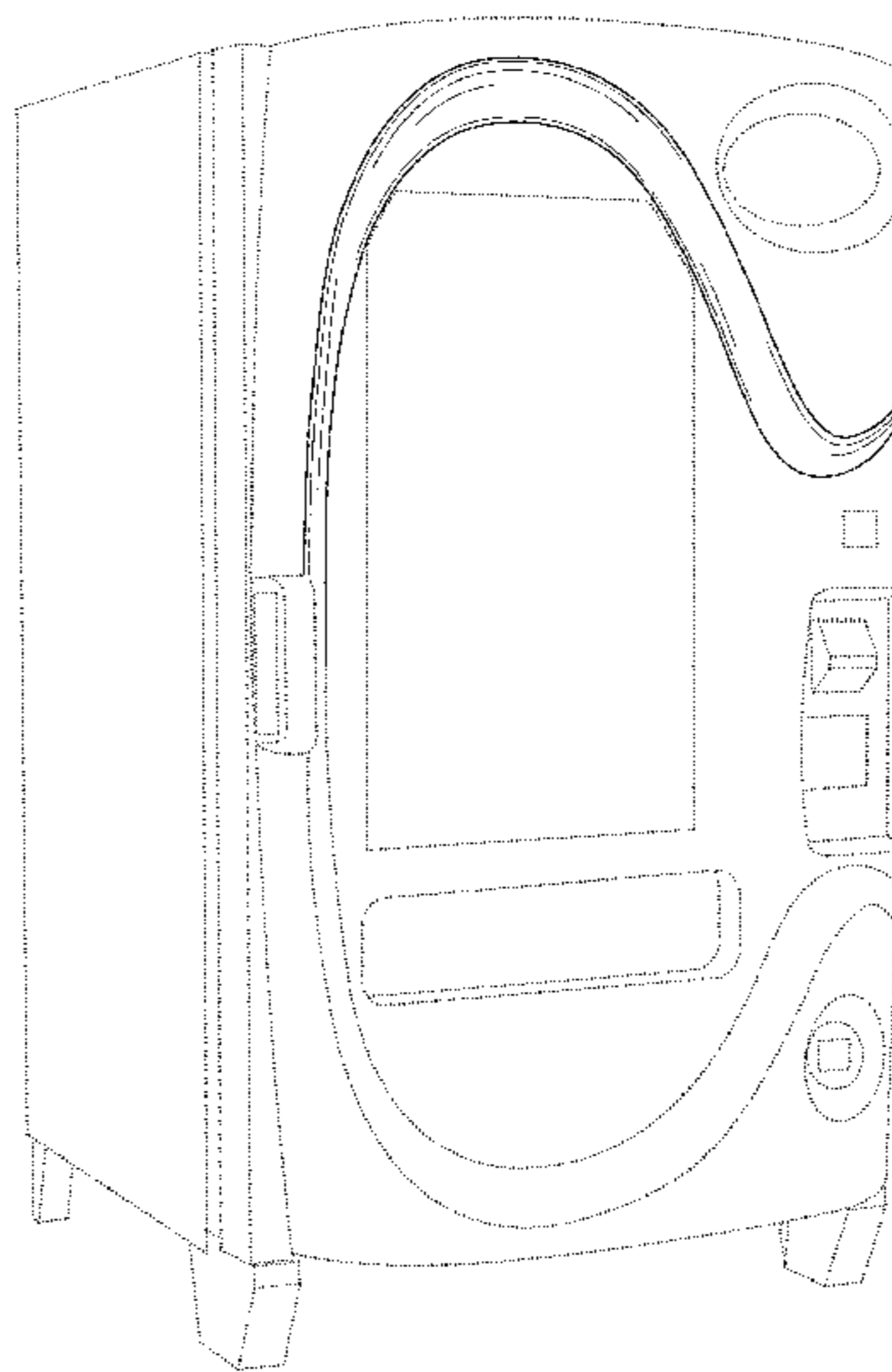
(57) **CLAIM**

We claim the ornamental design for a vending machine panel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vending machine panel, in accordance with our new design;
FIG. 2 is a front elevation view of the vending machine panel of FIG. 1;
FIG. 3 is a top plan view of the vending machine panel of FIG. 1;
FIG. 4 is a bottom plan view of the vending machine panel of FIG. 1;
FIG. 5 is an enlarged left side elevation view of the vending machine panel of FIG. 1; and,
FIG. 6 is an enlarged right side elevation view of the vending machine panel of FIG. 1.

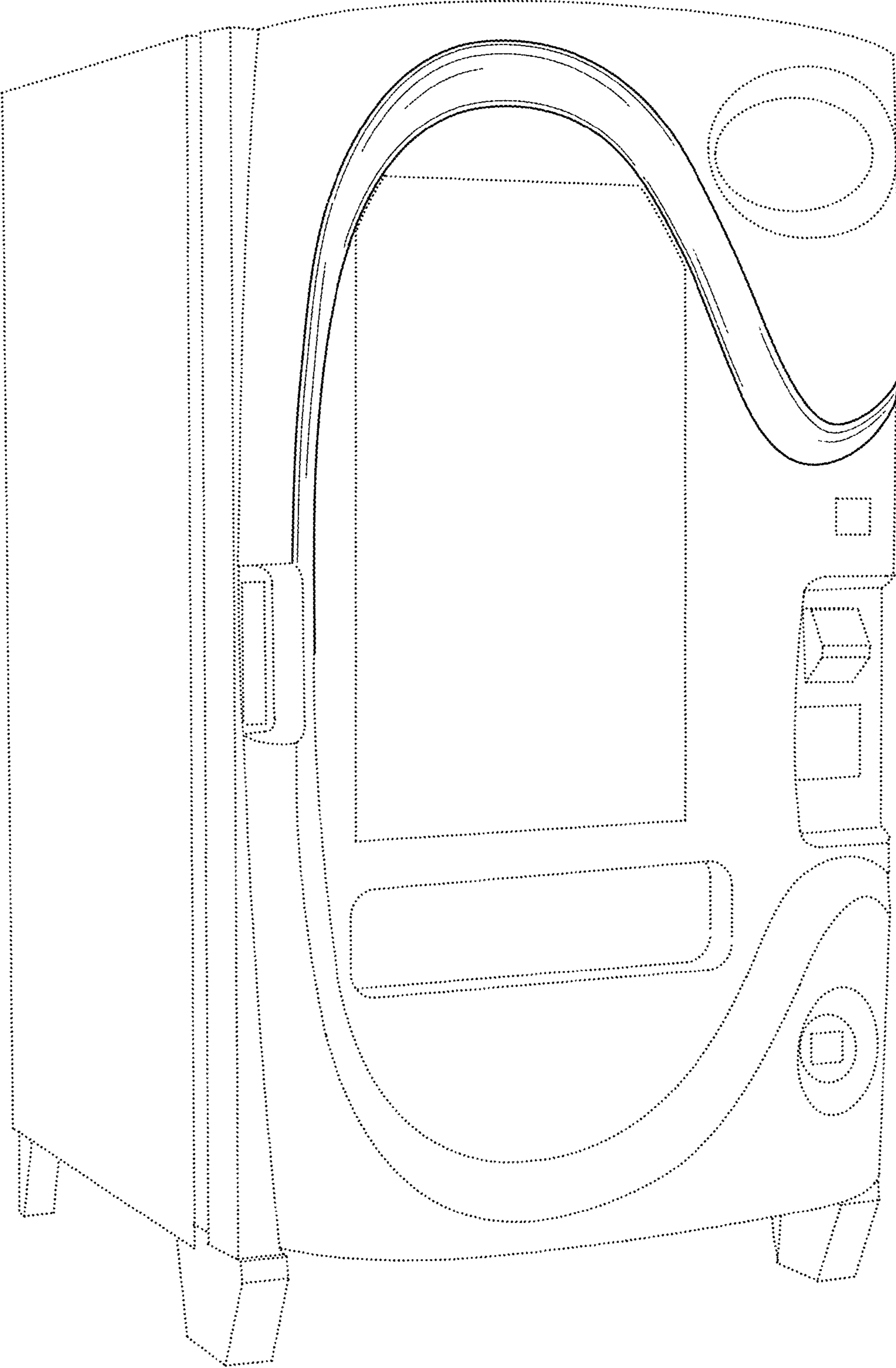

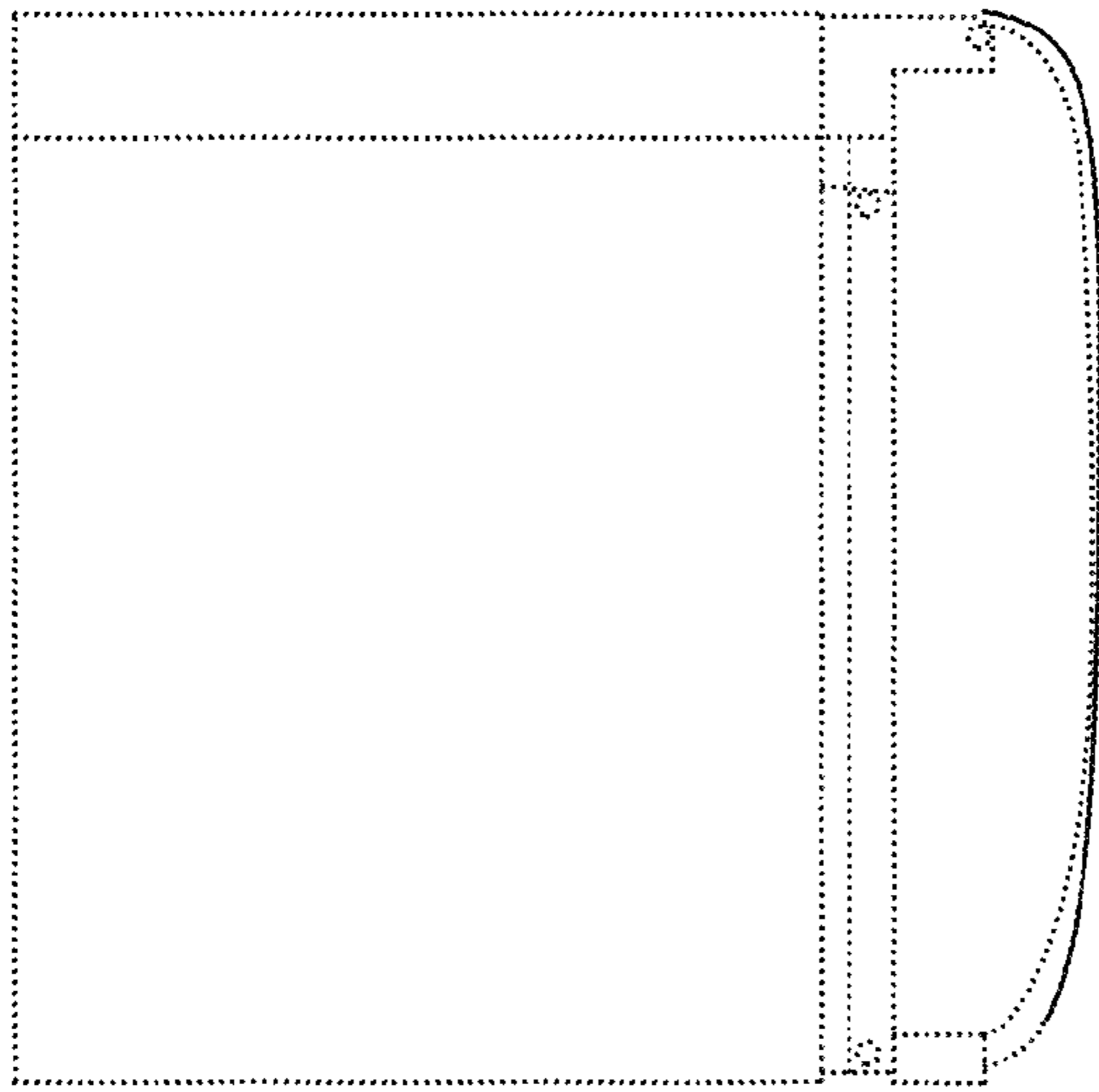

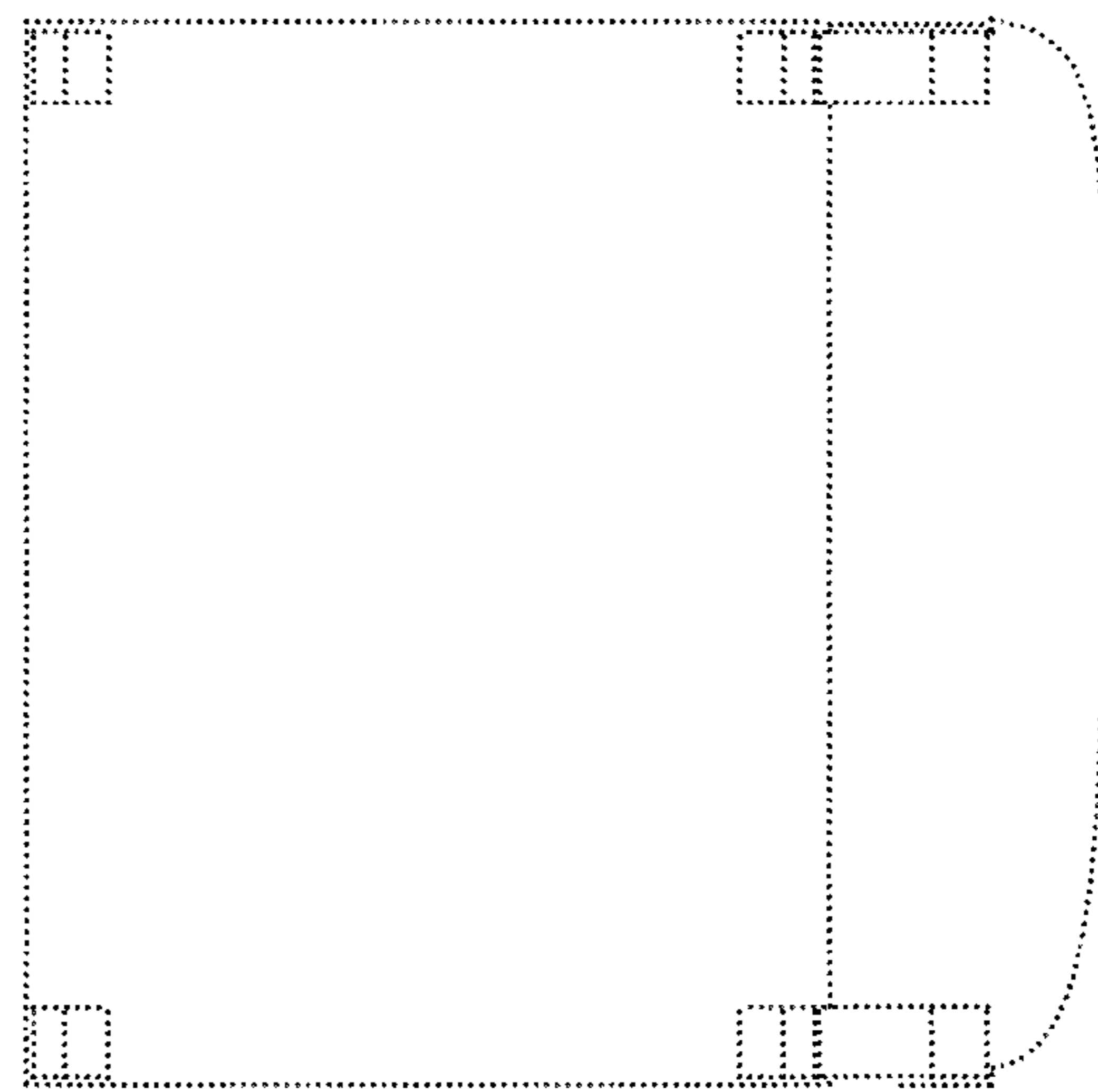

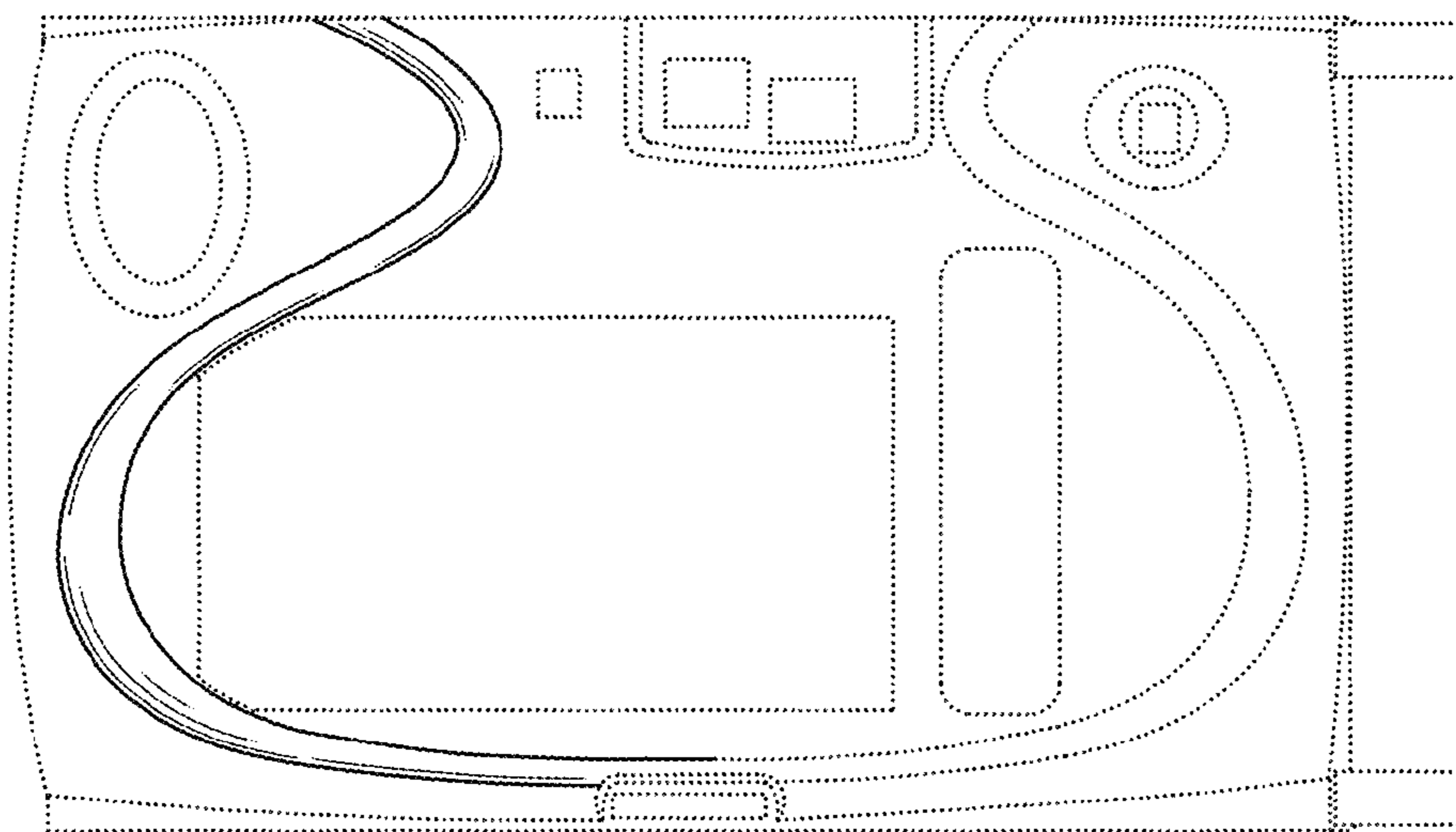

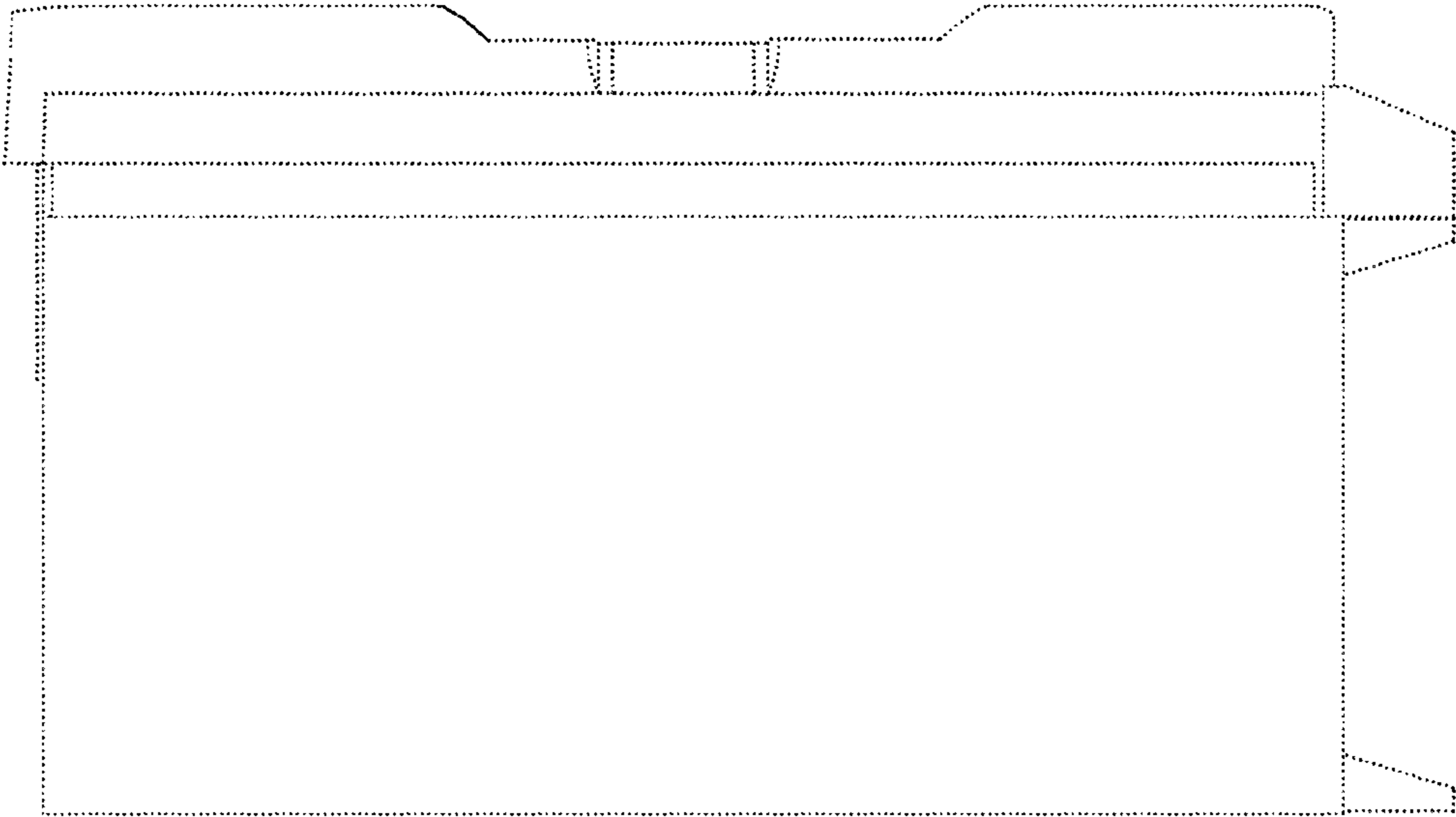
