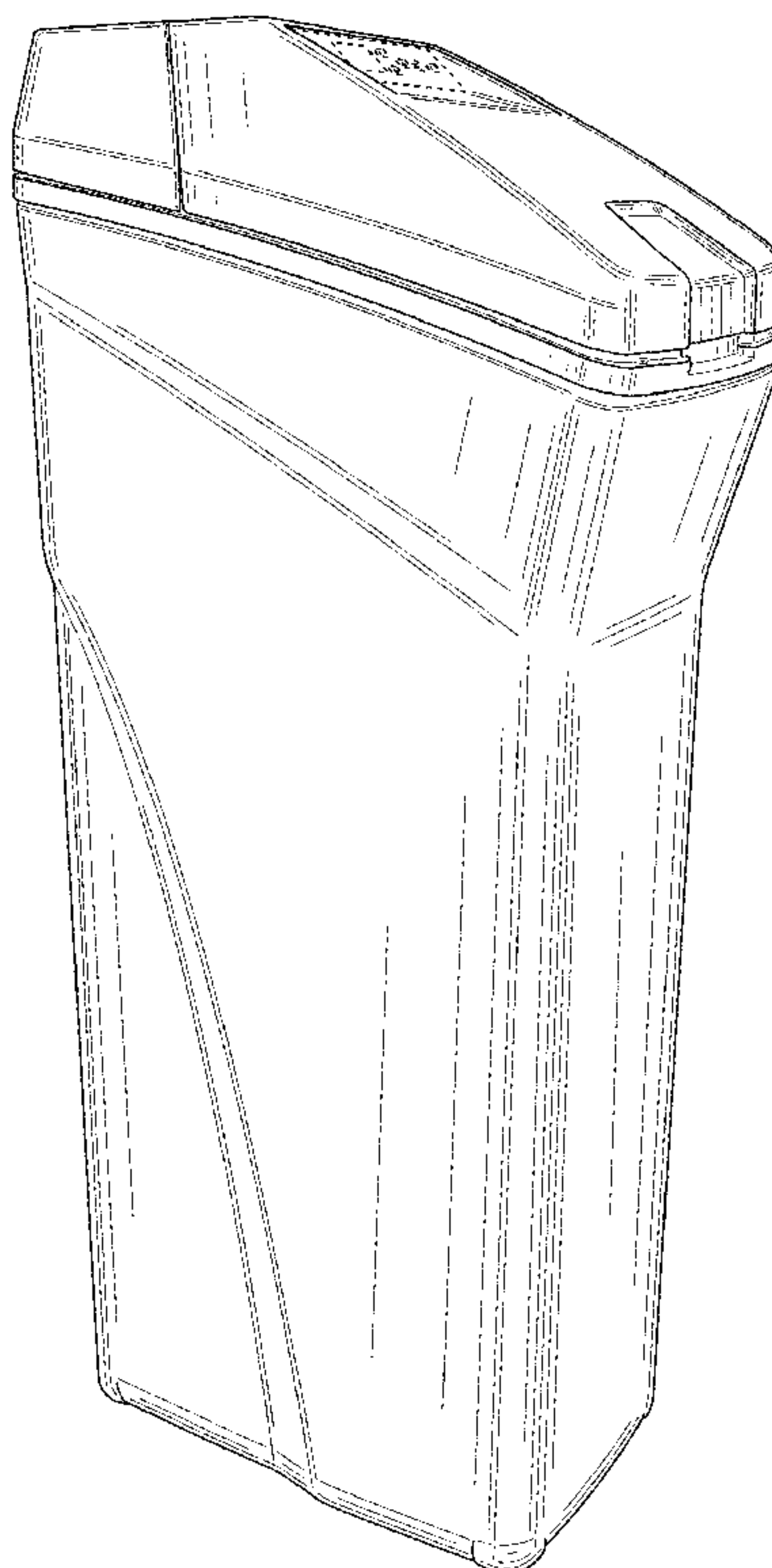
(57) **CLAIM**

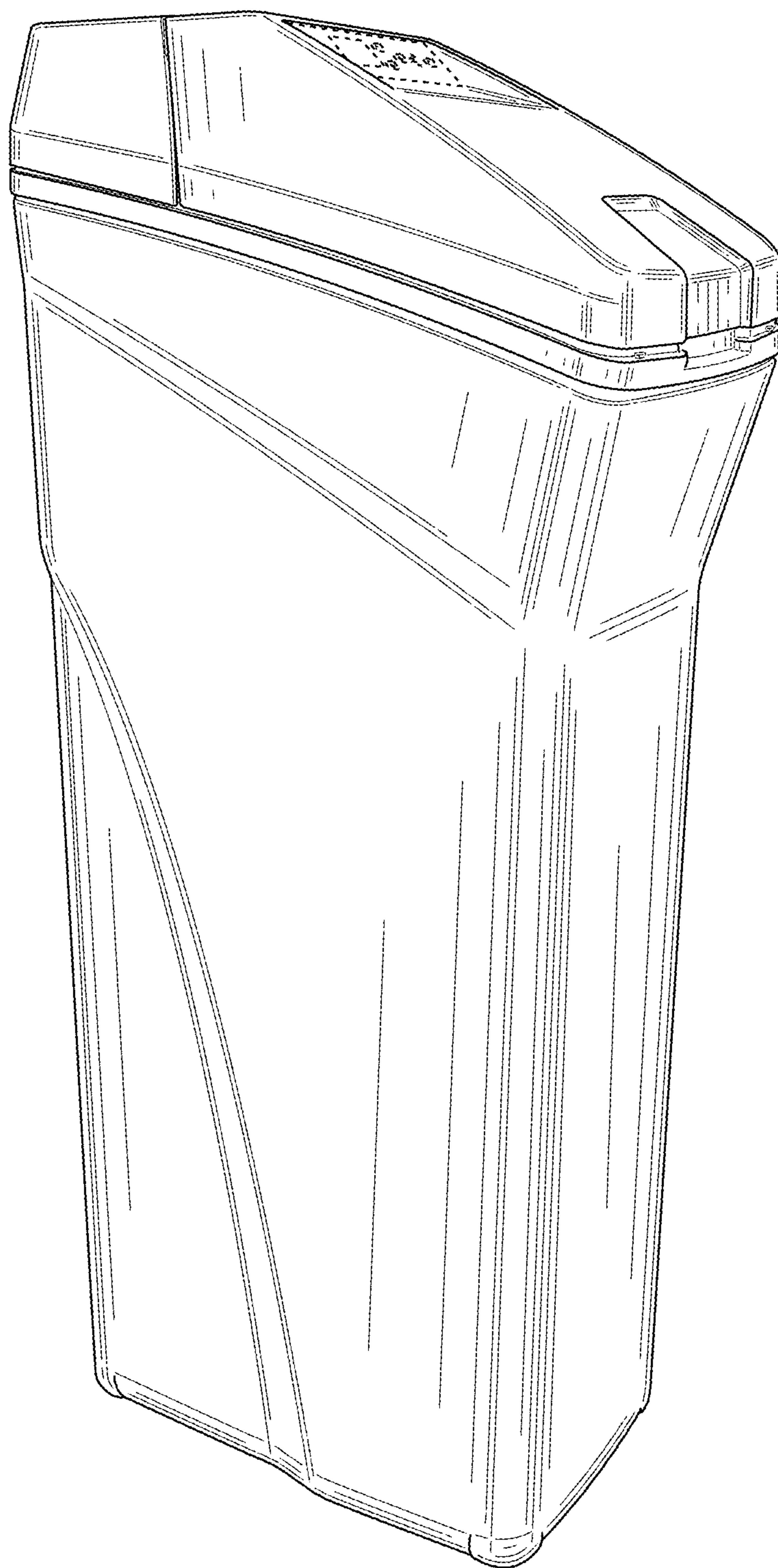
The ornamental design for an appliance cabinet, as shown and described.

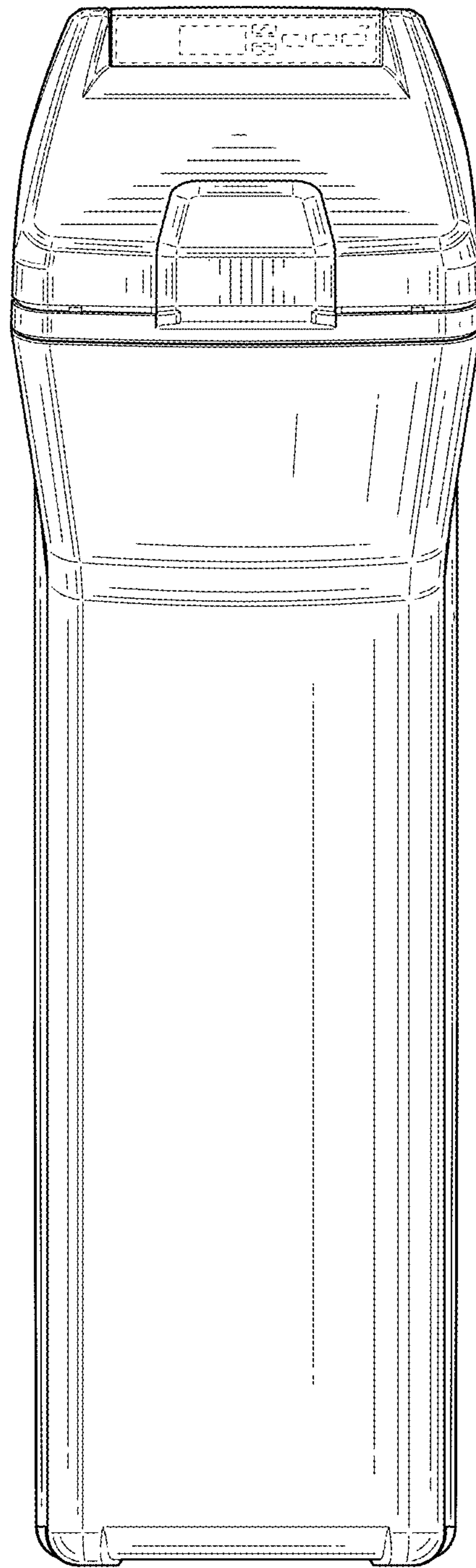
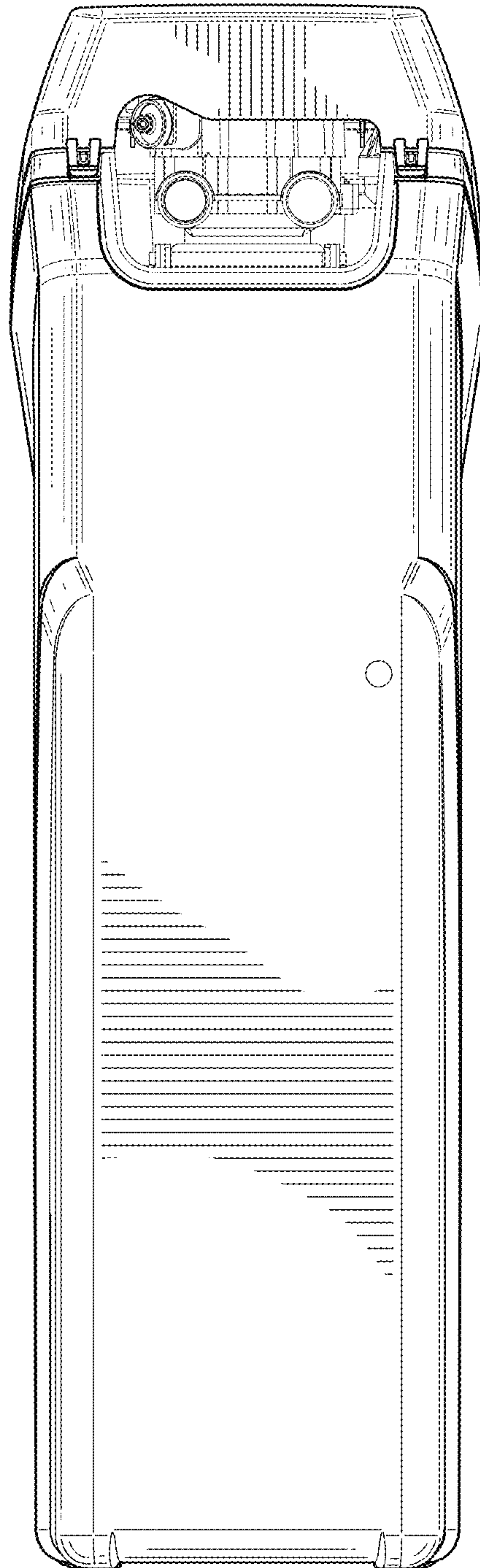

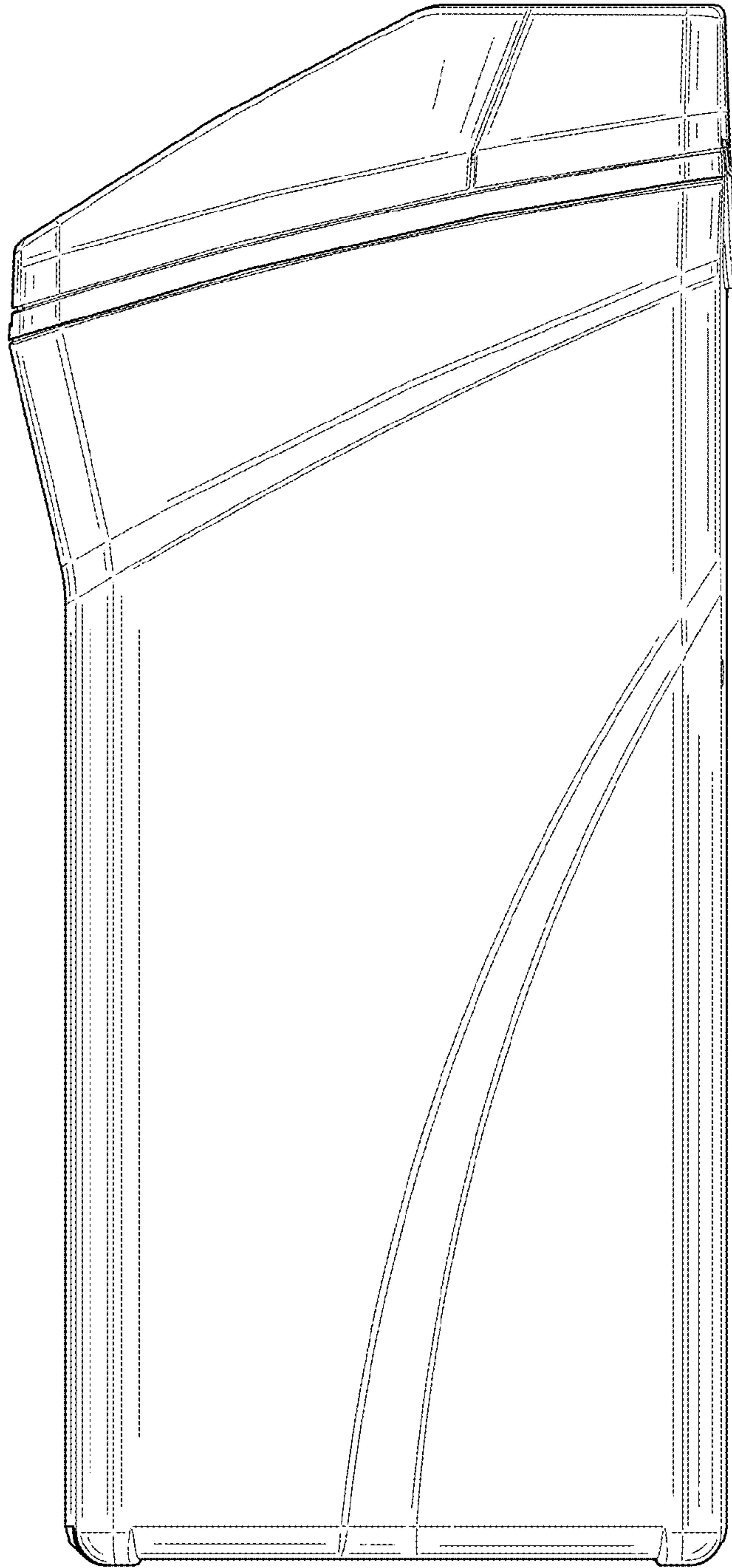
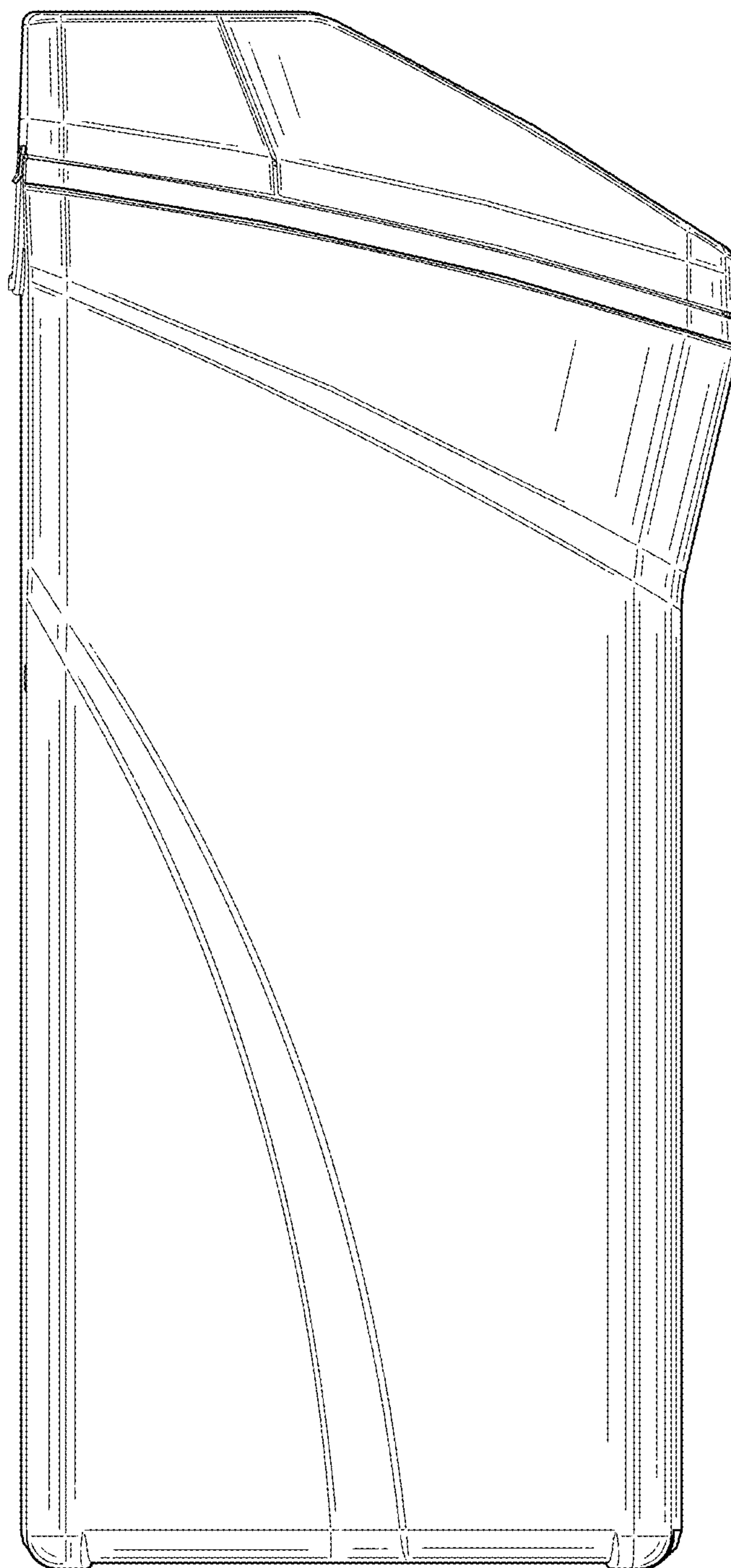
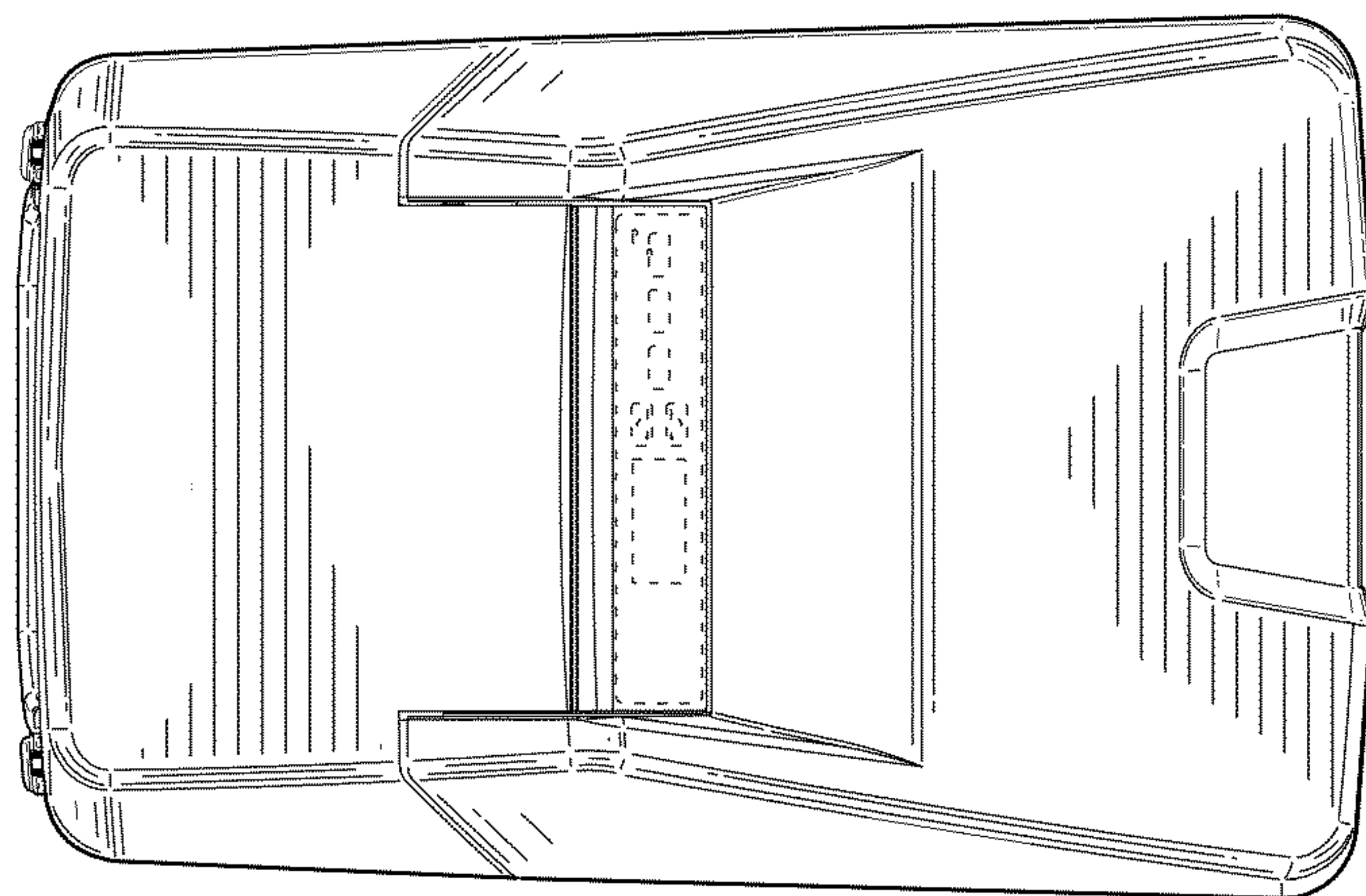


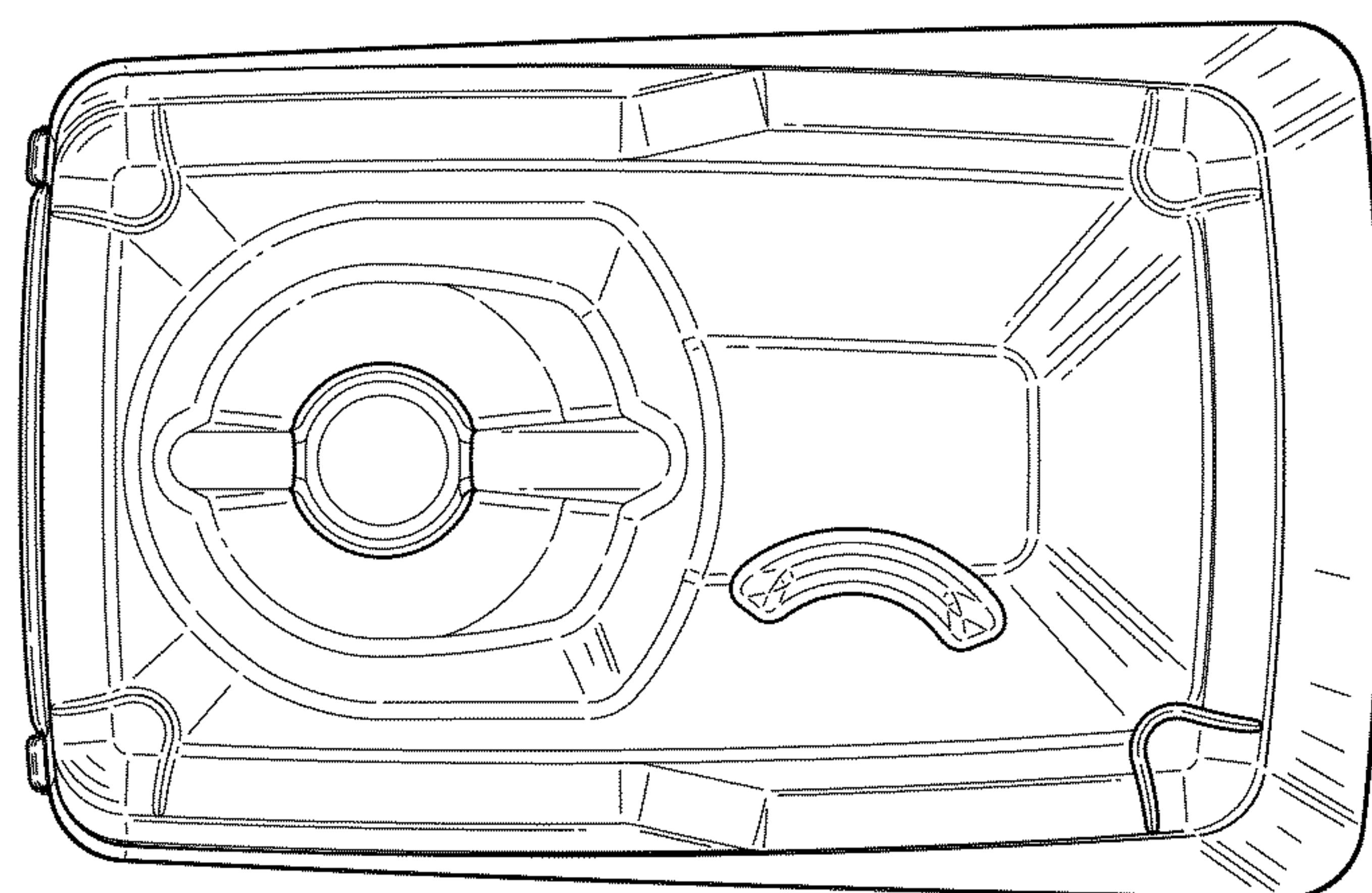
