(57) **CLAIM**

The ornamental design for a top sheet for a sanitary napkin, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of a top sheet for a sanitary napkin showing my new design. The inner broken line perimeter represents the boundary of the claimed design, and the outermost perimeter depicts a portion of the top sheet of a sanitary napkin that forms no part of the claimed design. The broken lines form no part of the claimed design.
