The ornamental design for an absorbent article with a pattern, as shown and described.

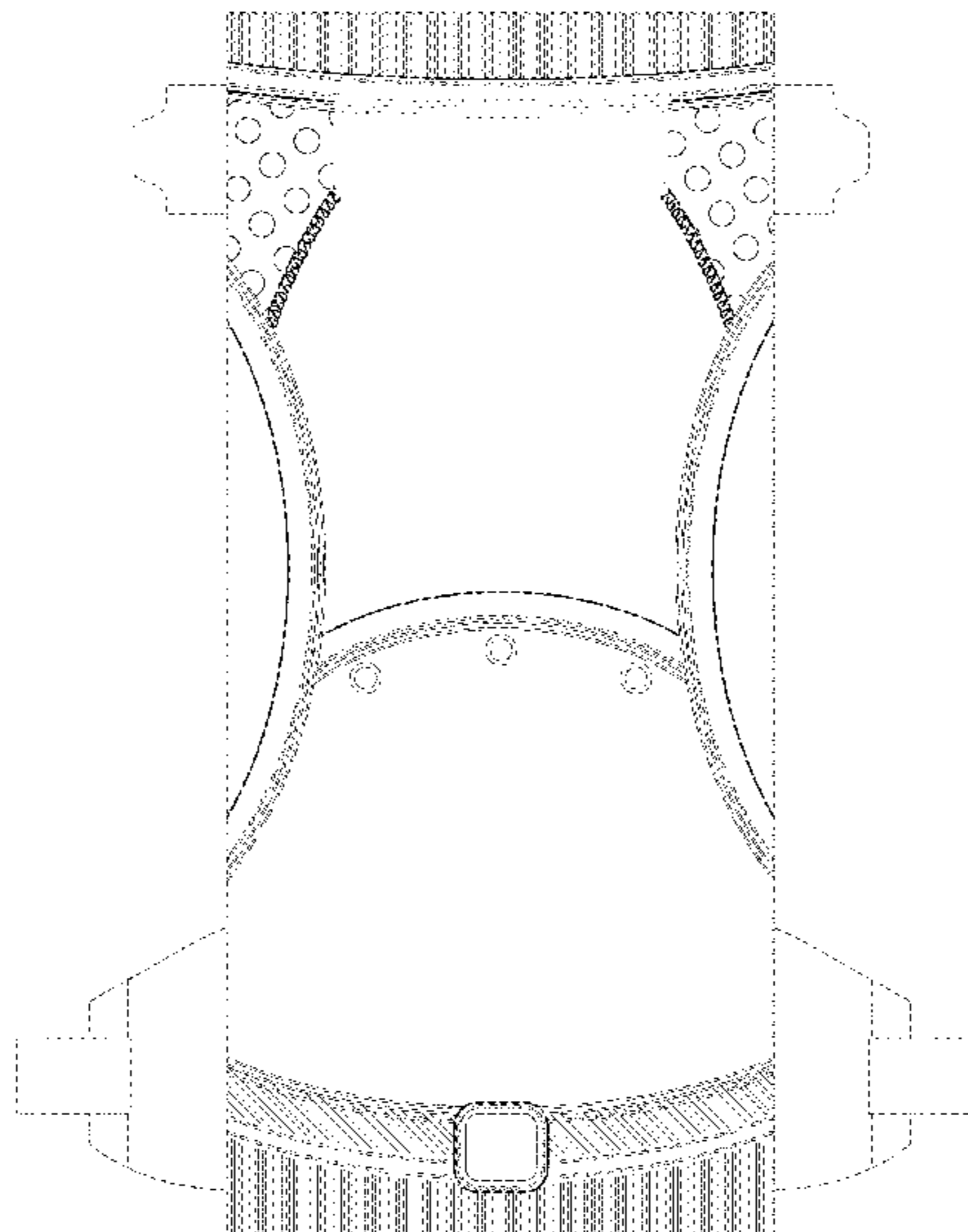
DESCRIPTION
