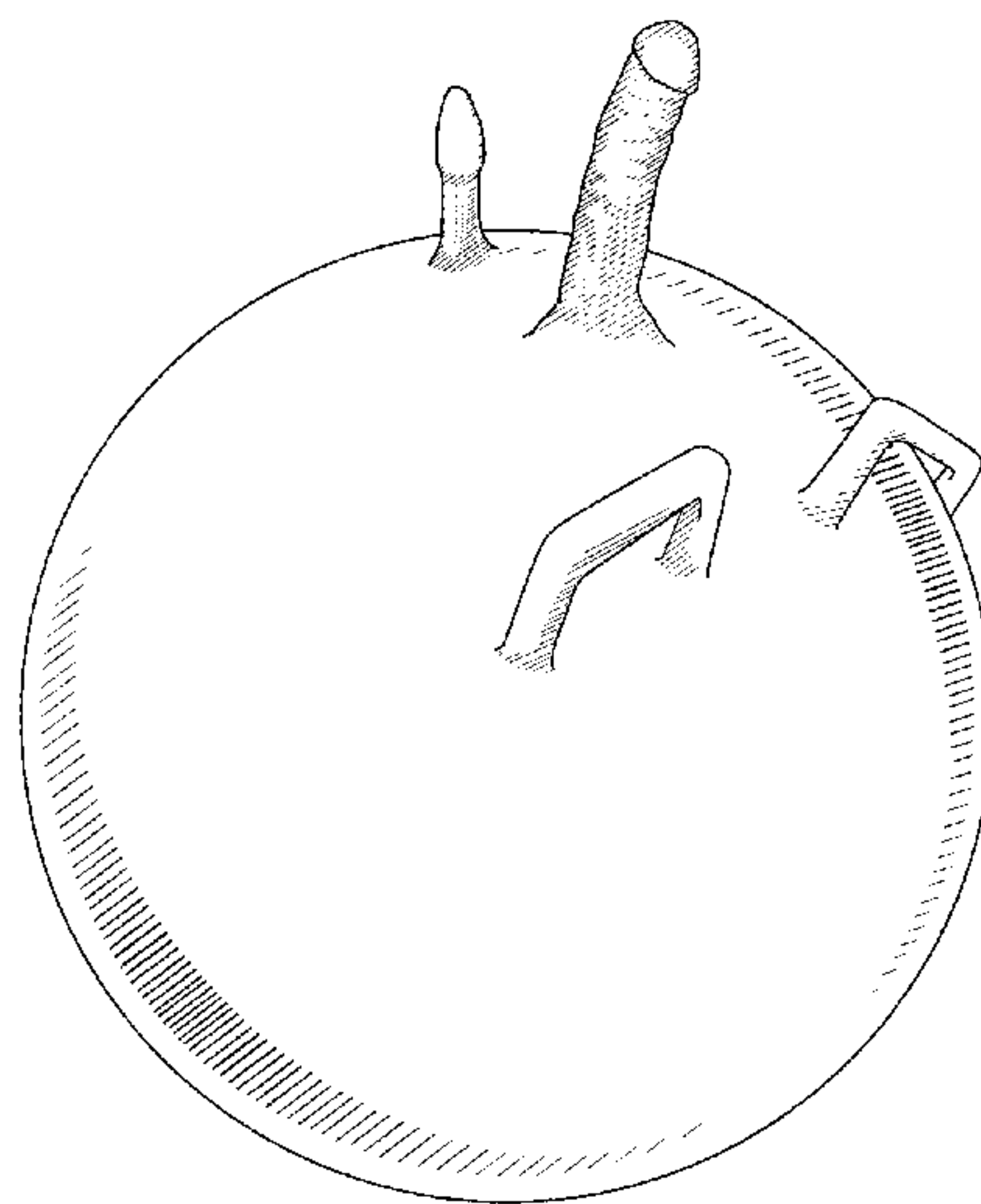
(57) **CLAIM**

The ornamental design for an adult novelty toy, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of an
adult novelty toy showing my new design;

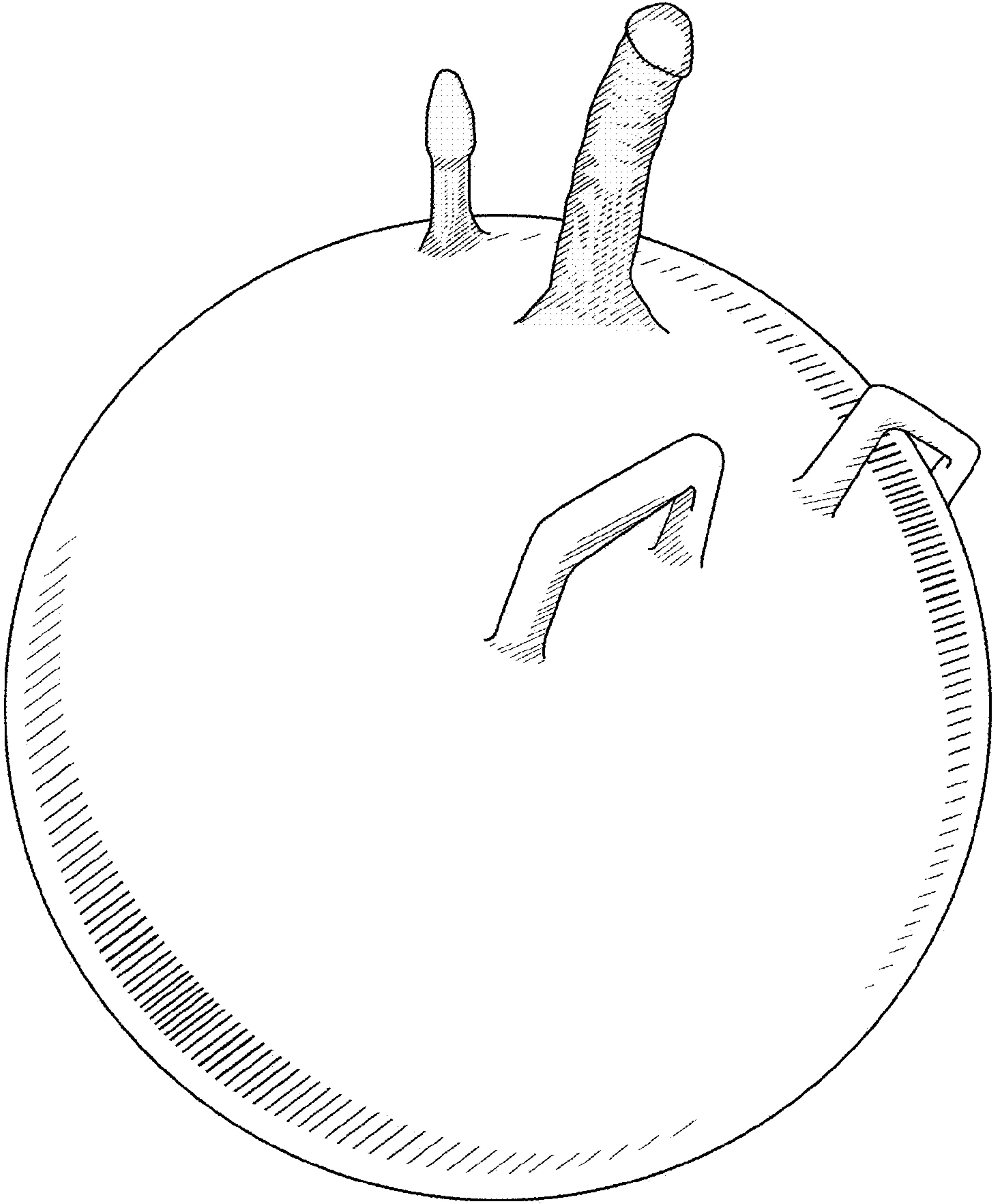

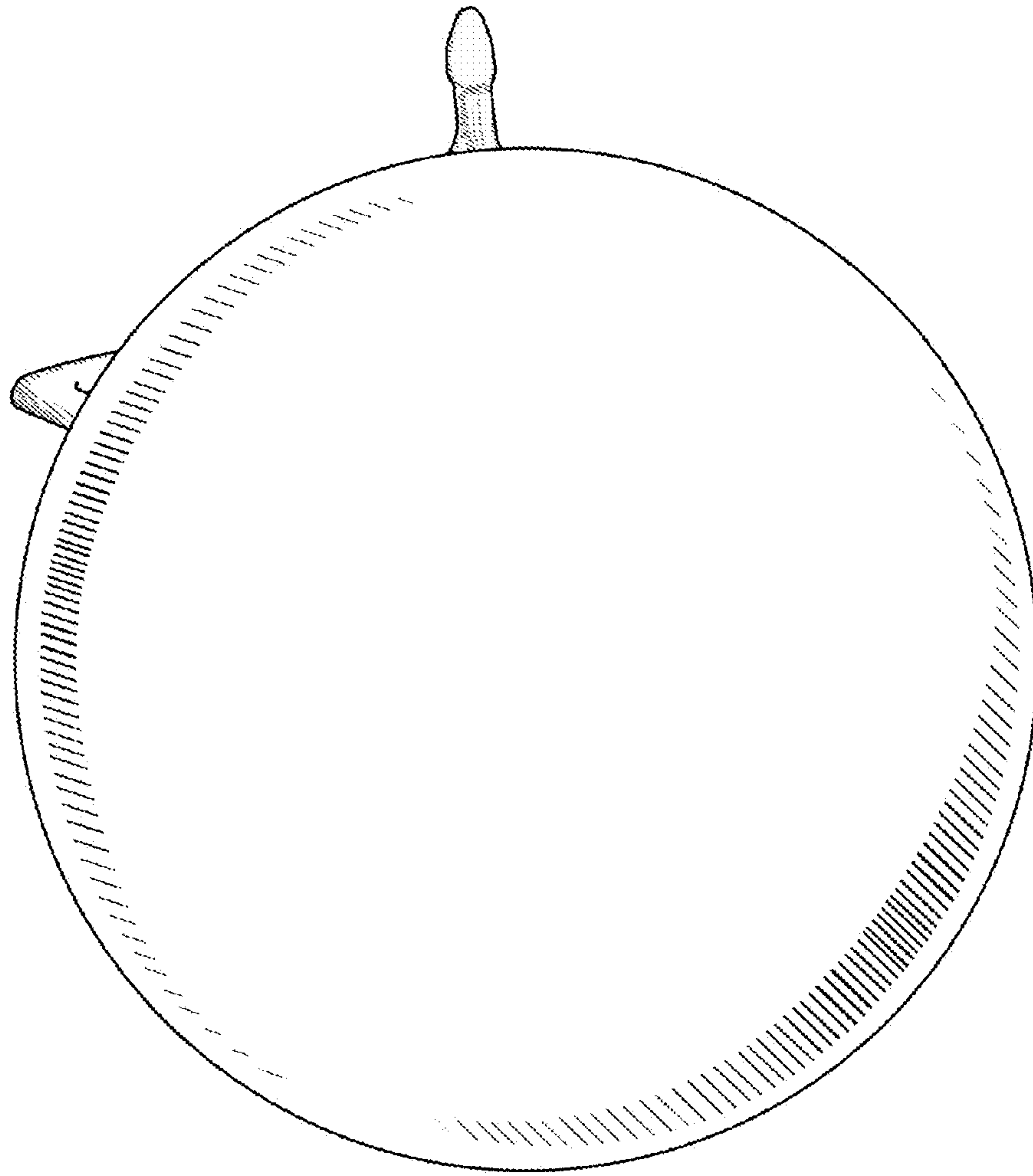

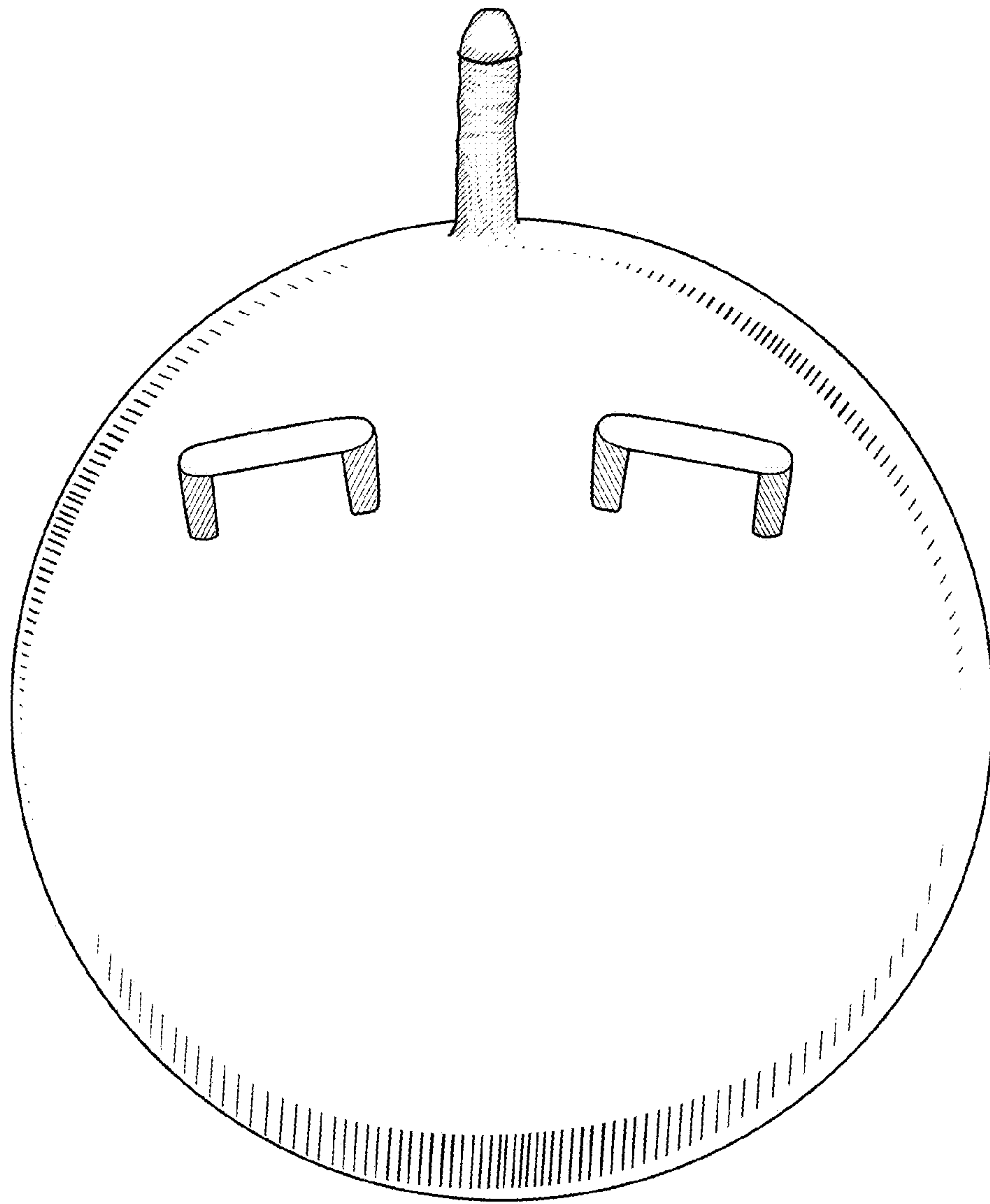

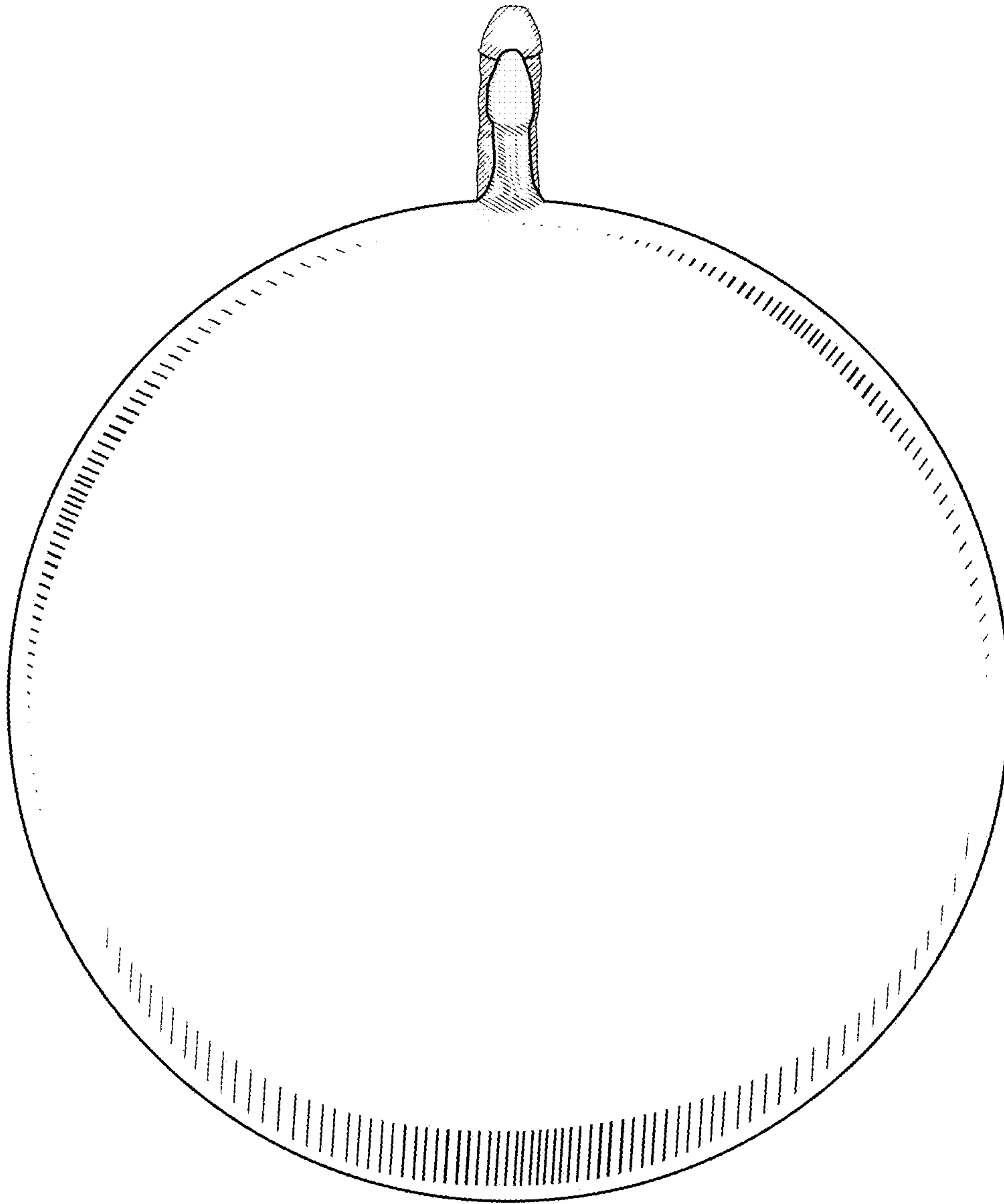

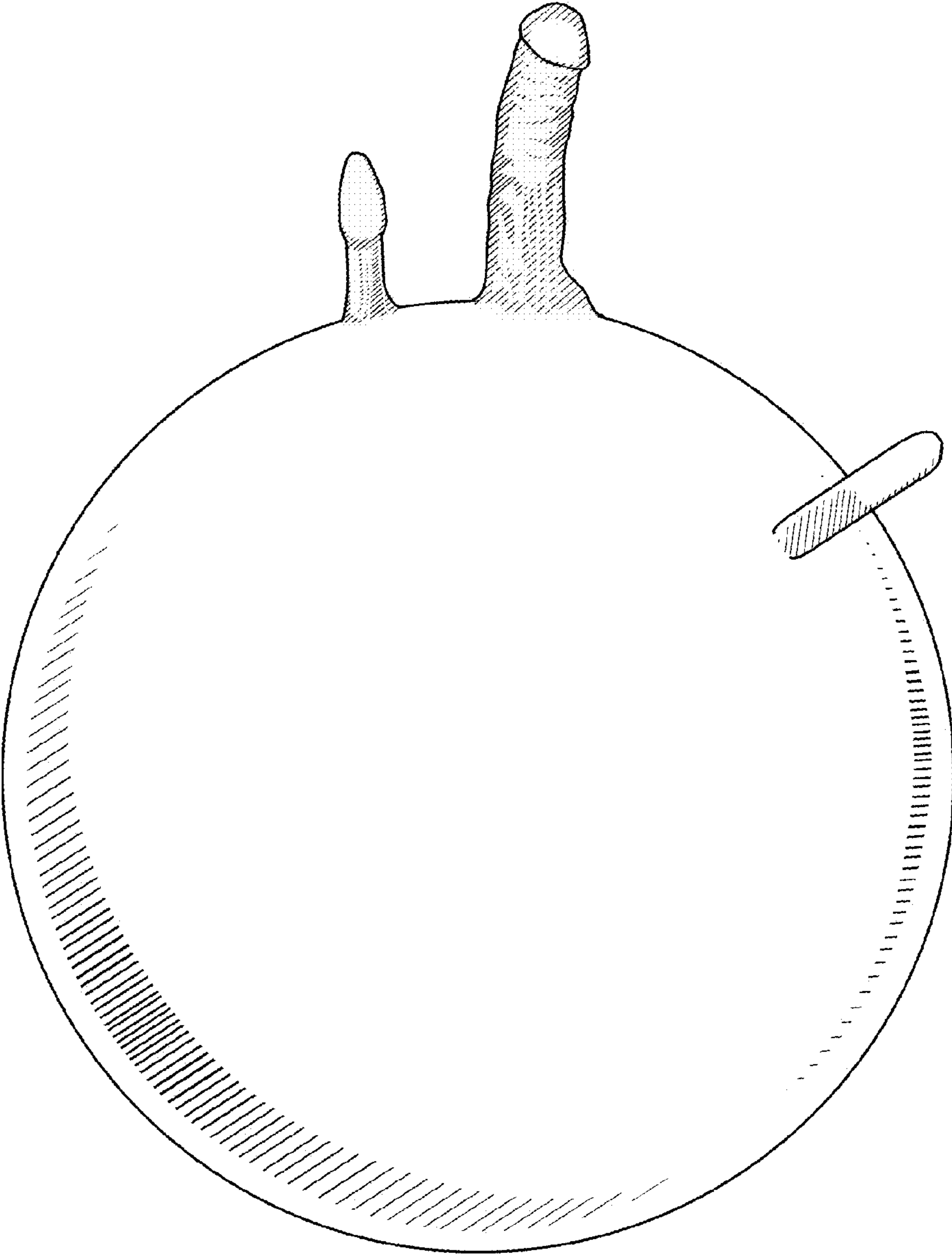

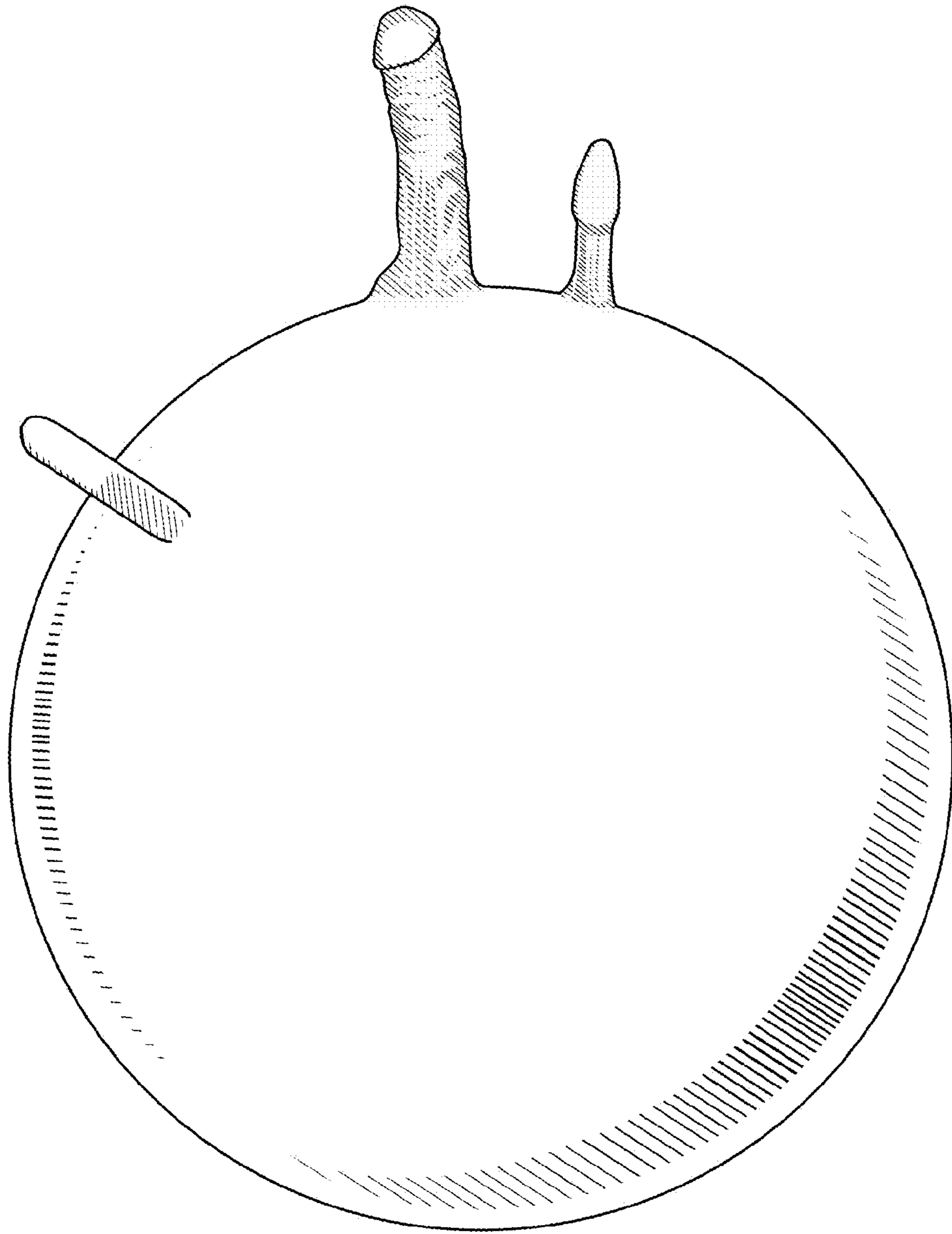

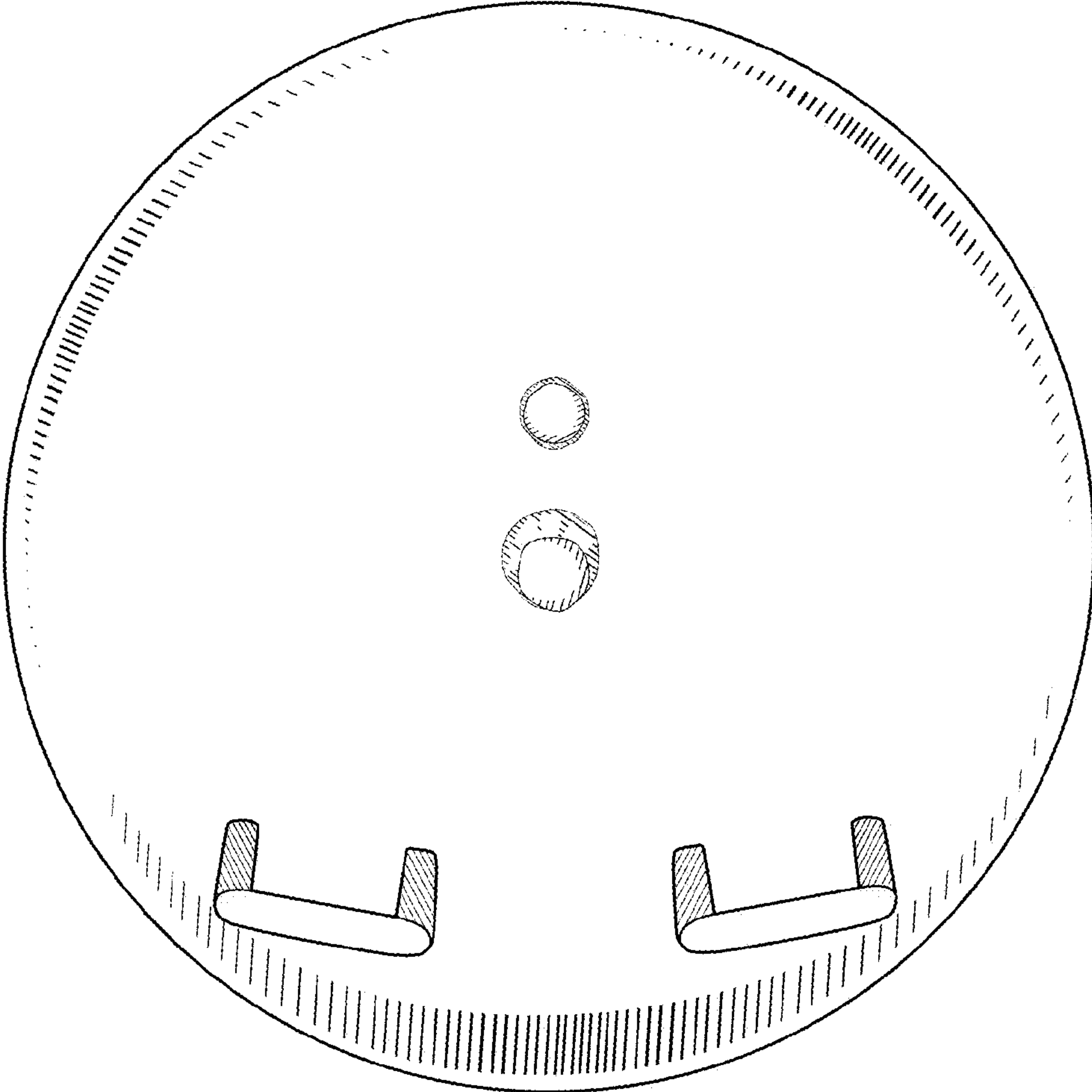

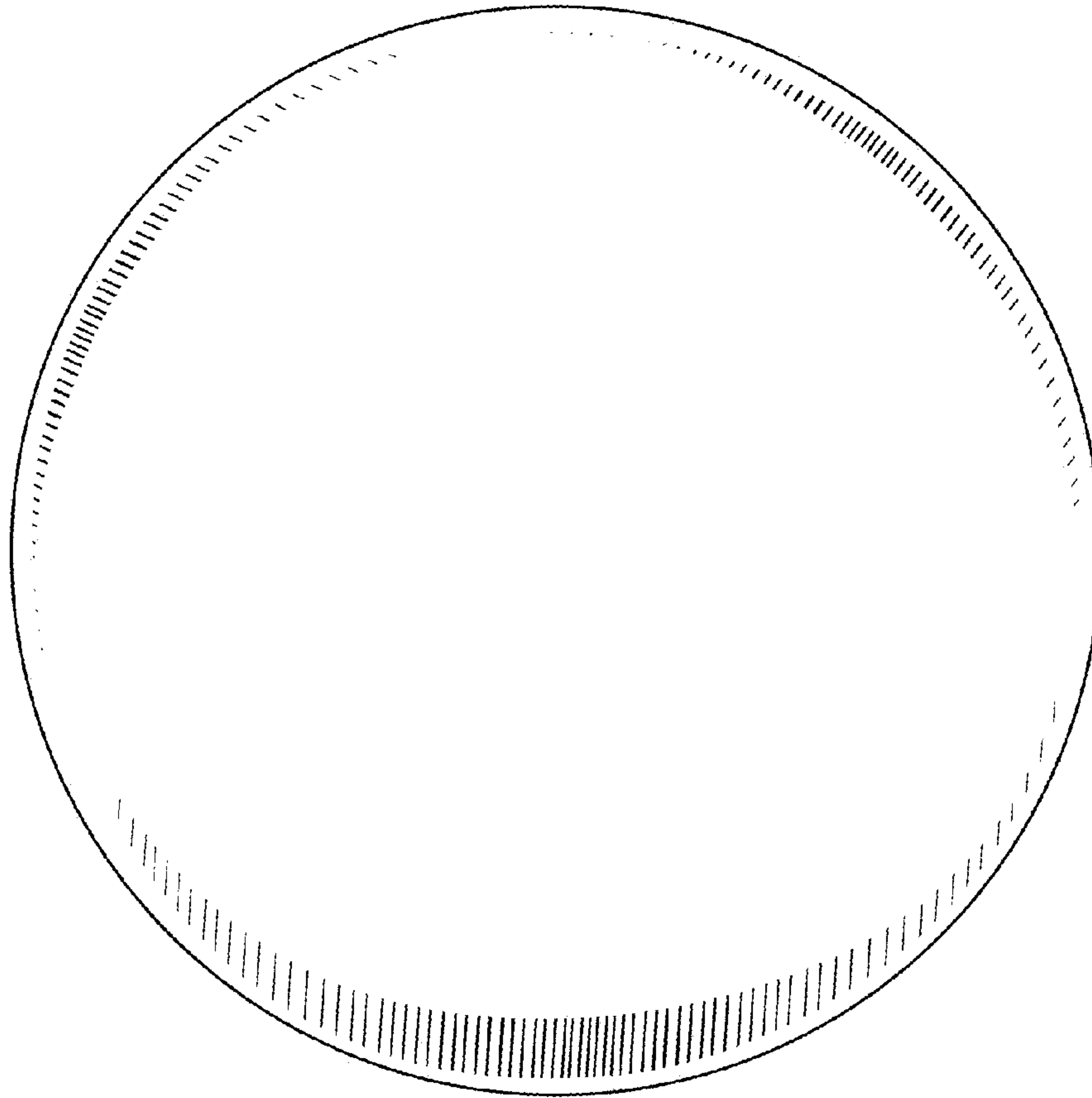

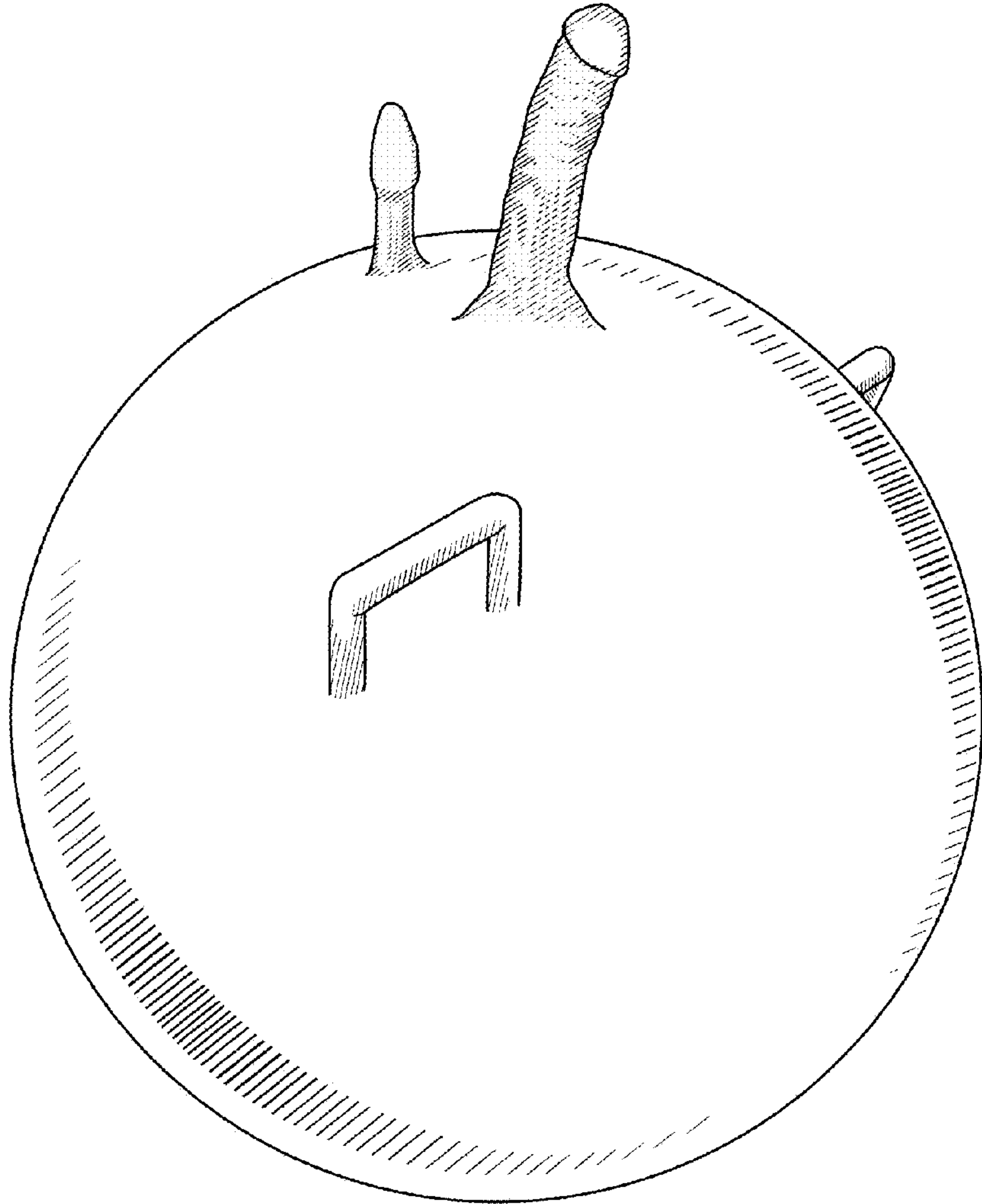

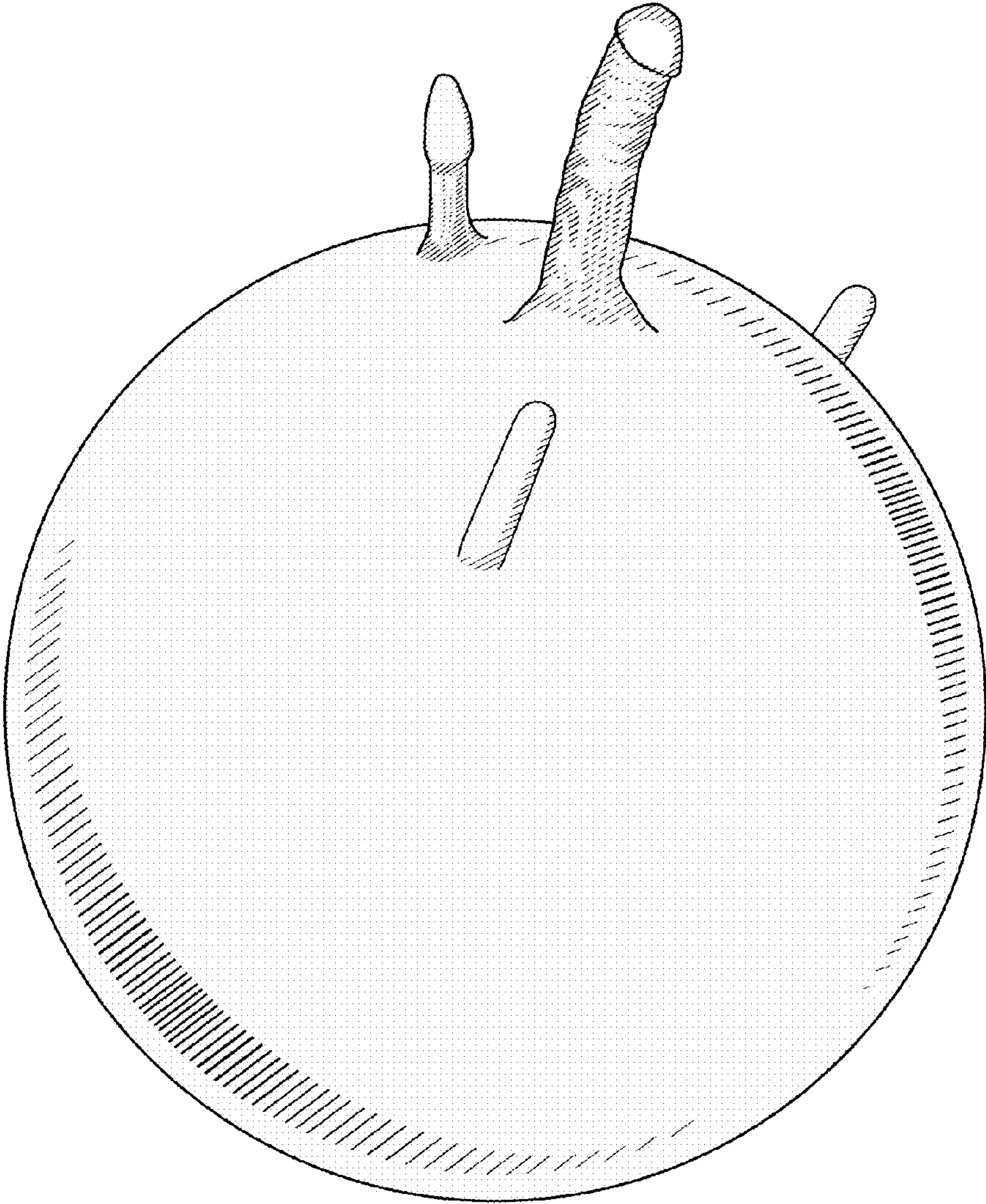

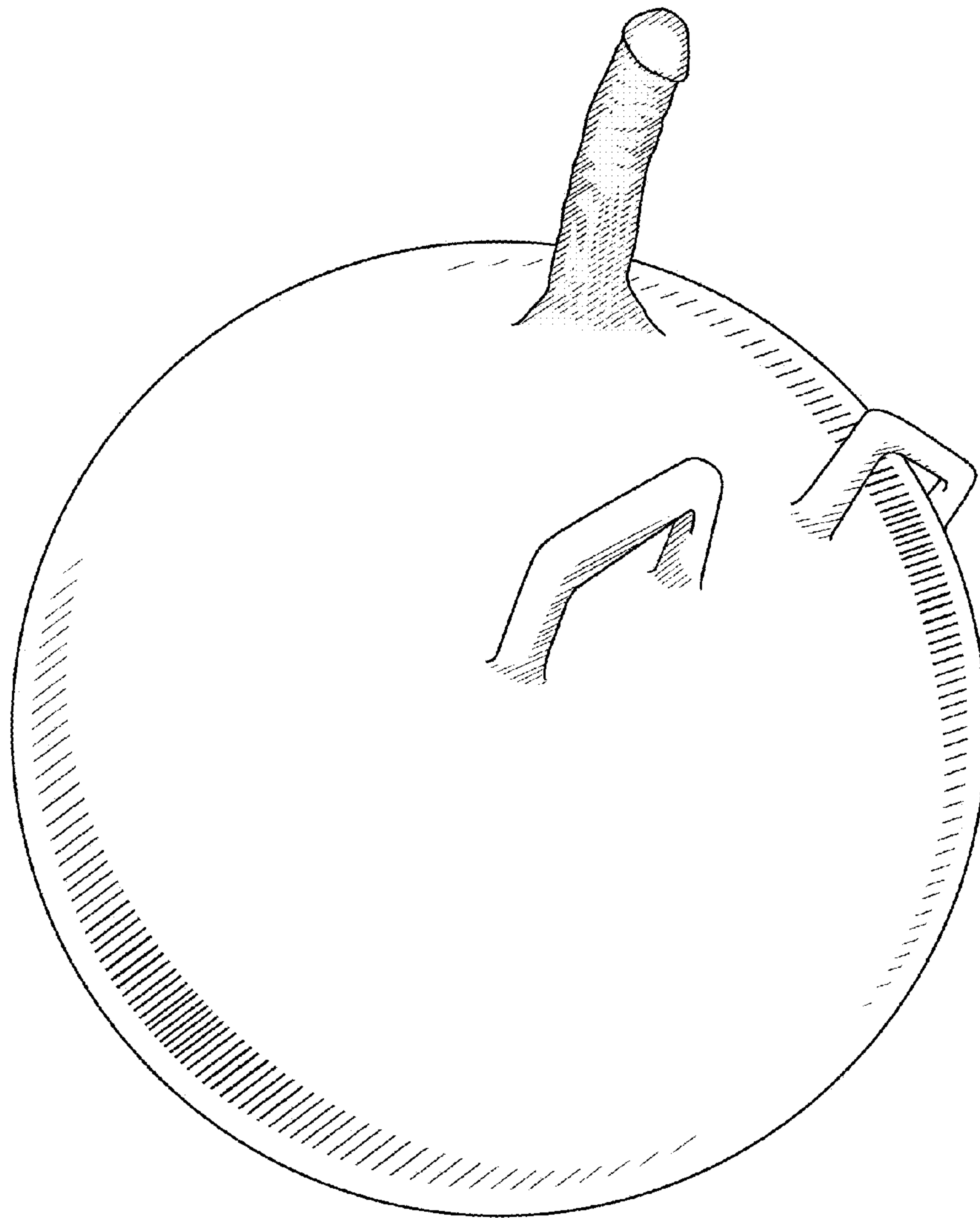

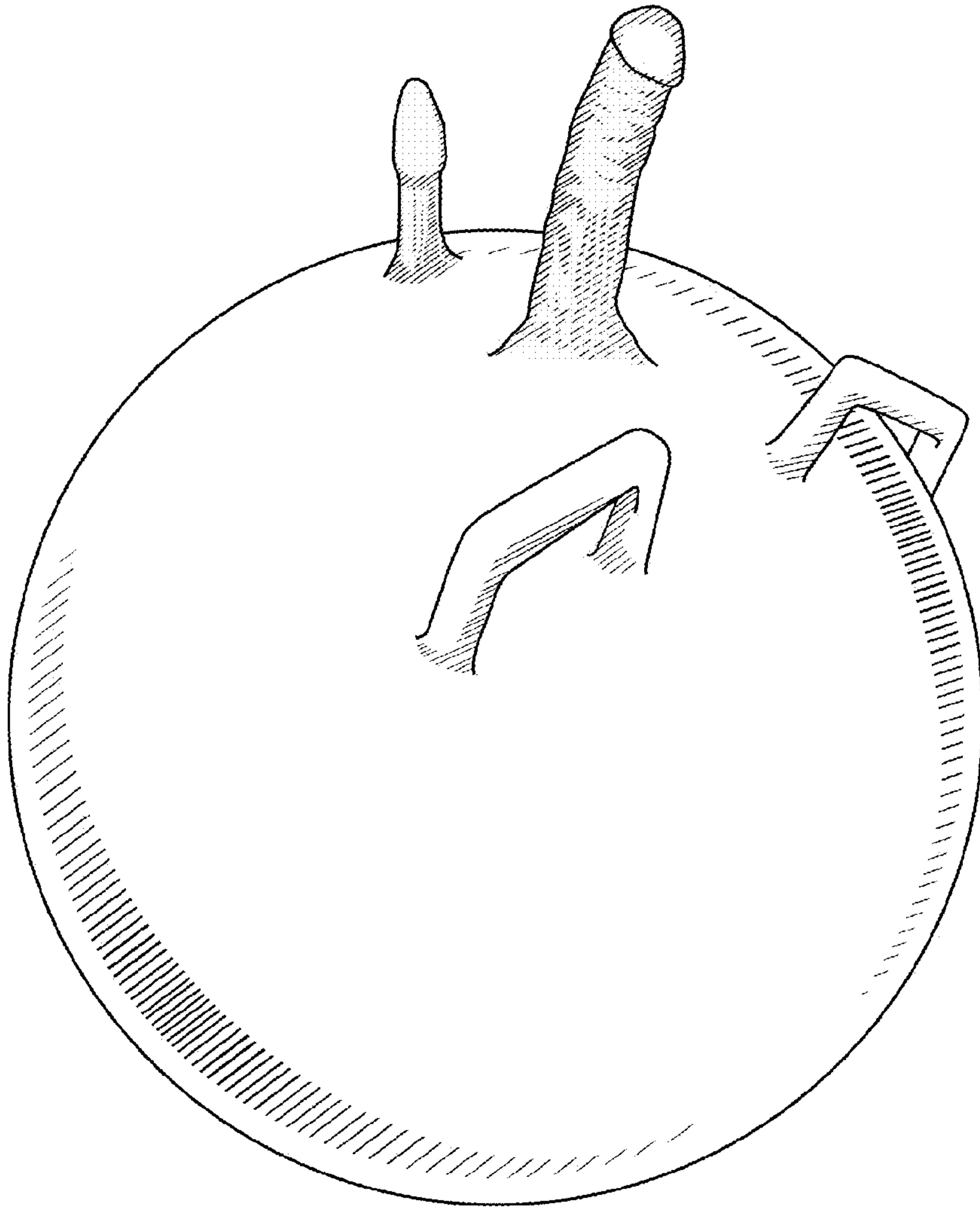

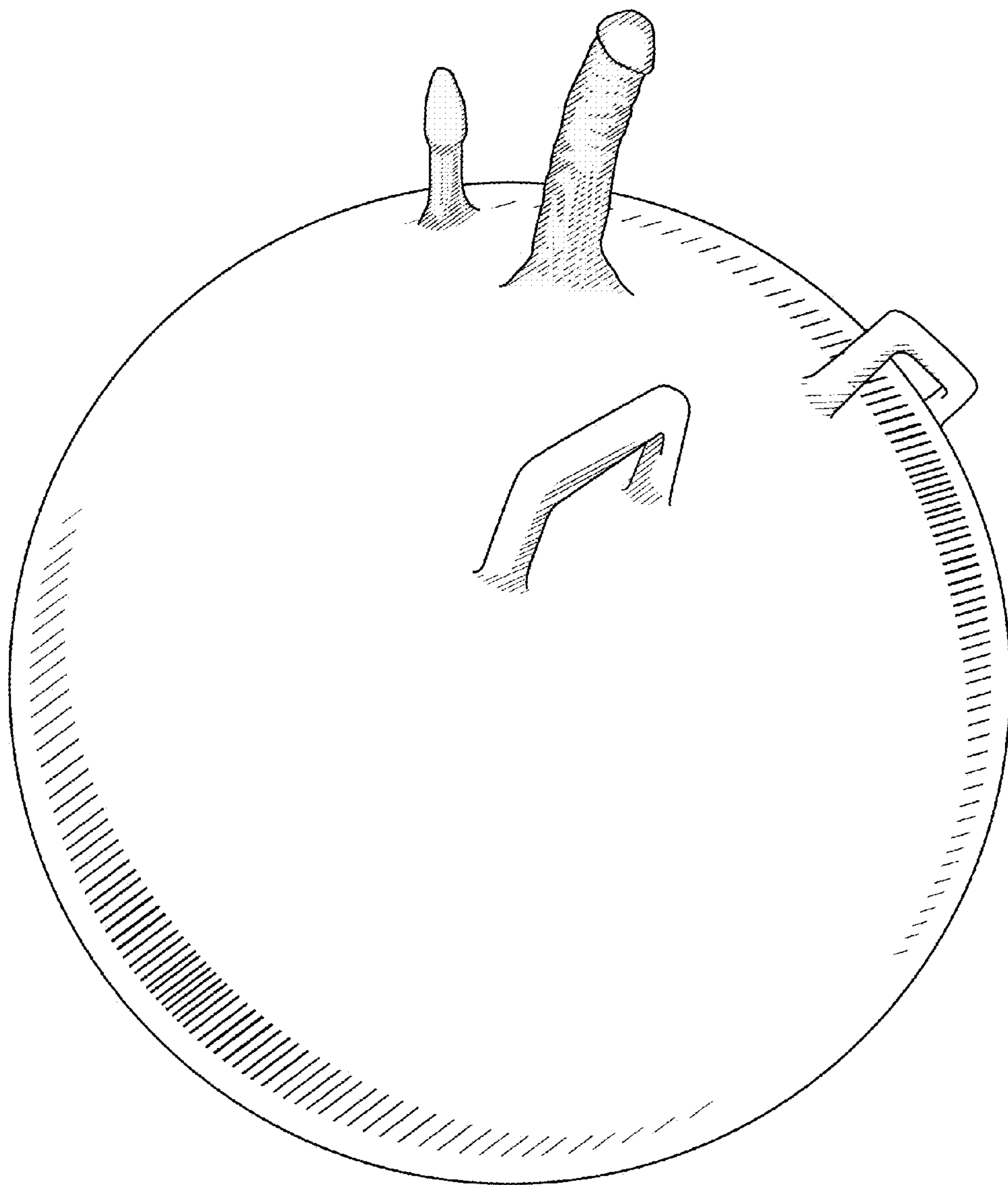

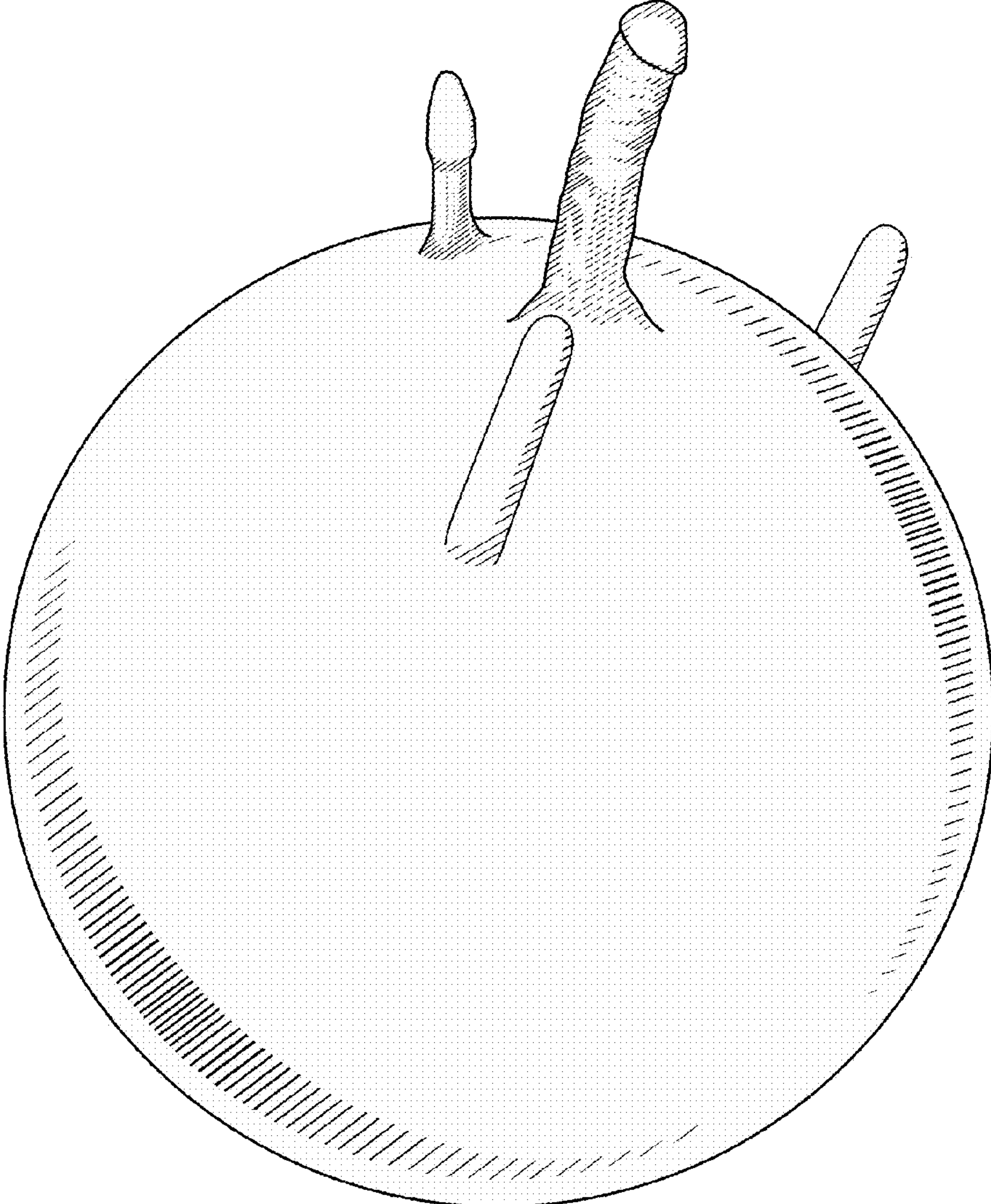
