The ornamental design for an edgelit garage luminaire, as shown and described.

**DESCRIPTION**

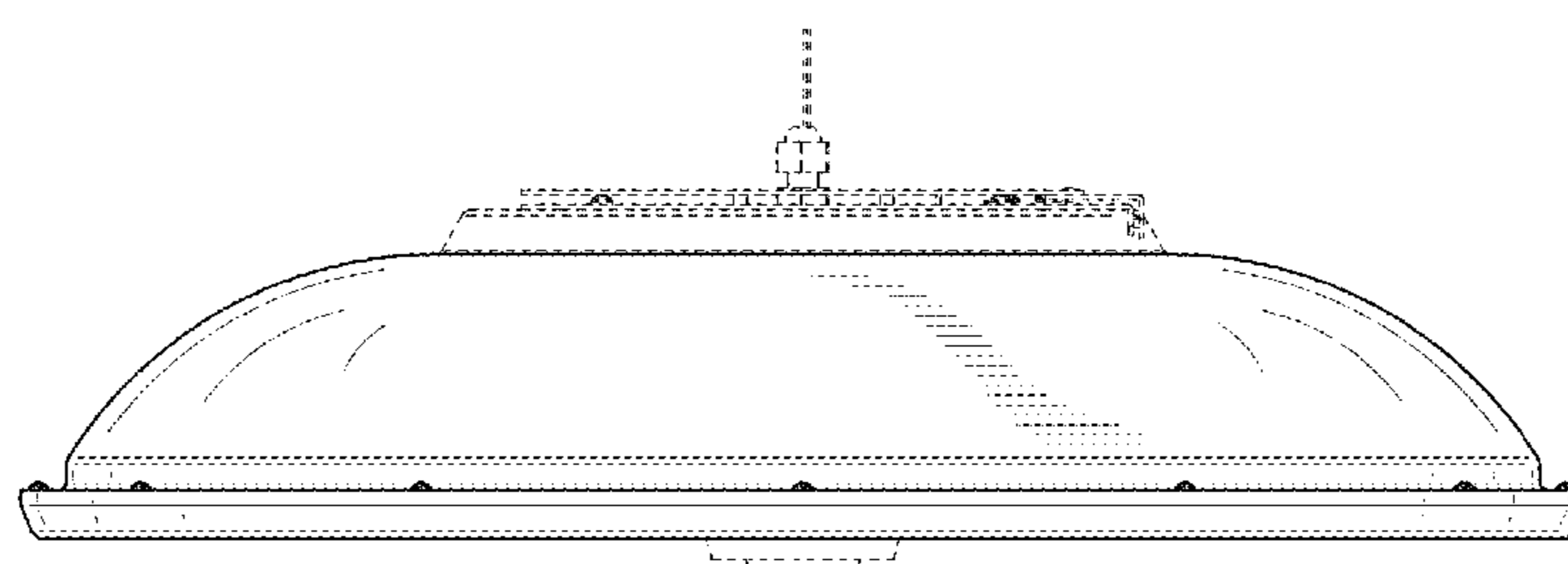
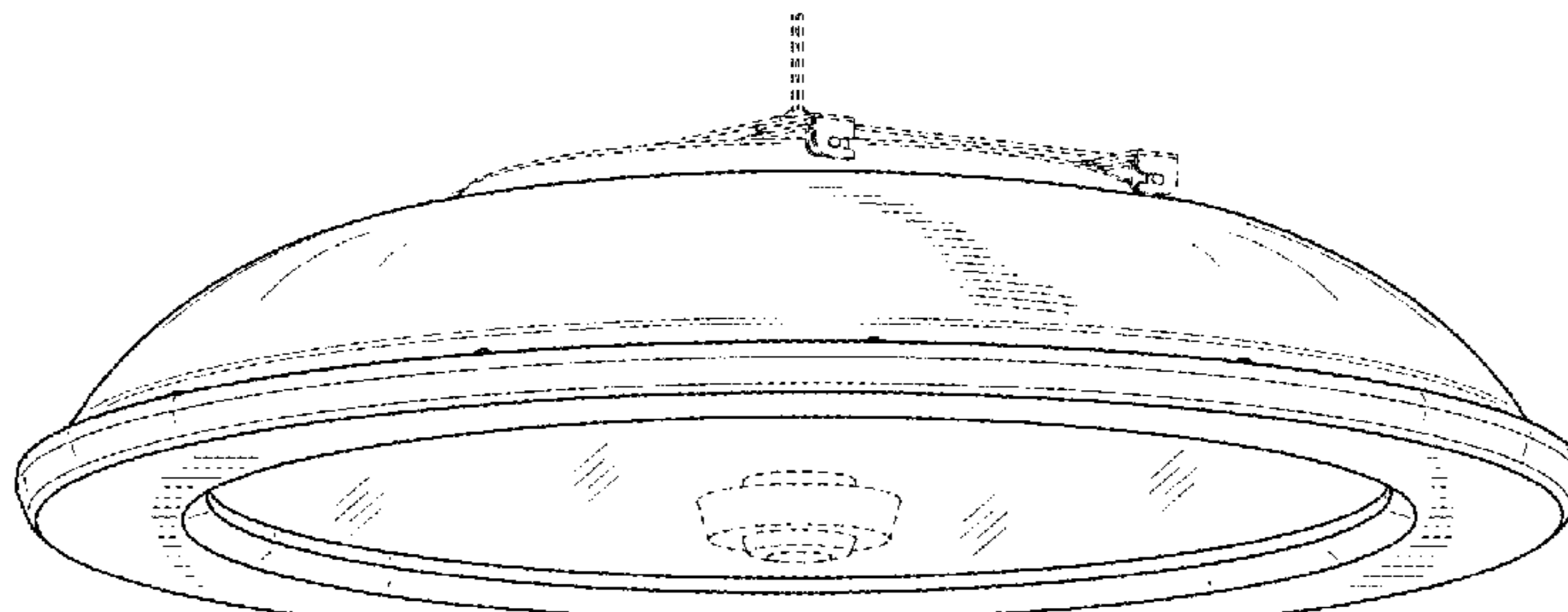

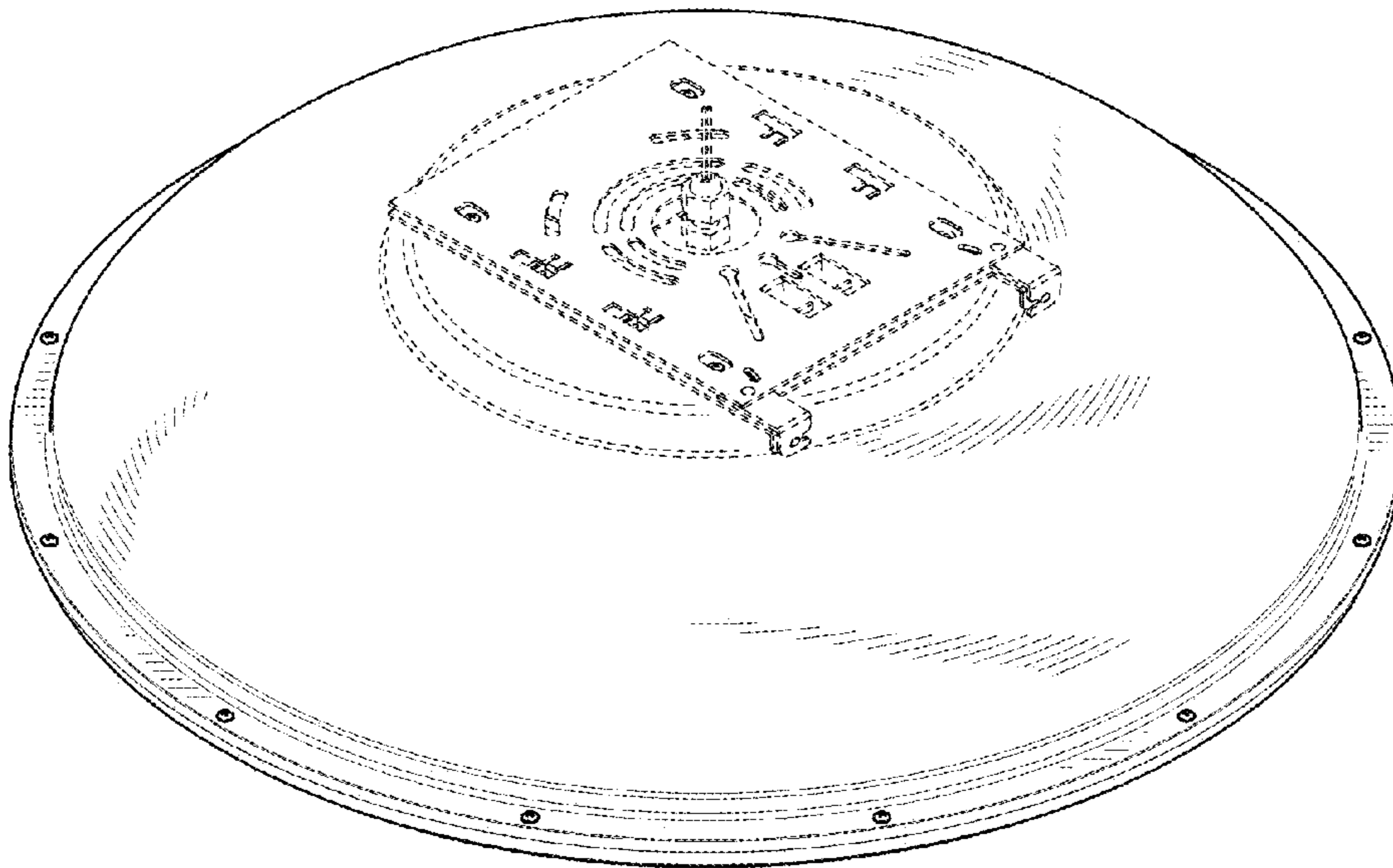

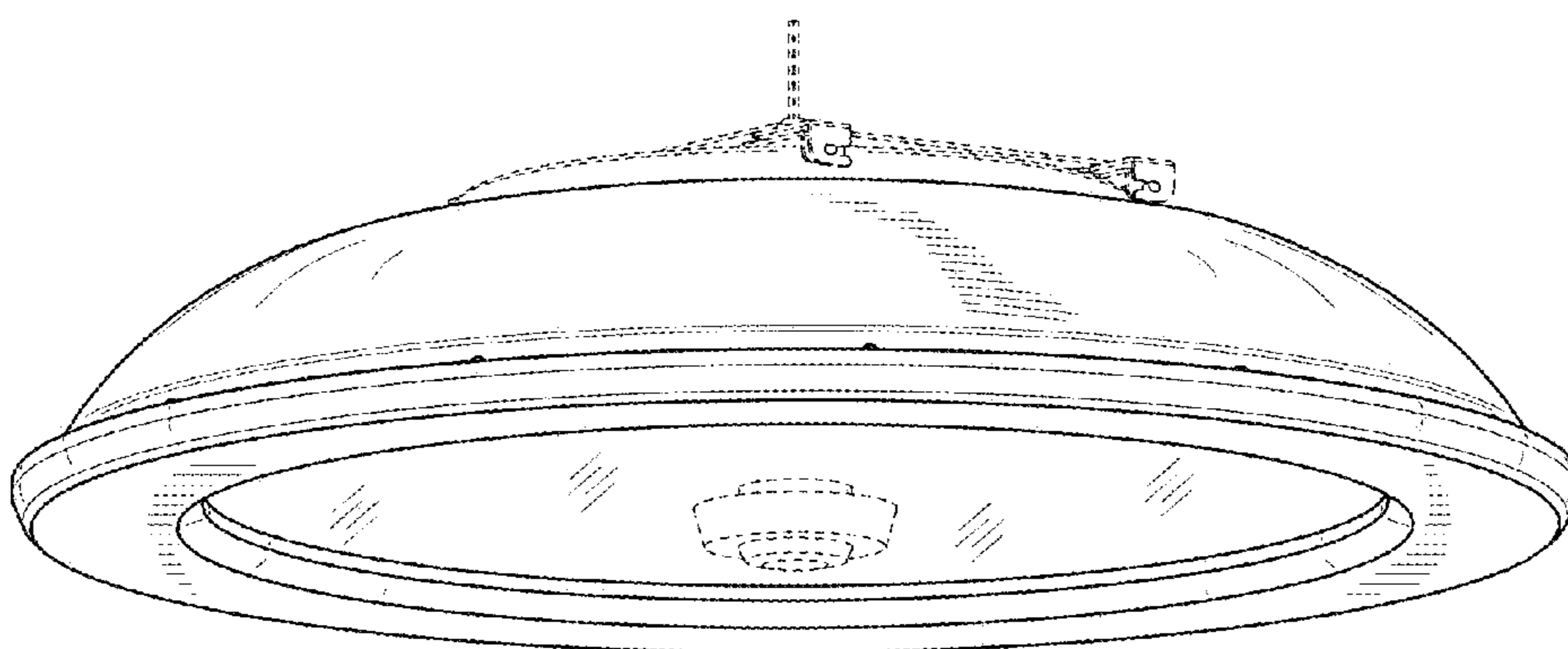

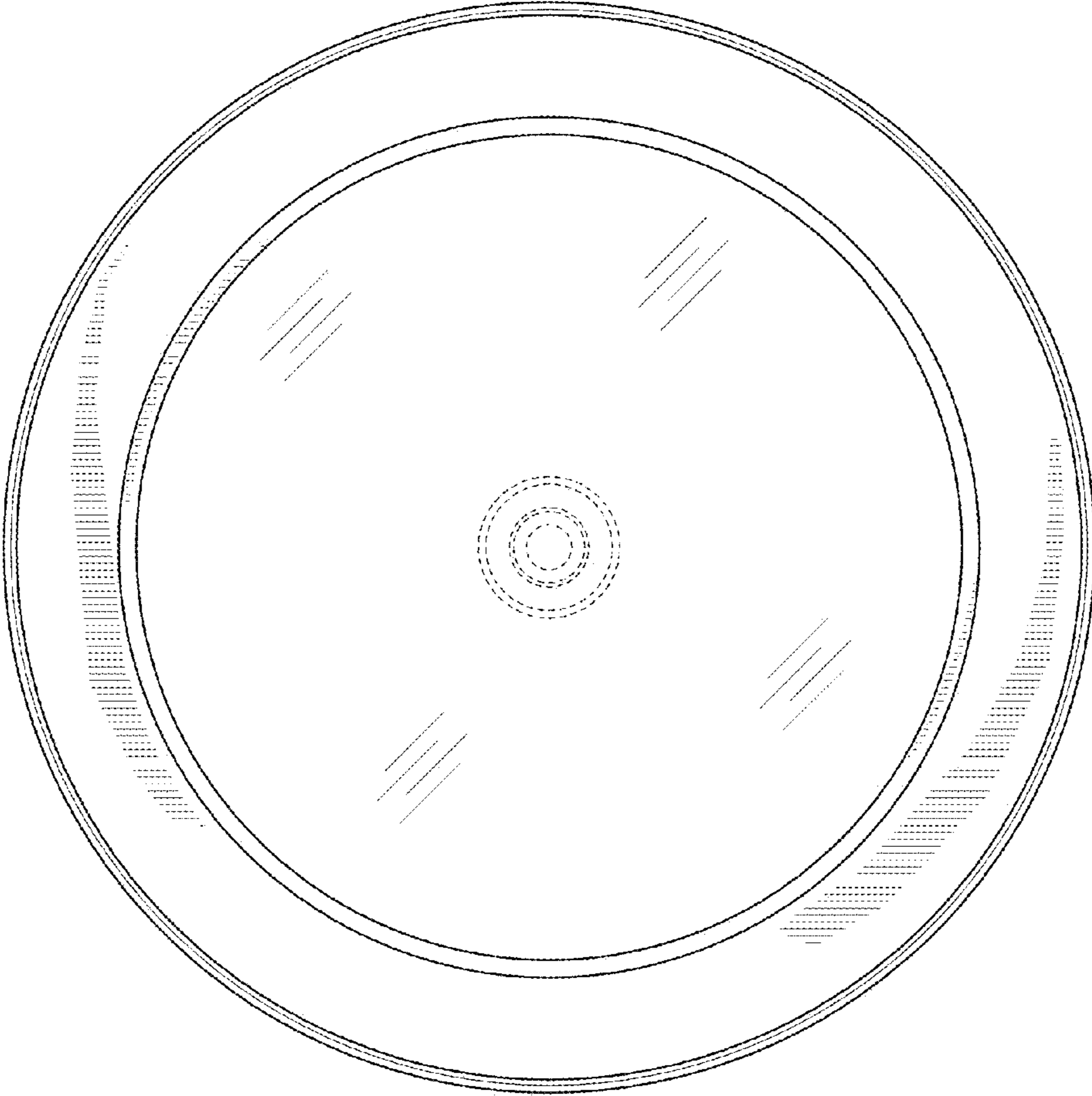

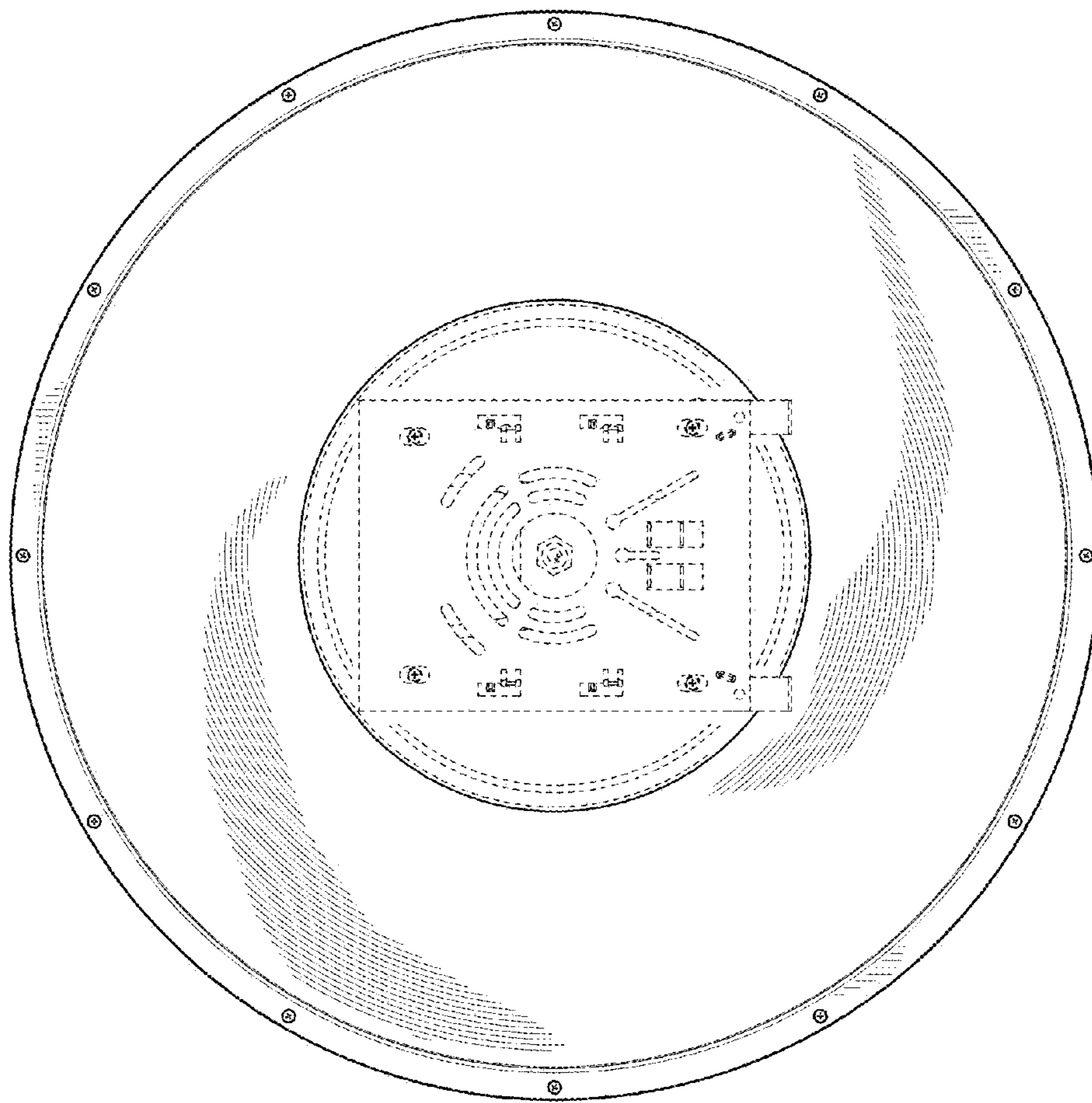

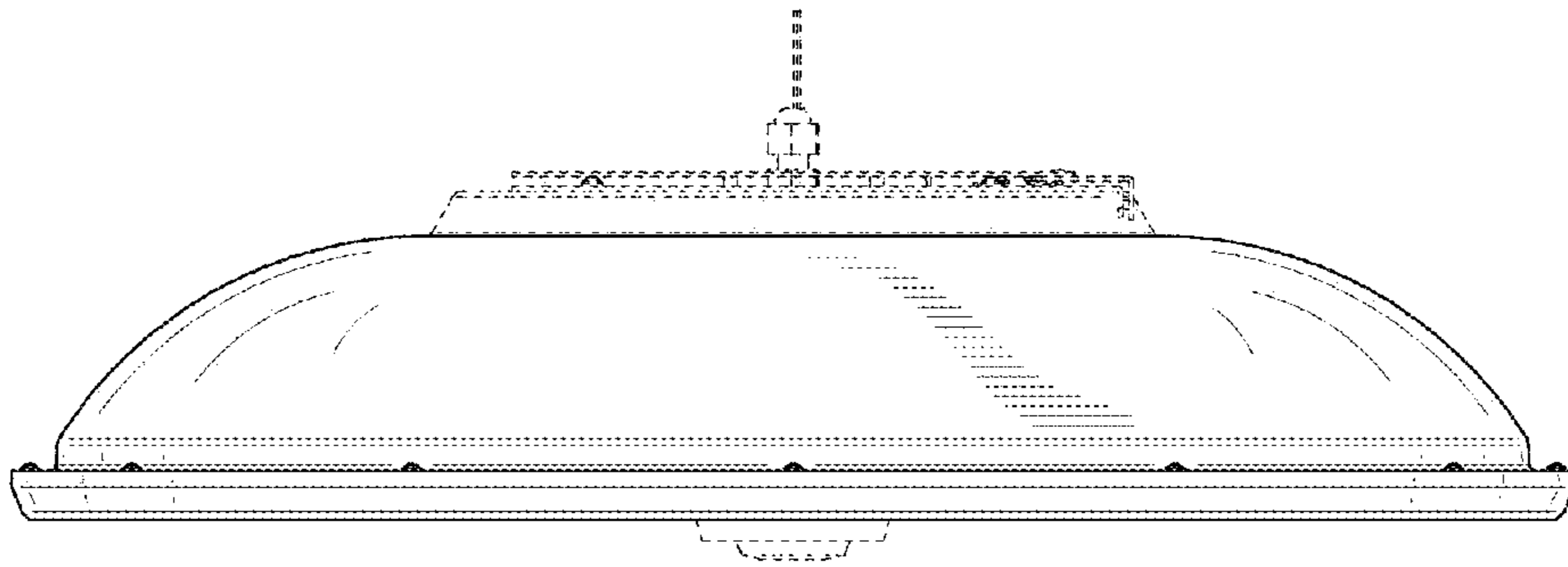

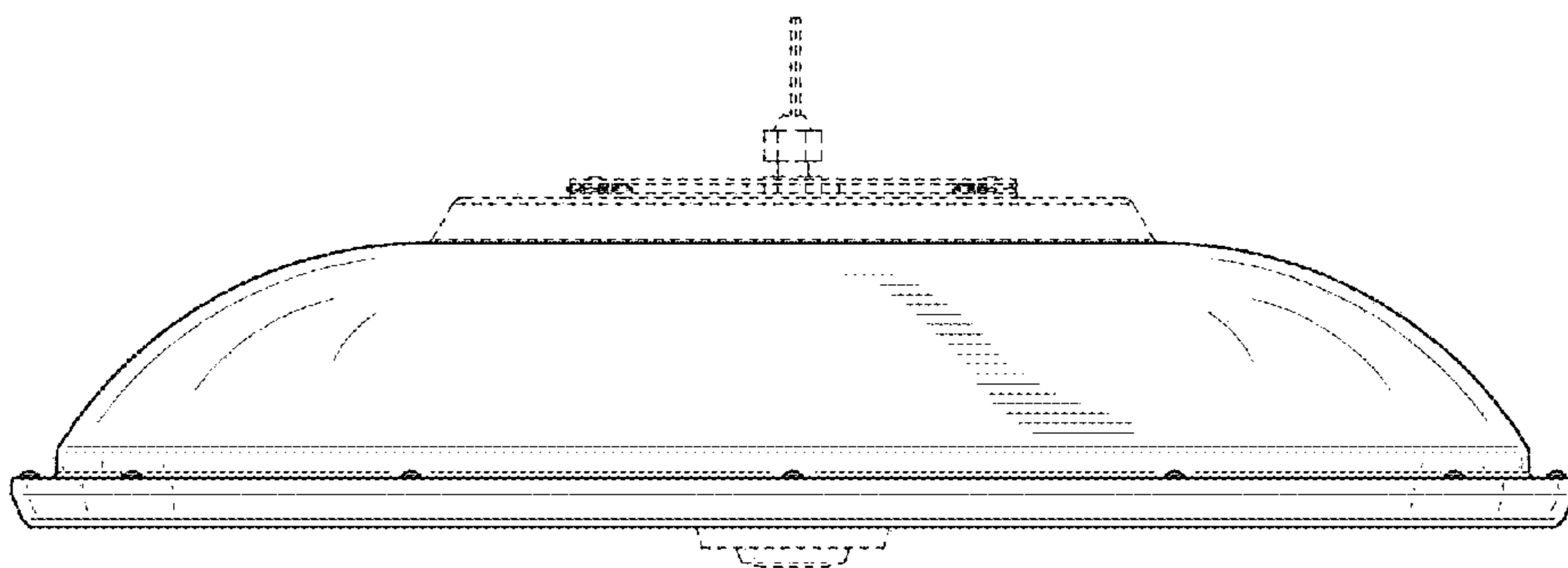

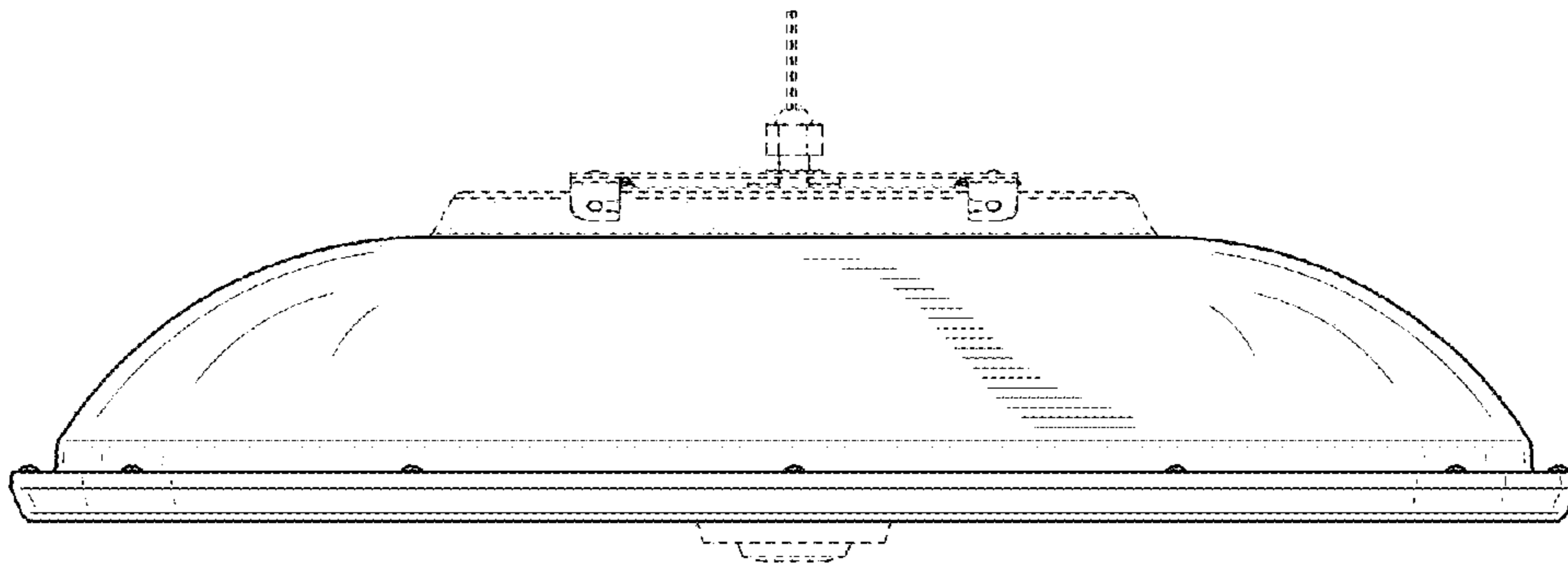
