The ornamental design for a medicine container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first medicine container depicted open and showing our design.

FIG. 2 is a front elevational view of the open medicine container of FIG. 1.

FIG. 3 is a rear view opposite the view of FIG. 2.

FIG. 4 is an end elevational view of the right end of FIG. 2.

FIG. 5 is an end elevational view of the left end of FIG. 2.

FIG. 6 is a top plan view of the open container of FIG. 1.

FIG. 7 is a bottom plan view of the open container of FIG. 1.

FIG. 8 is a top perspective view of a second medicine container depicted open and showing our design.

FIG. 9 is a front elevational view of the medicine container of FIG. 8.

FIG. 10 is a rear view opposite the view of FIG. 9.

FIG. 11 is an end elevational view of the right end of FIG. 8.

FIG. 12 is an end elevational view of the left end of FIG. 8.

FIG. 13 is a top plan view of the open container of FIG. 8.

FIG. 14 is a bottom plan view of the open container of FIG. 8.

FIG. 15 is a top perspective view of a third medicine container depicted open and showing our design.

FIG. 16 is a front elevational view of the open medicine container of FIG. 15.

FIG. 17 is a rear view opposite the view of FIG. 16.

FIG. 18 is an end elevational view of the right end of FIG. 17.

FIG. 19 is an end elevational view of the left end of FIG. 17.

FIG. 20 is a top plan view of the open container of FIG. 15; and,

FIG. 21 is a bottom plan view of the open container of FIG. 15.

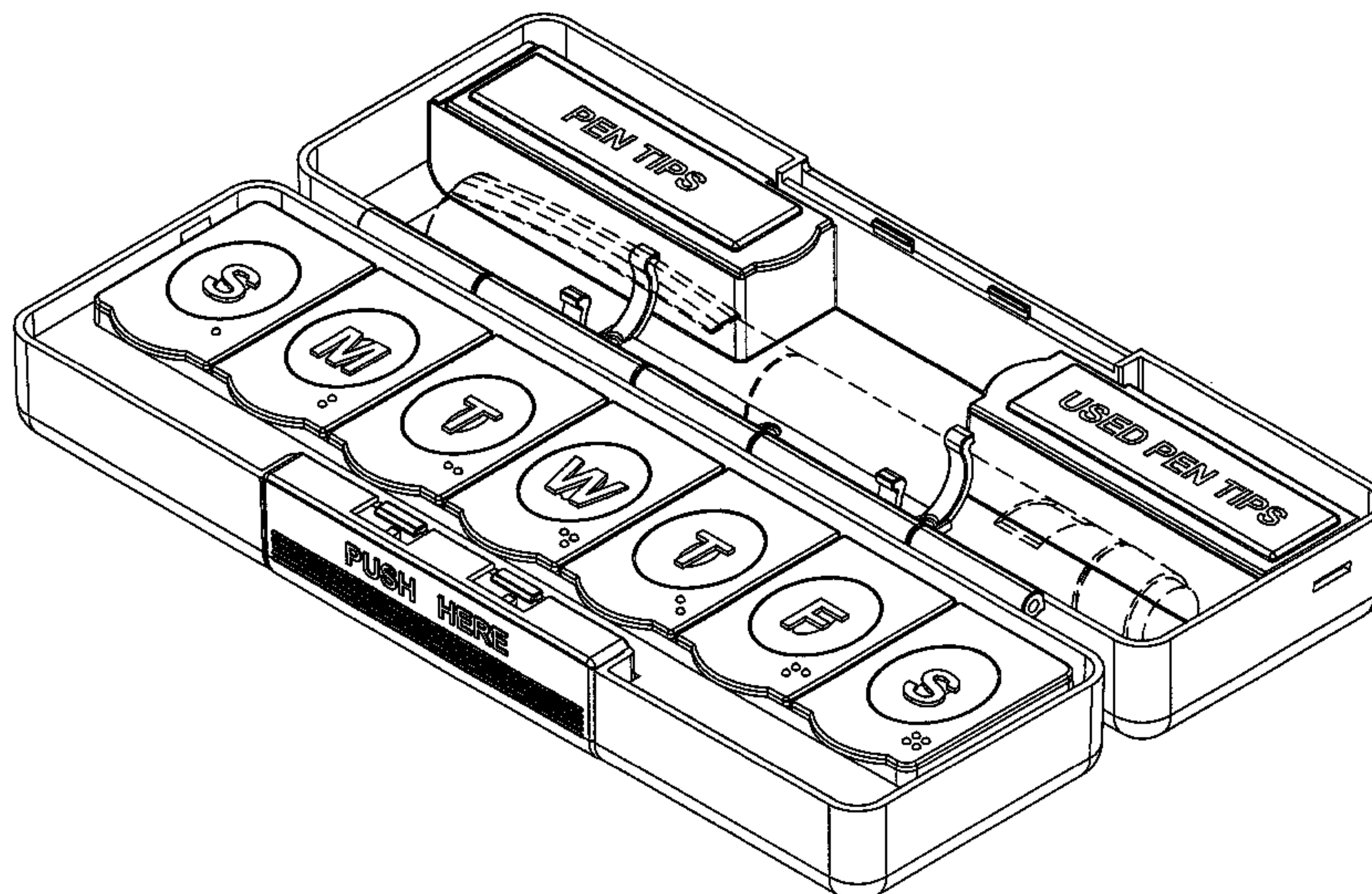

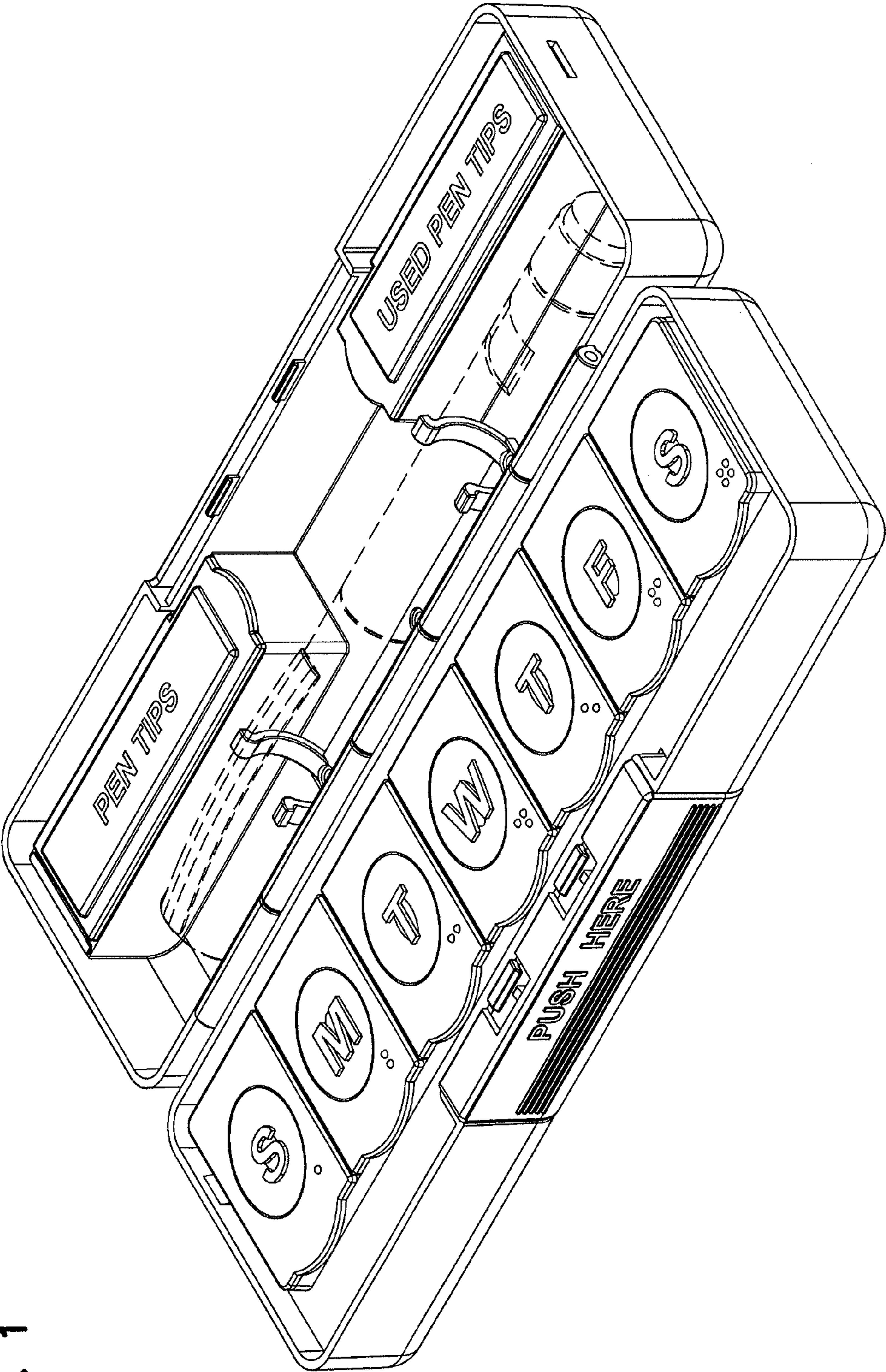

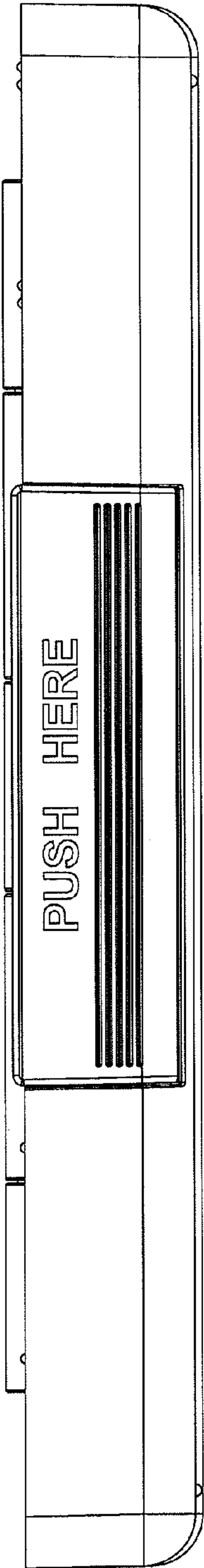

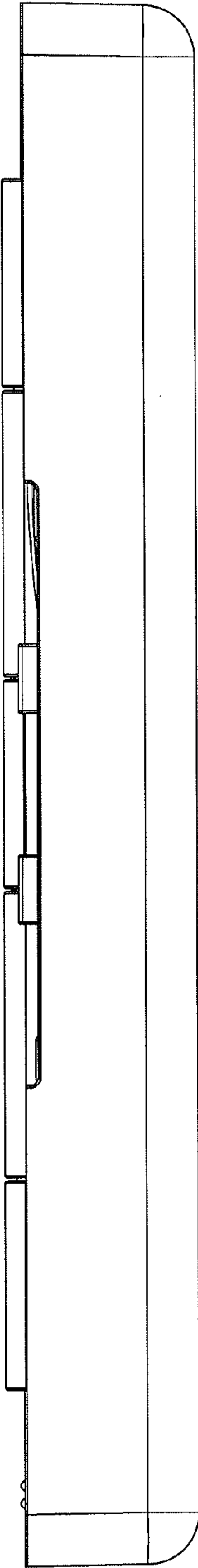

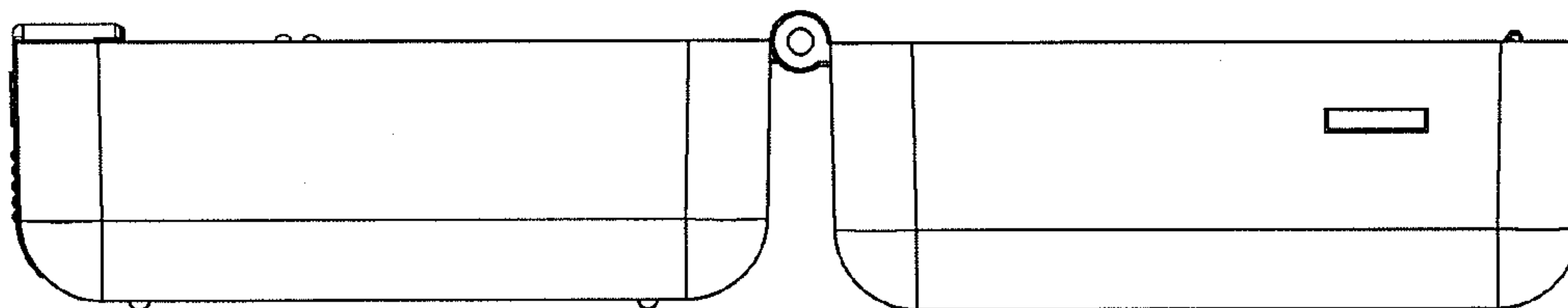

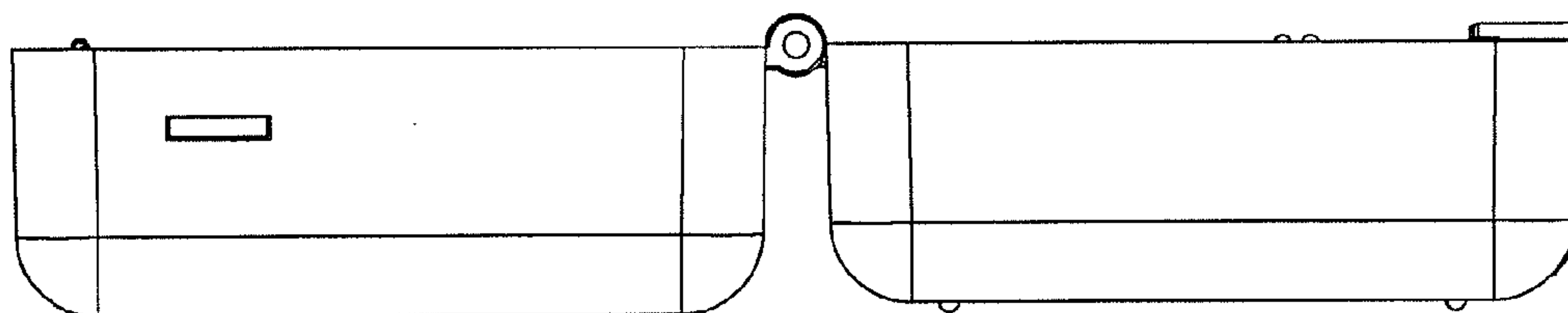
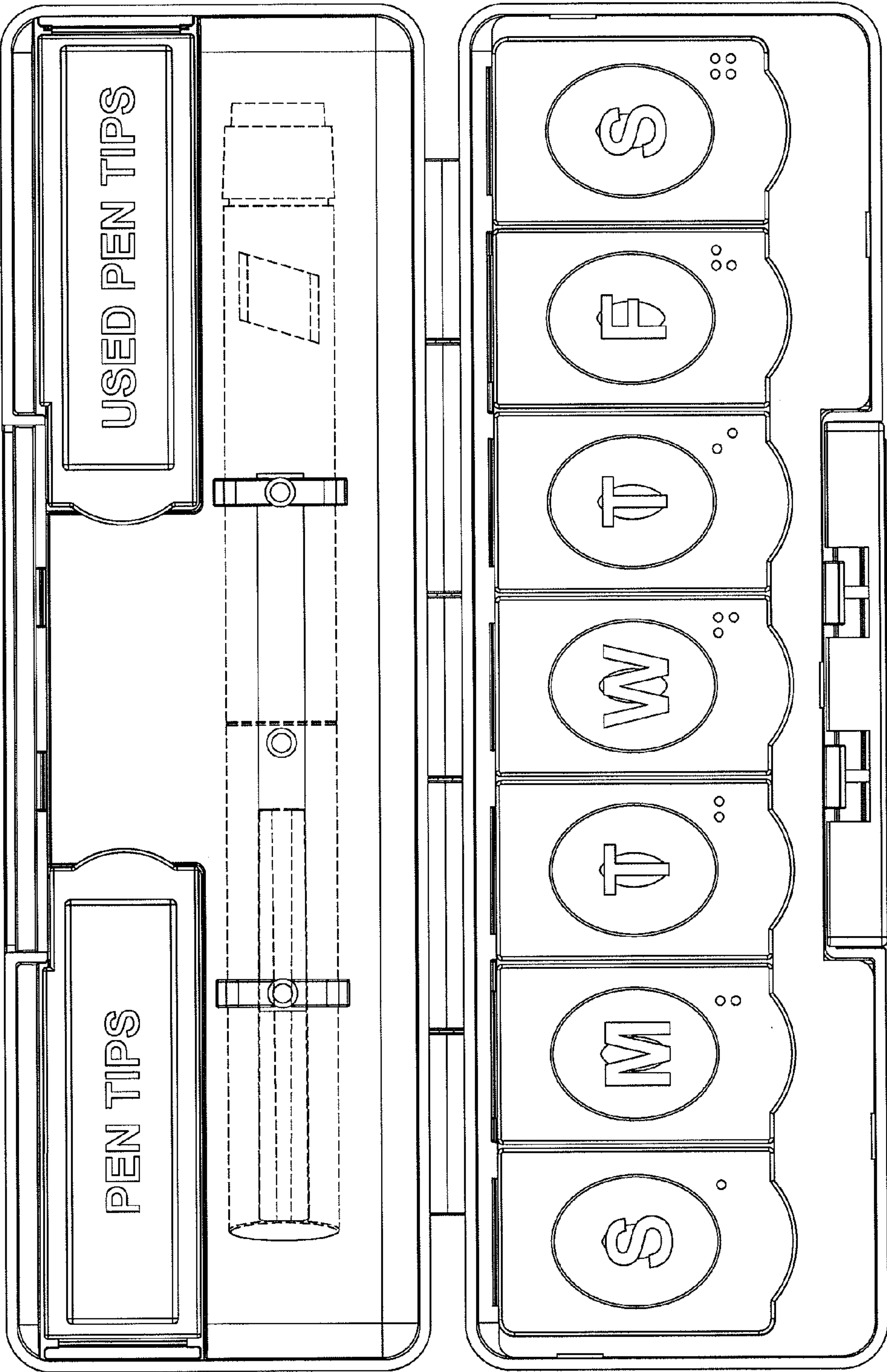
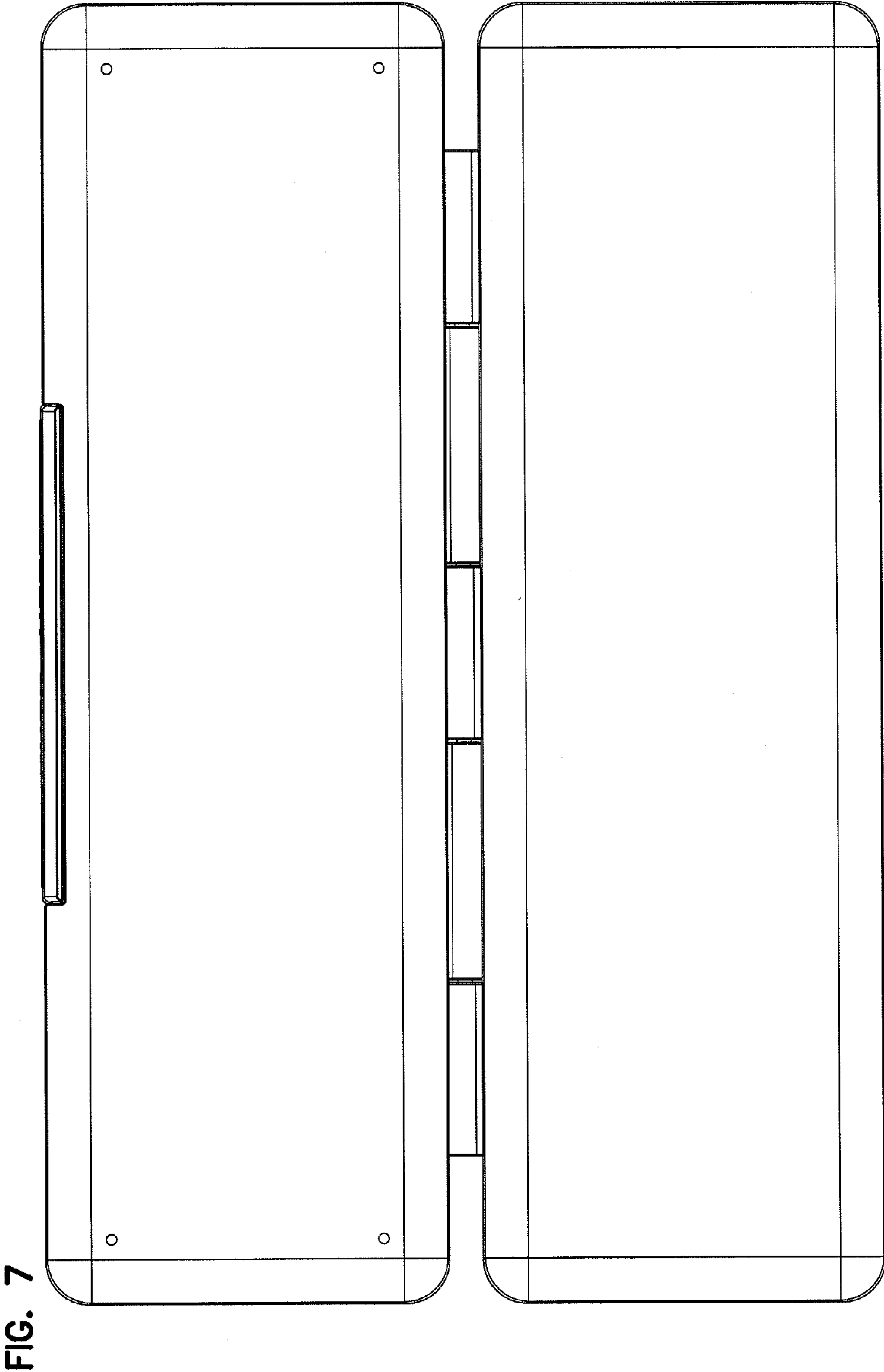

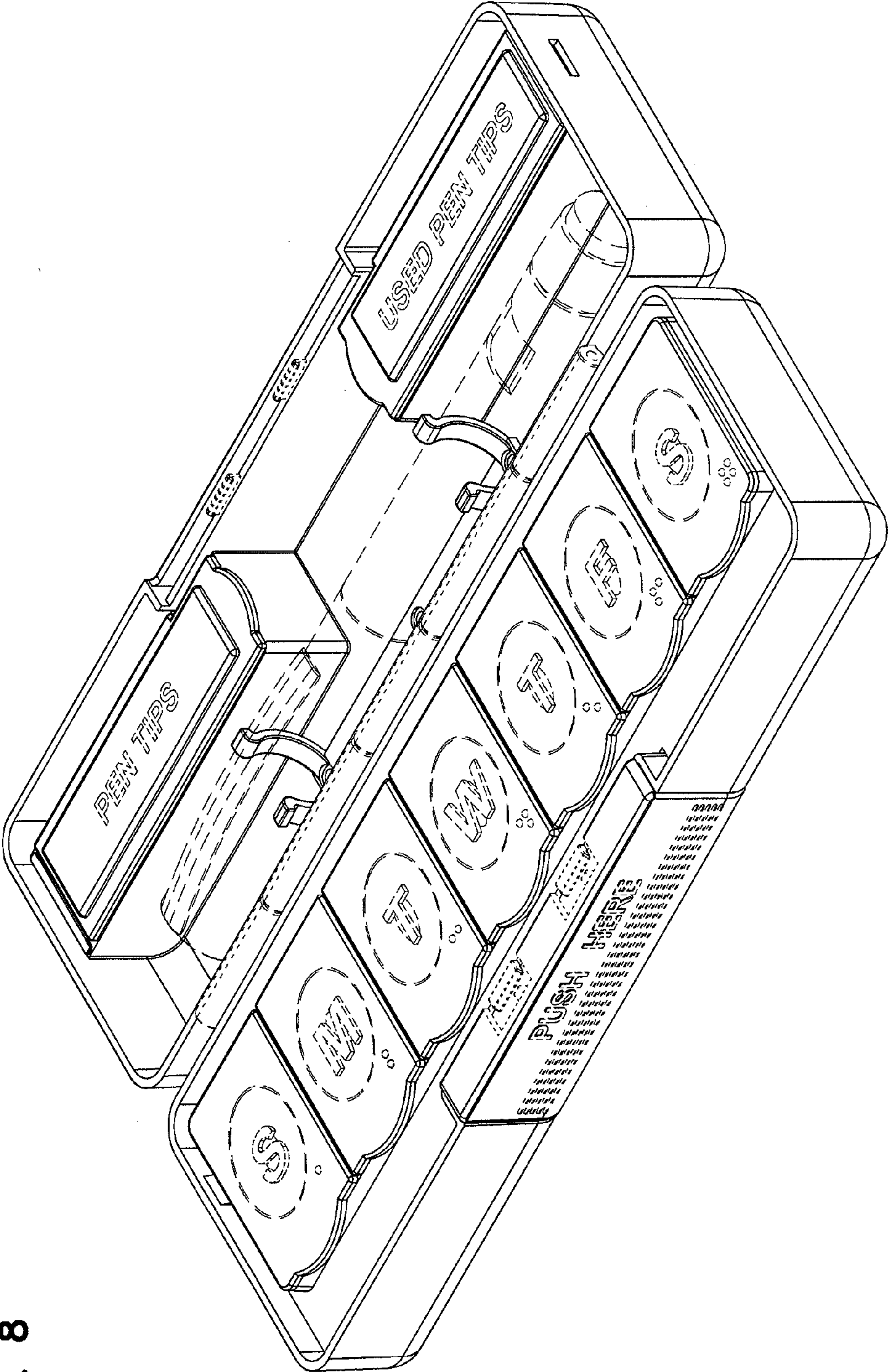

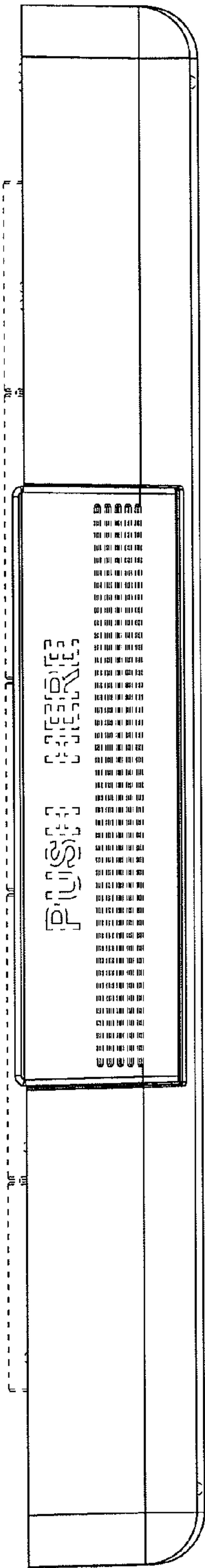

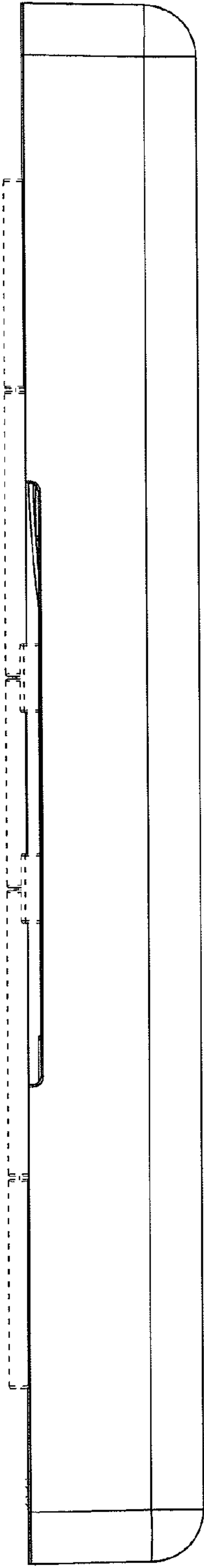

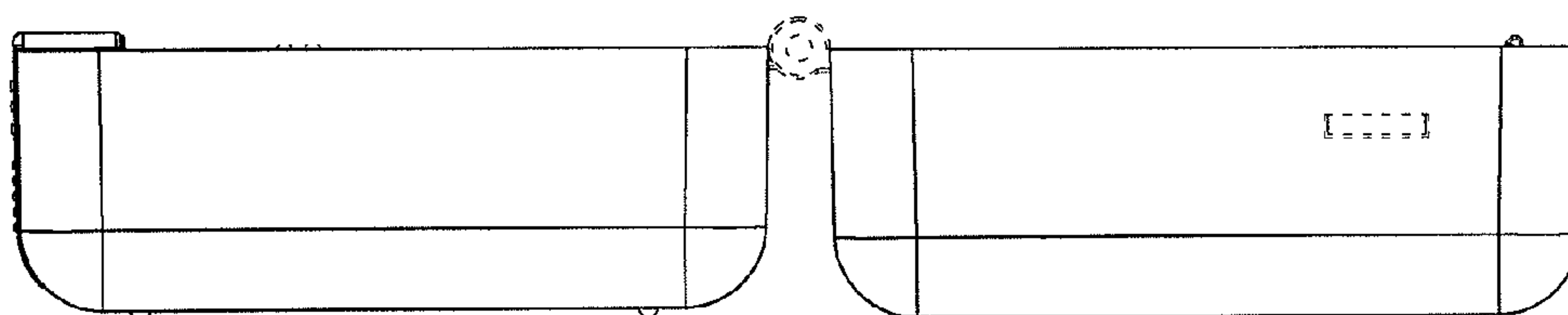

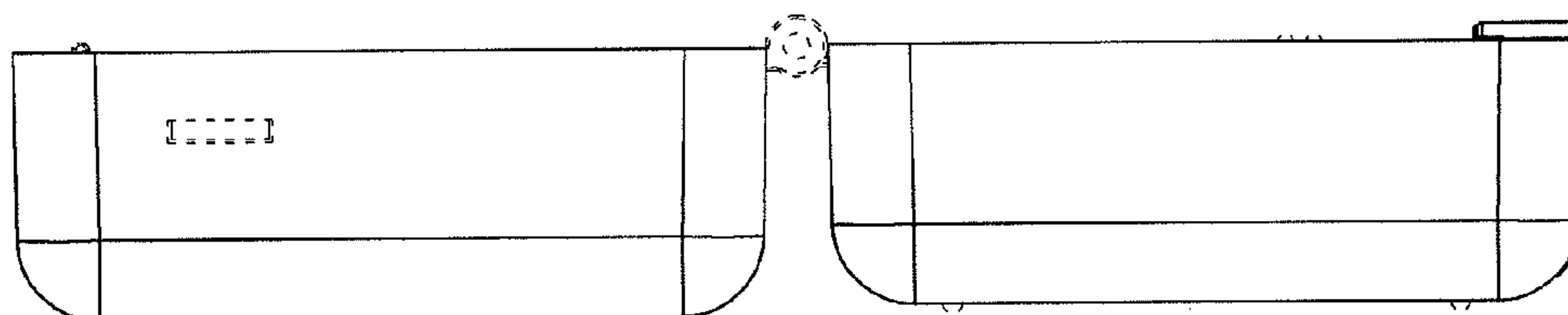

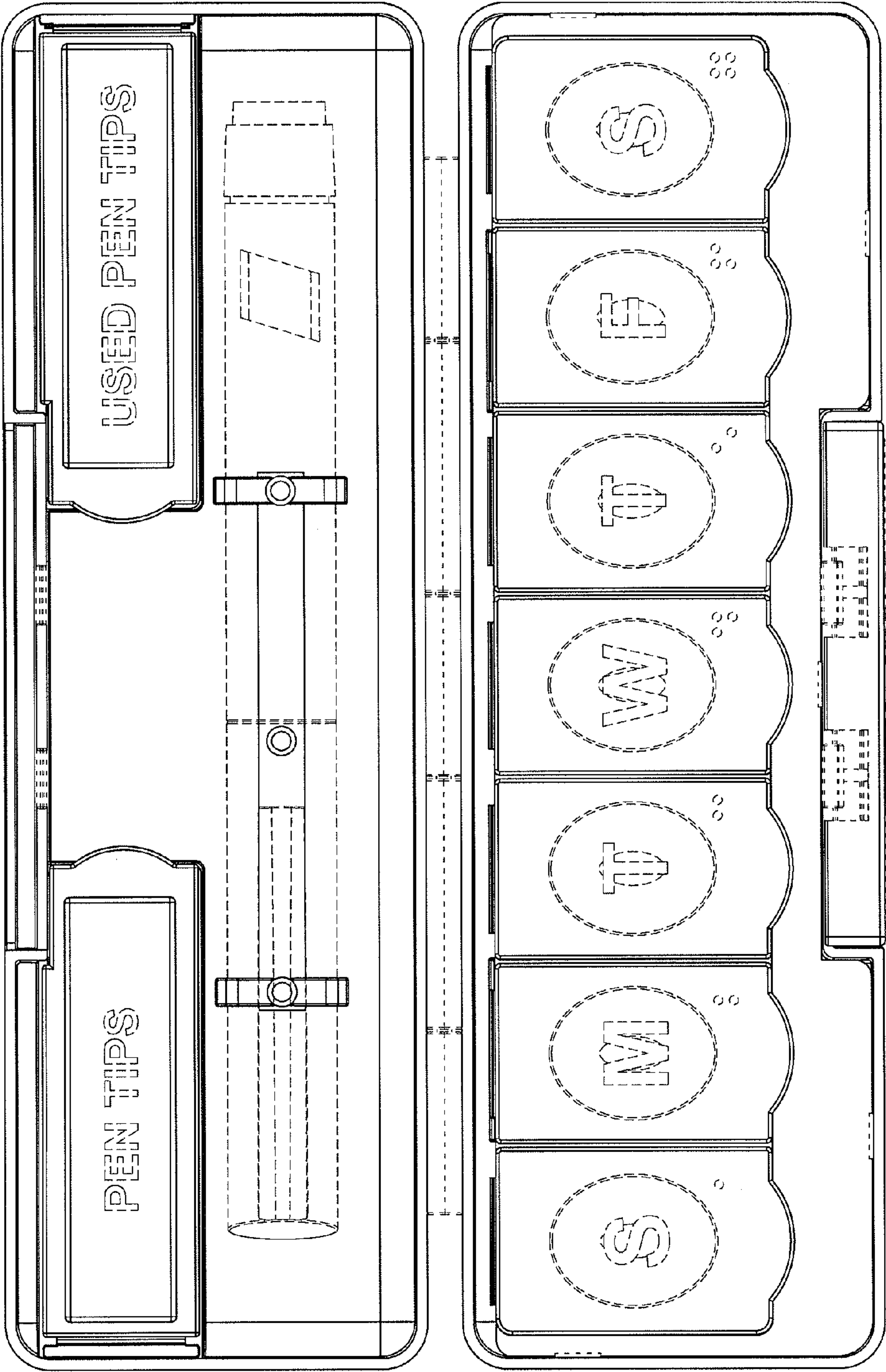
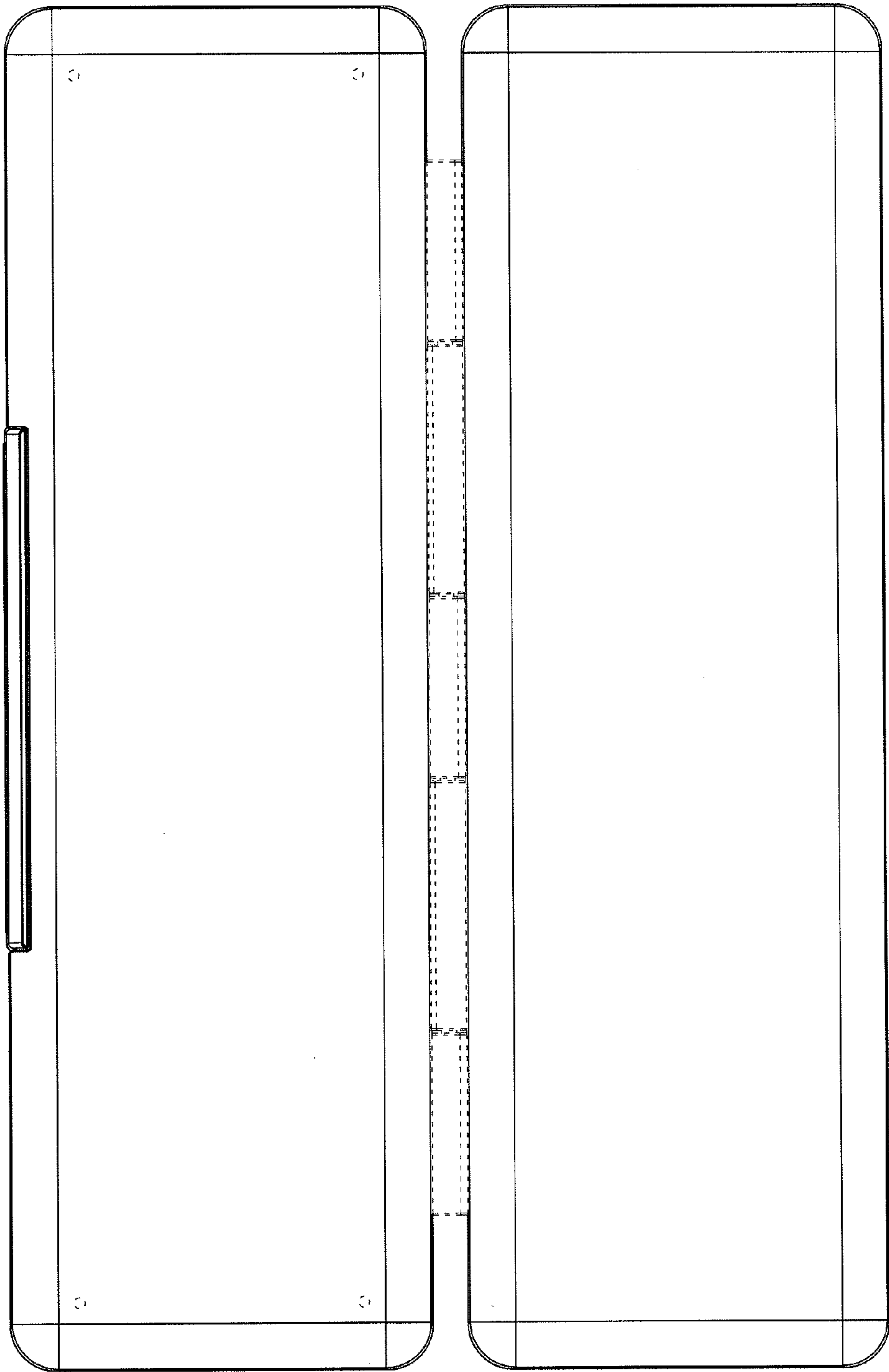

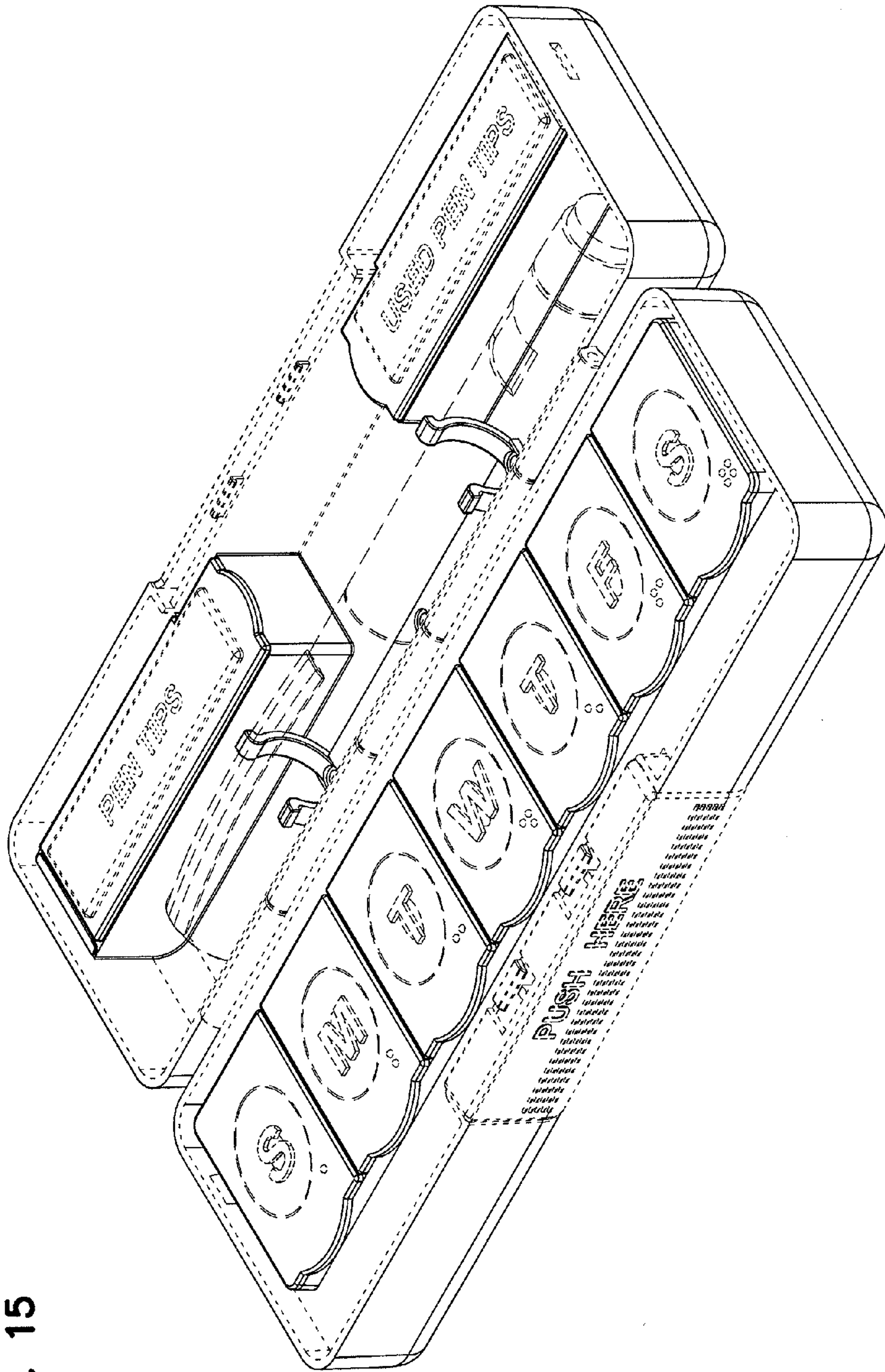

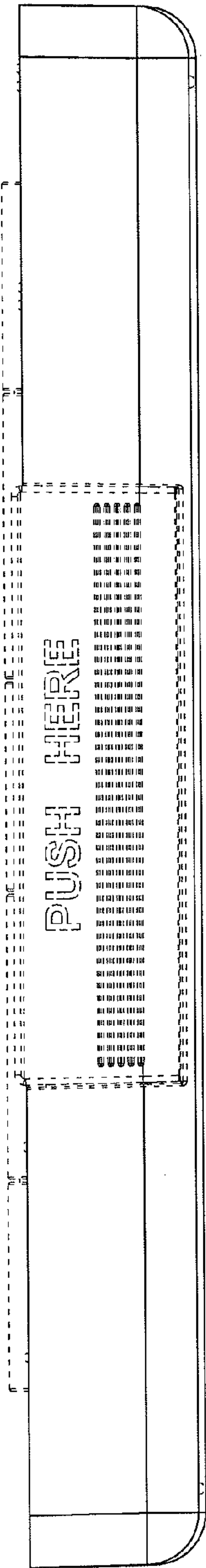

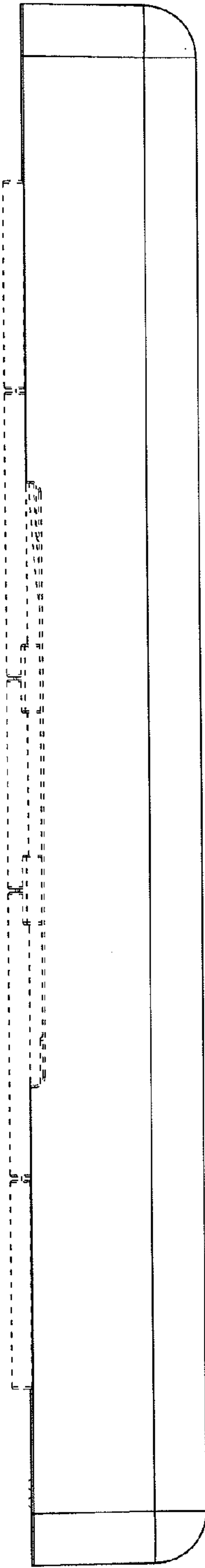

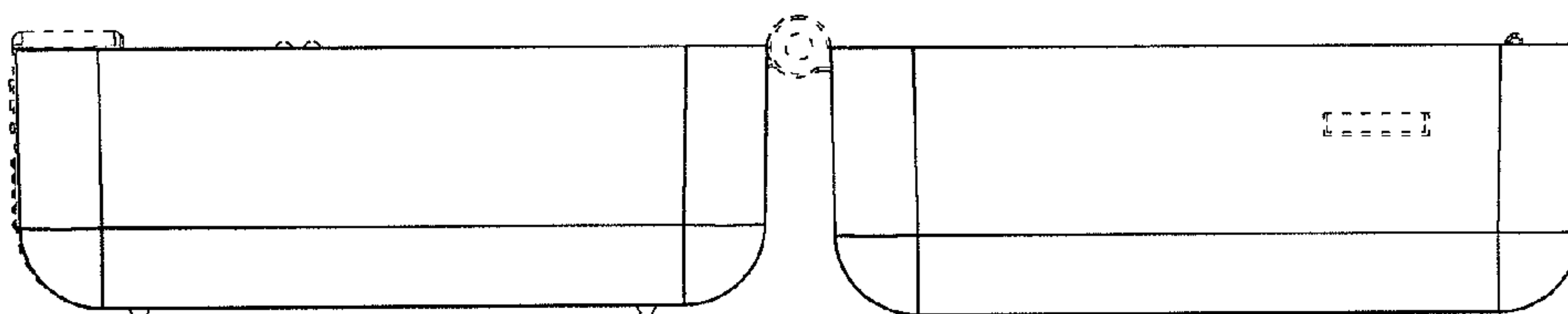

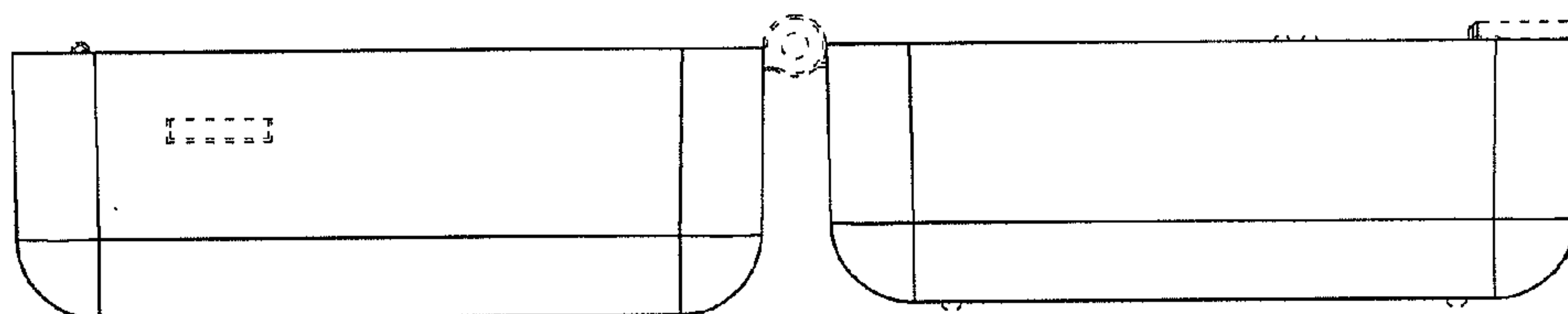

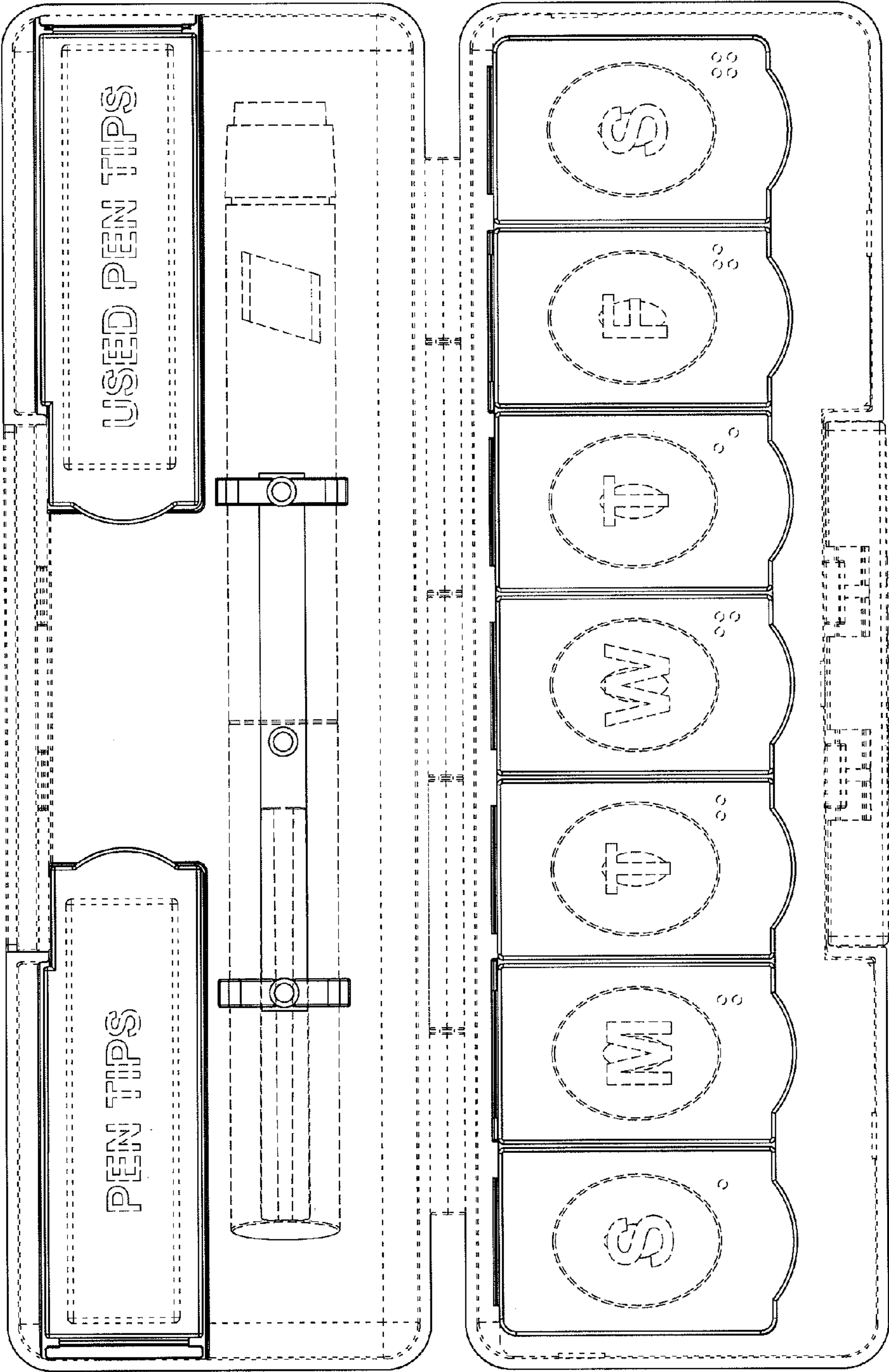
