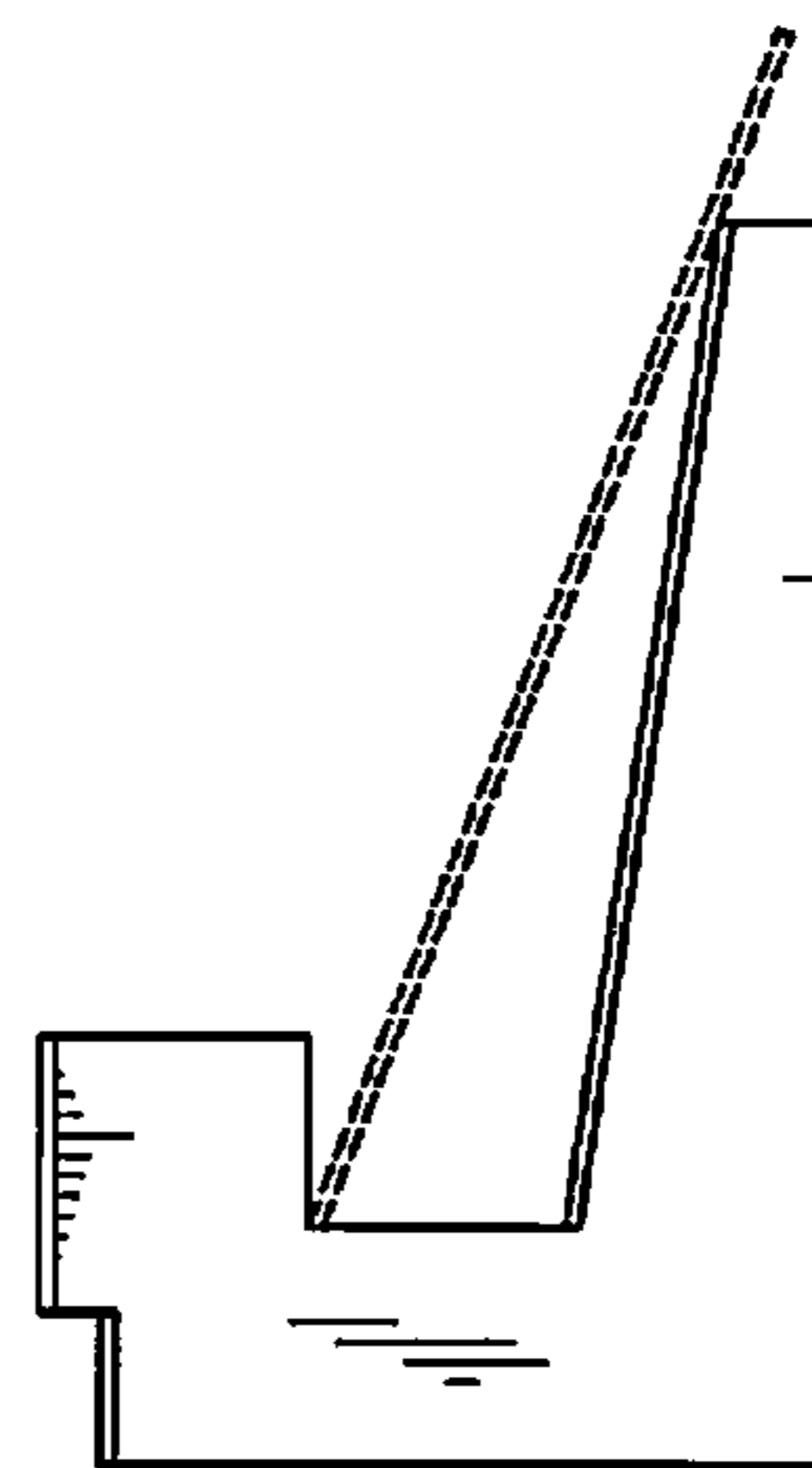
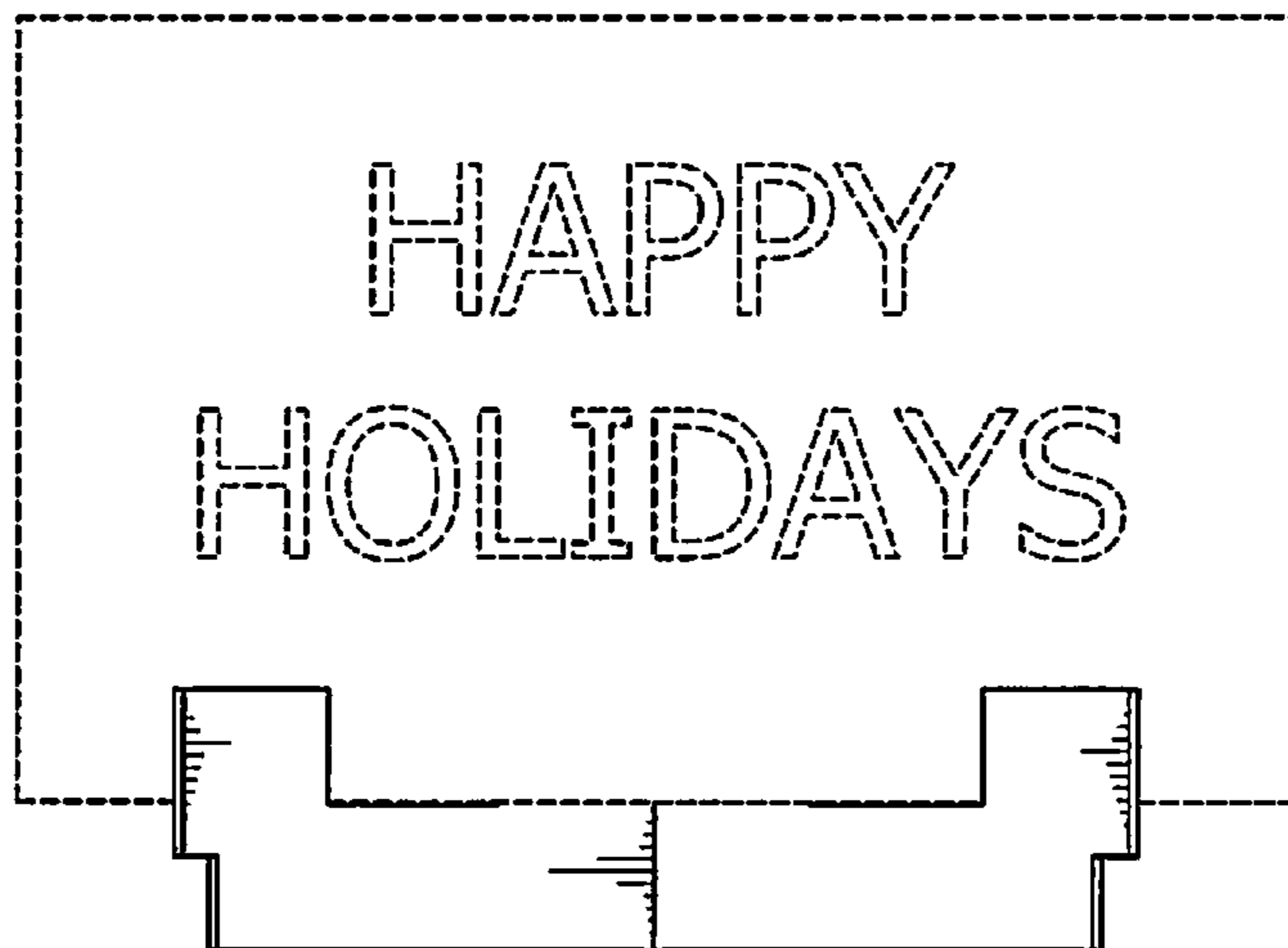
(57) **CLAIM**

The ornamental design for a card, photo or photocard holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a card, photo or photocard holder with a card shown in broken lines. The broken lines represent environment and form no part of the claim design; FIG. 2 is a another front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view.

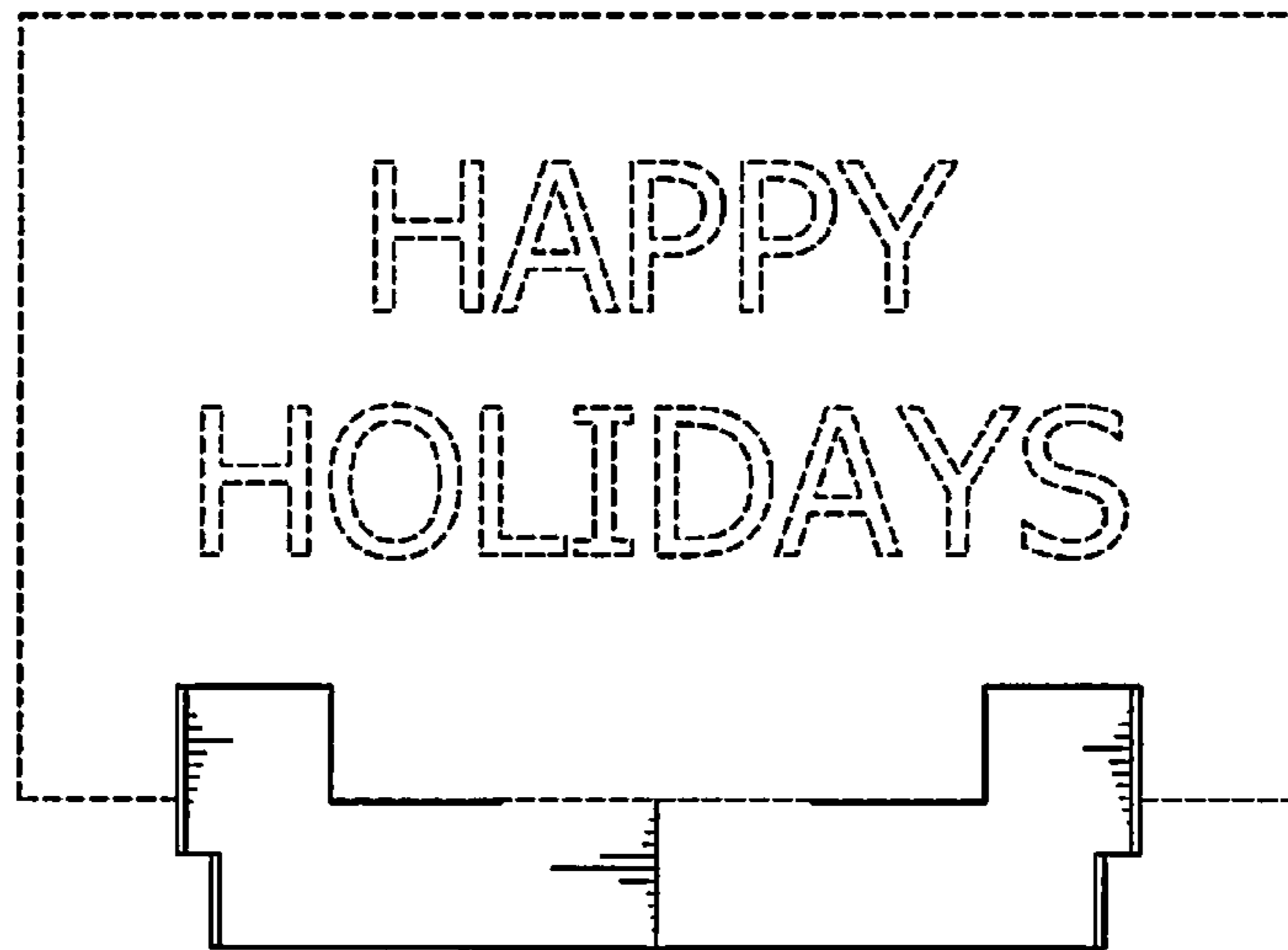

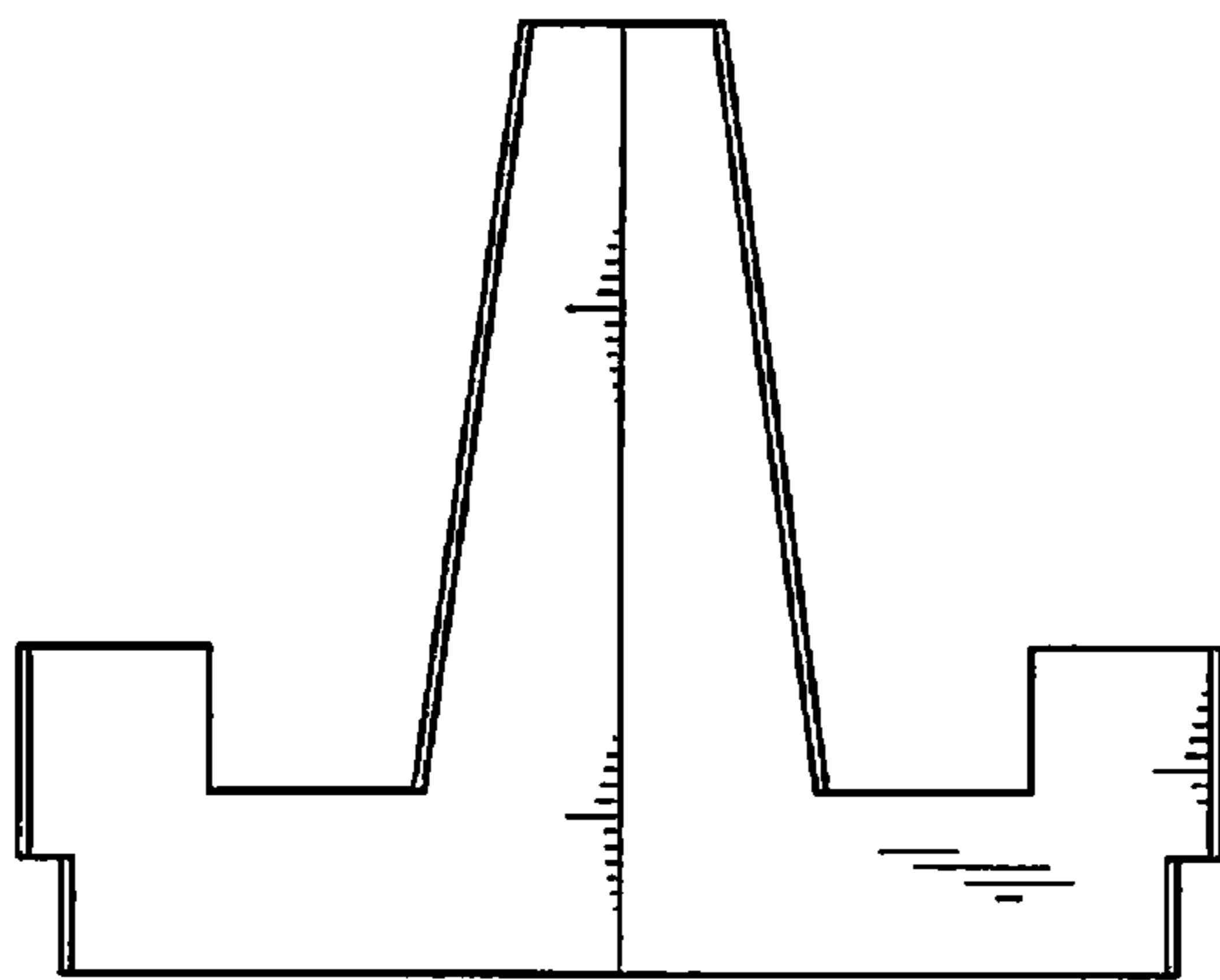

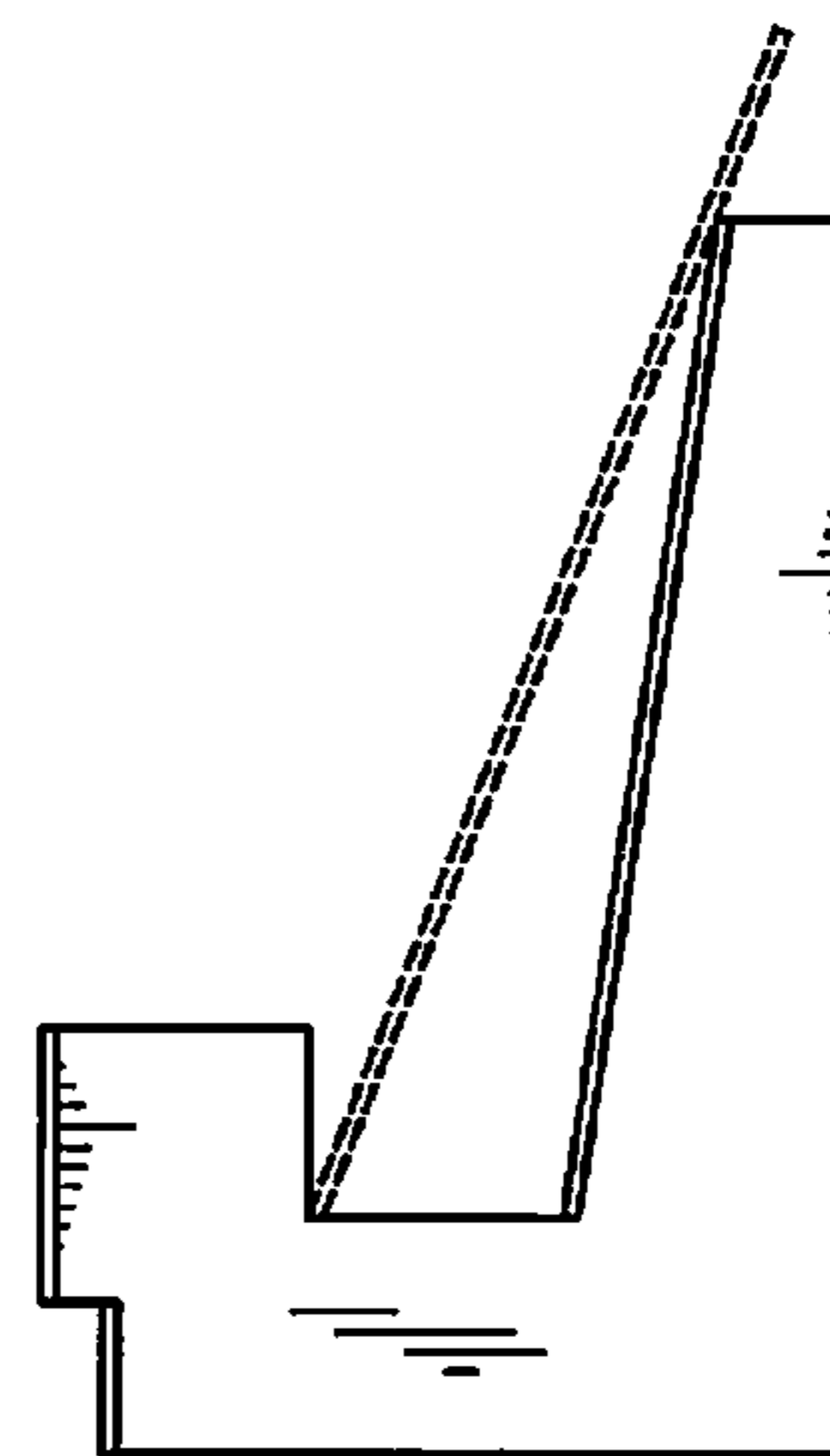

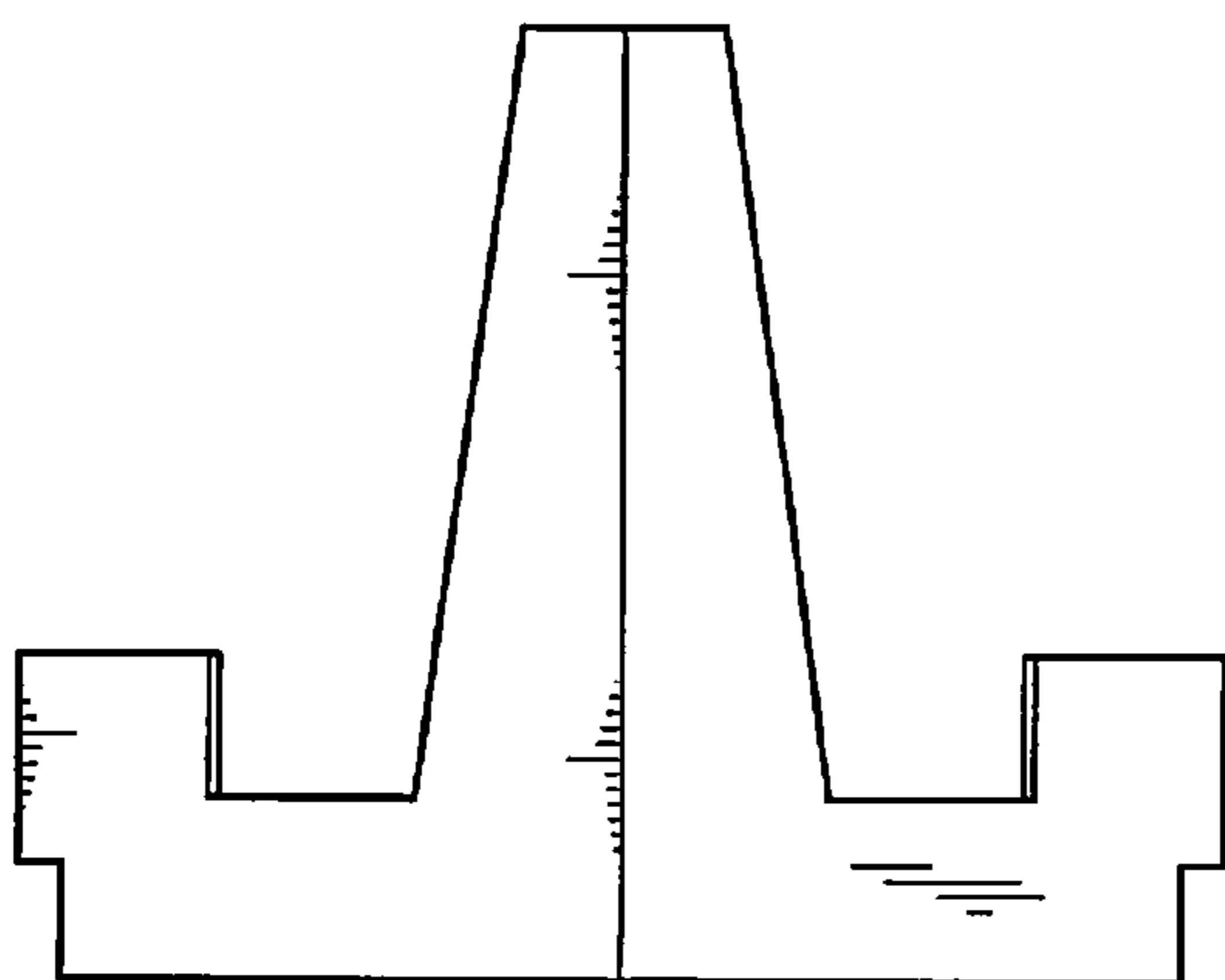

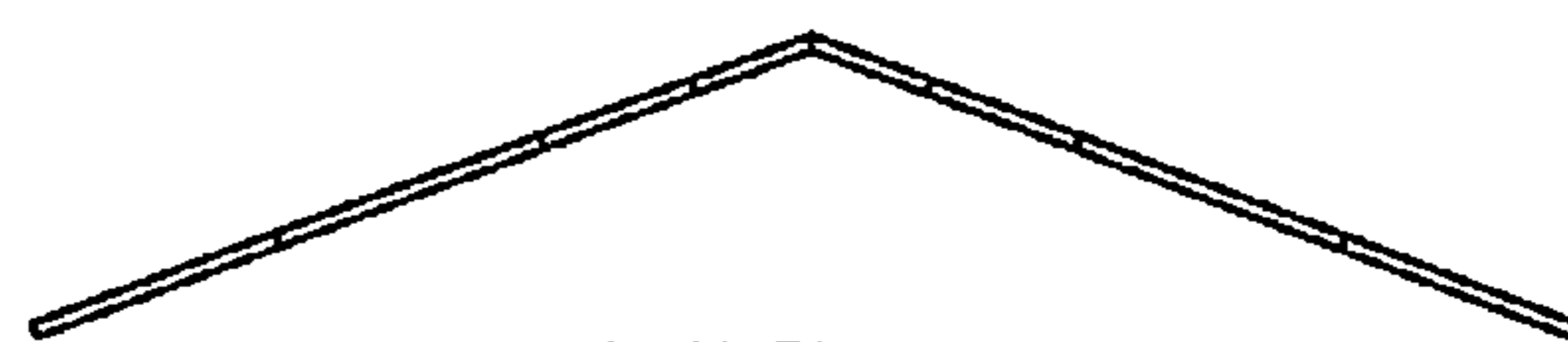

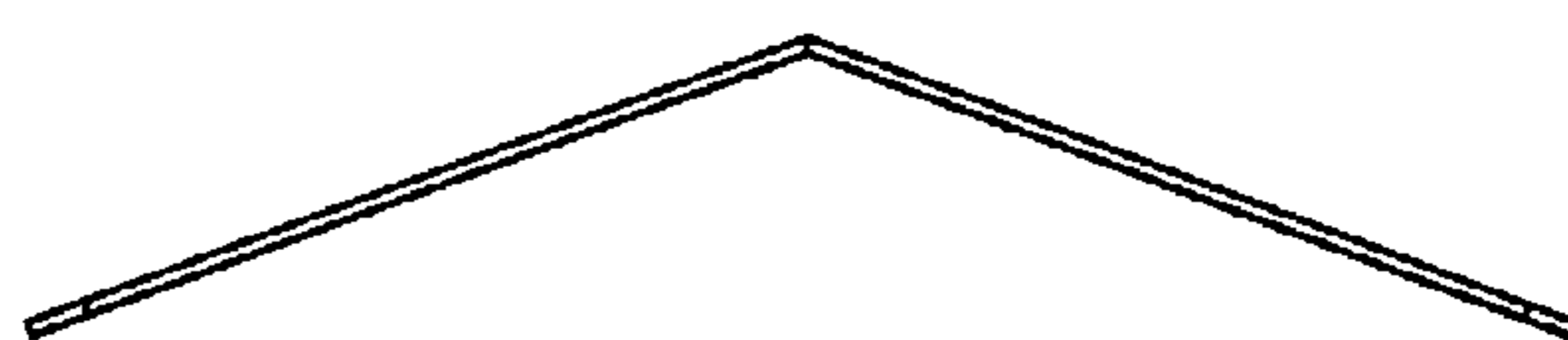
