The ornamental design for a seat for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a seat for a motor vehicle;

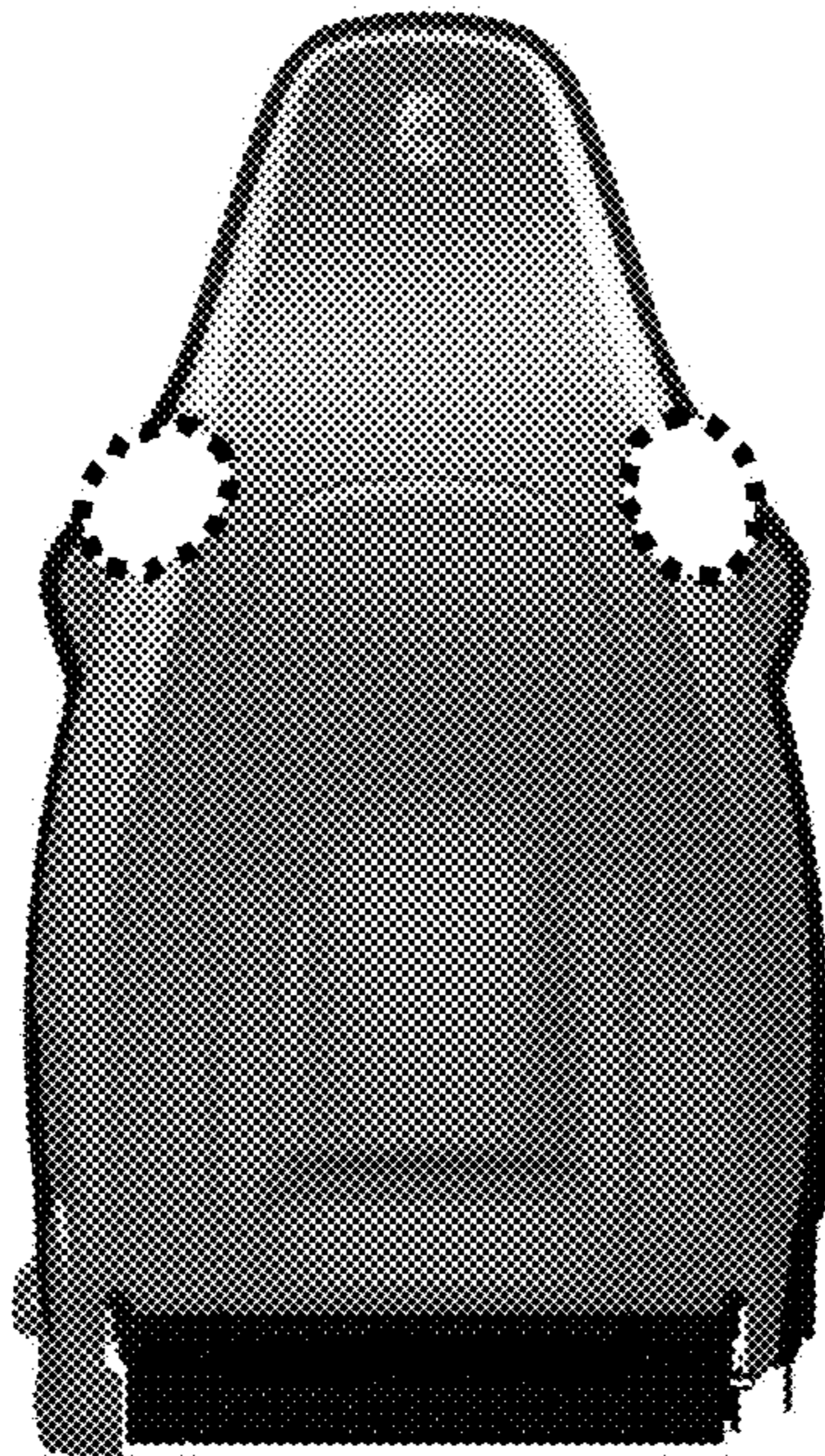

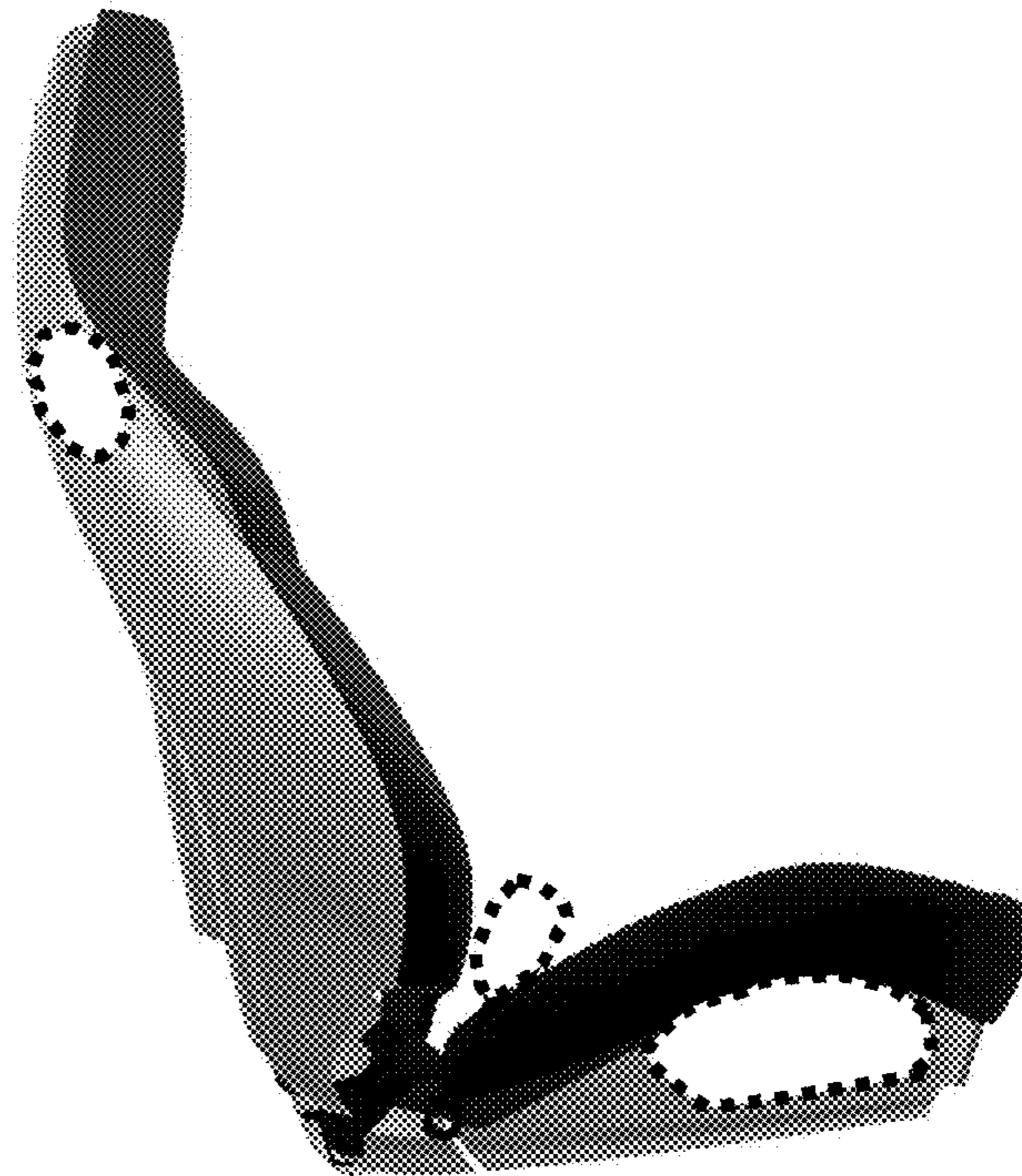

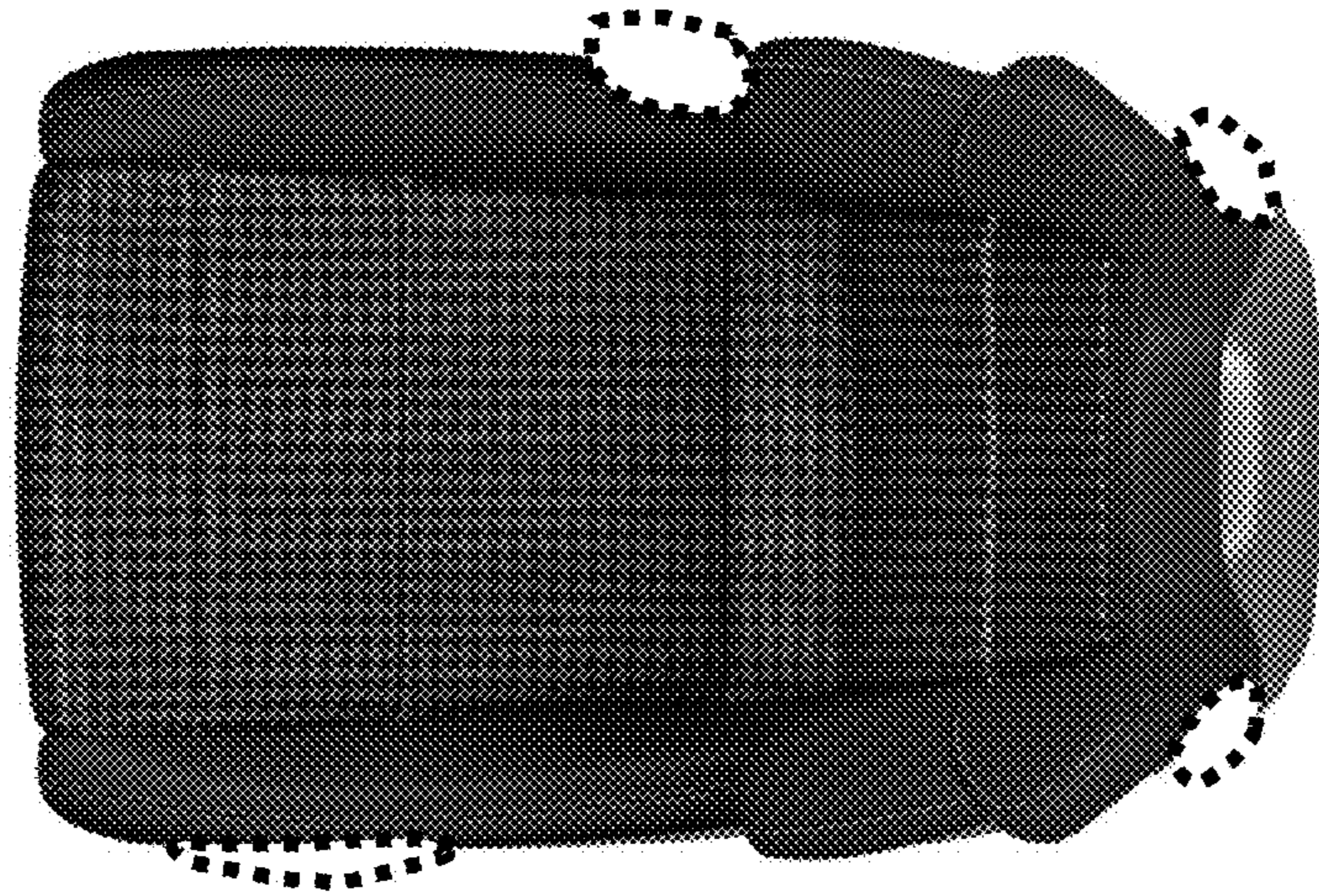
