(57) **CLAIM**

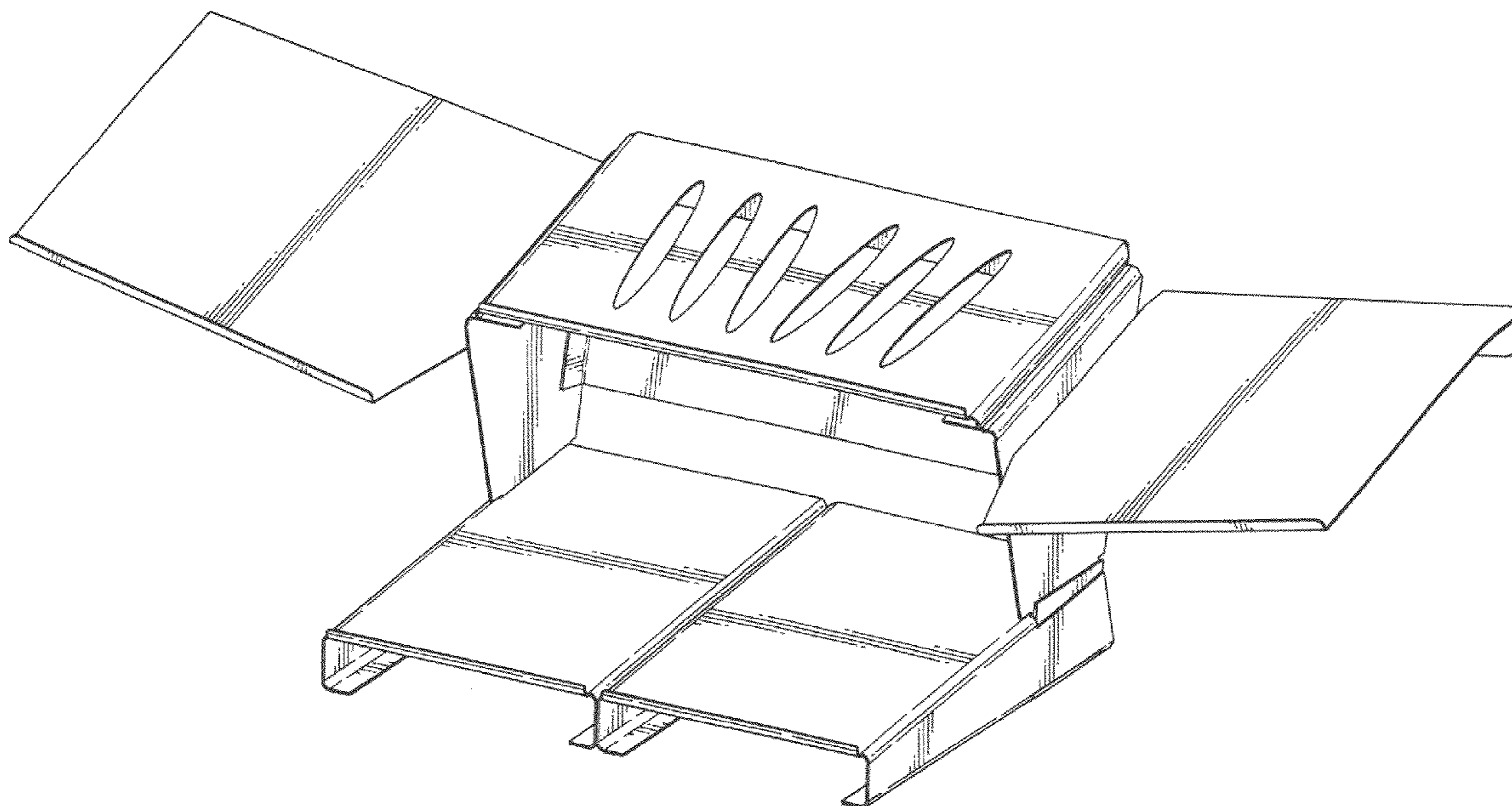
I claim the ornamental design for a disc jockey stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of the disc jockey stand;  
FIG. 2 is a top view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a right side view thereof; the left side view being a mirror image; and,  
FIG. 5 is a back view thereof.

The bottom of the disc jockey stand is not being claimed as part of the design.

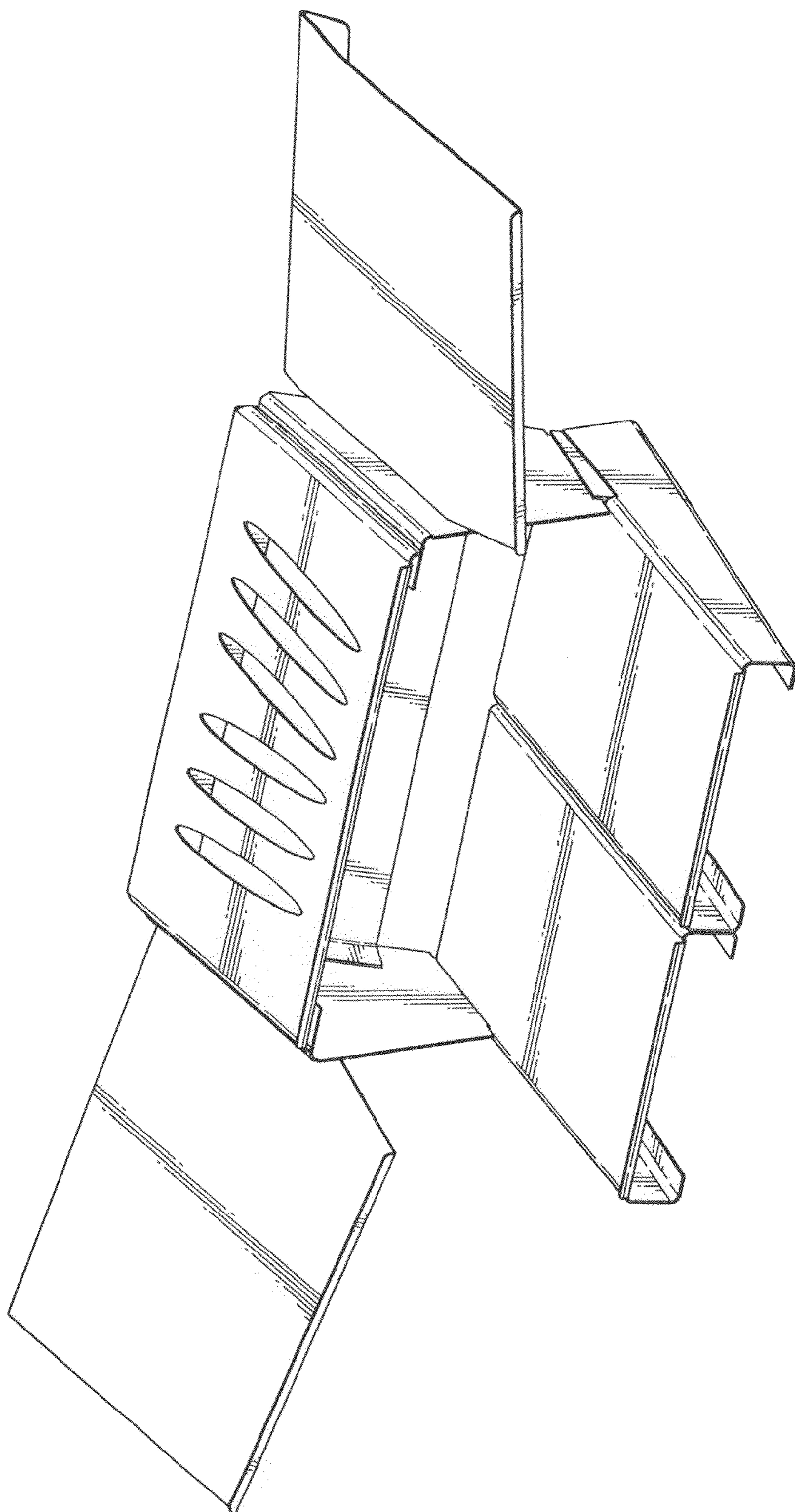

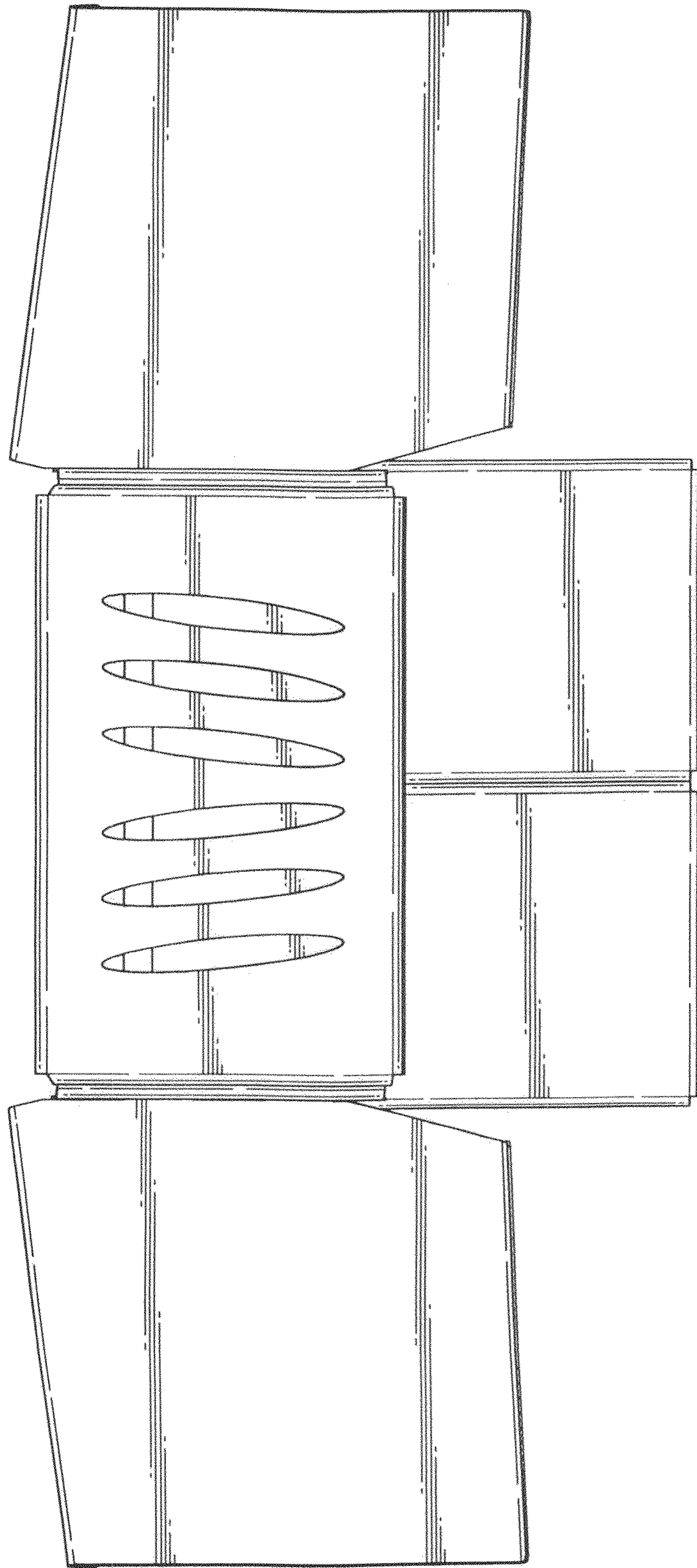
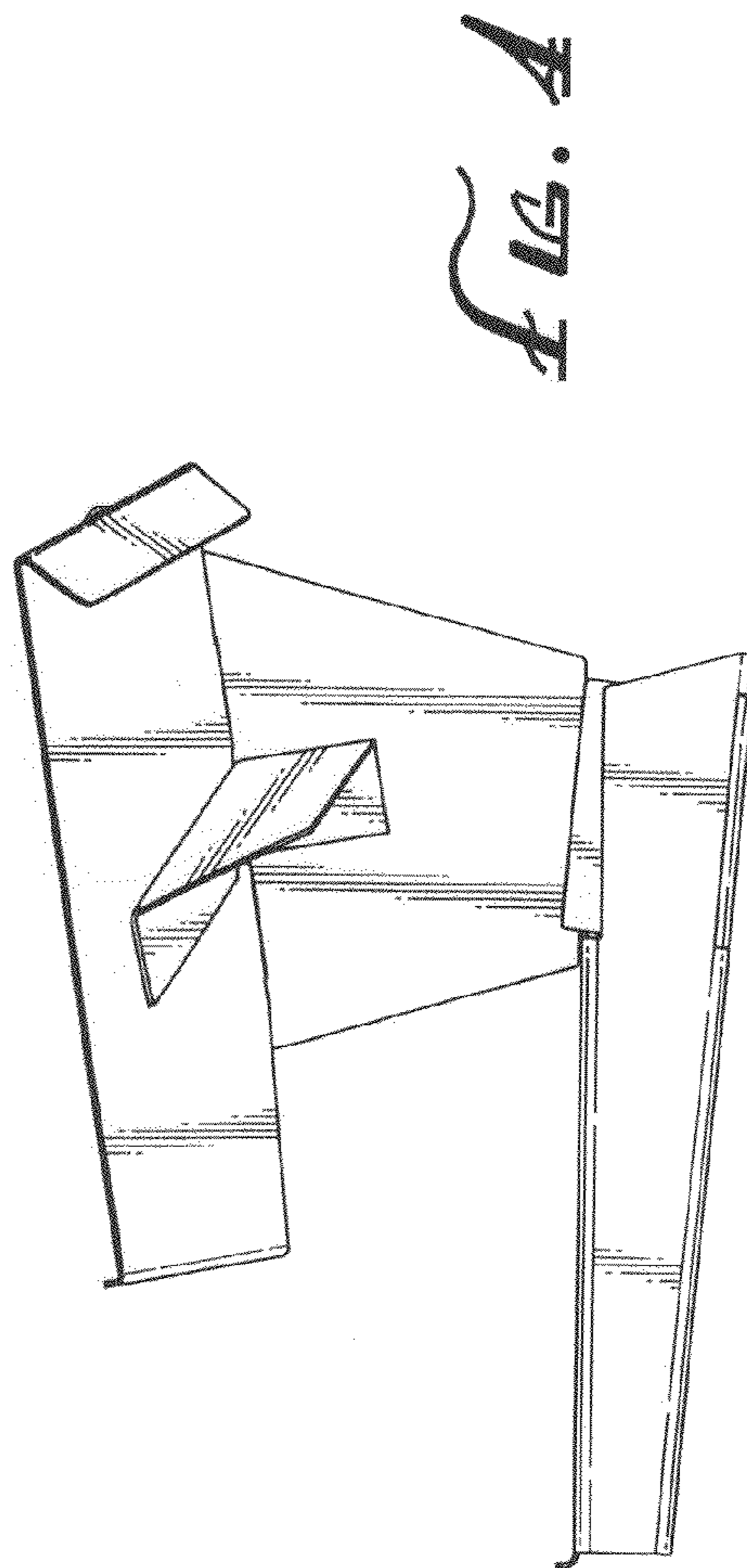
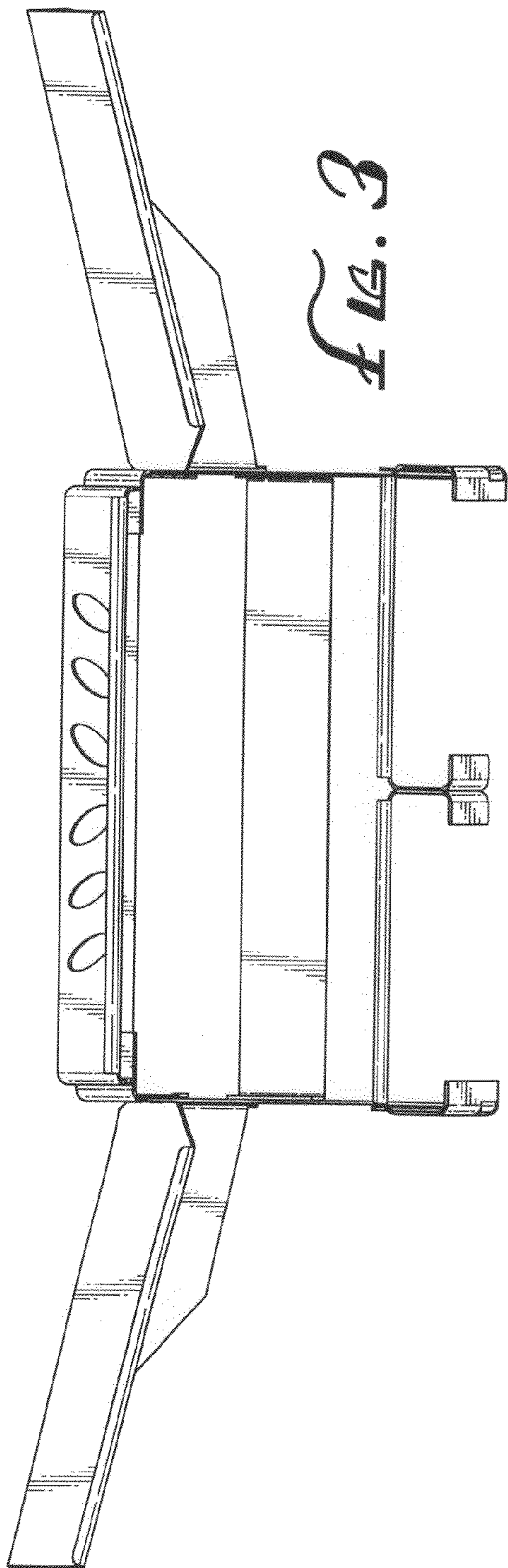

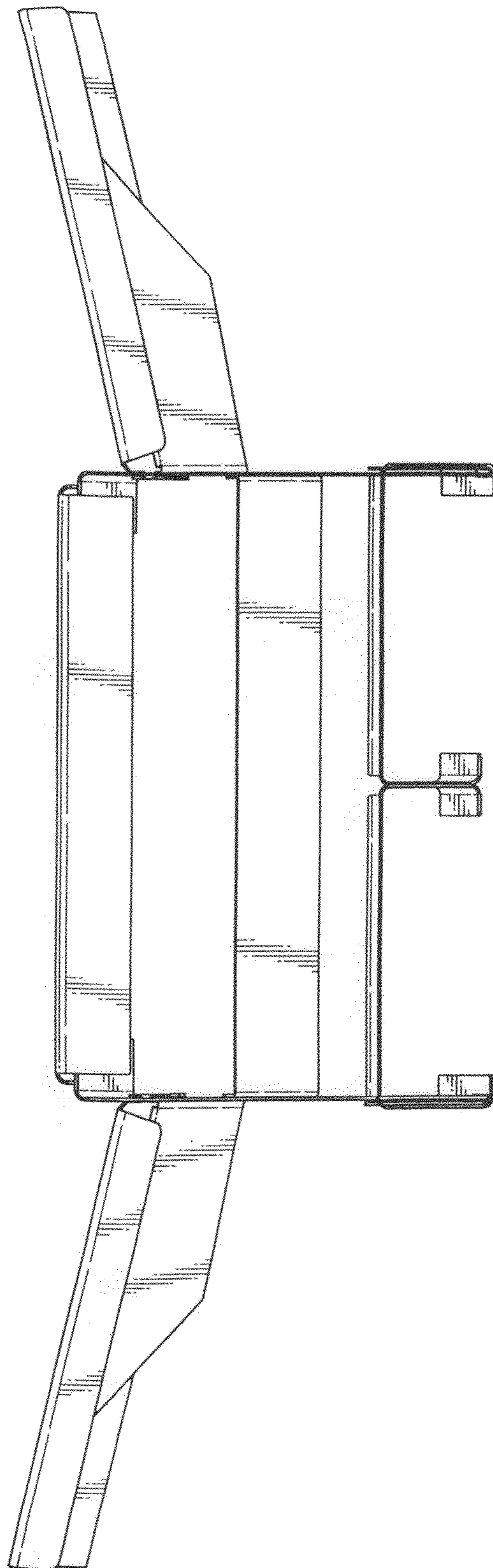
