The ornamental design for a coaster, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of the coaster shown in an open position showing my new design;
FIG. 2 is a front, right perspective view of the coaster showing my new design;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side elevational view thereof; and,
FIG. 8 is a cross-sectional view taken along line 8-8 of the coaster showing my new design.

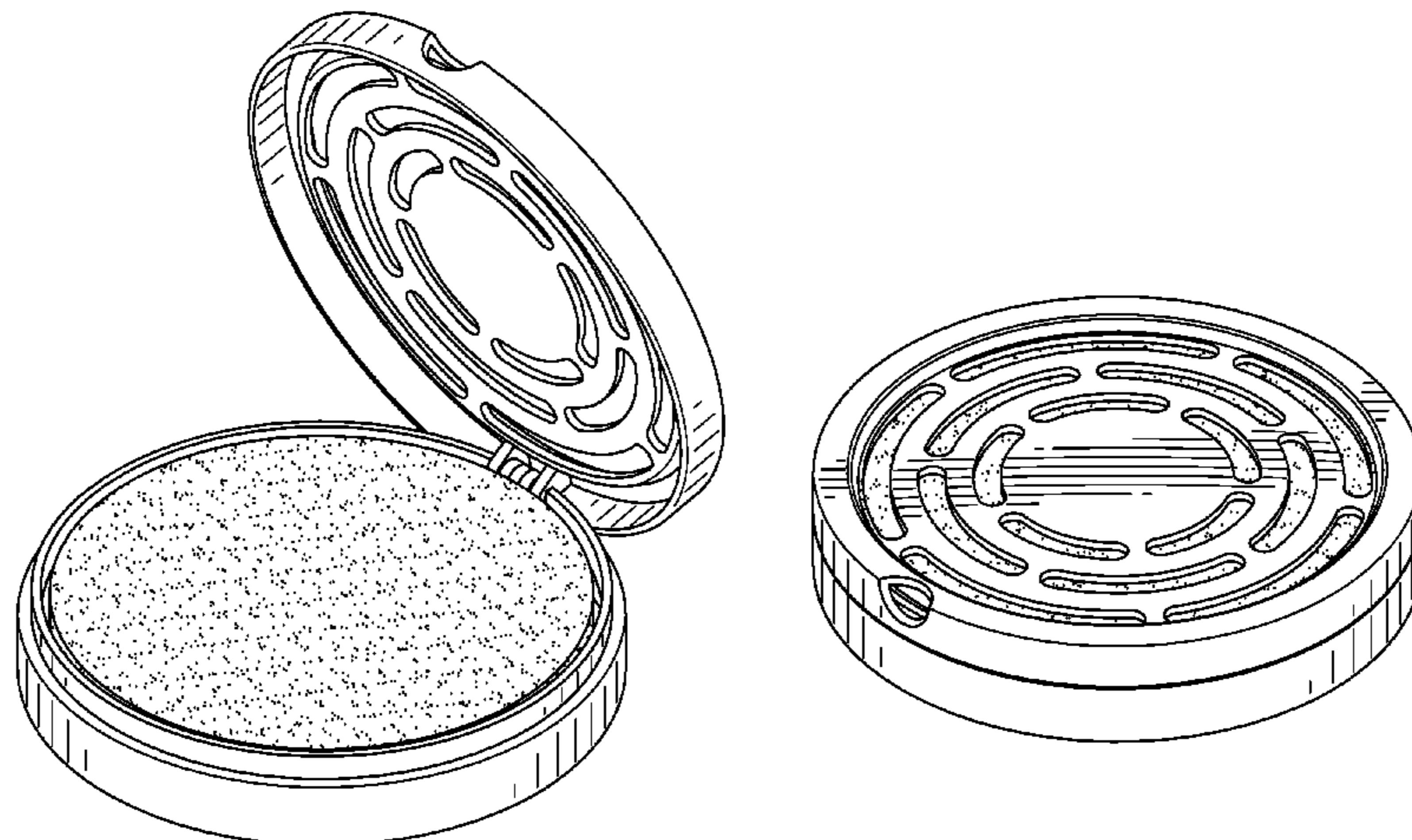

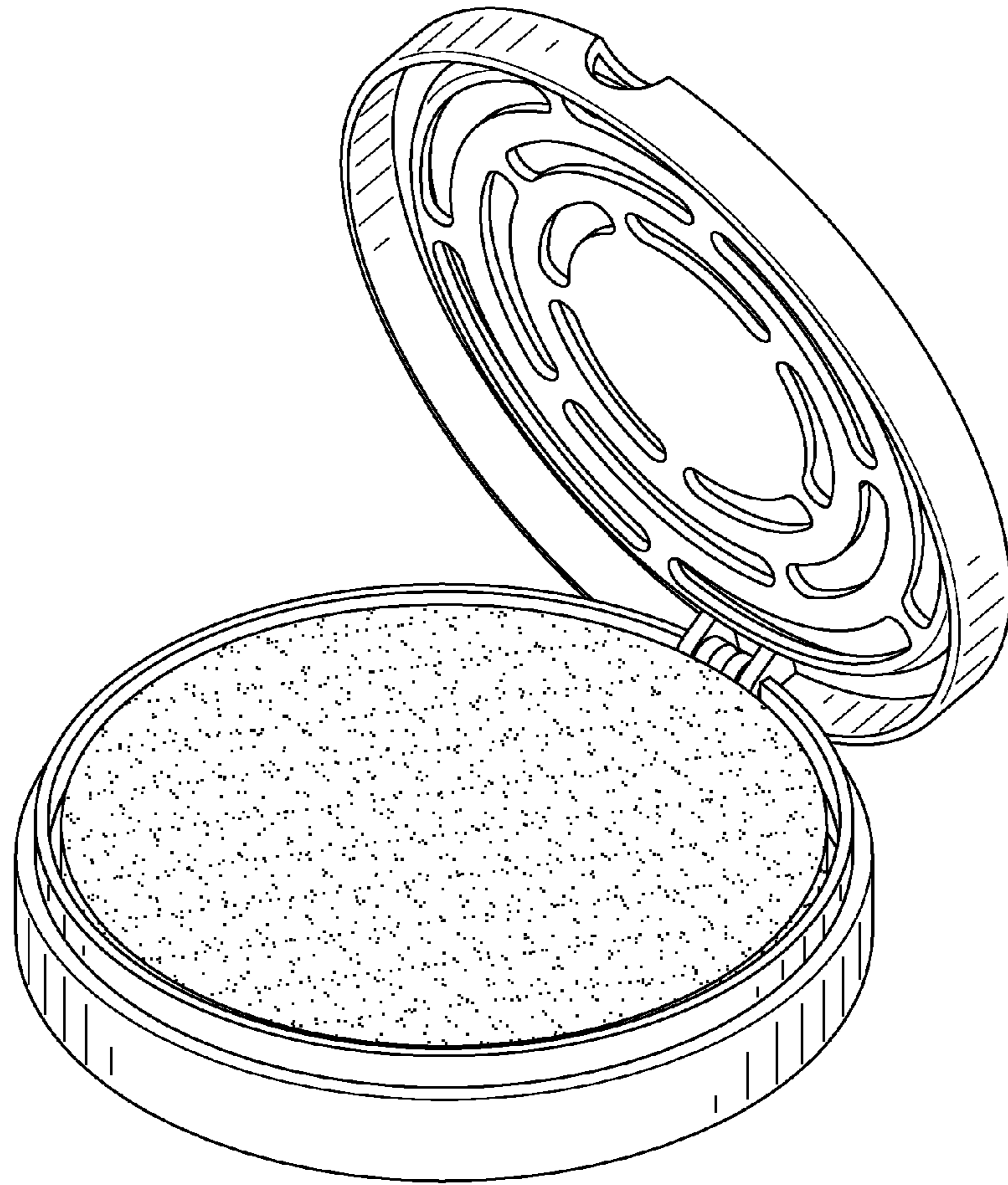
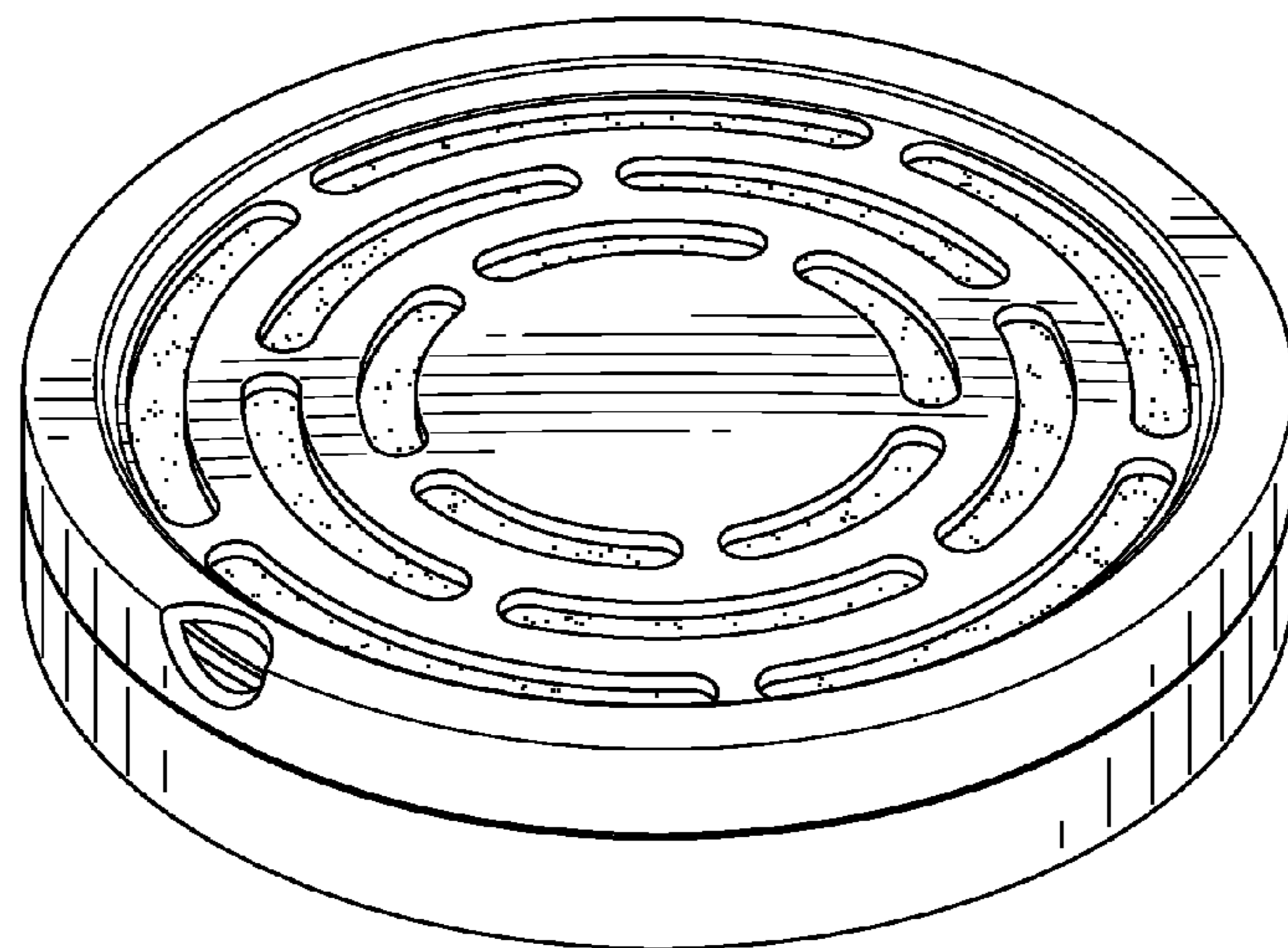

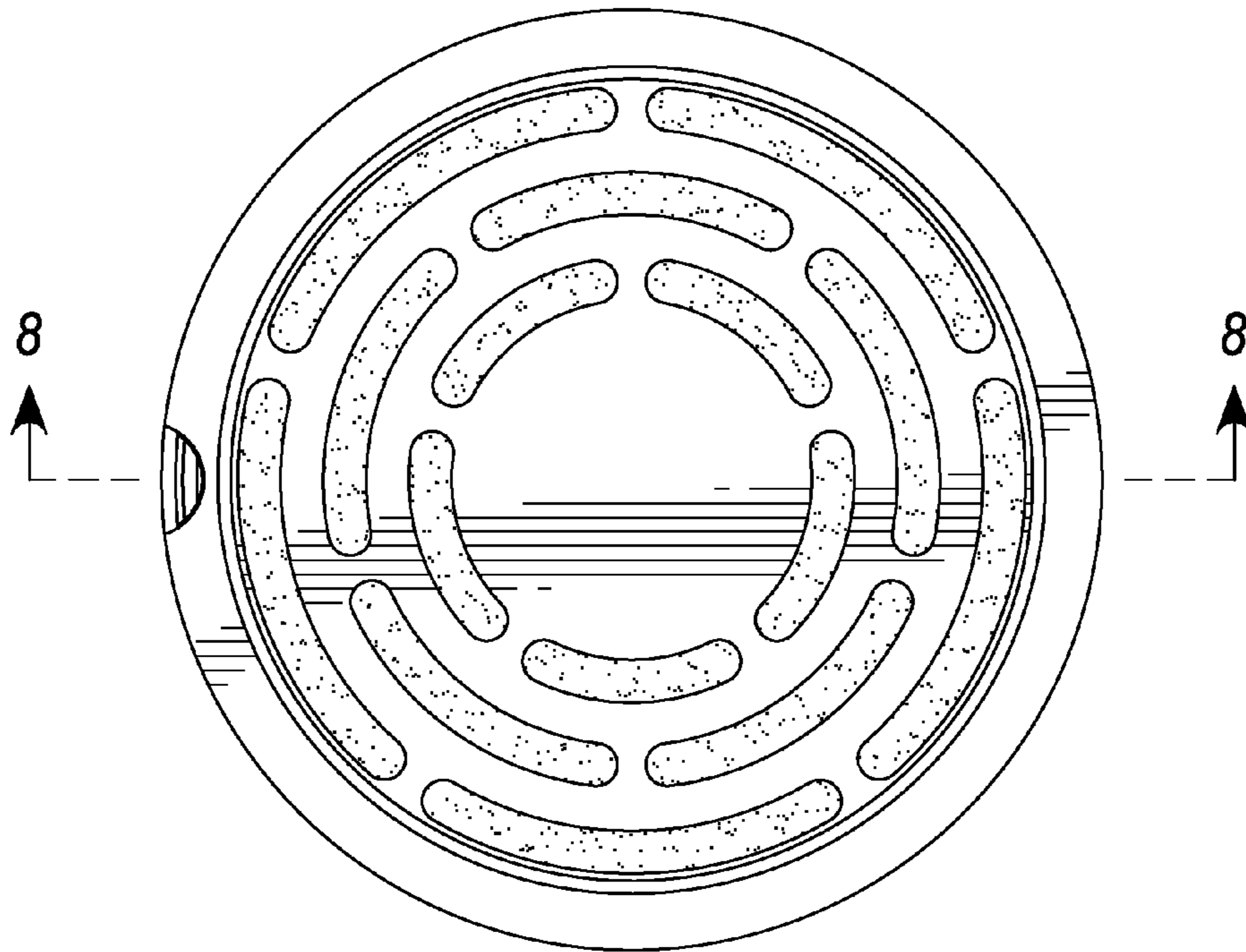

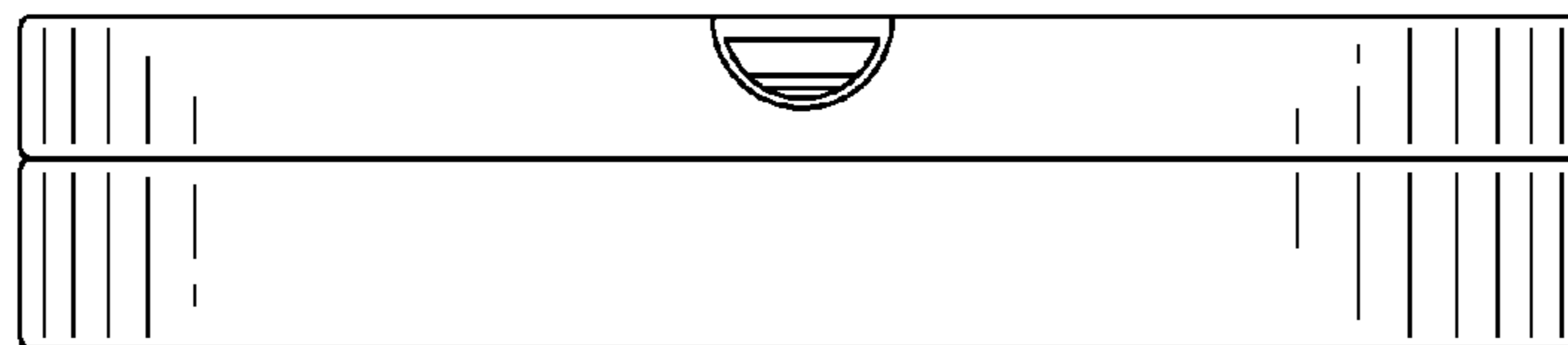

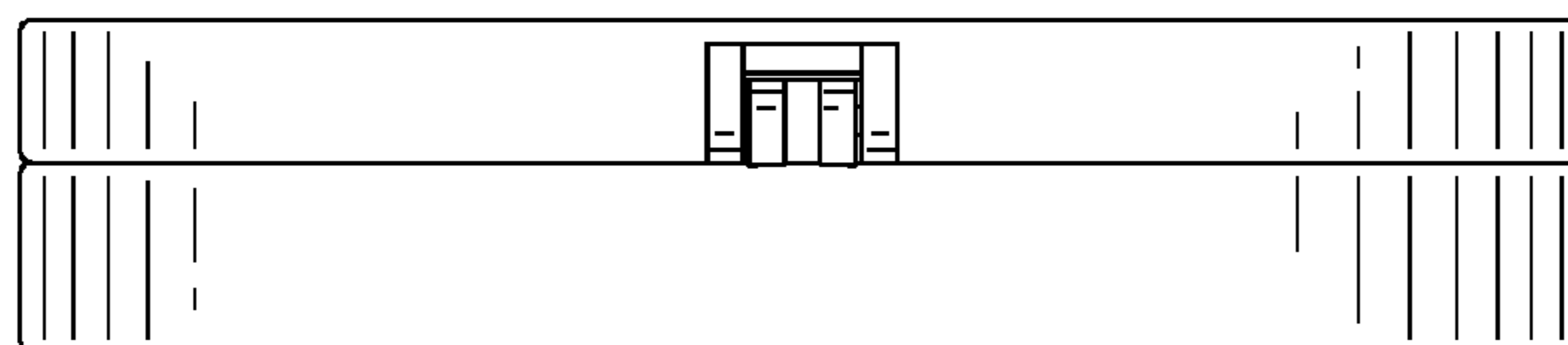

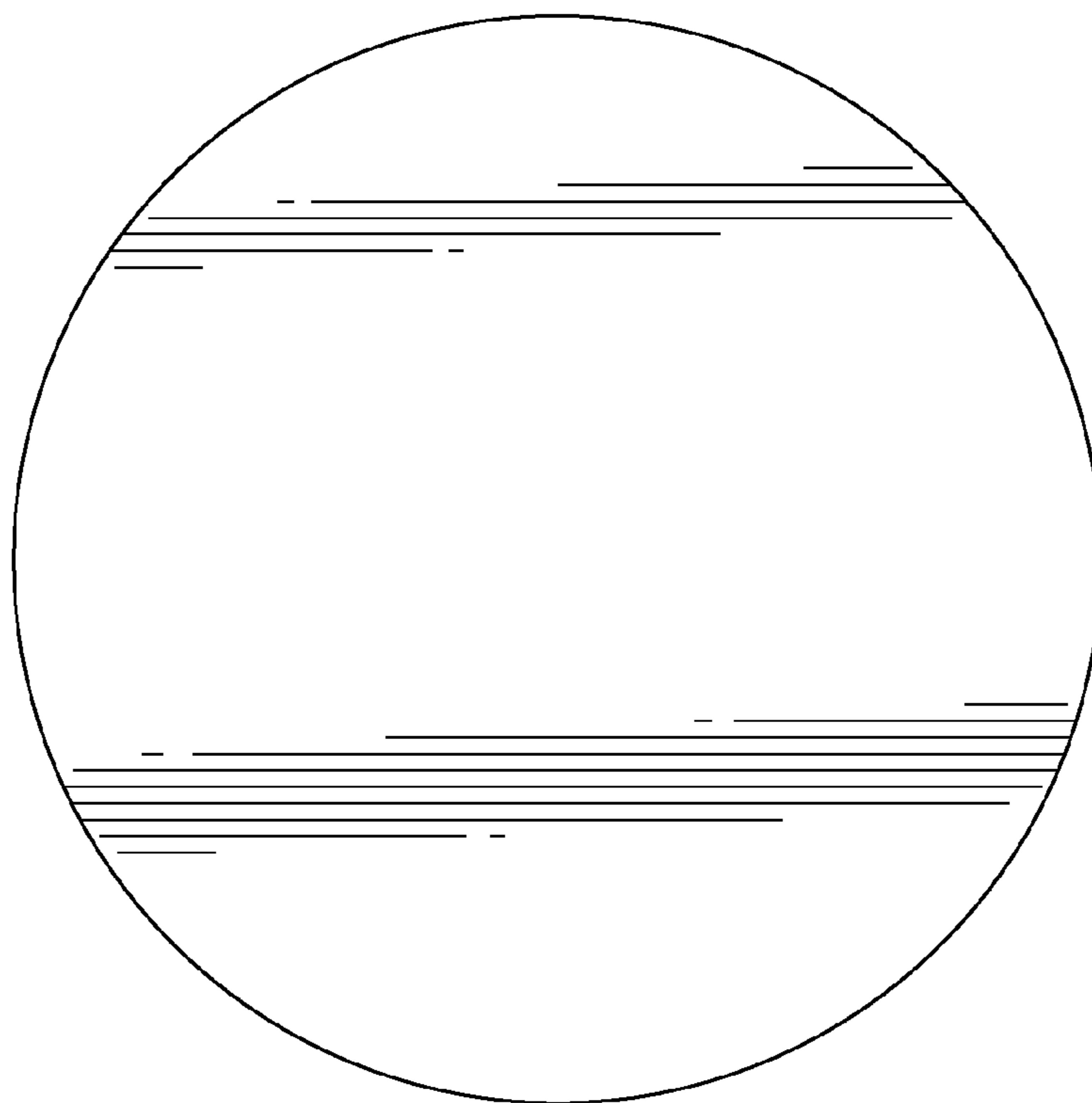

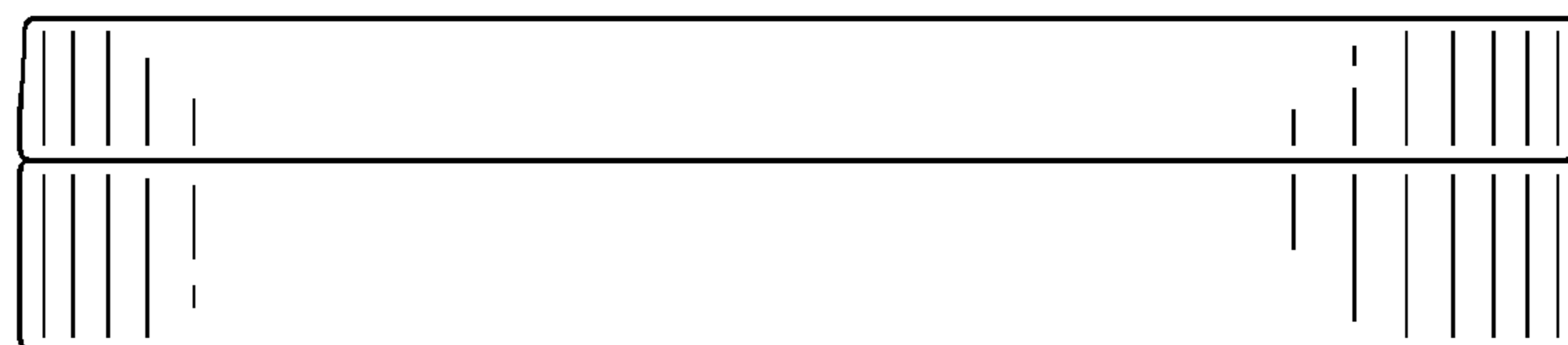

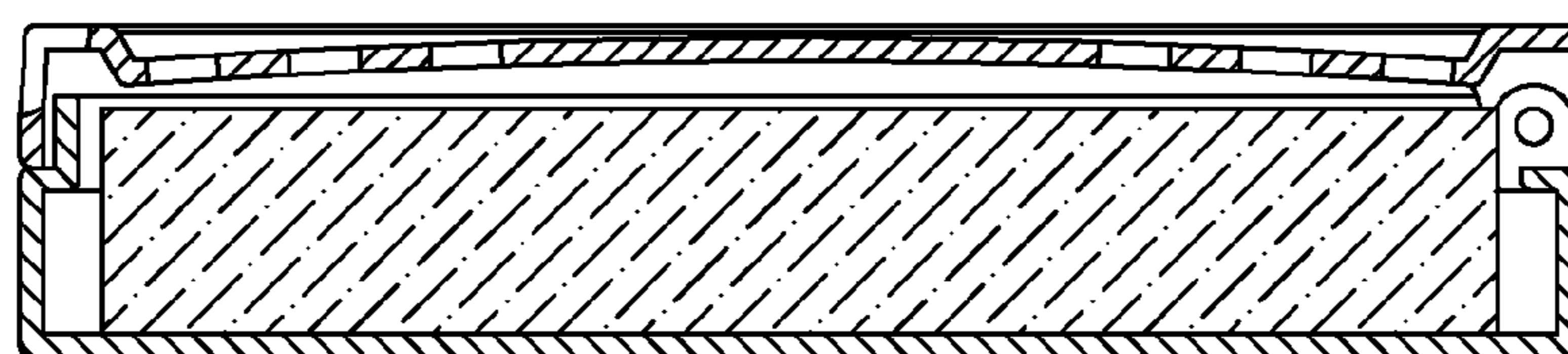
