**DESCRIPTION**

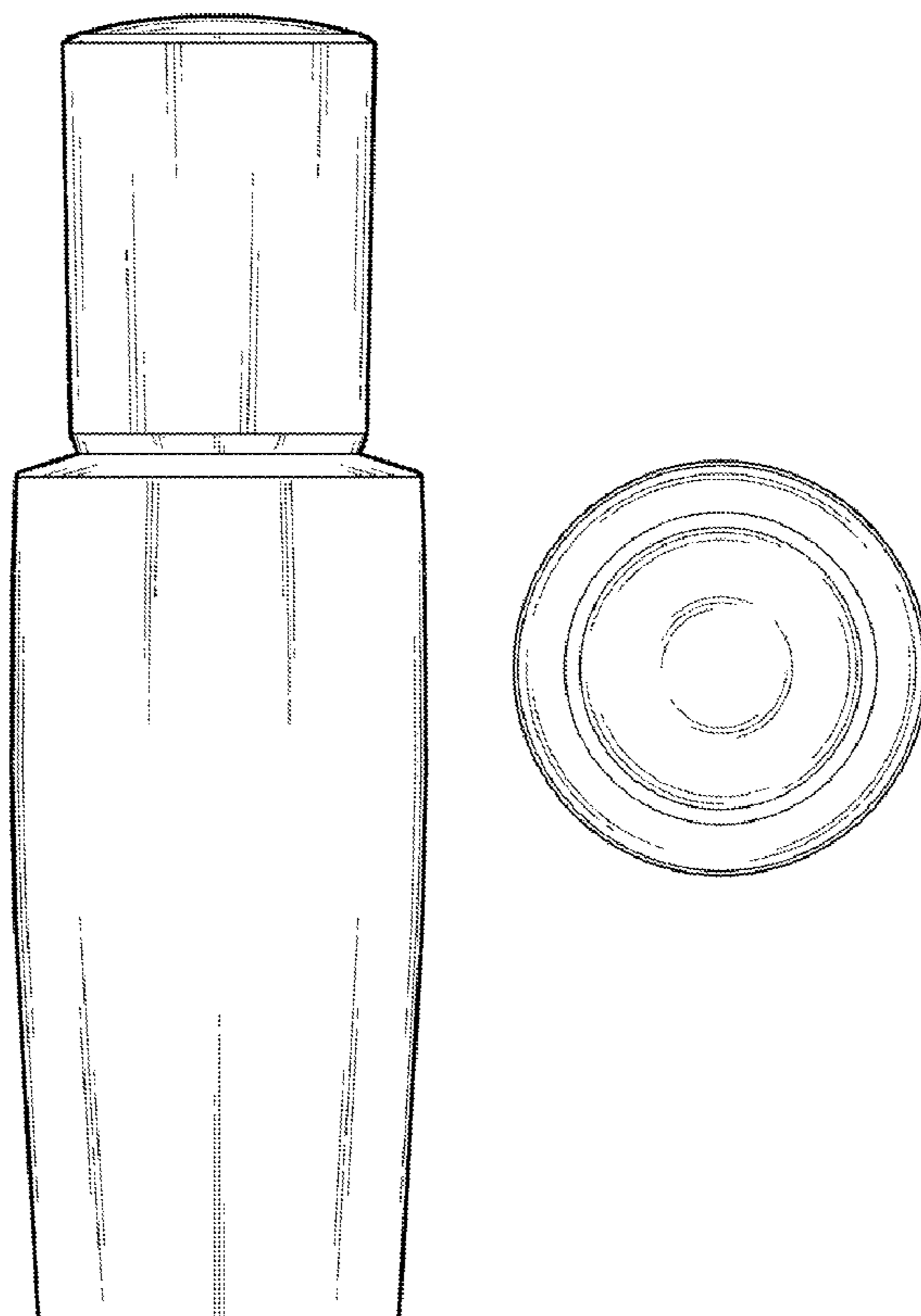
FIG. 1 is a perspective view of the cosmetic container of the present invention;

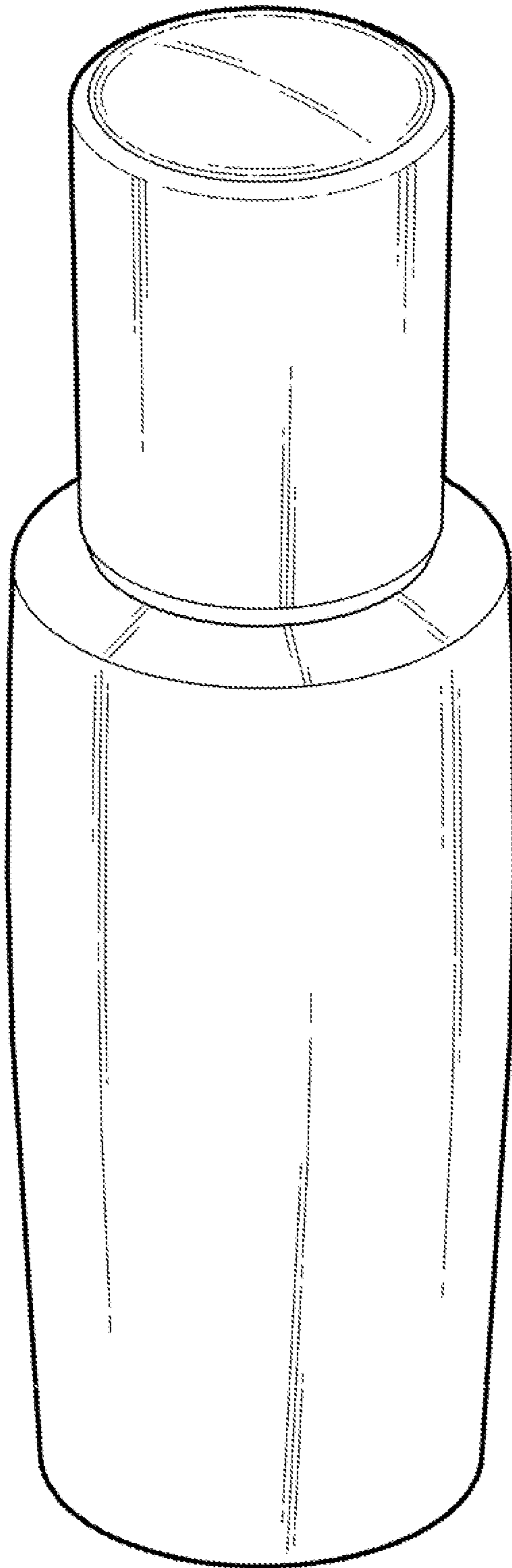

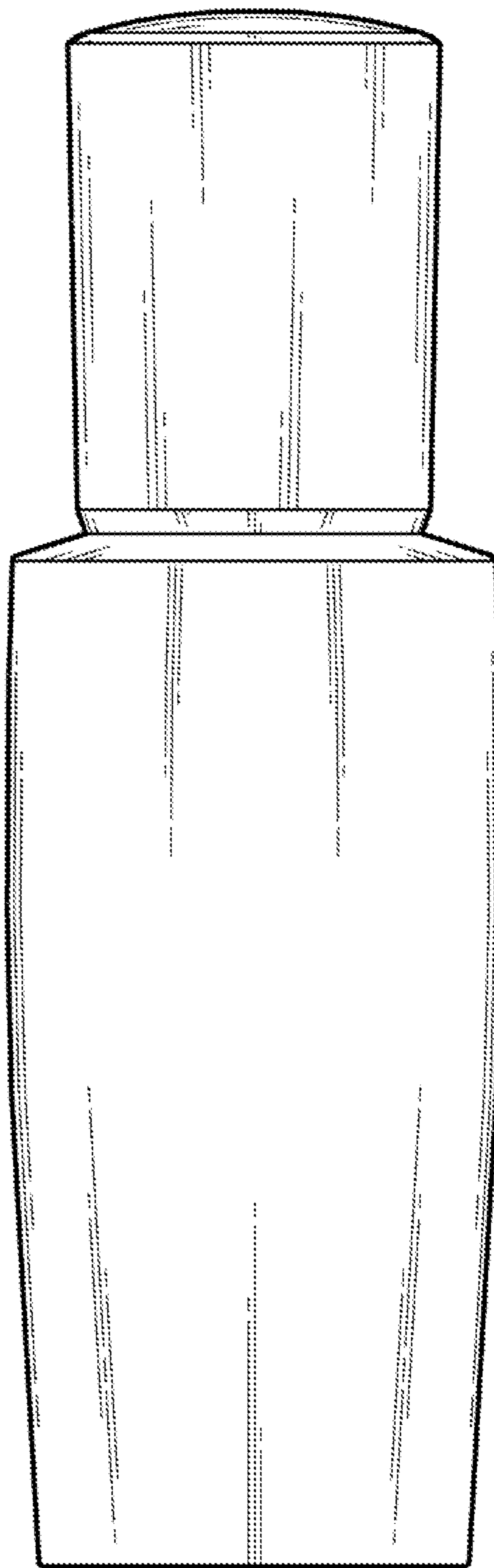

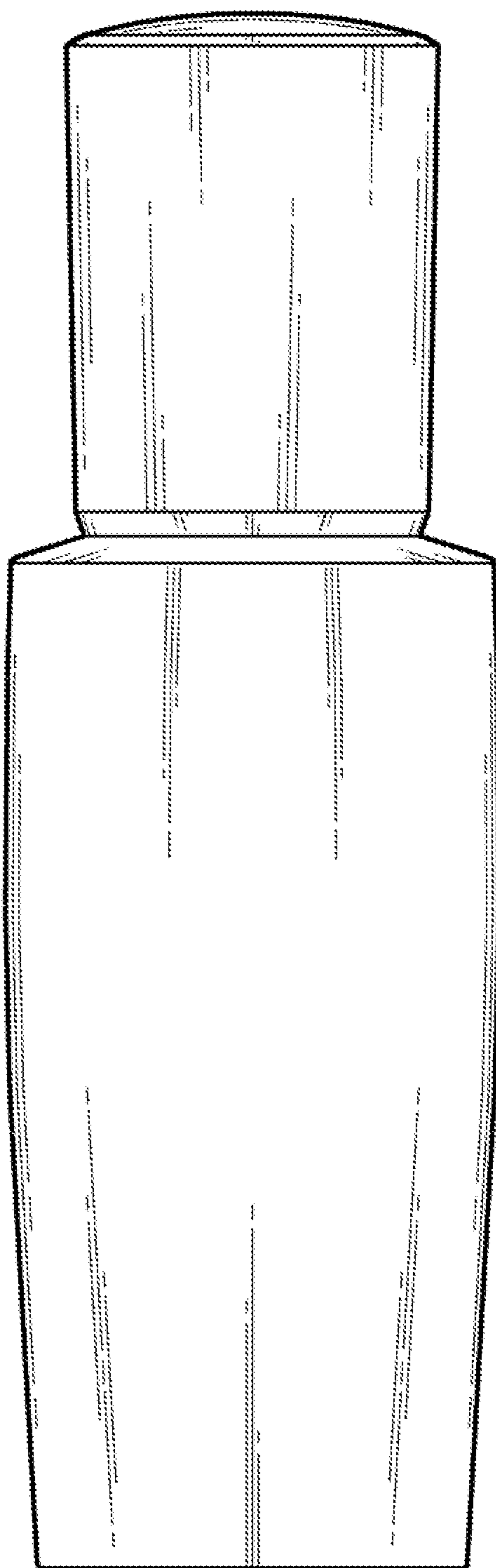

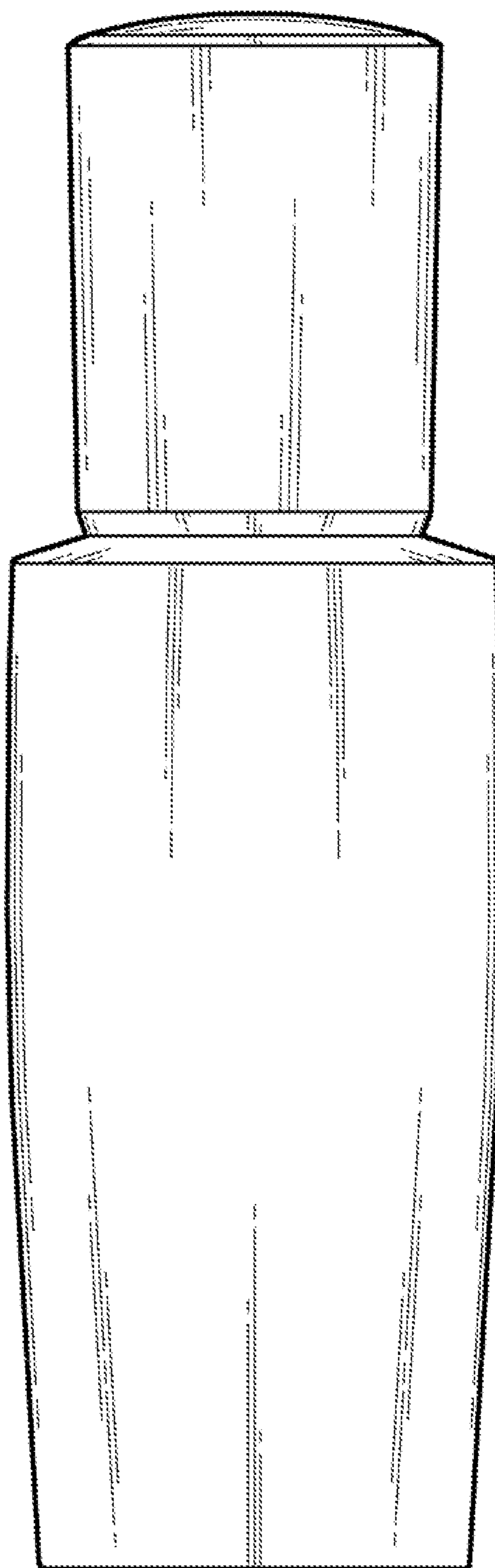

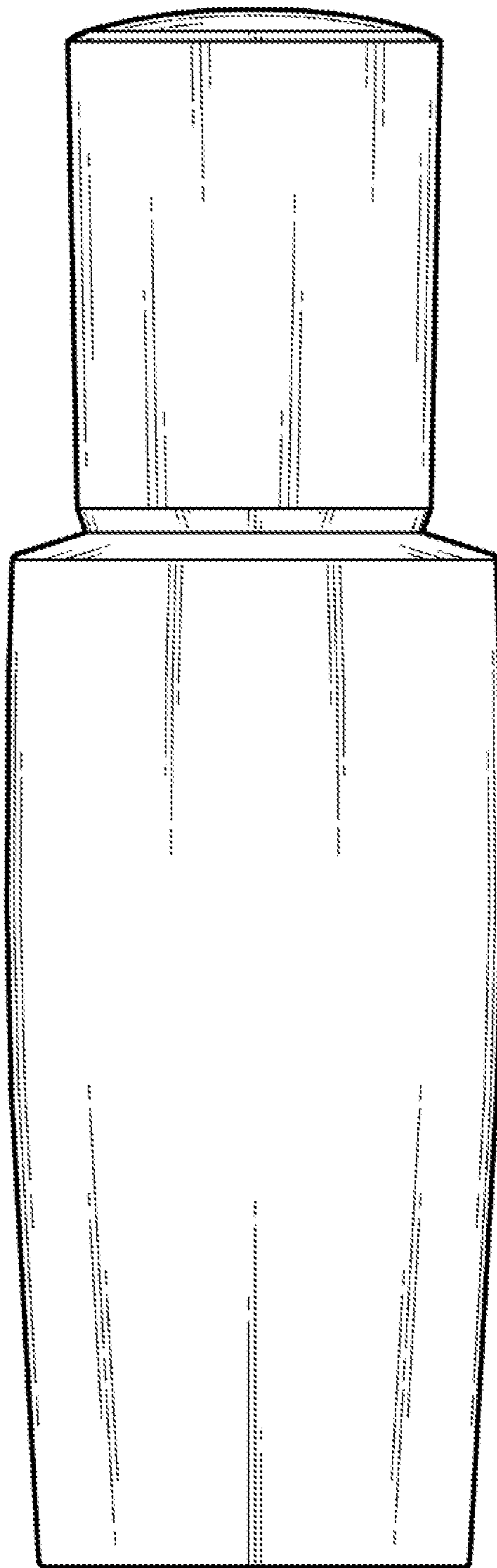

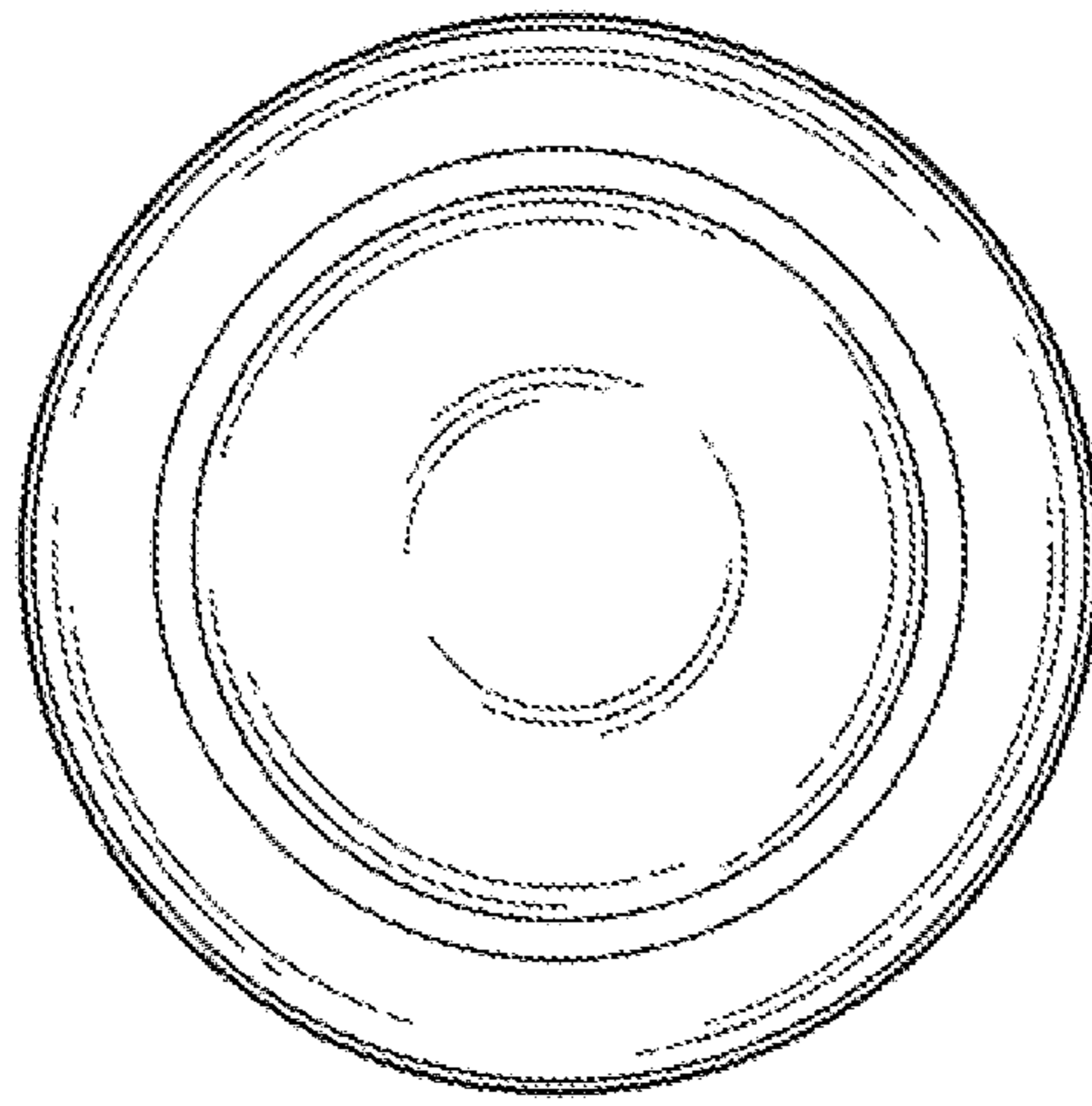

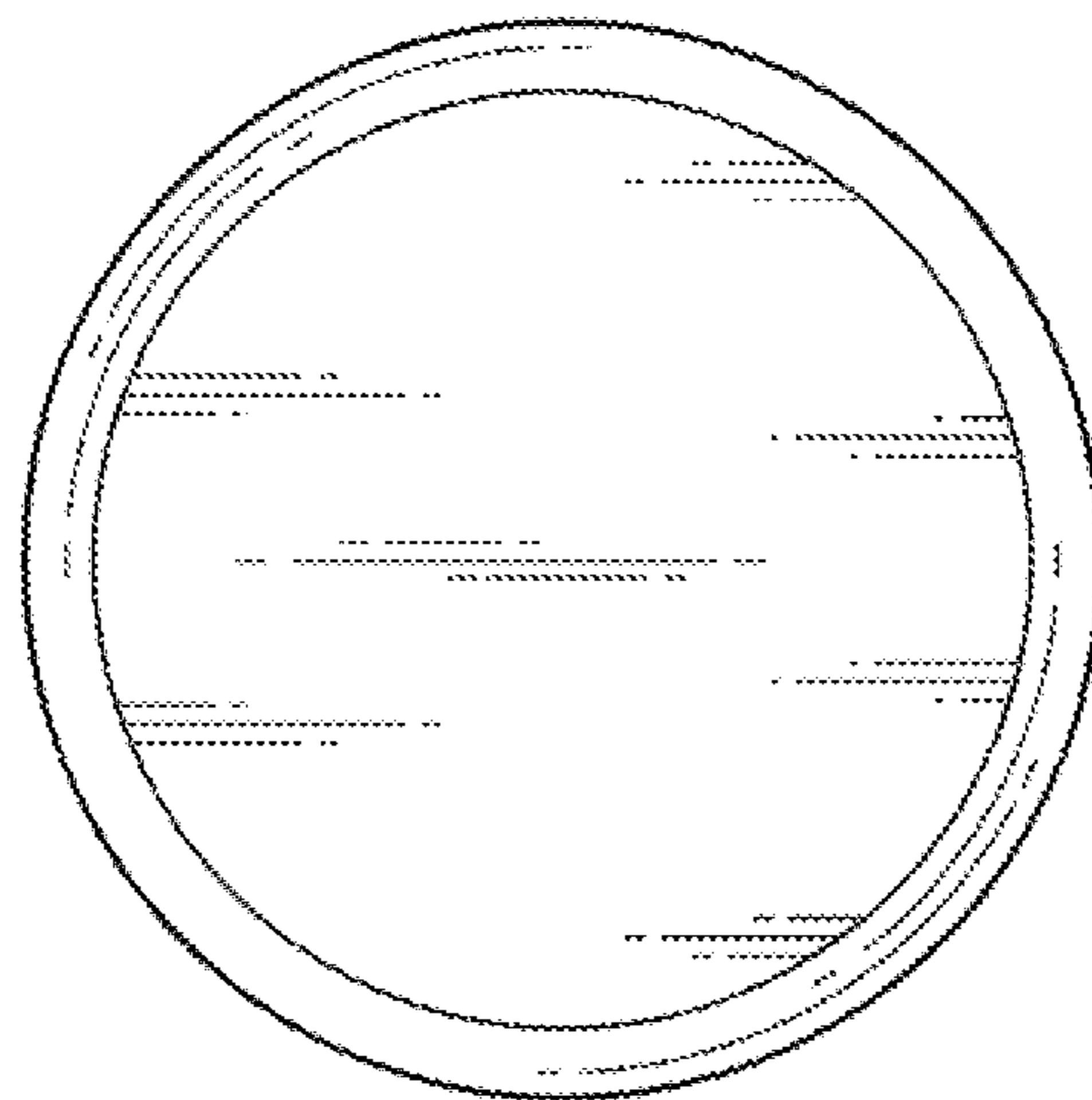
