**DESCRIPTION**

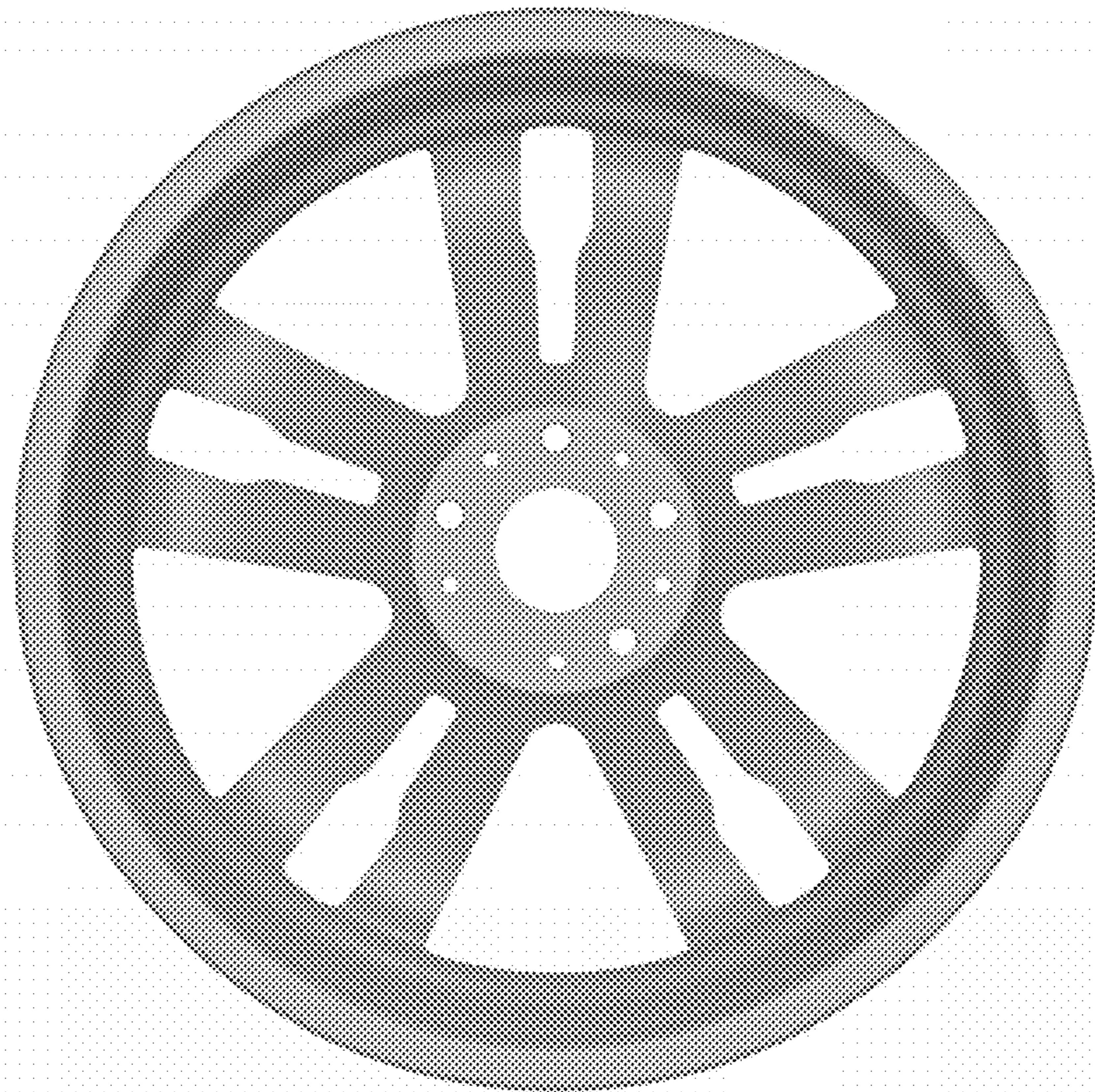
