**DESCRIPTION**

FIG. 1 is a first perspective view of a cogeneration unit, showing my new design;

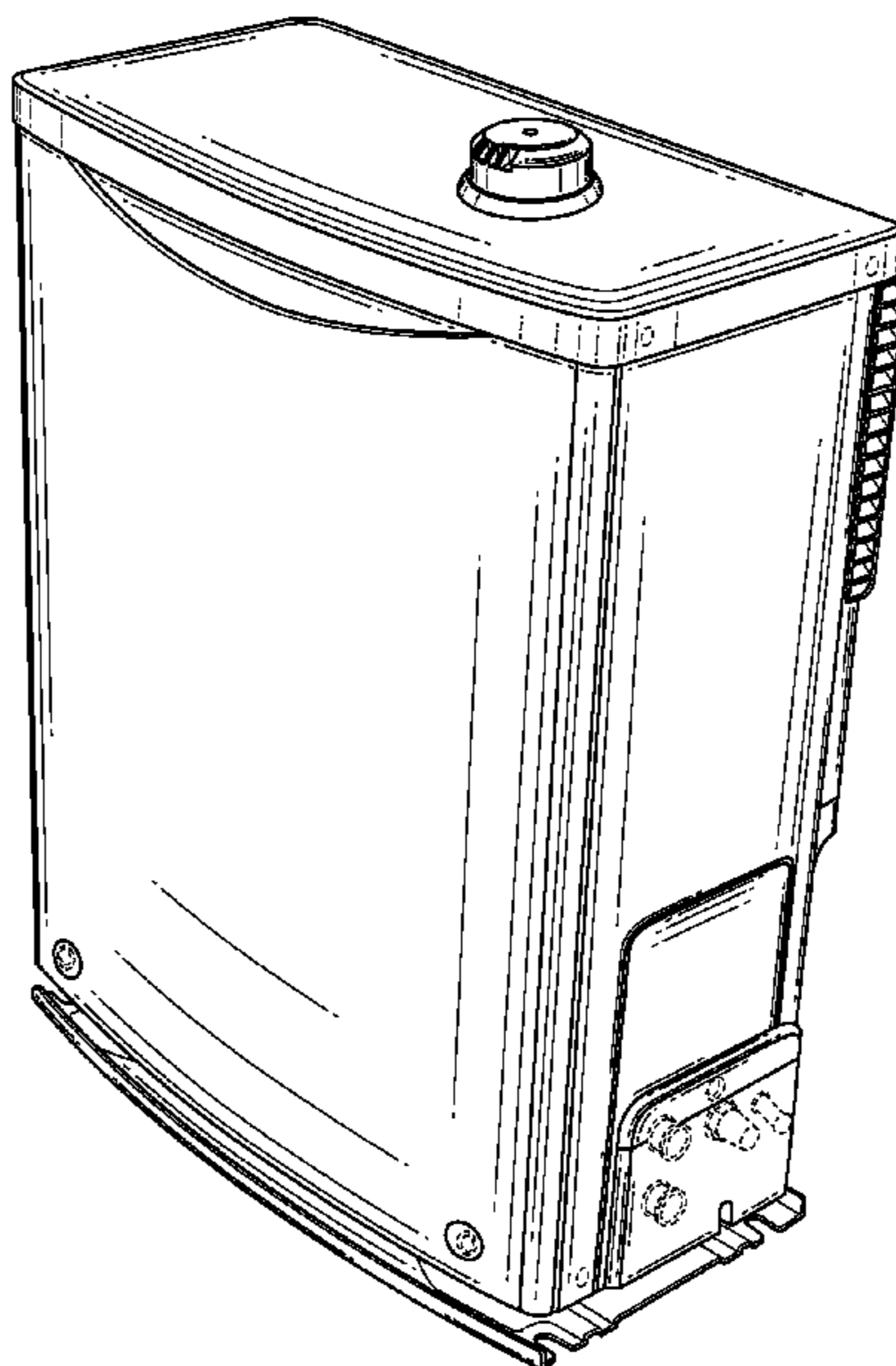

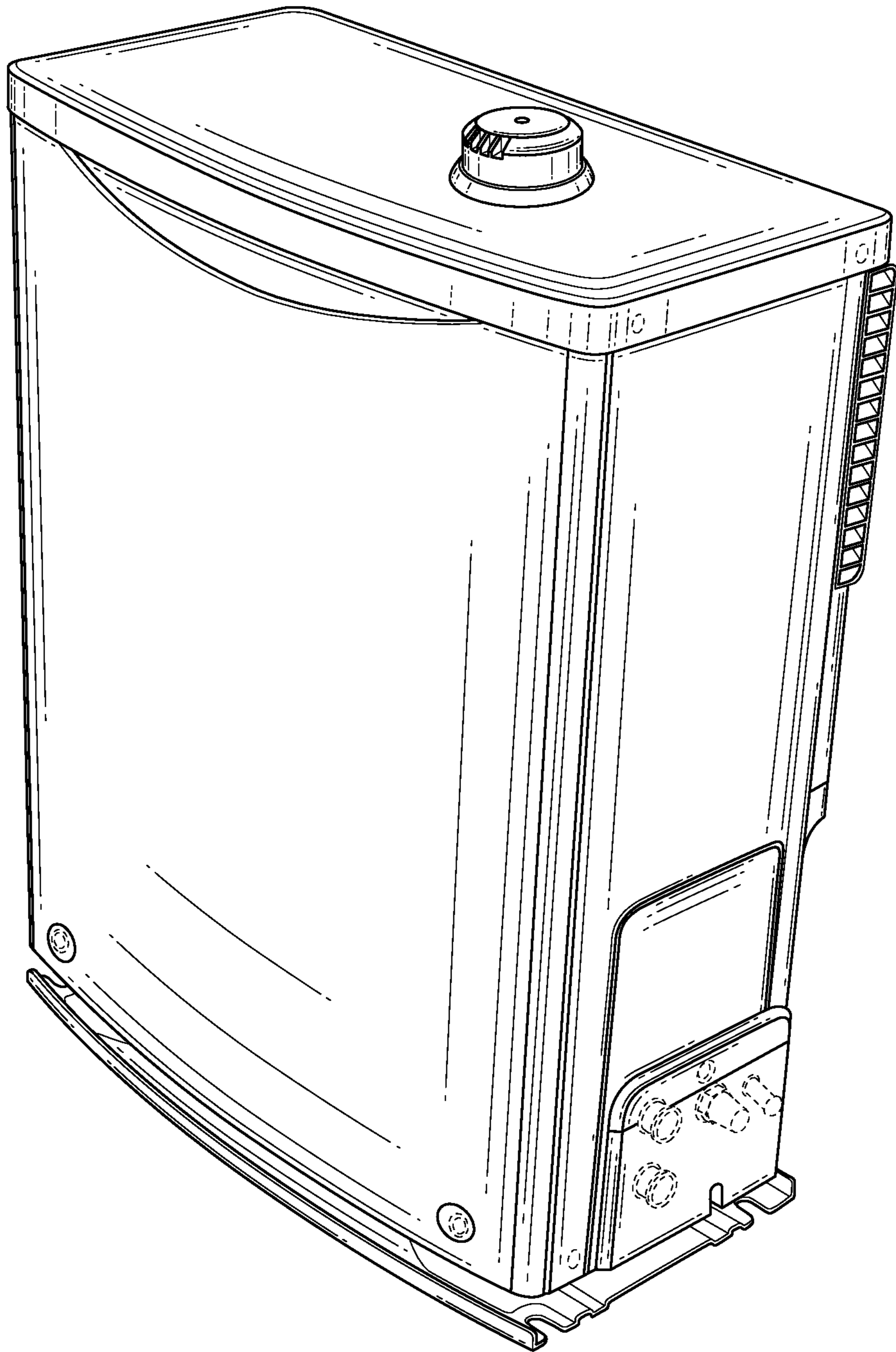

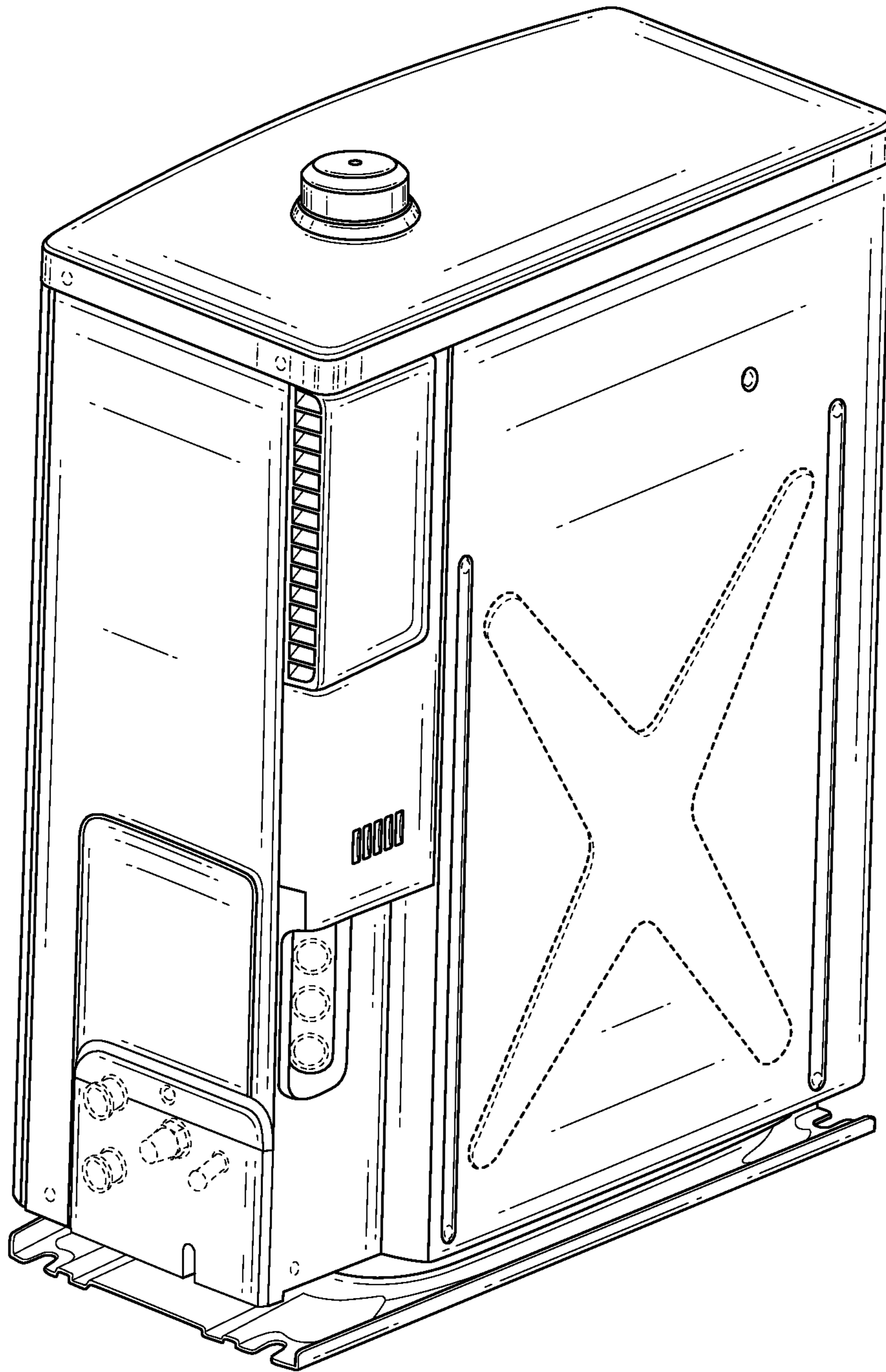

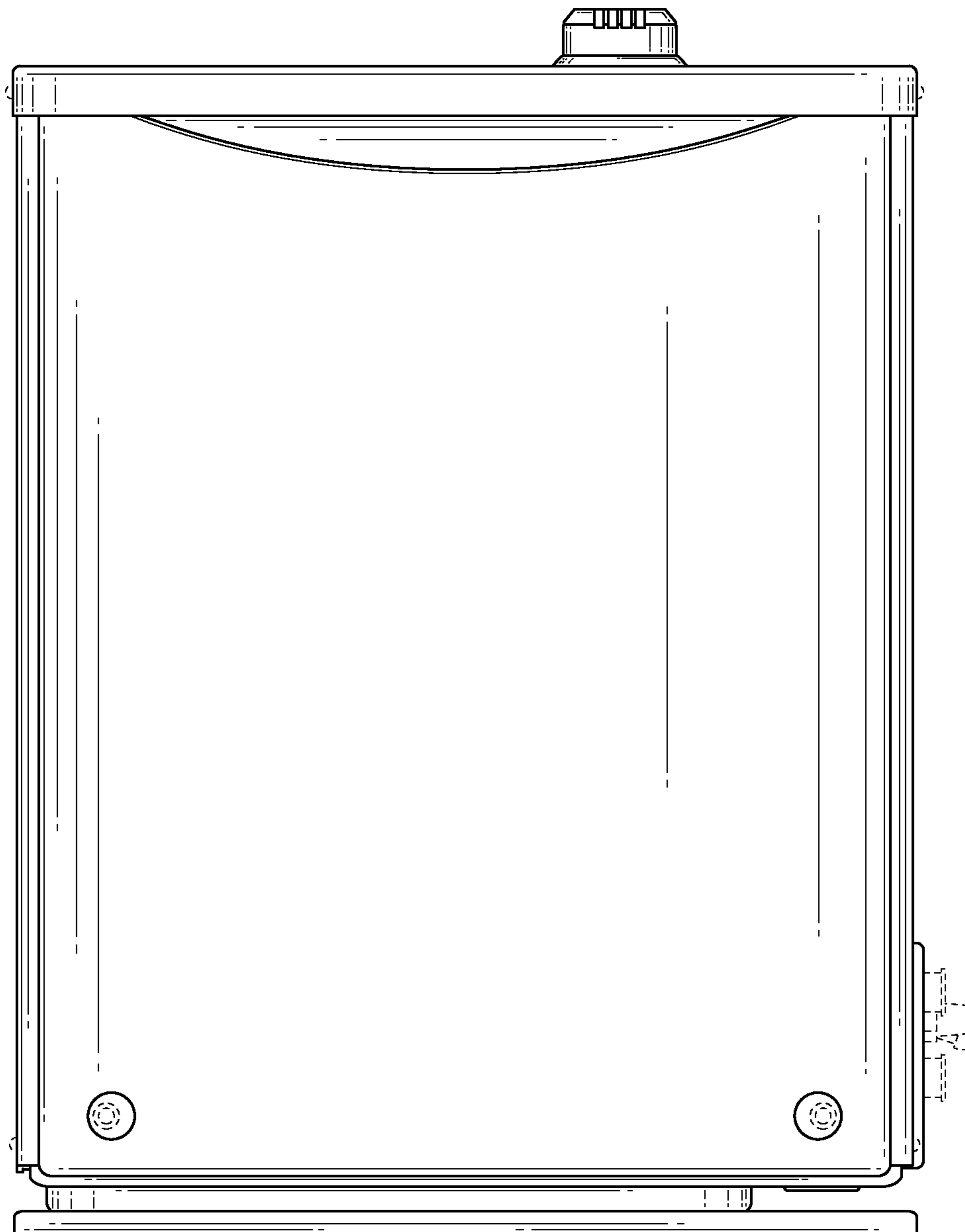

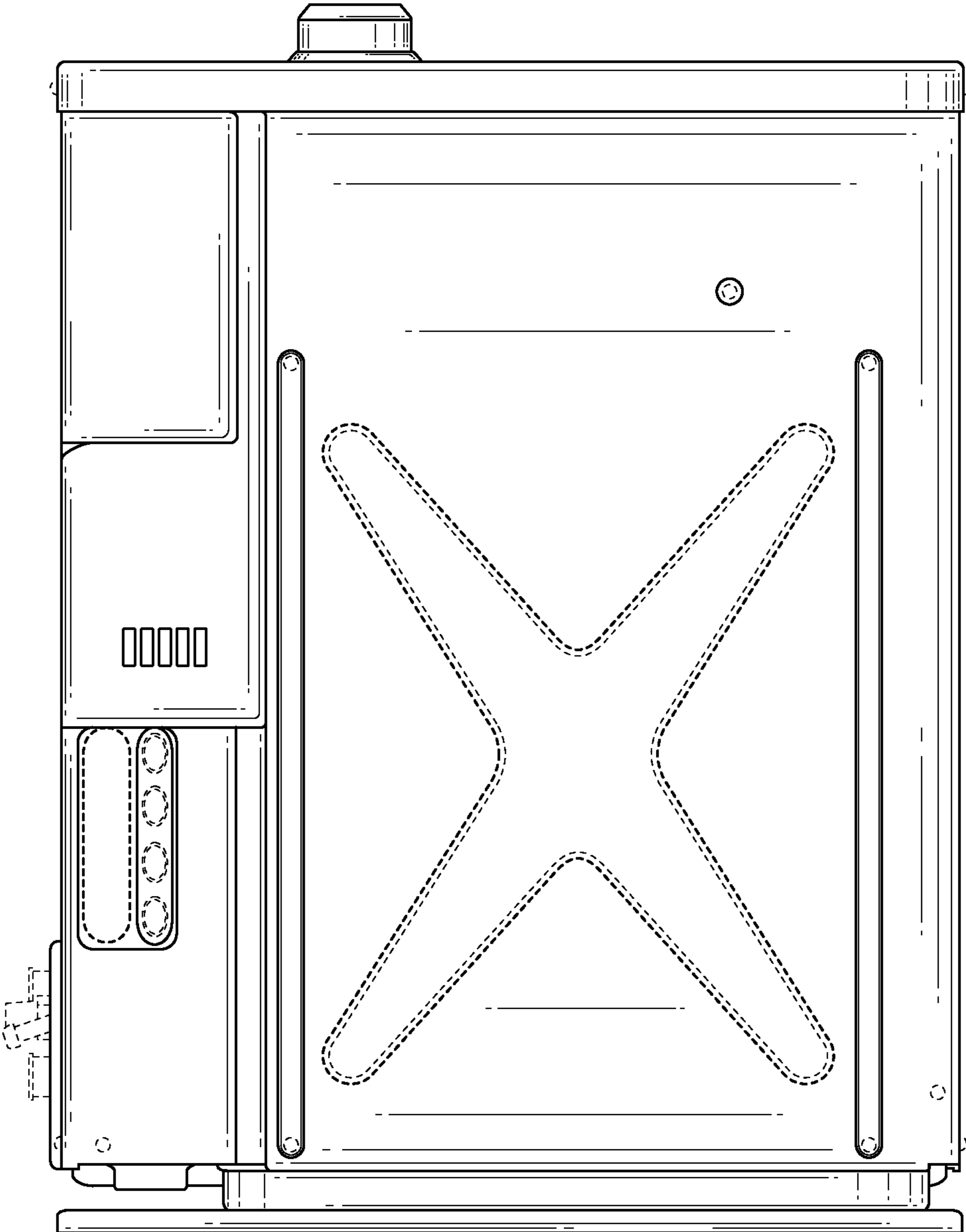

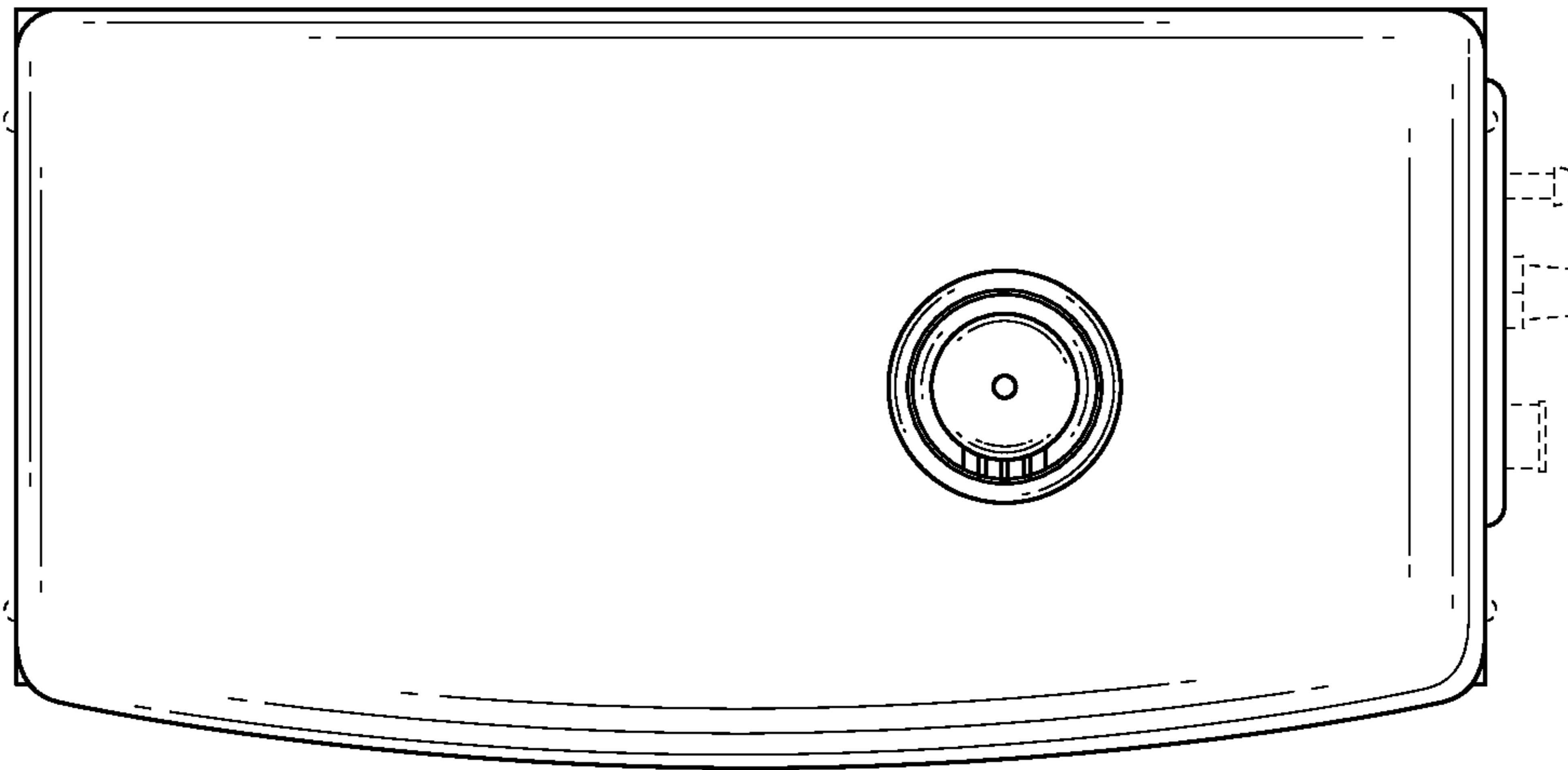

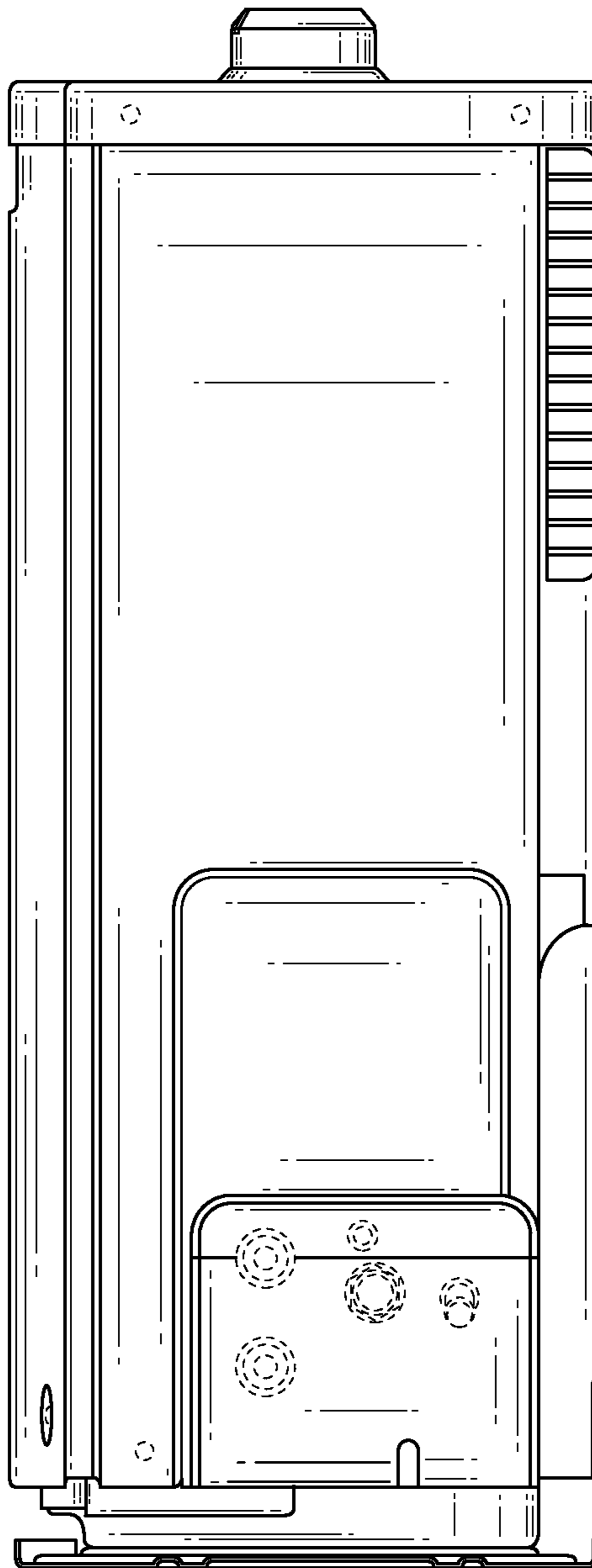
