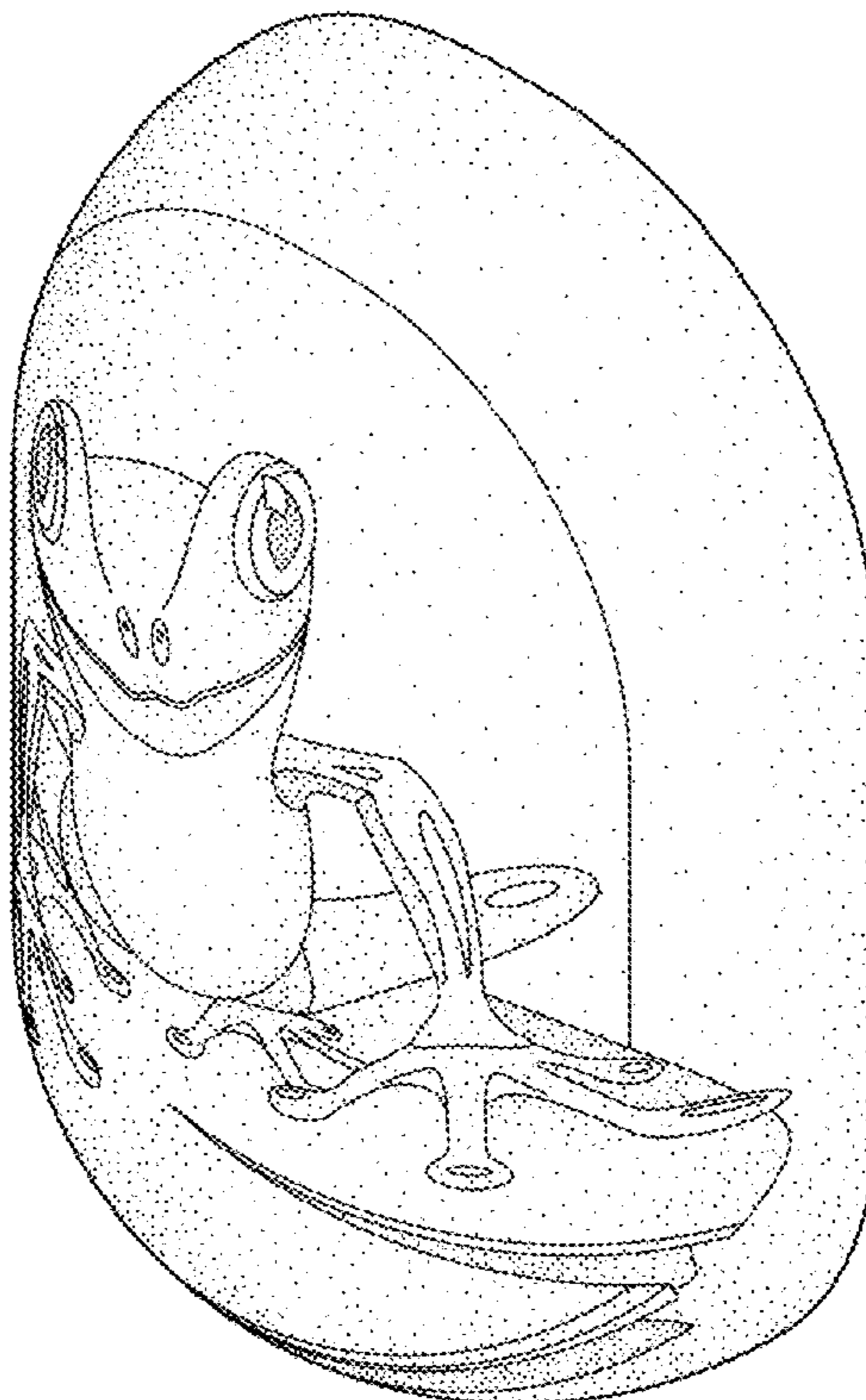
(57) **CLAIM**

The ornamental design for an electrical outlet cover with frog graphic, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of an electrical outlet cover with frog graphic incorporating my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

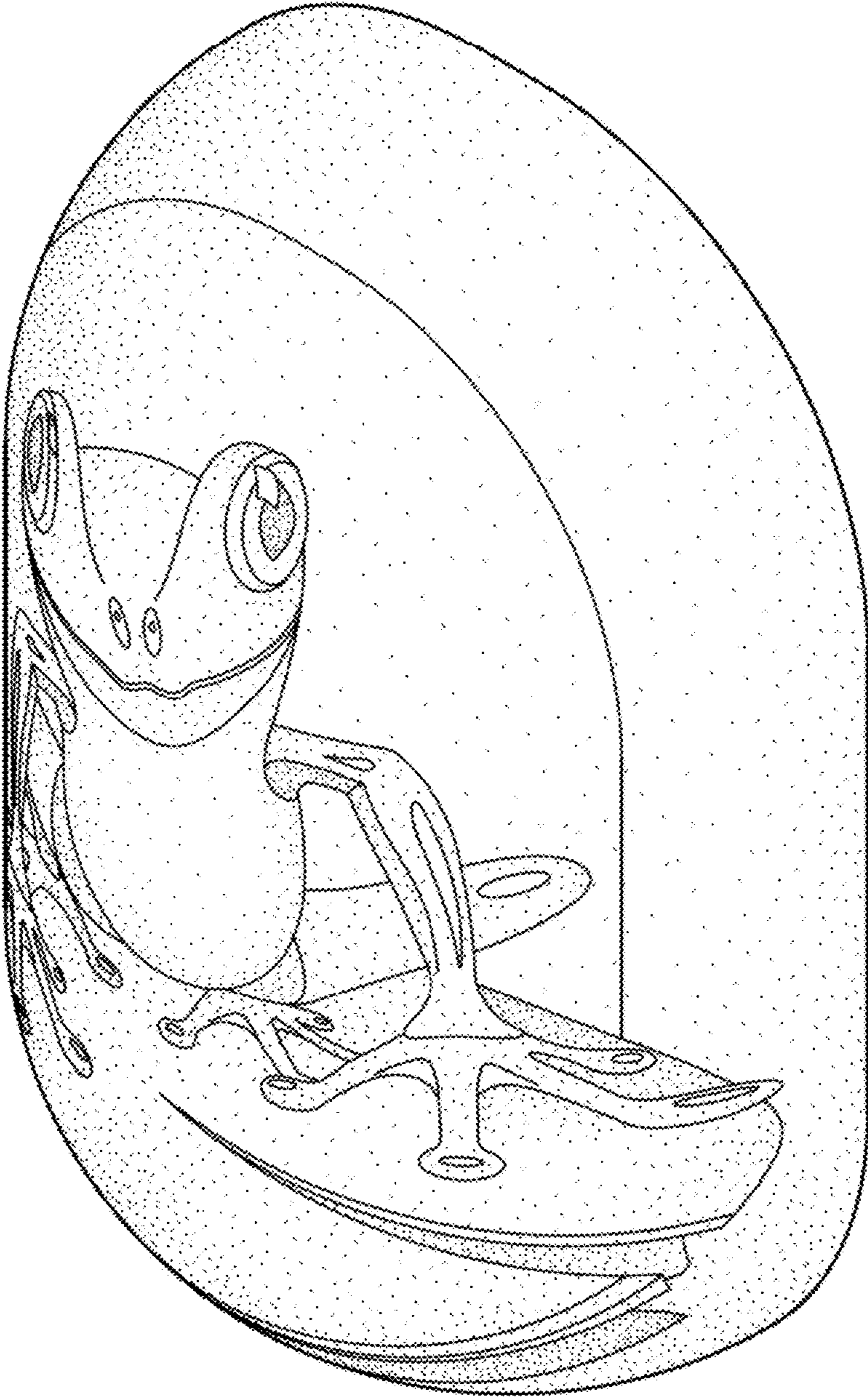

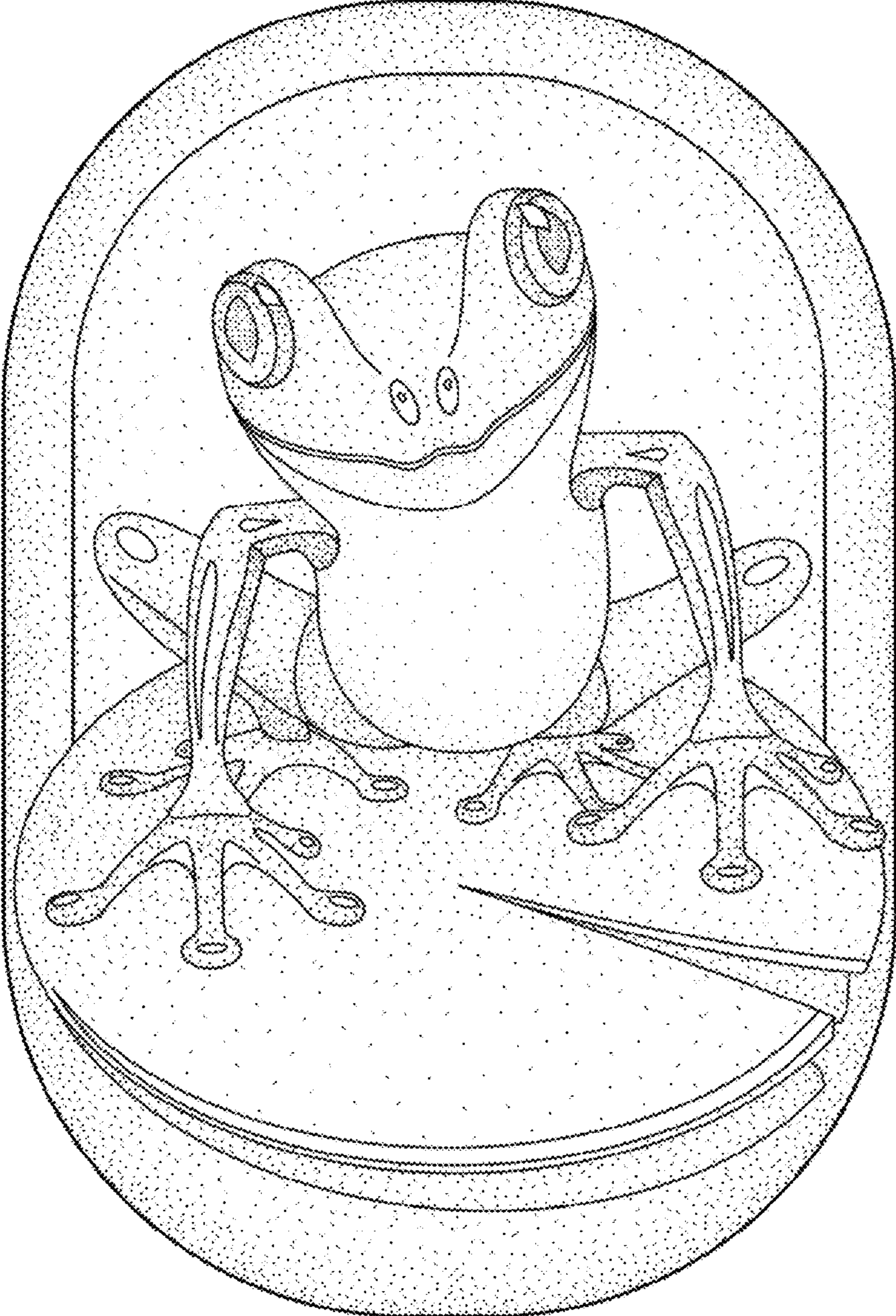

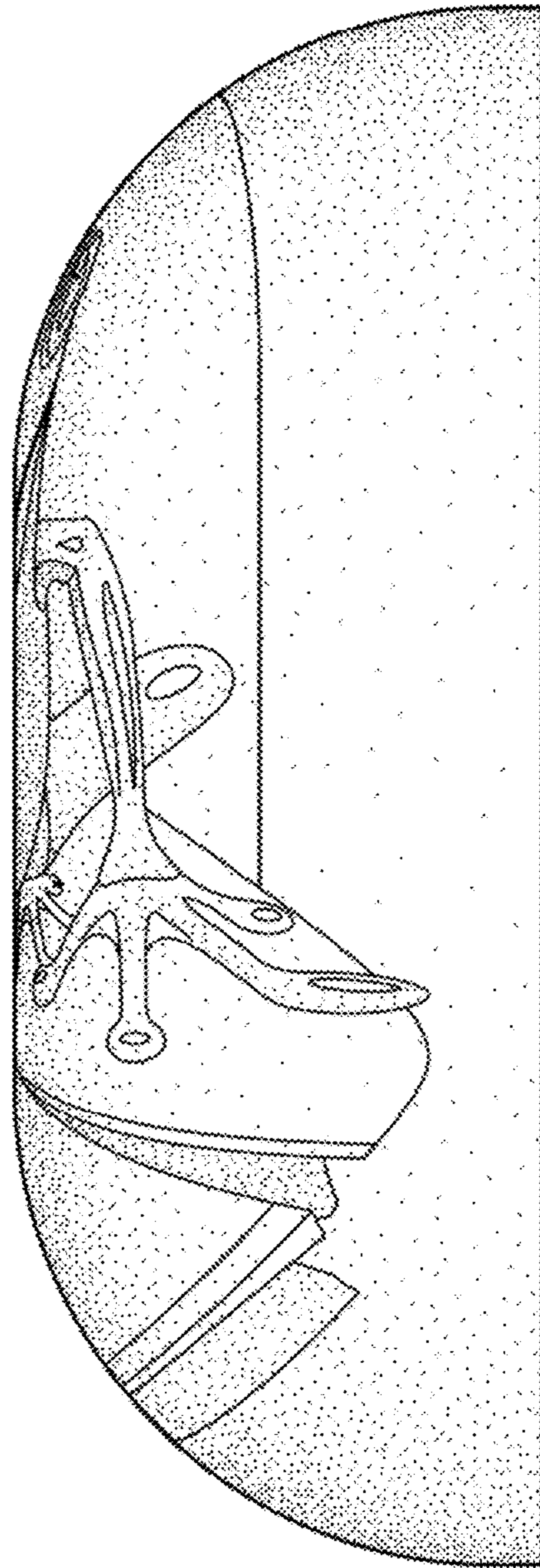

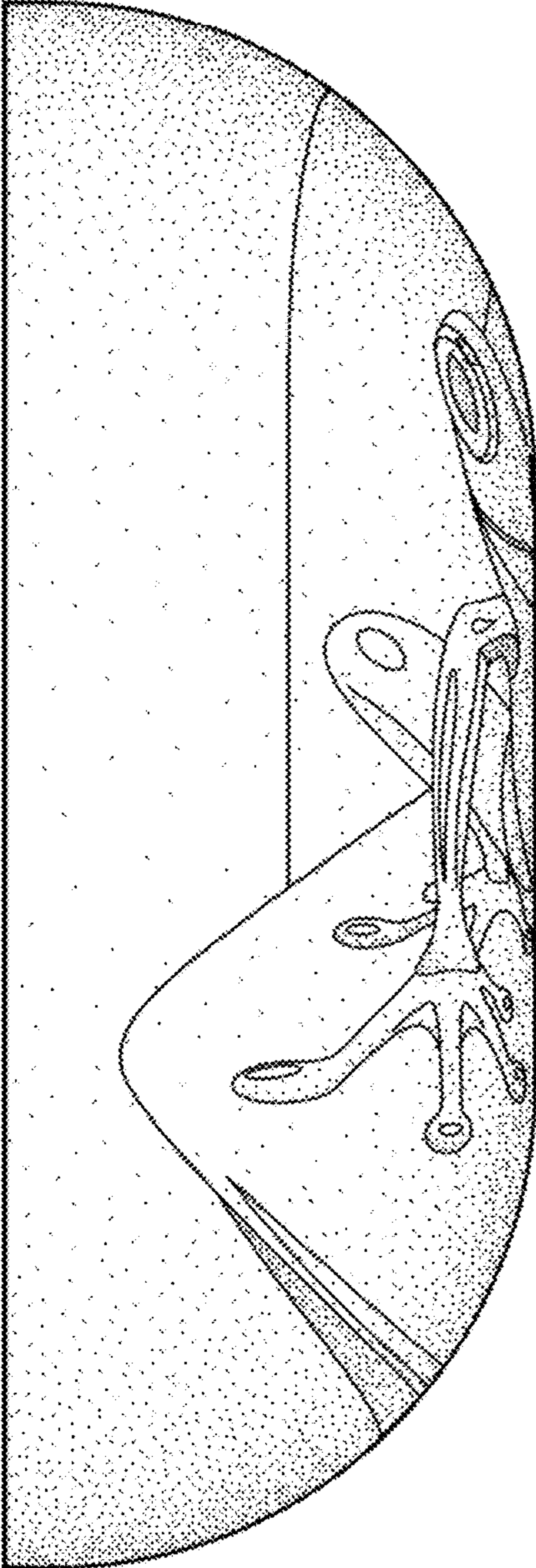

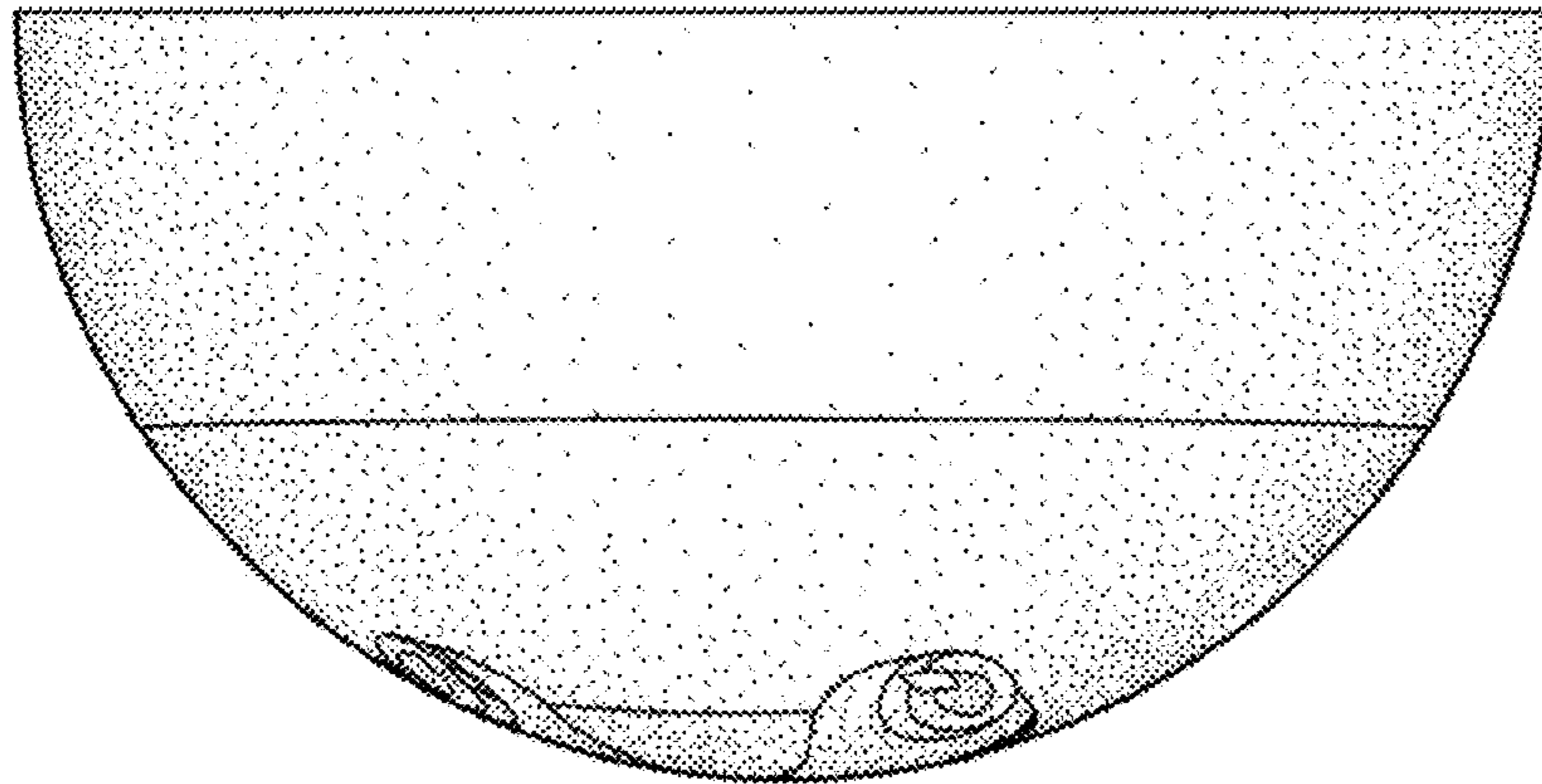

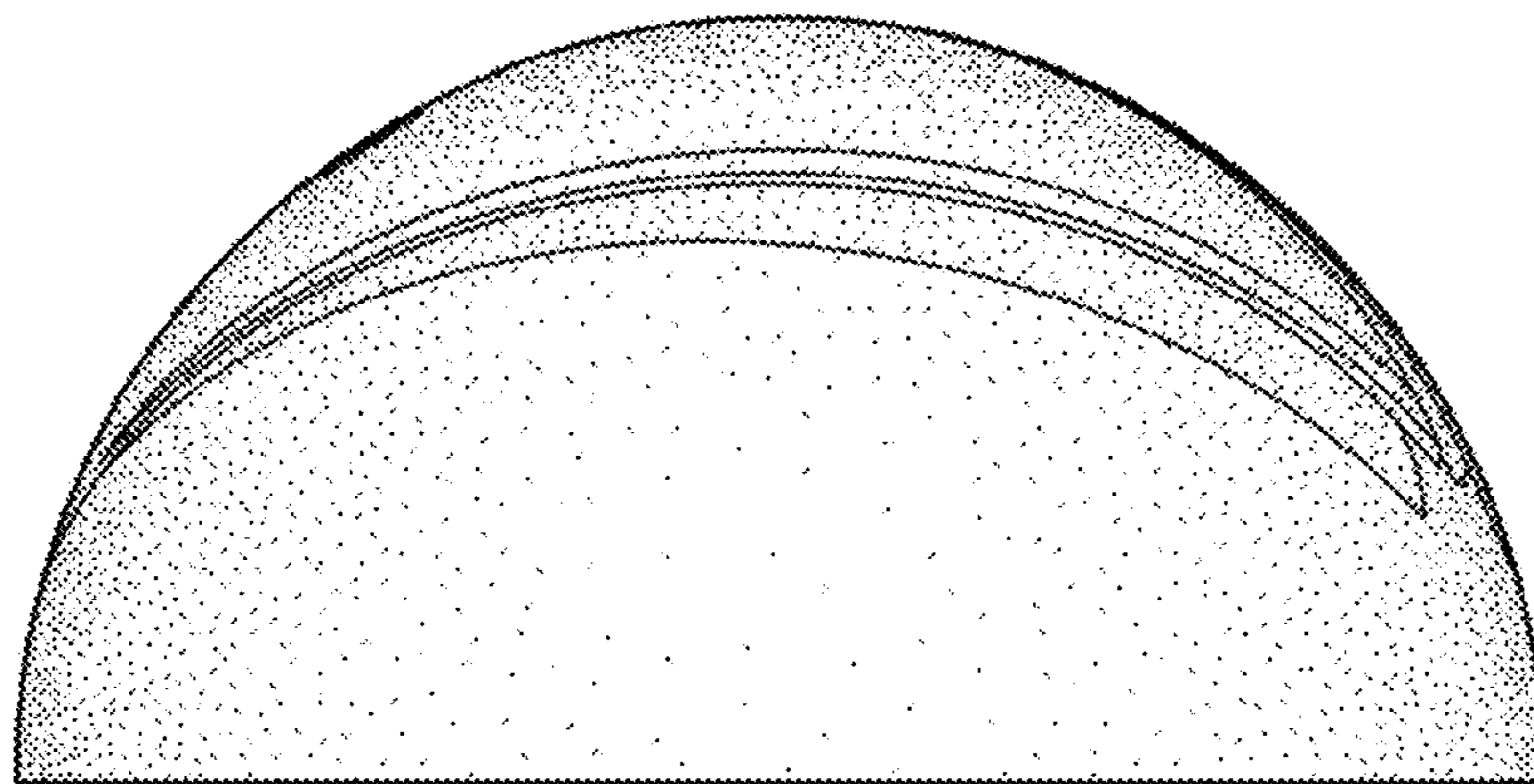
