The ornamental design for a protective cover for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a protective cover for an electronic device;

FIG. 5 is a side view of the longer, left side of the protective cover for an electronic device;

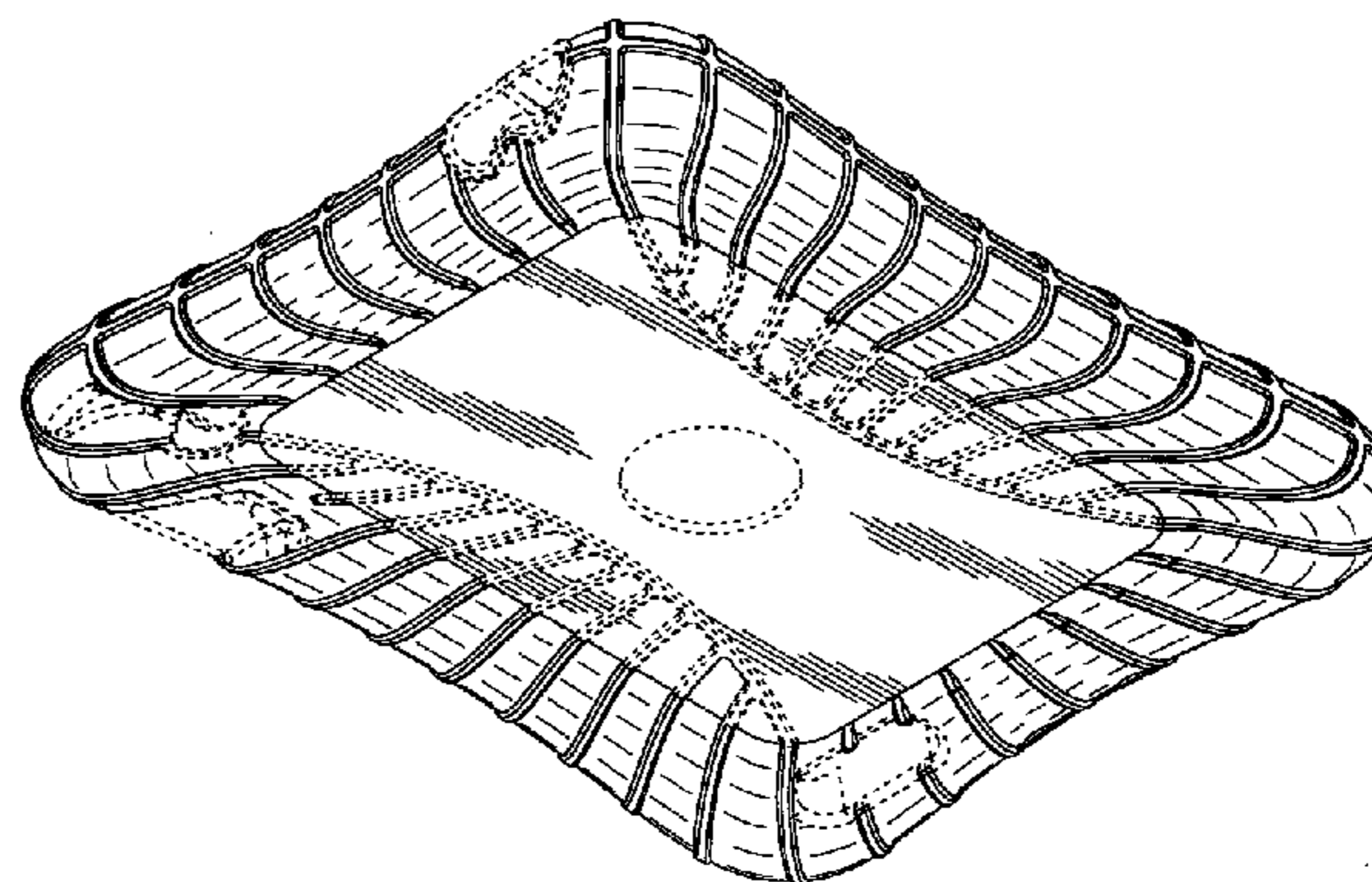
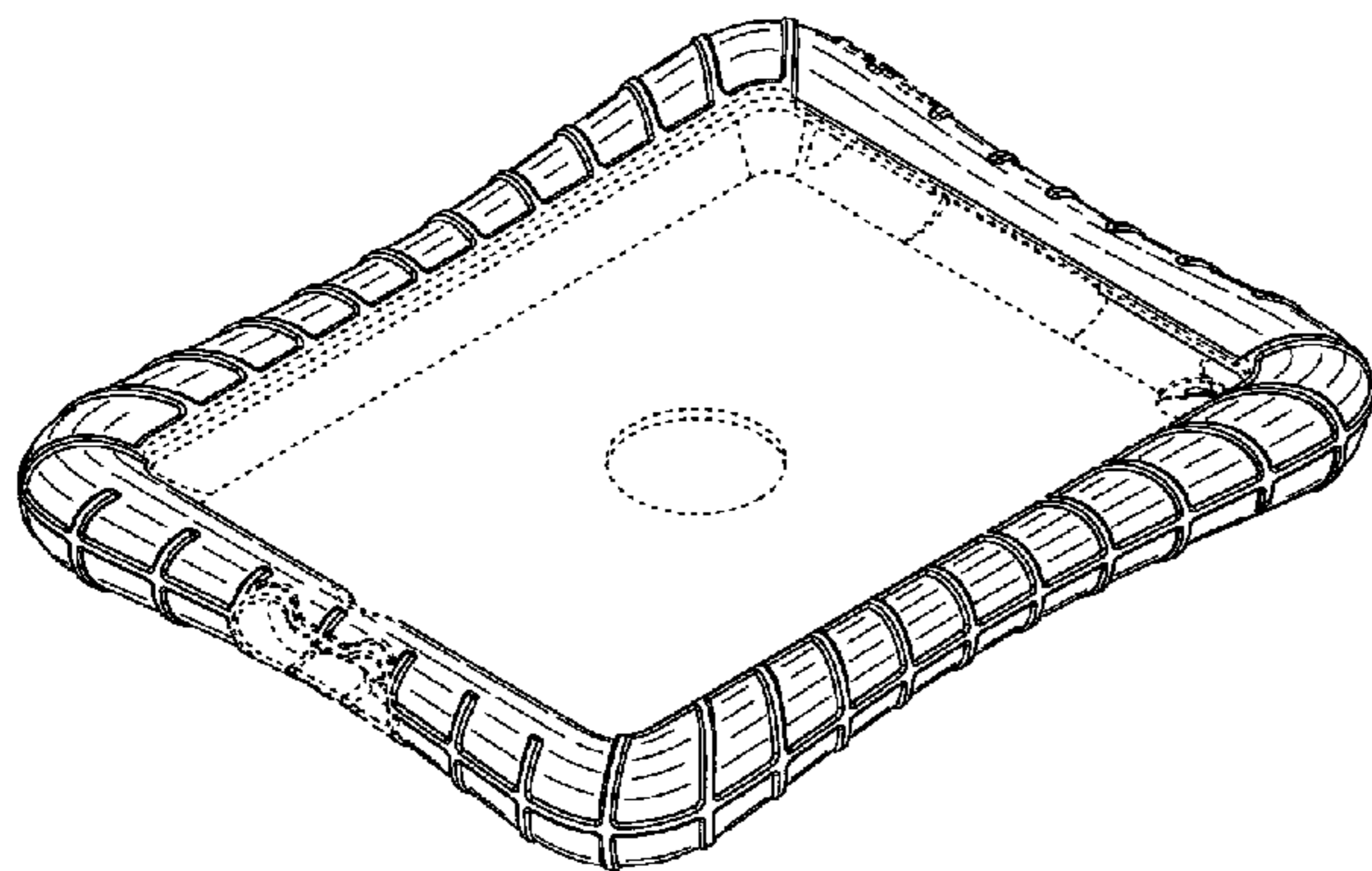
FIG. 6 is a side view of the longer, right side of the protective cover for an electronic device;

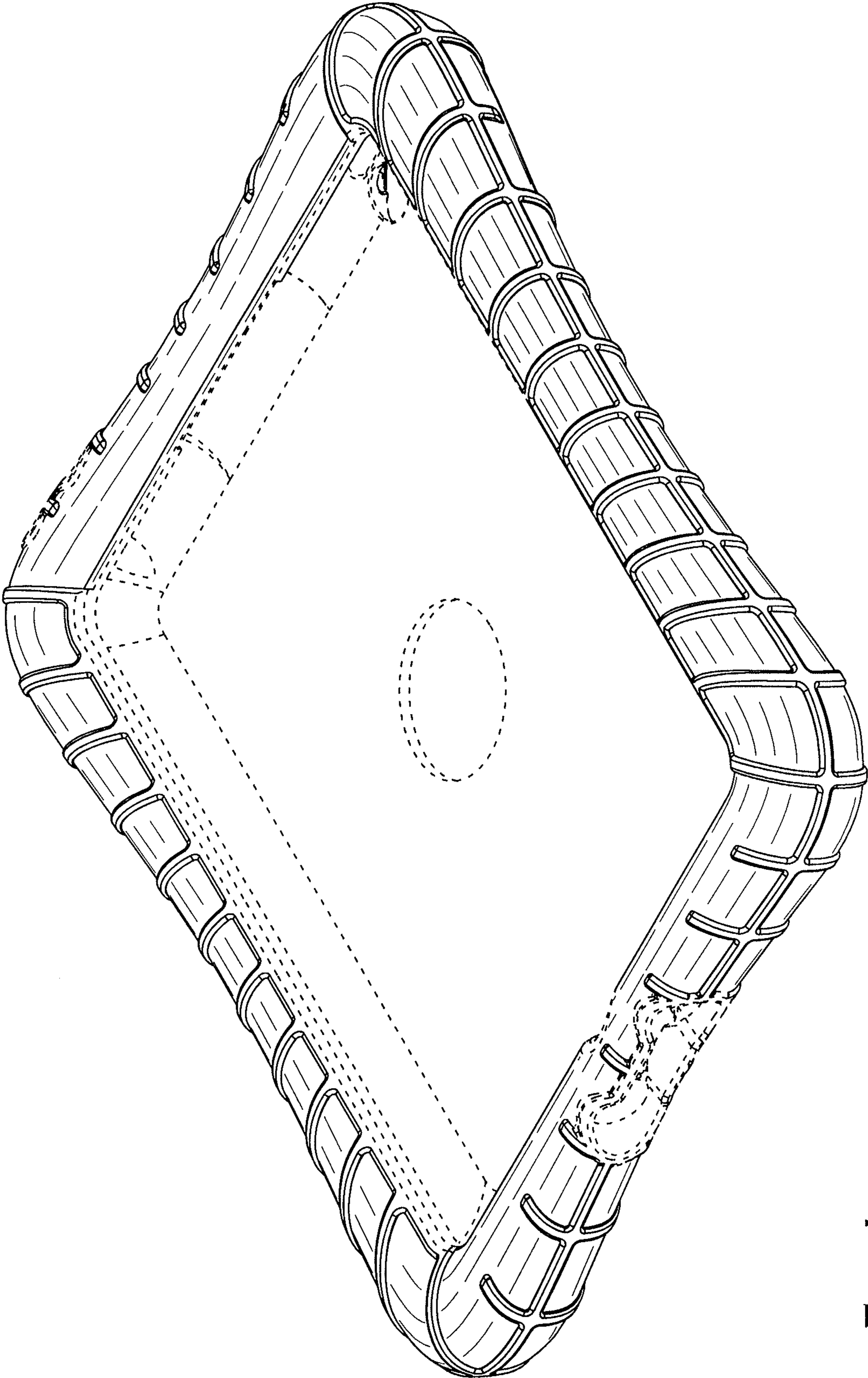

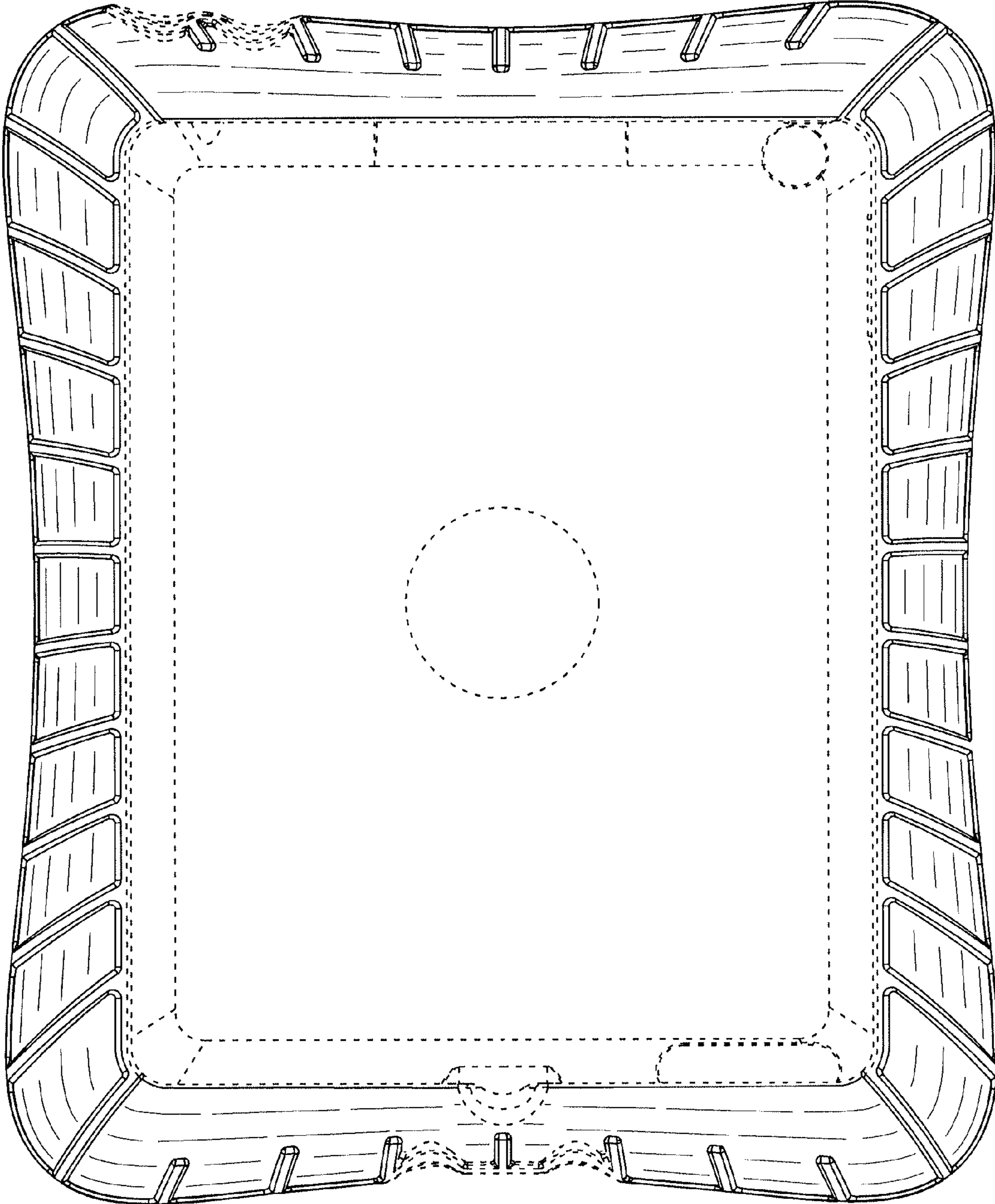

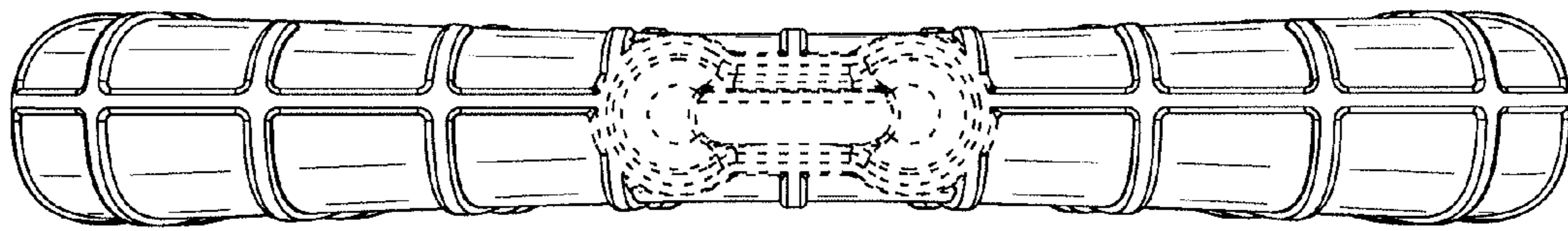

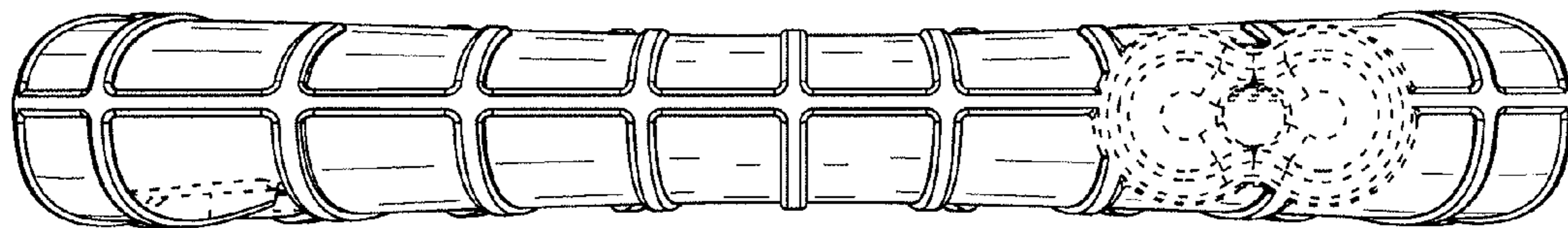

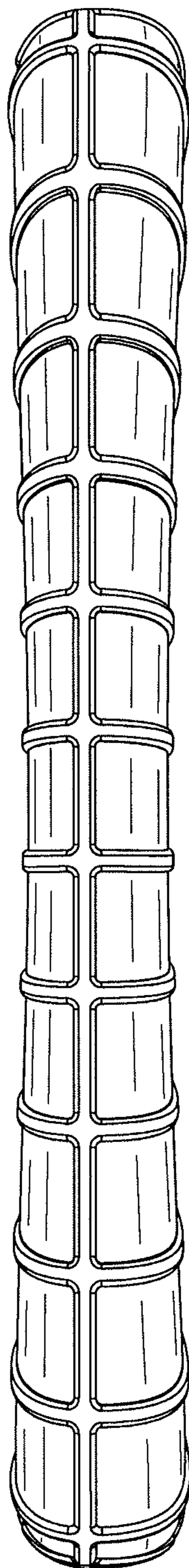

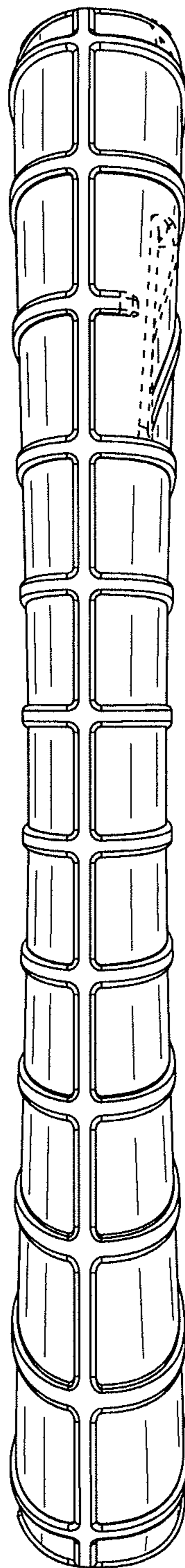

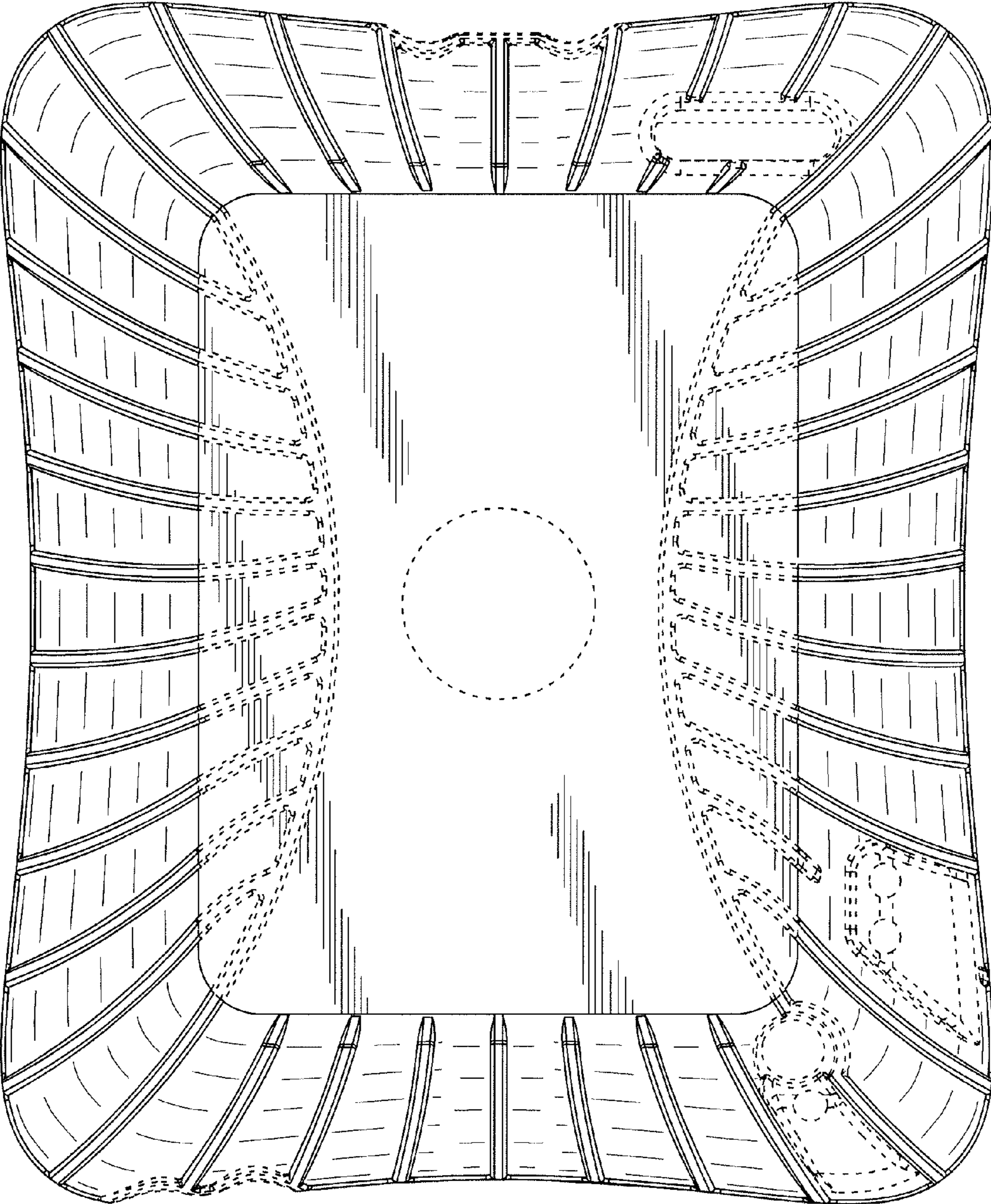

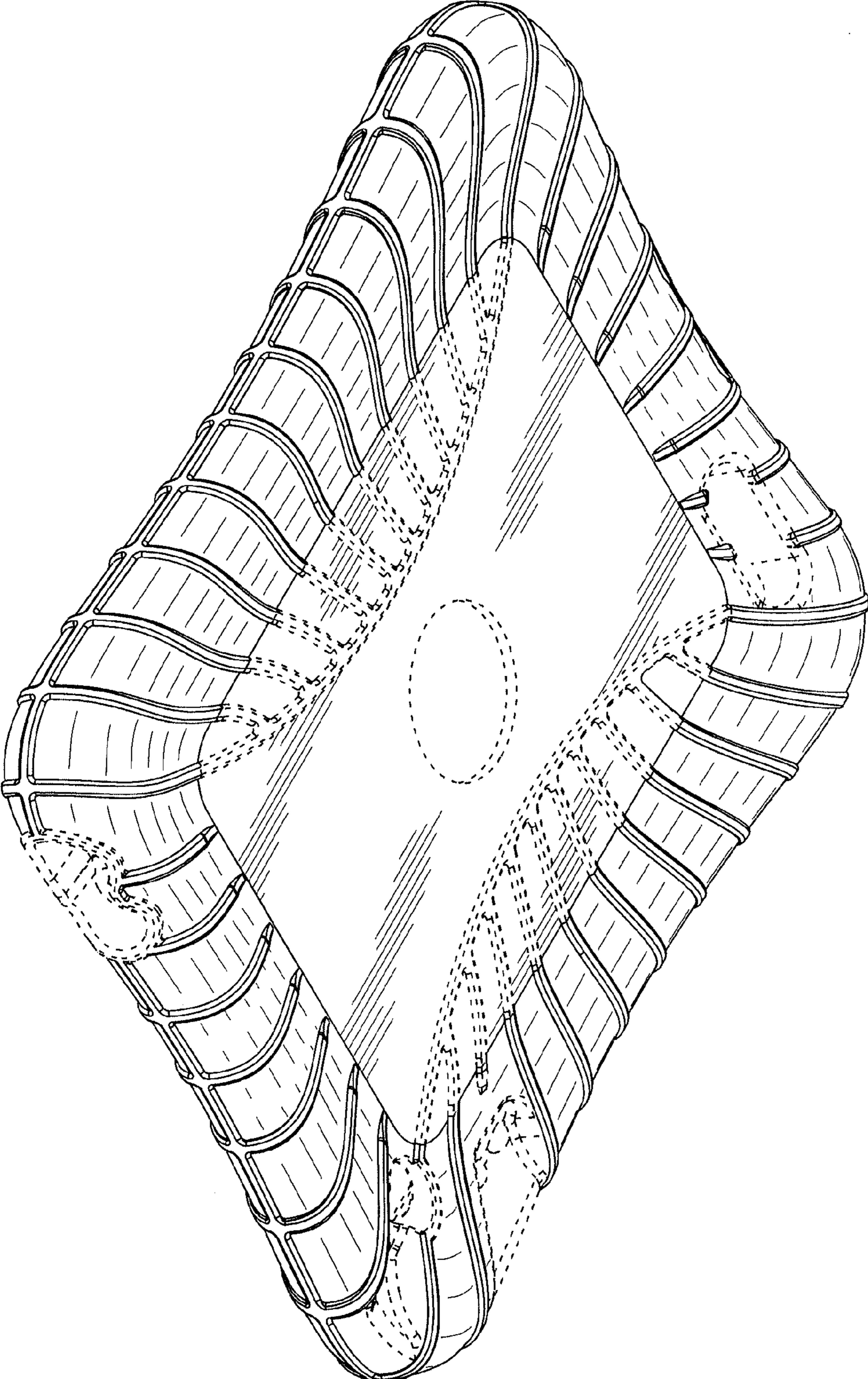
