The ornamental design for an all in one turning tool, as shown and described.

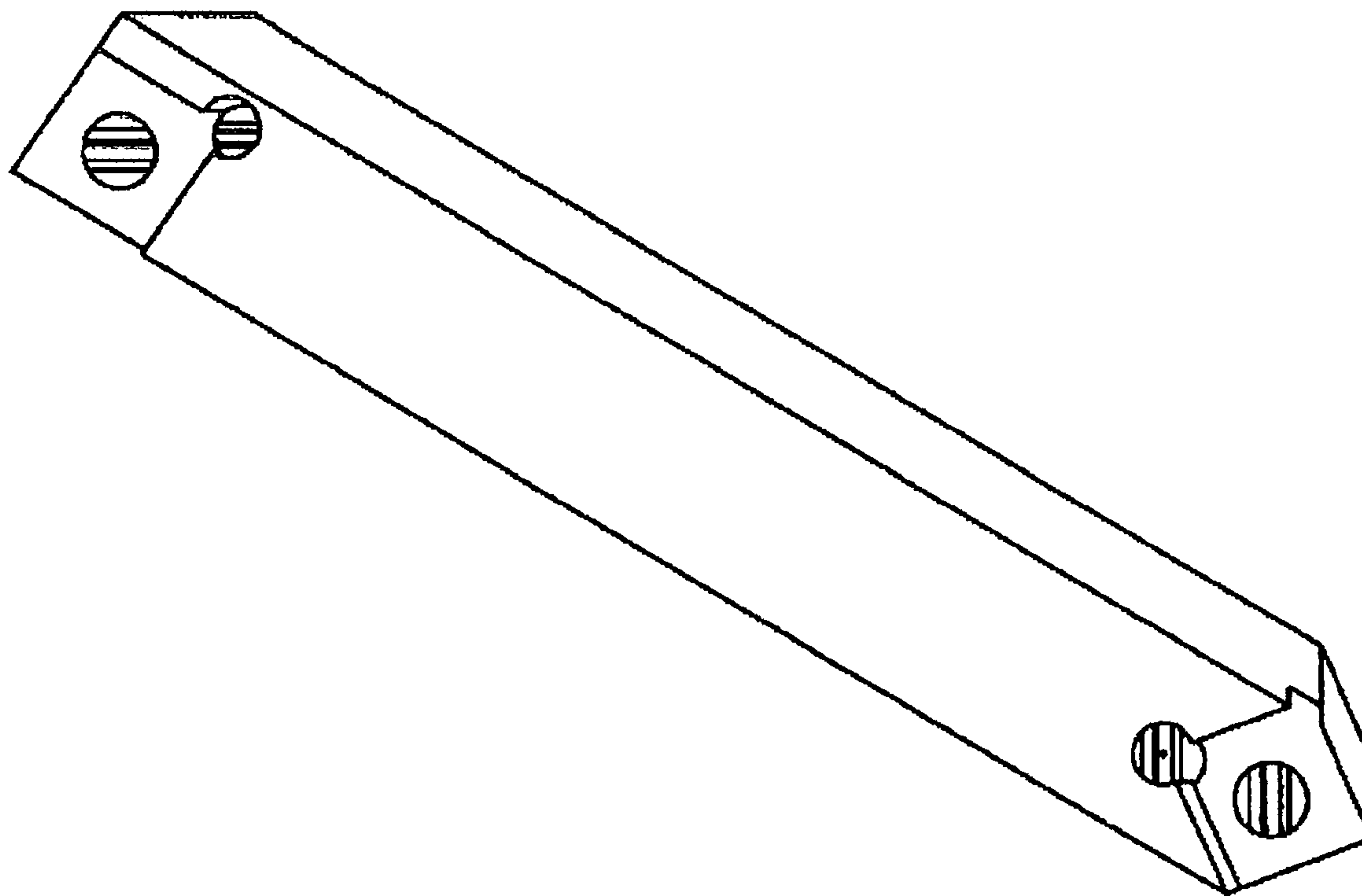
**DESCRIPTION**

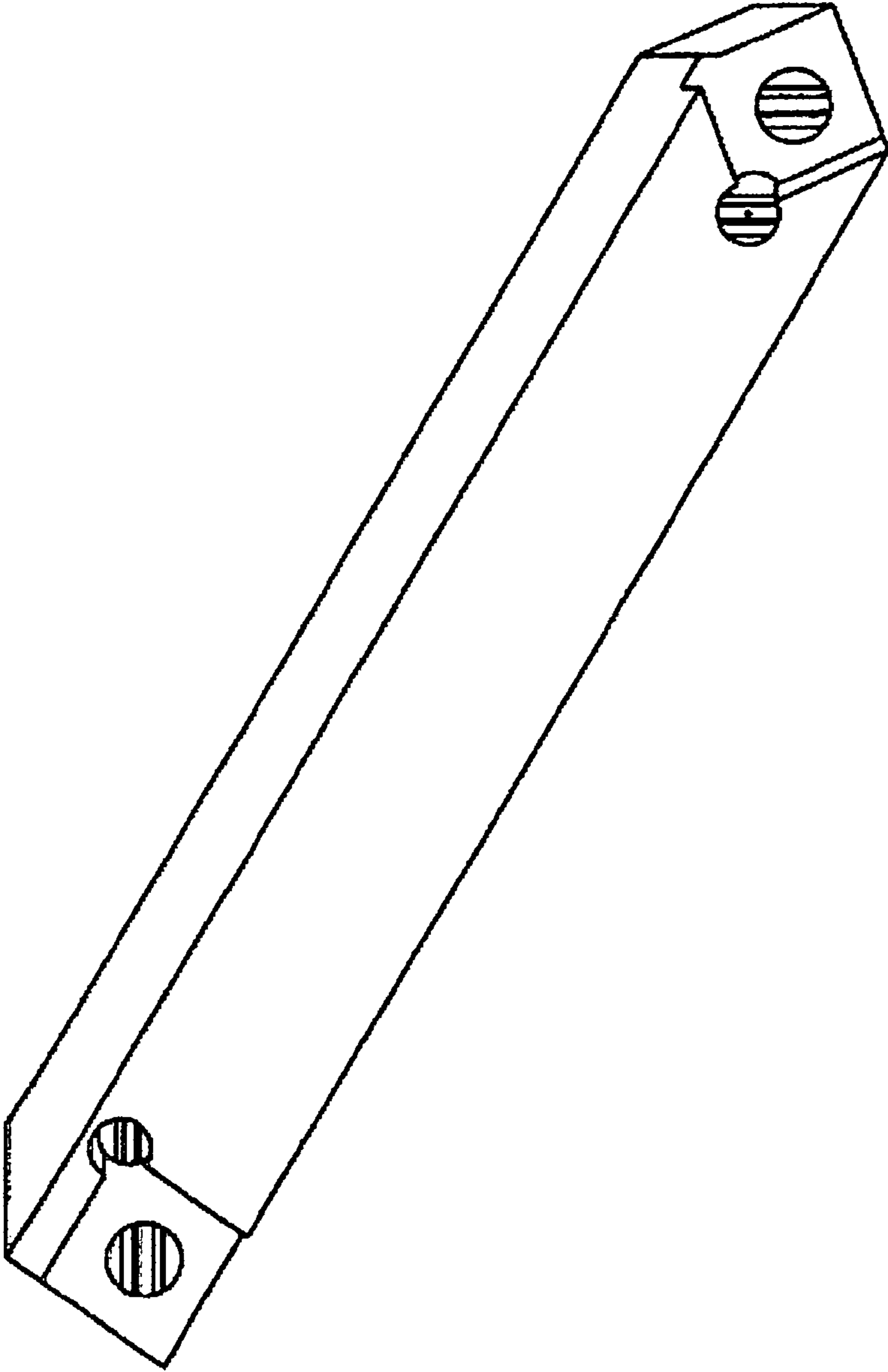

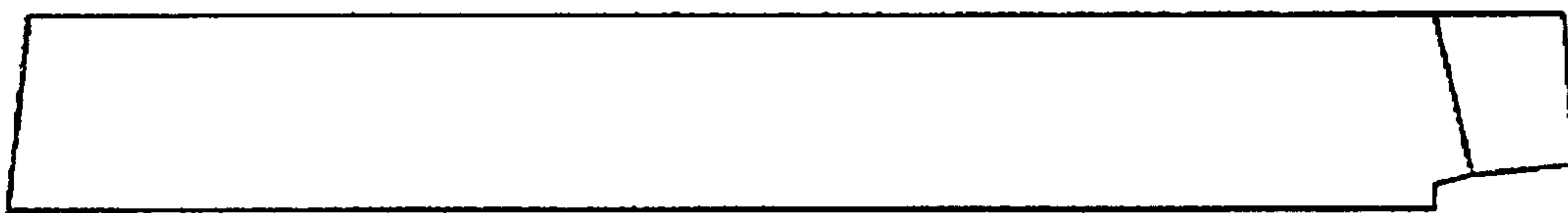

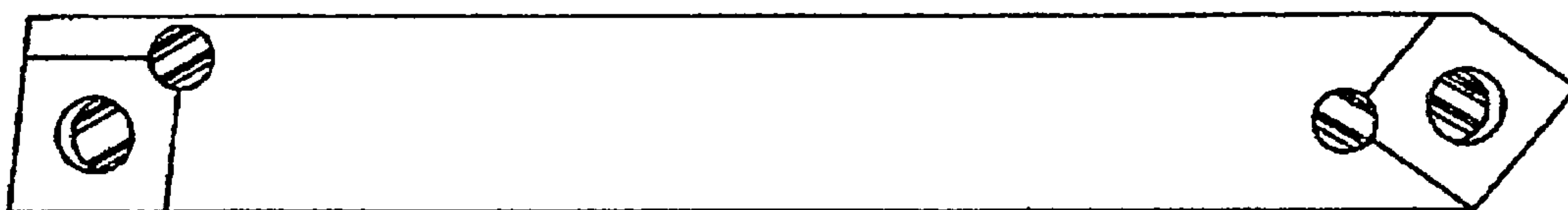
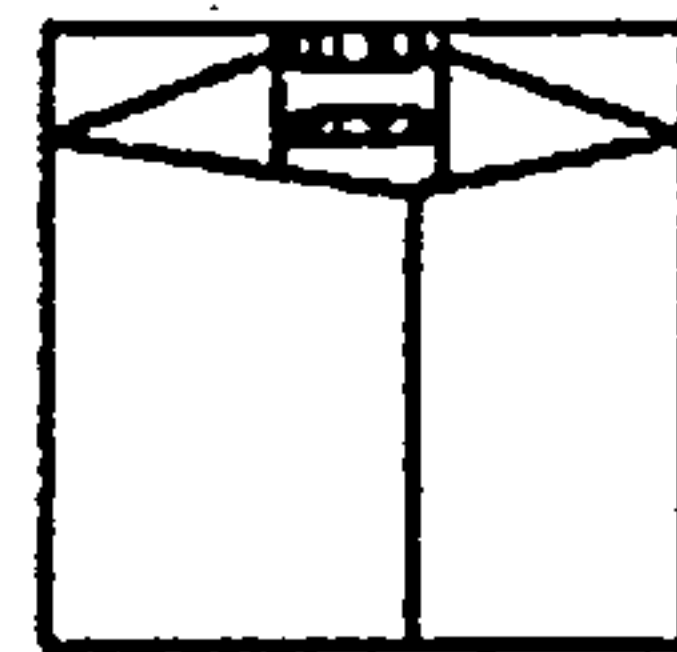
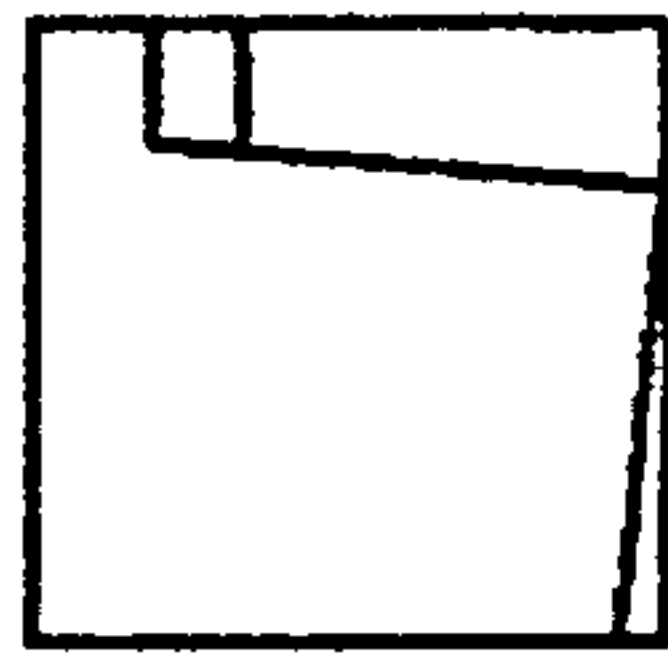
