FIG. 3 is an end view of the putting apparatus of FIG. 1;

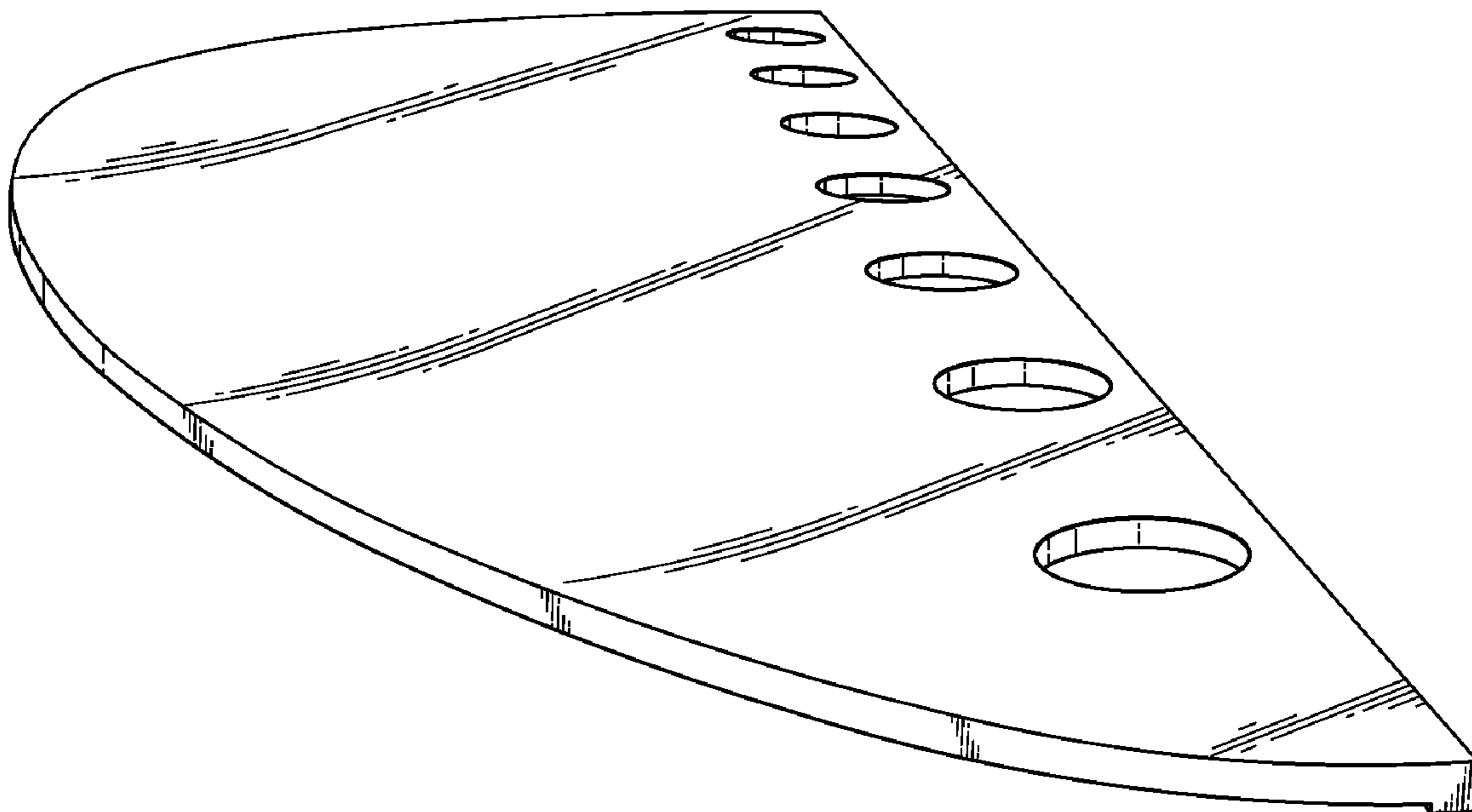
FIG. 4 is the other end view thereof;

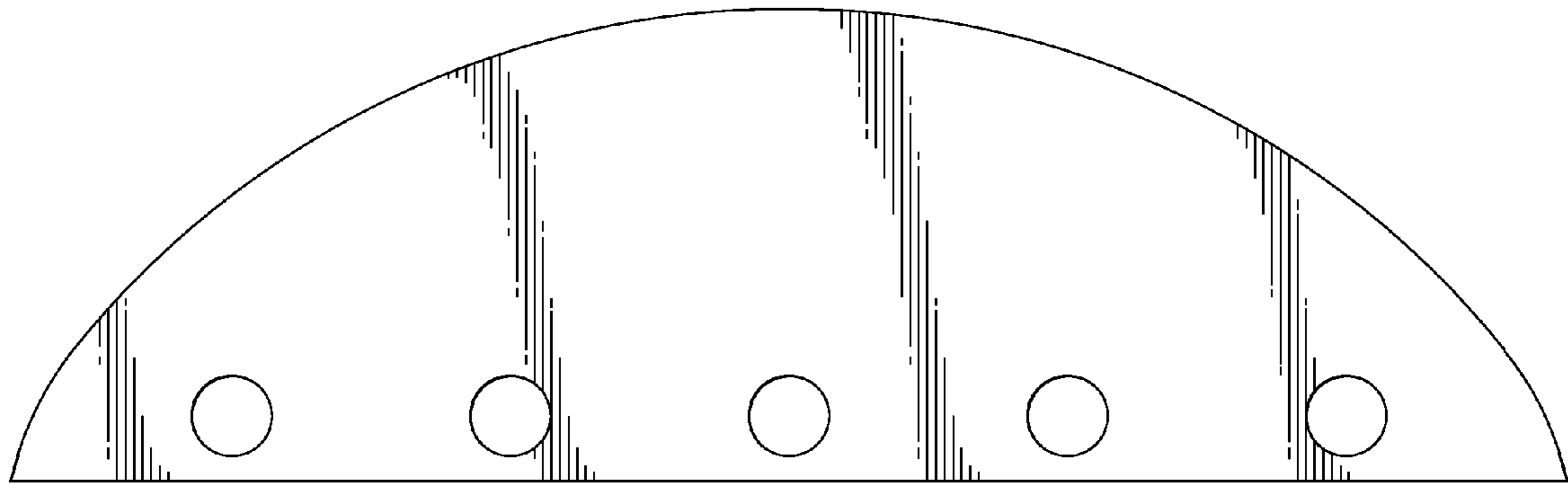

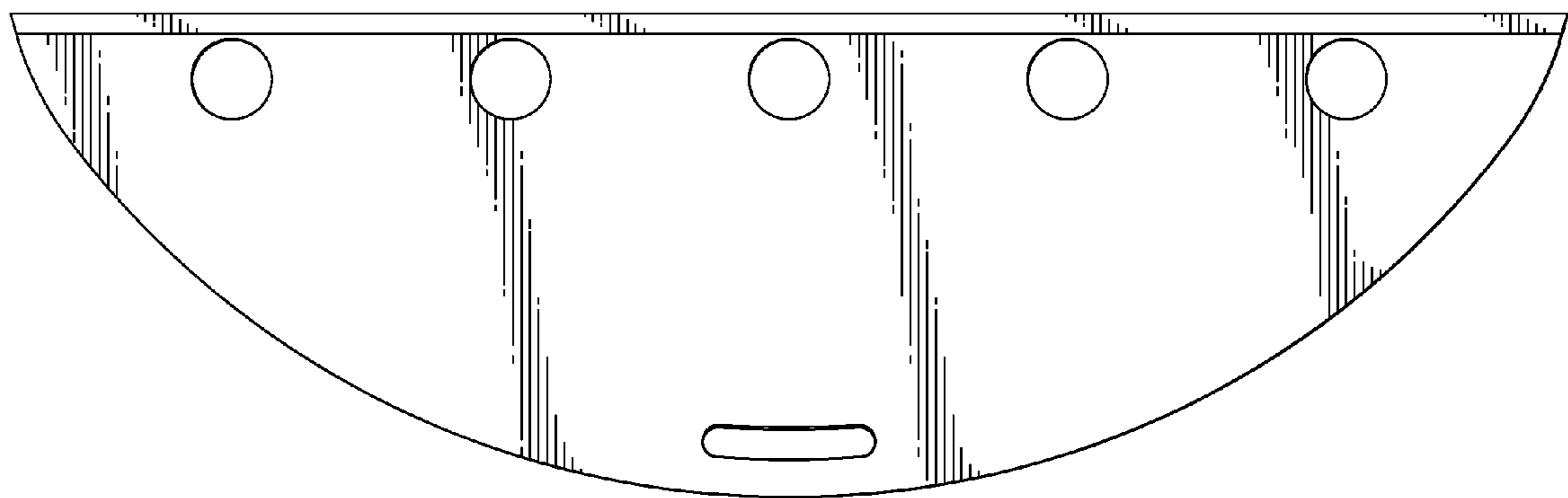

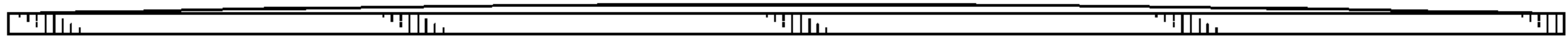

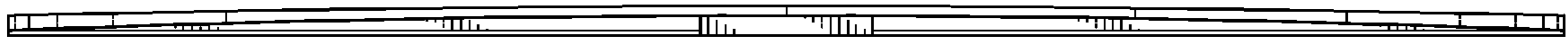

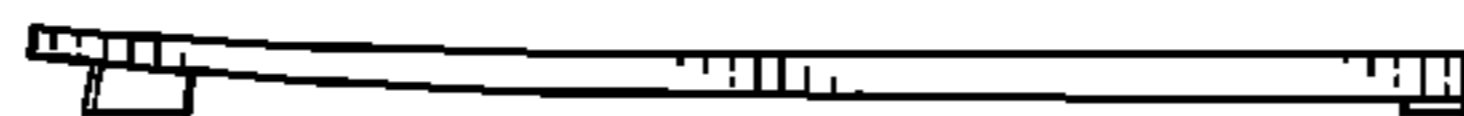

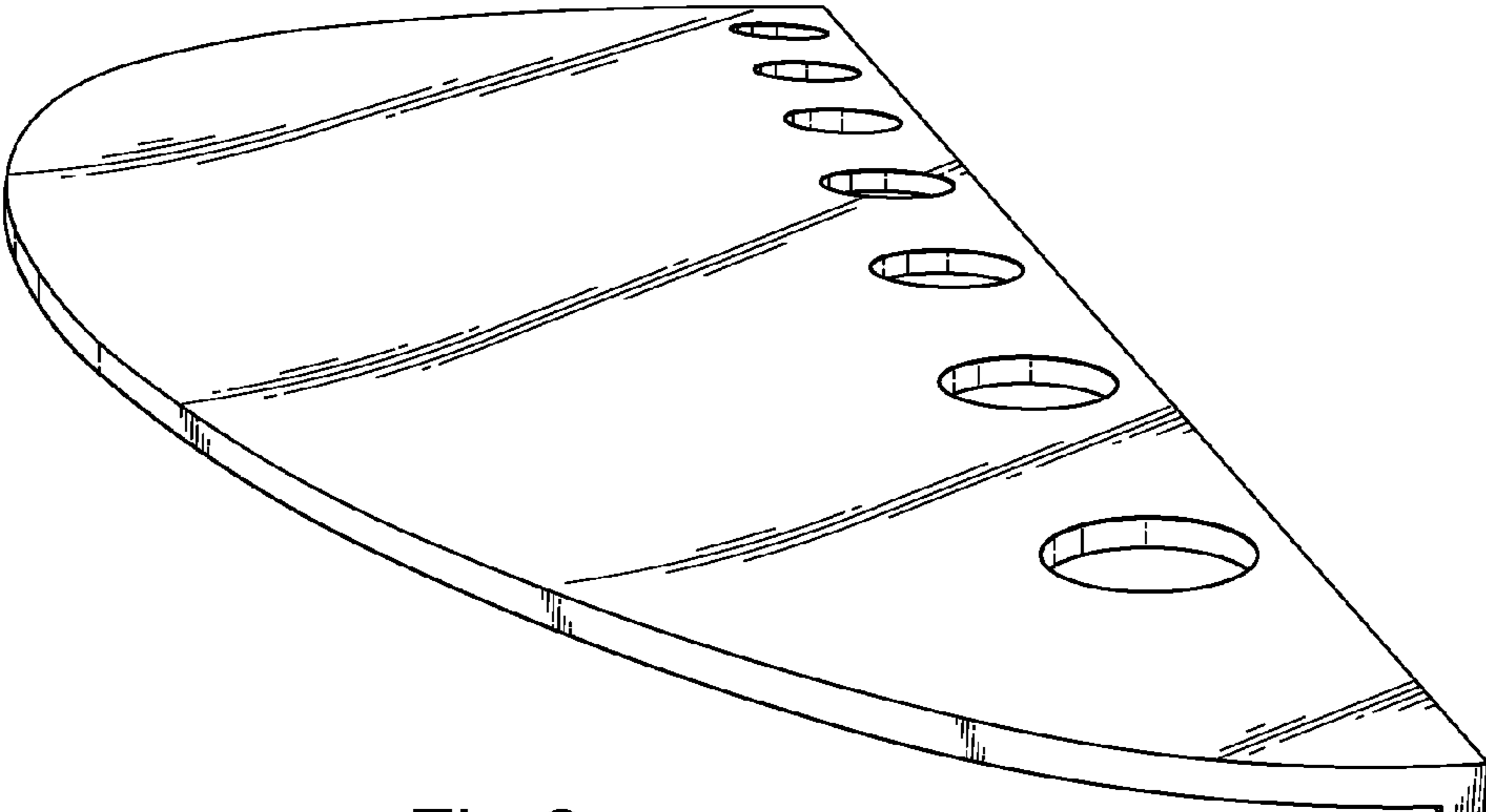

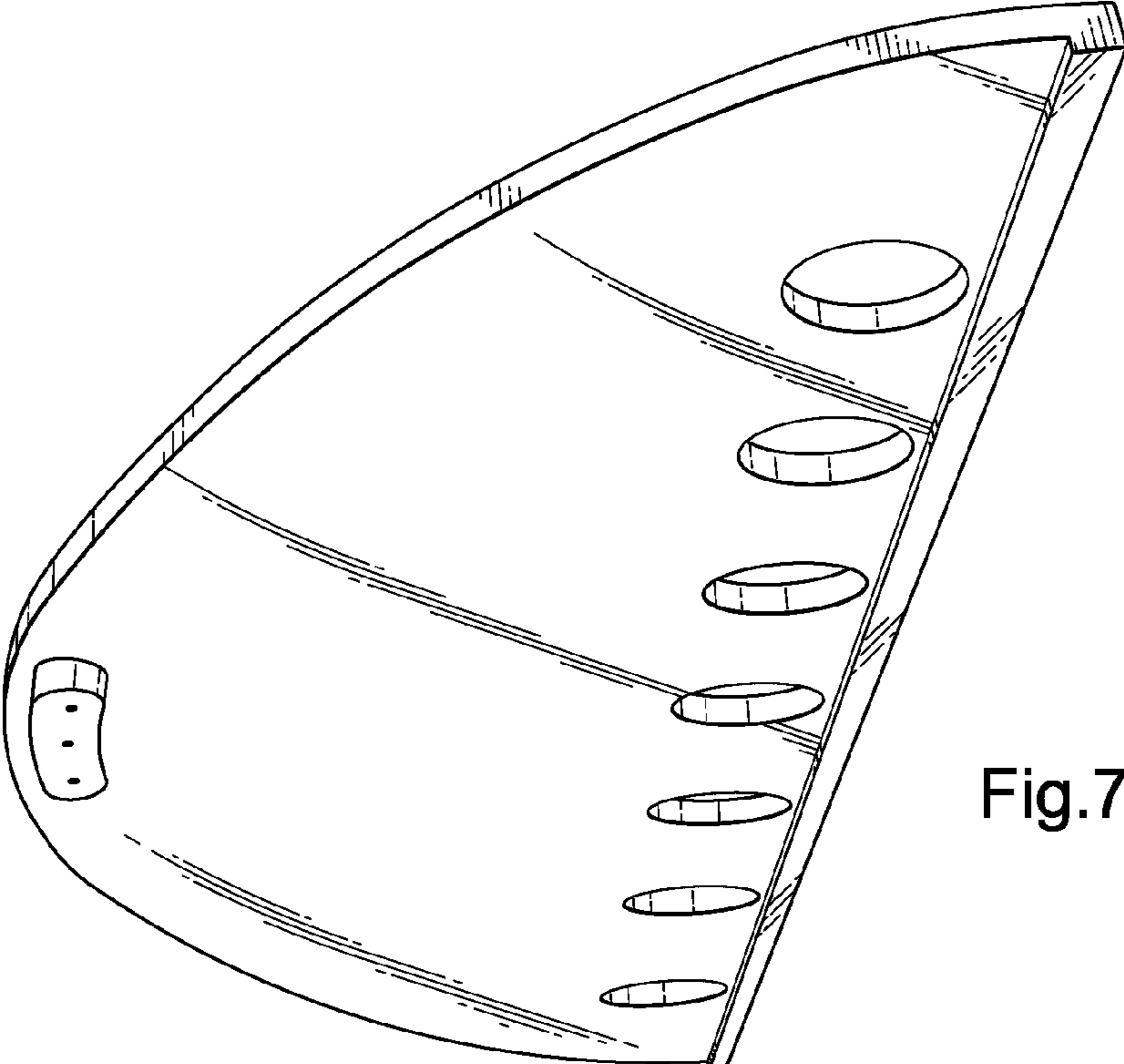
