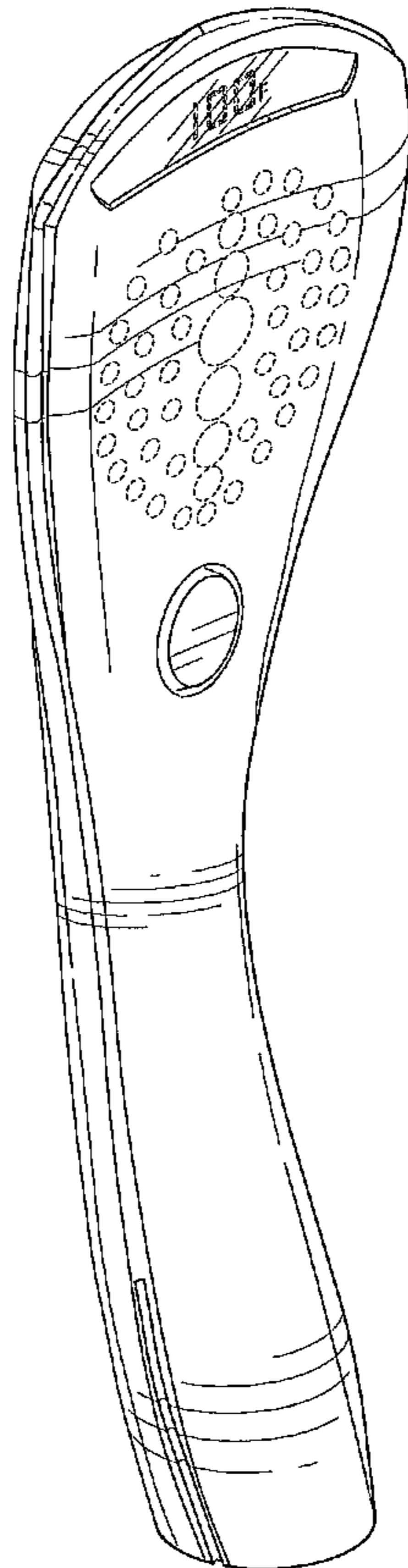
The ornamental design for a handheld shower, as shown and described.

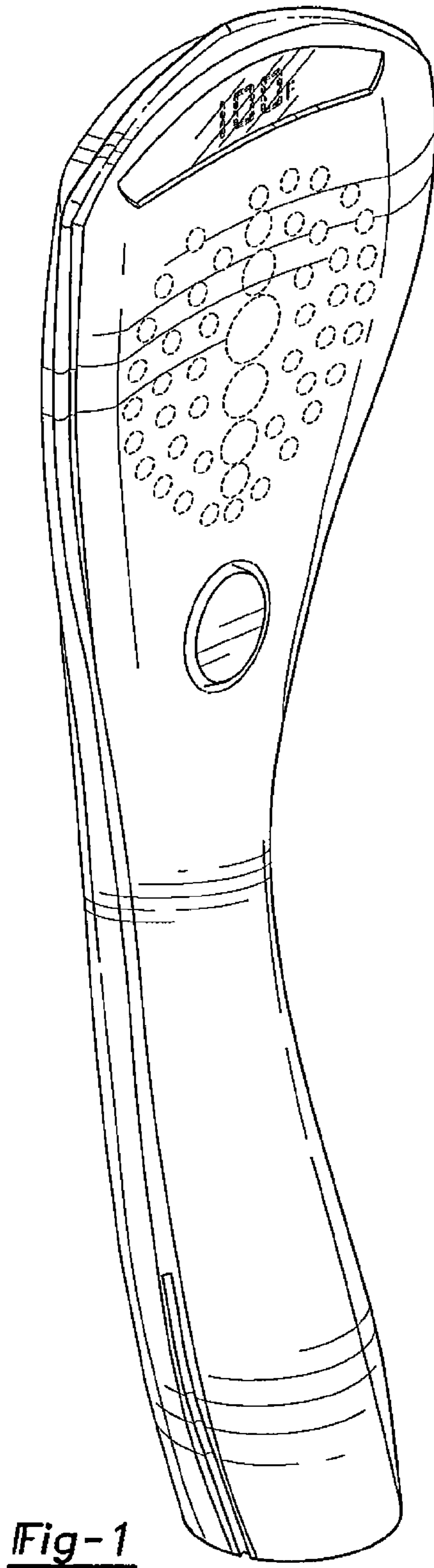
**DESCRIPTION**

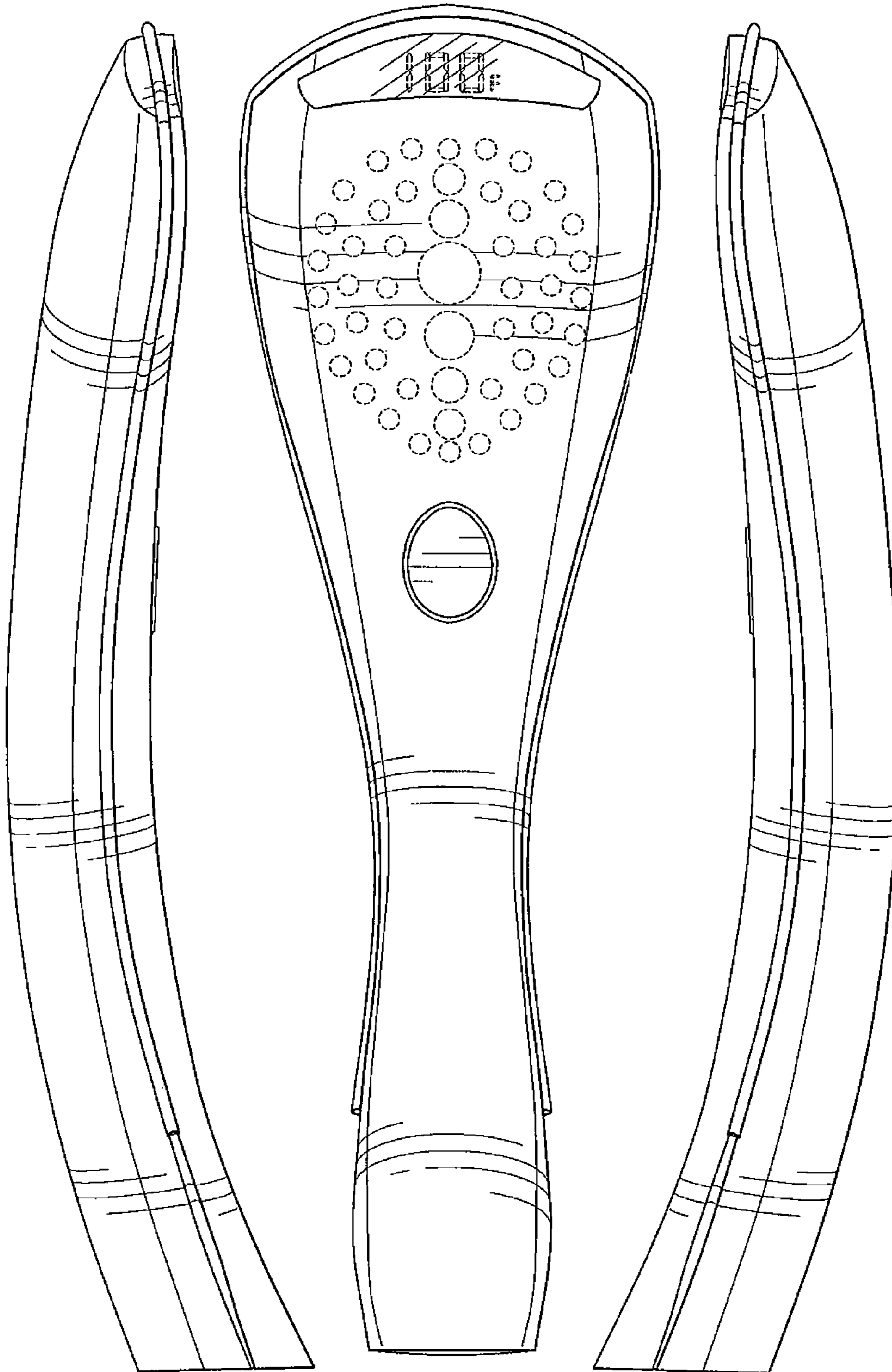
