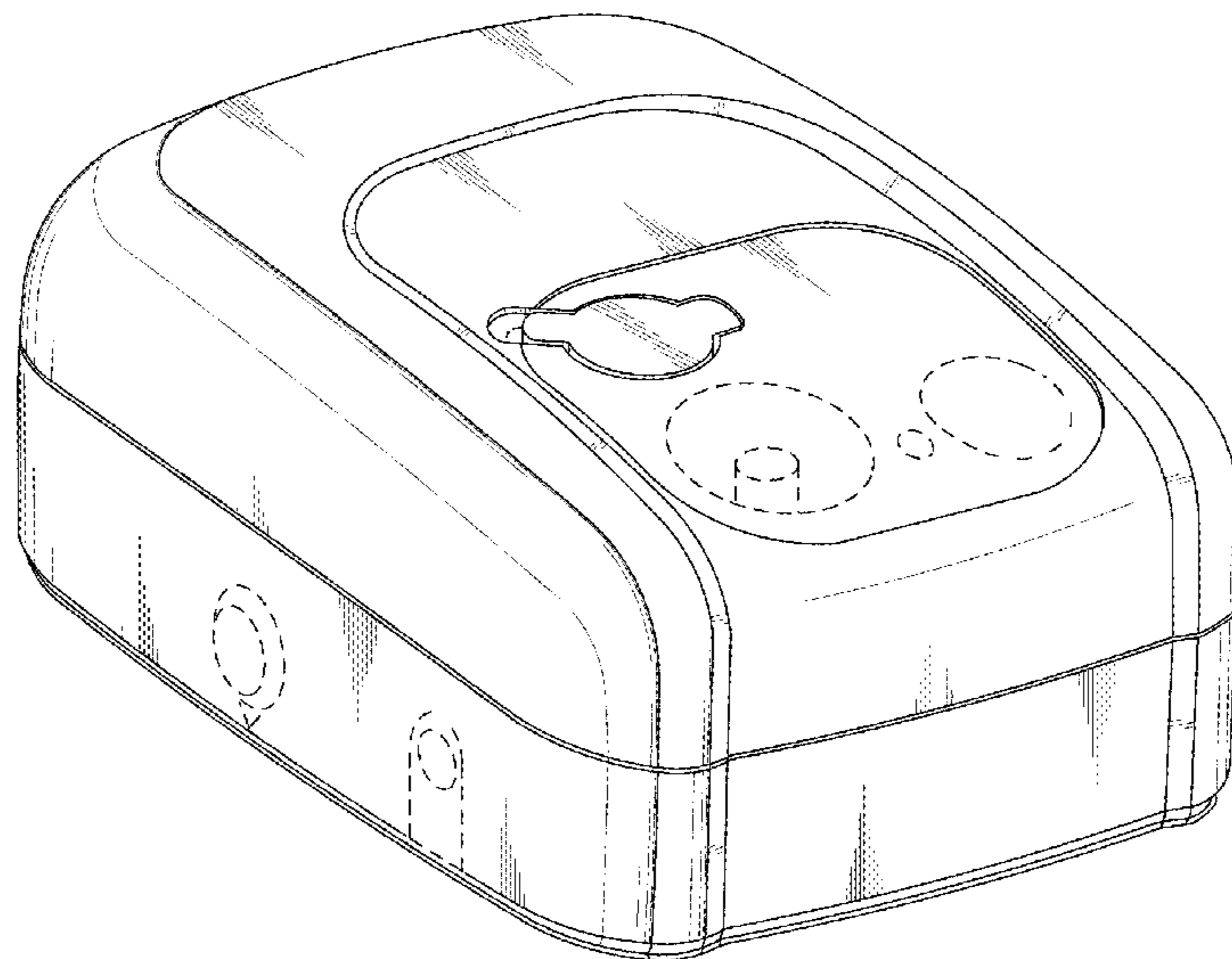
(57) **CLAIM**

I claim the ornamental design for a portable compressor for medical devices, as shown and described.

DESCRIPTION

FIG. 1 is a top left side perspective view of a portable compressor of the present invention;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevation view thereof; and,
FIG. 7 is a right side elevation view thereof.
The ornamental design which is claimed is shown in solid lines in the drawings. The broken line showing of portions of the article is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

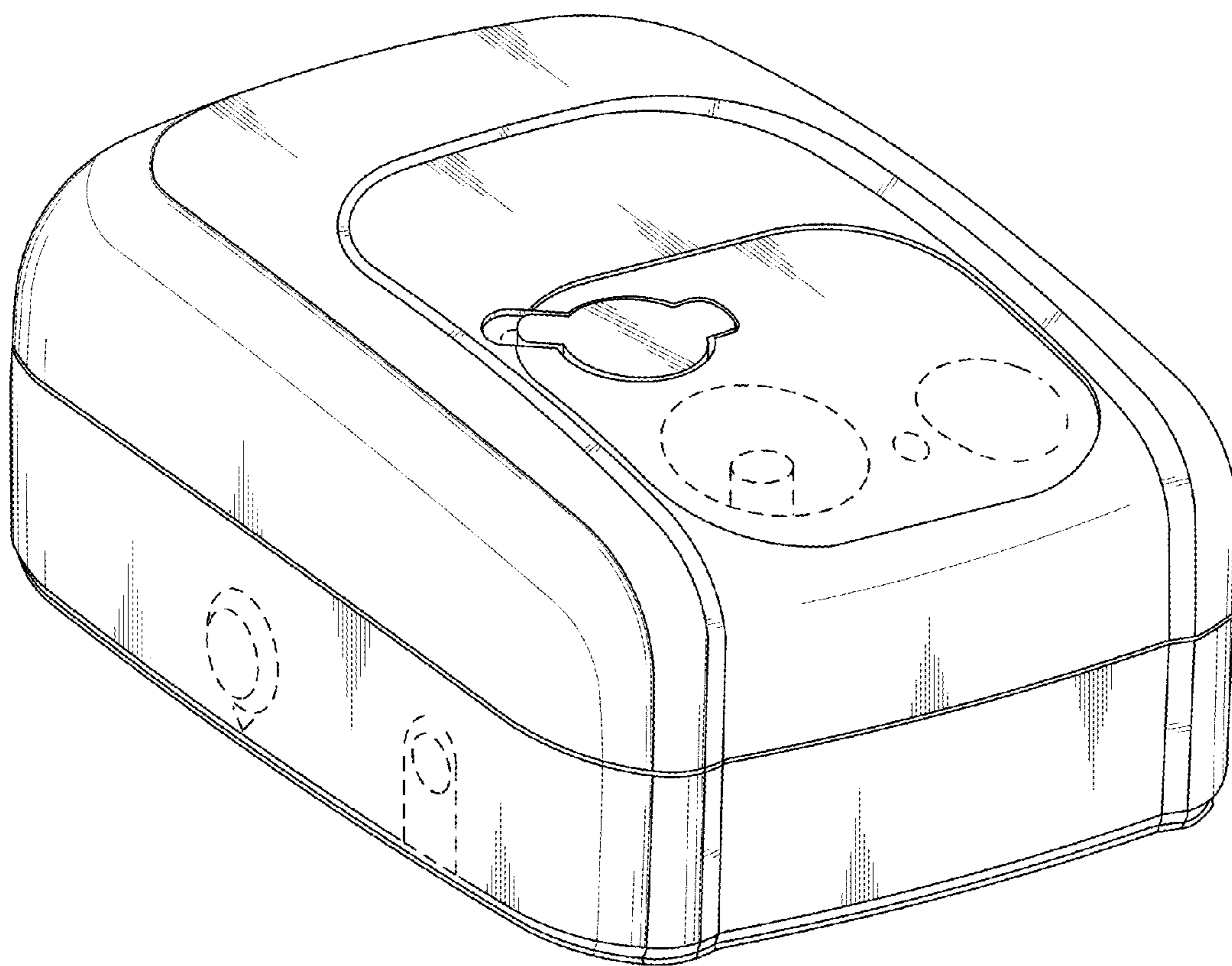

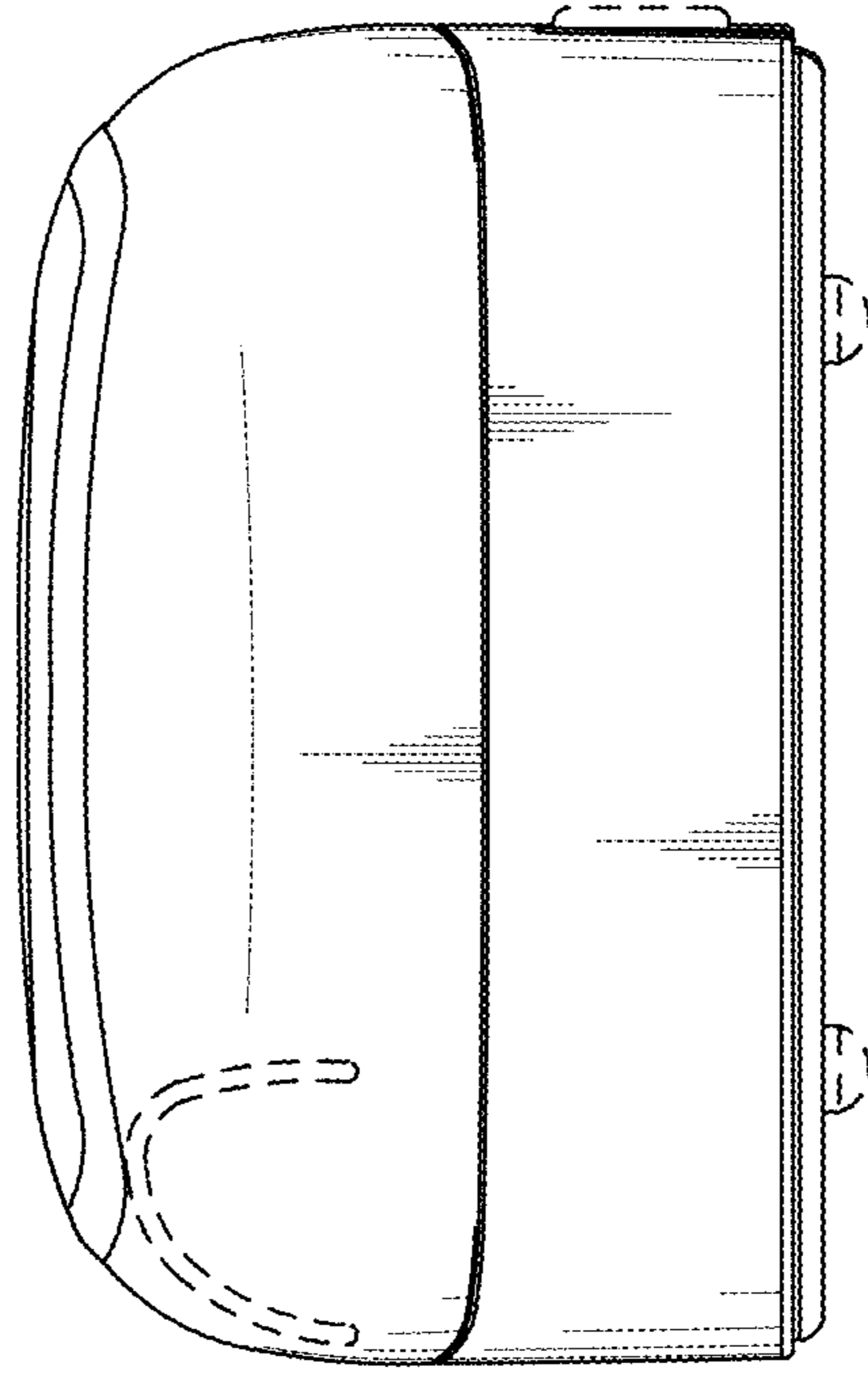

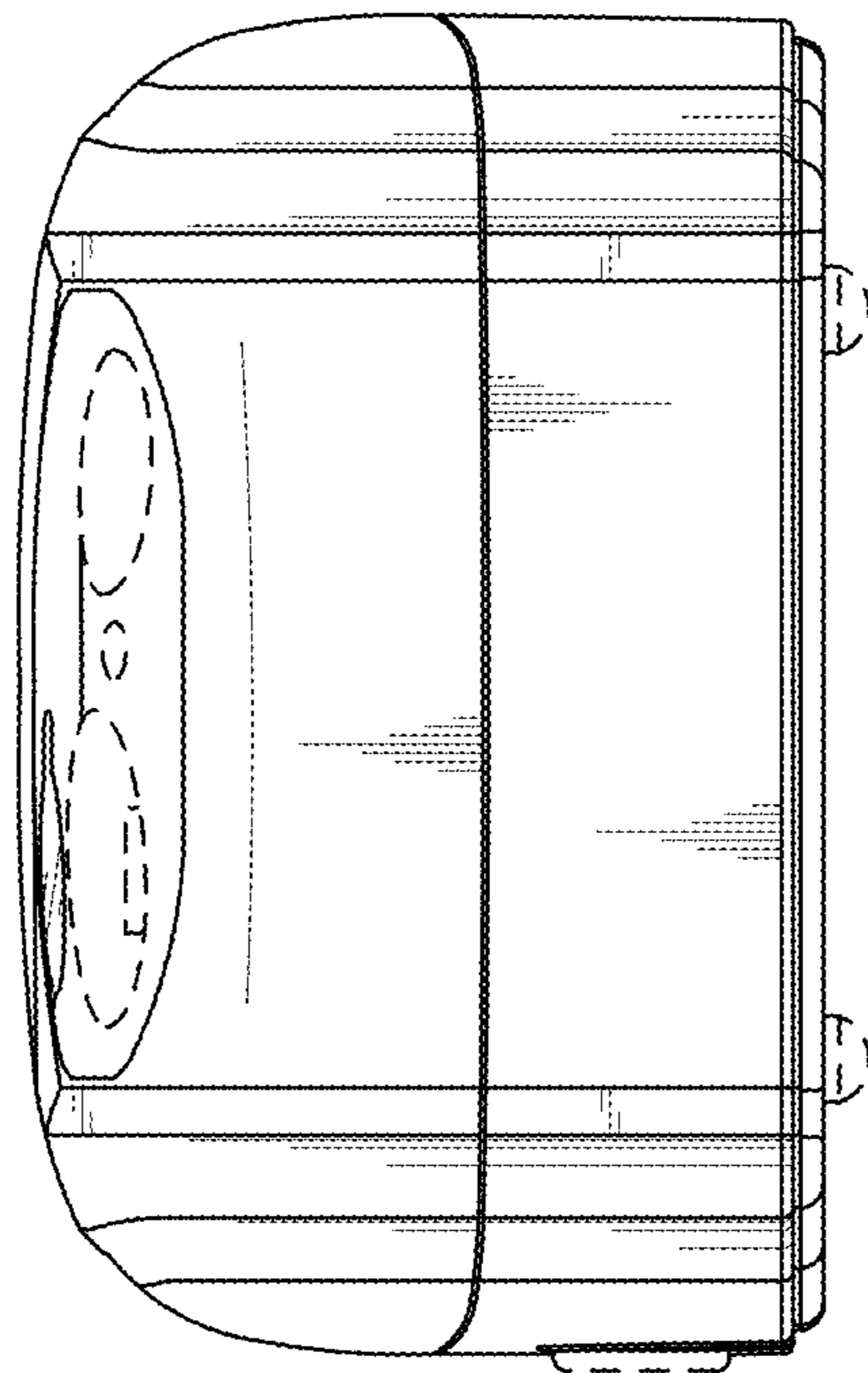

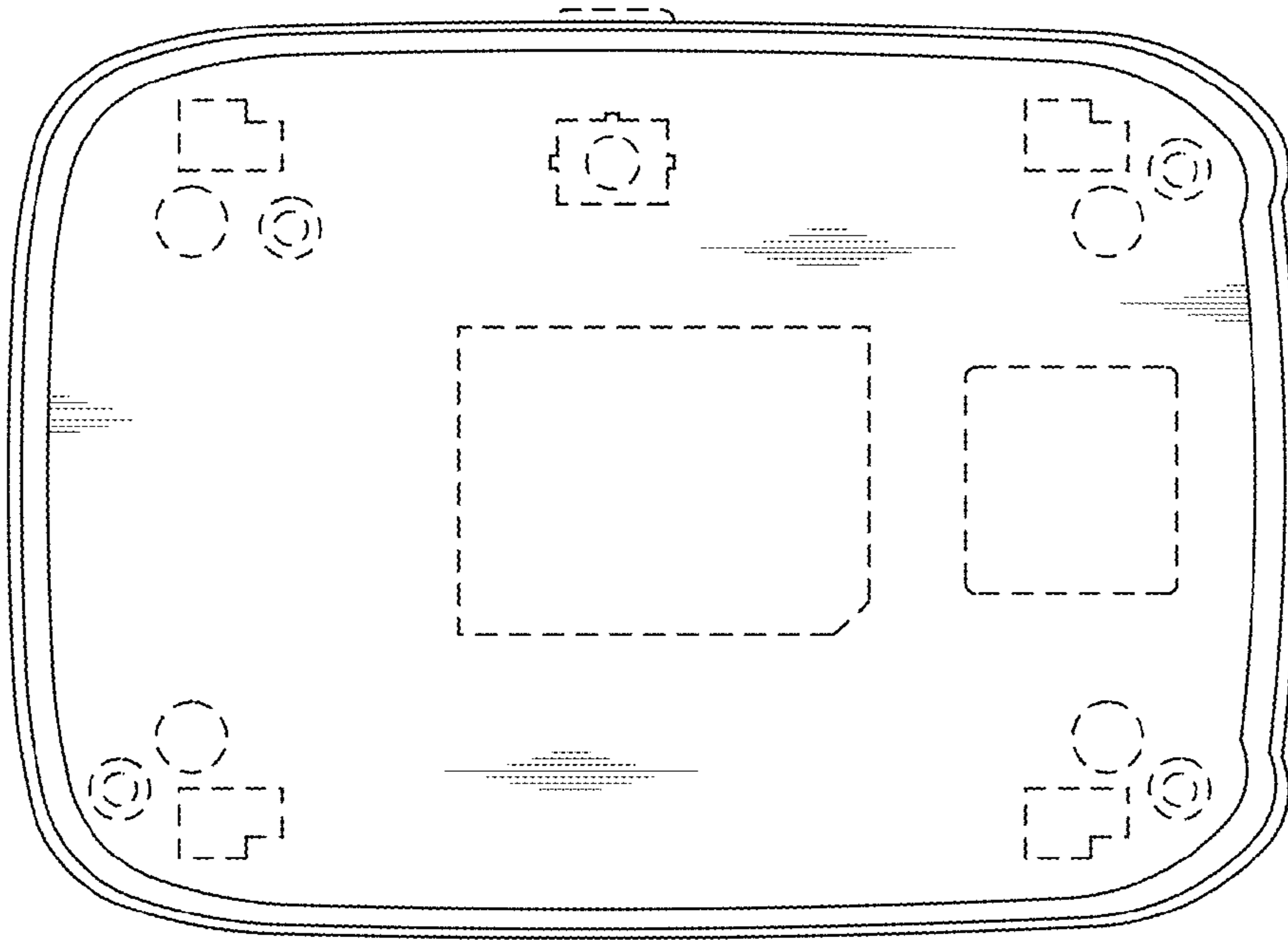

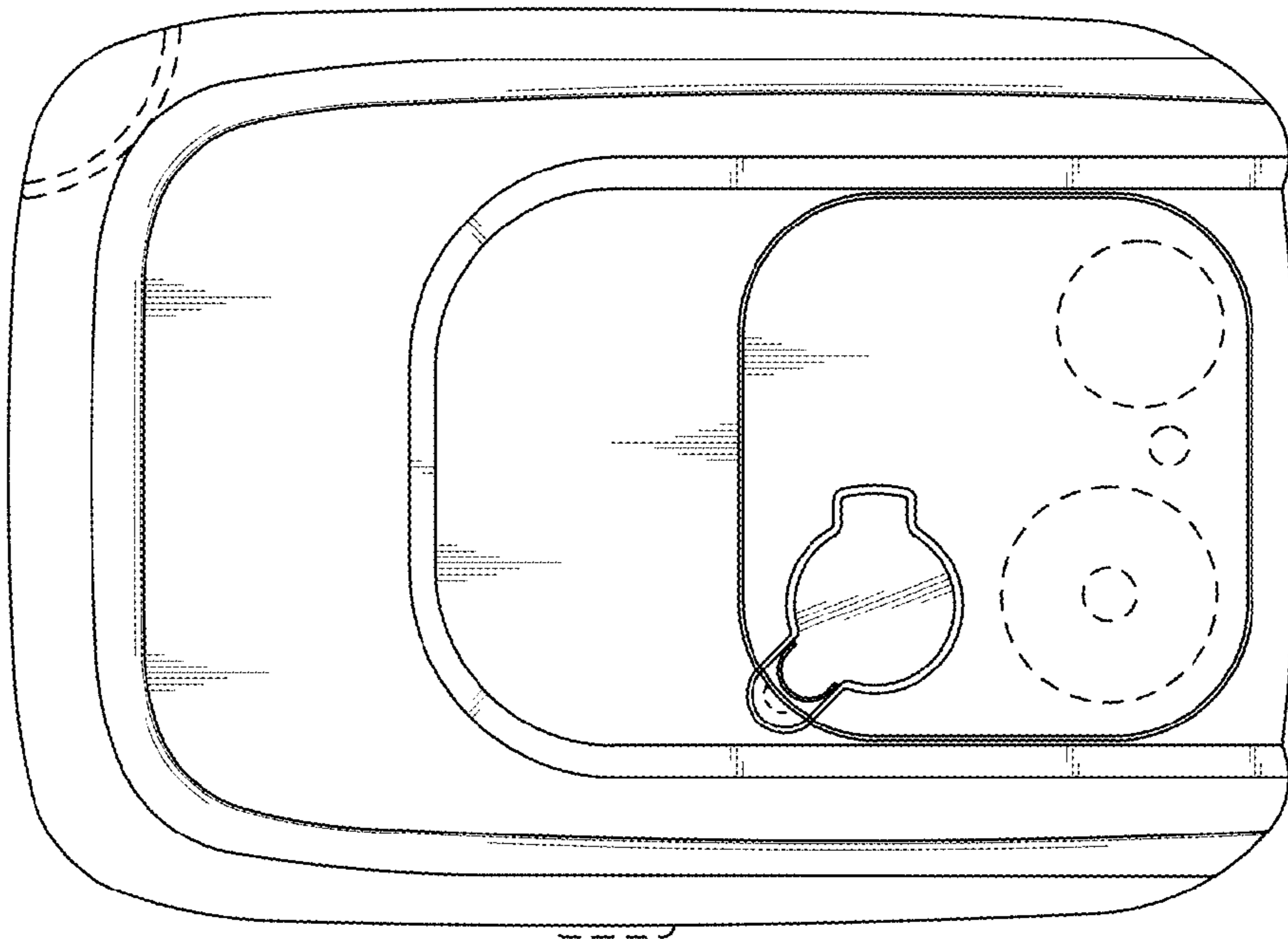

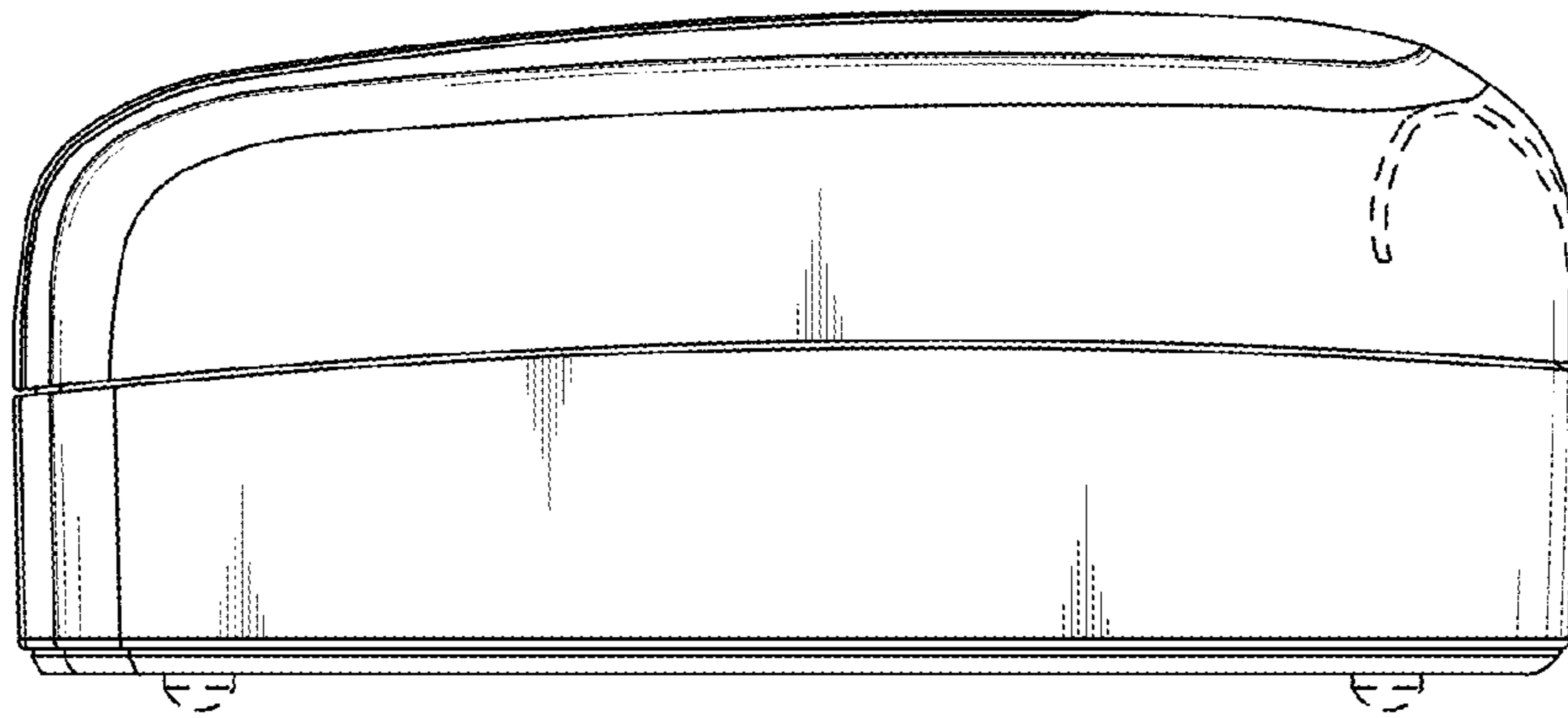

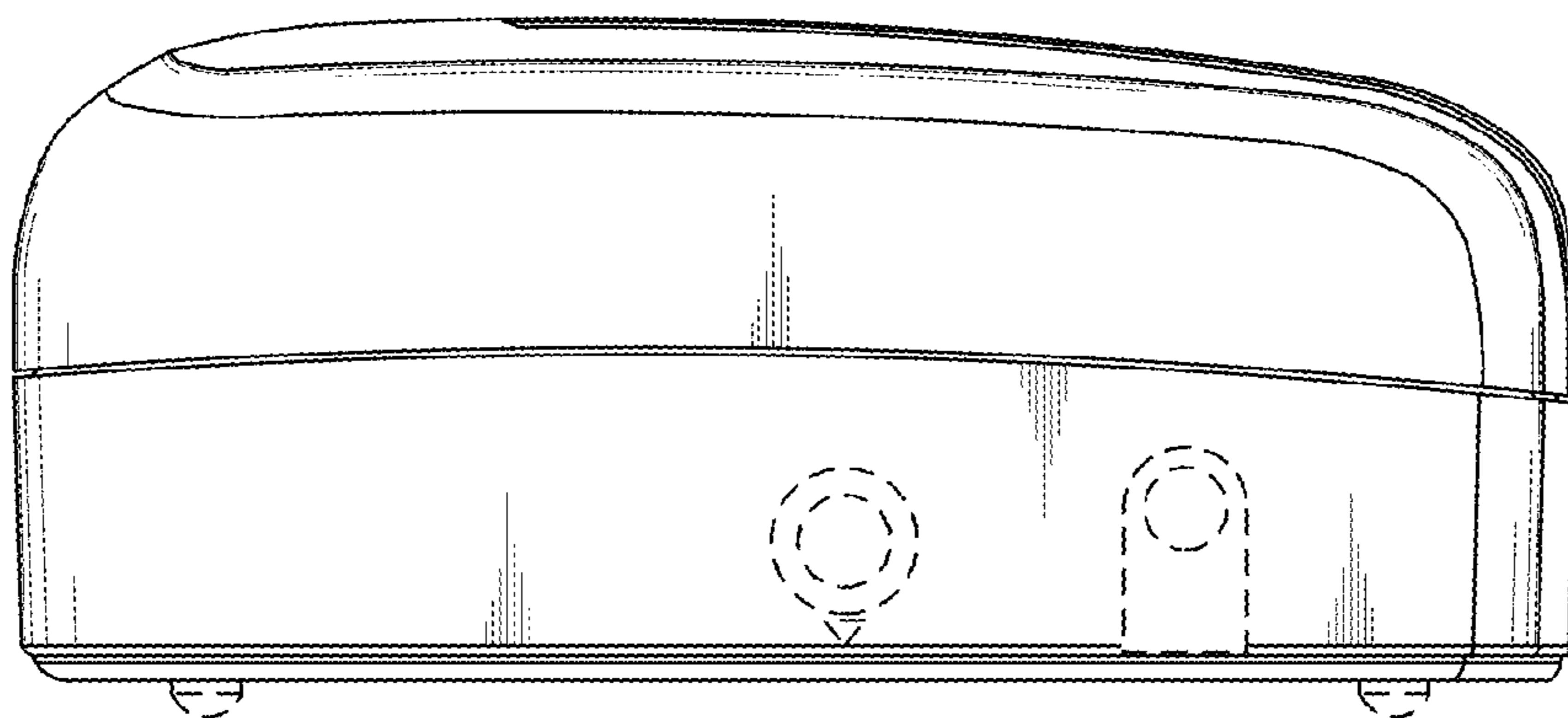
