DESCRIPTION

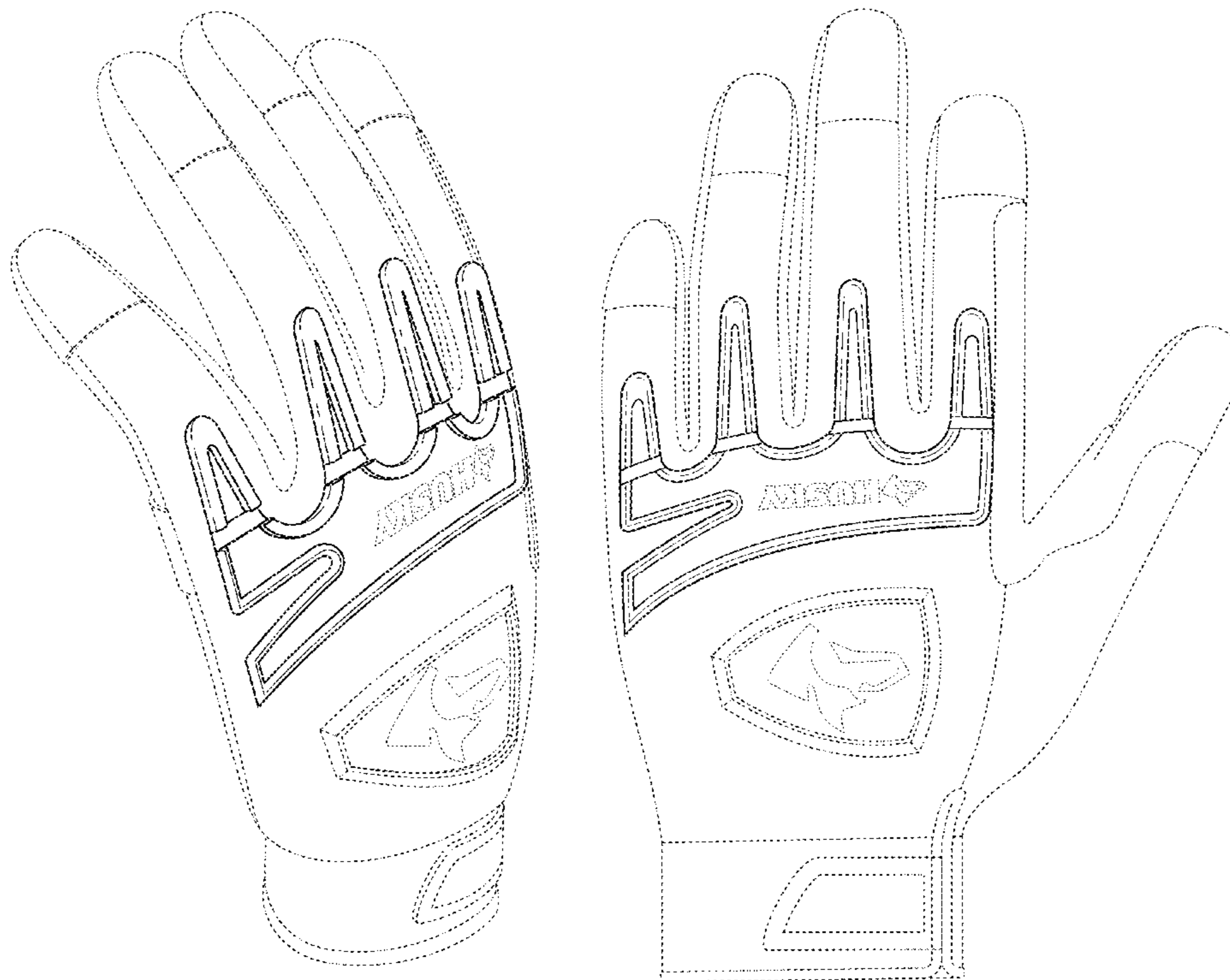
FIG. 1 is a perspective view of an embodiment of a glove showing my invention;

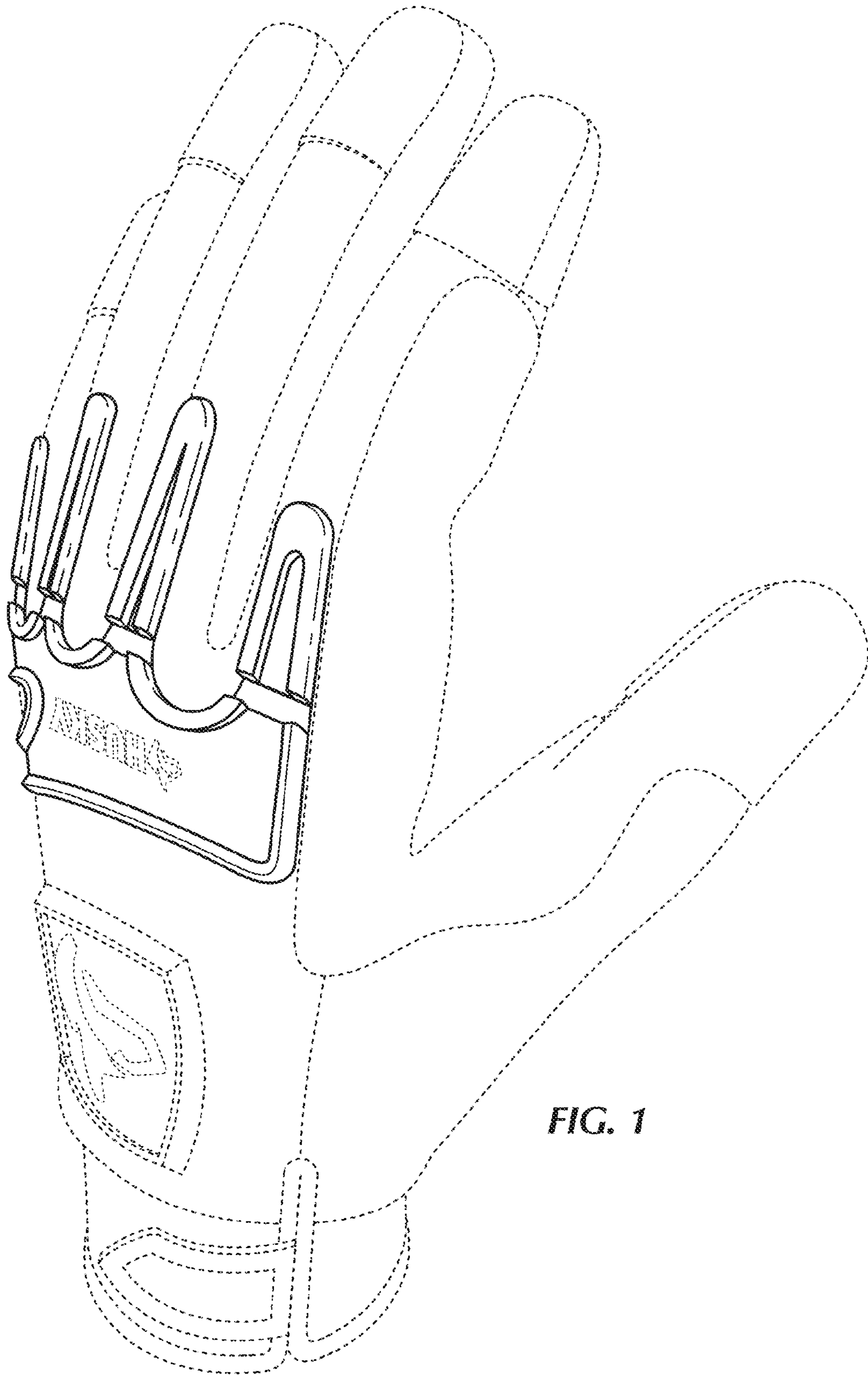

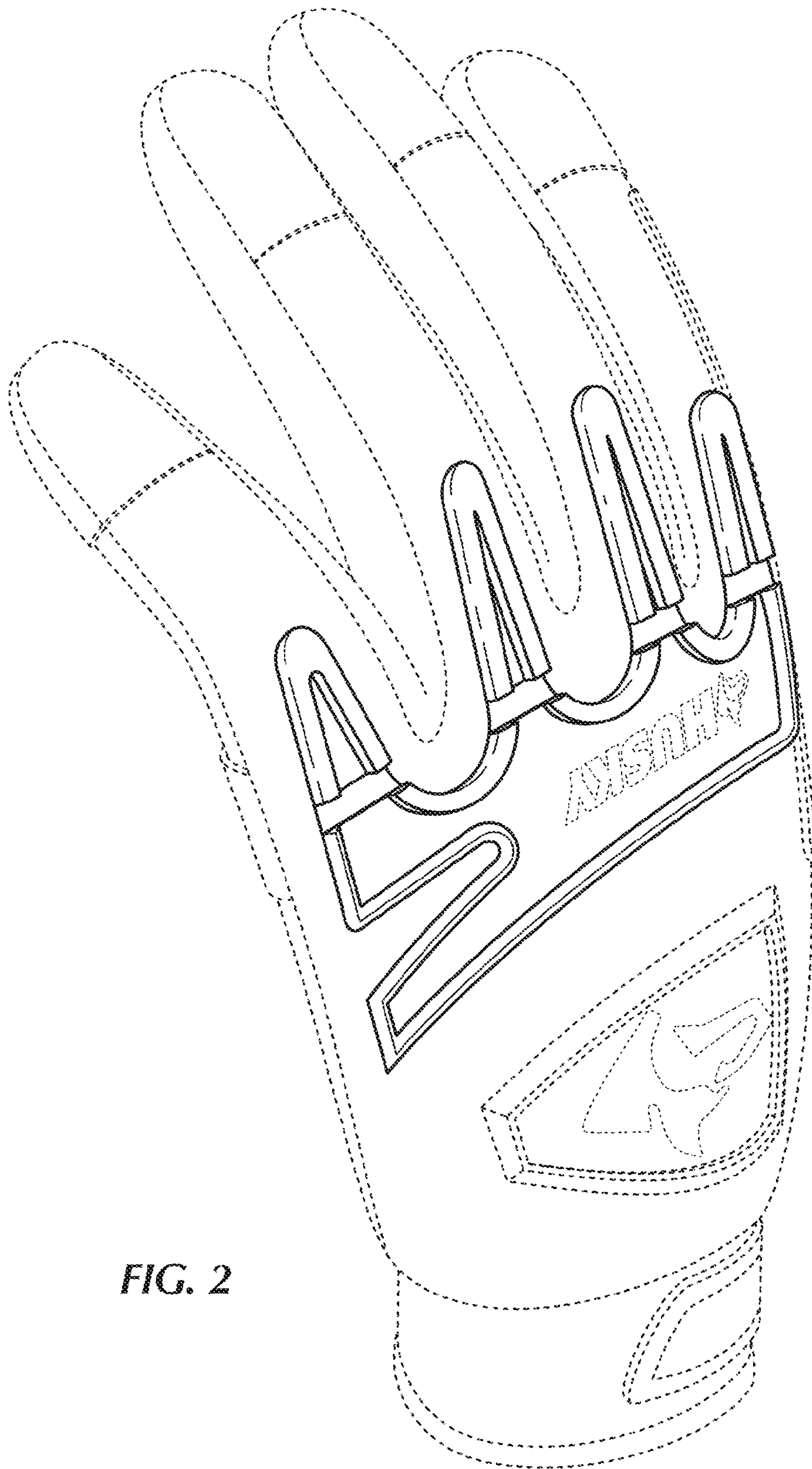

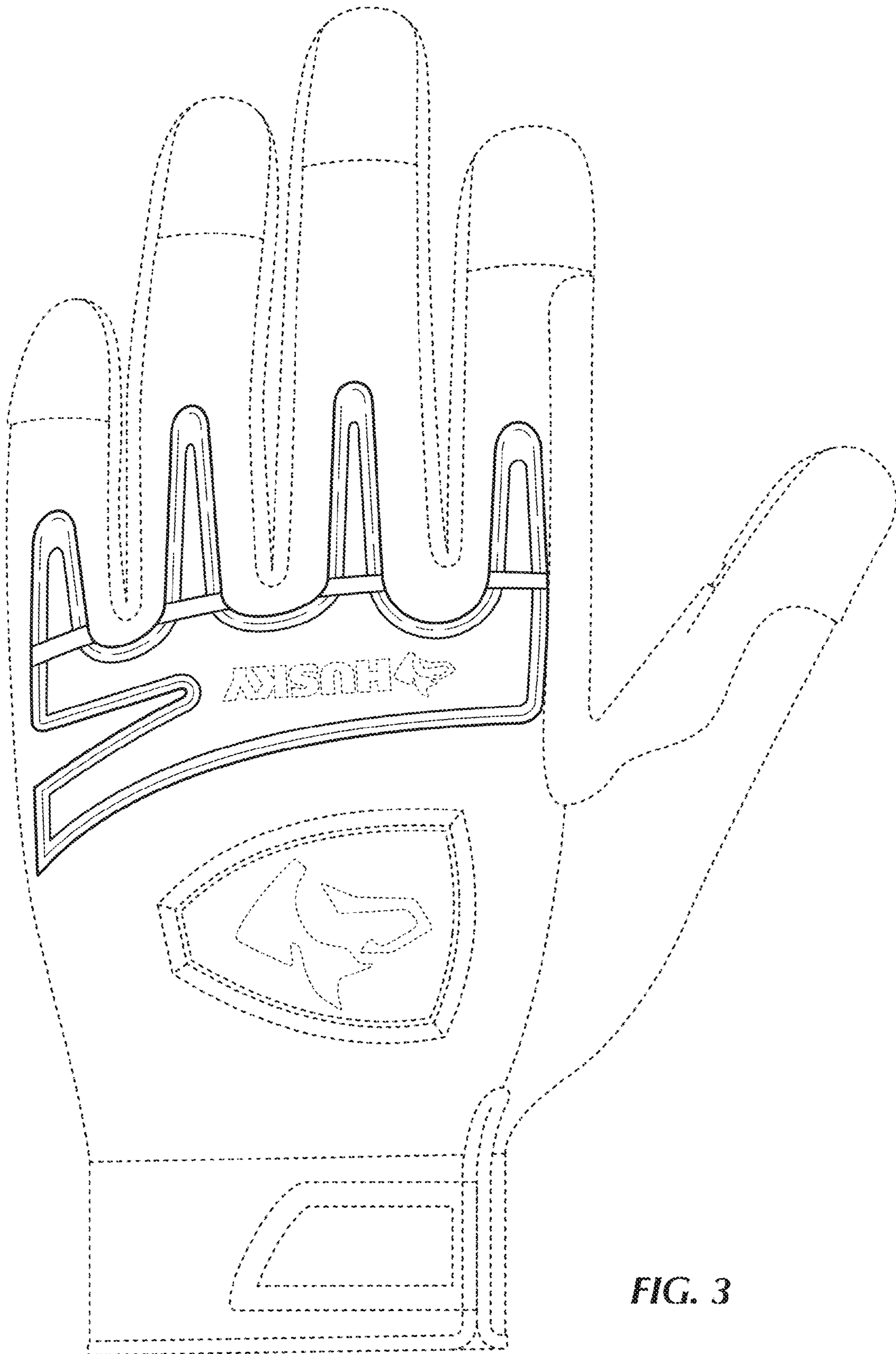
