DESCRIPTION

FIG. 6 is a left side elevation view thereof;

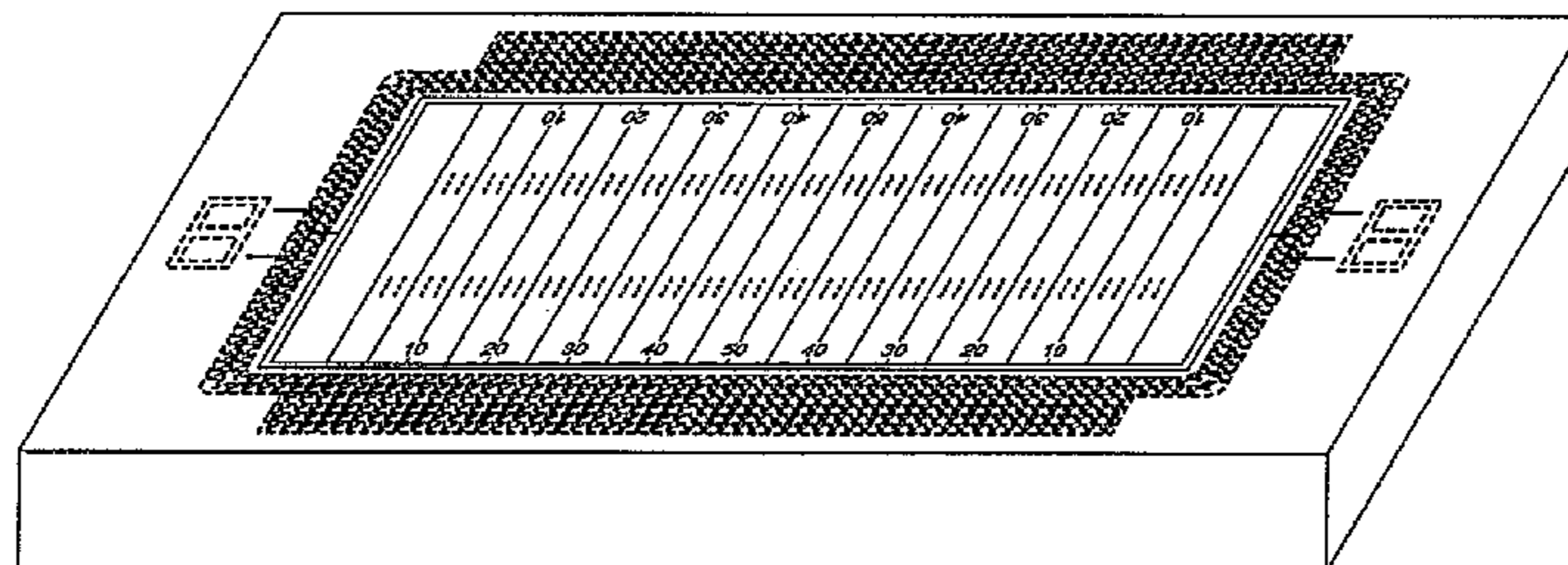
FIG. 7 is a top view thereof;

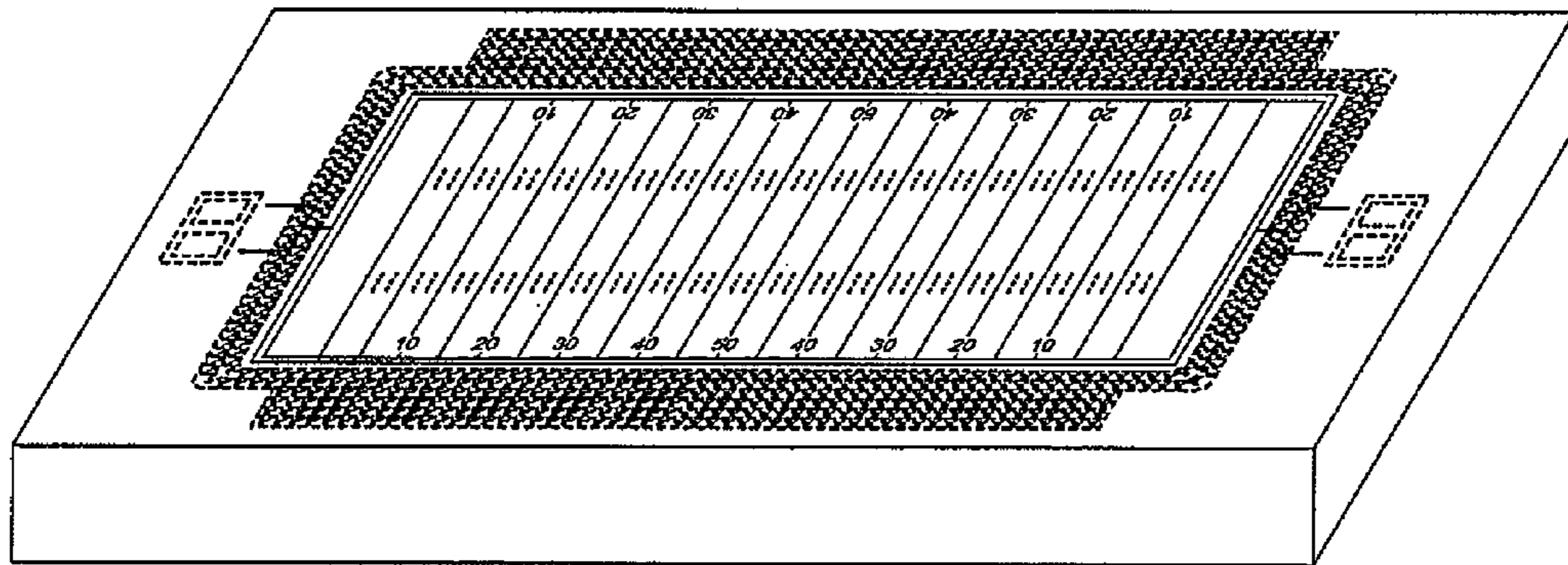

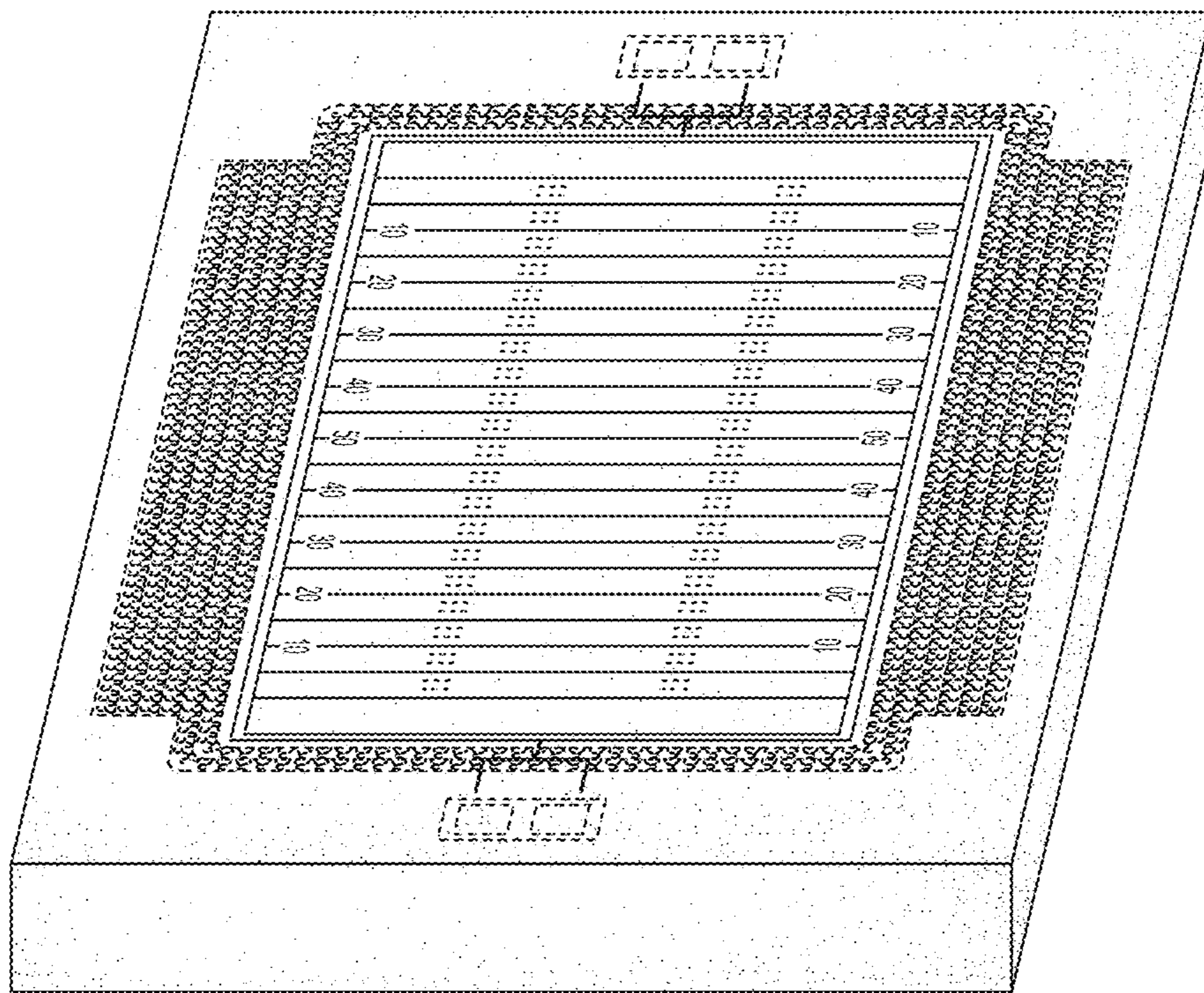

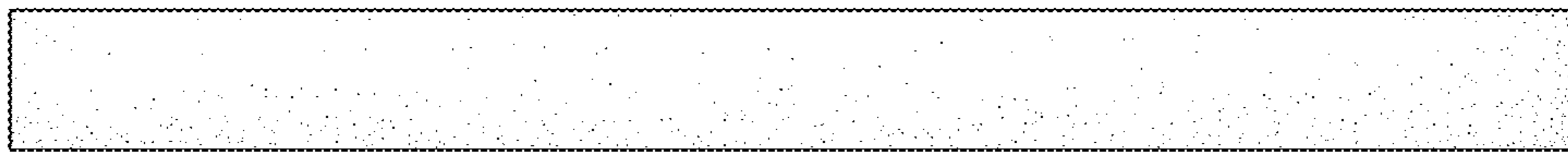

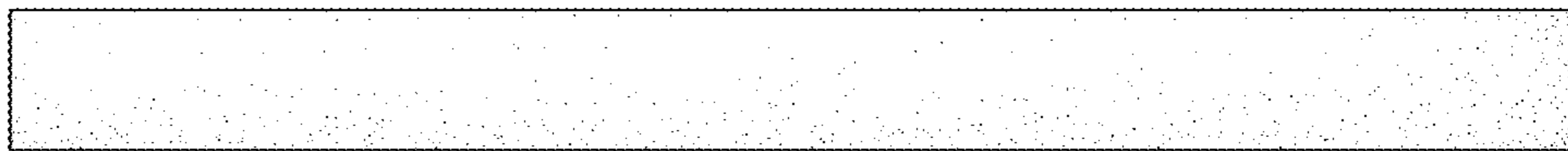

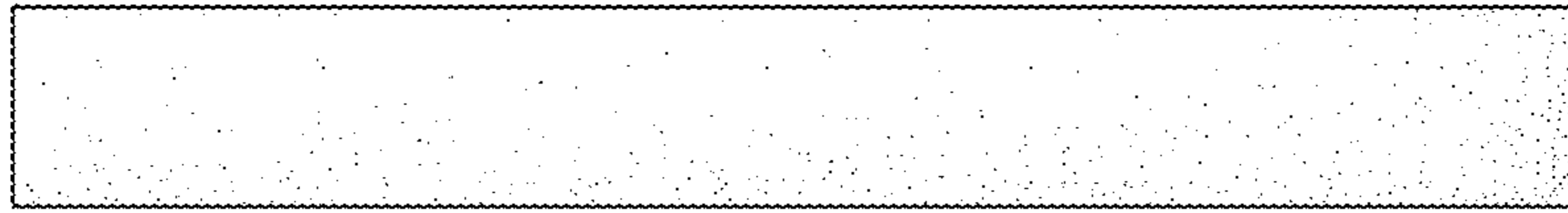

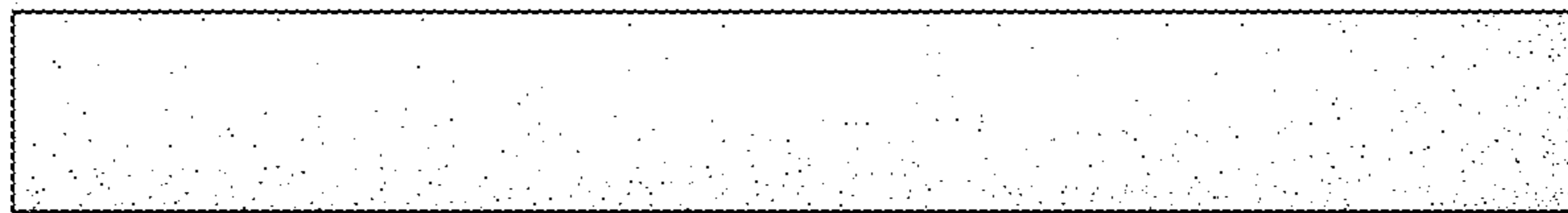

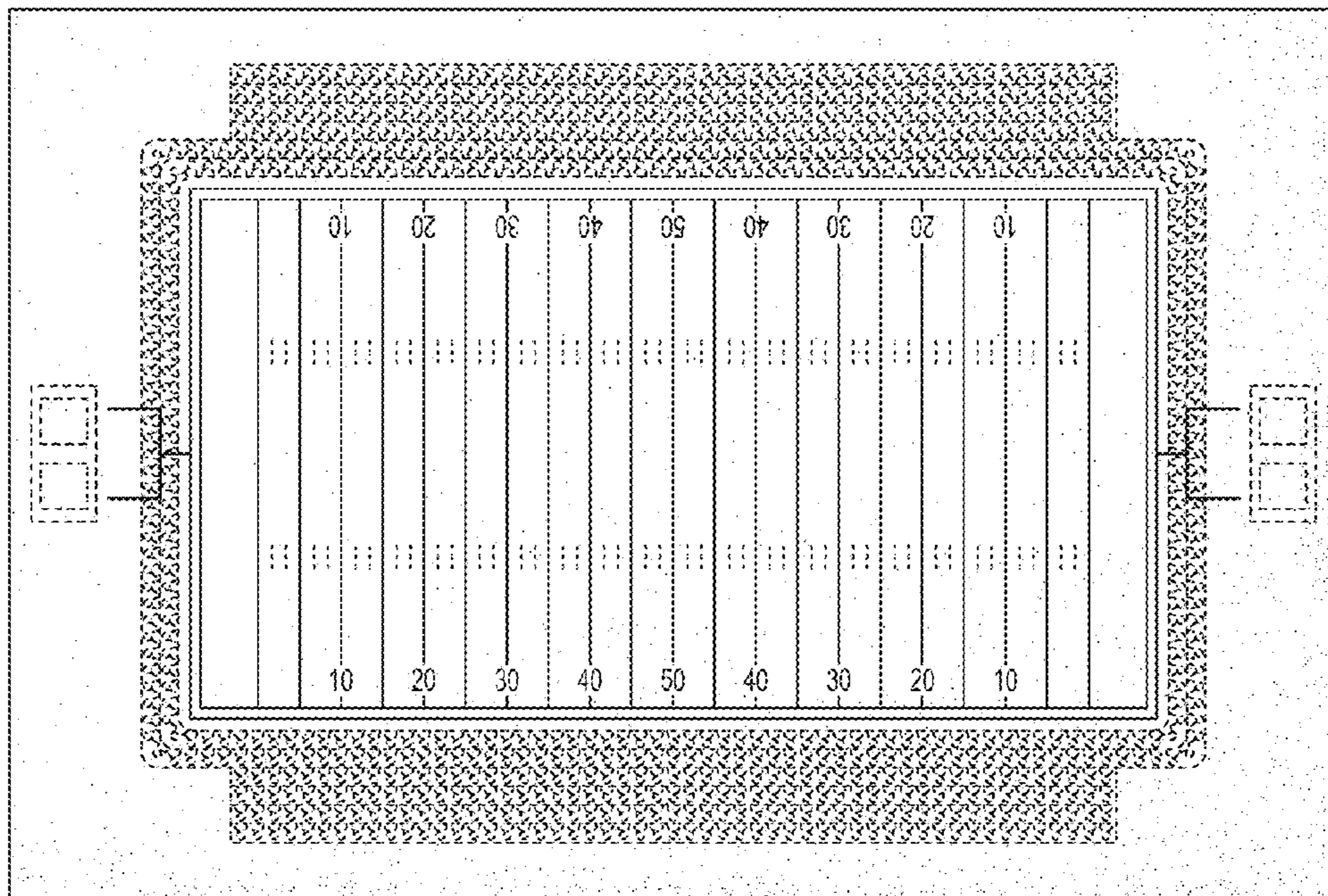

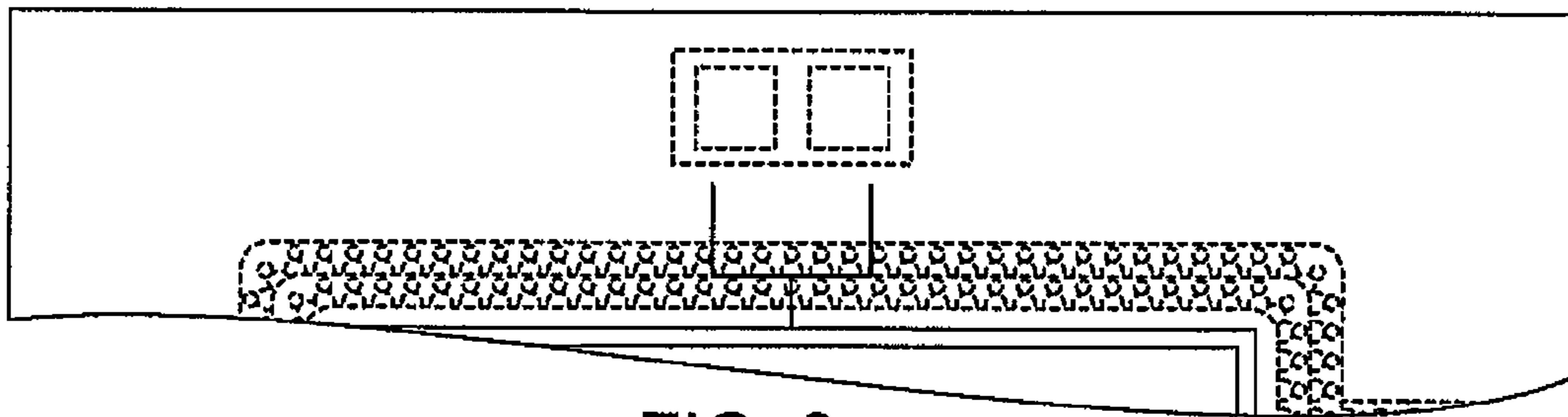

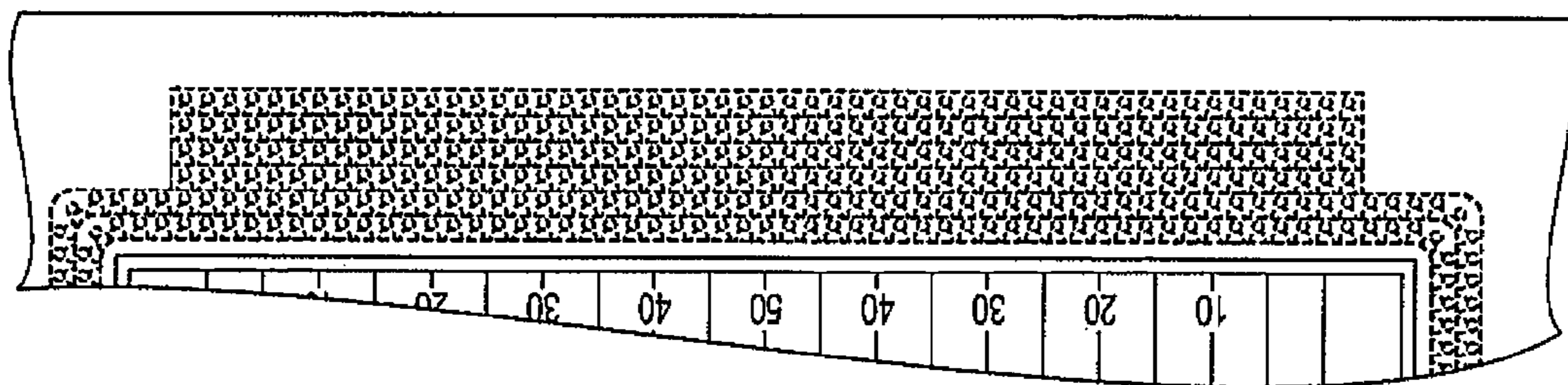
