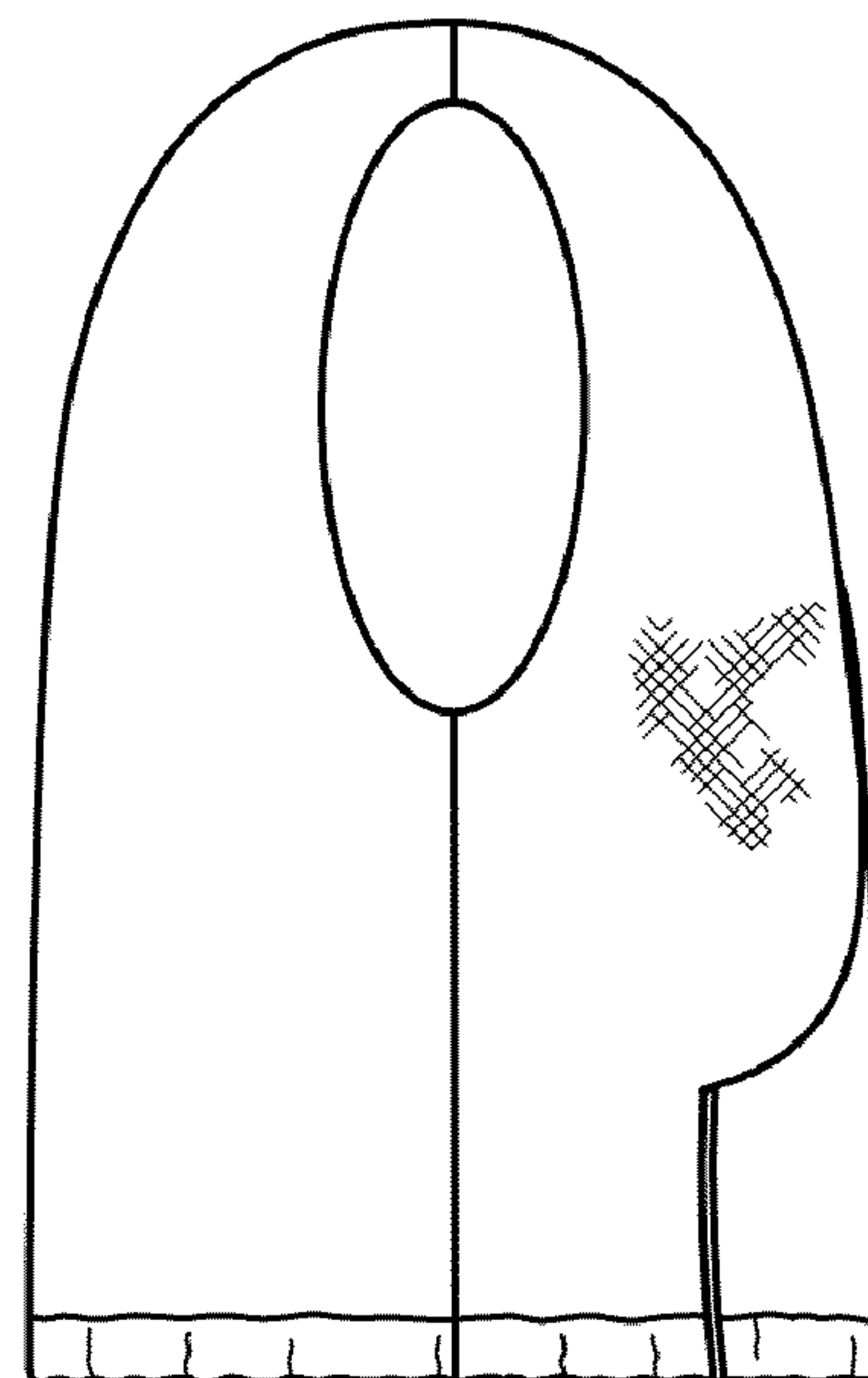
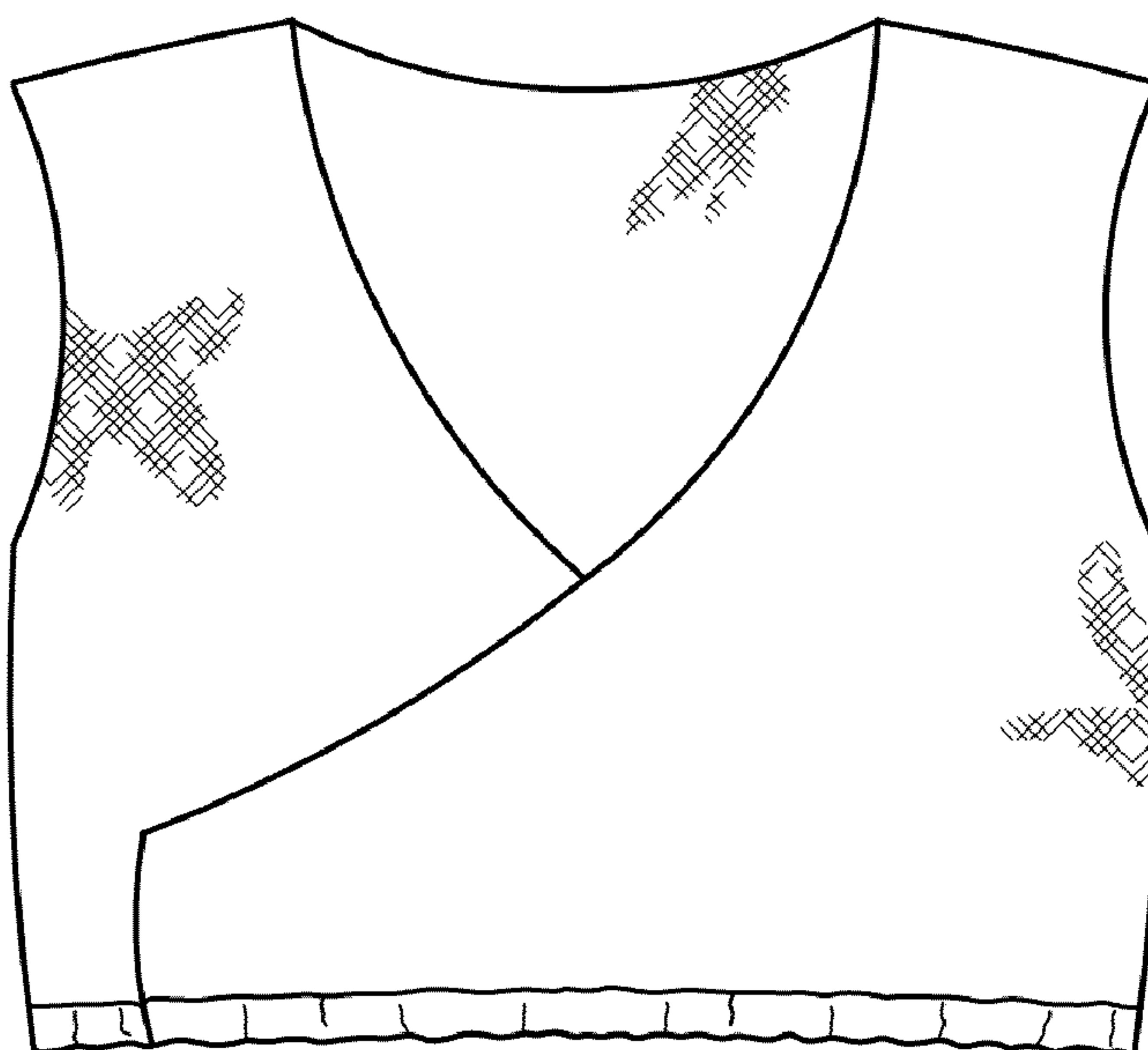
FIG. 1 is a front view of a women's garment of my new design;

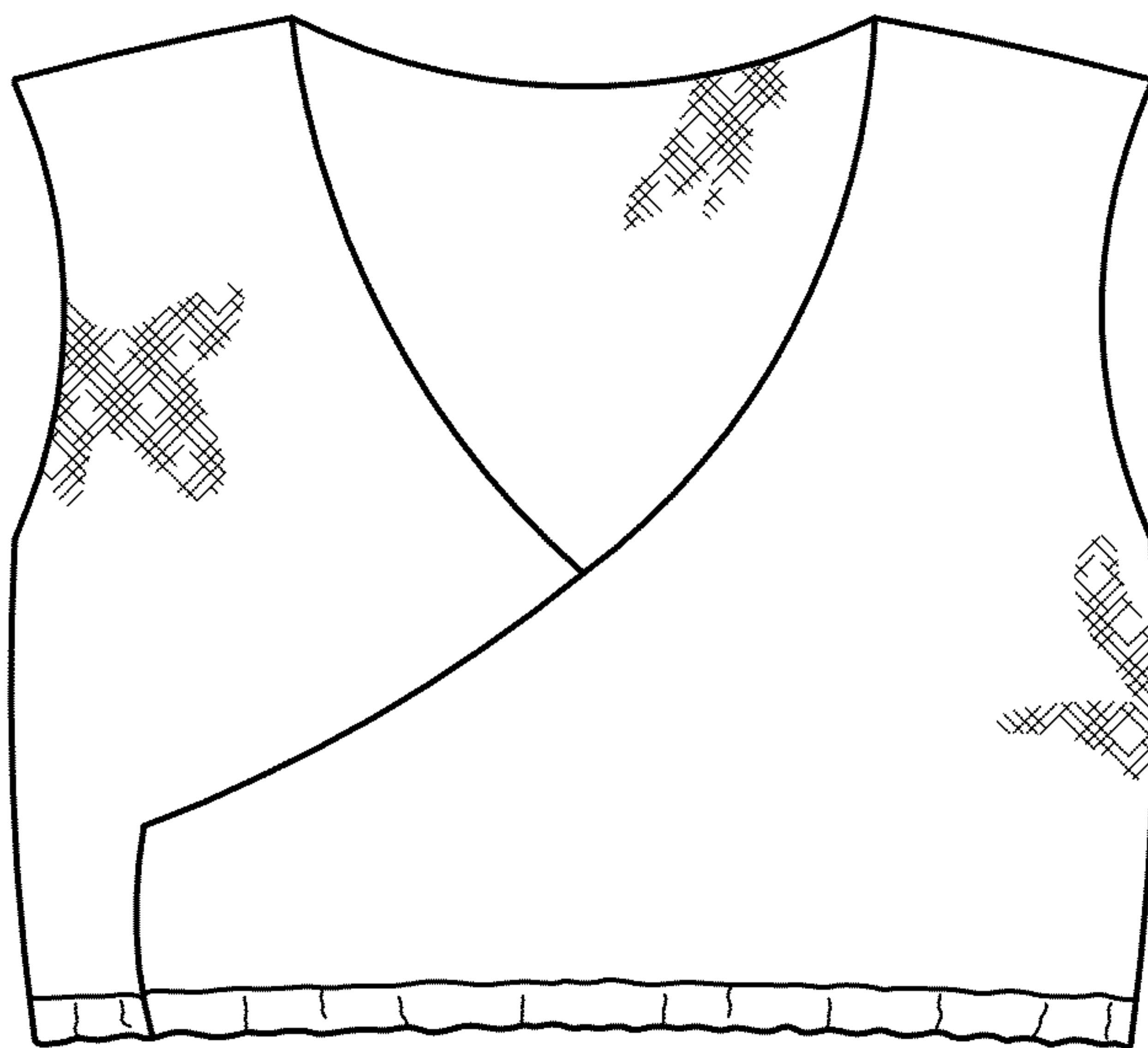

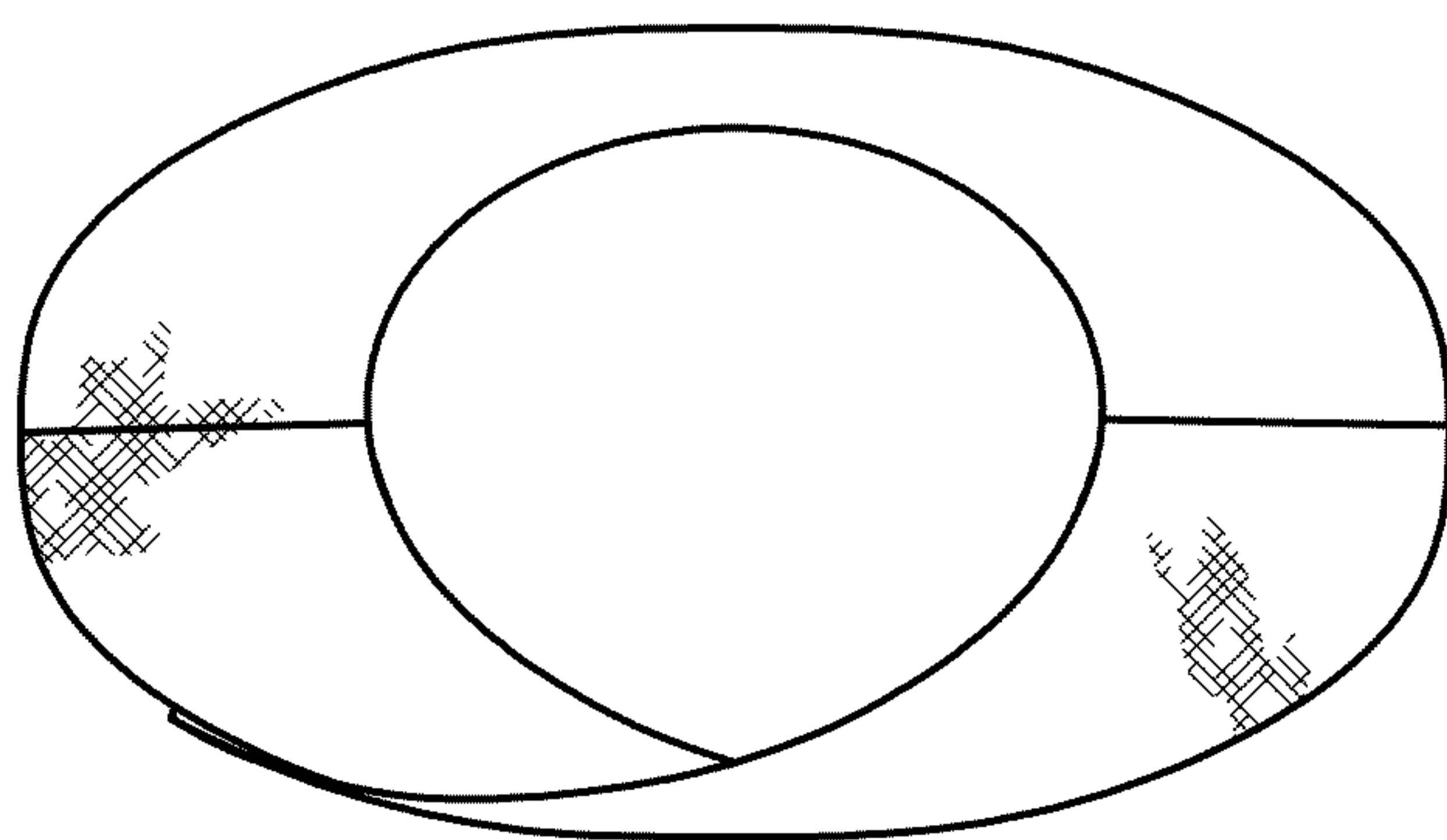

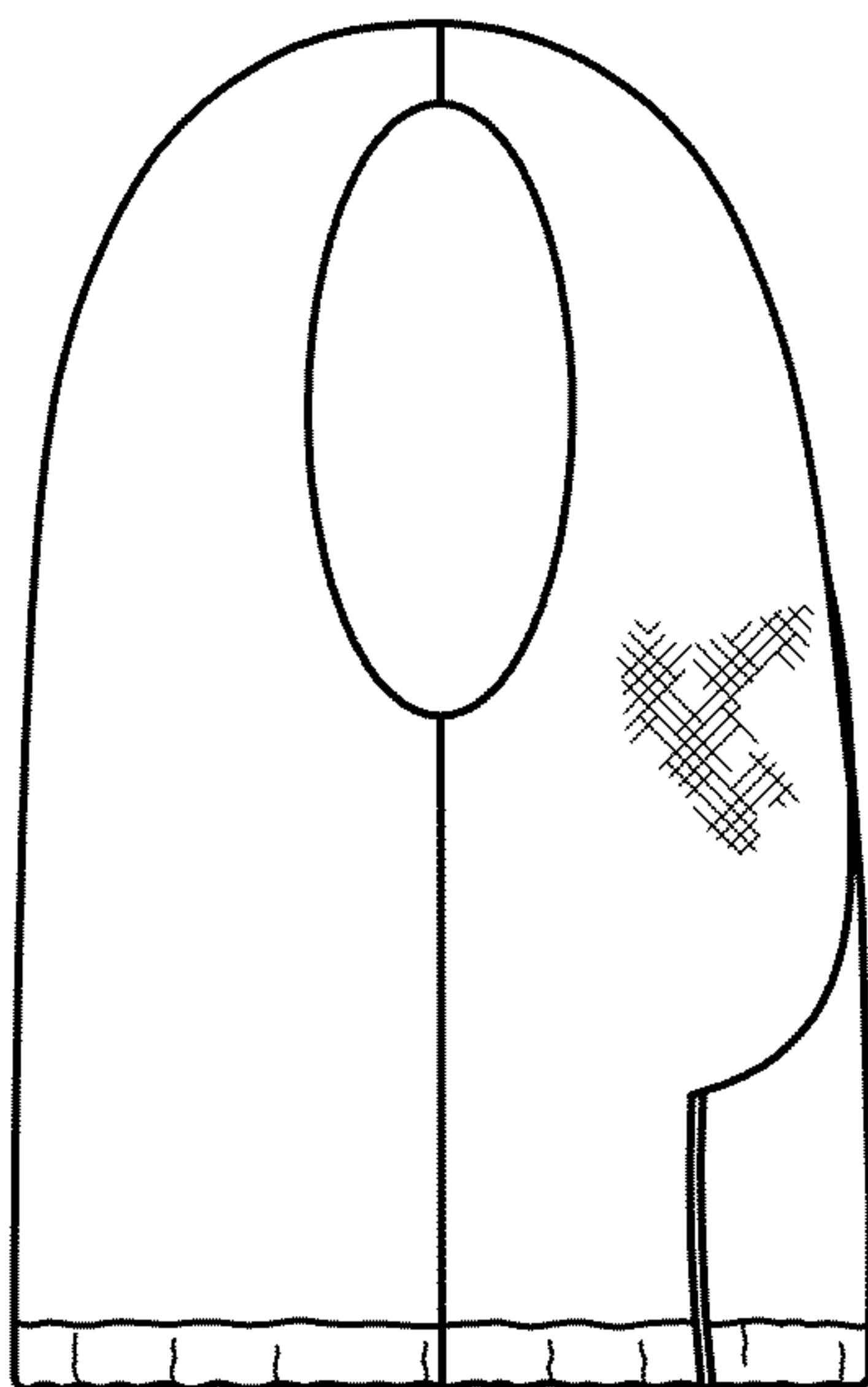

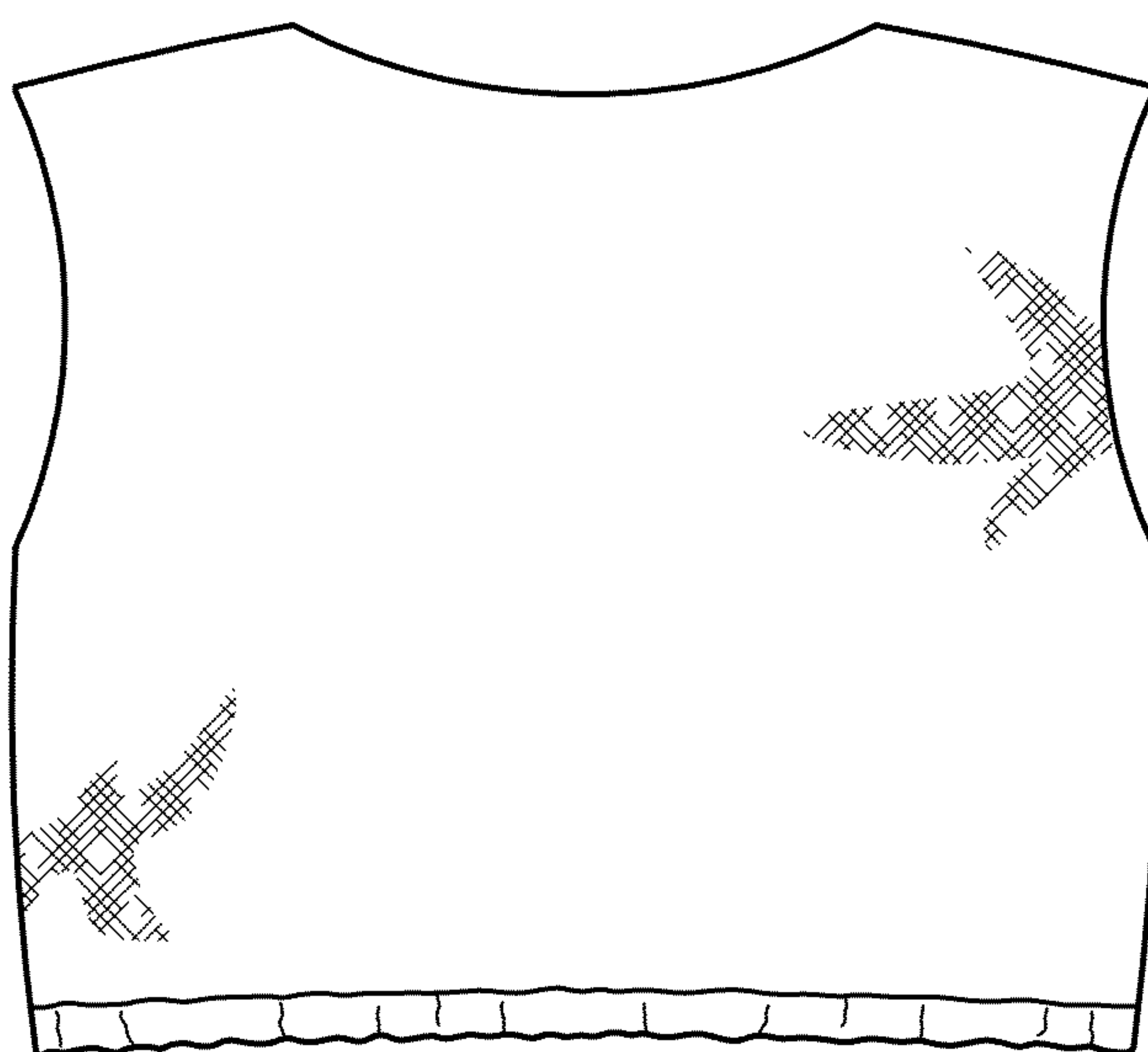
