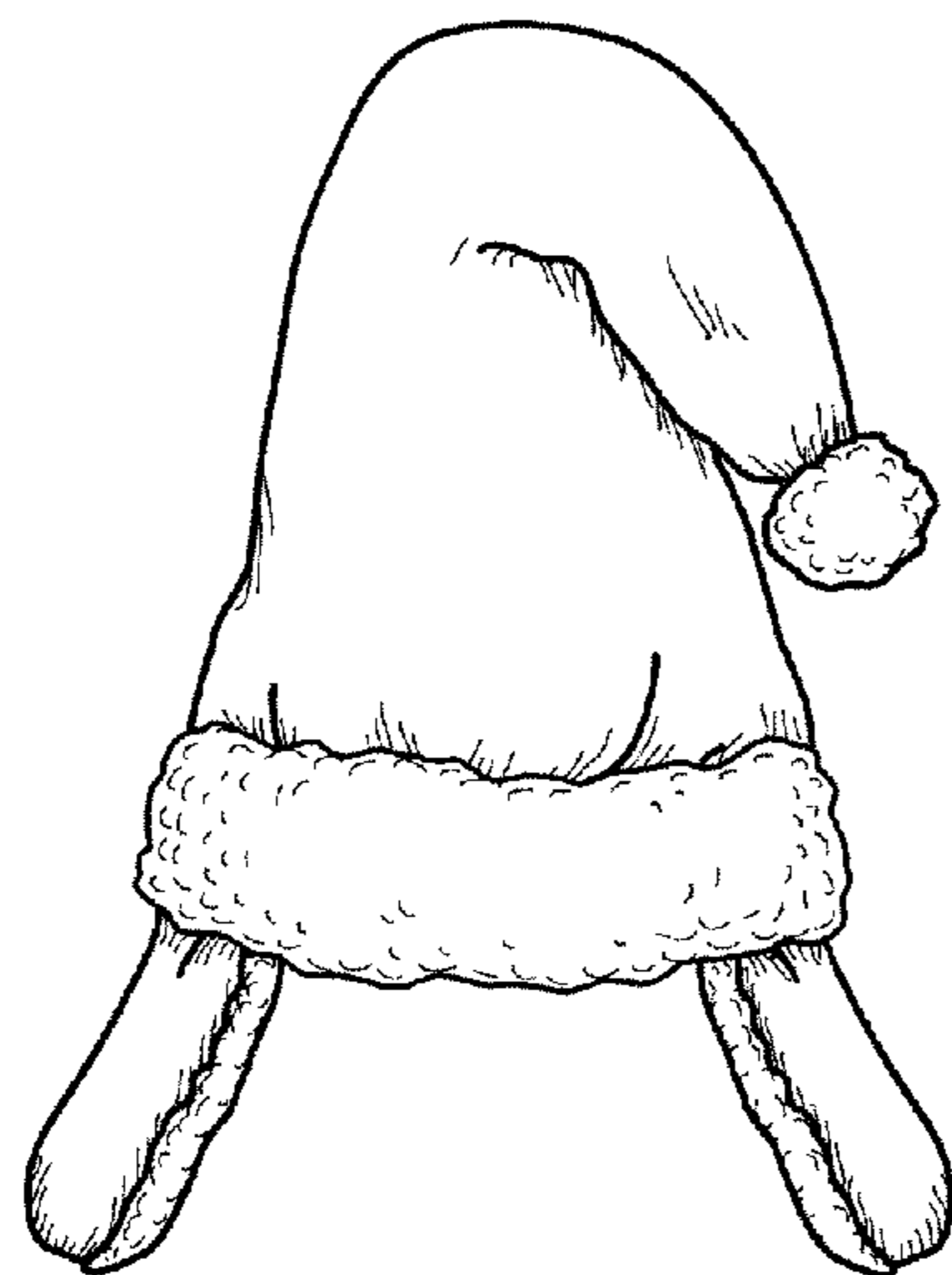

DESCRIPTION

FIG. 1 is a front view of a Santa hat with ear flaps embodying my design;
FIG. 2 is a back view of the Santa hat with ear flaps shown in FIG. 1;
FIG. 3 is a left side view of the Santa hat with ear flaps shown in FIGS. 1 and 2;
FIG. 4 is a right side view of the Santa hat with ear flaps shown in FIGS. 1-3;
FIG. 5 is a top view of the Santa hat with ear flaps shown in FIGS. 1-4; and,
FIG. 6 is a bottom view of the Santa hat with ear flaps shown in FIGS. 1-5.

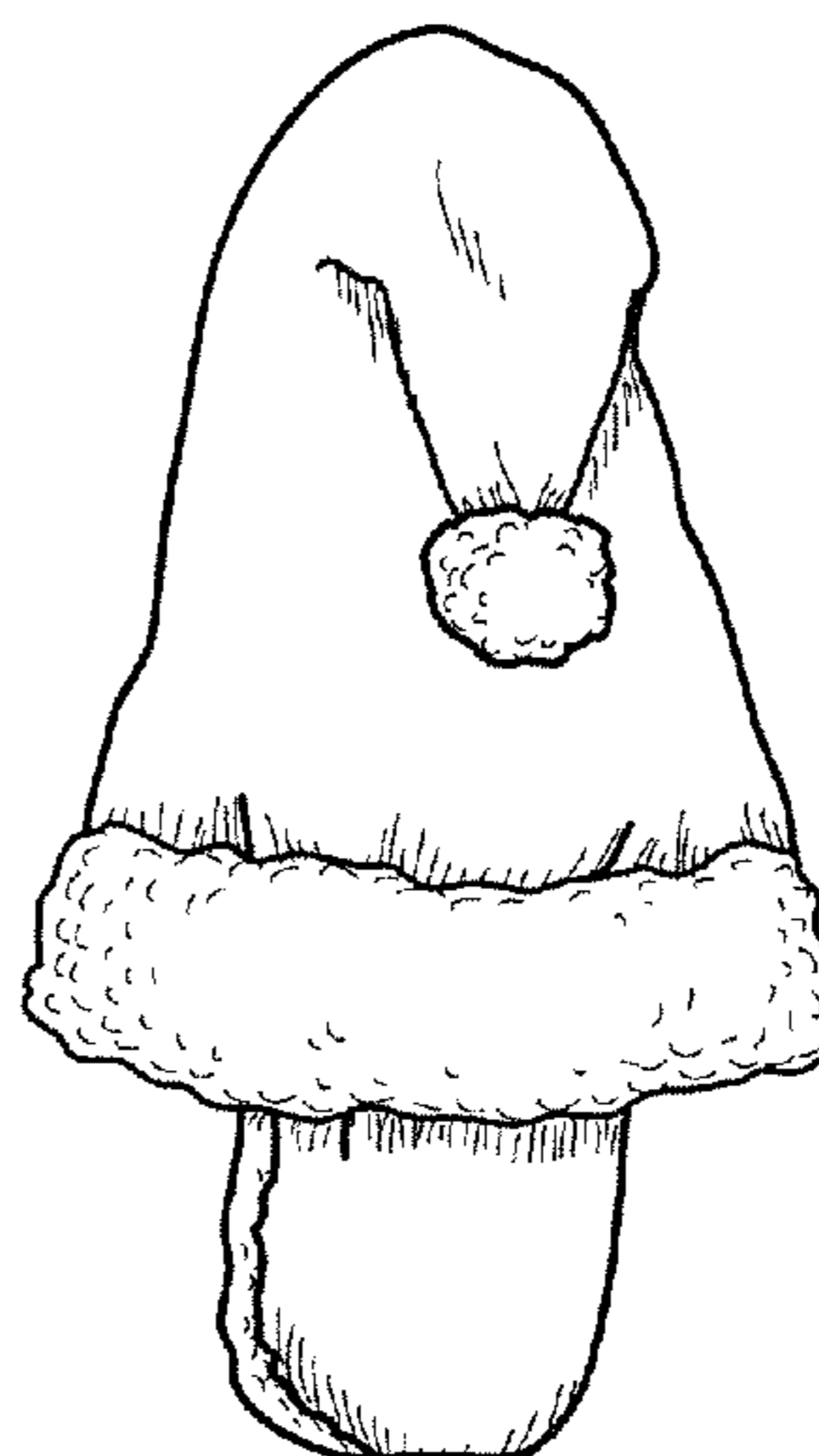

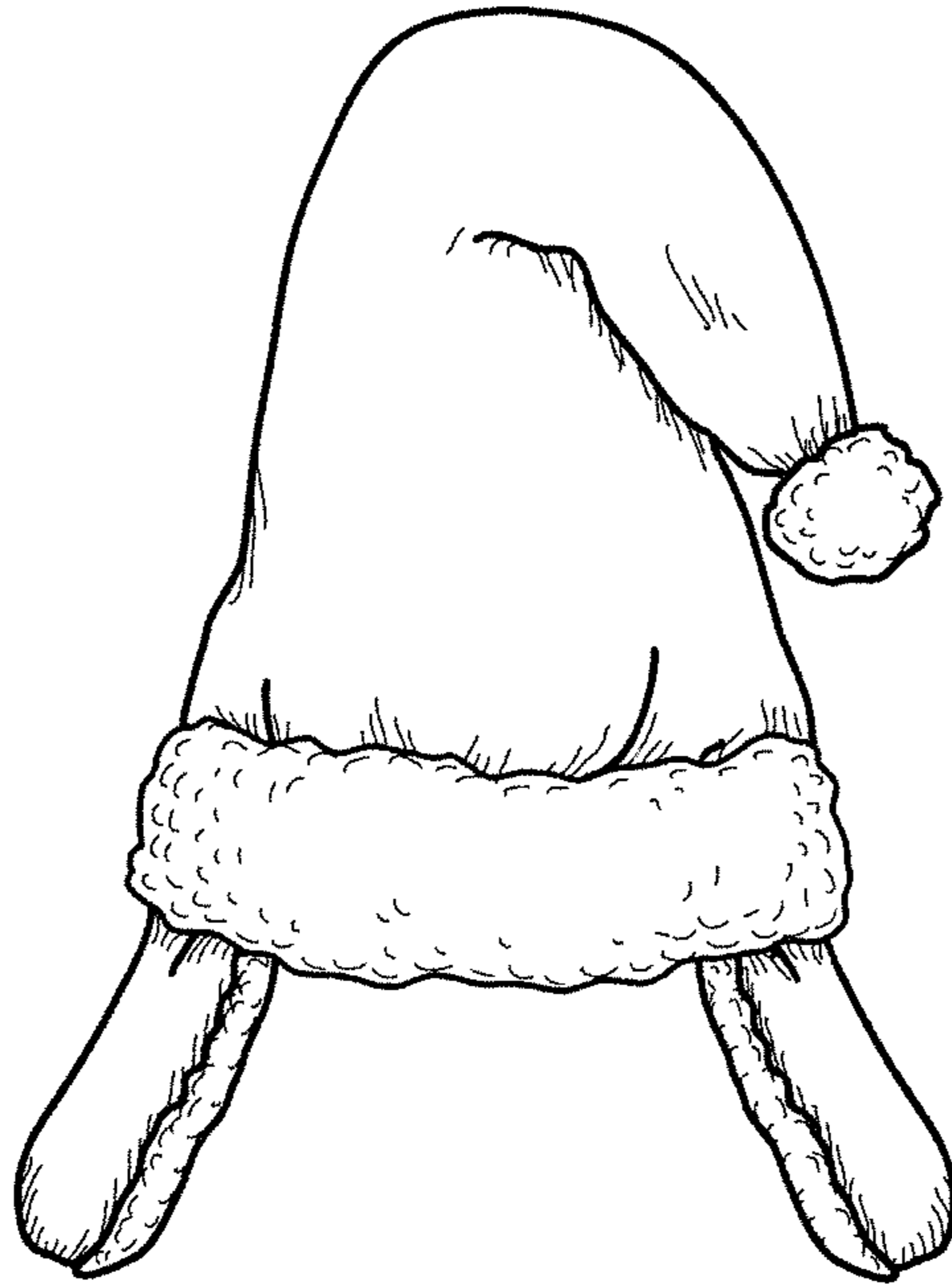

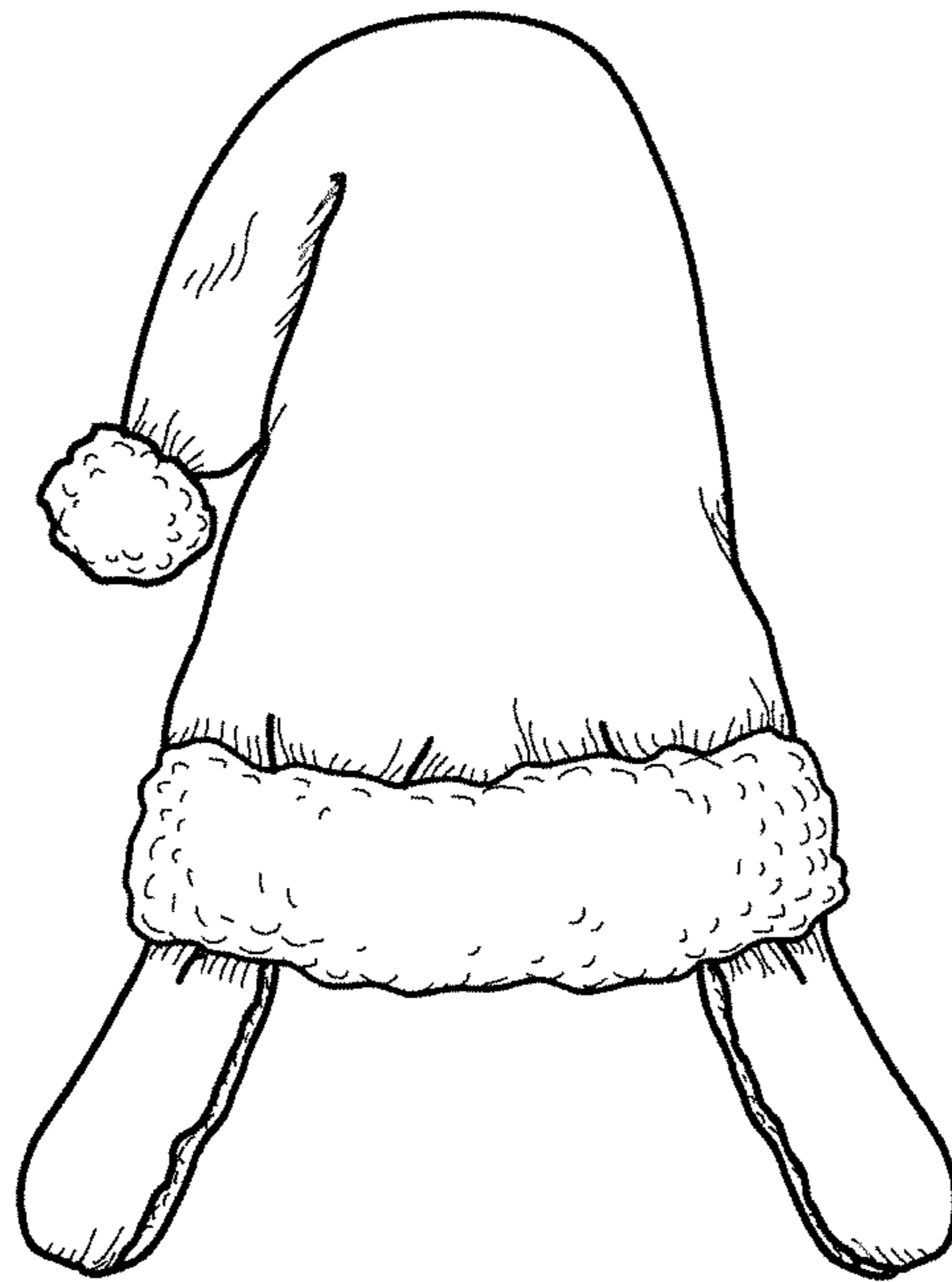

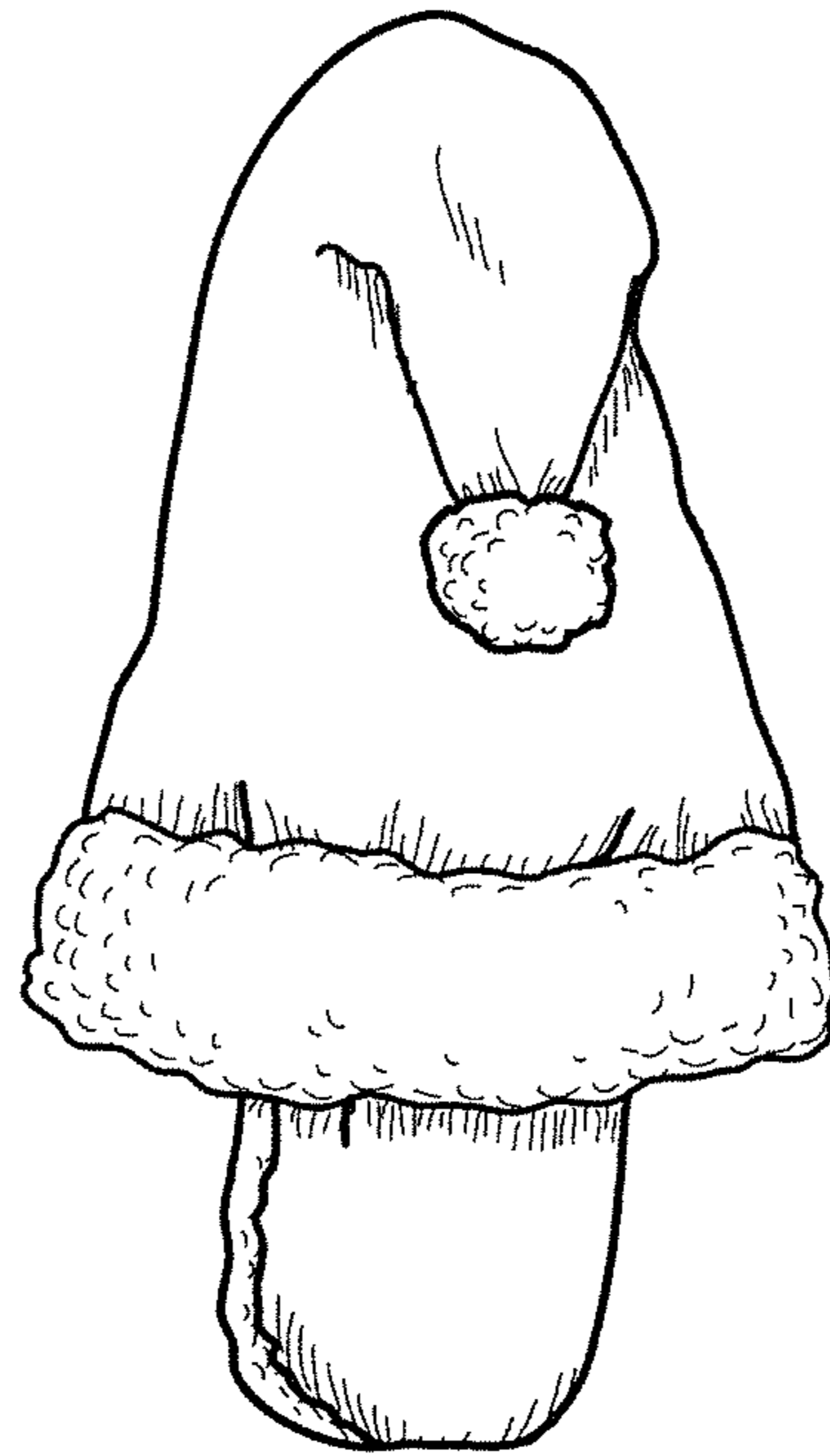

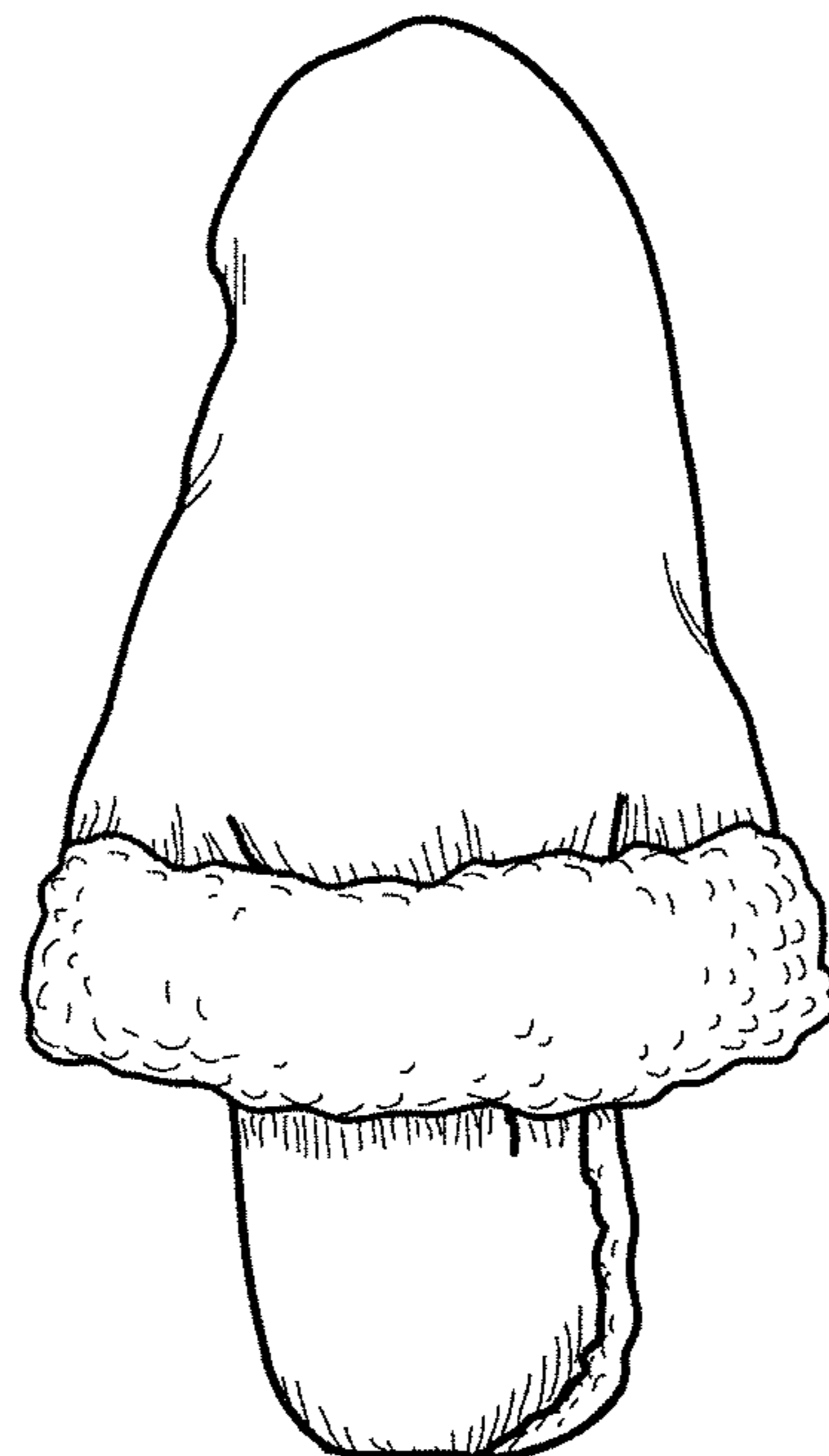

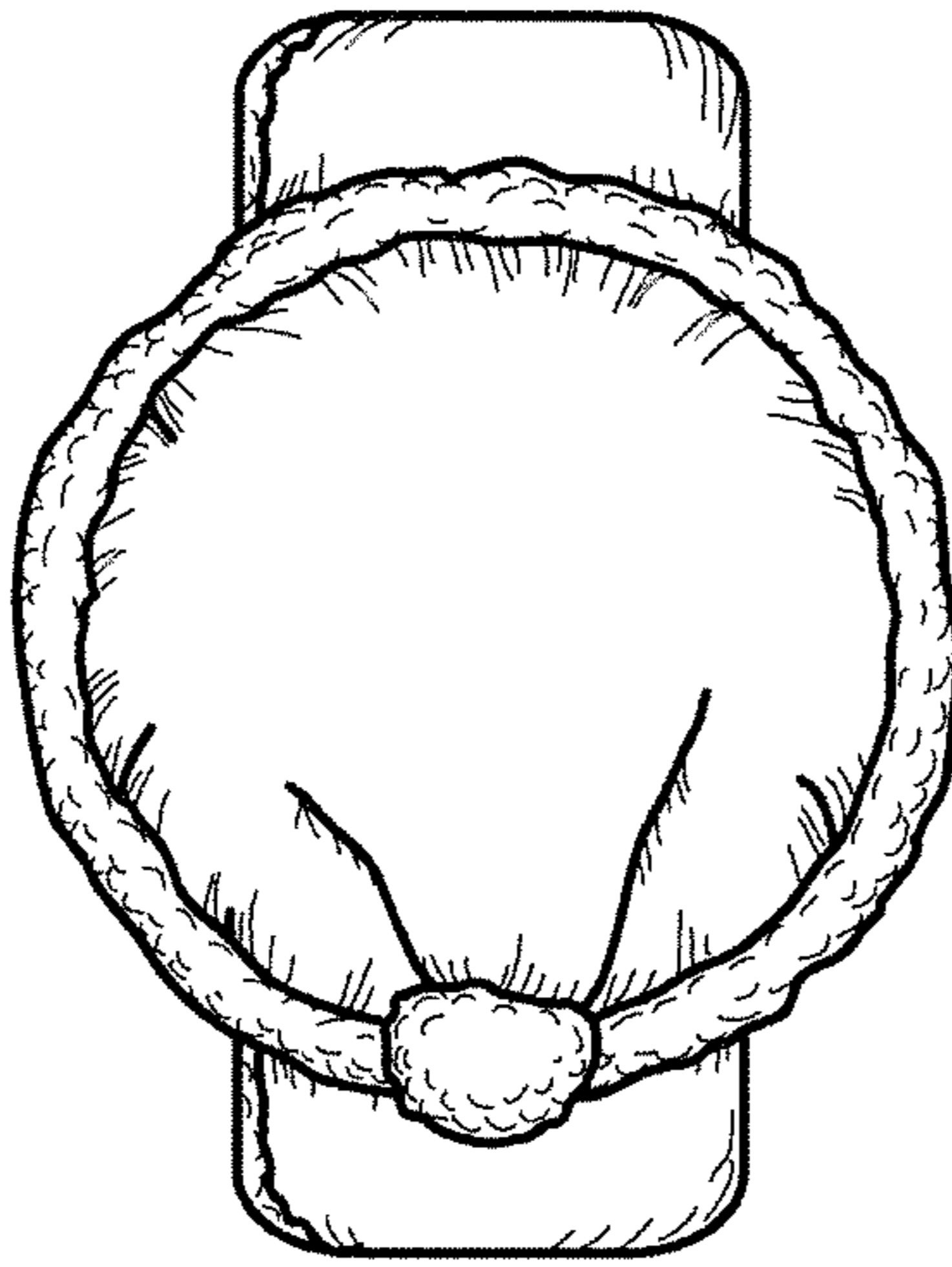
