(57) **CLAIM**

The ornamental design for a sock pocket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sock pocket showing my new design in its environment.

FIG. 4 is an elevational view of one side thereof.

The opposite side elevational view is a mirror image thereof.

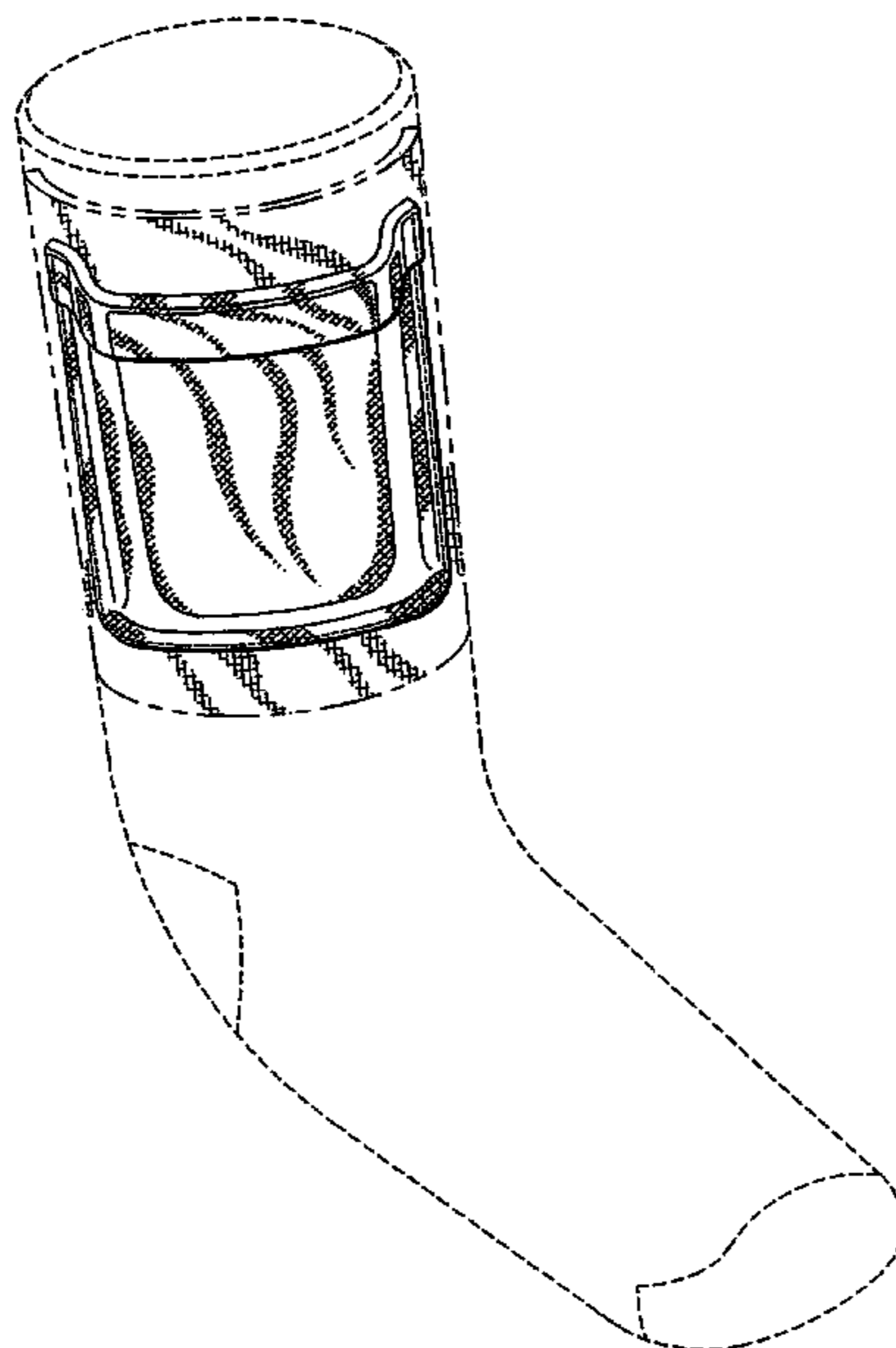
FIG. 5 is a bottom plan view thereof; and,

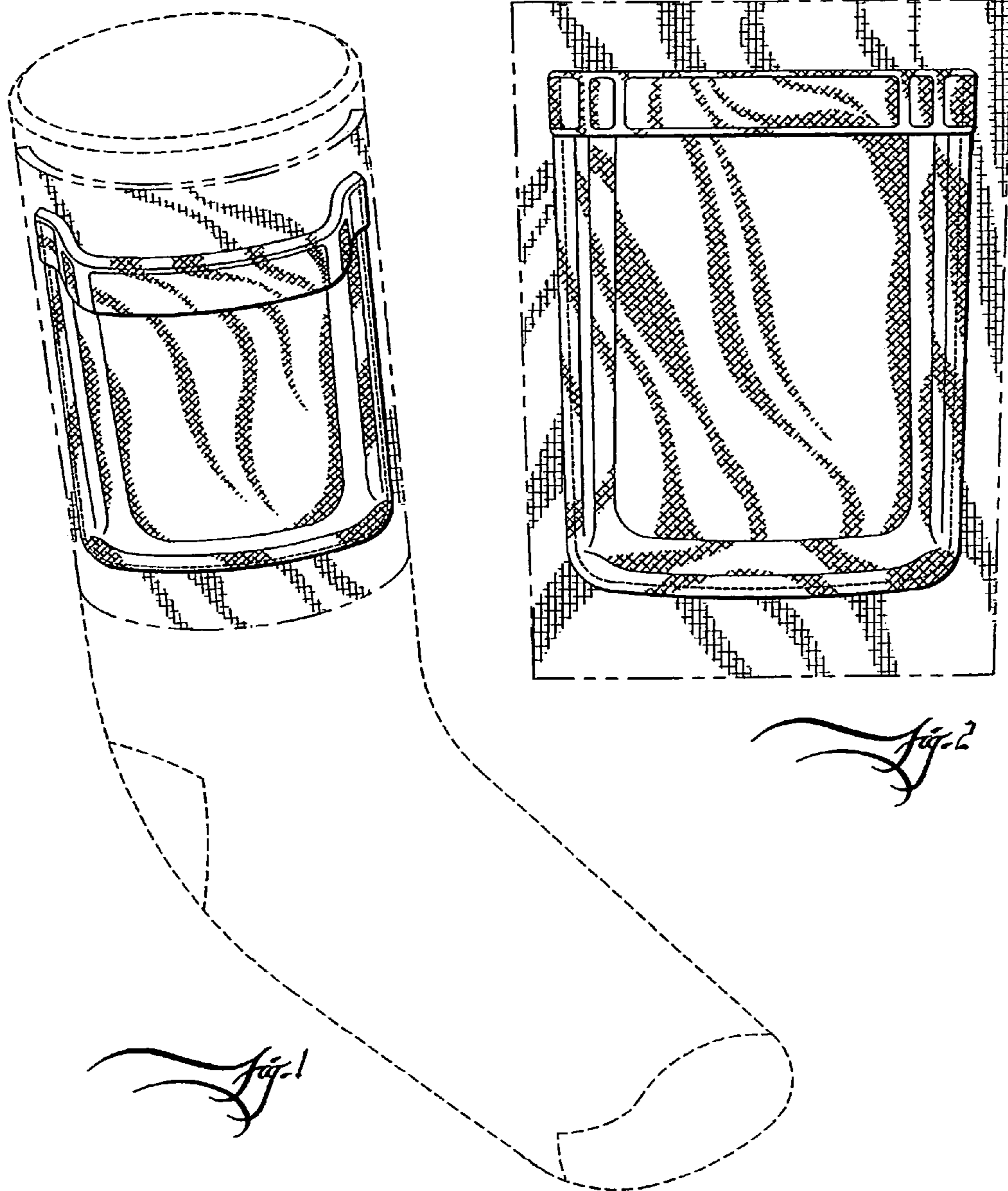
FIG. 6 is a elevational view from back side thereof.

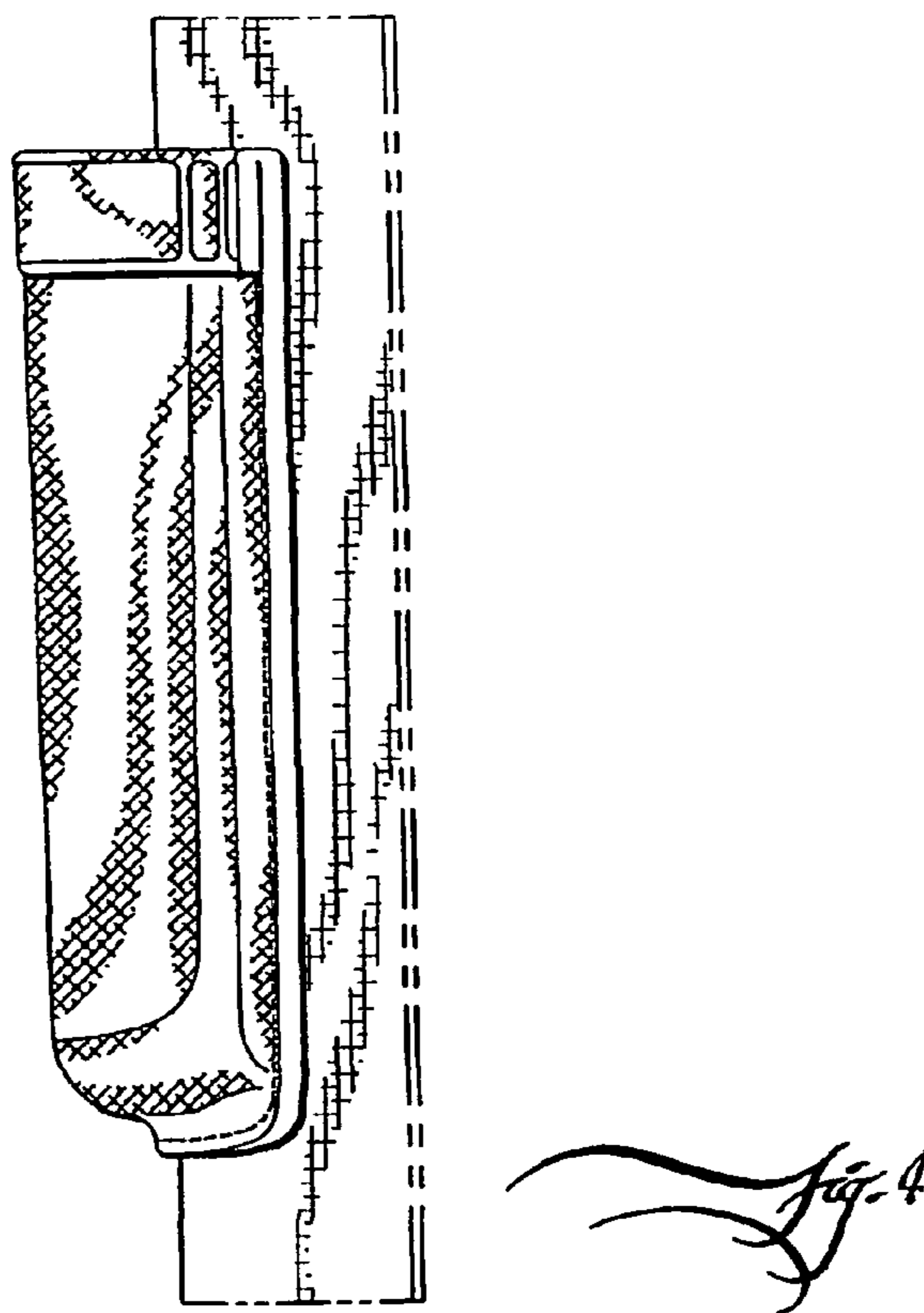
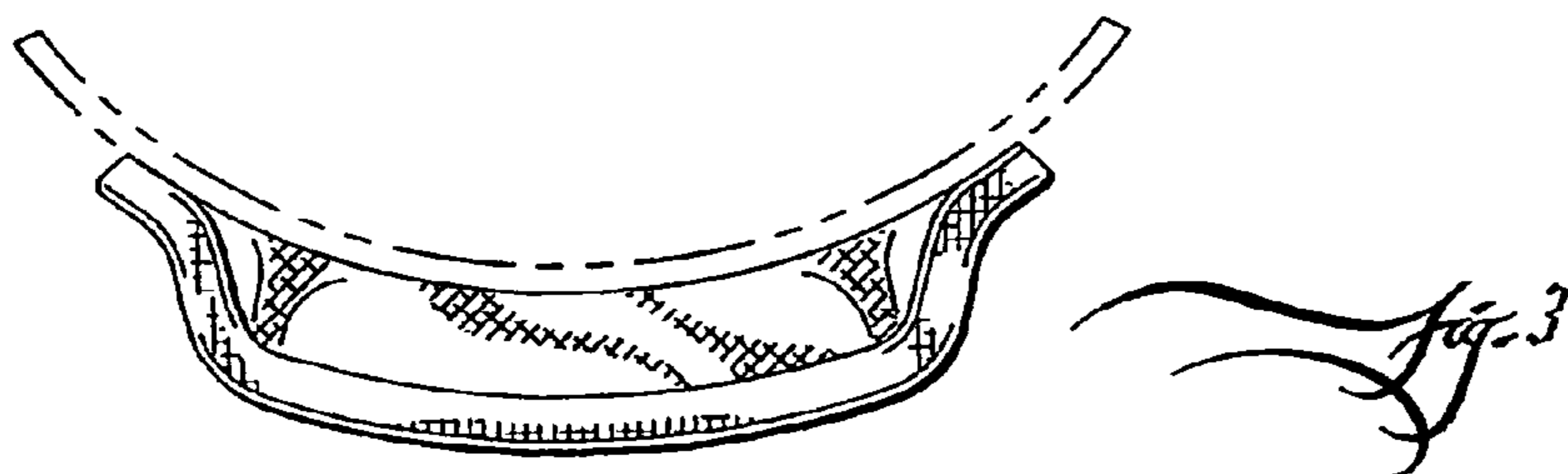

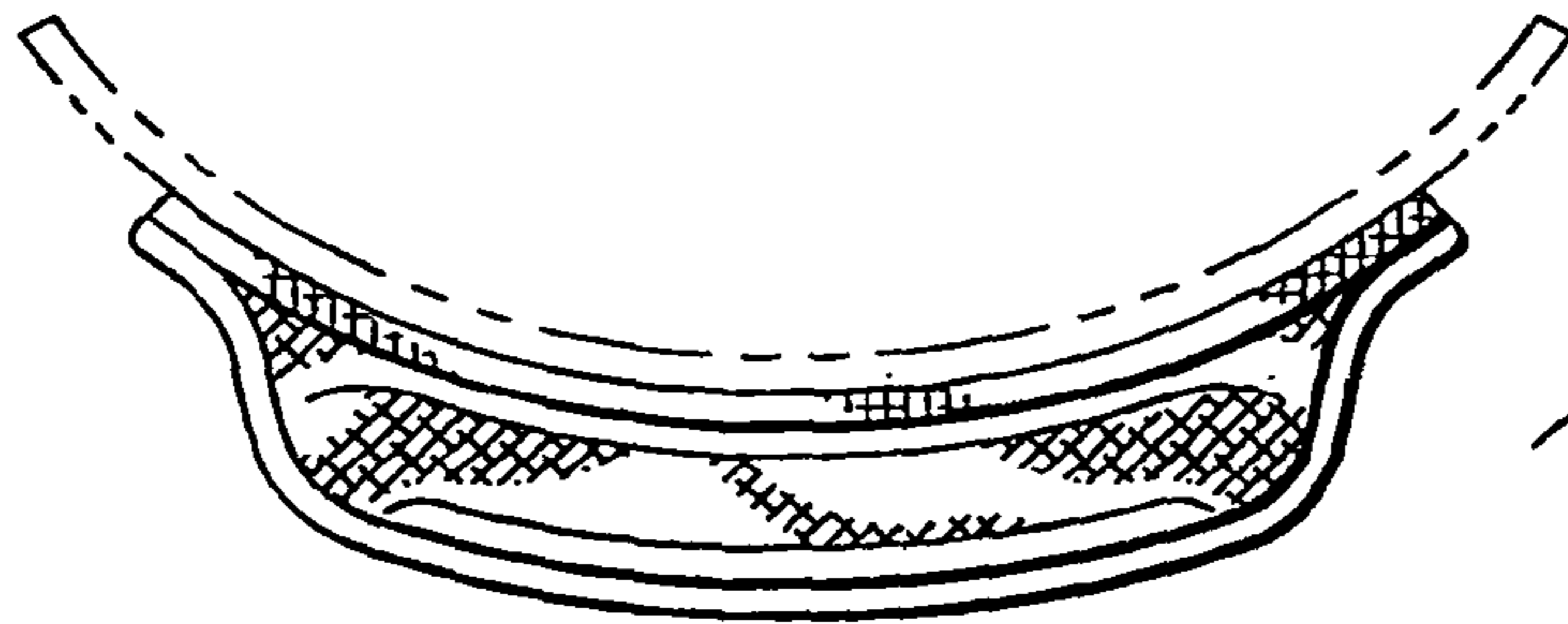
The small dashed lines shown in FIGS. 1, 2, 3 and 6 represent conventional stitching and are a part of the claimed design.

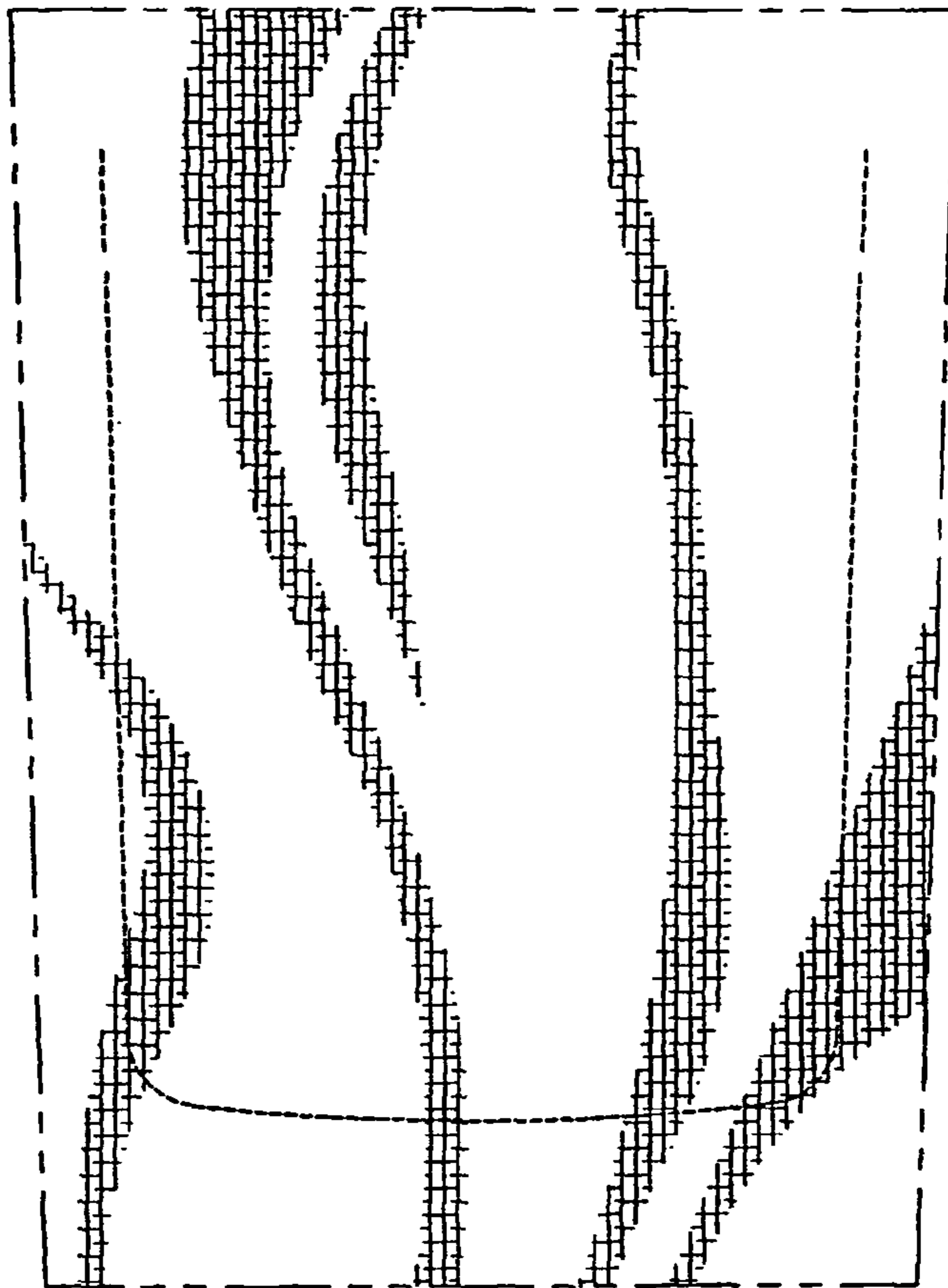
