(57) **CLAIM**

I claim the ornamental design for a tapered wearable pocket
with earphone ports, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tapered wearable pocket
with earphone ports;

FIG. 2 is a top plan view of the tapered wearable pocket of
FIG. 1;

FIG. 3 is a front elevation view of the tapered wearable pocket
of FIG. 1;

FIG. 4 is a rear elevation view of the tapered wearable pocket
of FIG. 1;

FIG. 5 is a bottom plan view of the tapered wearable pocket of
FIG. 1;

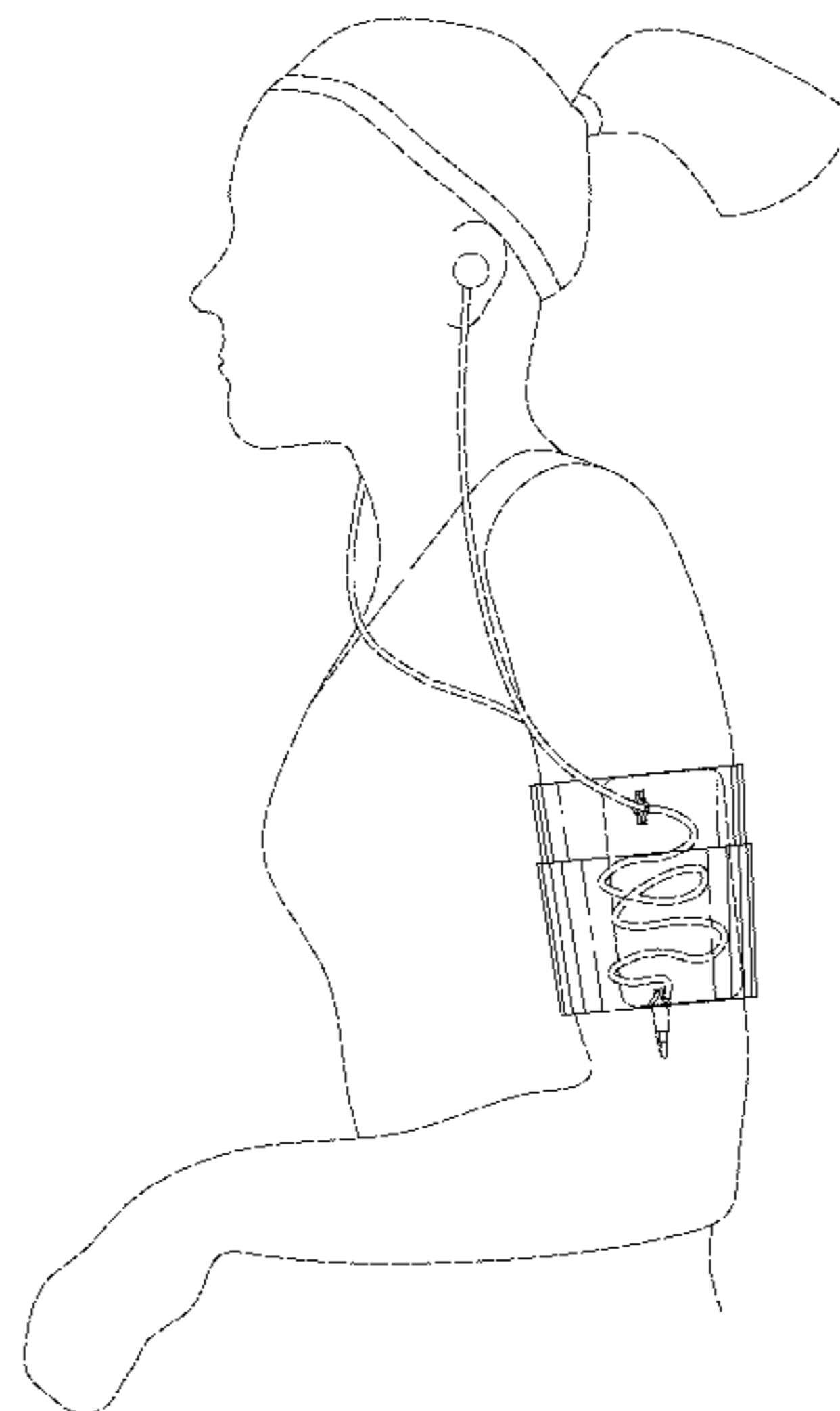
FIG. 6 is a left side elevation view of the tapered wearable
pocket of FIG. 1;

FIG. 7 is a right side elevation view of the tapered wearable
pocket of FIG. 1; and,

FIG. 8 is a perspective view of the tapered wearable pocket of
FIG. 1 being worn on the arm of a person with an earphone
cord and plug extending through the earphone ports of the
wearable pocket.

The dashed lines in FIGS. 1 through 7 represent stitch lines
and do not form part of the claimed design. The dashed lines
in FIG. 8 represent environment and do not form part of the
claimed design.

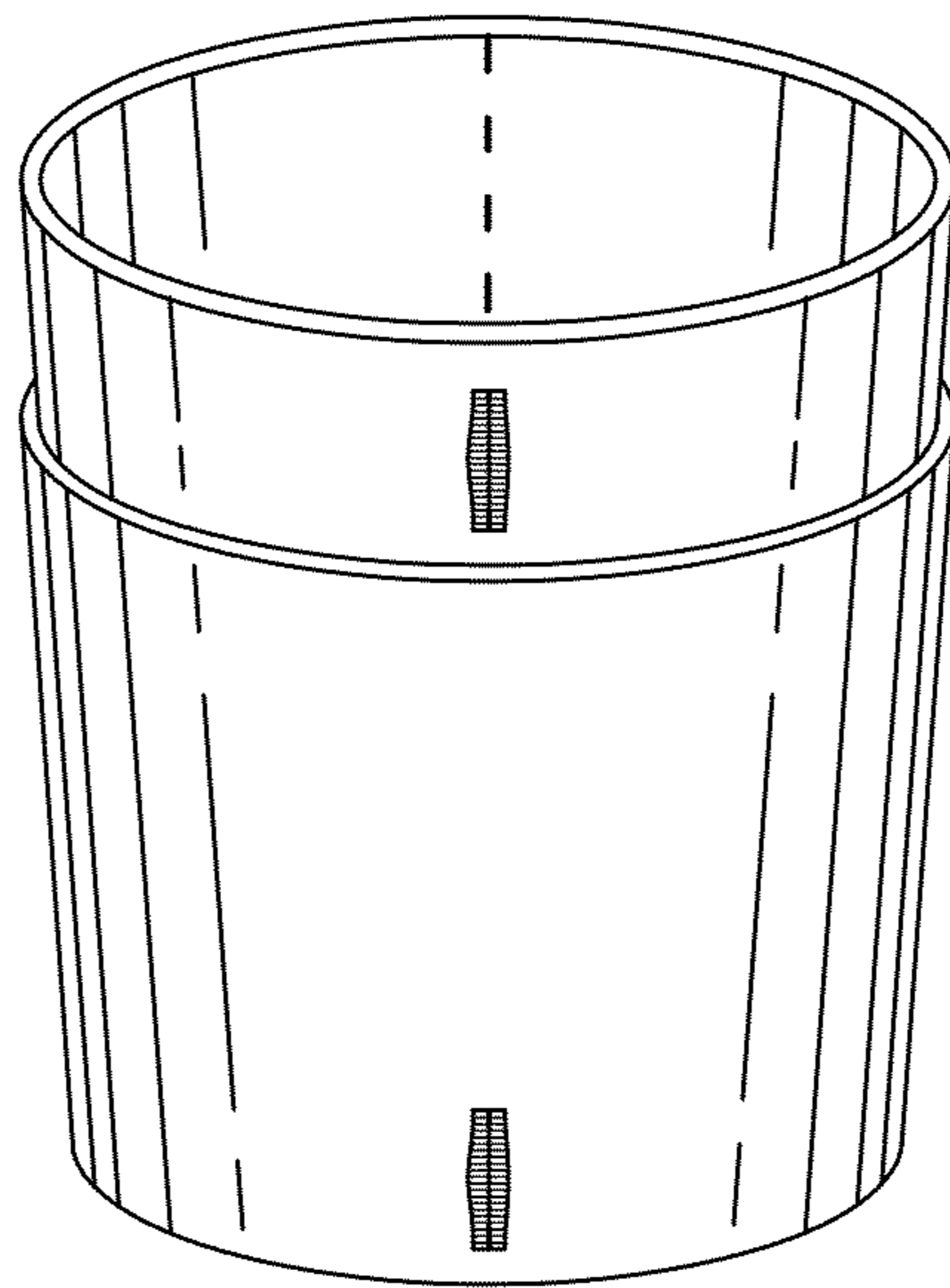

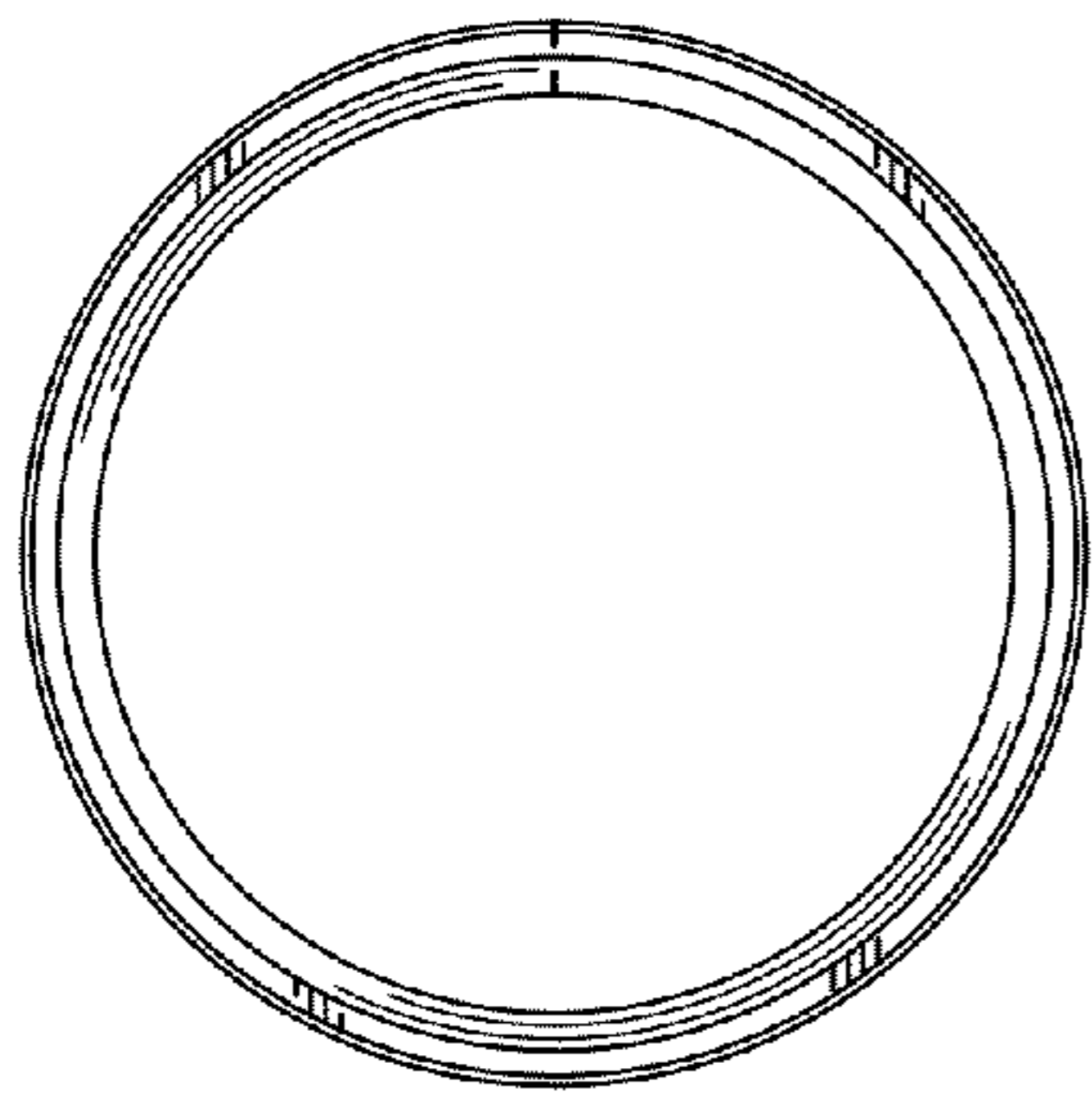

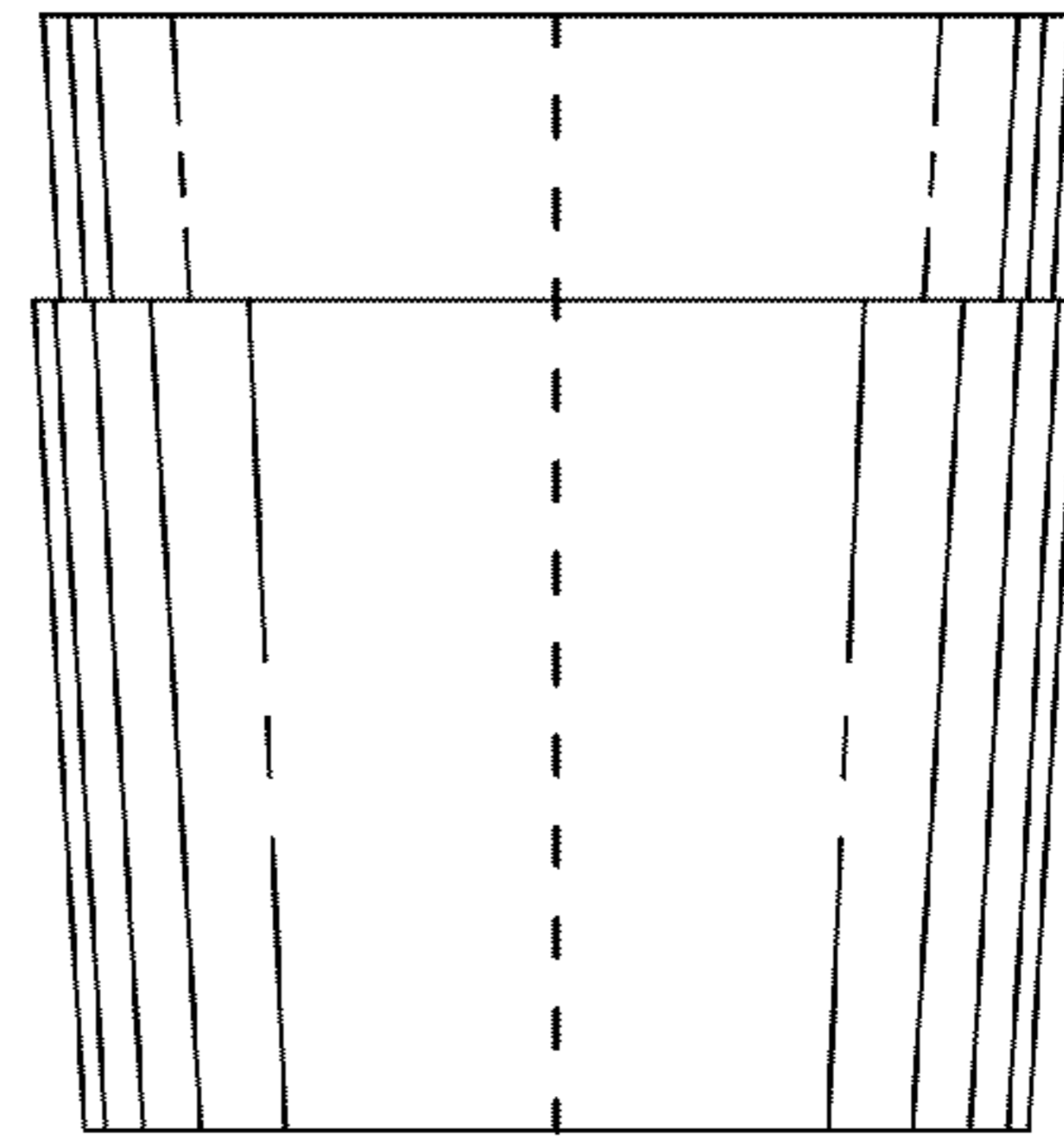

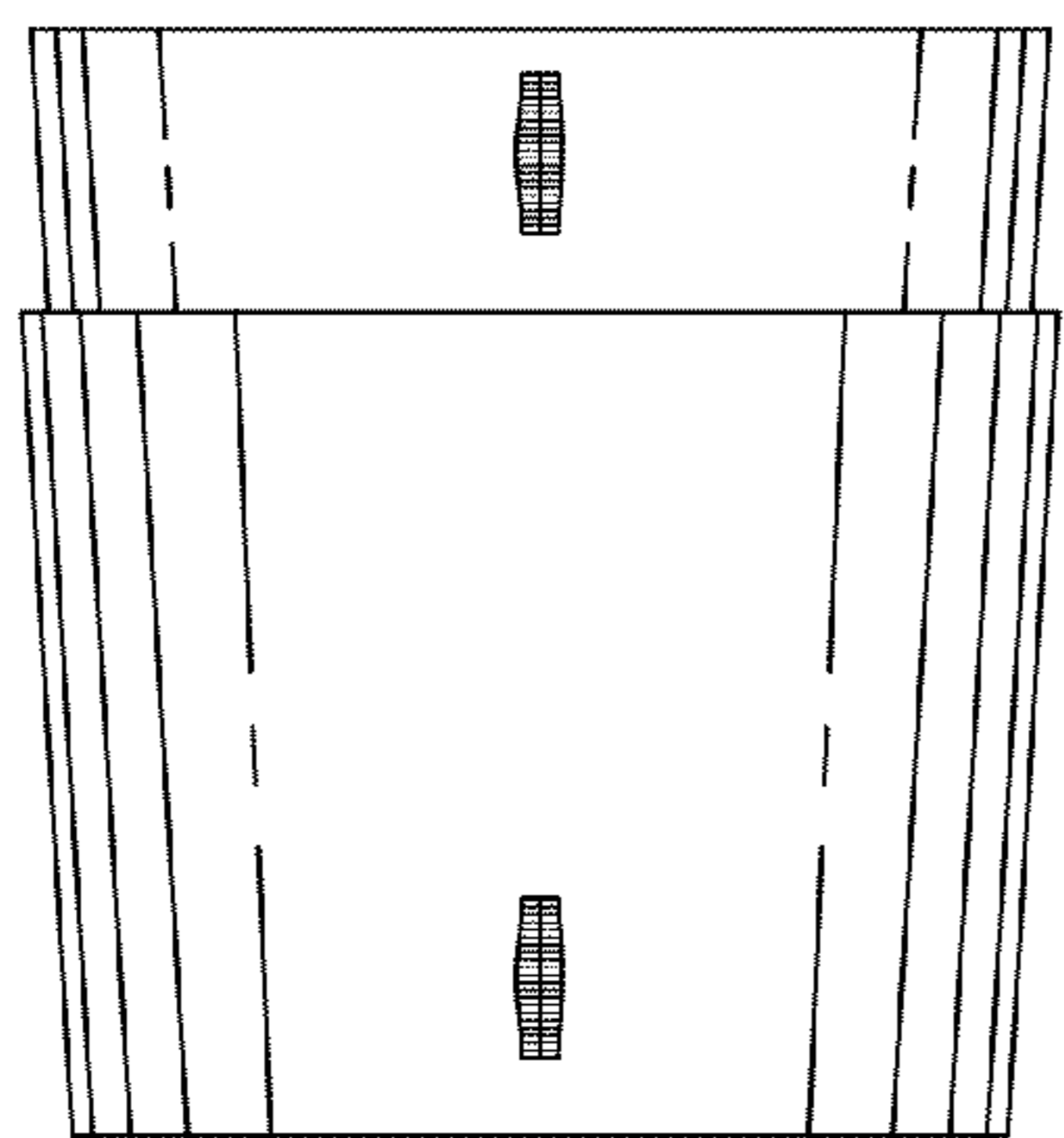

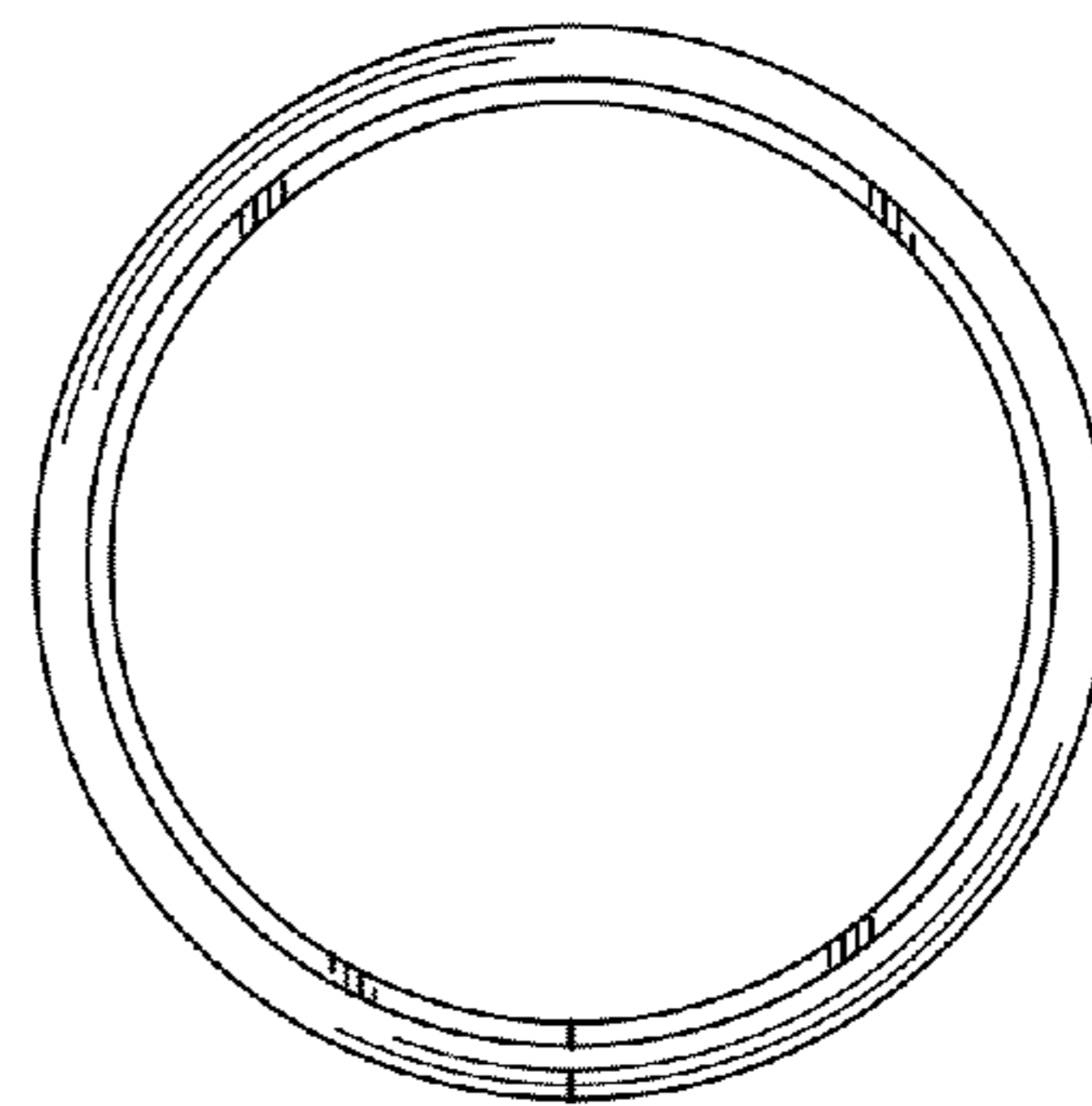

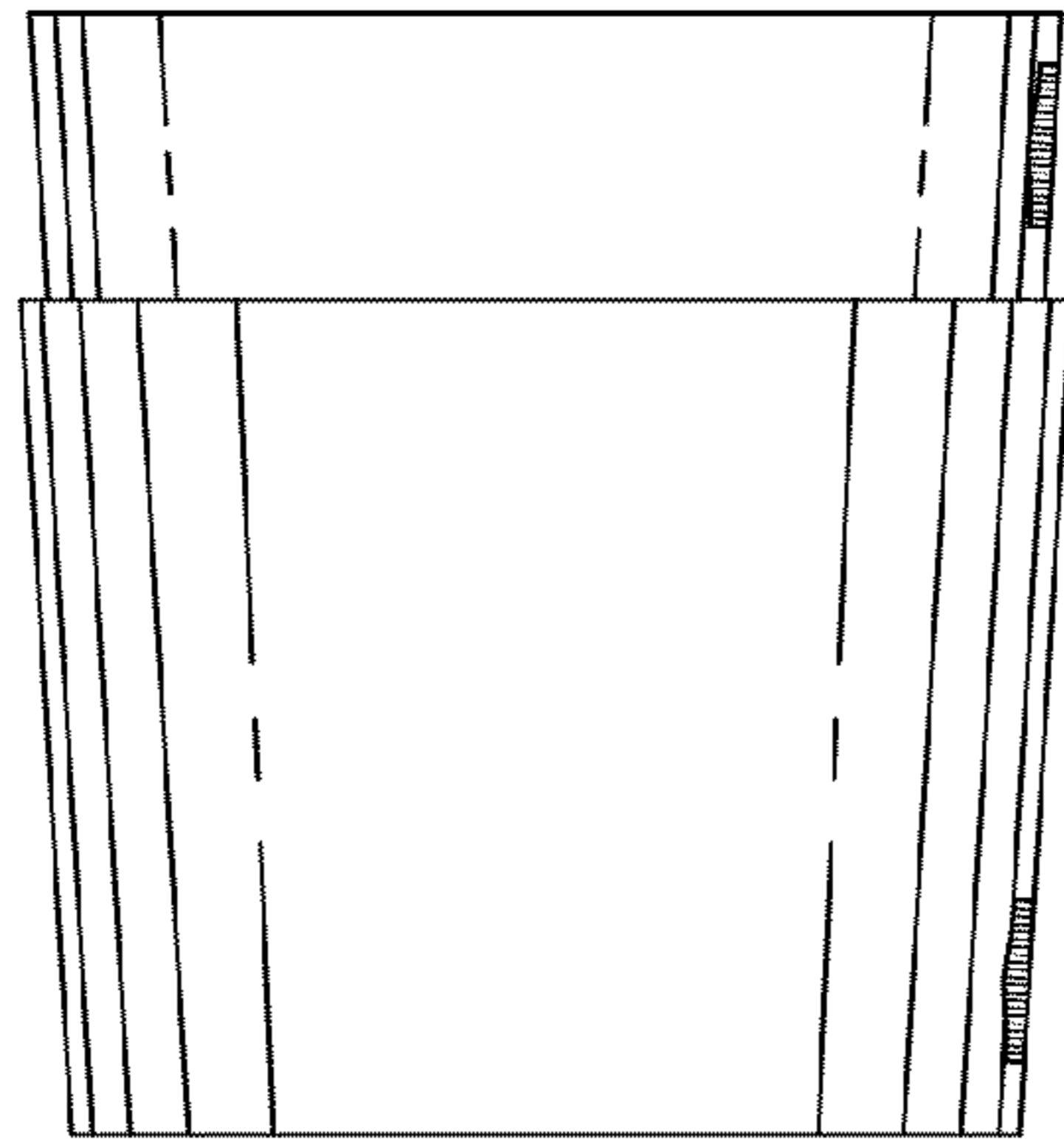

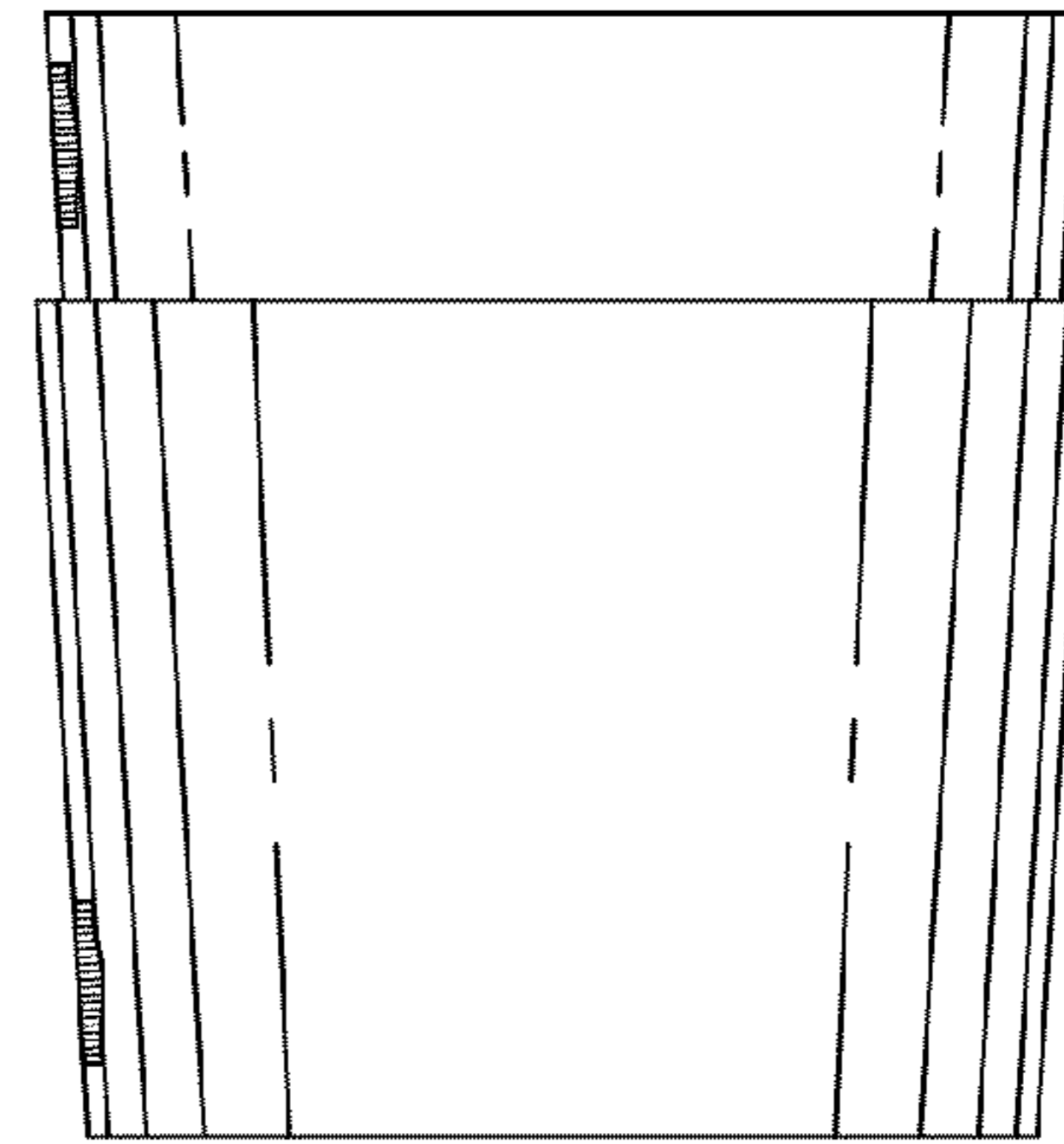

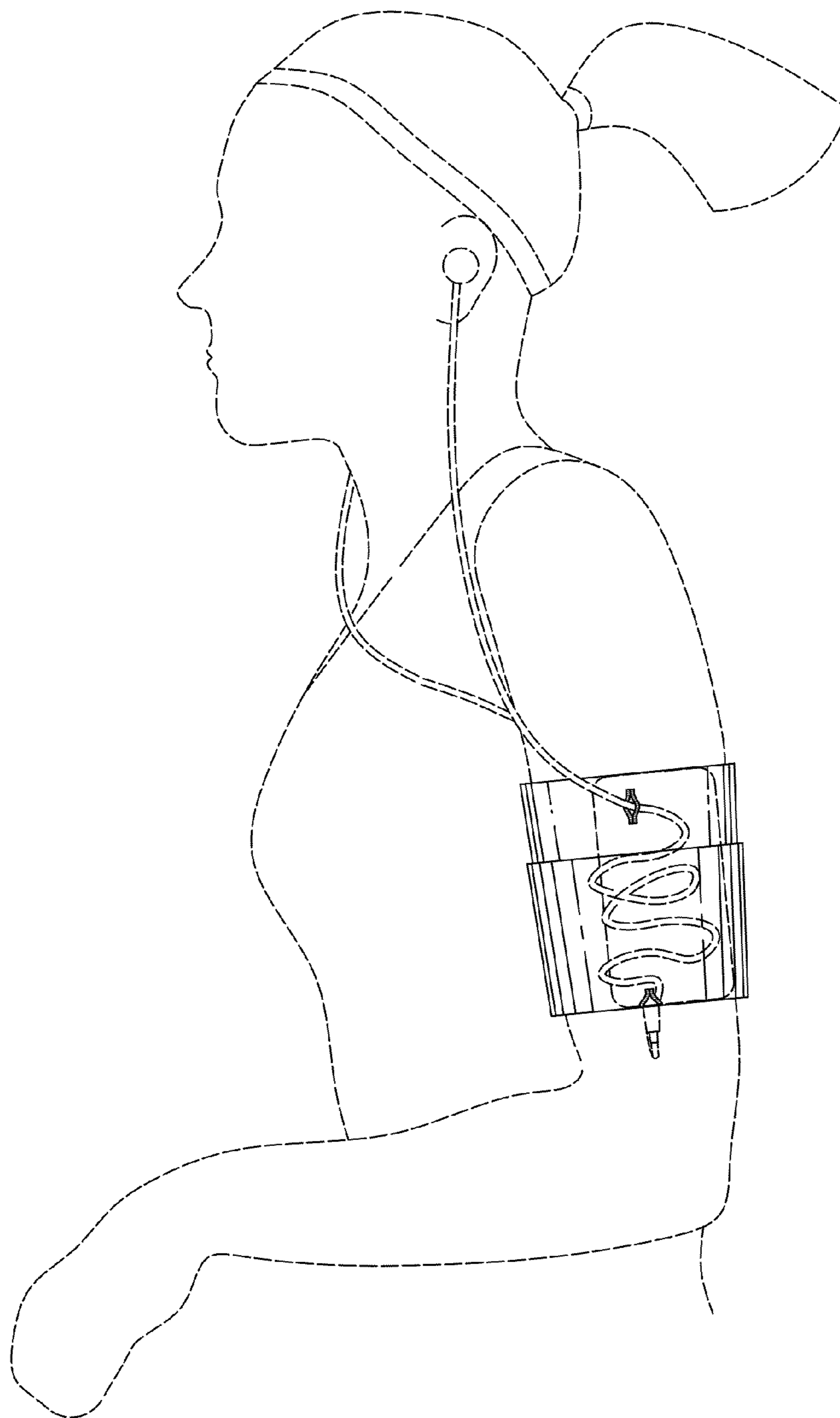
