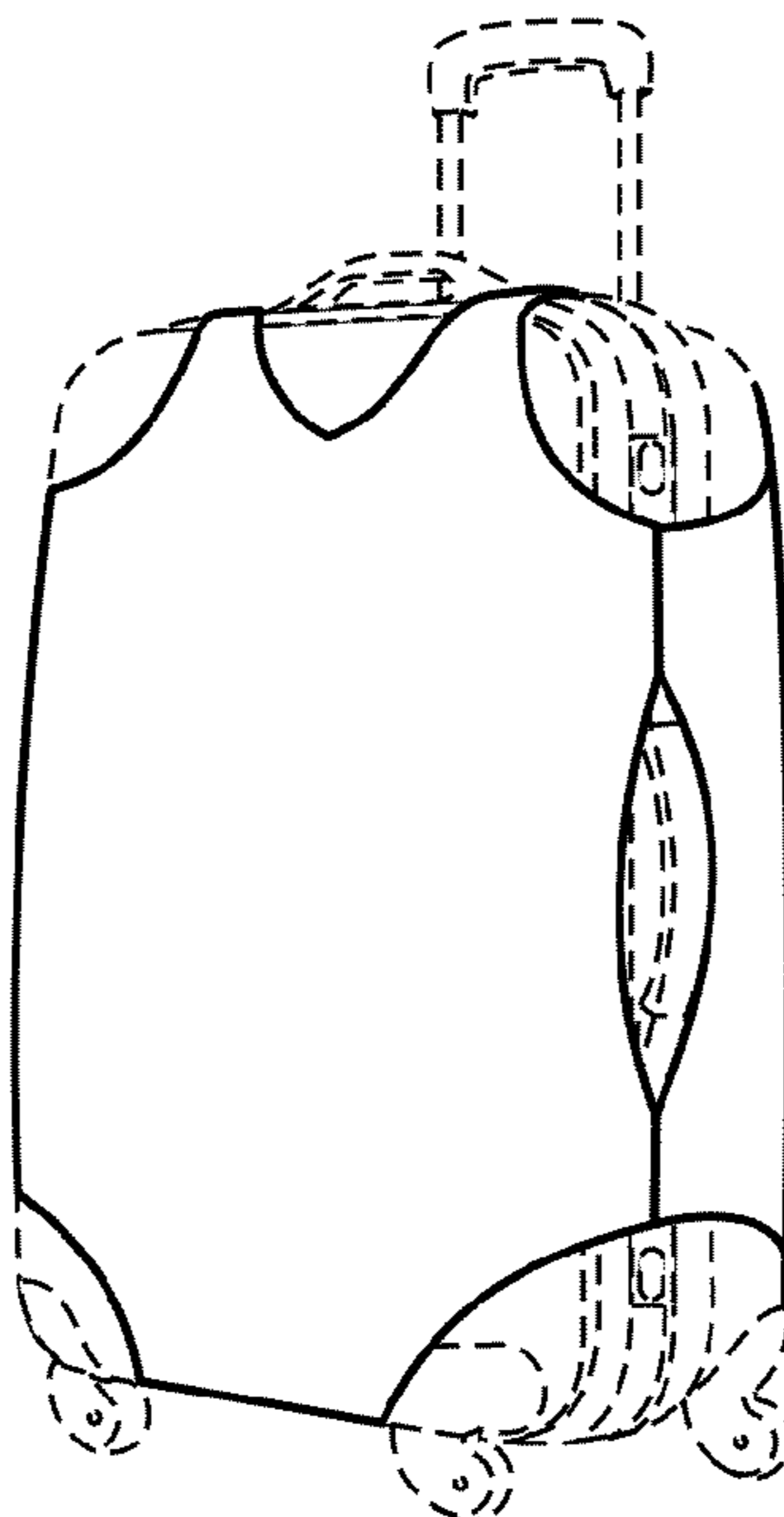
FIG. 1 is a side view of a combined baggage cover and protector shown in use;

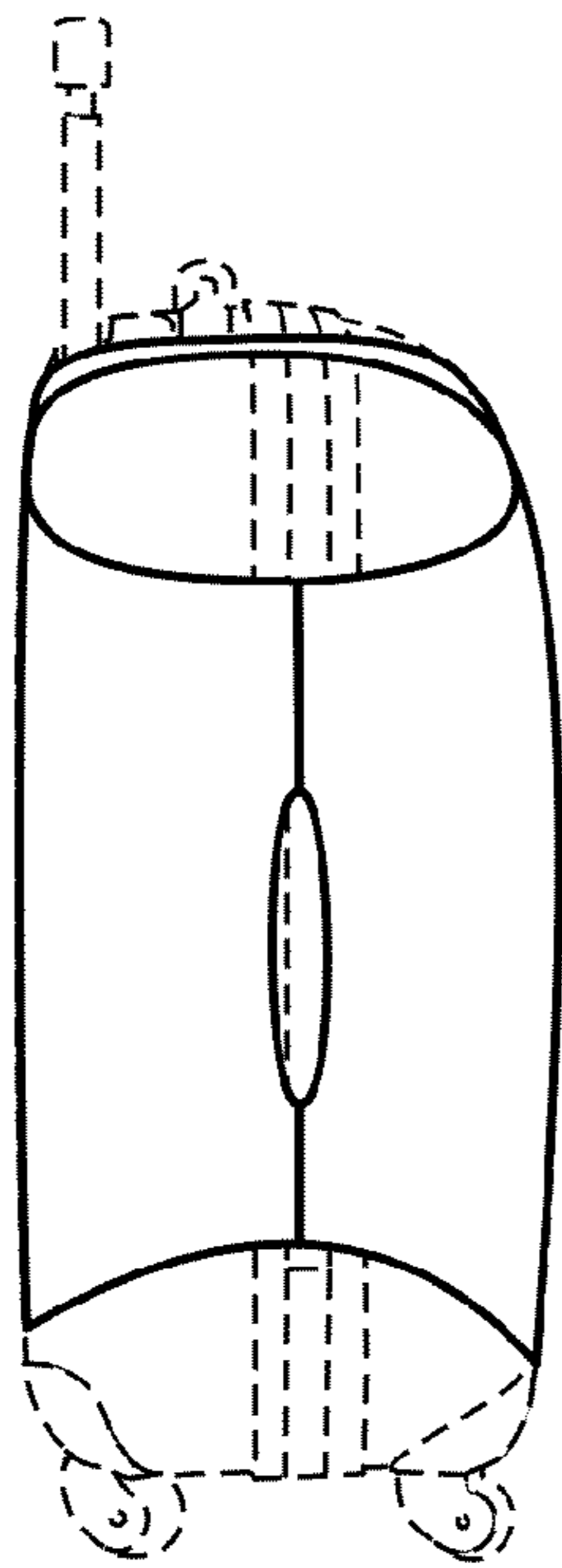

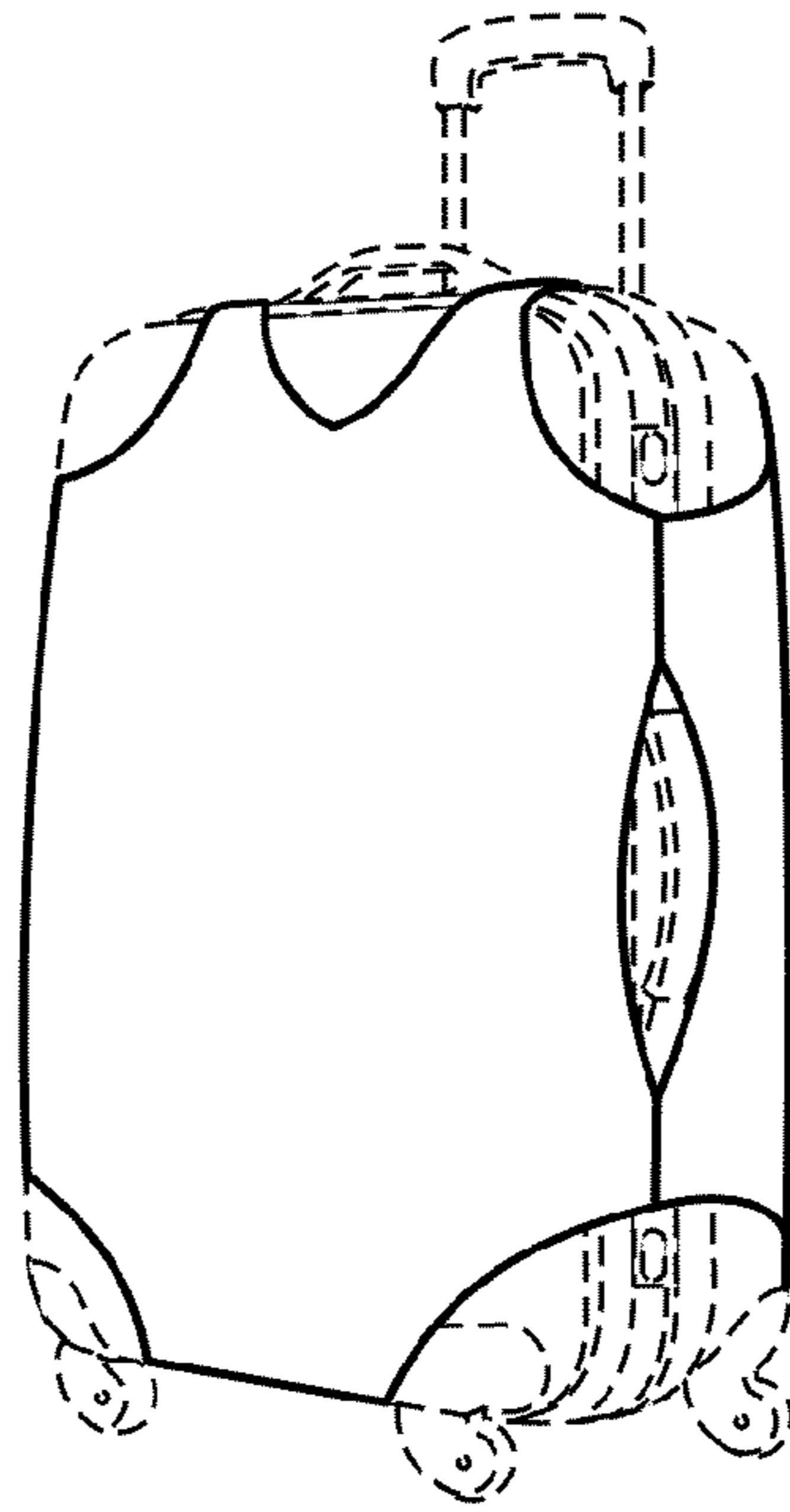

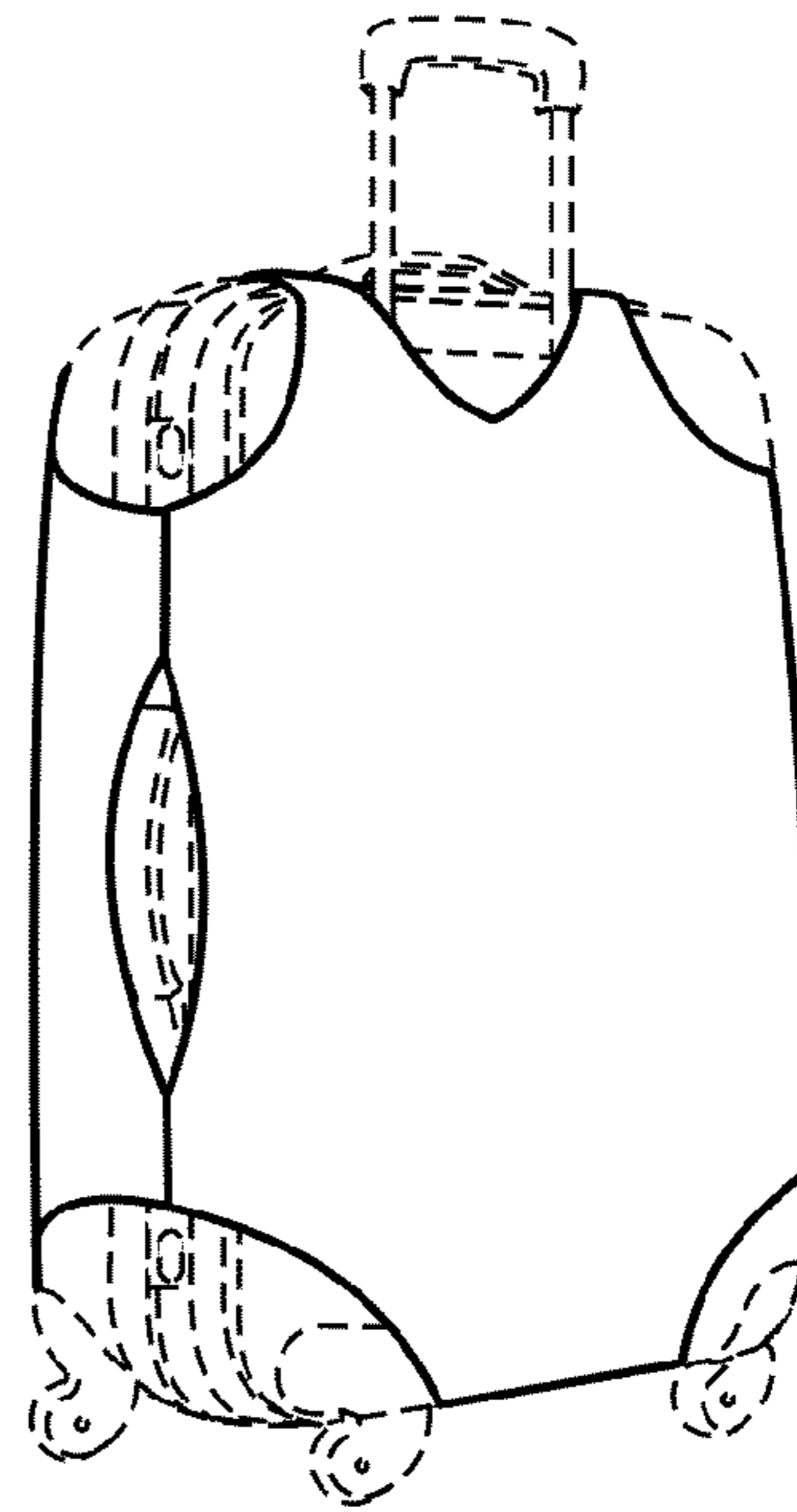

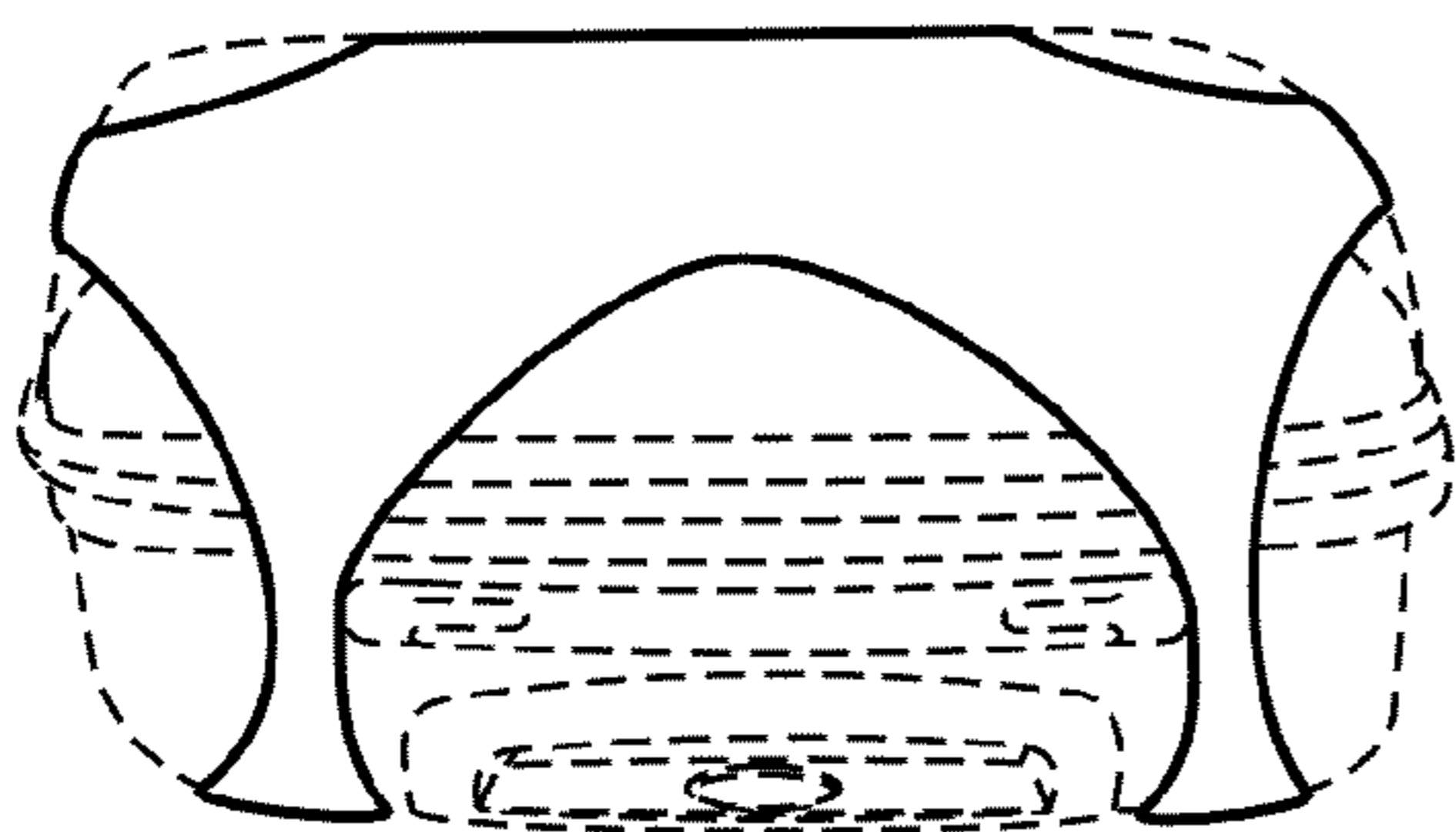

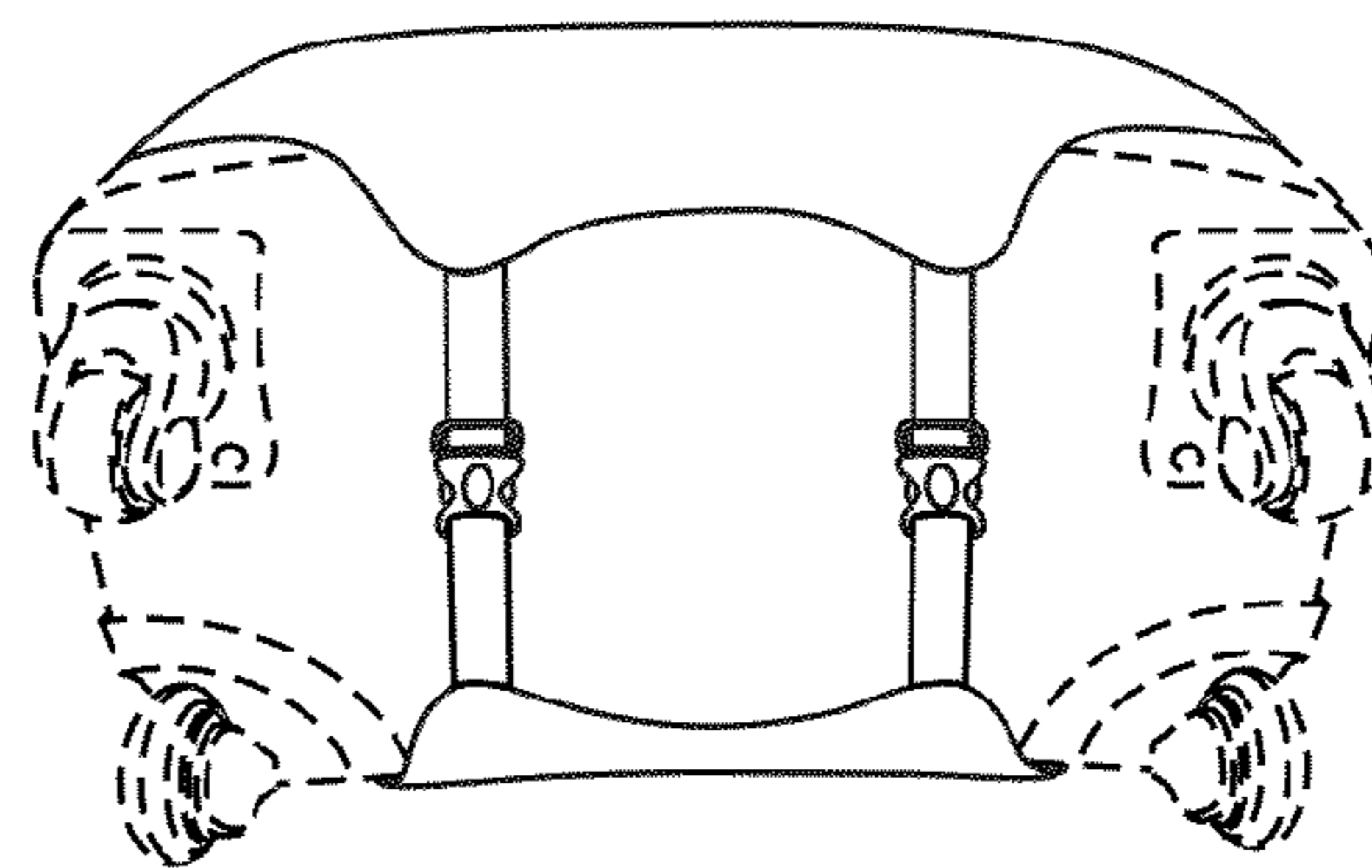

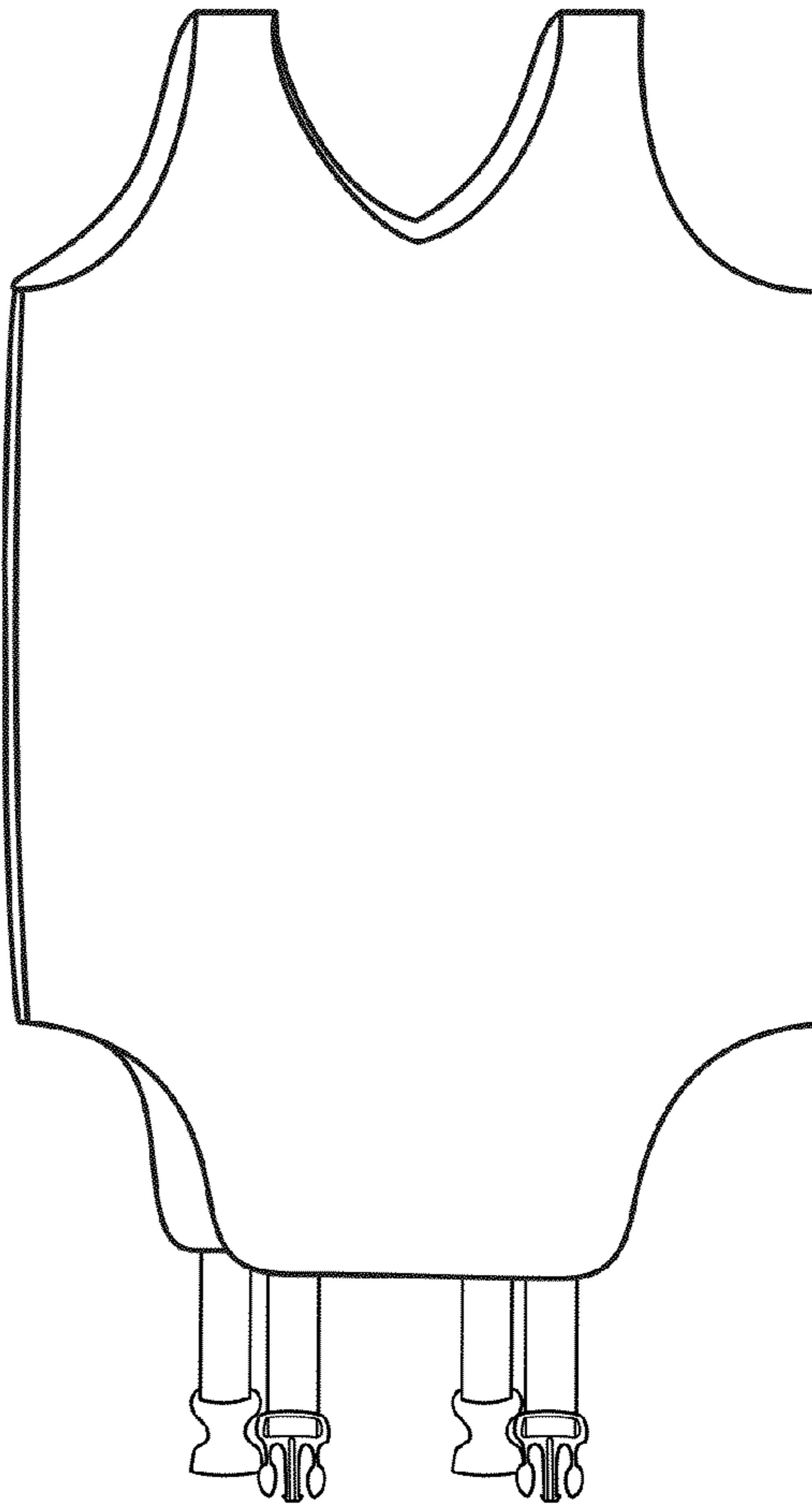

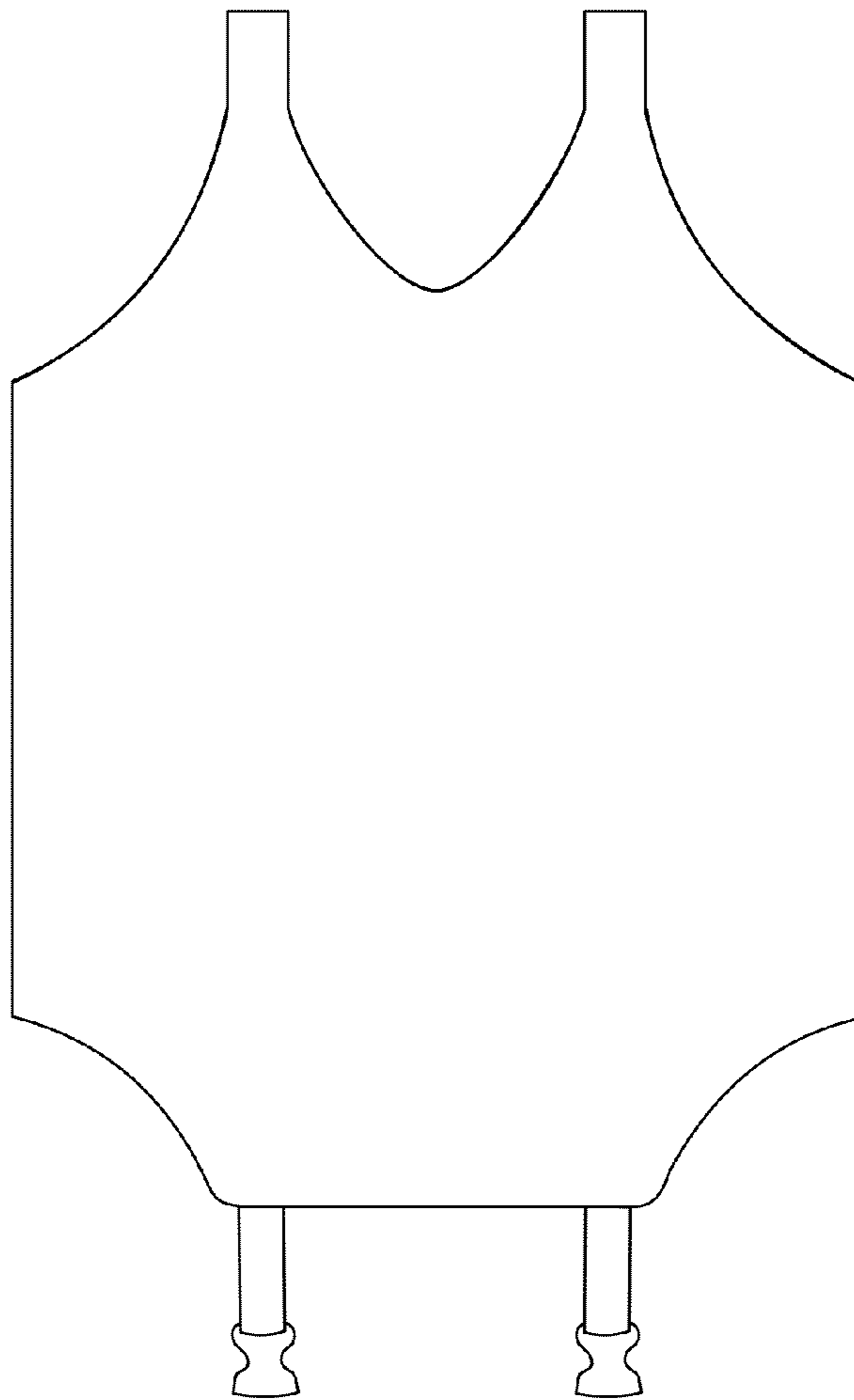

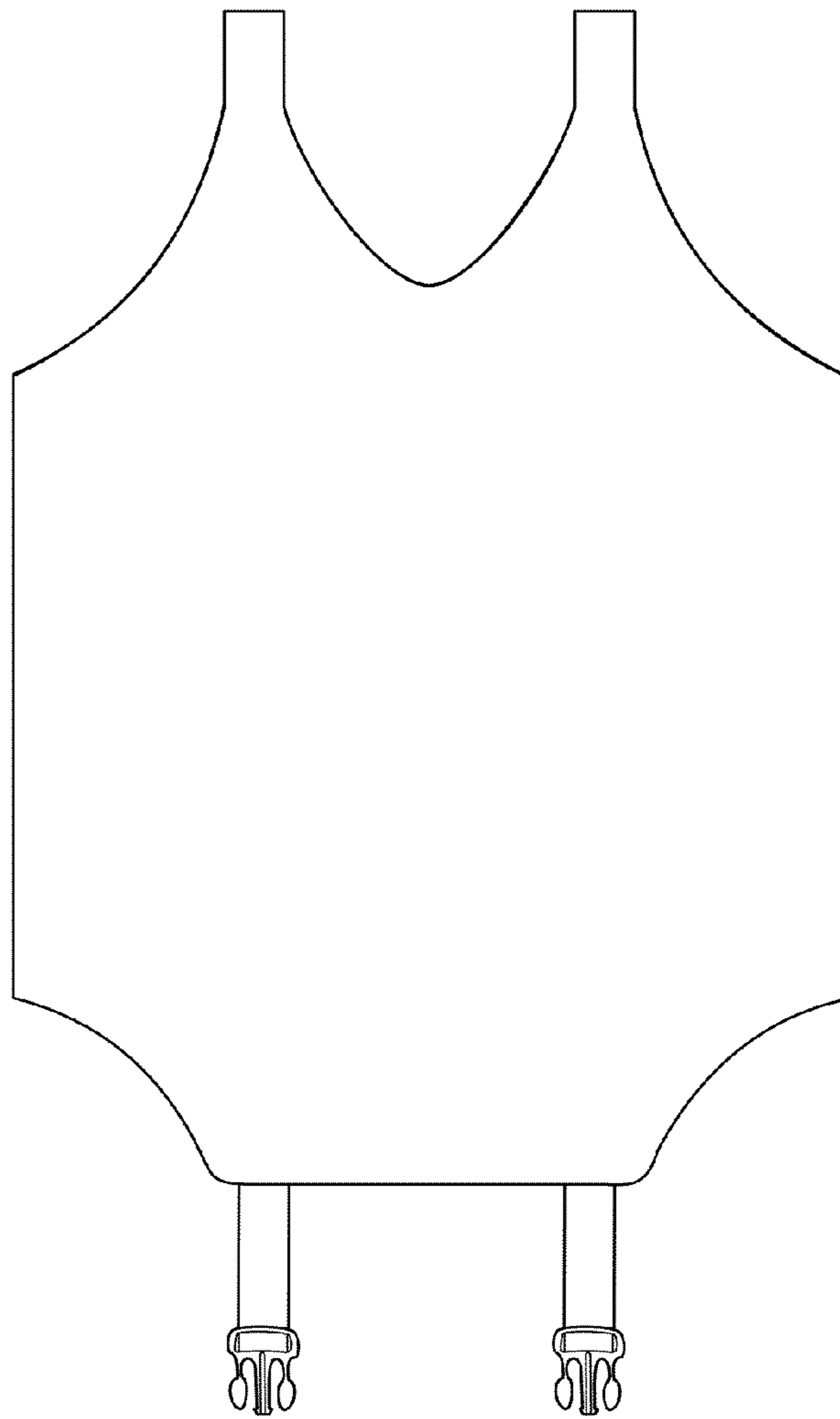

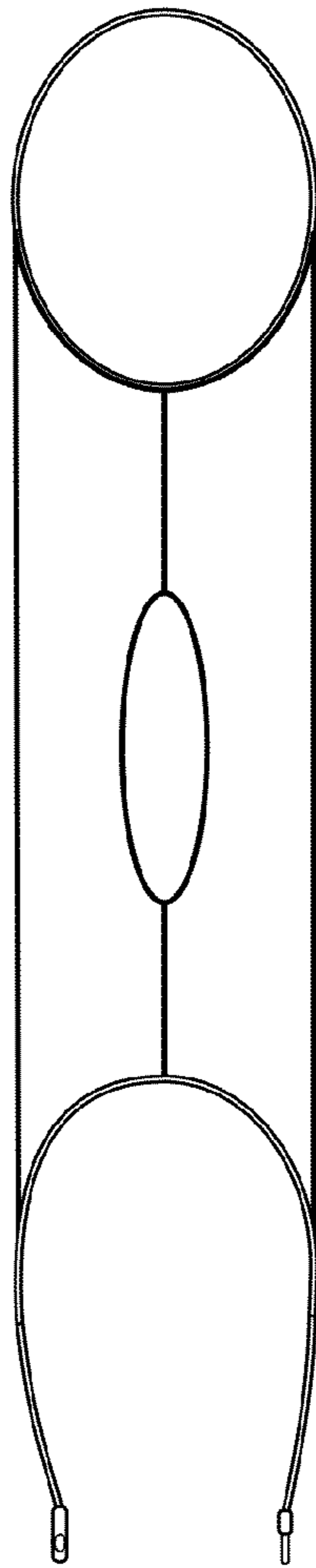
