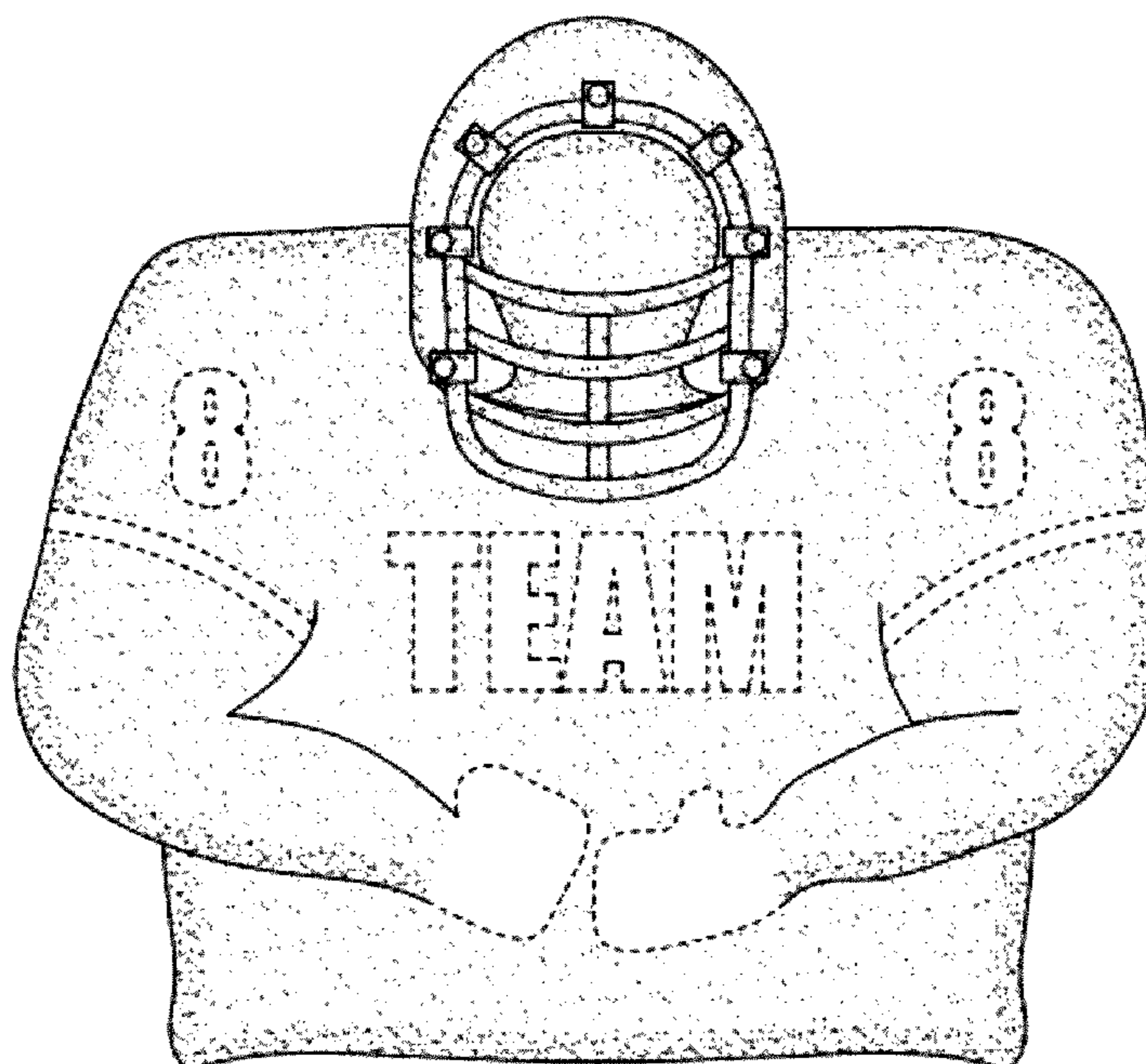
(57) **CLAIM**

The ornamental design for a seat cover, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective elevational view of a seat cover; FIG. 2 shows a front side view thereof; FIG. 3 shows a left side view thereof; and, FIG. 4 shows a rear view thereof. The broken lines in the drawing figures show portions of a seat and seat cover that form no part of the claimed design.

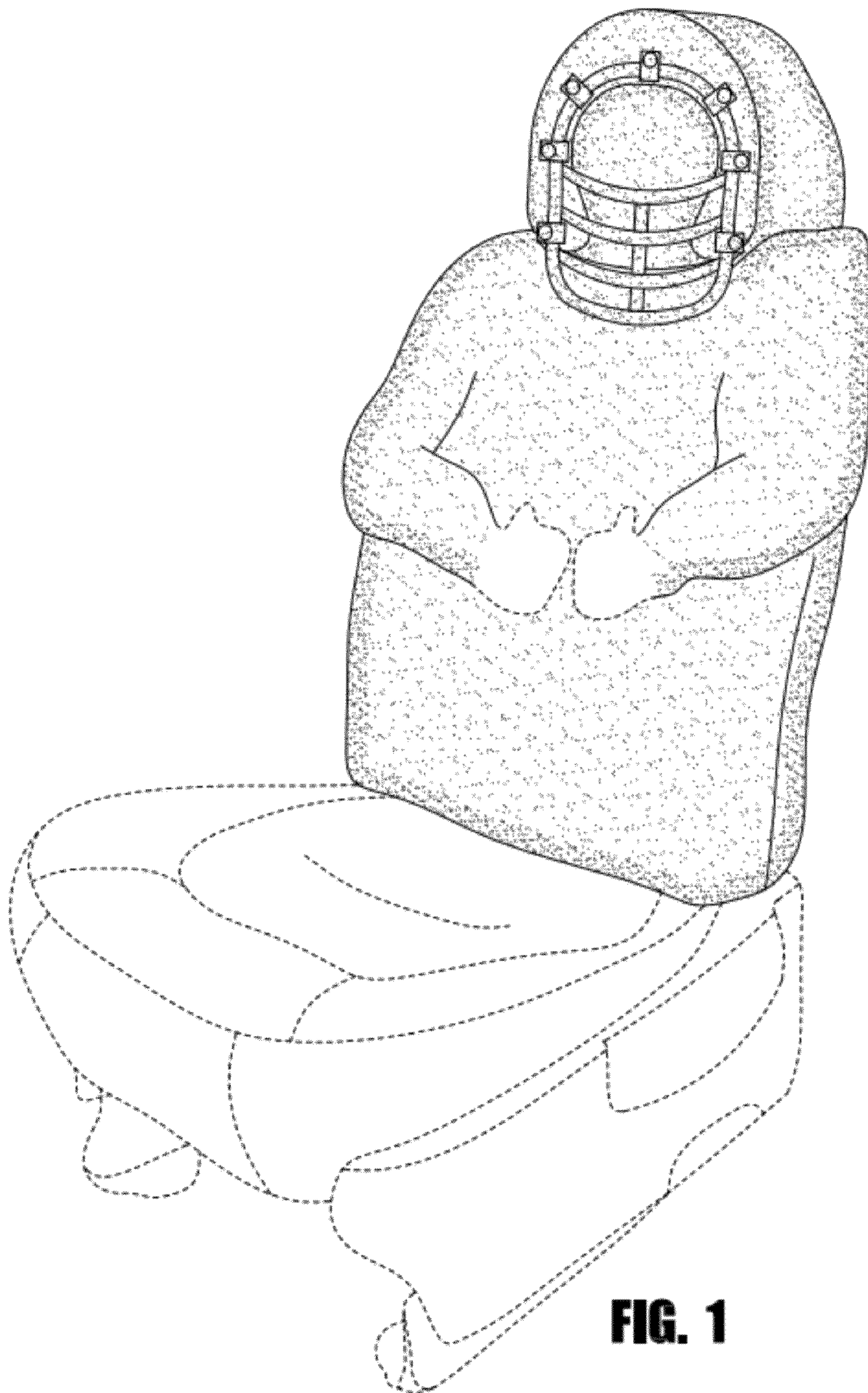

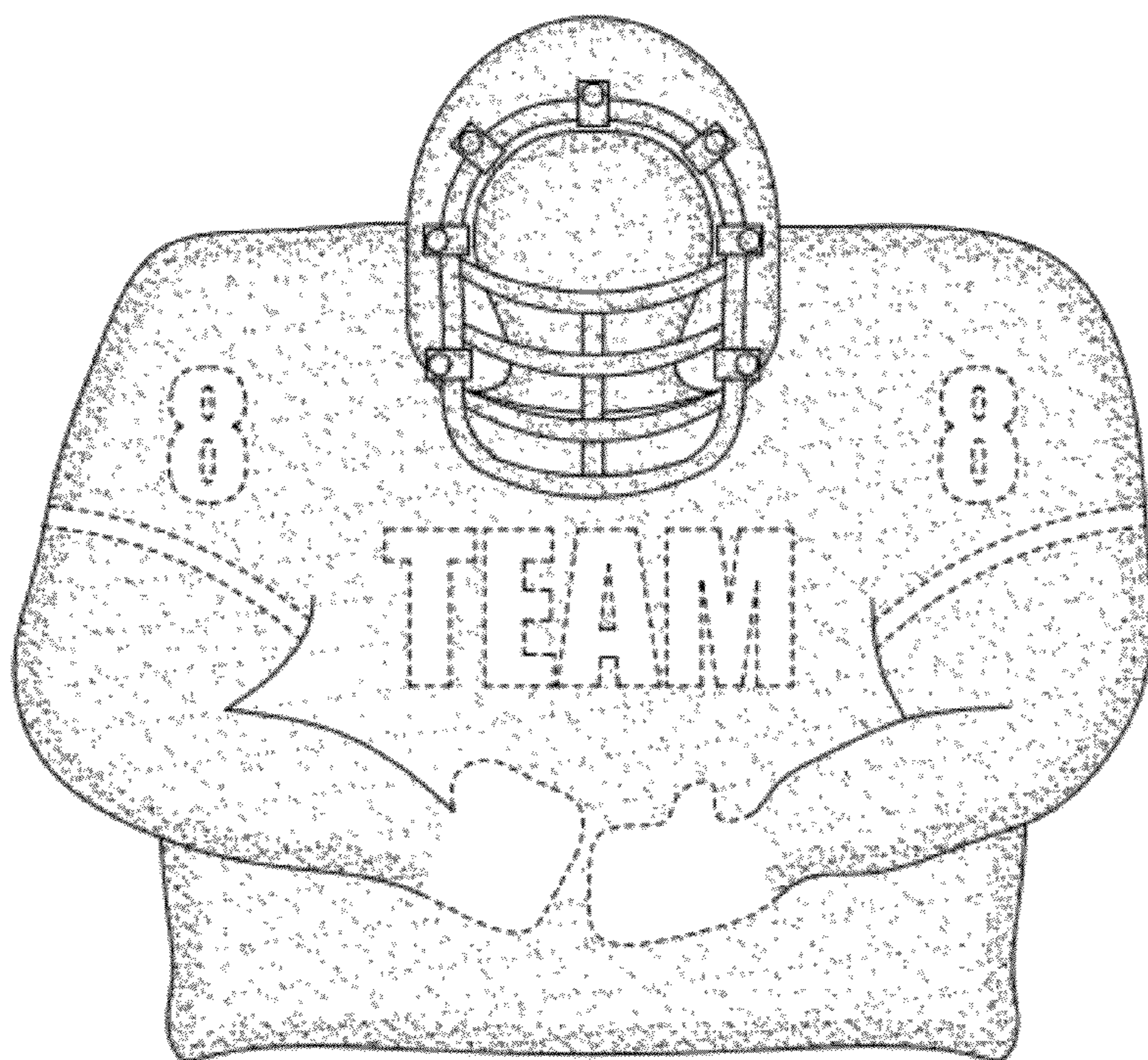

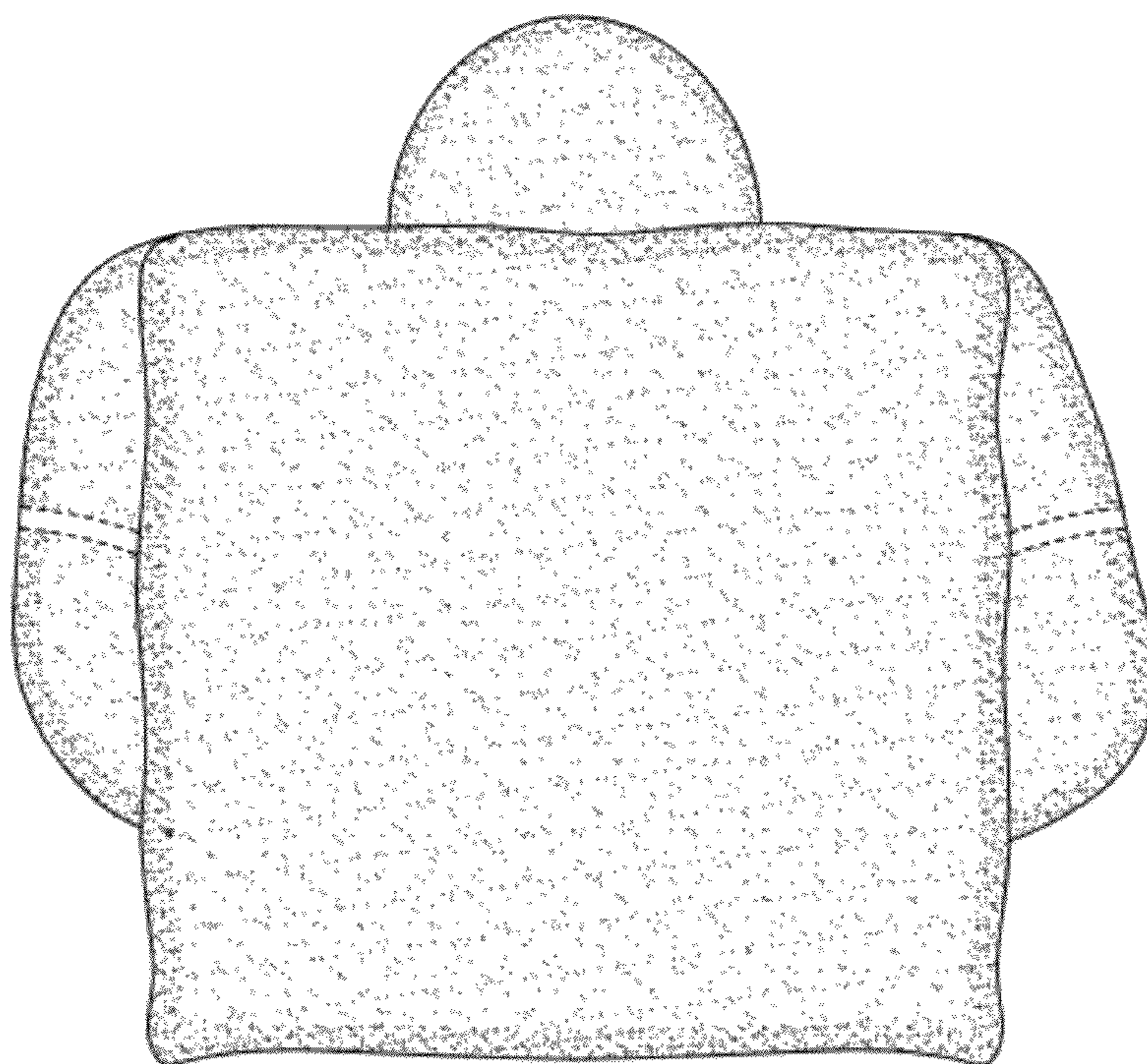
