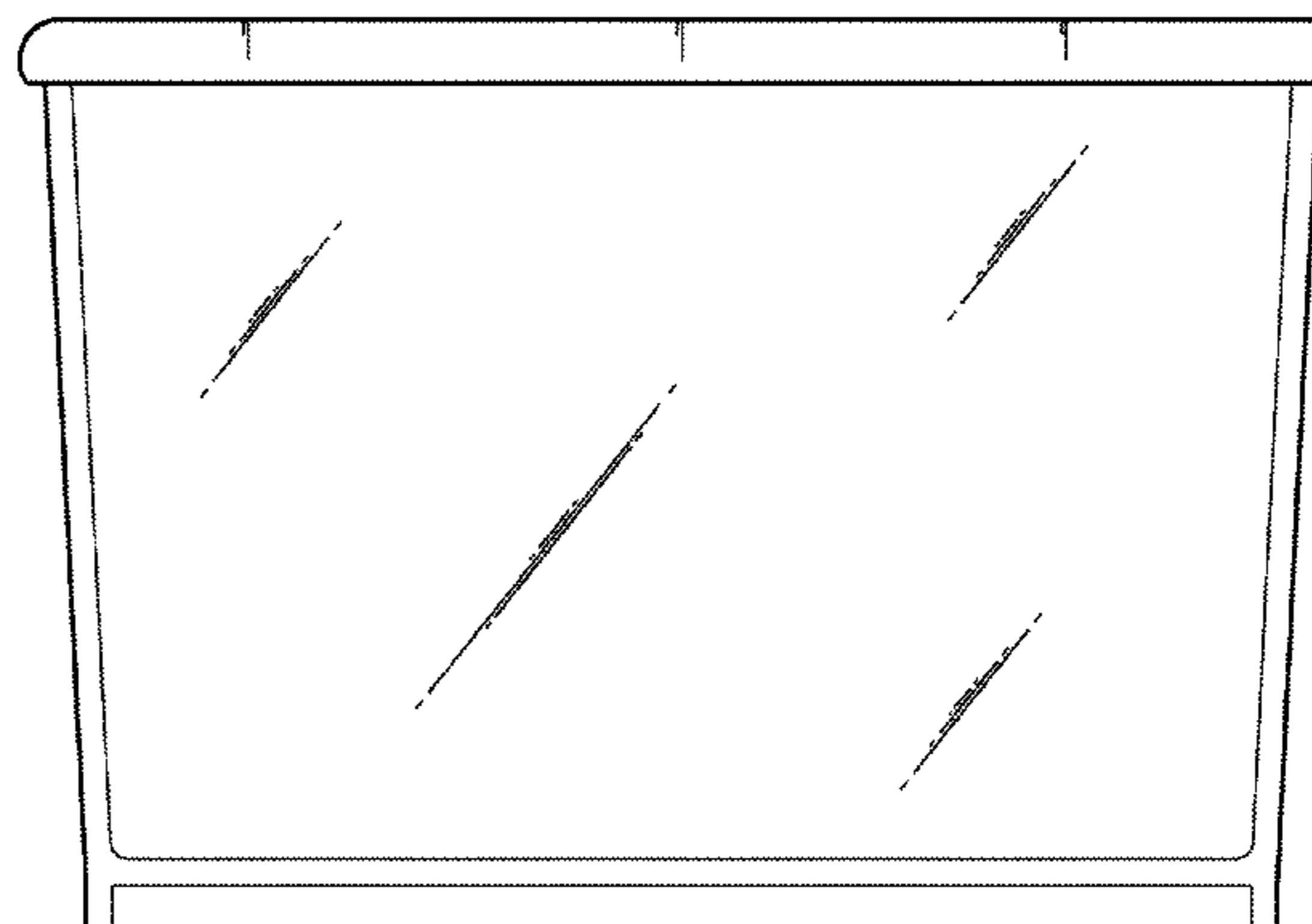
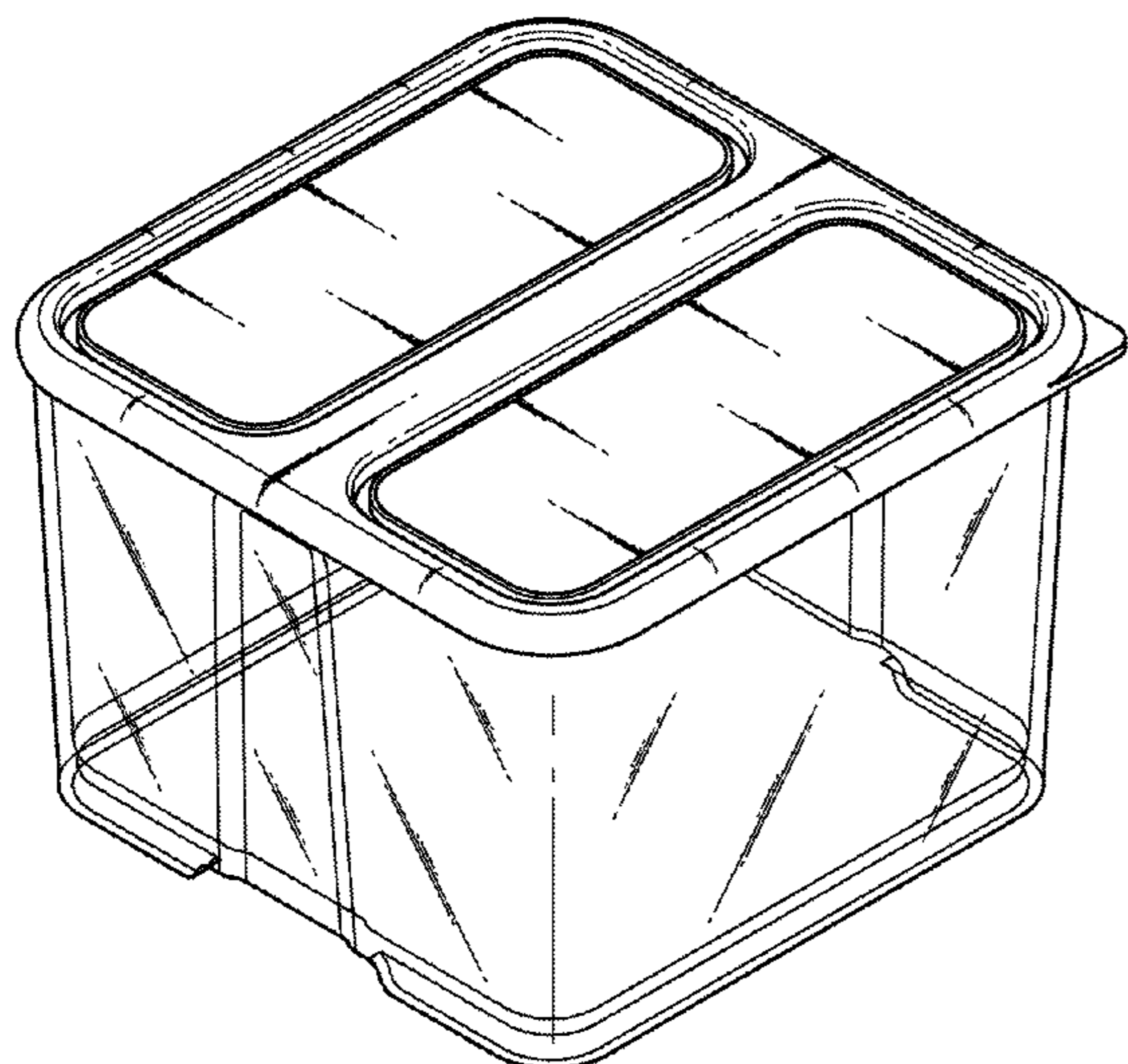
(57) **CLAIM**

I claim the ornamental design for a food storage container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a food storage container showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;

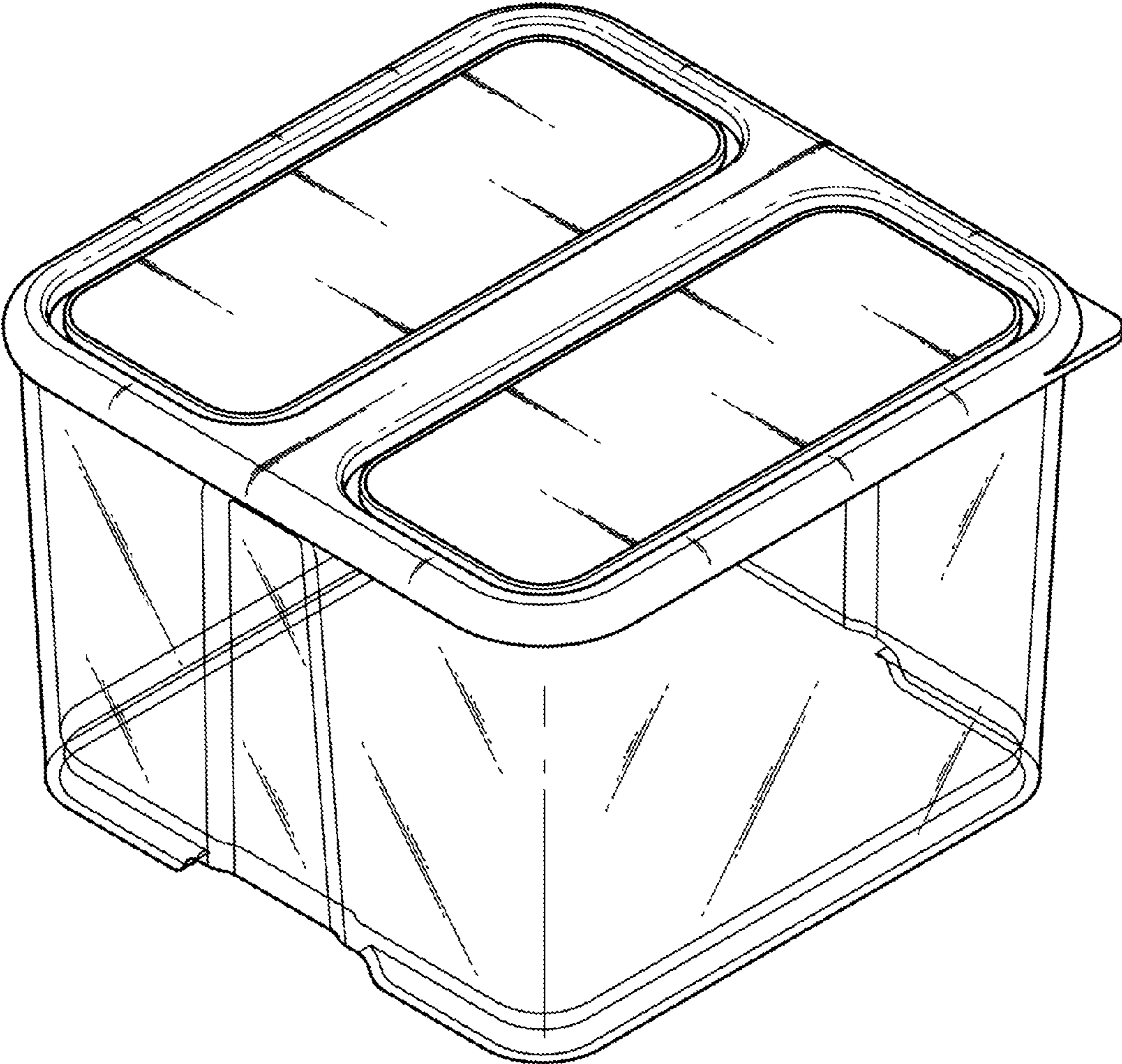

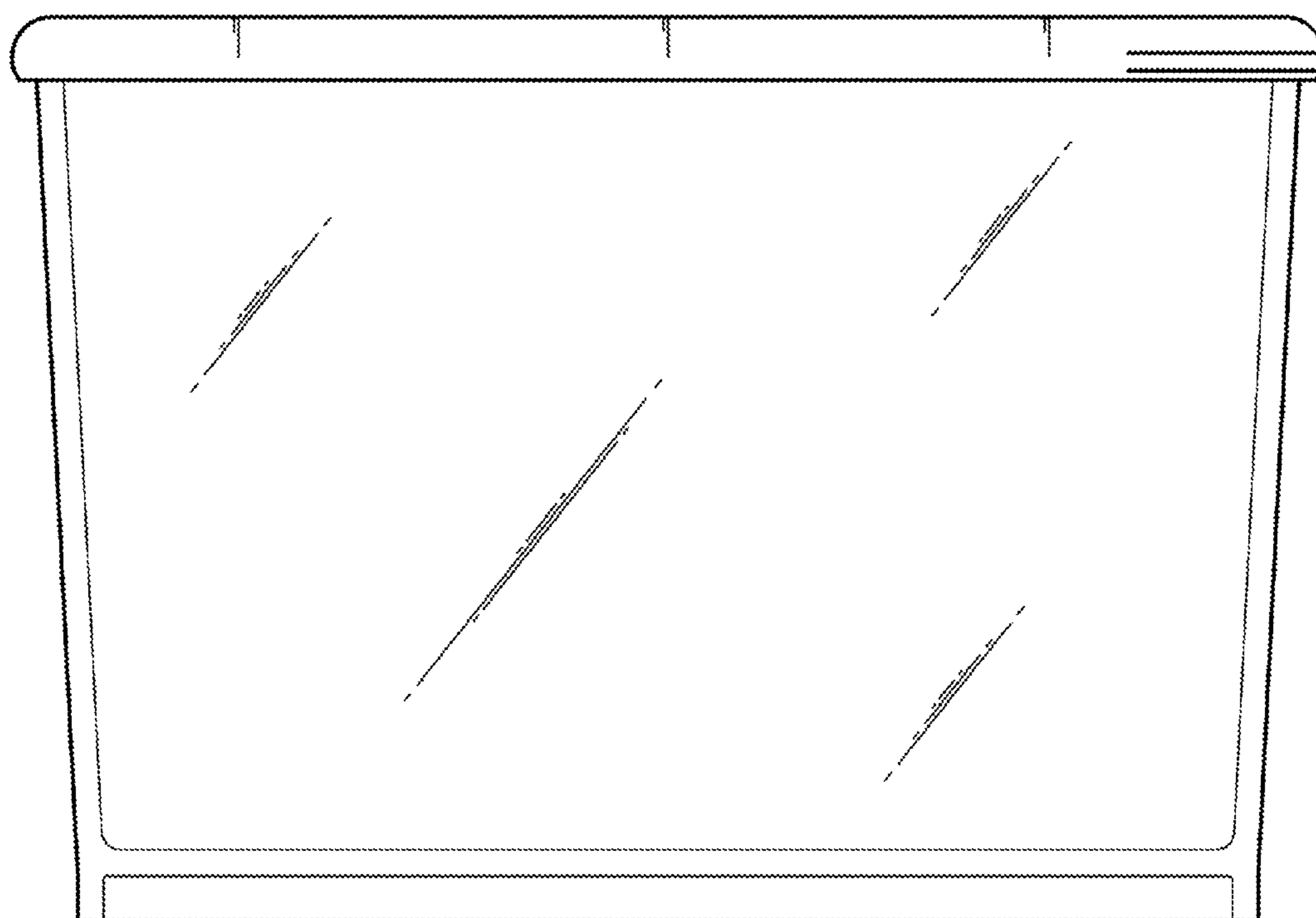

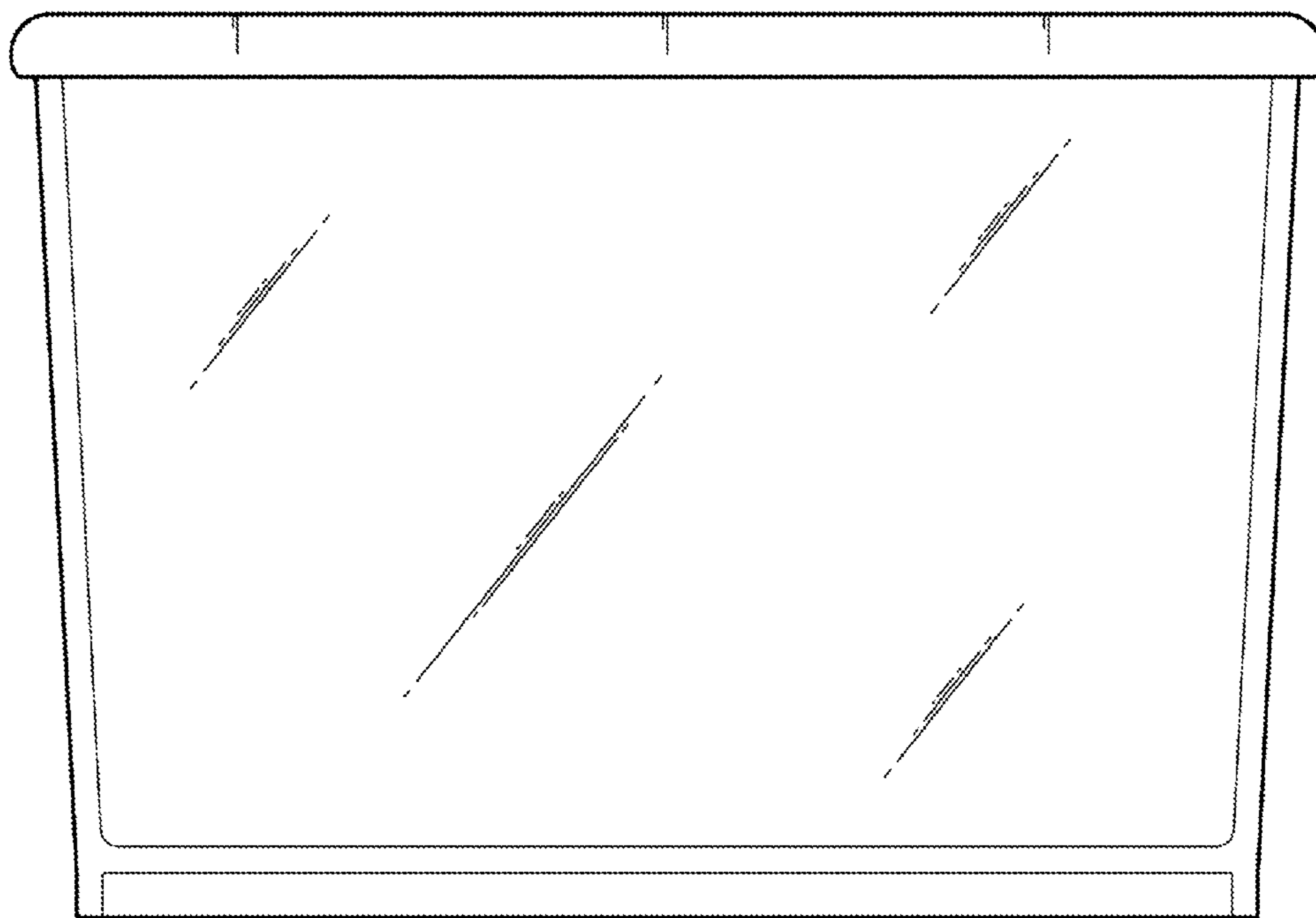

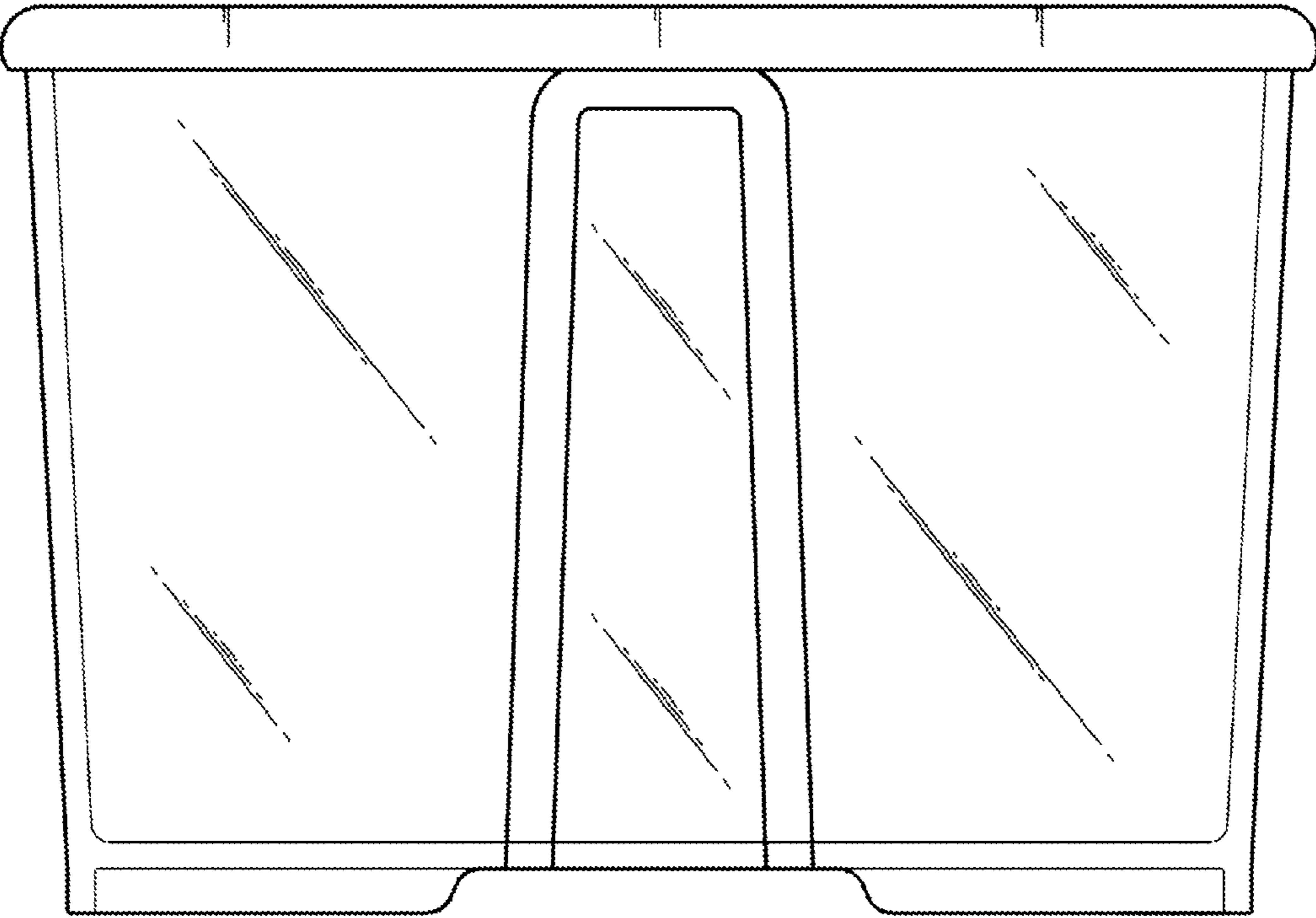

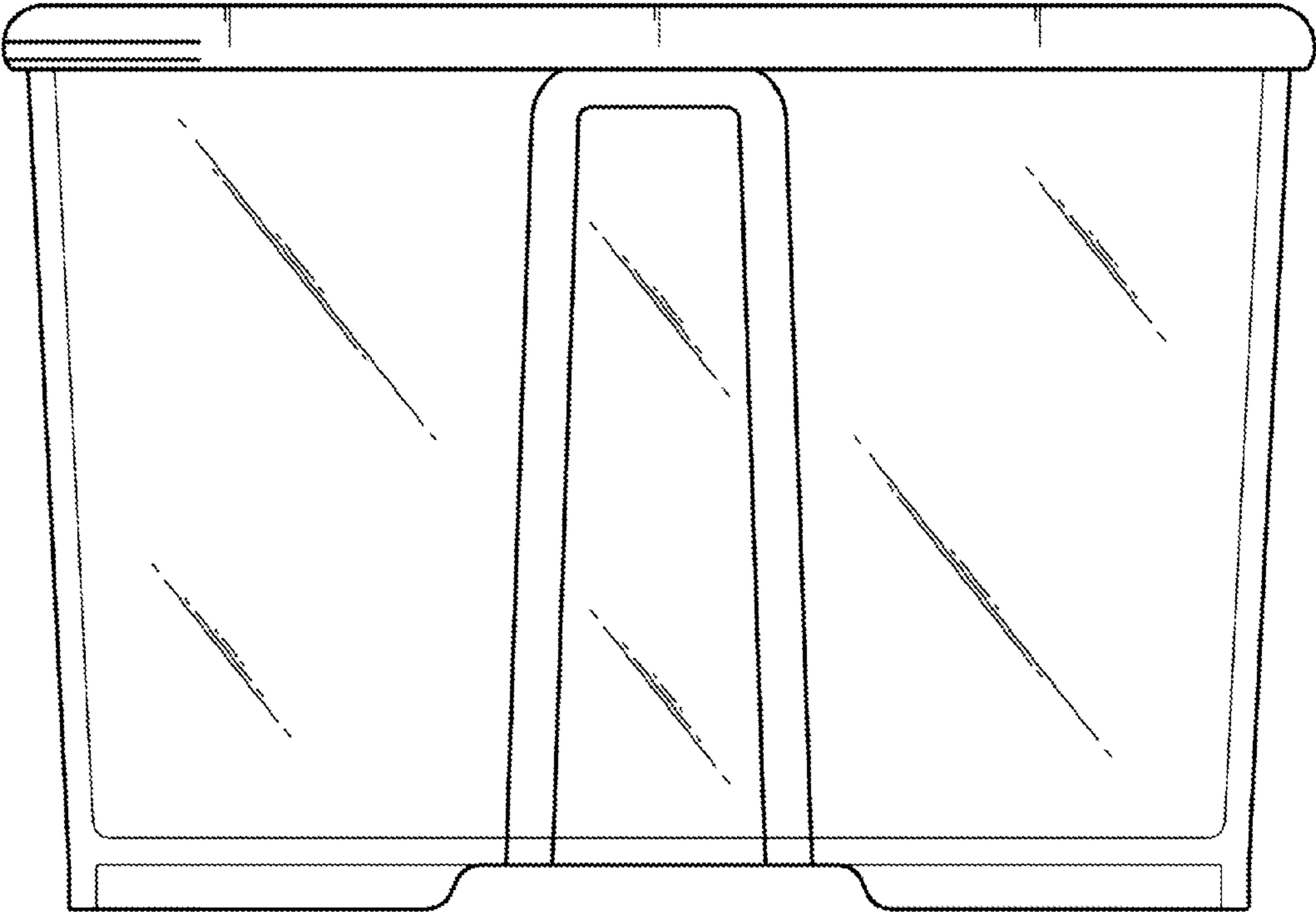

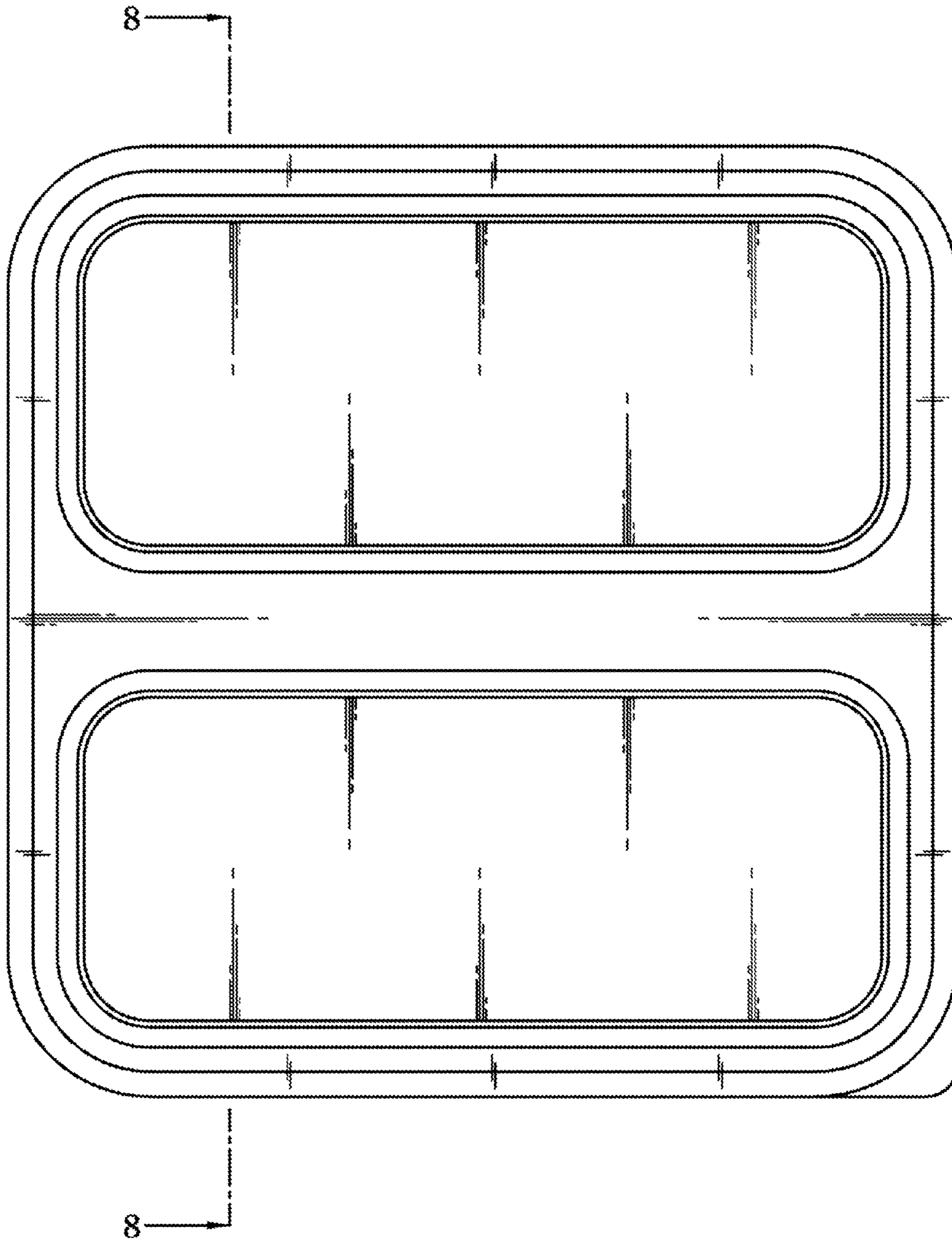

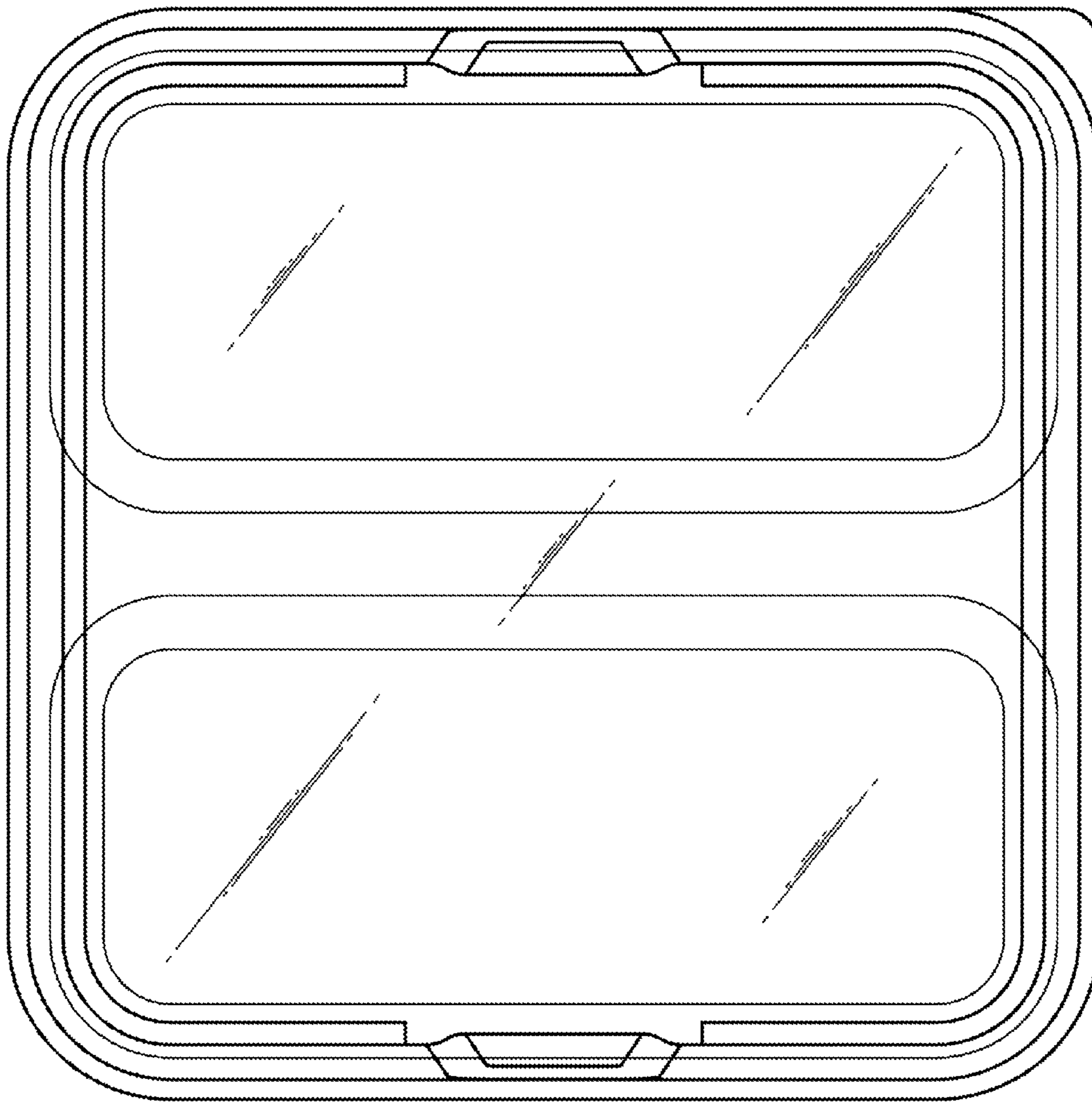
