FIG. 1 is an upper right front perspective view of a product container according to an embodiment of the present invention.

FIG. 2 is a front elevational view of the product container of the present invention shown in FIG. 1.

FIG. 3 is a rear elevational view of the product container of the present invention shown in FIG. 1.

FIG. 4 is a left side elevational view of the product container of the present invention shown in FIG. 1.

FIG. 5 is a right side elevational view of the product container of the present invention shown in FIG. 1.

FIG. 6 is a top view of the product container of the present invention shown in FIG. 1; and,

FIG. 7 is a bottom view of the product container of the present invention shown in FIG. 1.

The broken lines showing the ends of the product container are for illustrative purposes only and form no part of the claimed design.

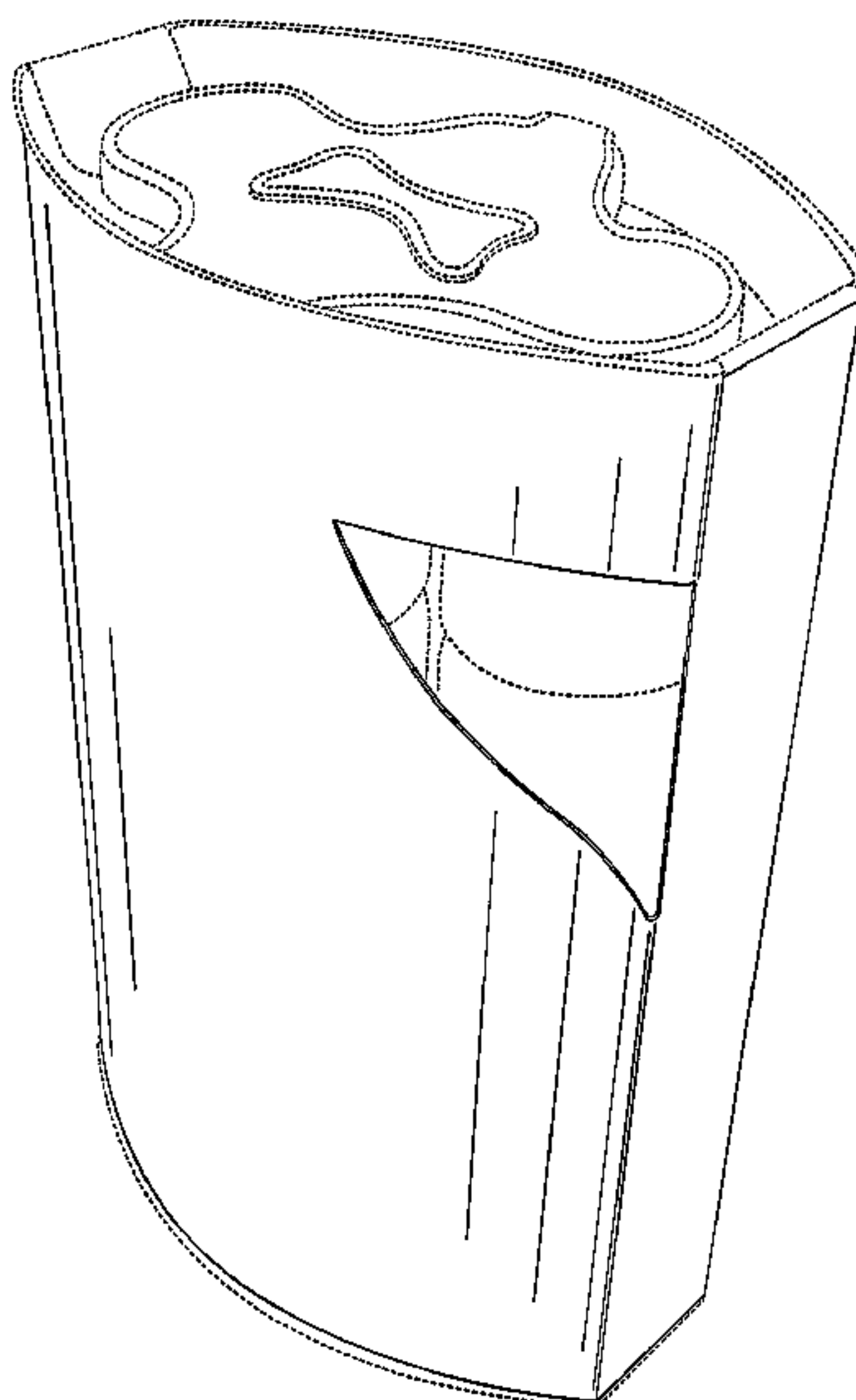

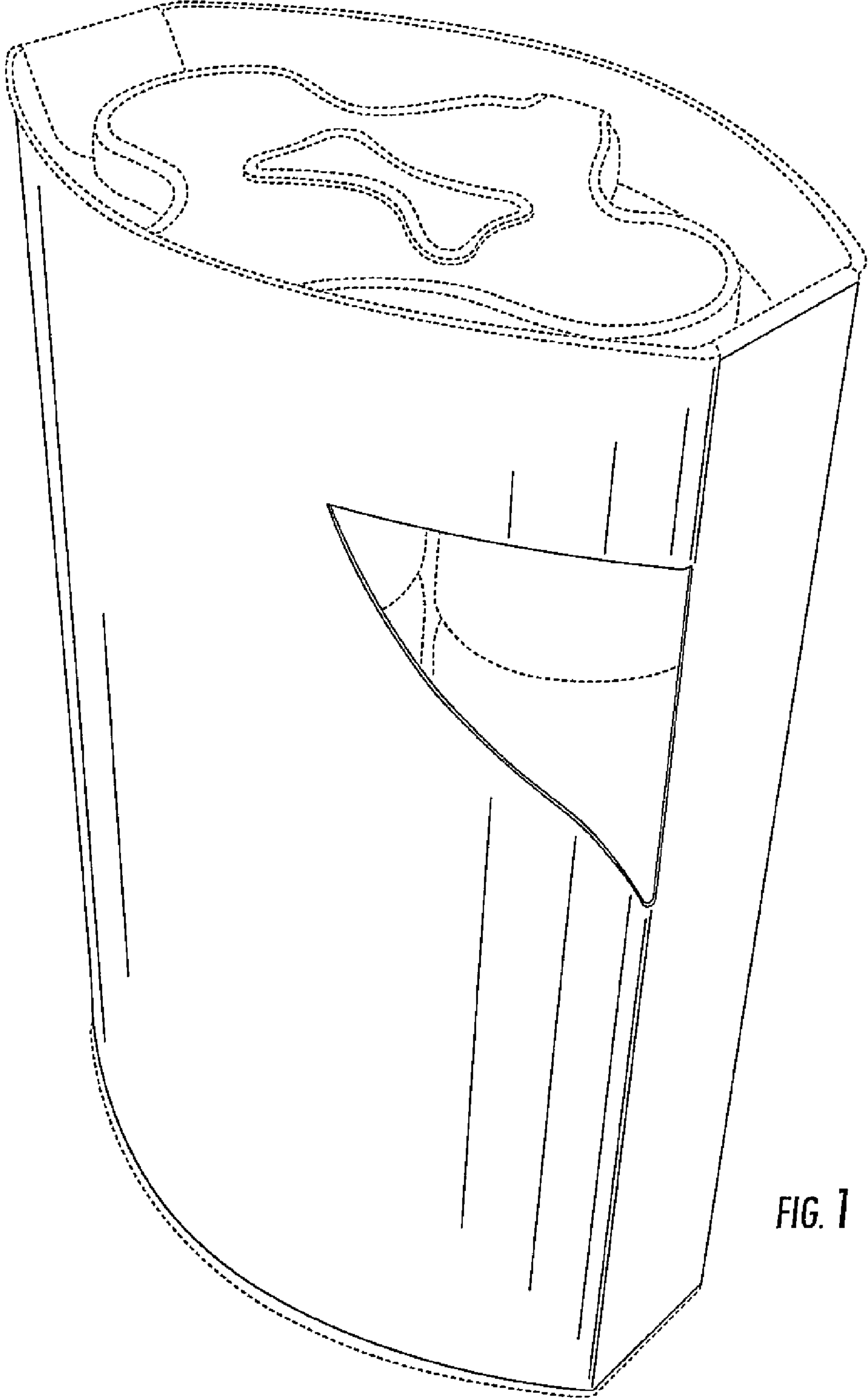

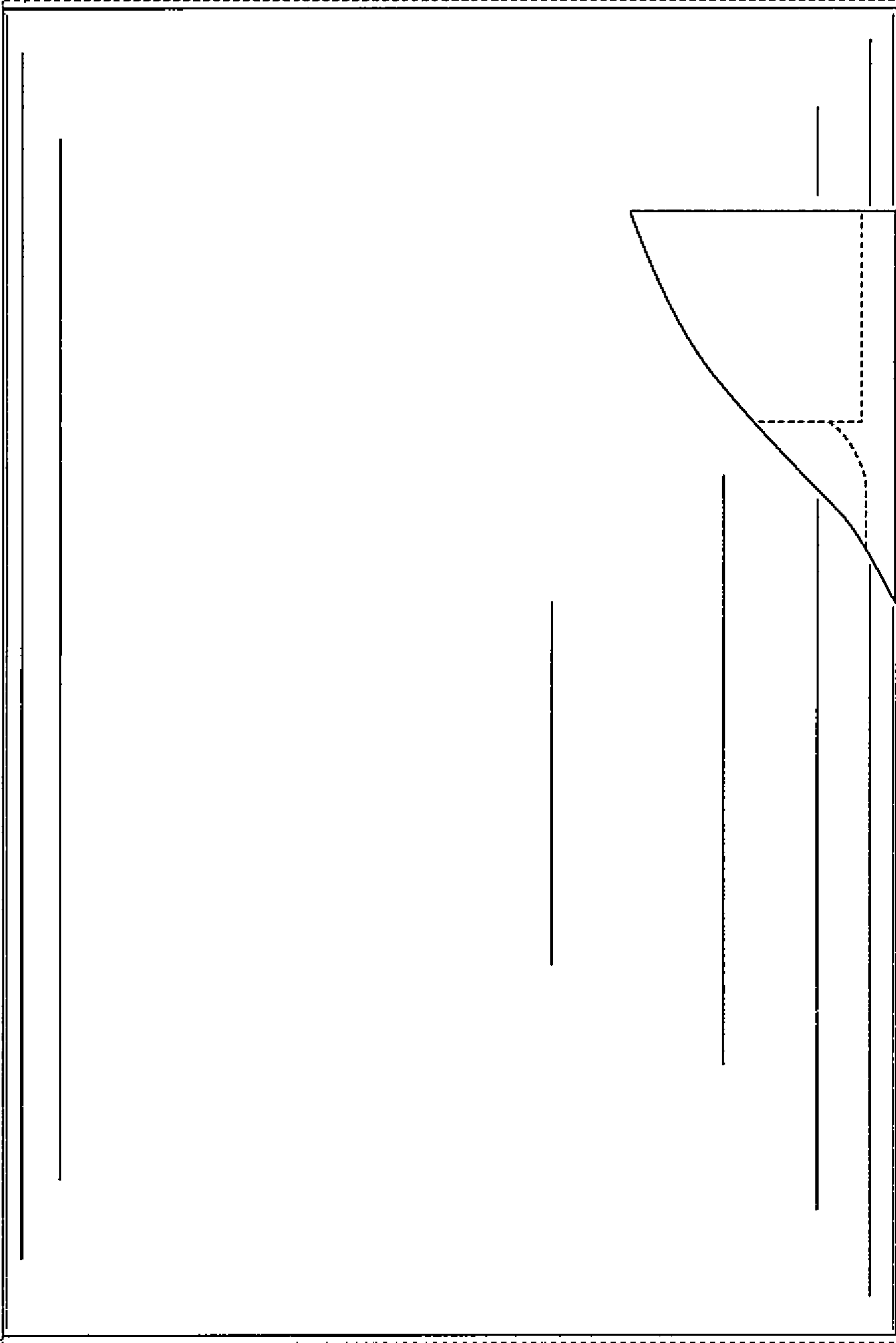

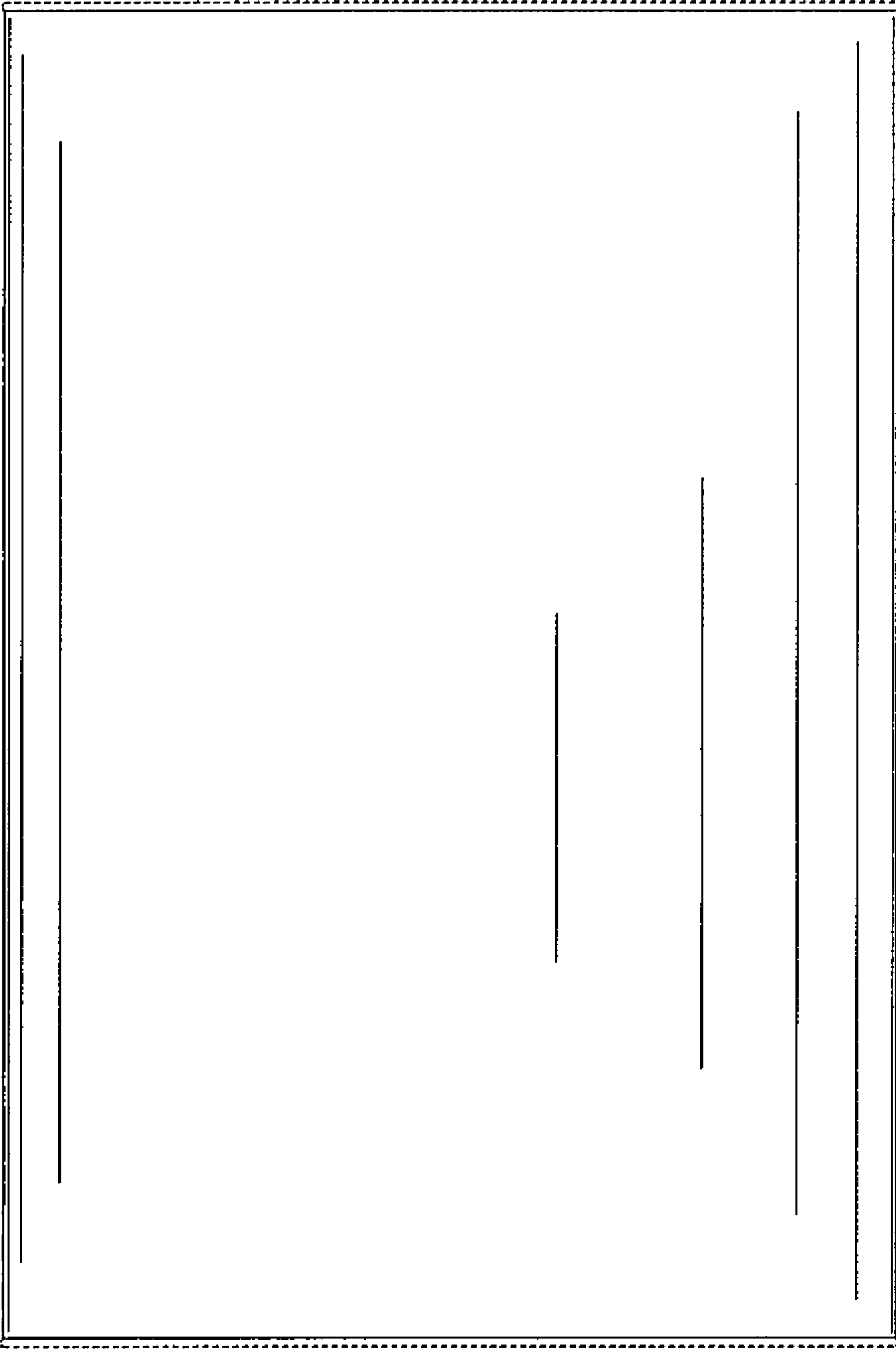

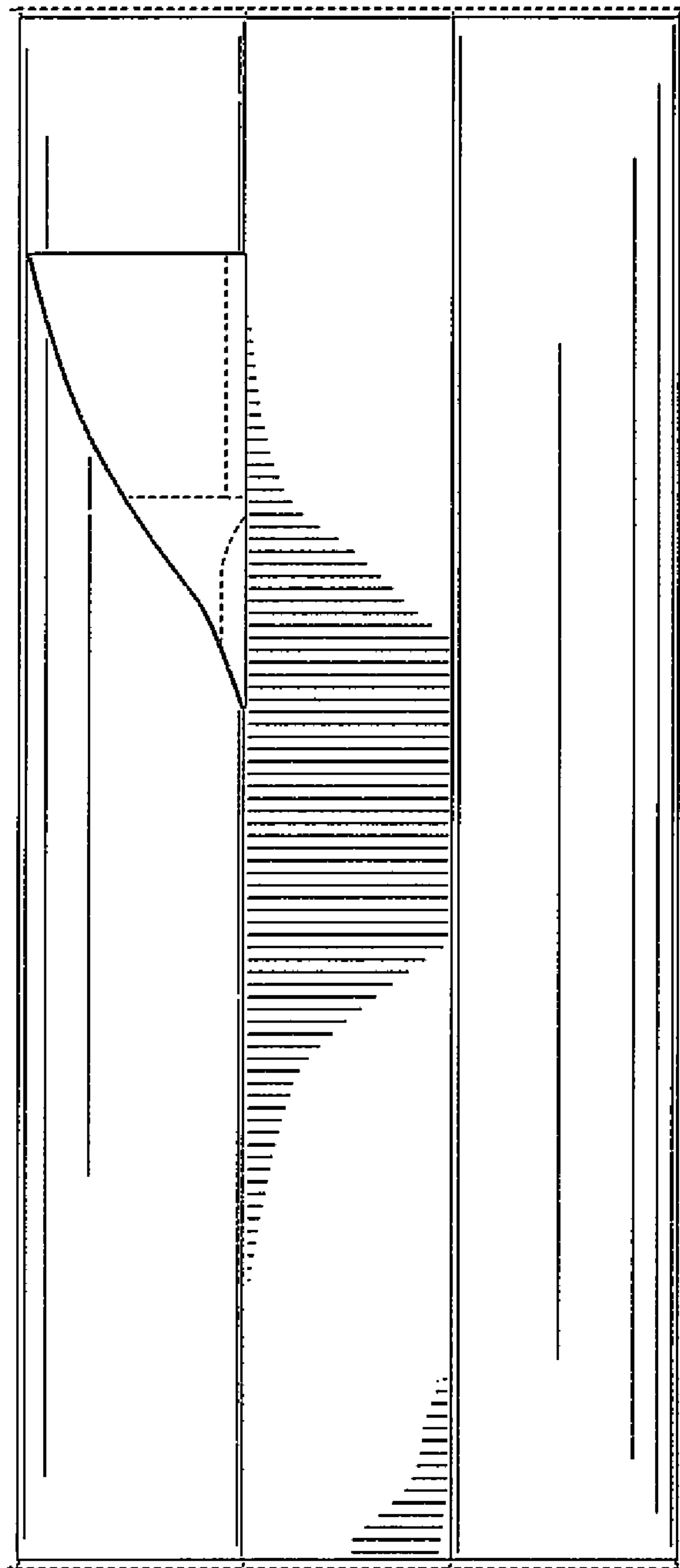

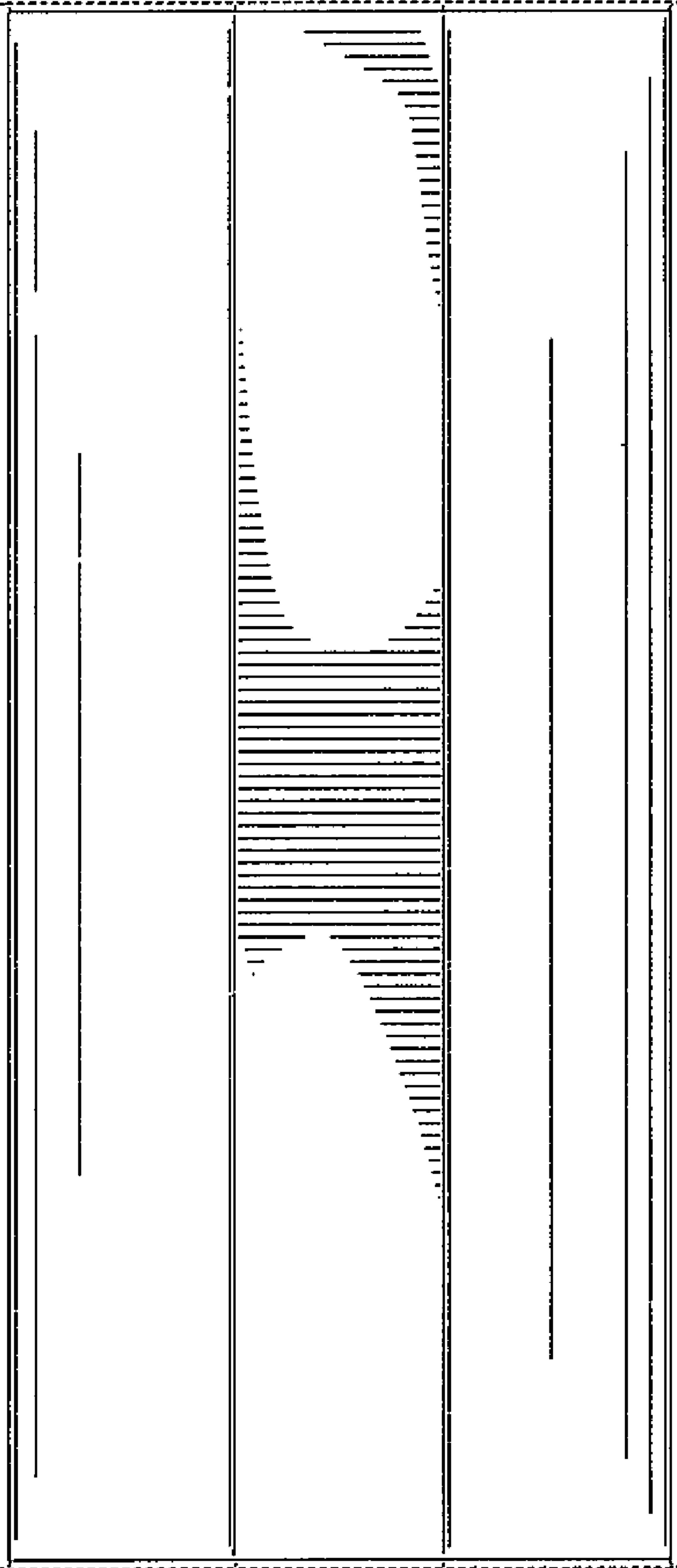

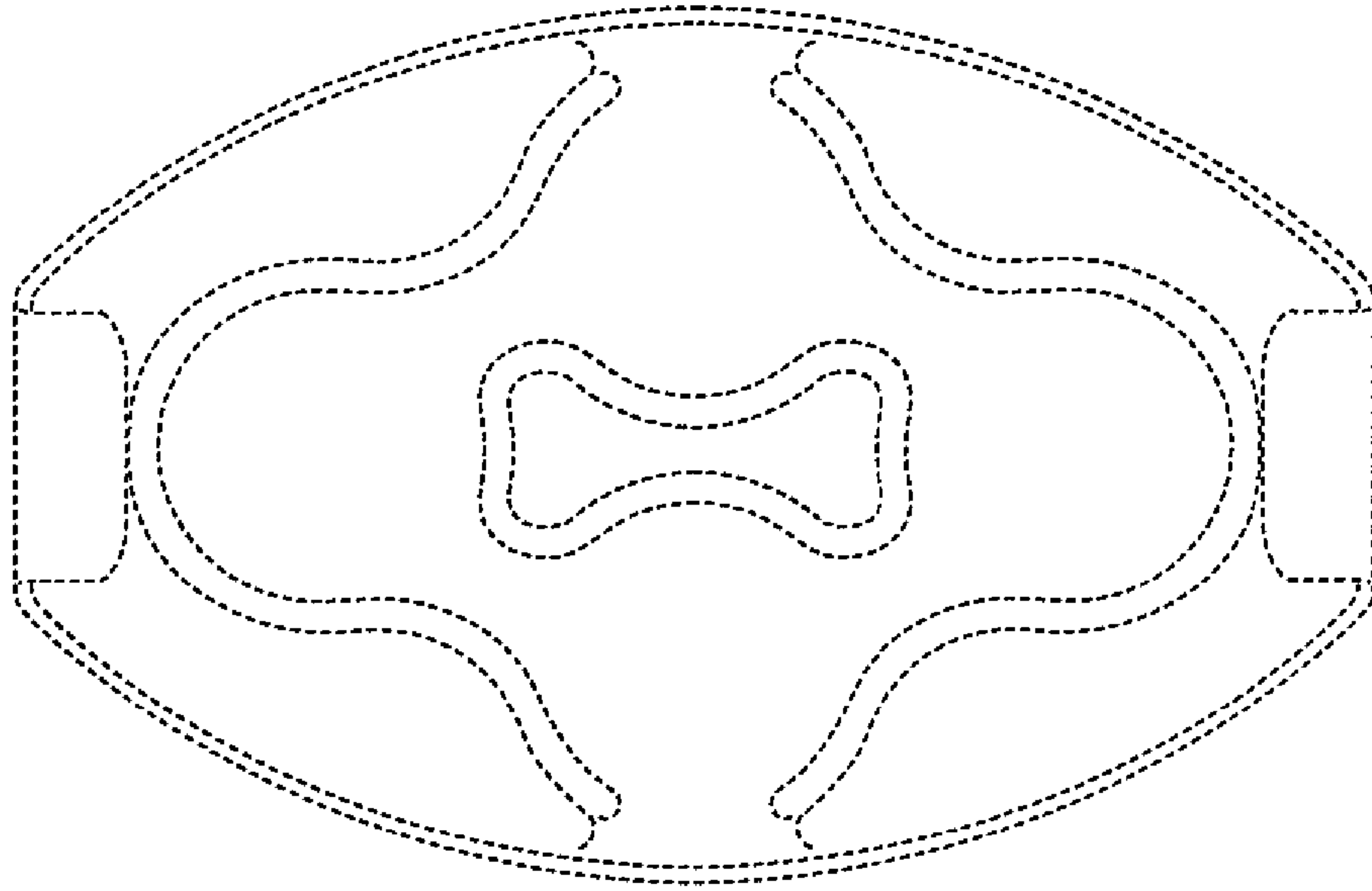

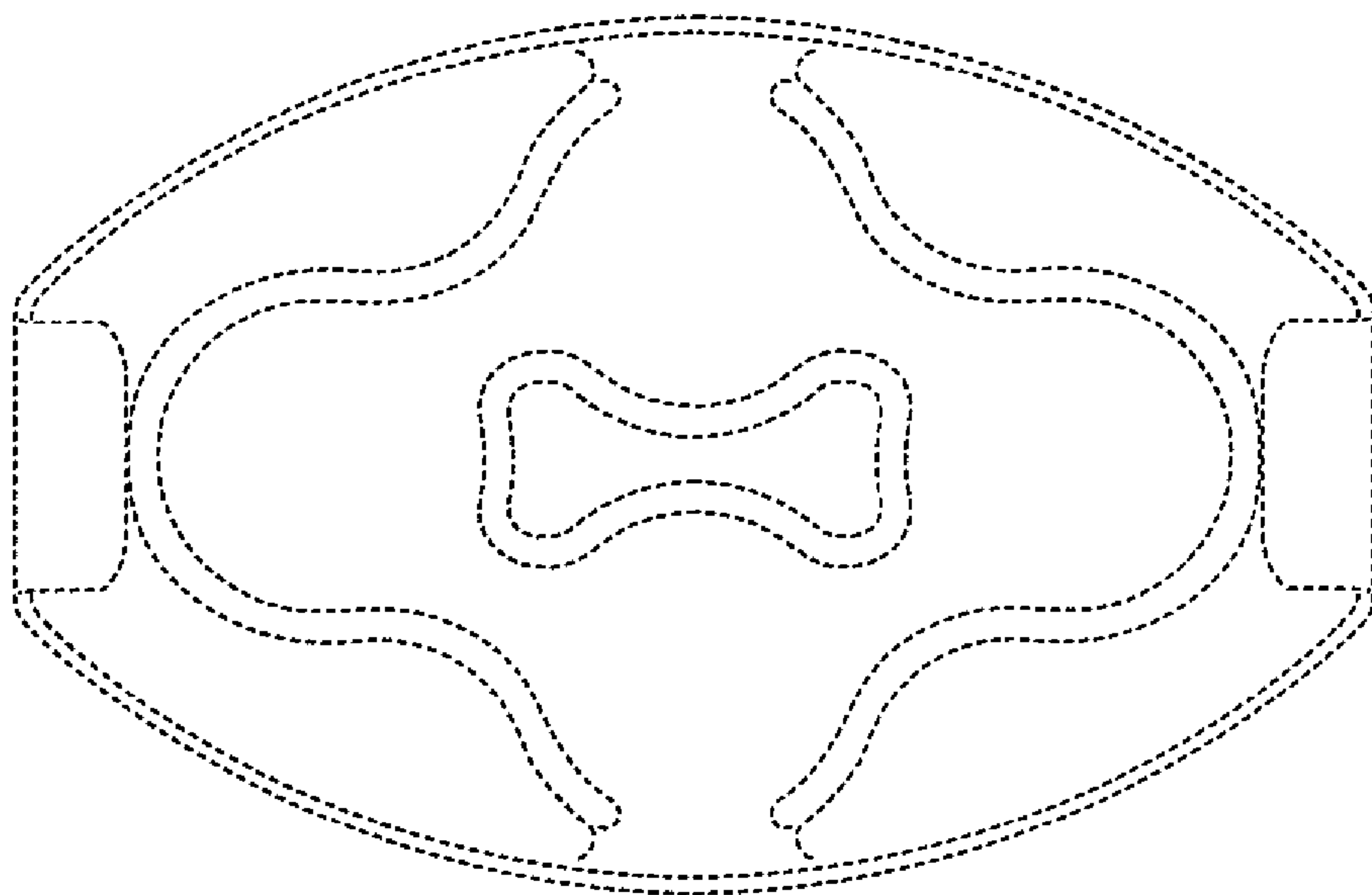
