DESCRIPTION

FIG. 21 is a top plan view thereof;

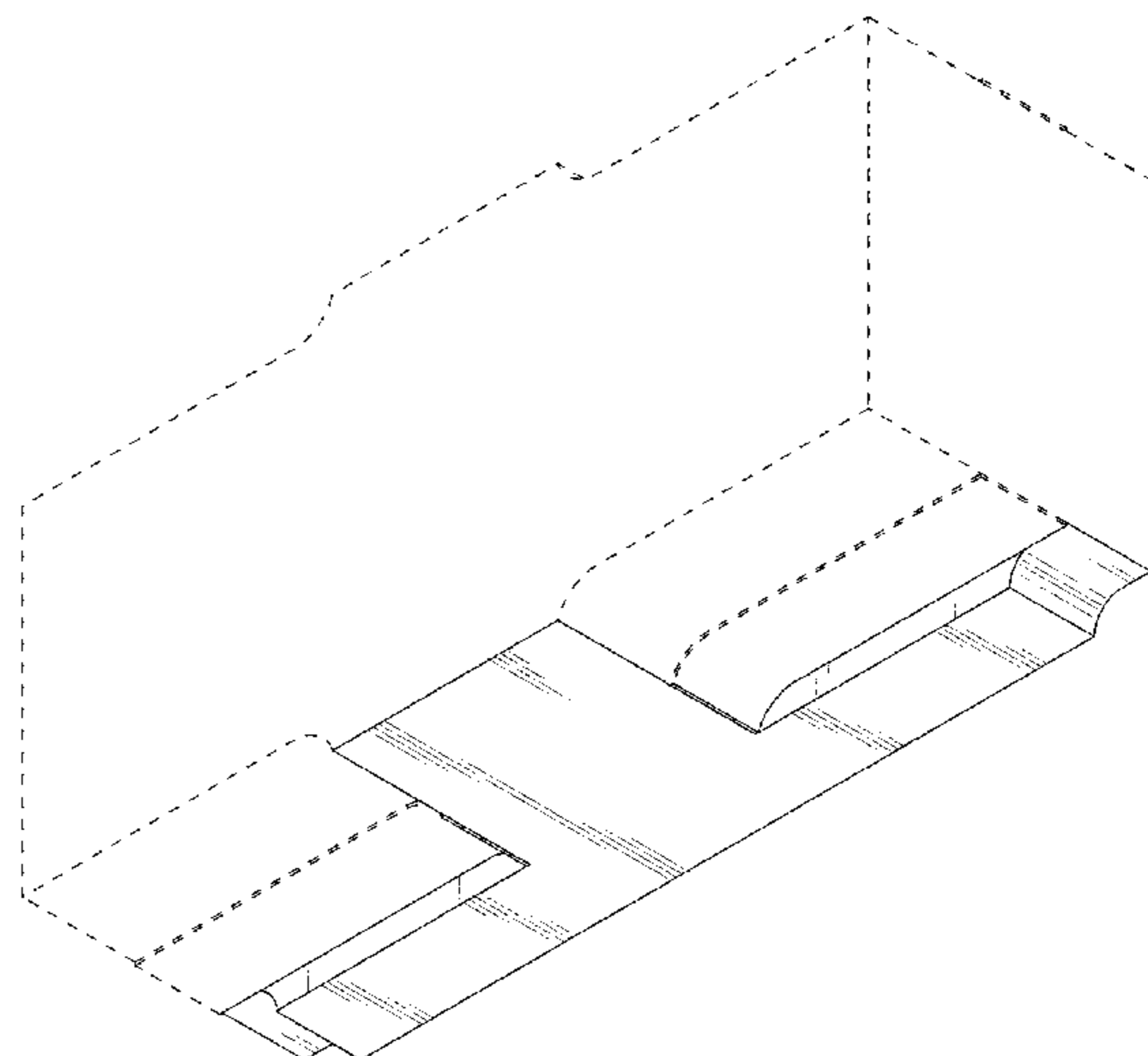
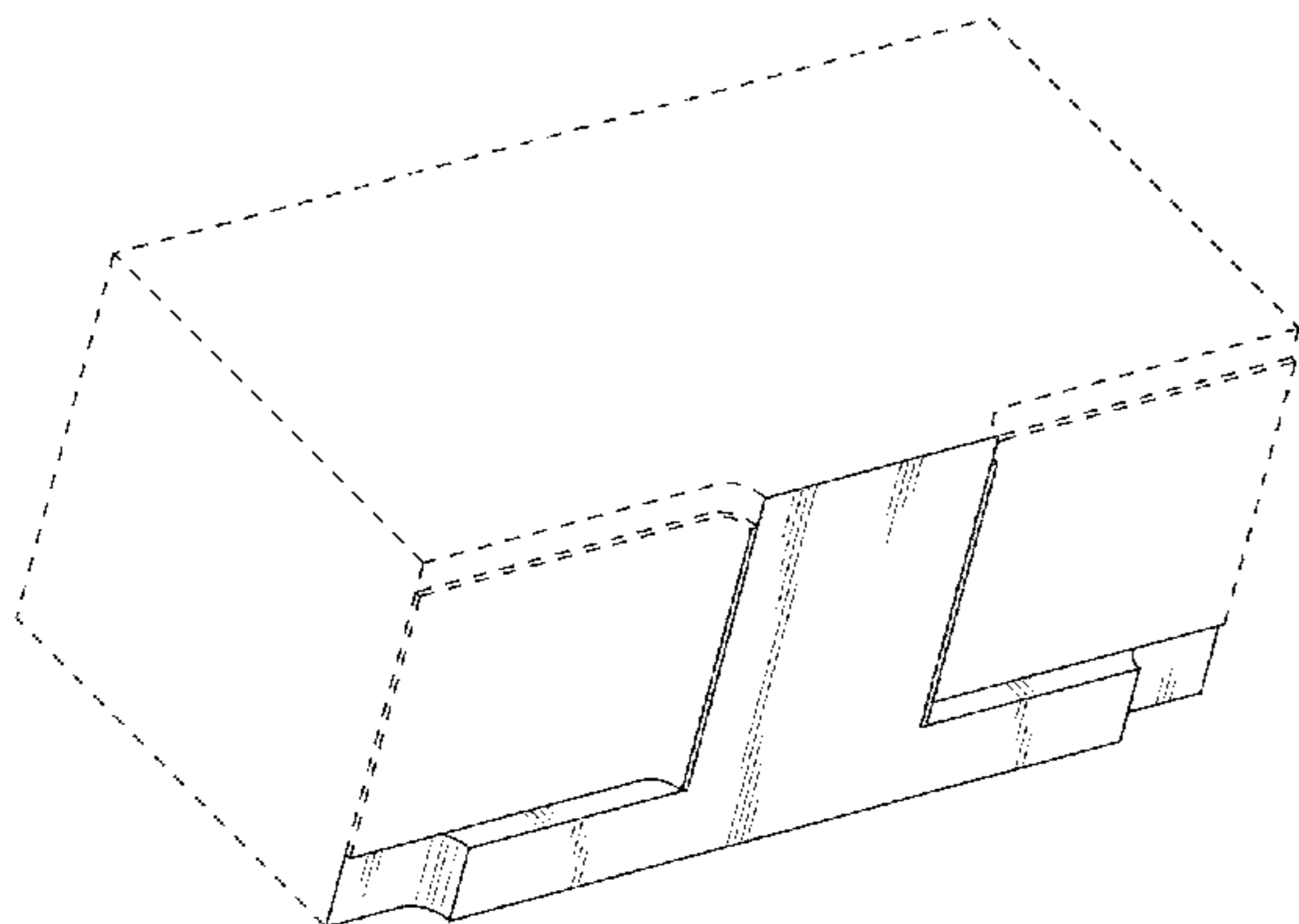
FIG. 22 is a bottom plan view thereof;

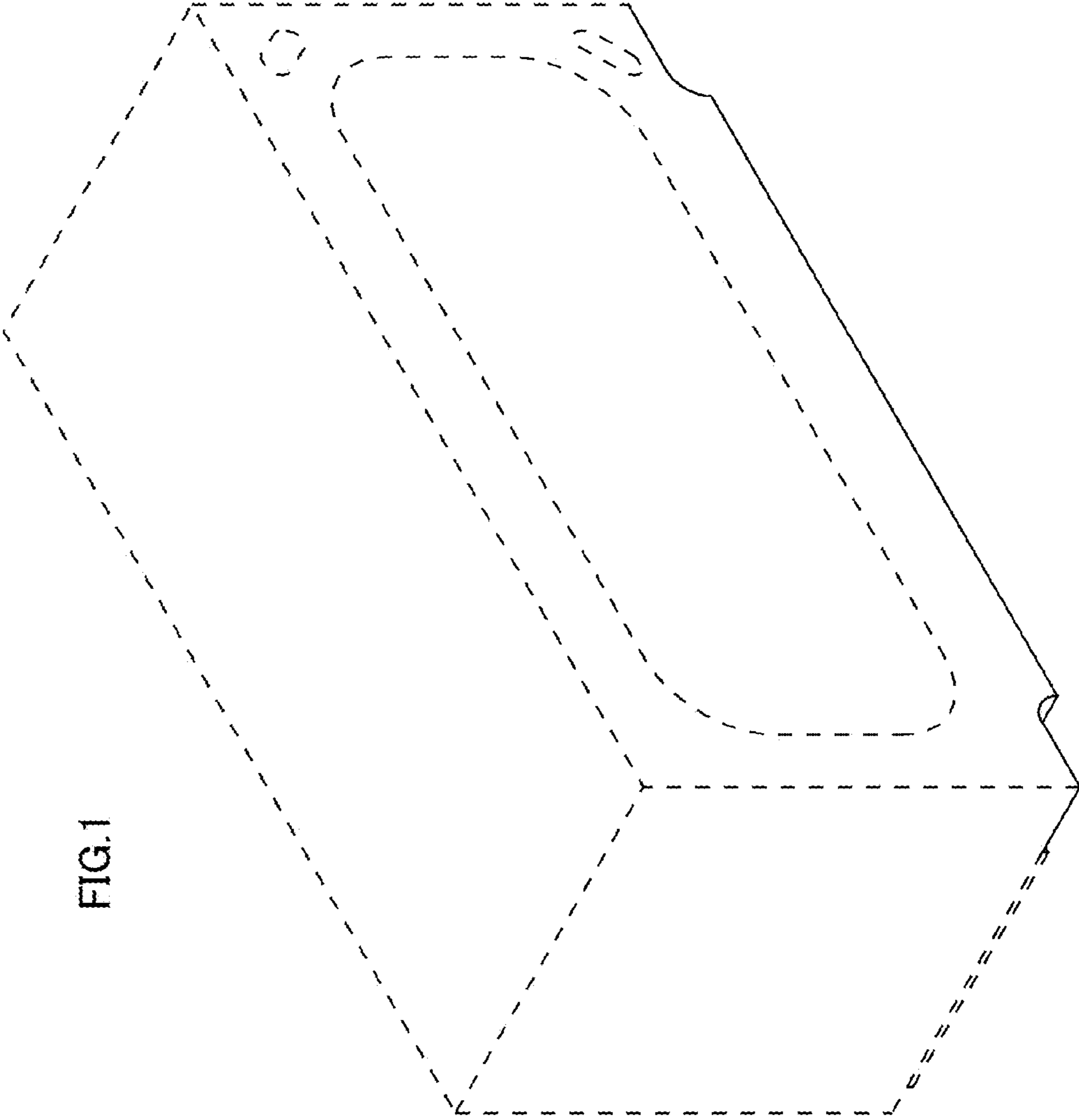

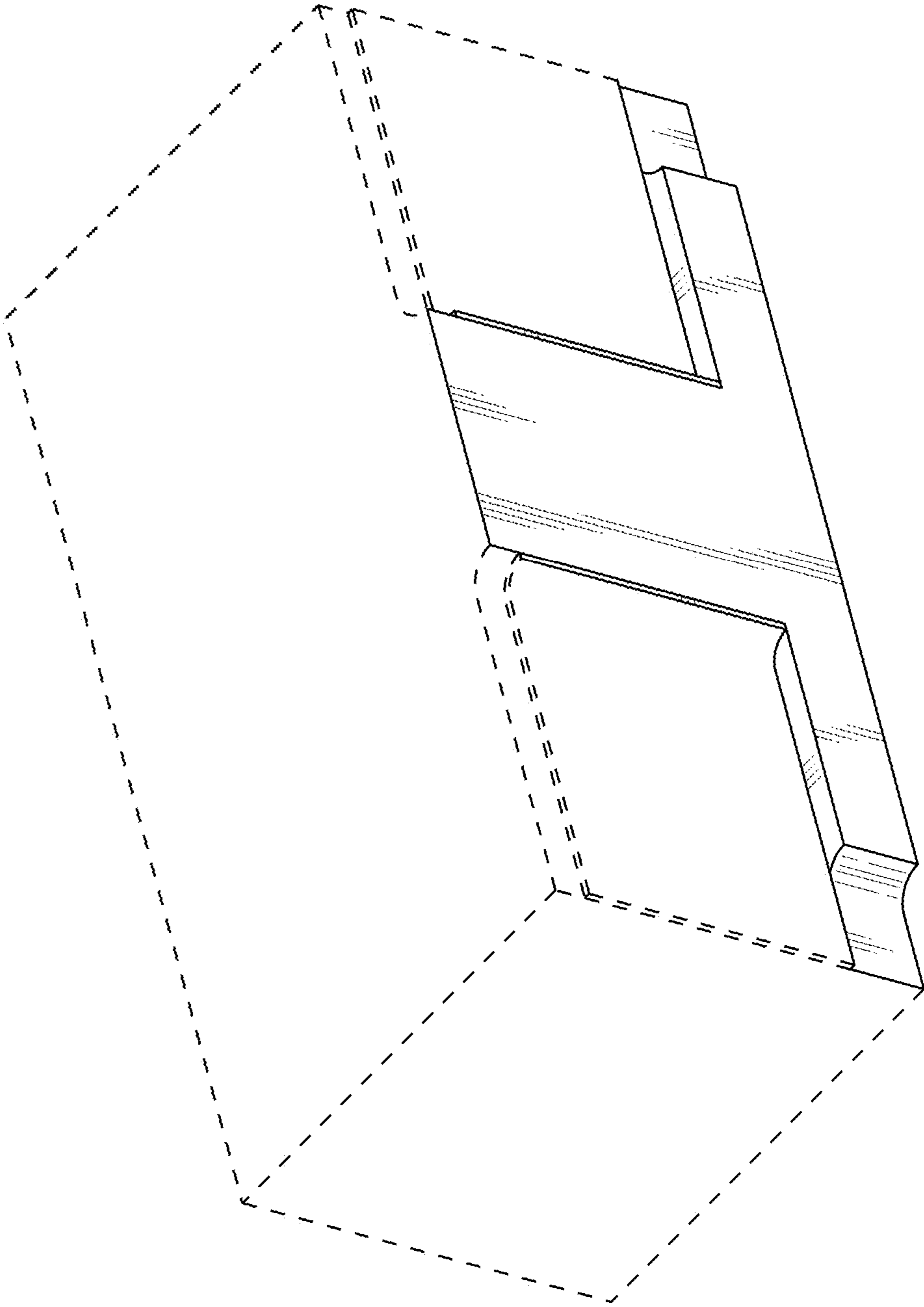

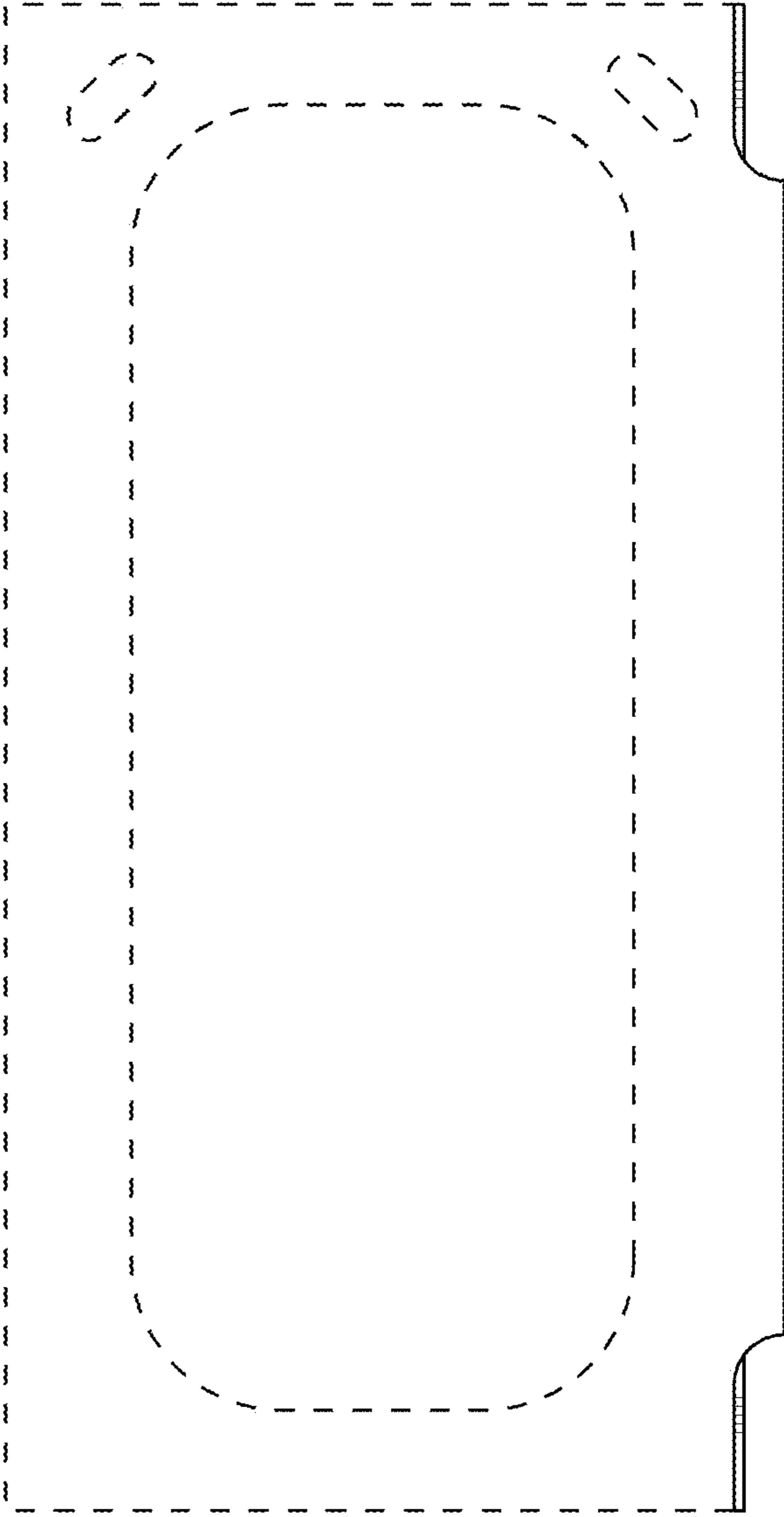

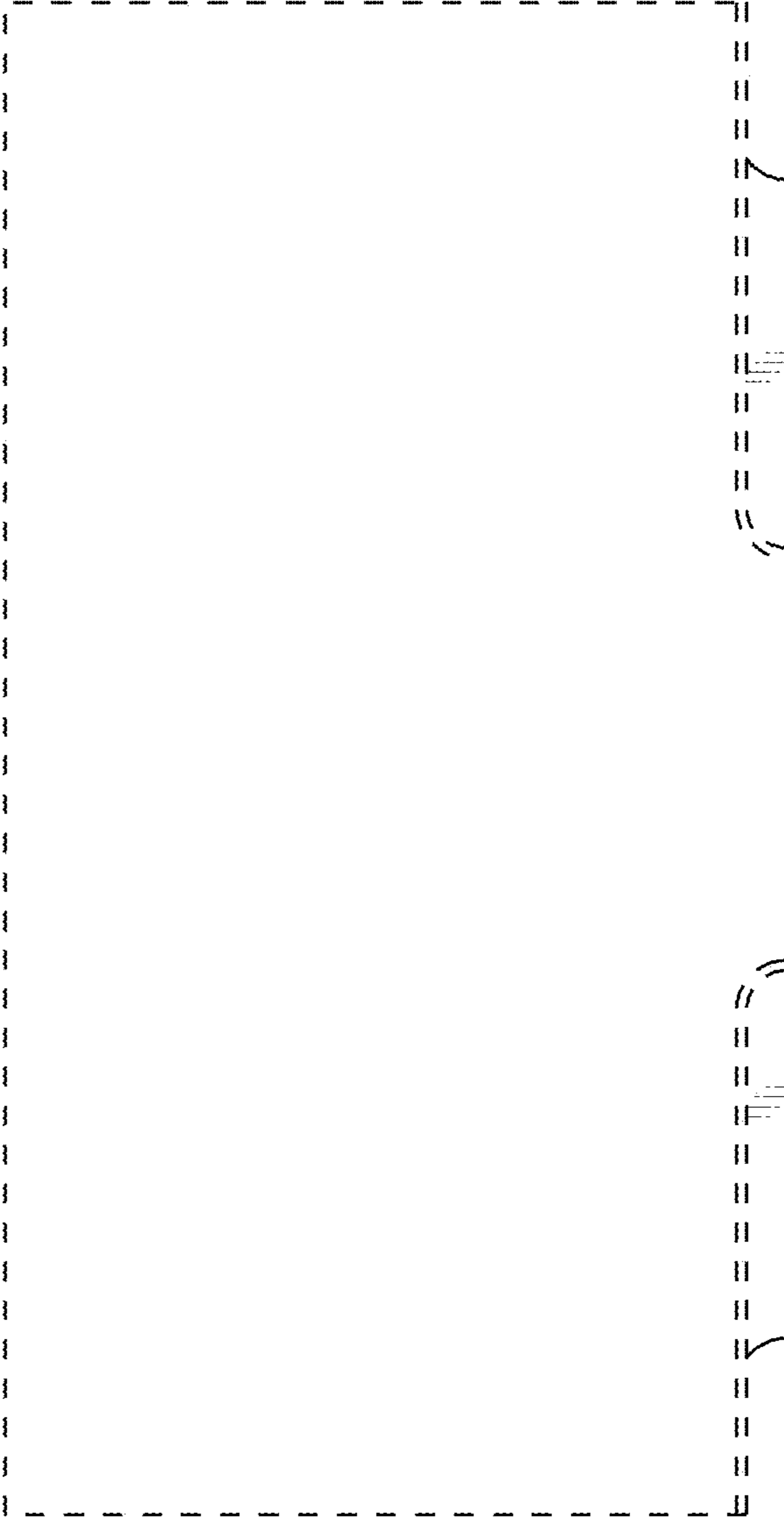

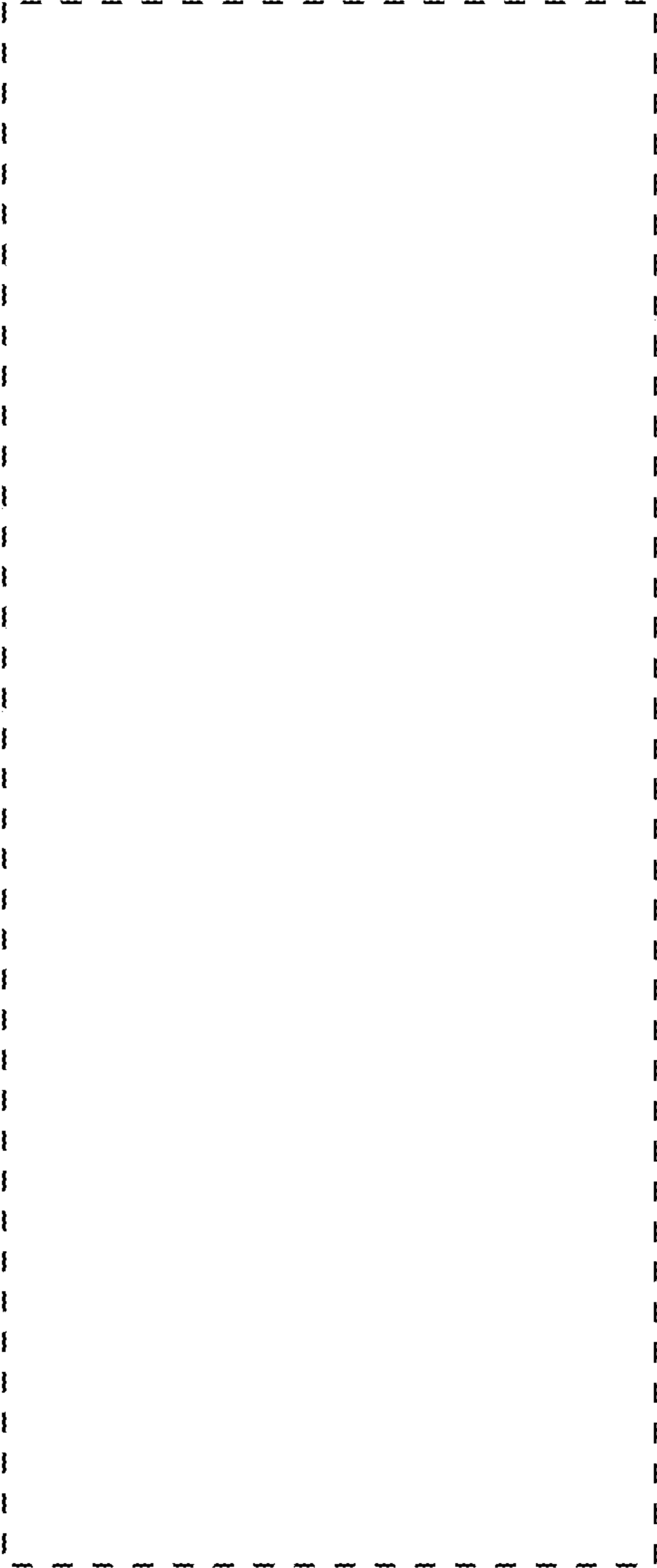

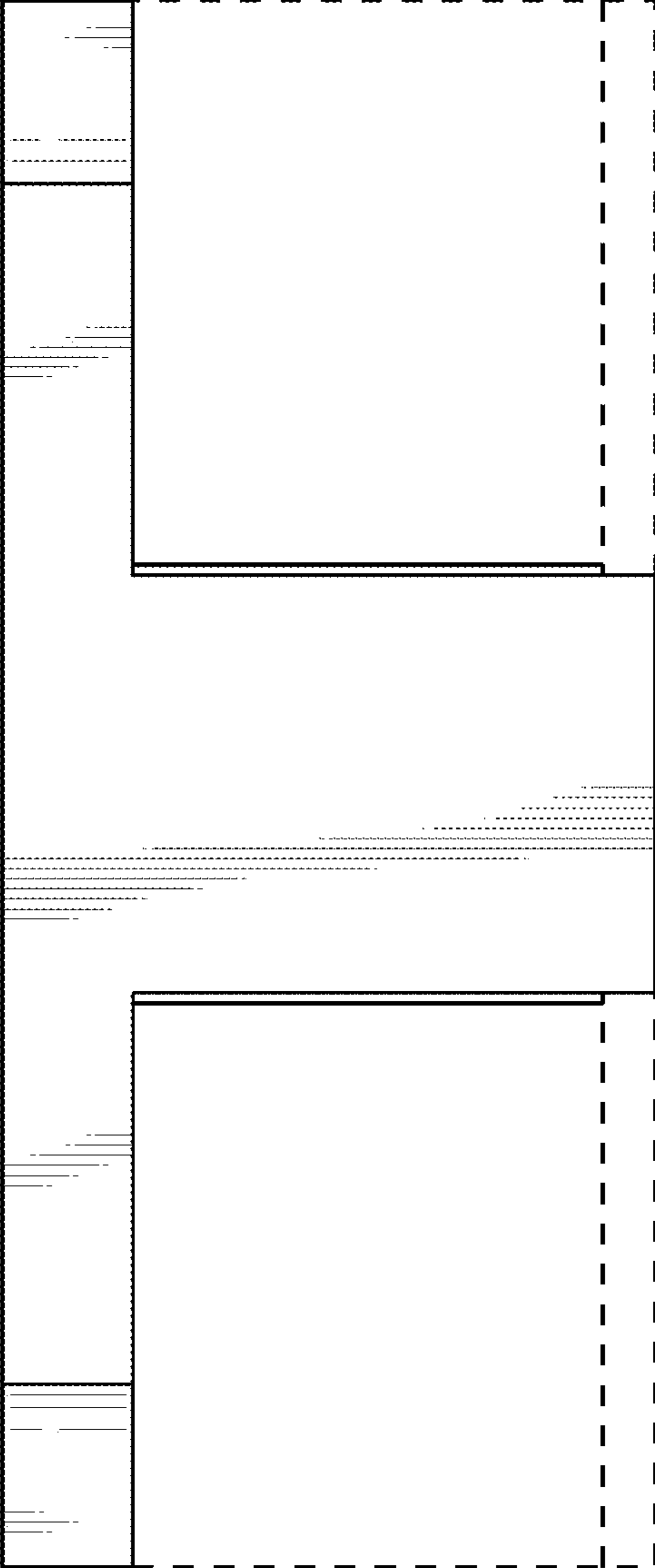

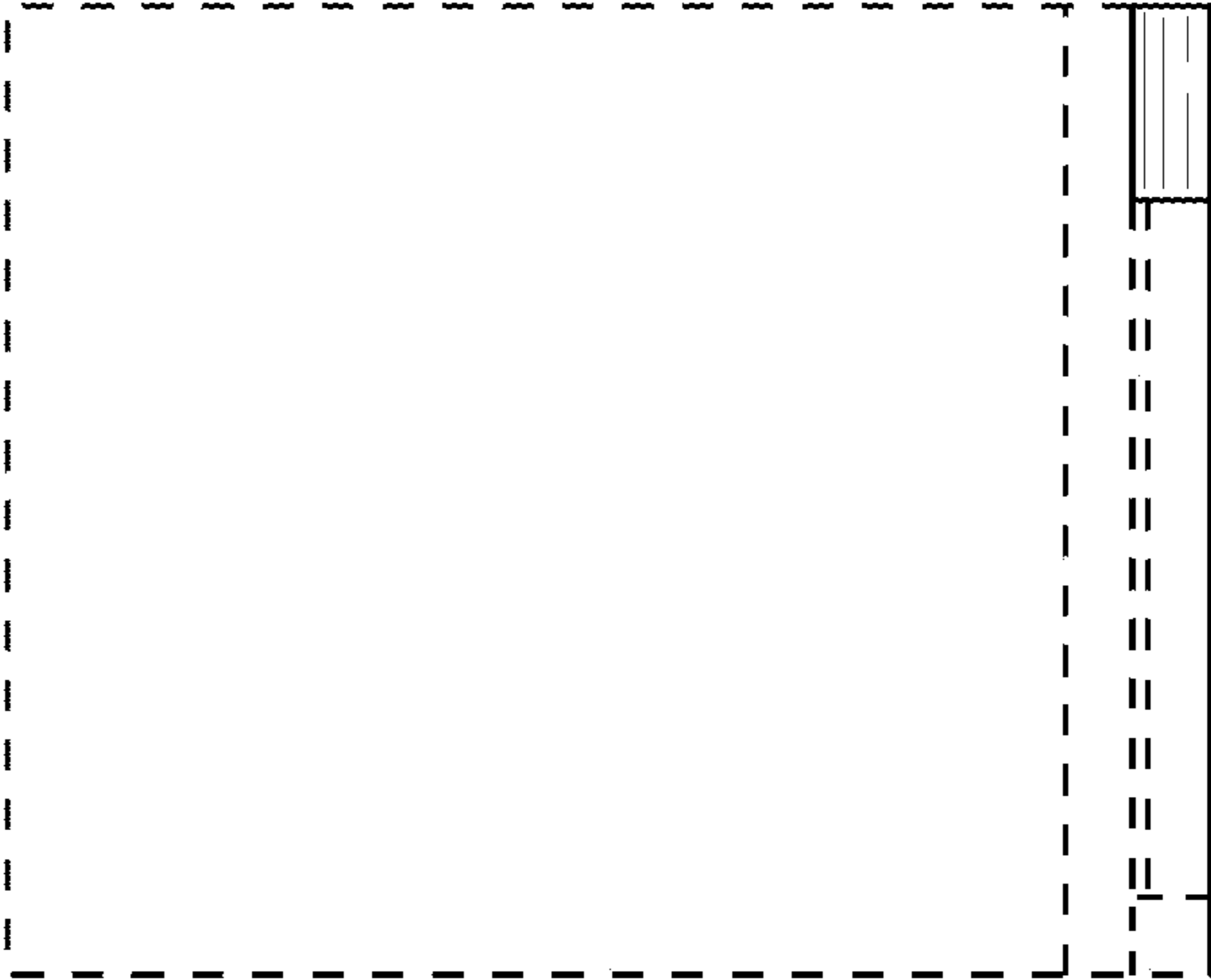
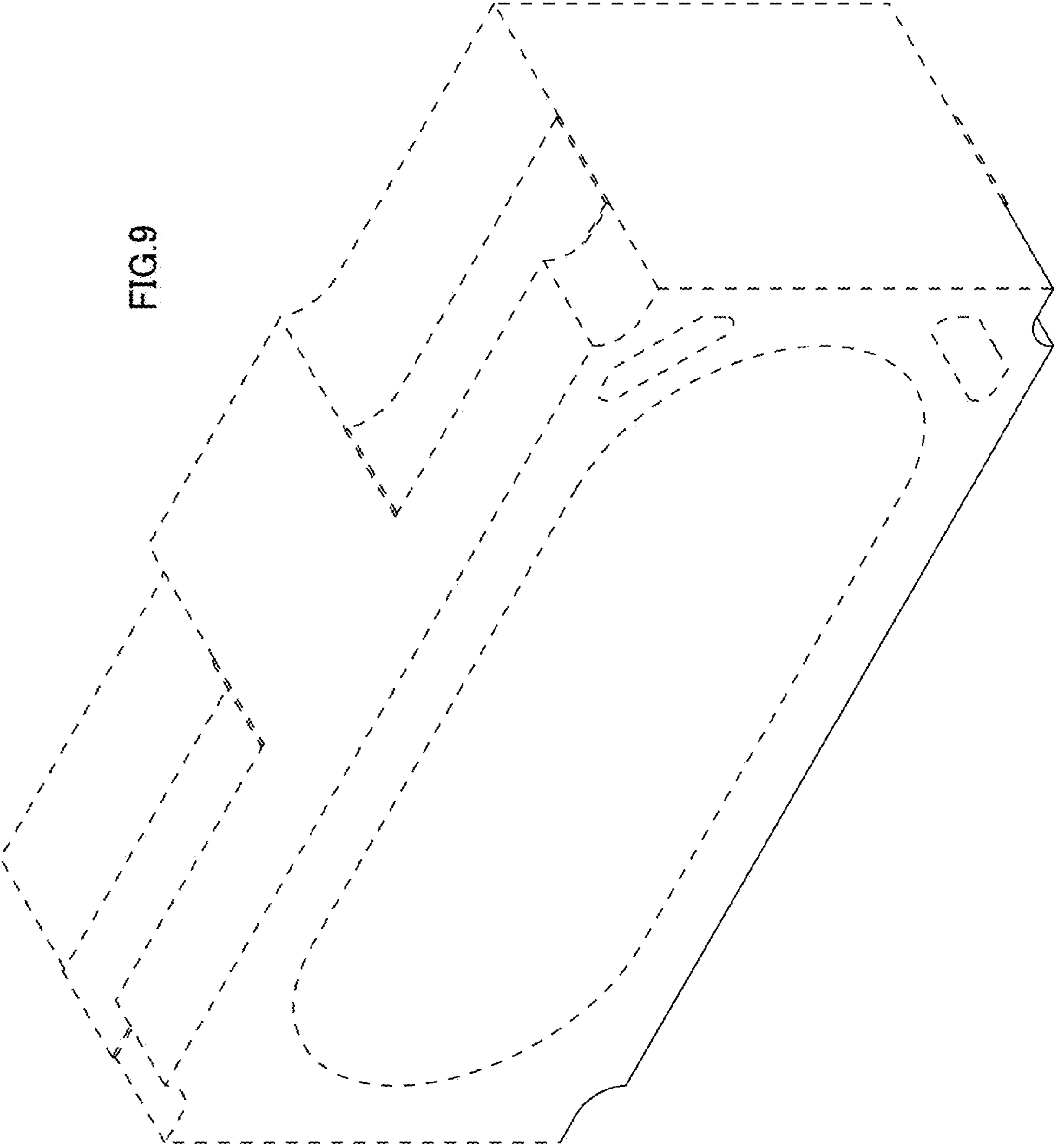

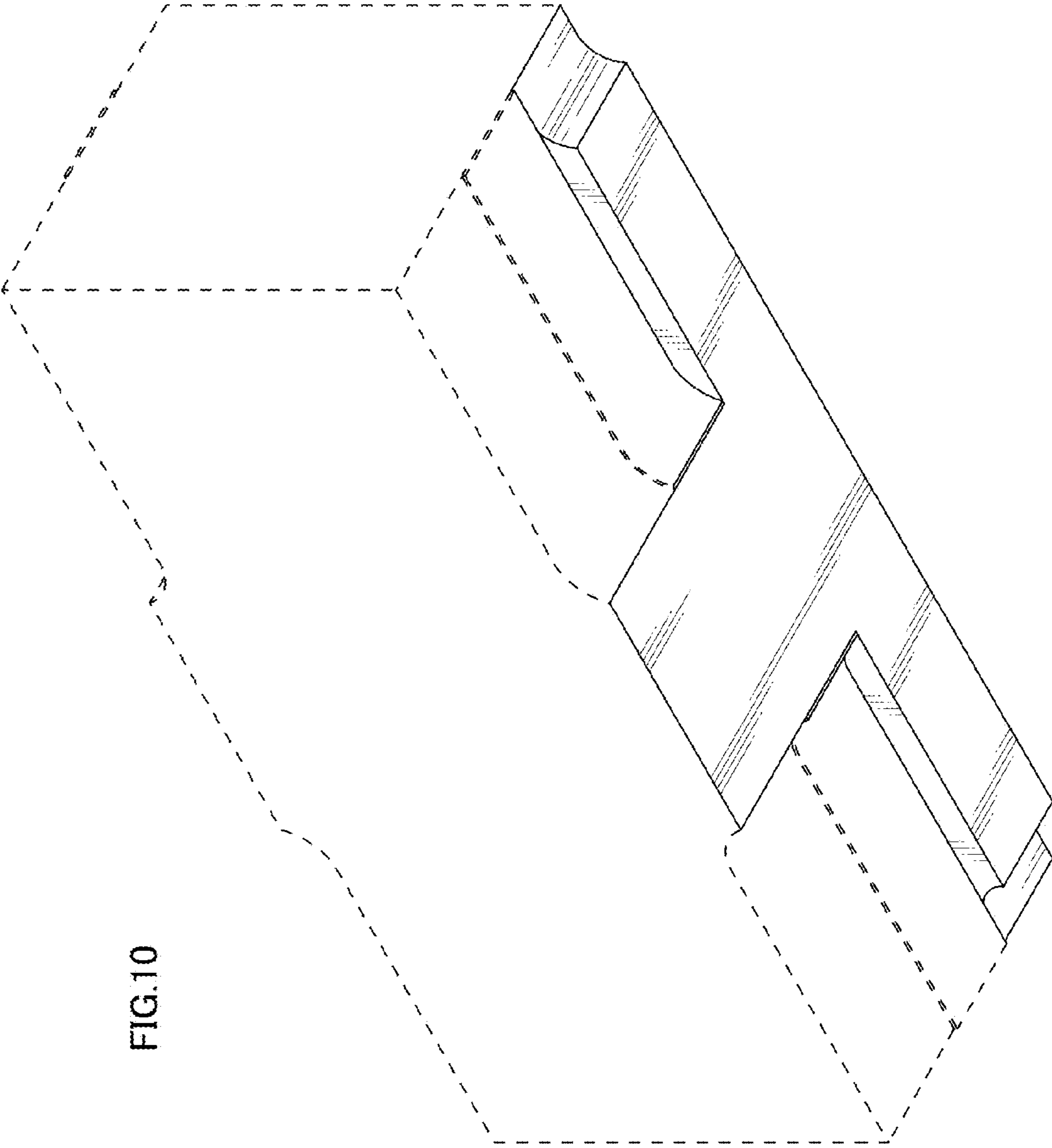

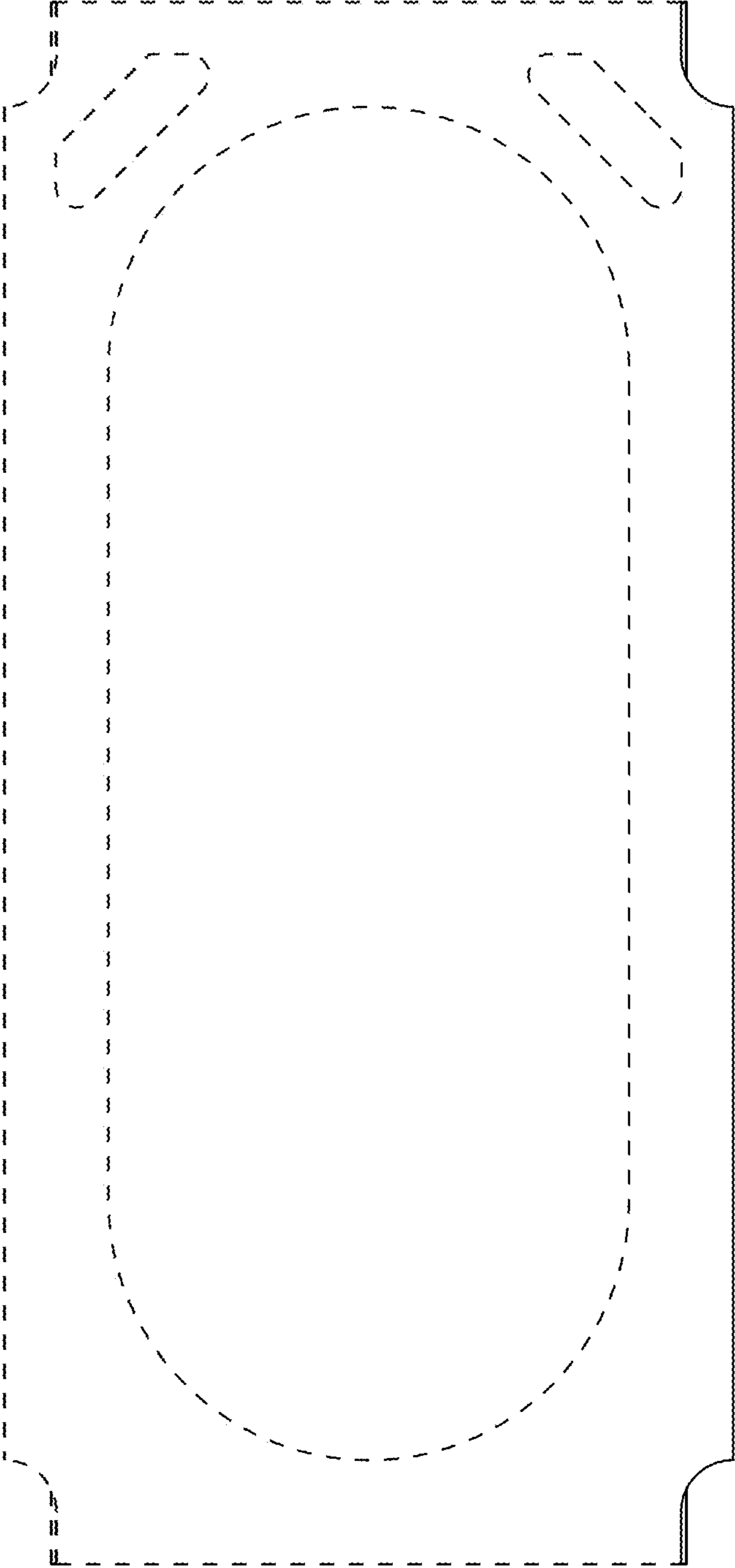

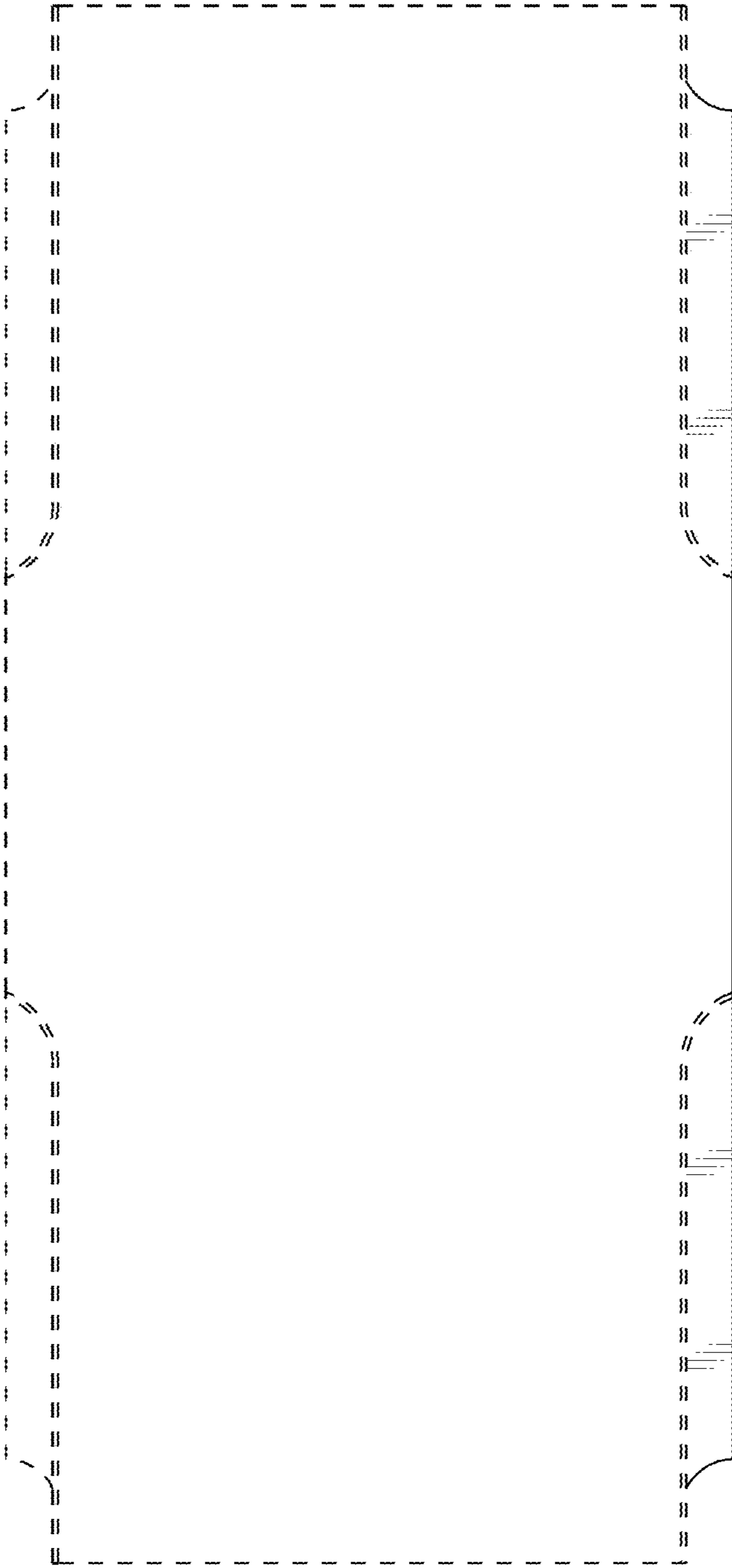

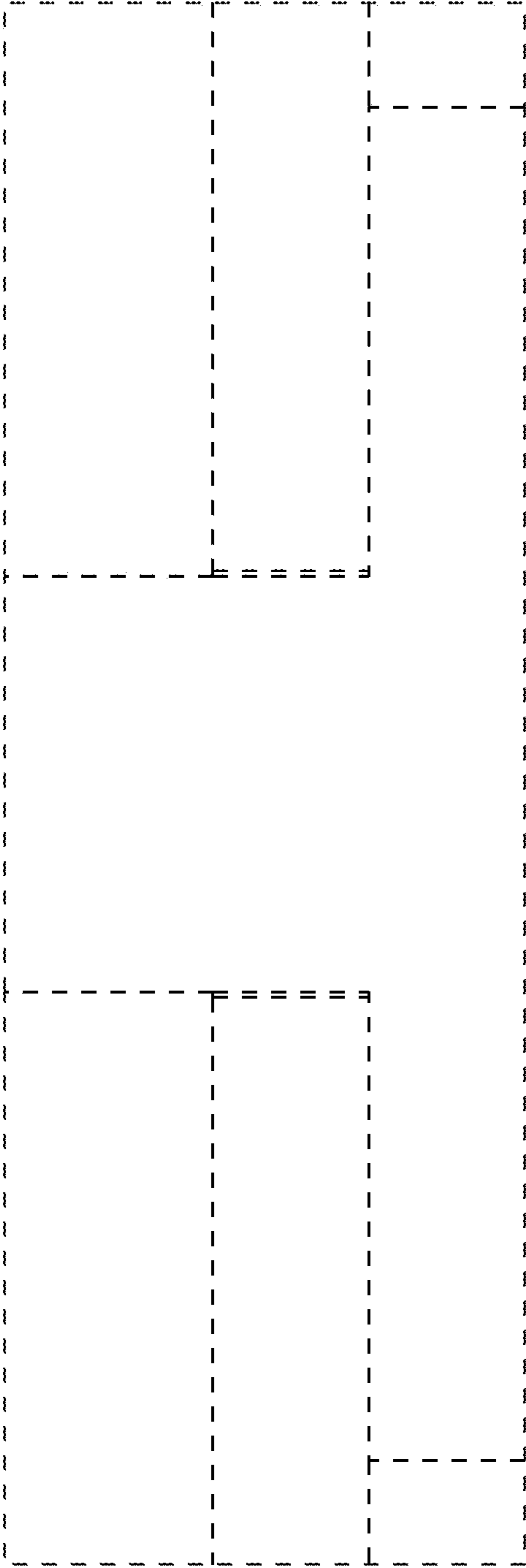

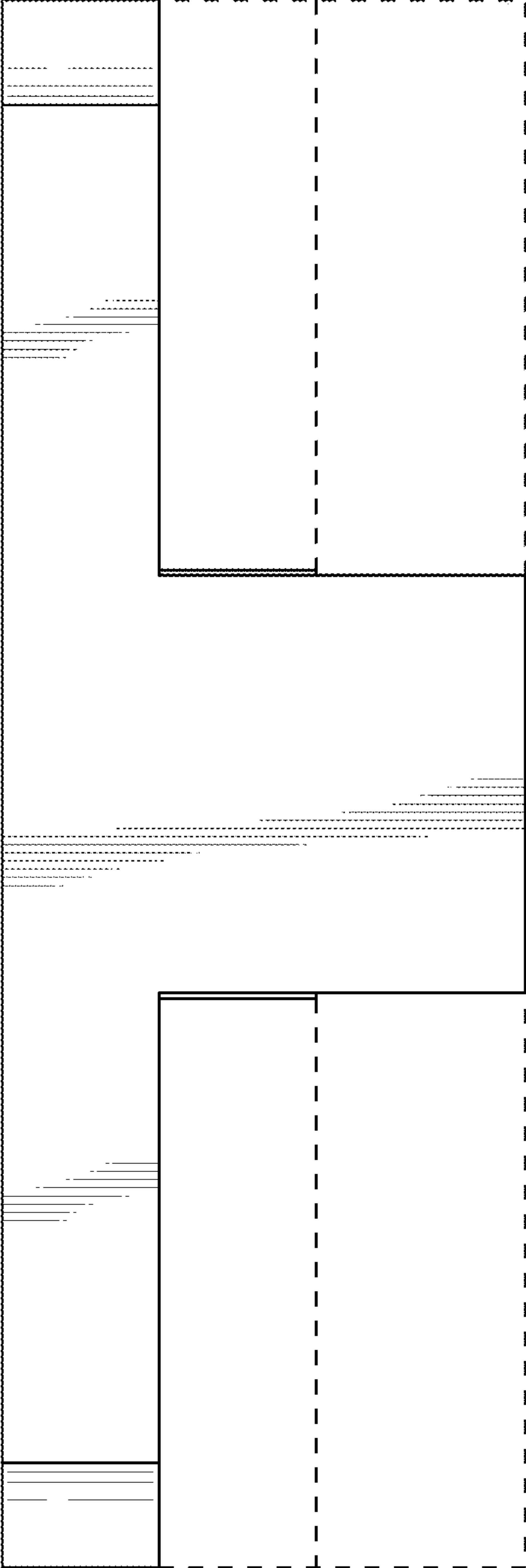

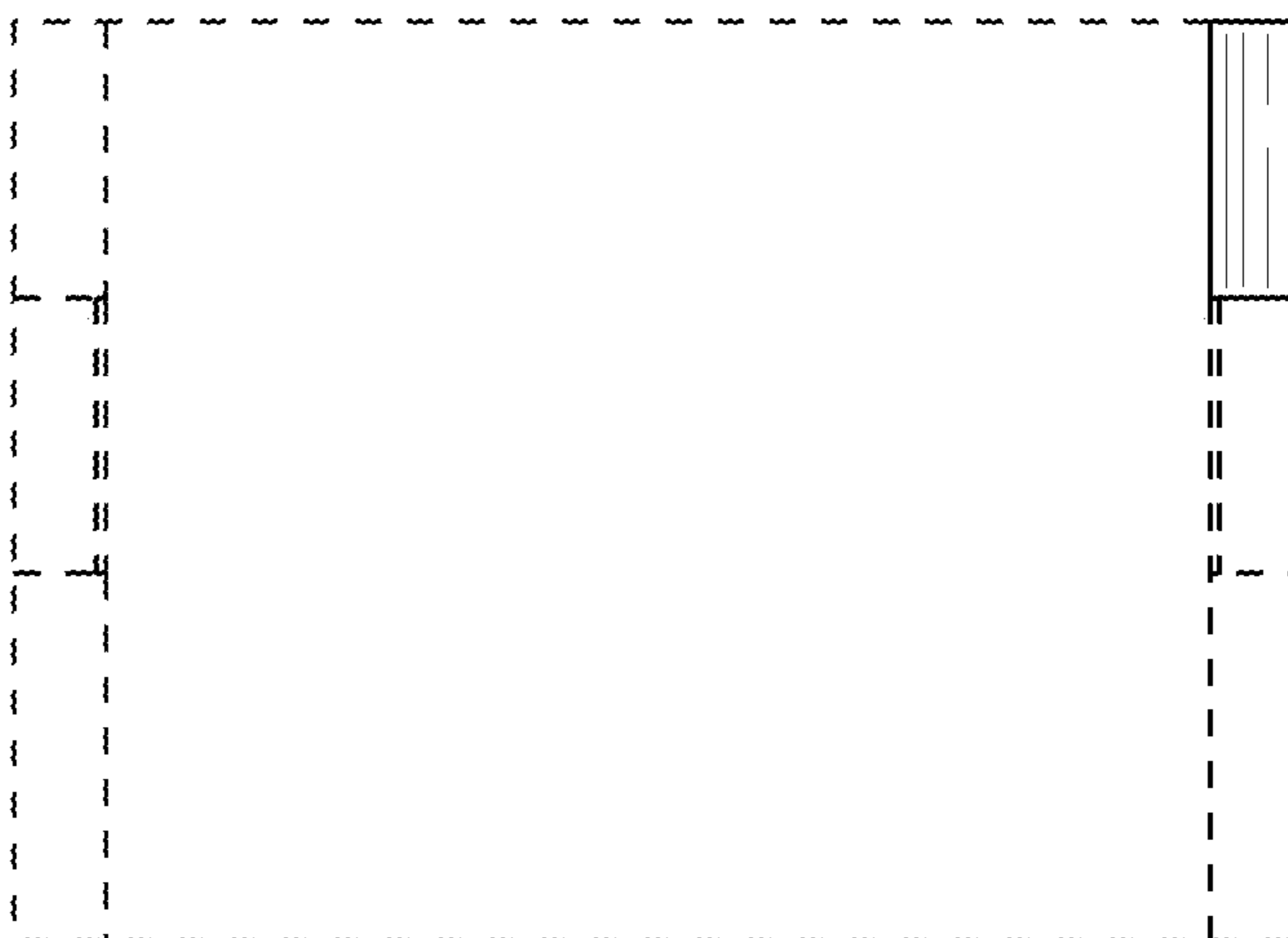
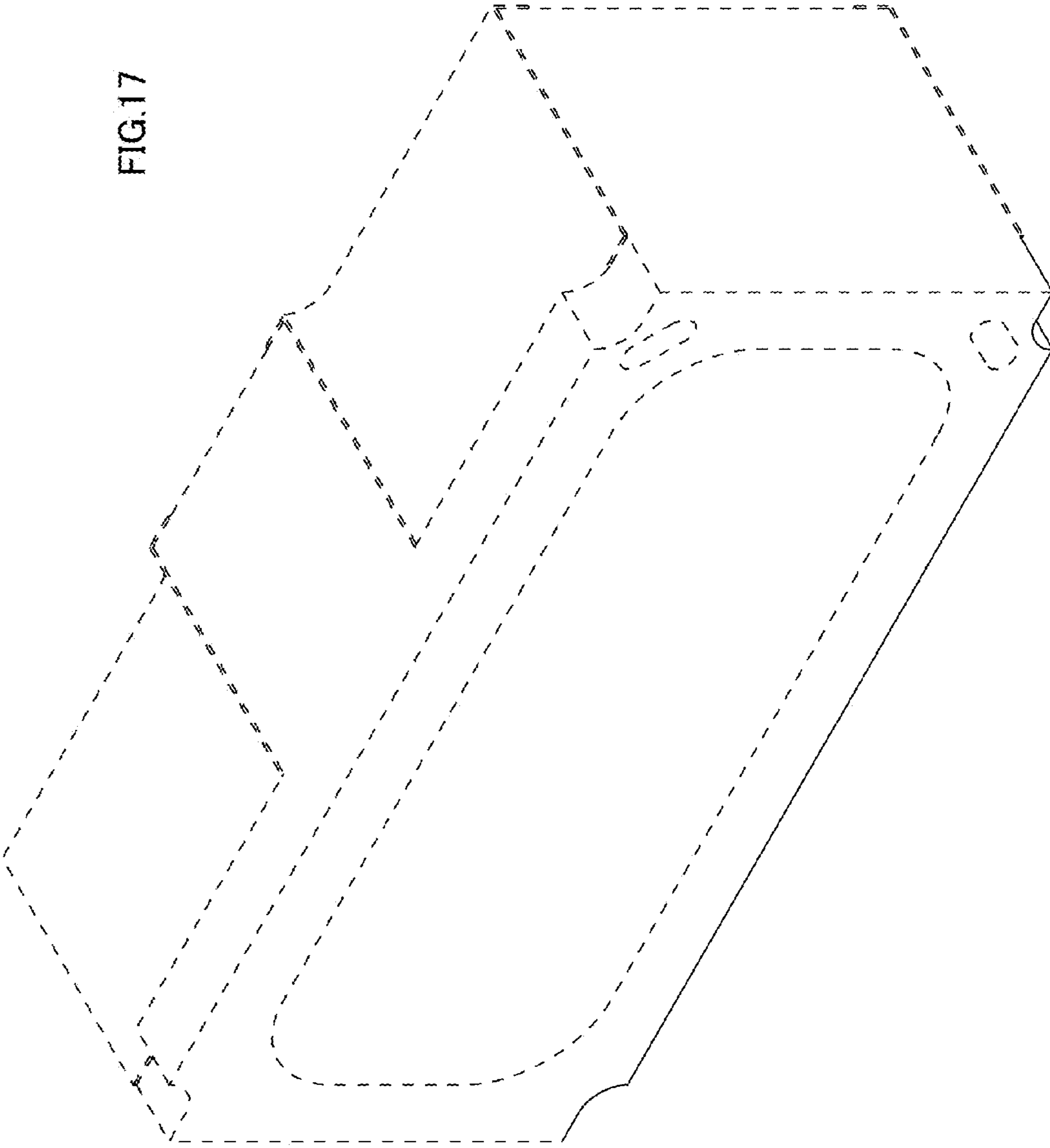

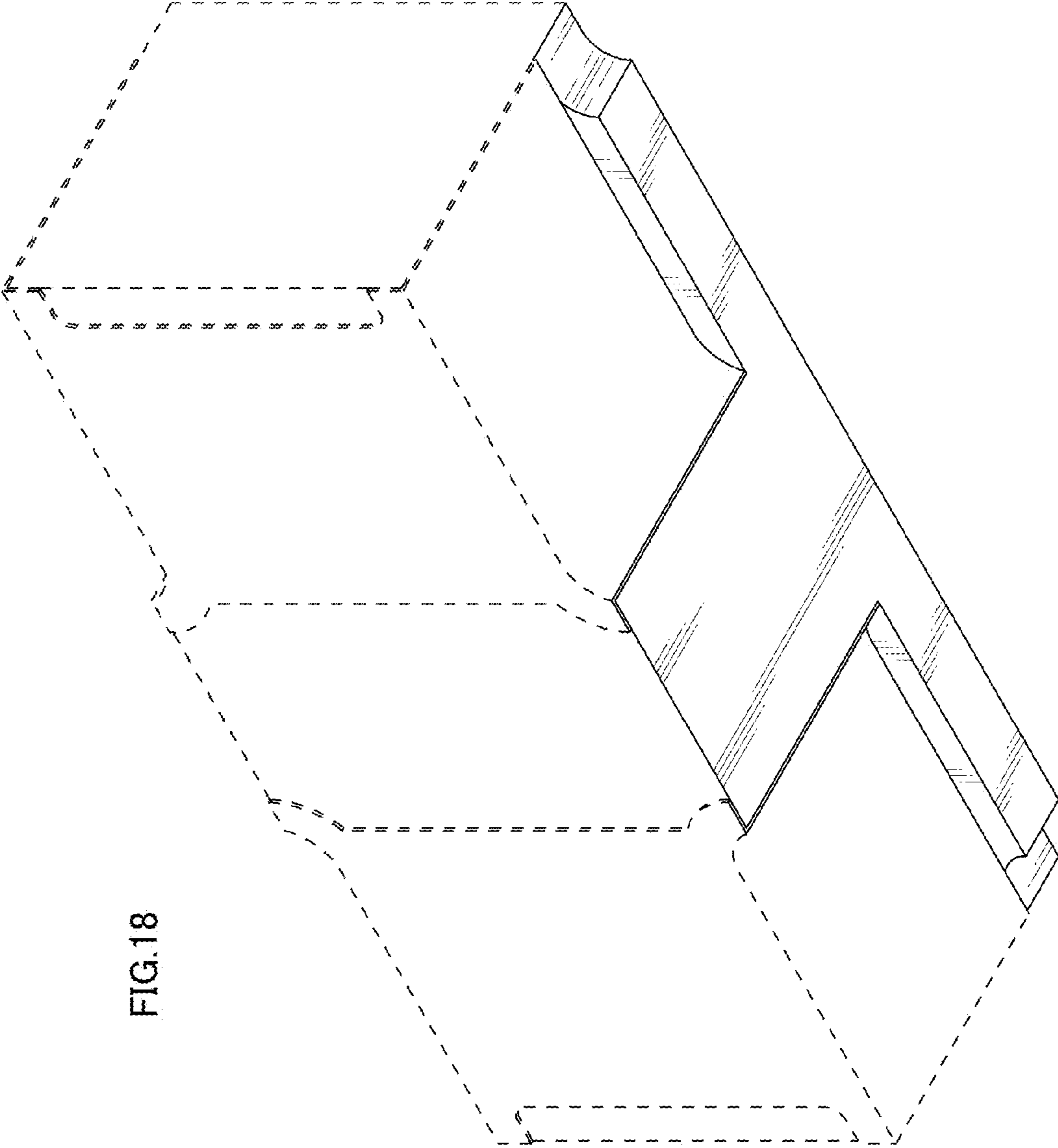

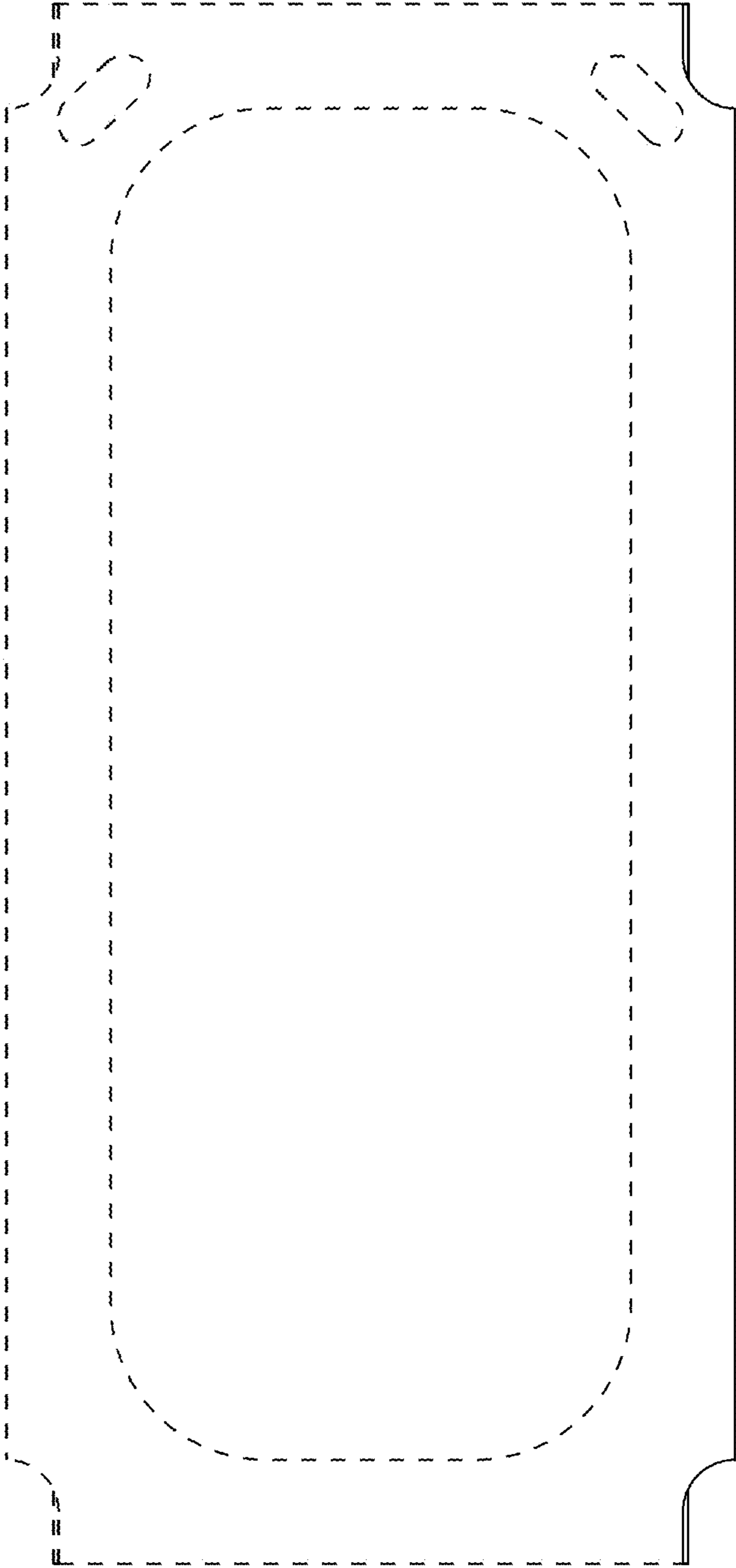

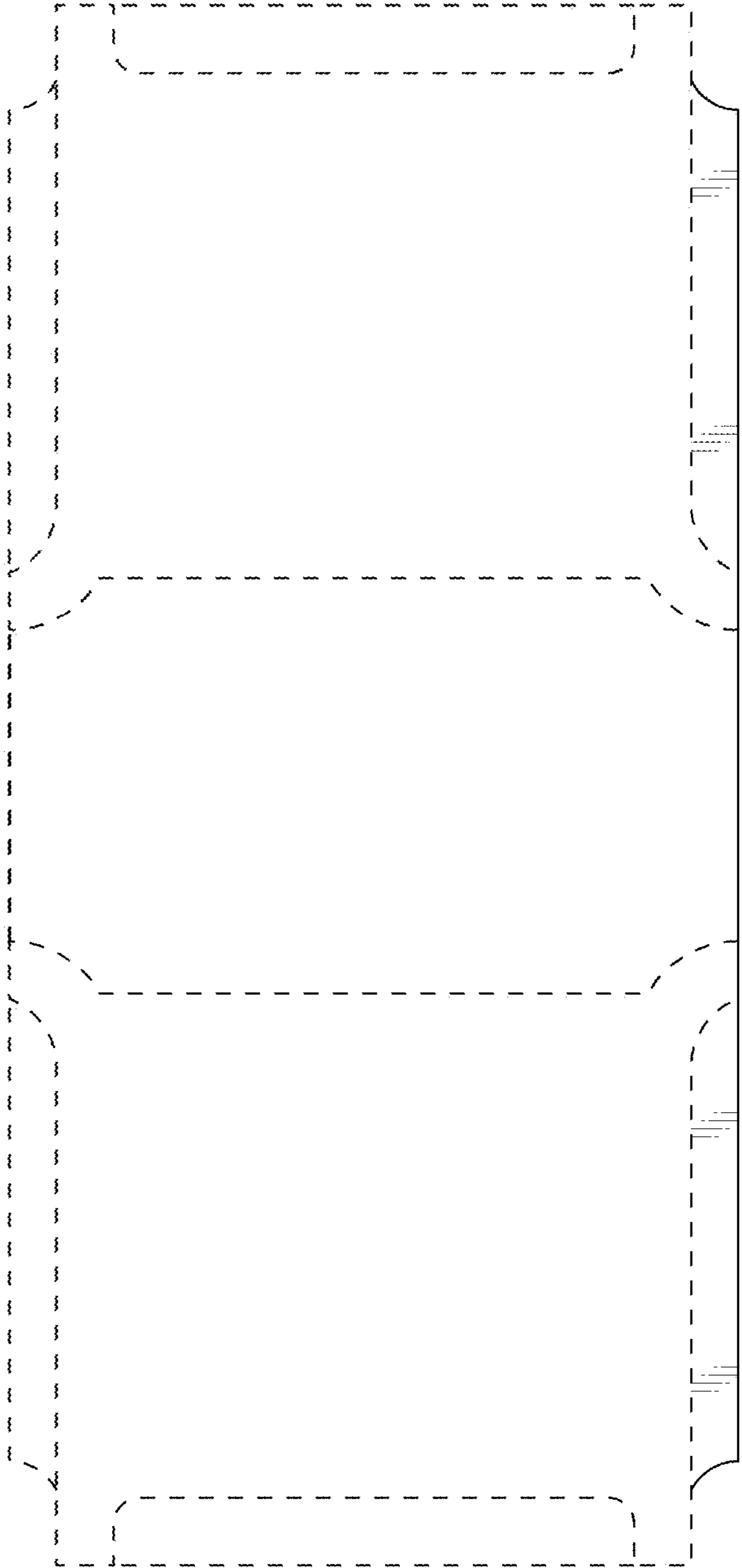

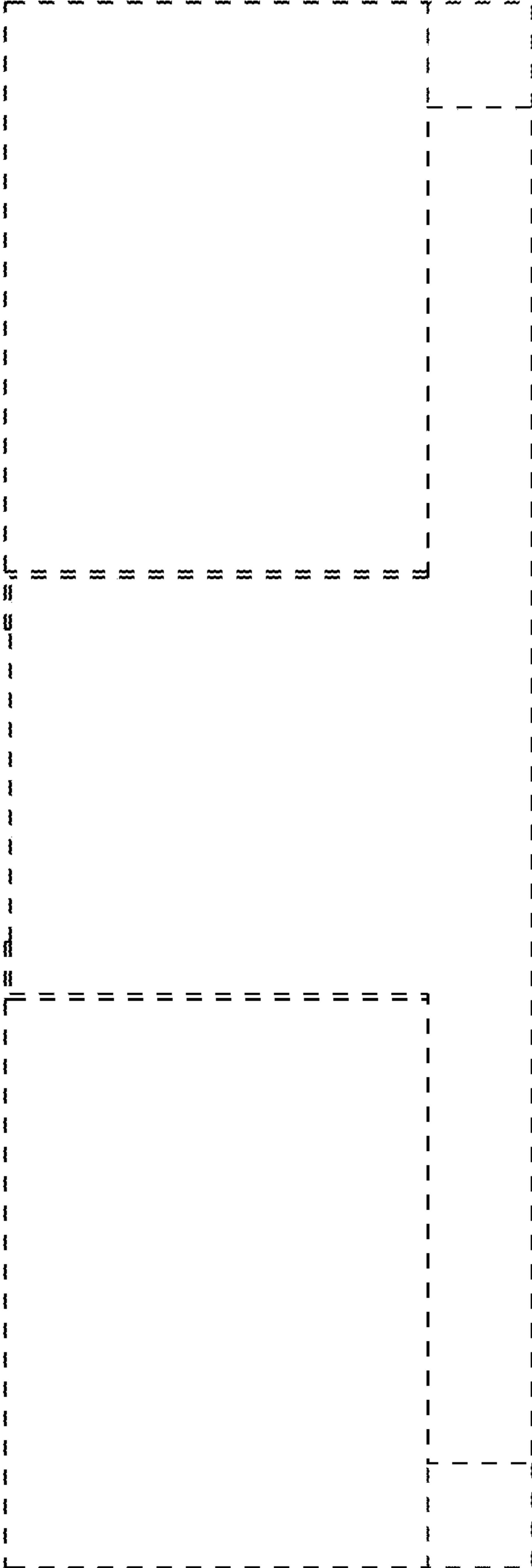

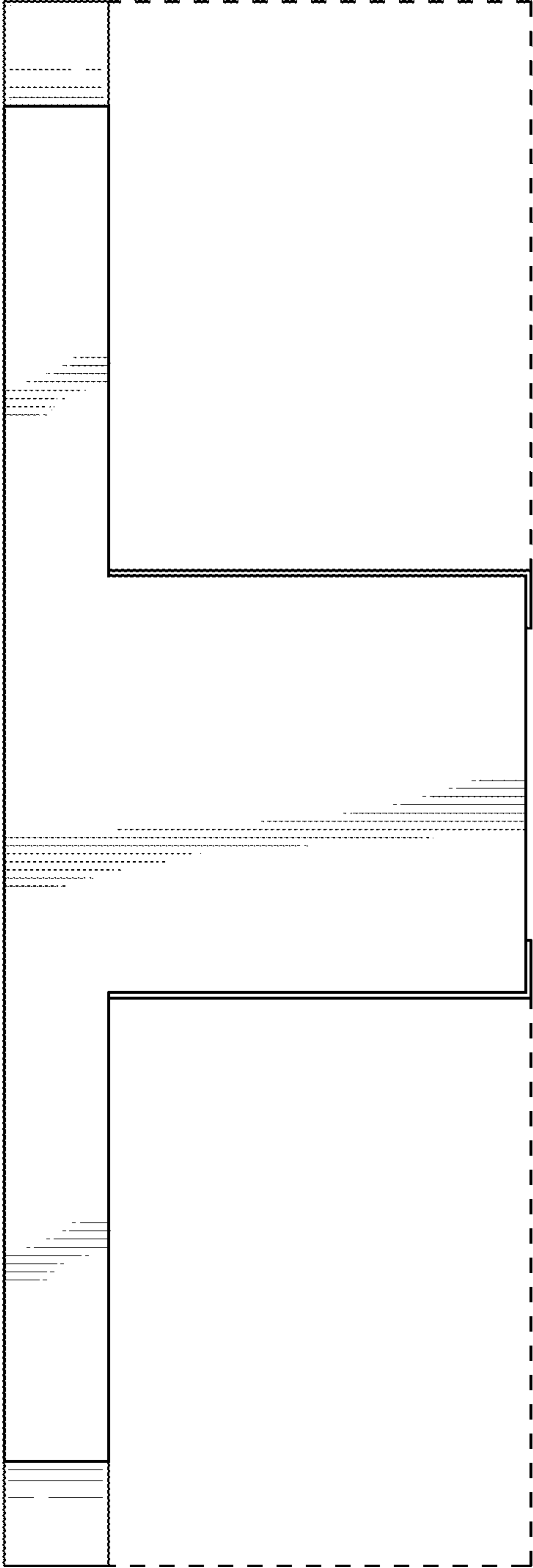
