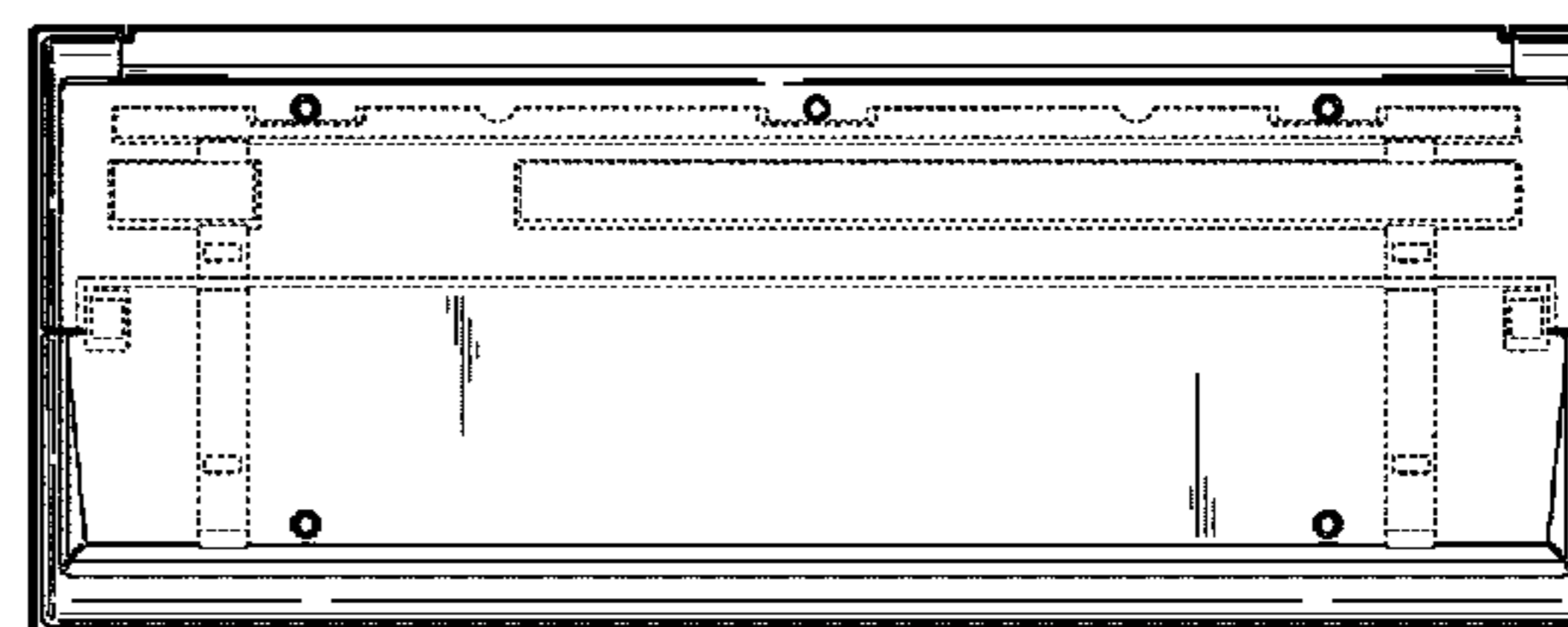
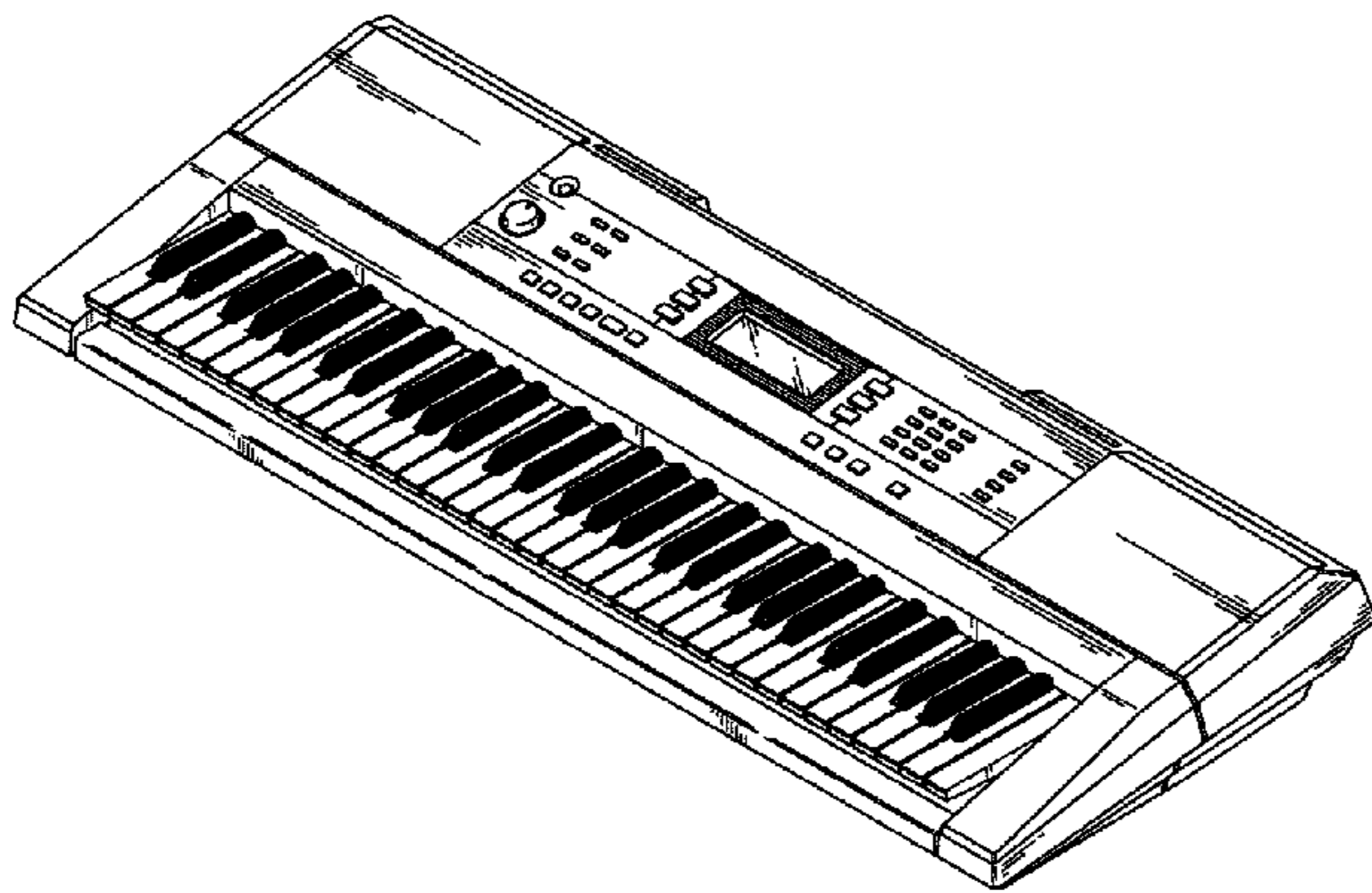
The ornamental design for an electronic keyboard, as shown and described.

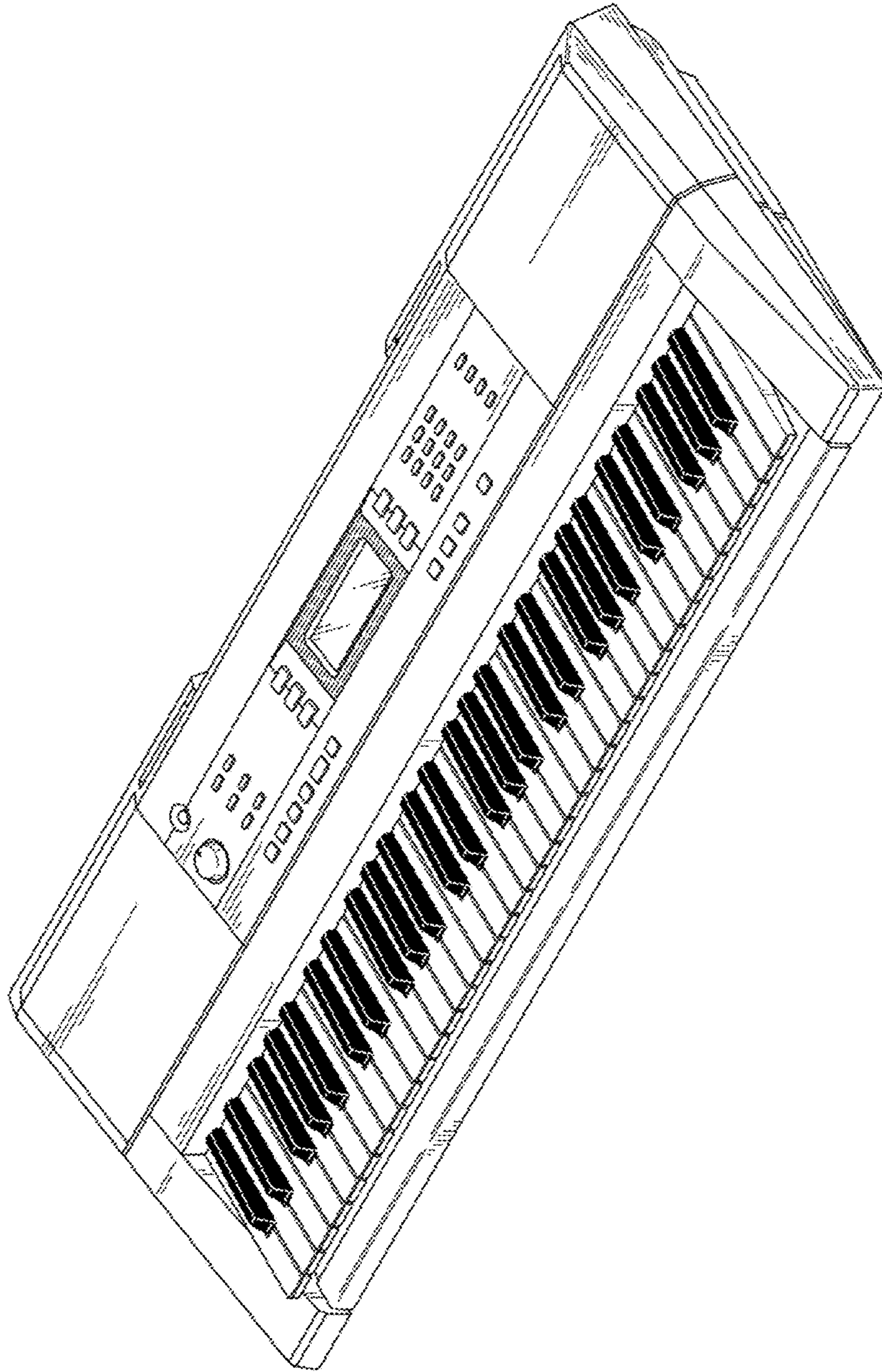

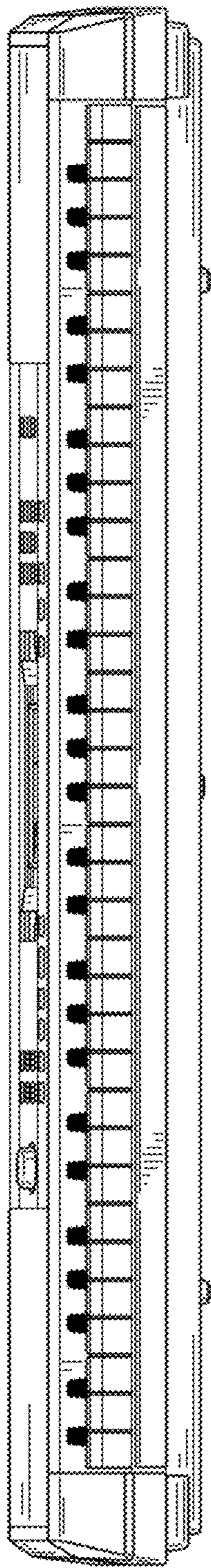

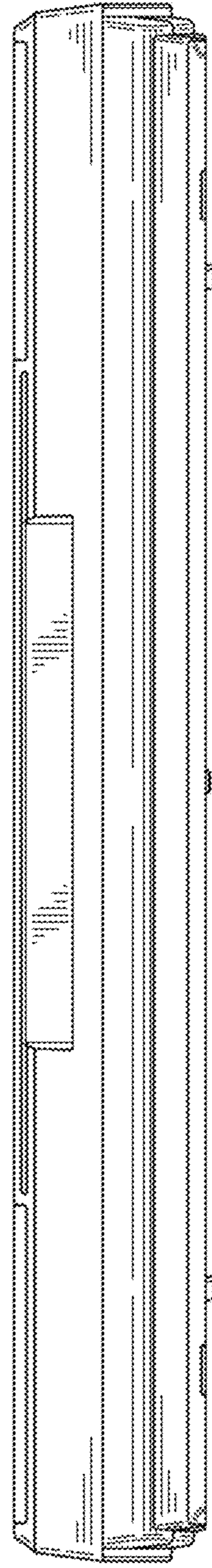

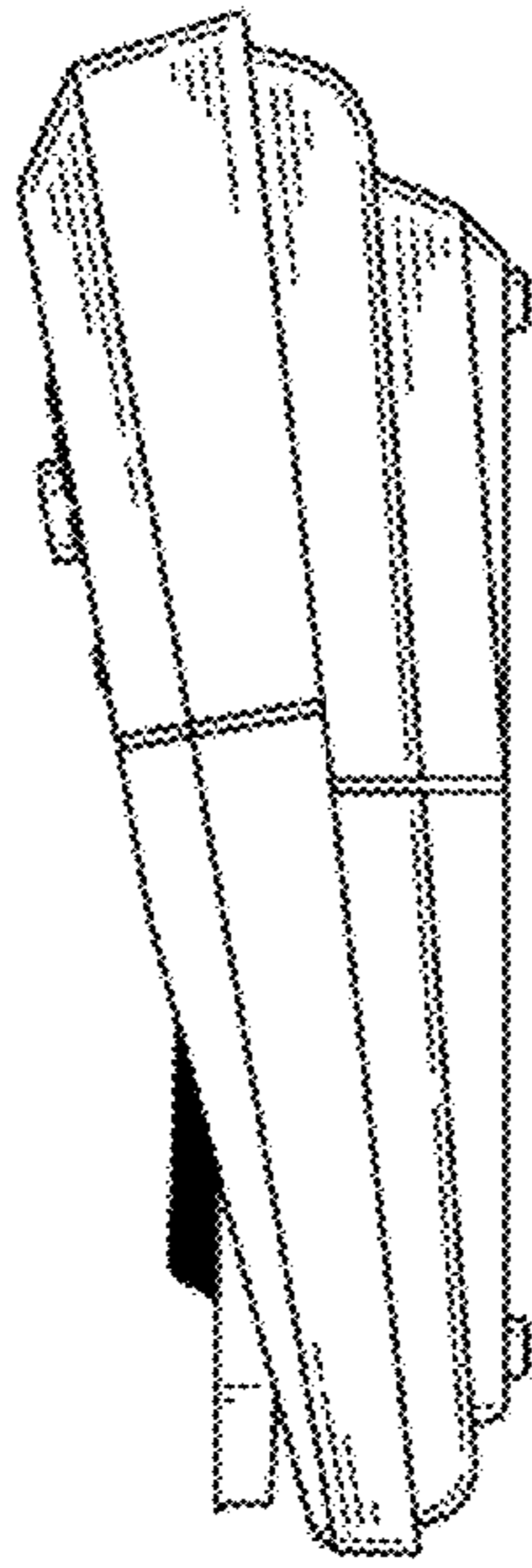

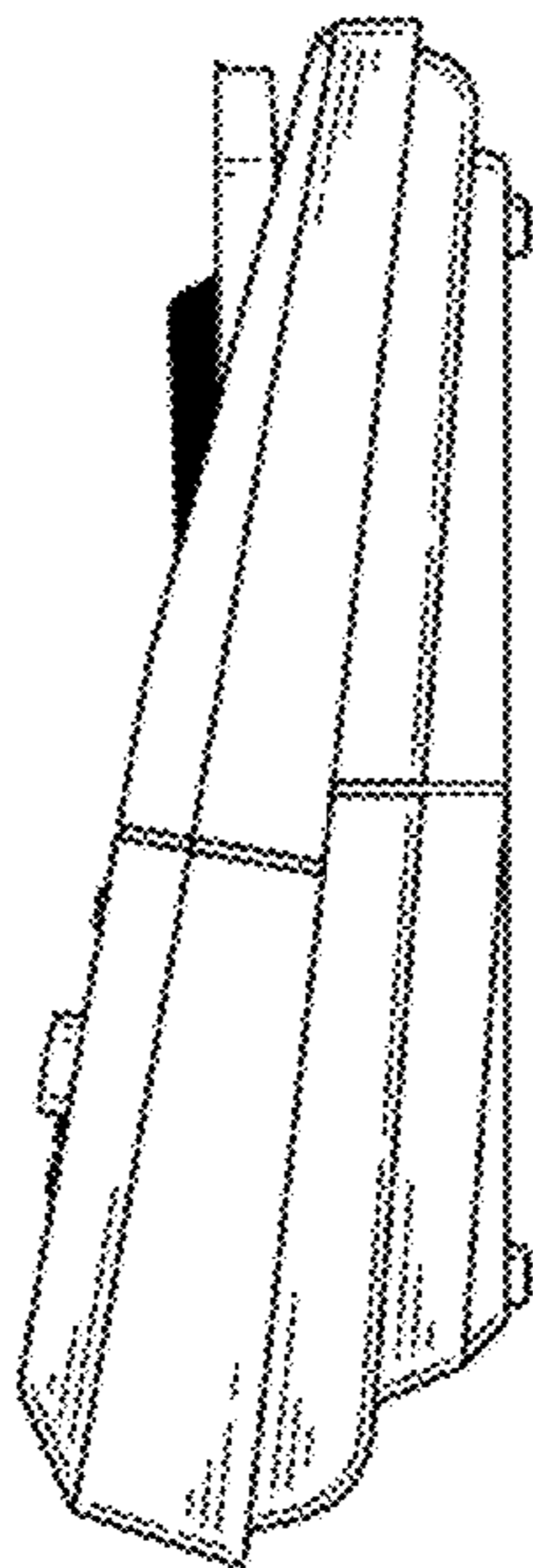

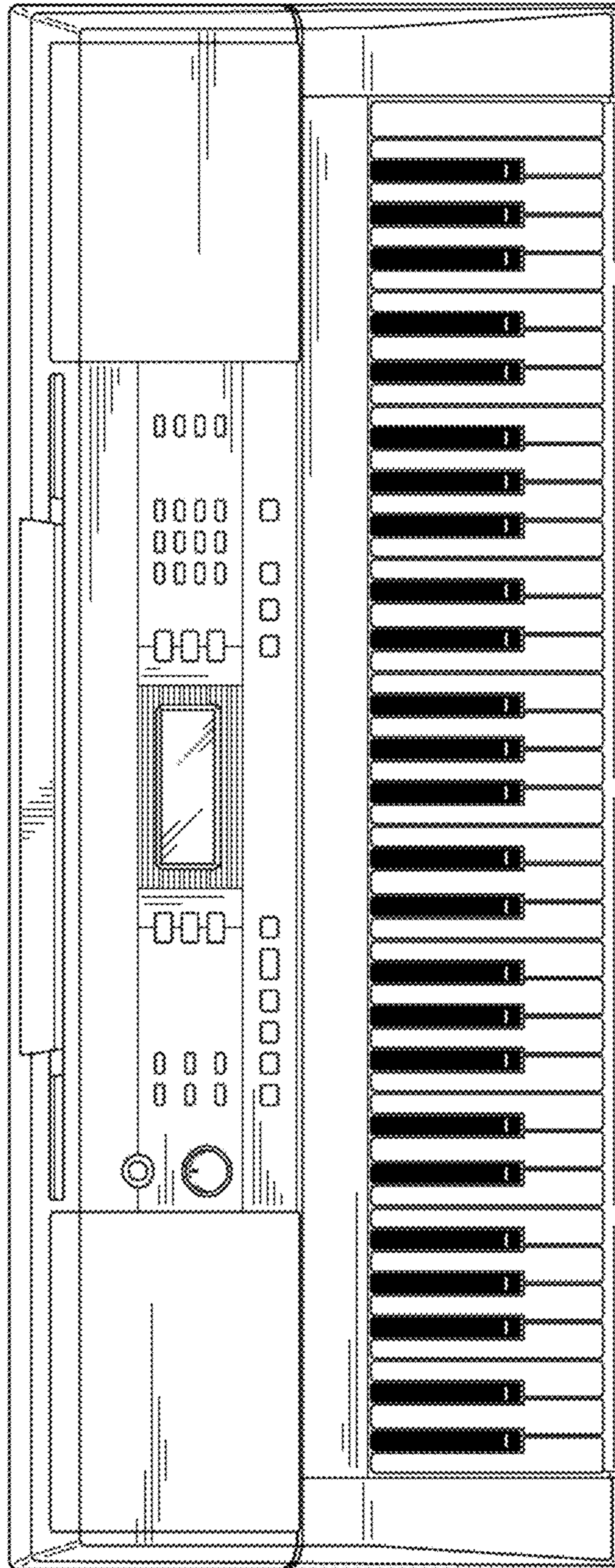

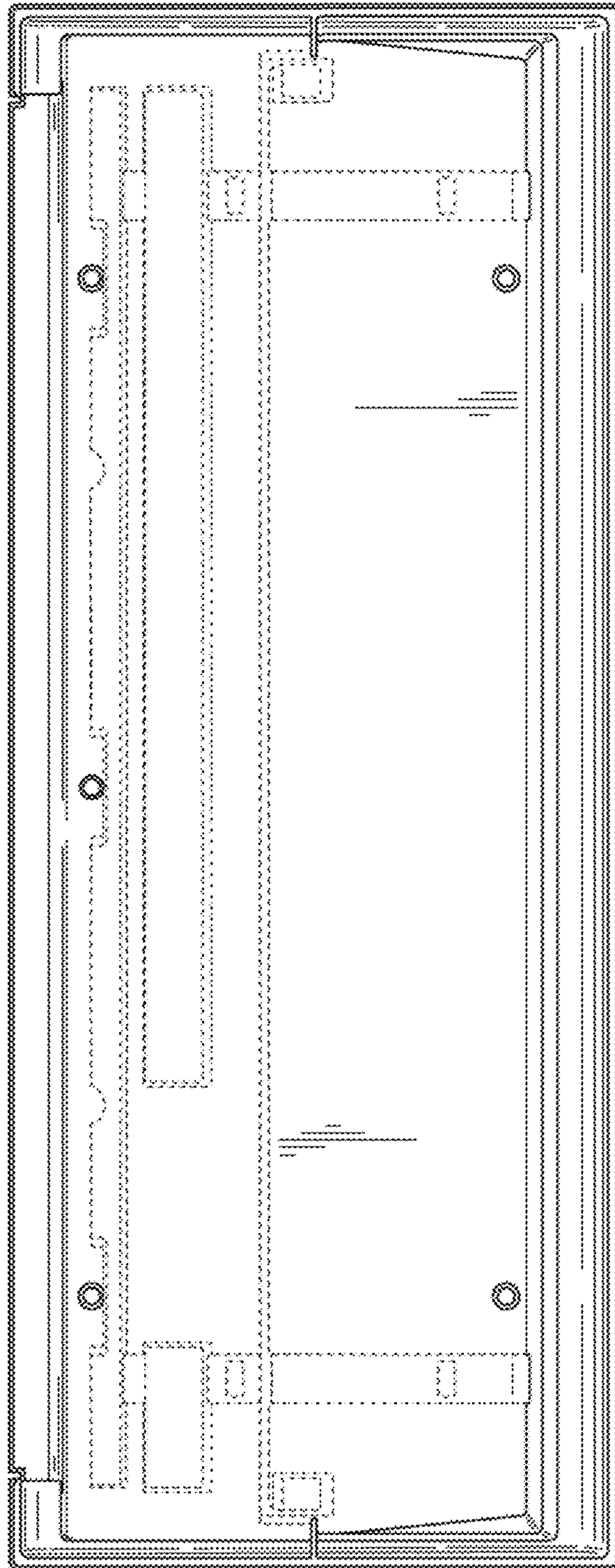
