DESCRIPTION

(with the other side view being a mirror image thereof);

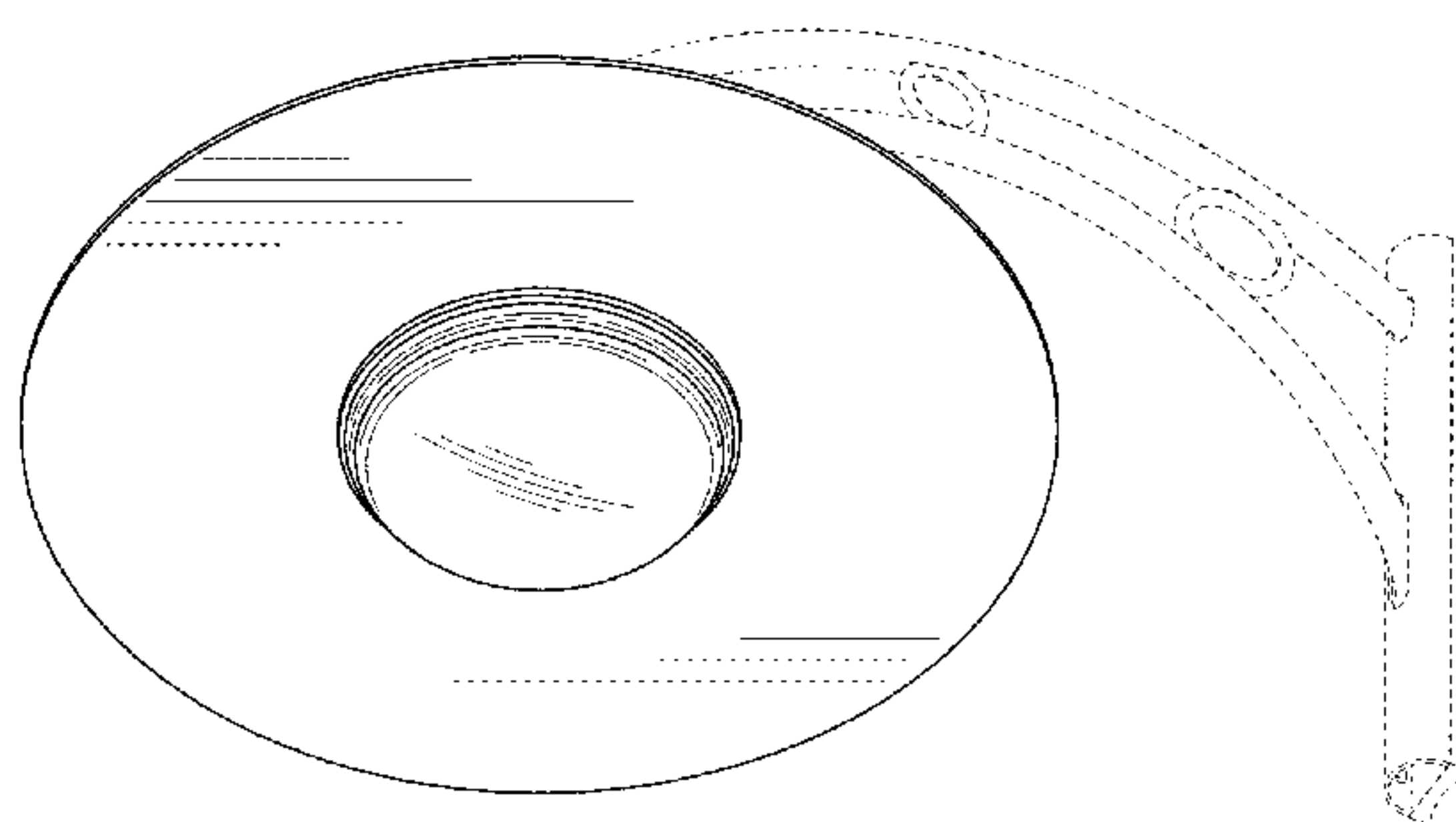
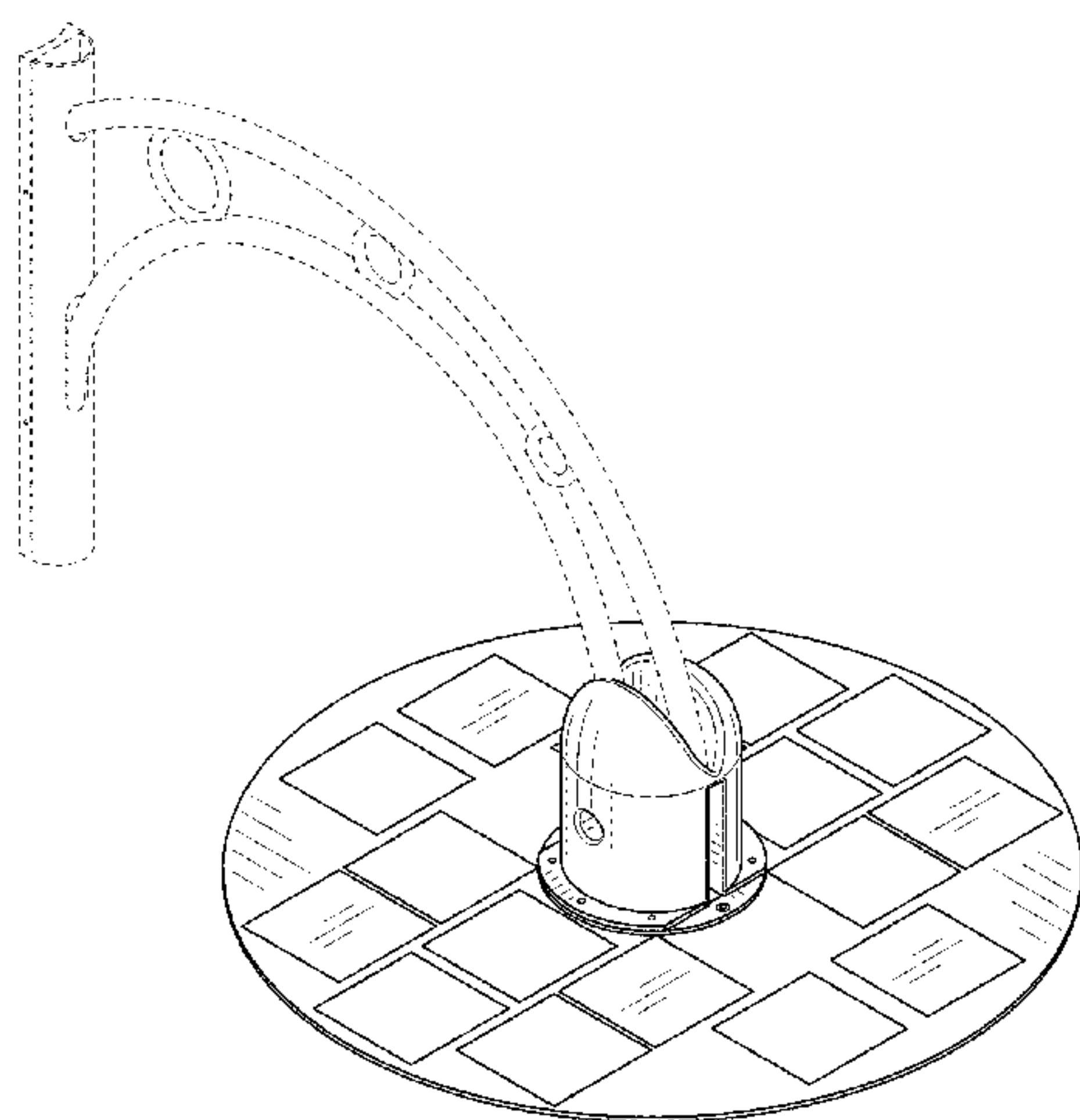
FIG. 5 is a top view of the outdoor lamp shown in FIG. 1;

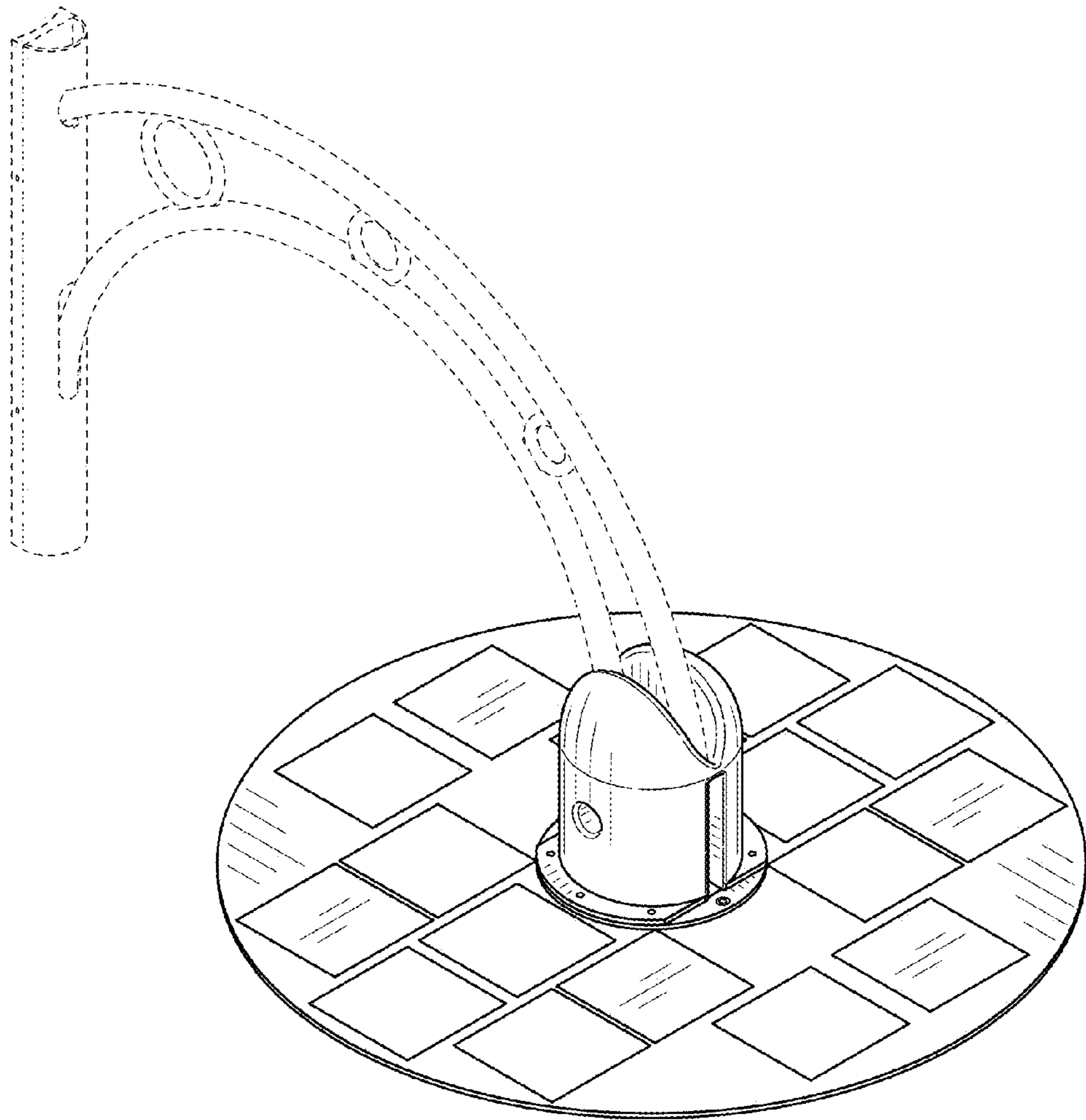

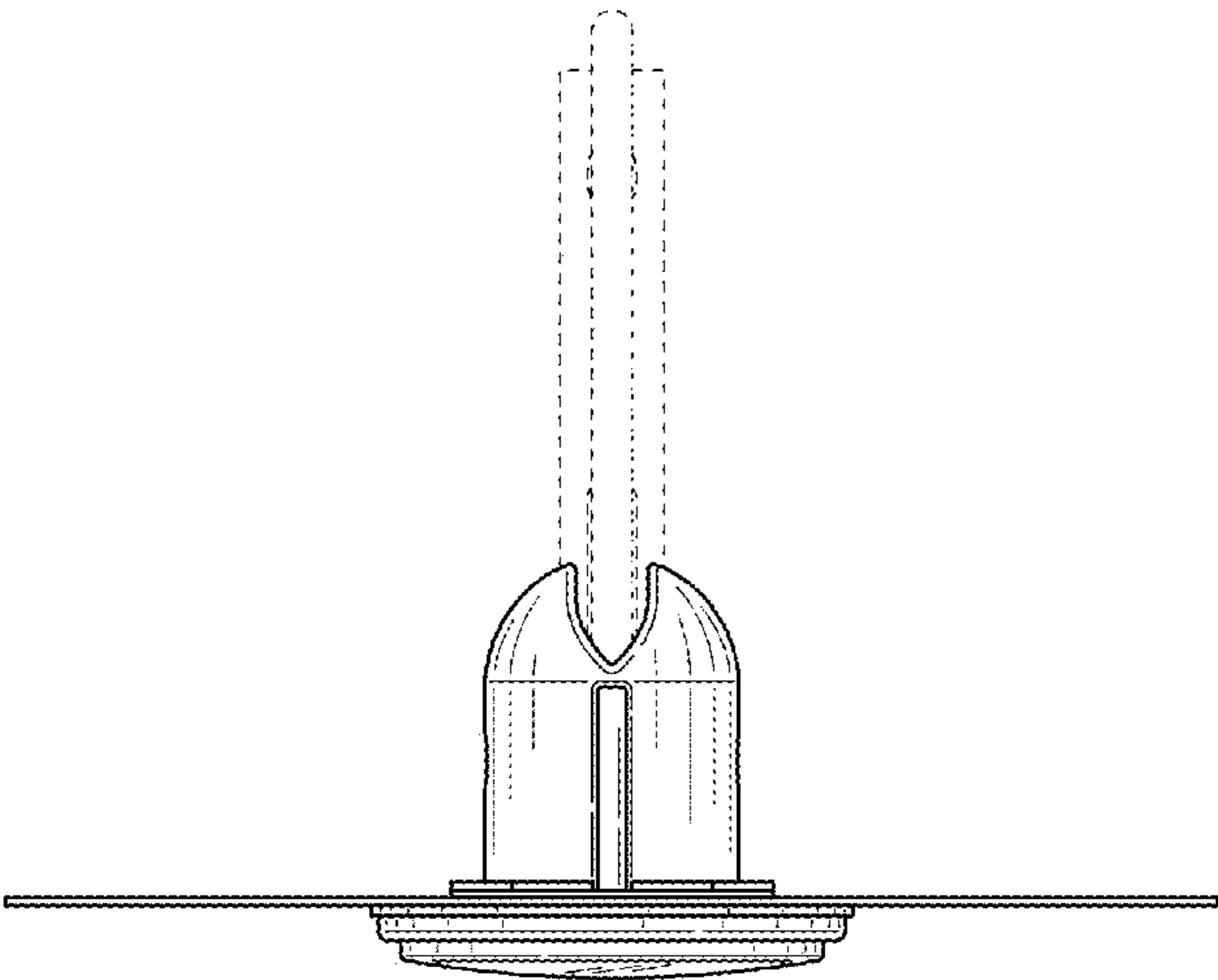

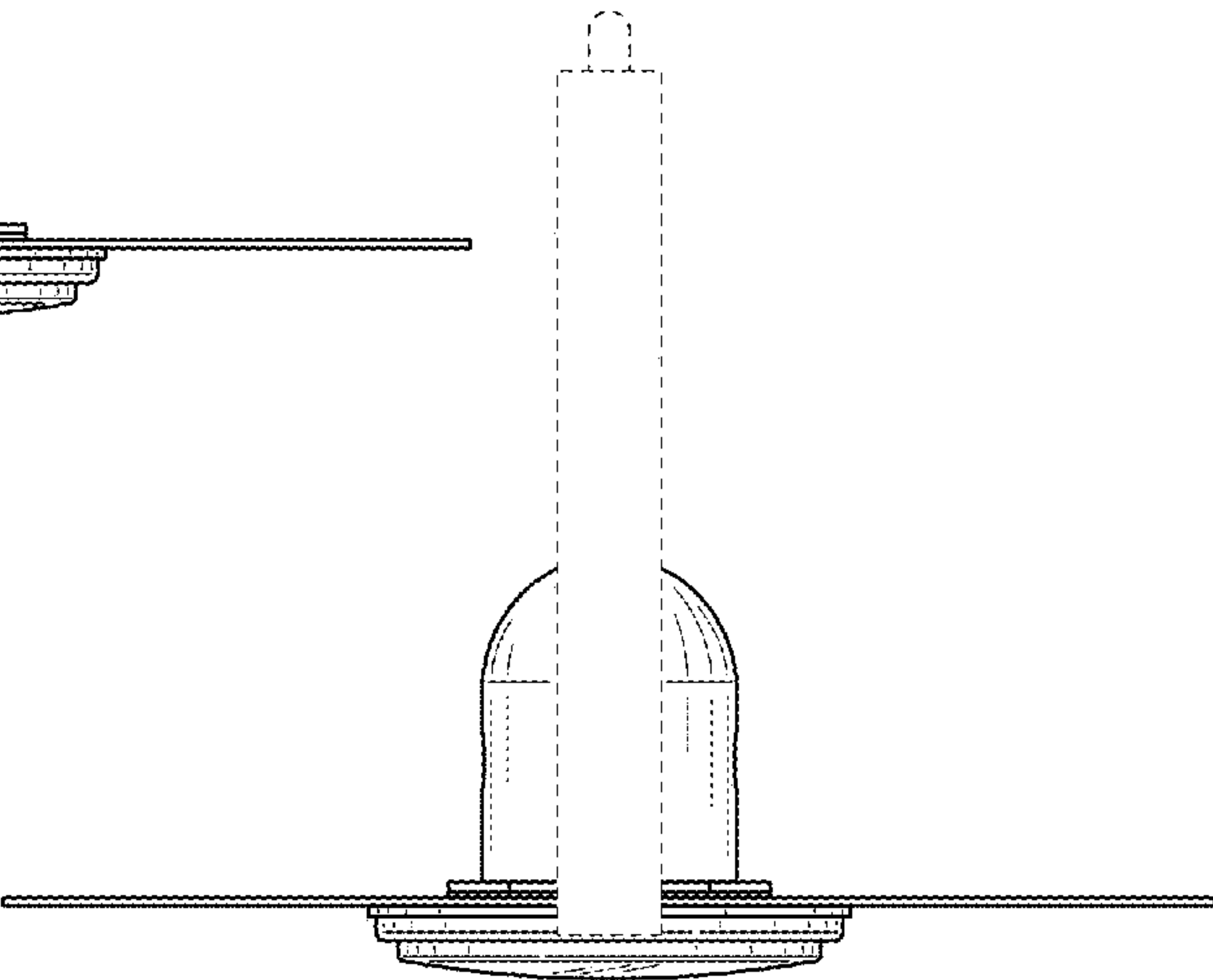

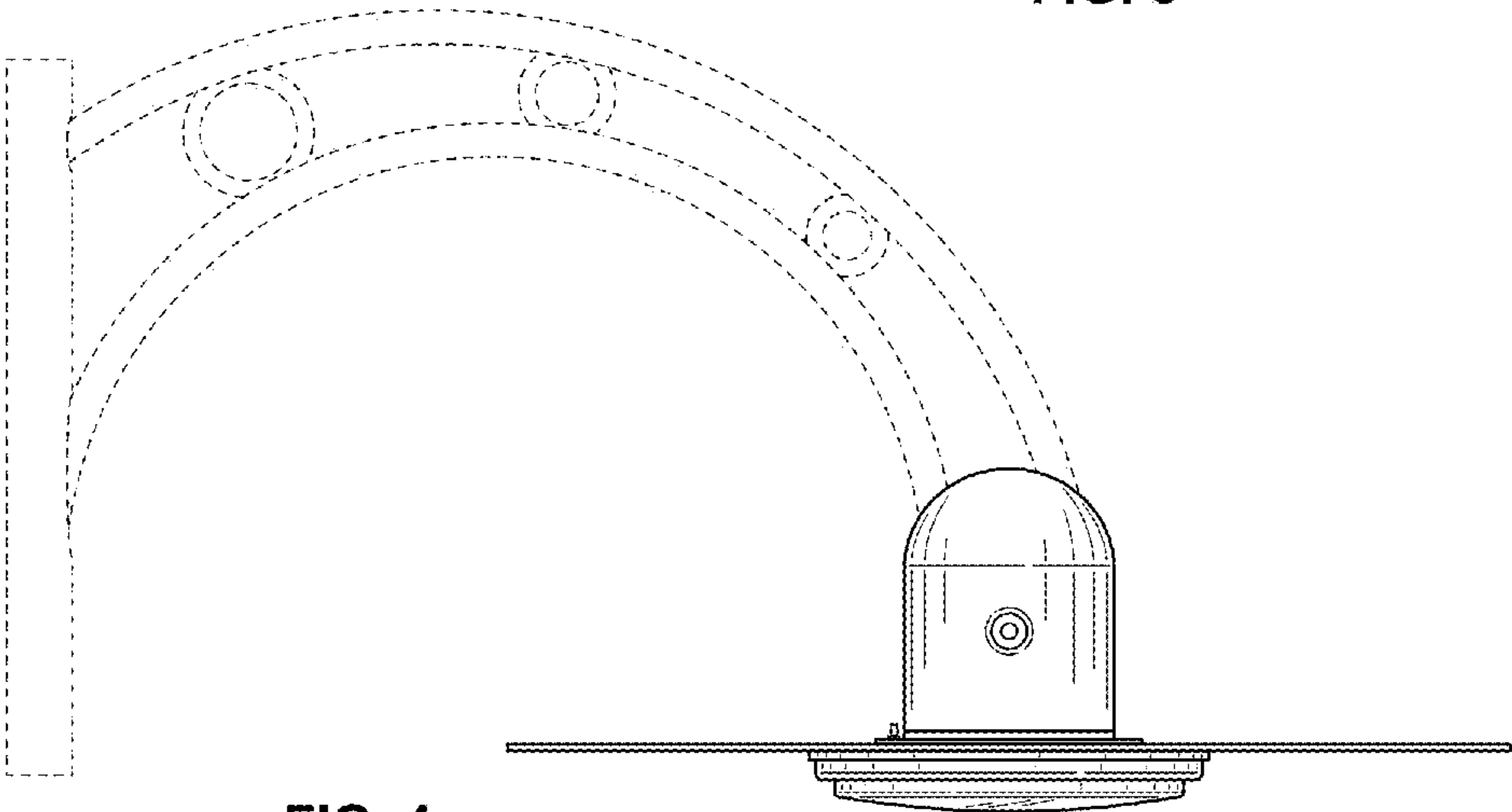

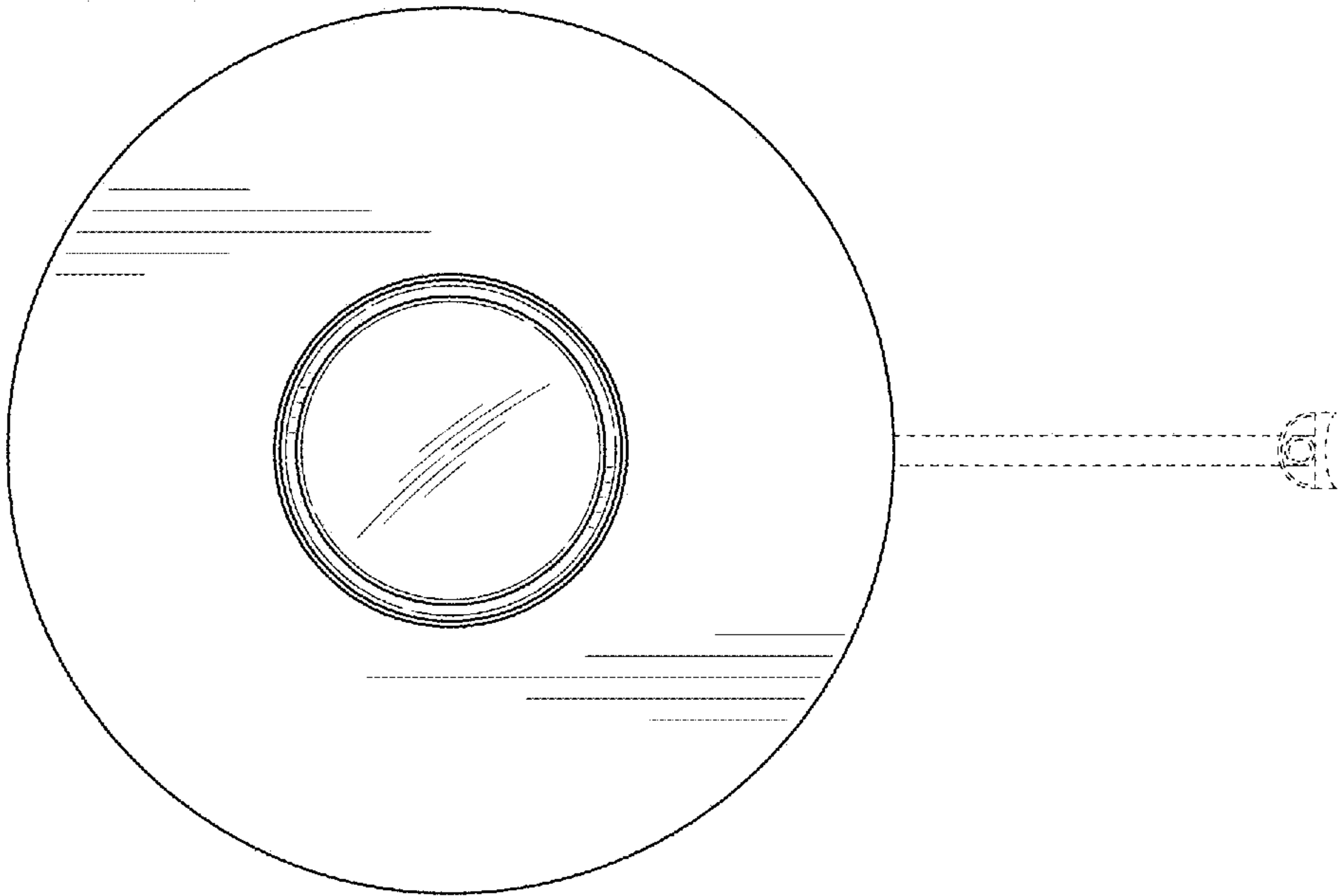

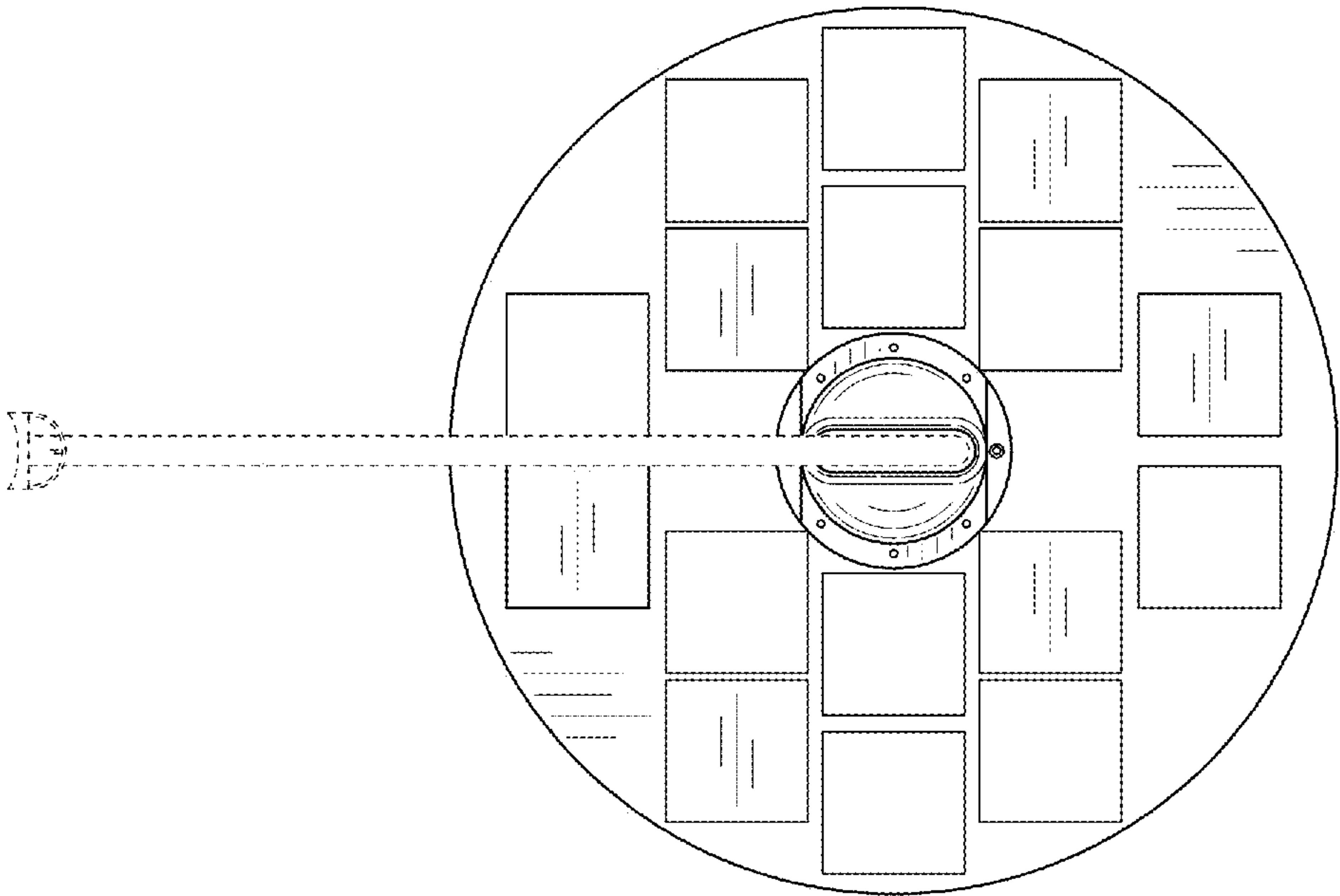

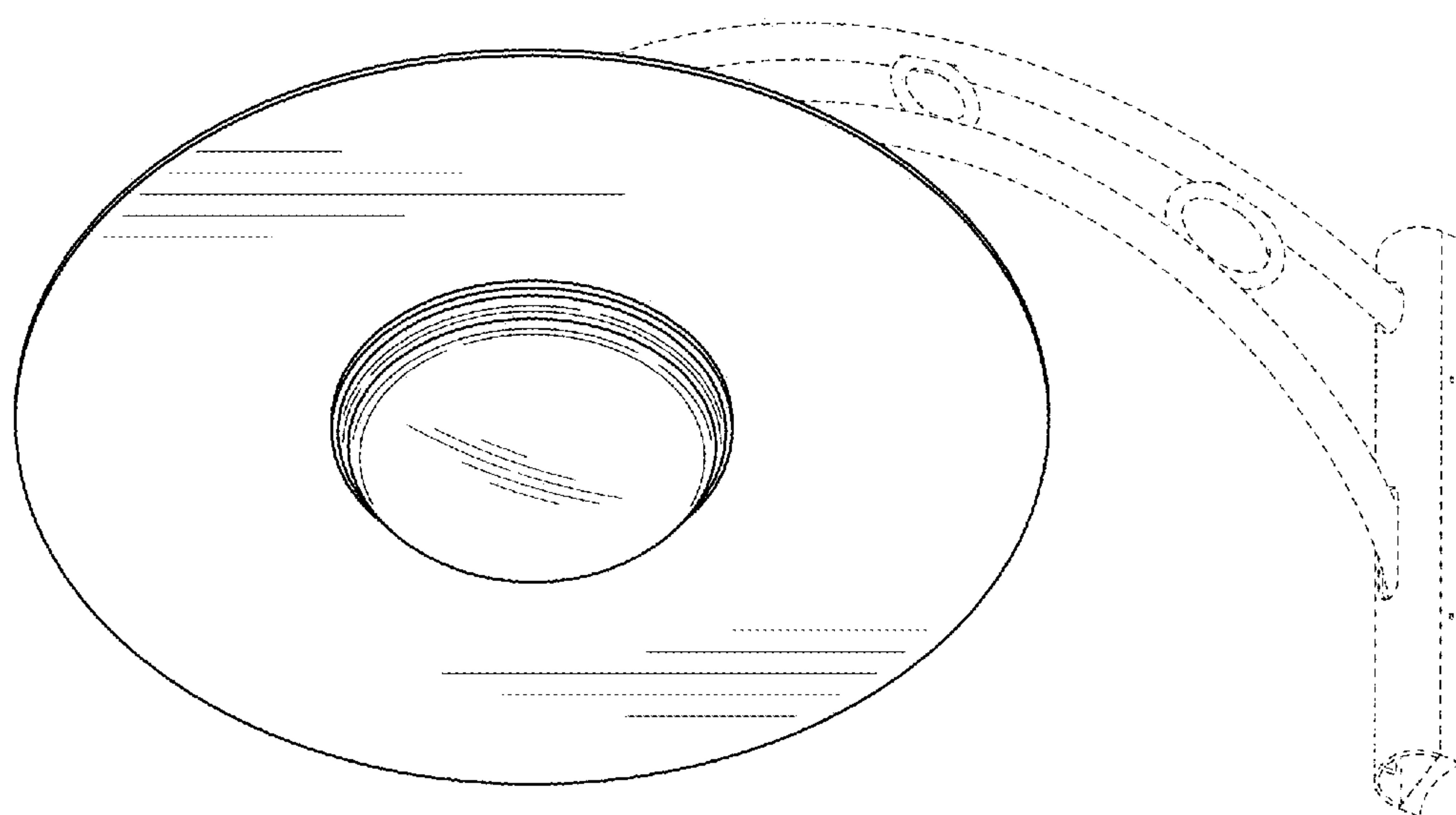
