FIG. 2 is a front, top and right side perspective view thereof;

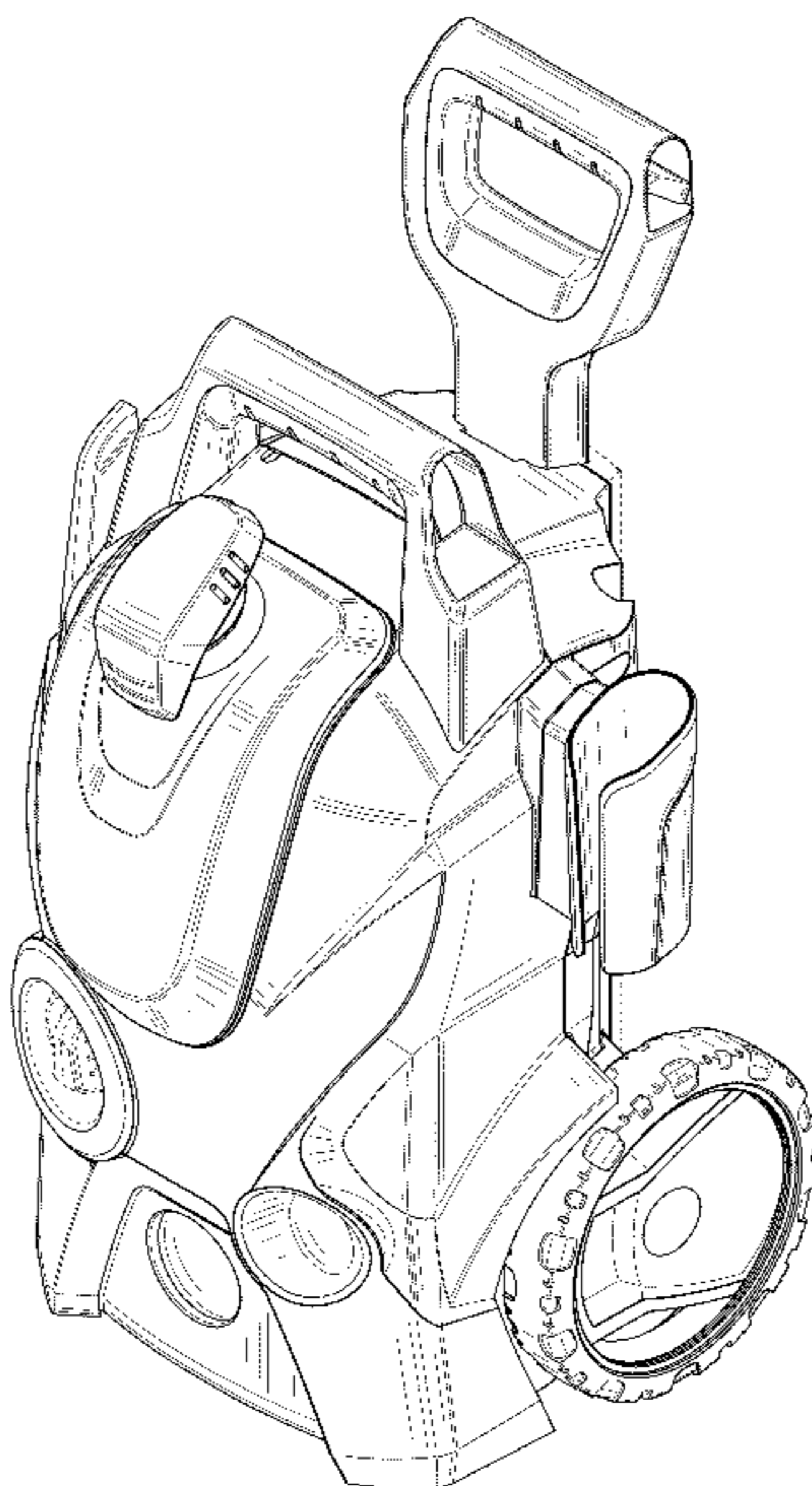
FIG. 3 is a front elevational view thereof;

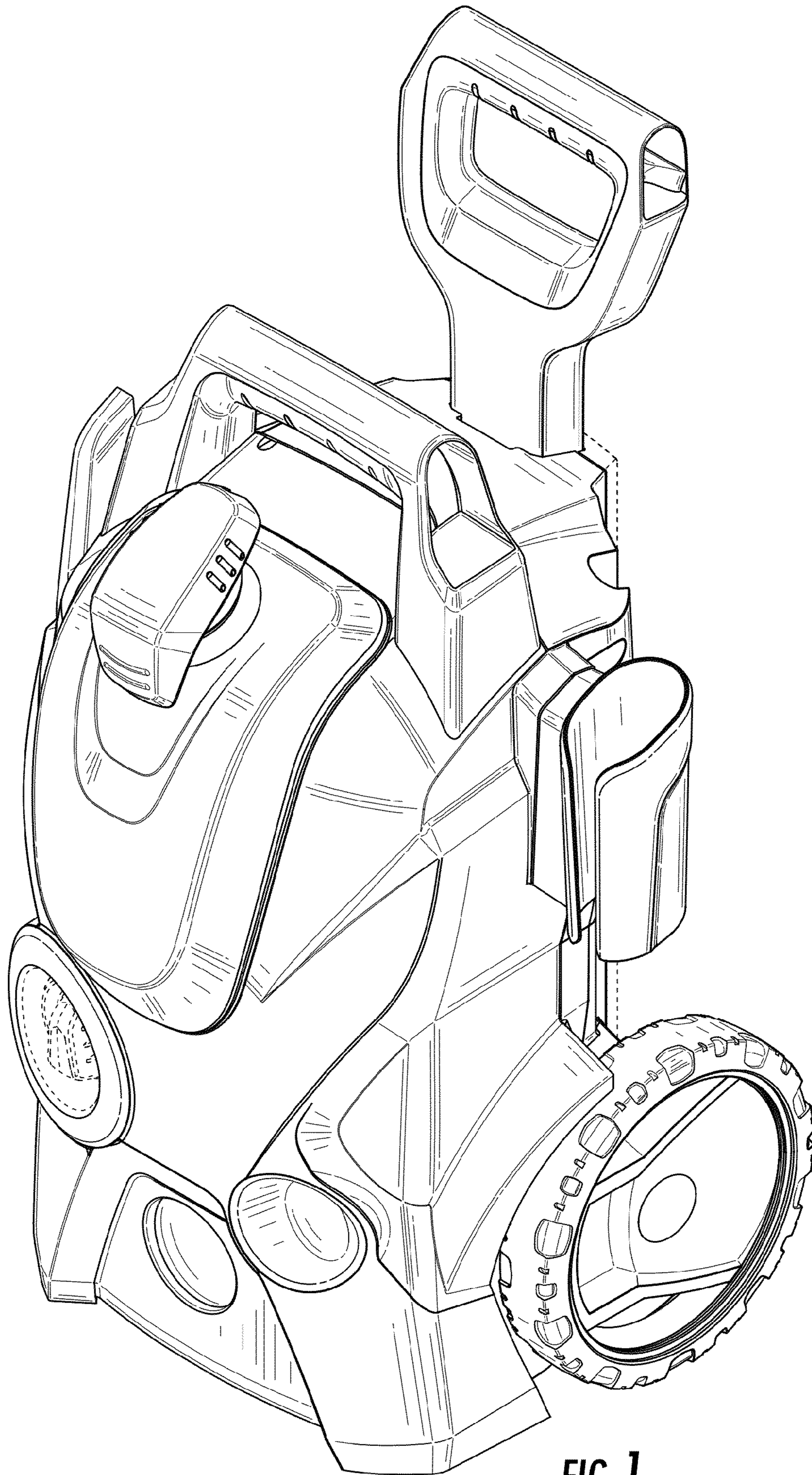

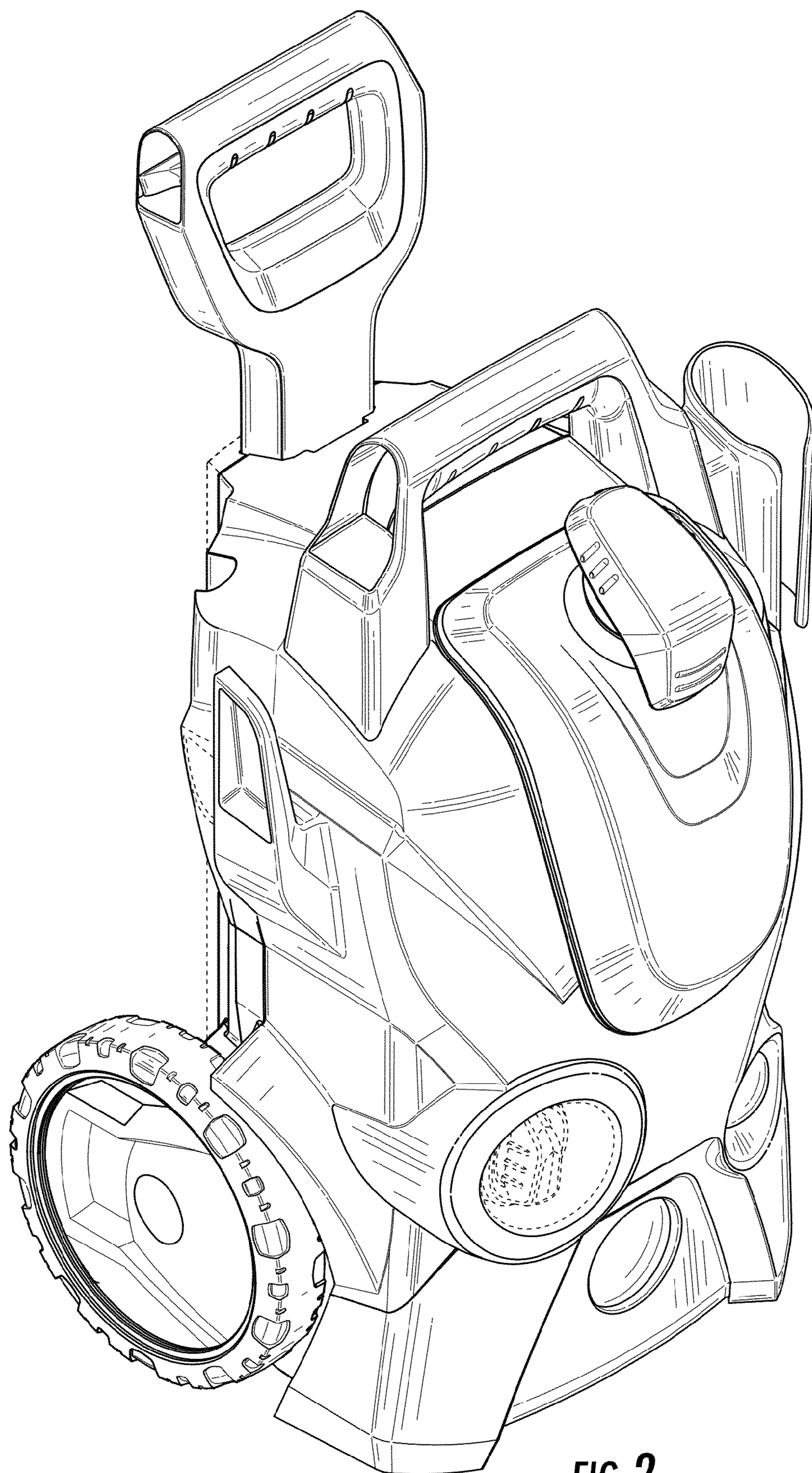

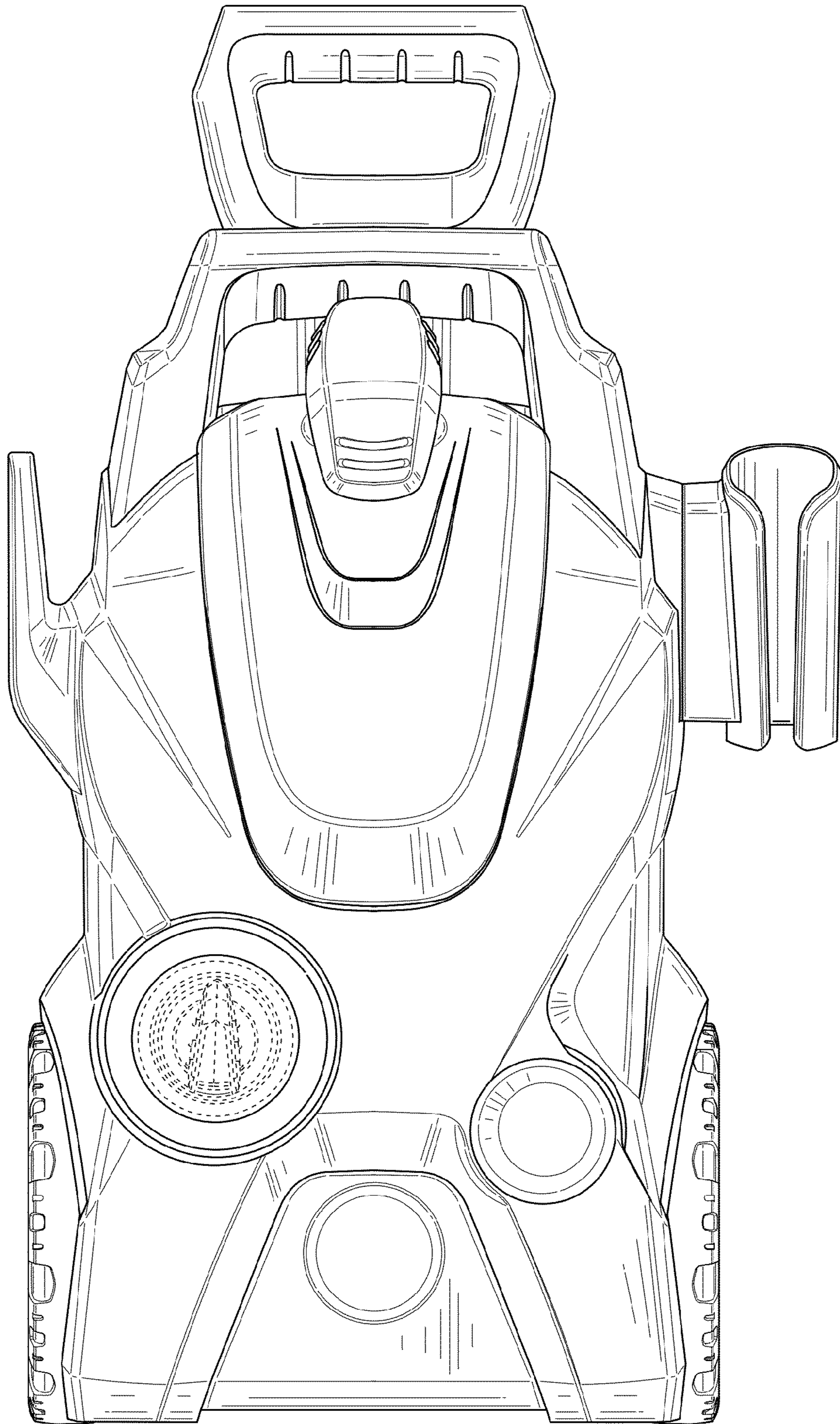

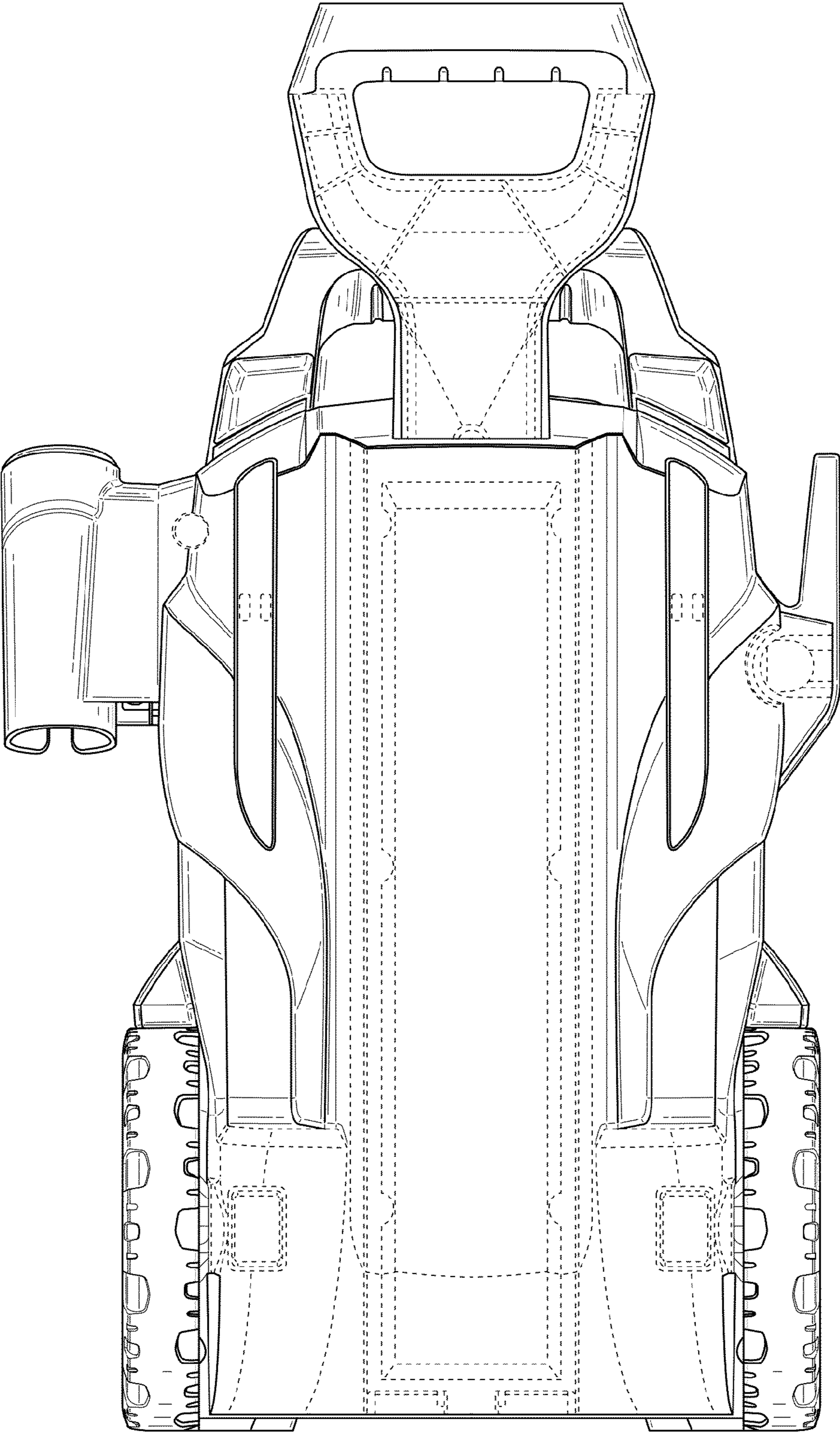

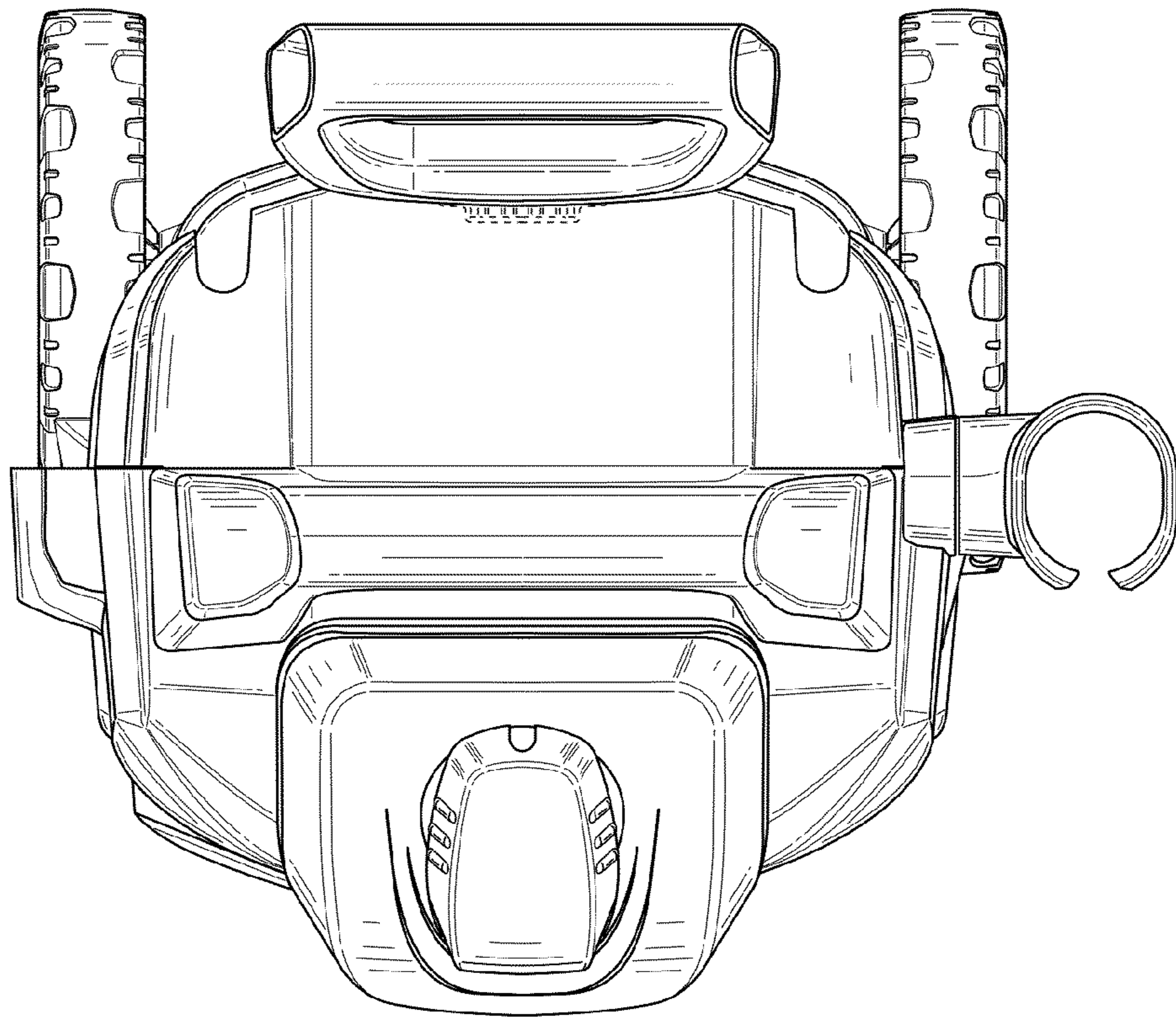
