DESCRIPTION

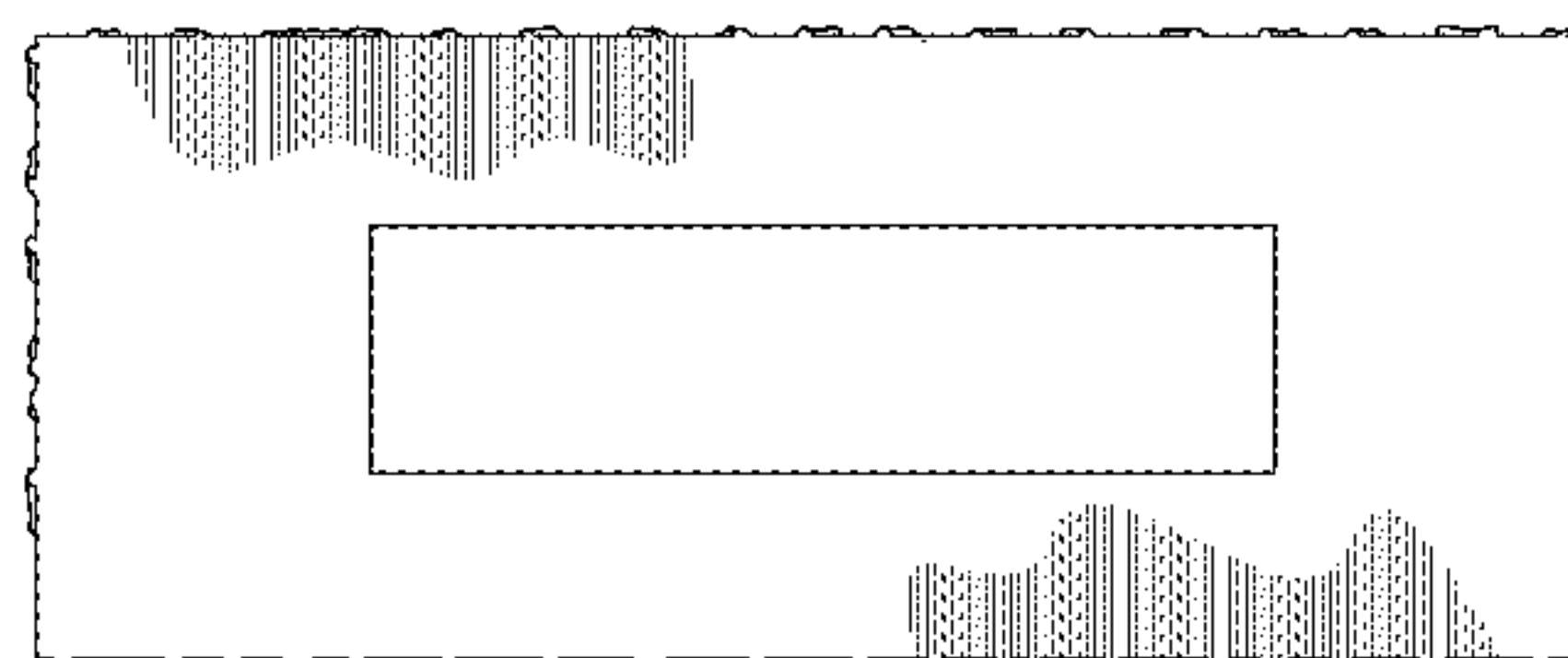
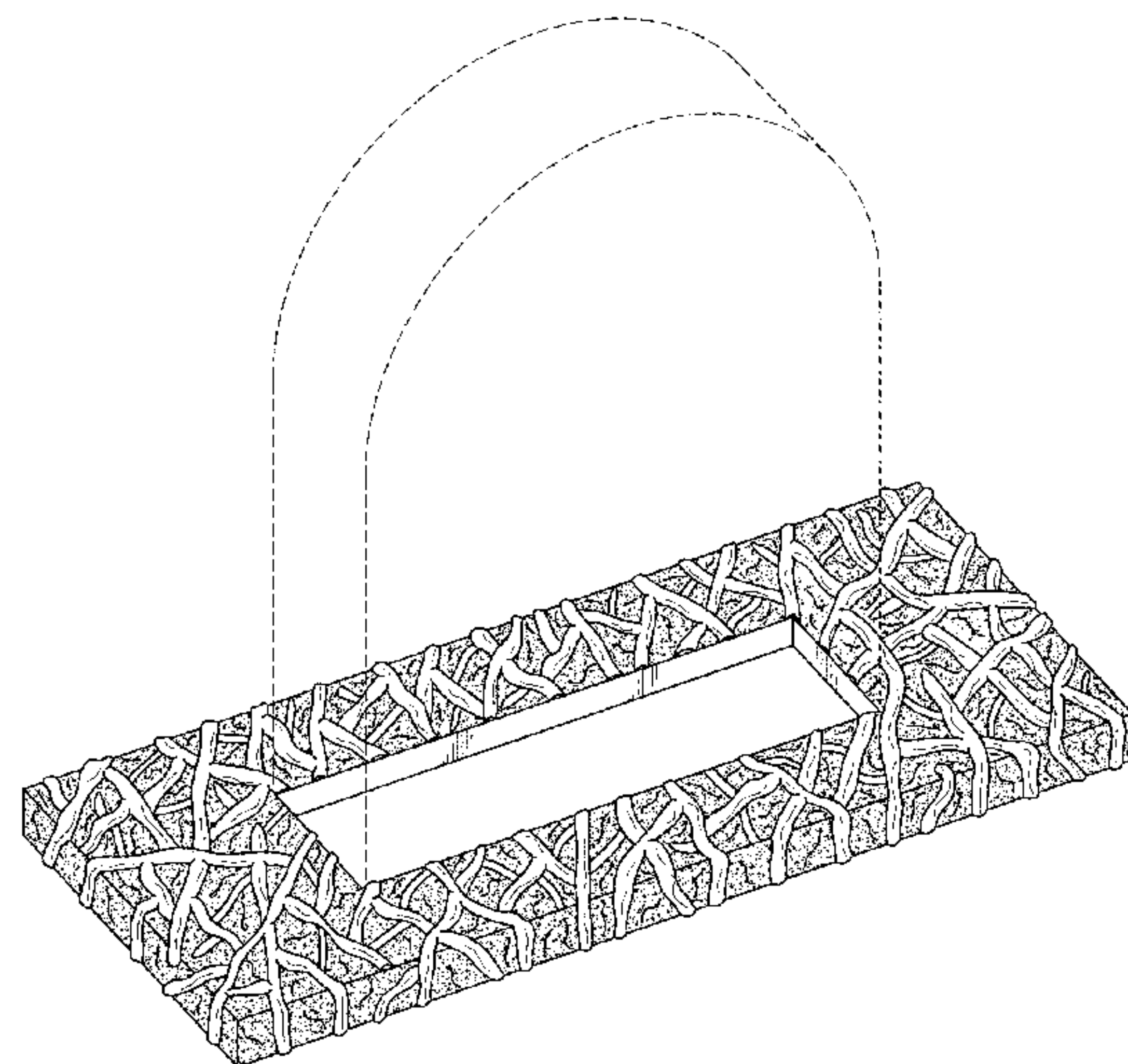
FIG. 1 is a front perspective view of our headstone border design;

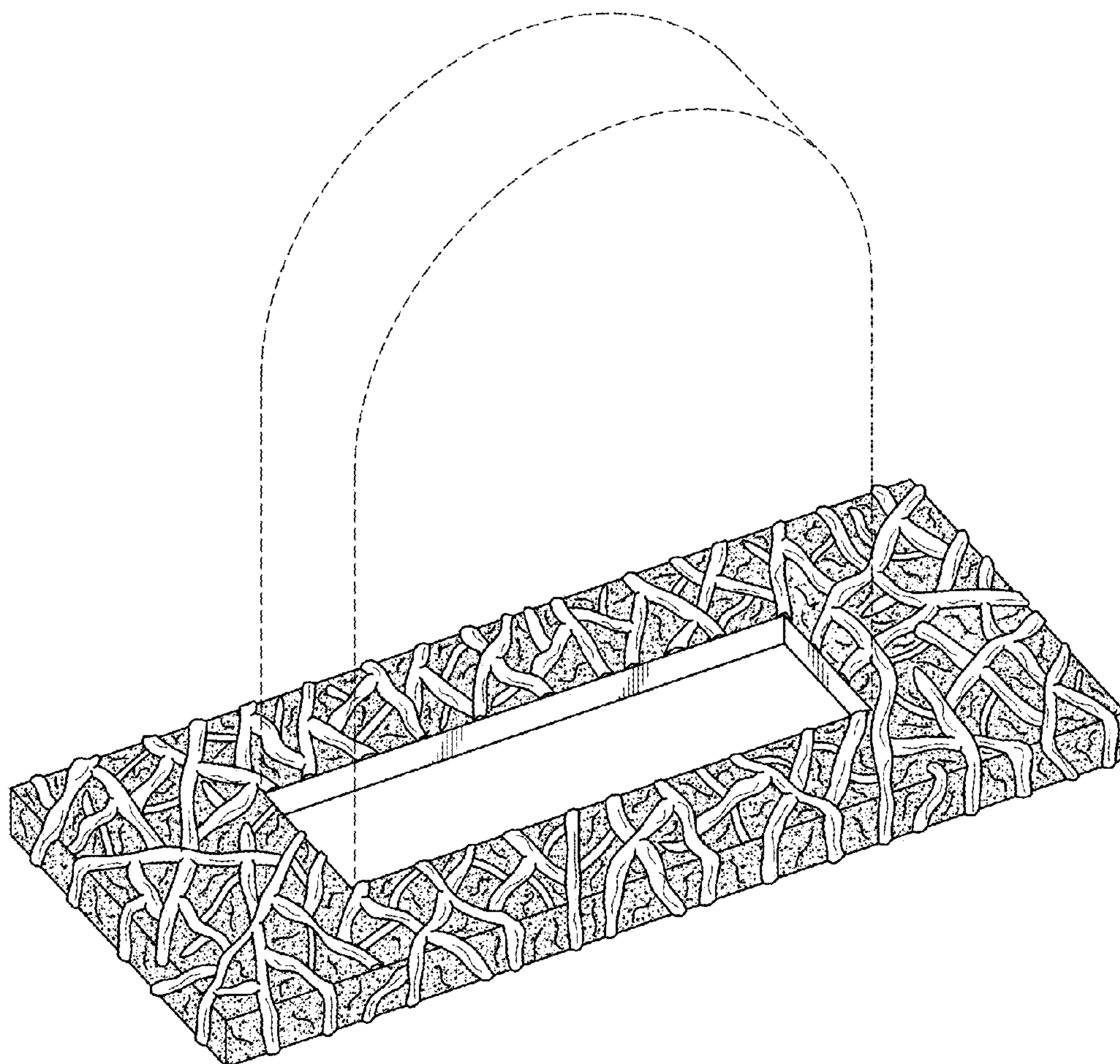

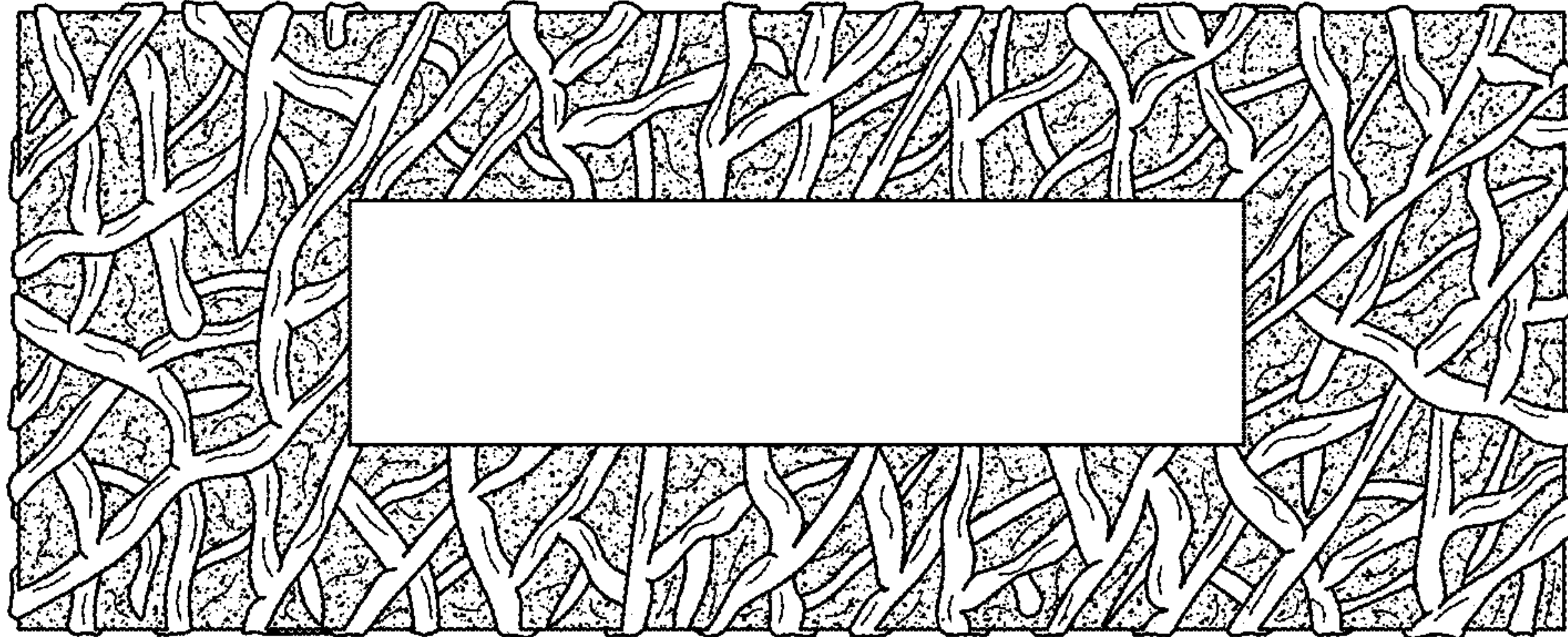

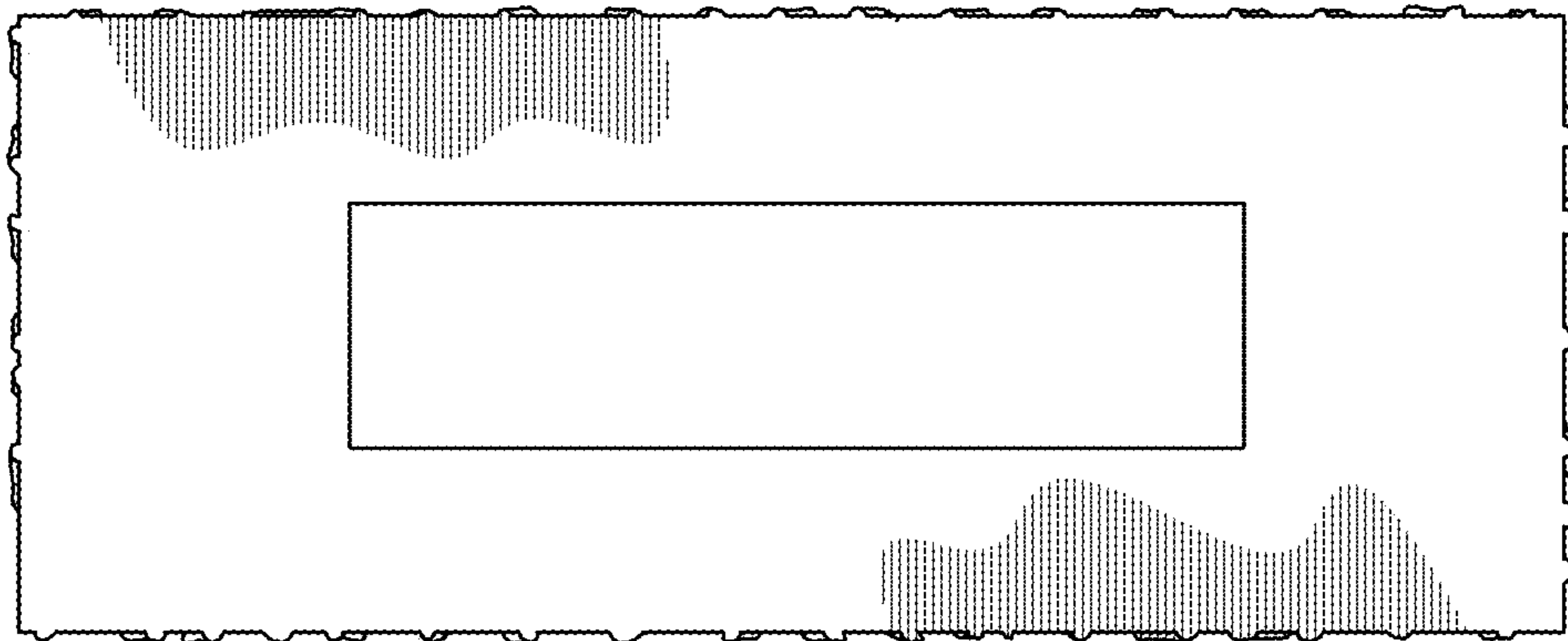
