DESCRIPTION

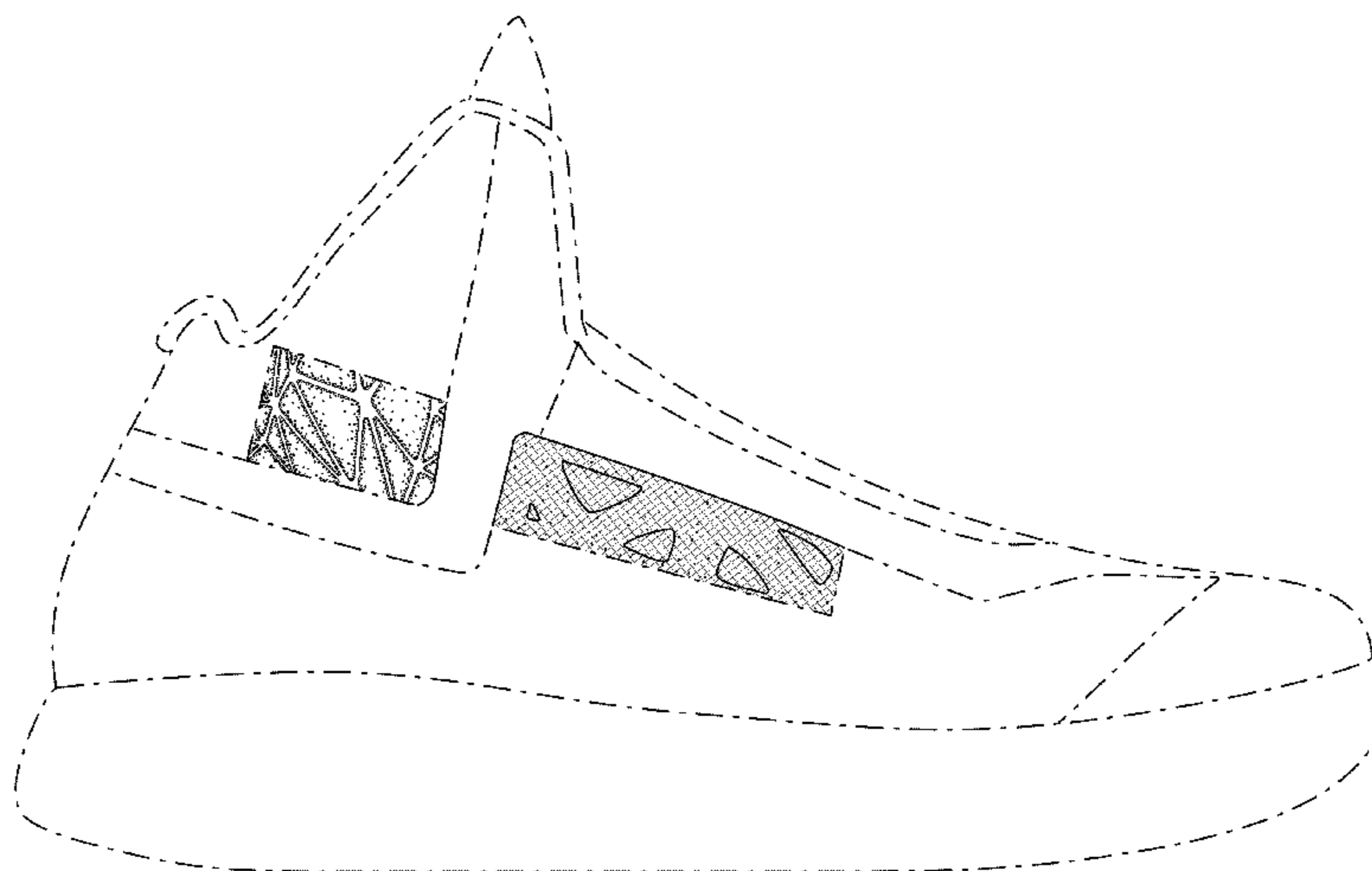

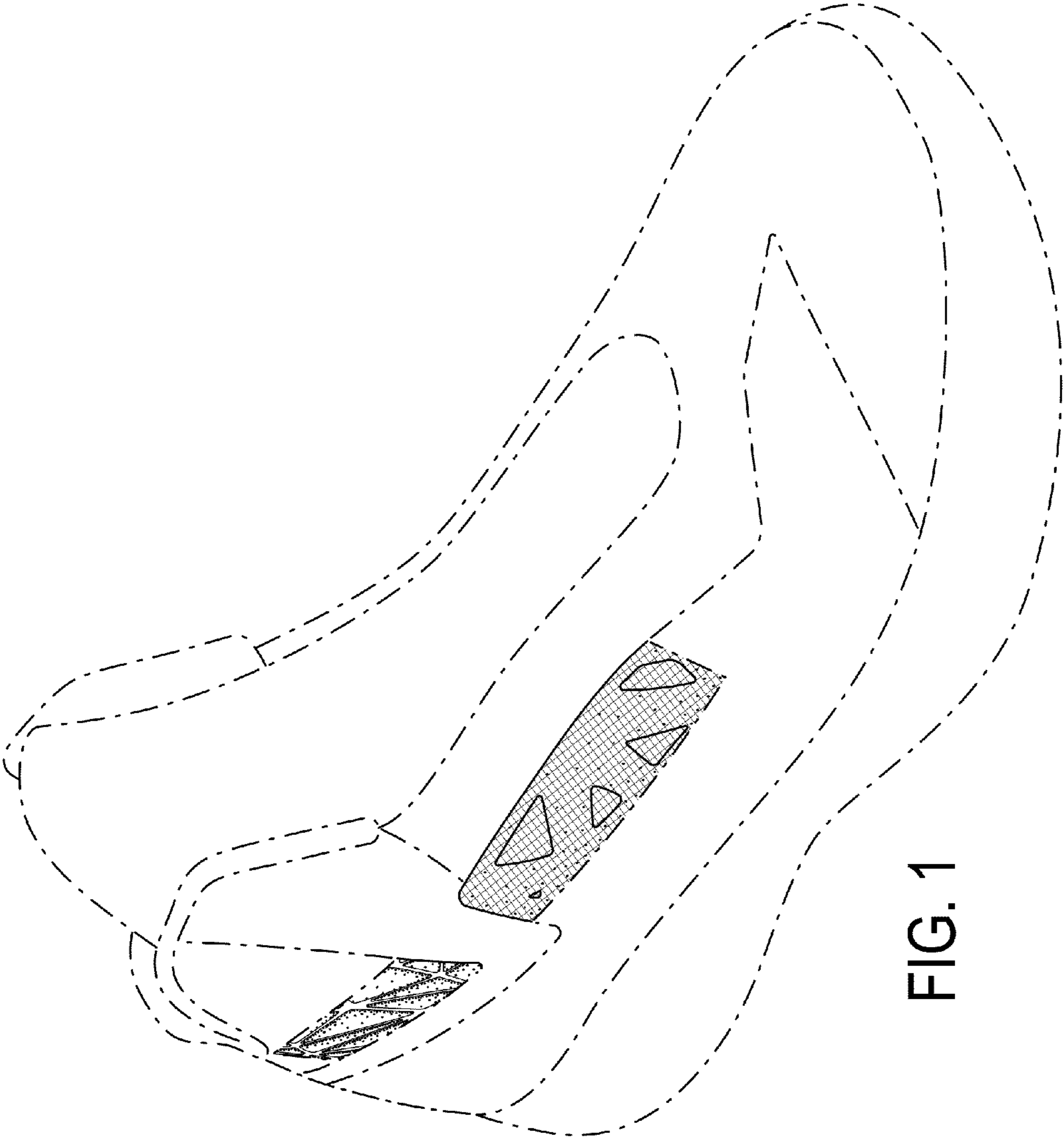

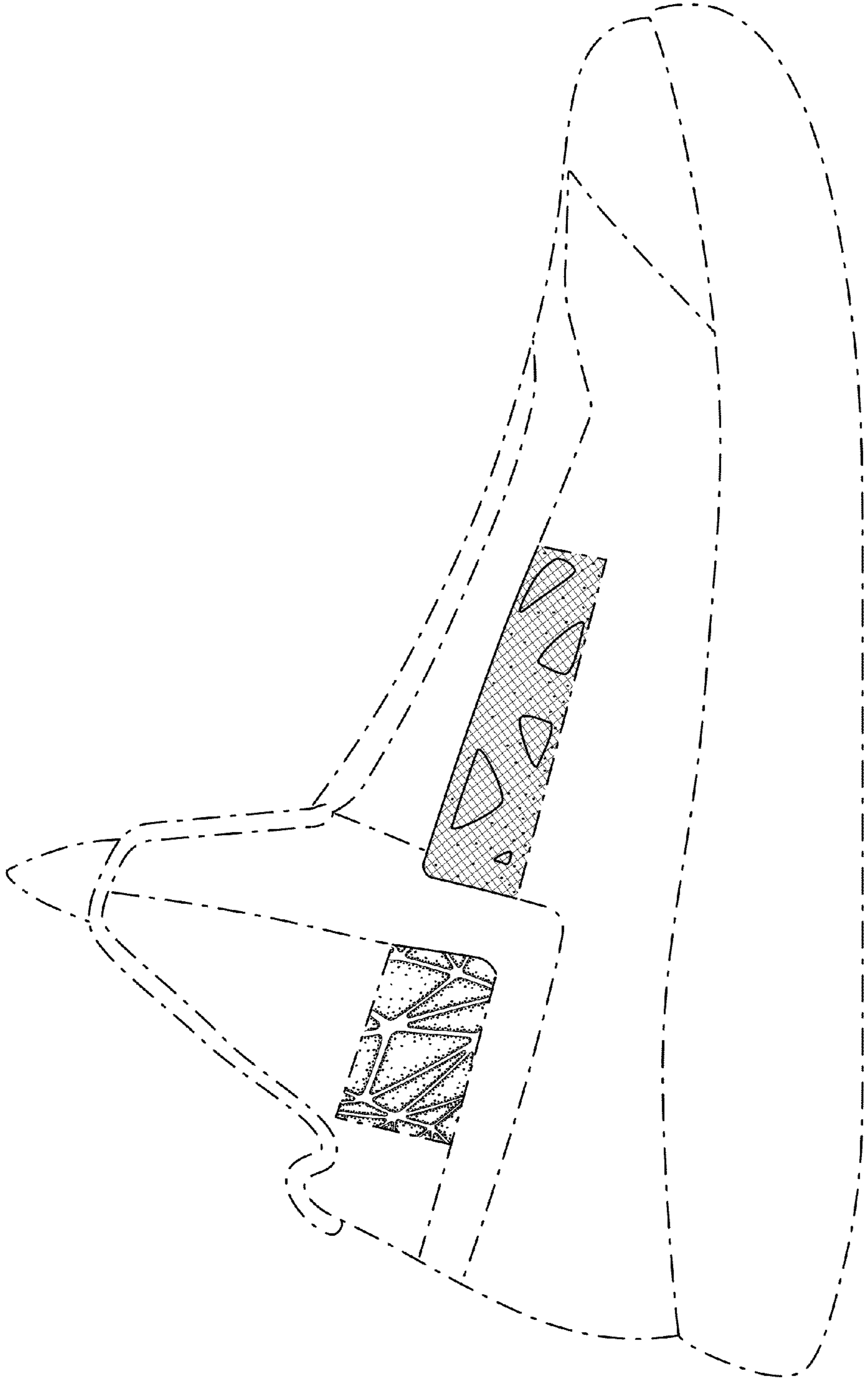

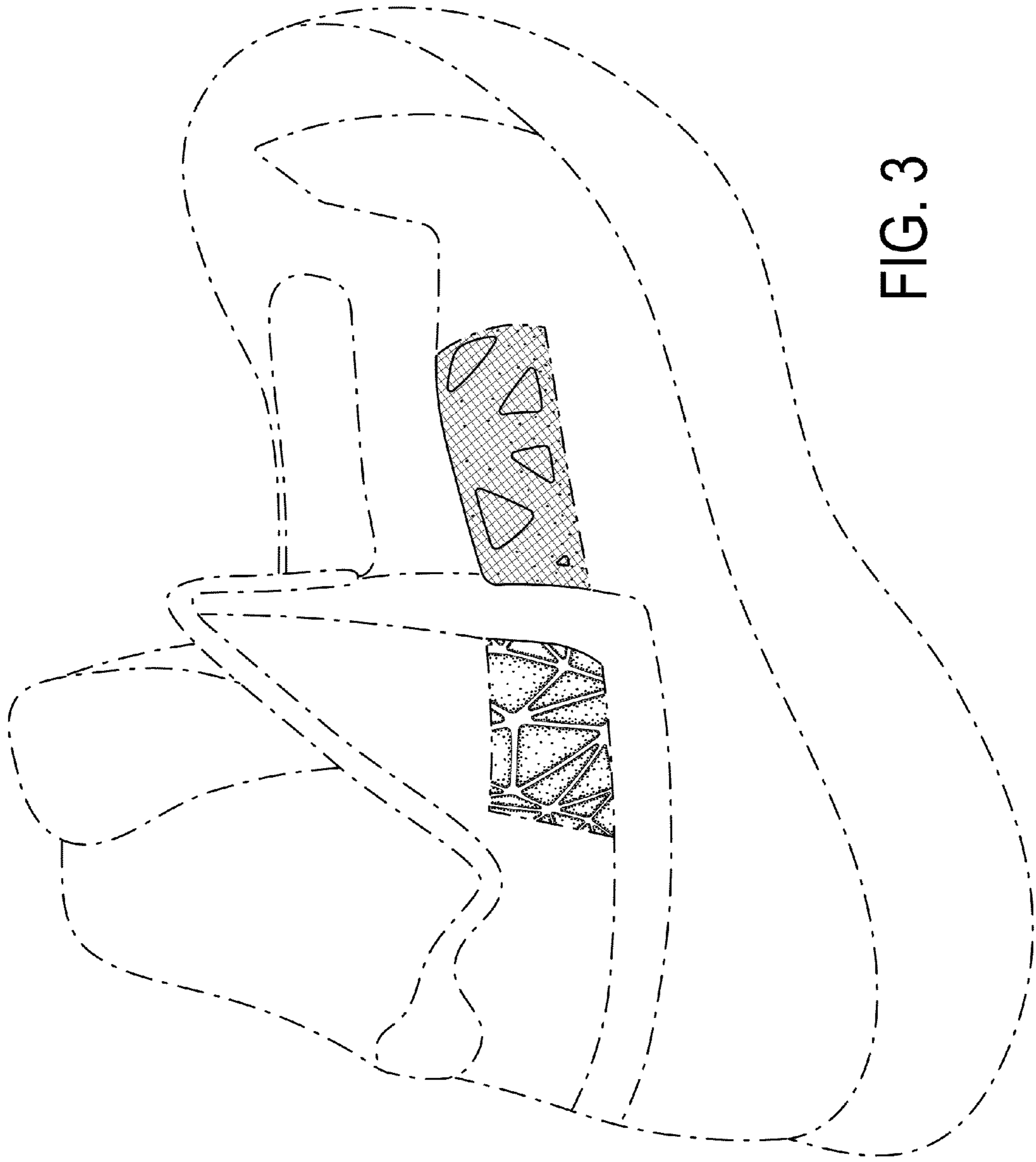
