(57) **CLAIM**

I claim the ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a photo evidencing a front view of a first embodiment of a chair, with arms, showing my design;

FIG. 2 is a photo evidencing a right side view thereof, with arms;

FIG. 3 is a photo evidencing a front right perspective view thereof, with arms;

FIG. 4 is a photo evidencing a right rear perspective view thereof, with arms;

FIG. 5 is a photo evidencing a rear view thereof, with arms;

FIG. 6 is a photo evidencing a left side view thereof, with arms;

FIG. 7 is a photo evidencing a front left perspective view thereof, with arms.

FIG. 8 is a photo evidencing a left rear perspective view thereof, with arms.

FIG. 9 is a photo evidencing a front view of a second embodiment, without arms.

FIG. 10 is a photo evidencing a right side view thereof, without arms;

FIG. 11 is a photo evidencing a front right perspective view thereof, without arms;

FIG. 12 is a photo evidencing a right rear perspective view thereof, without arms;

FIG. 13 is a photo evidencing a rear view thereof, without arms;

FIG. 14 is a photo evidencing a left side view thereof, without arms;

FIG. 15 is a photo evidencing a front left perspective view thereof, without arms; and,

FIG. 16 is a photo evidencing a left rear perspective view thereof, without arms.
