DESCRIPTION

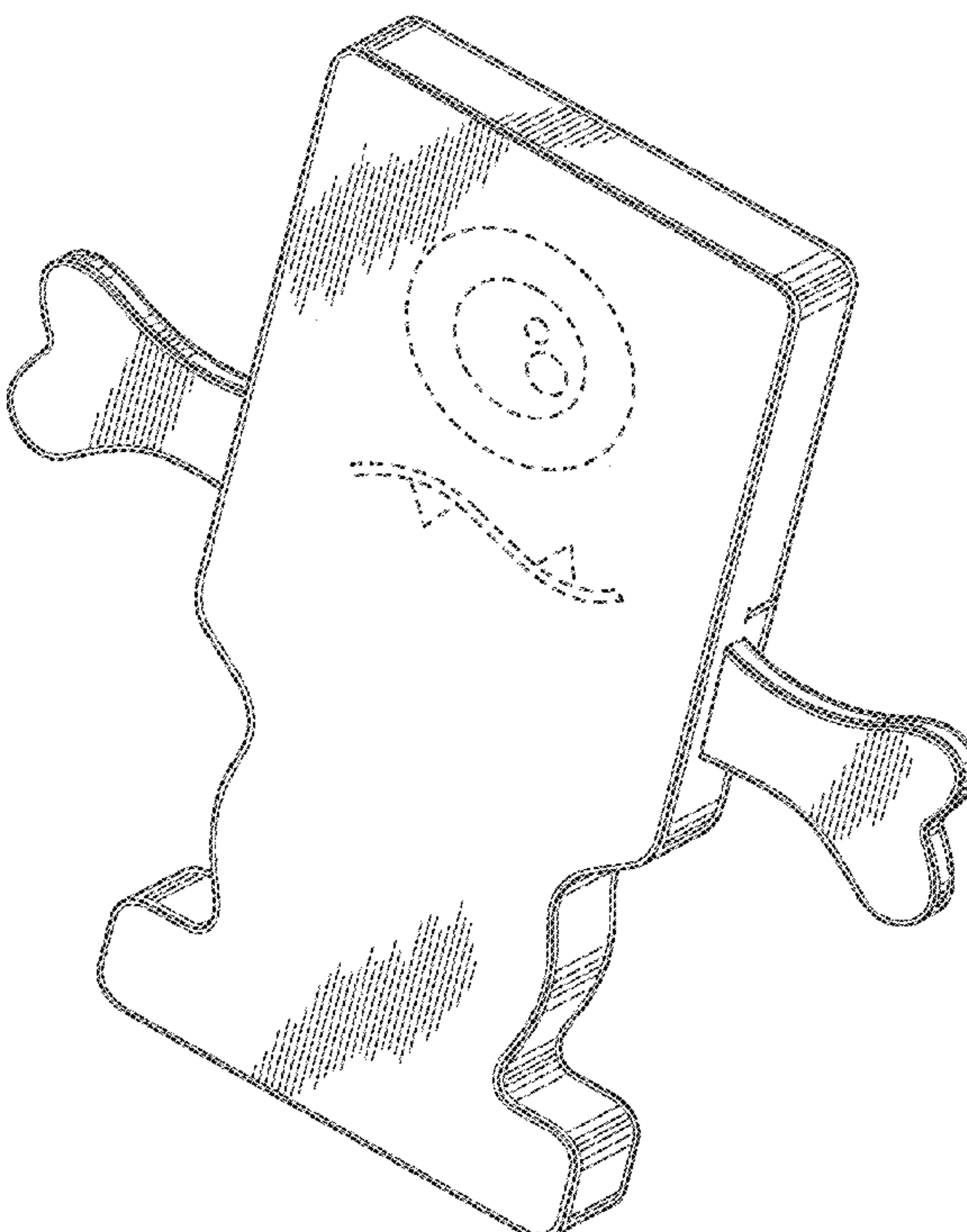
FIG. 1 is a front perspective view illustrating my design for a monster body pillow;

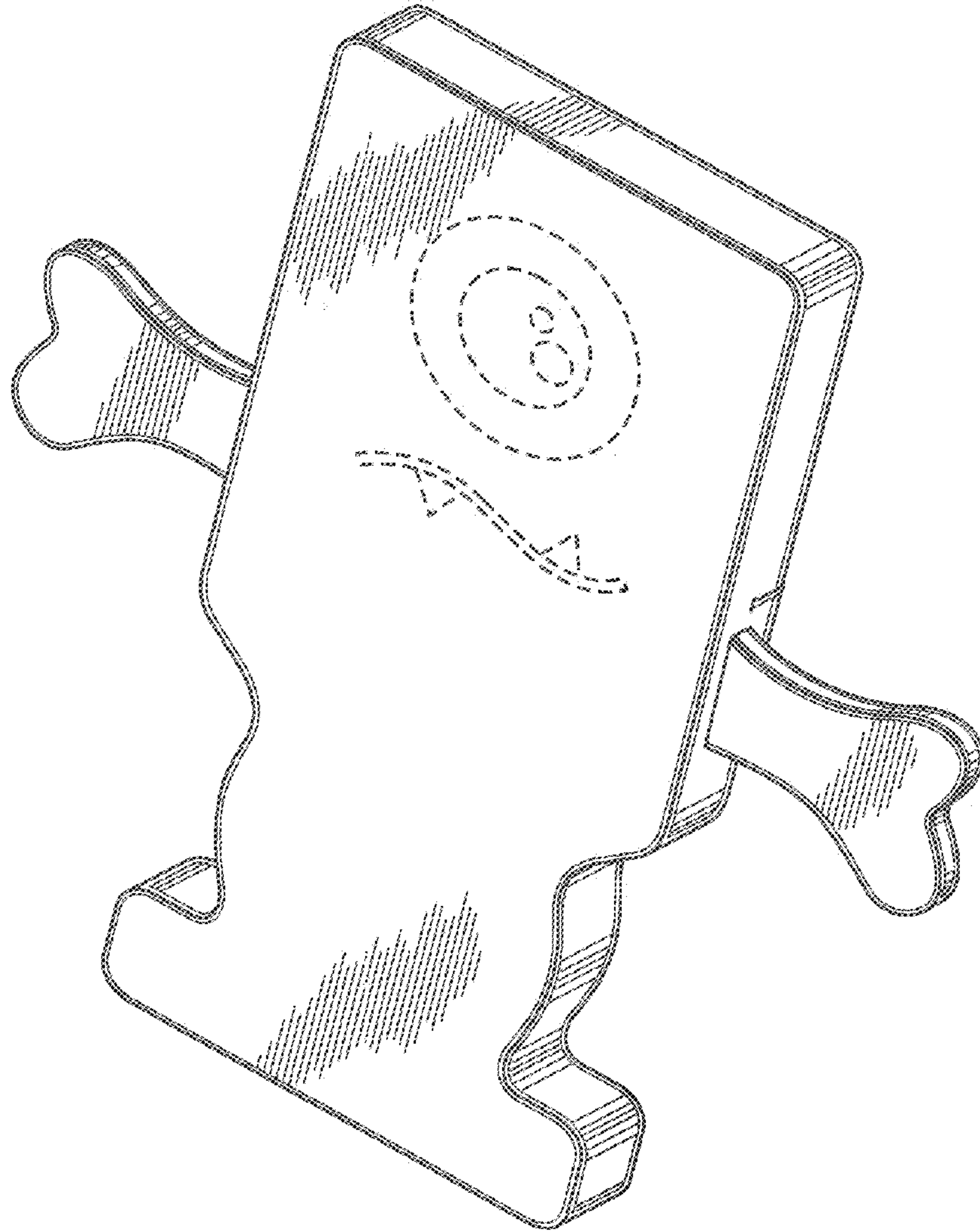

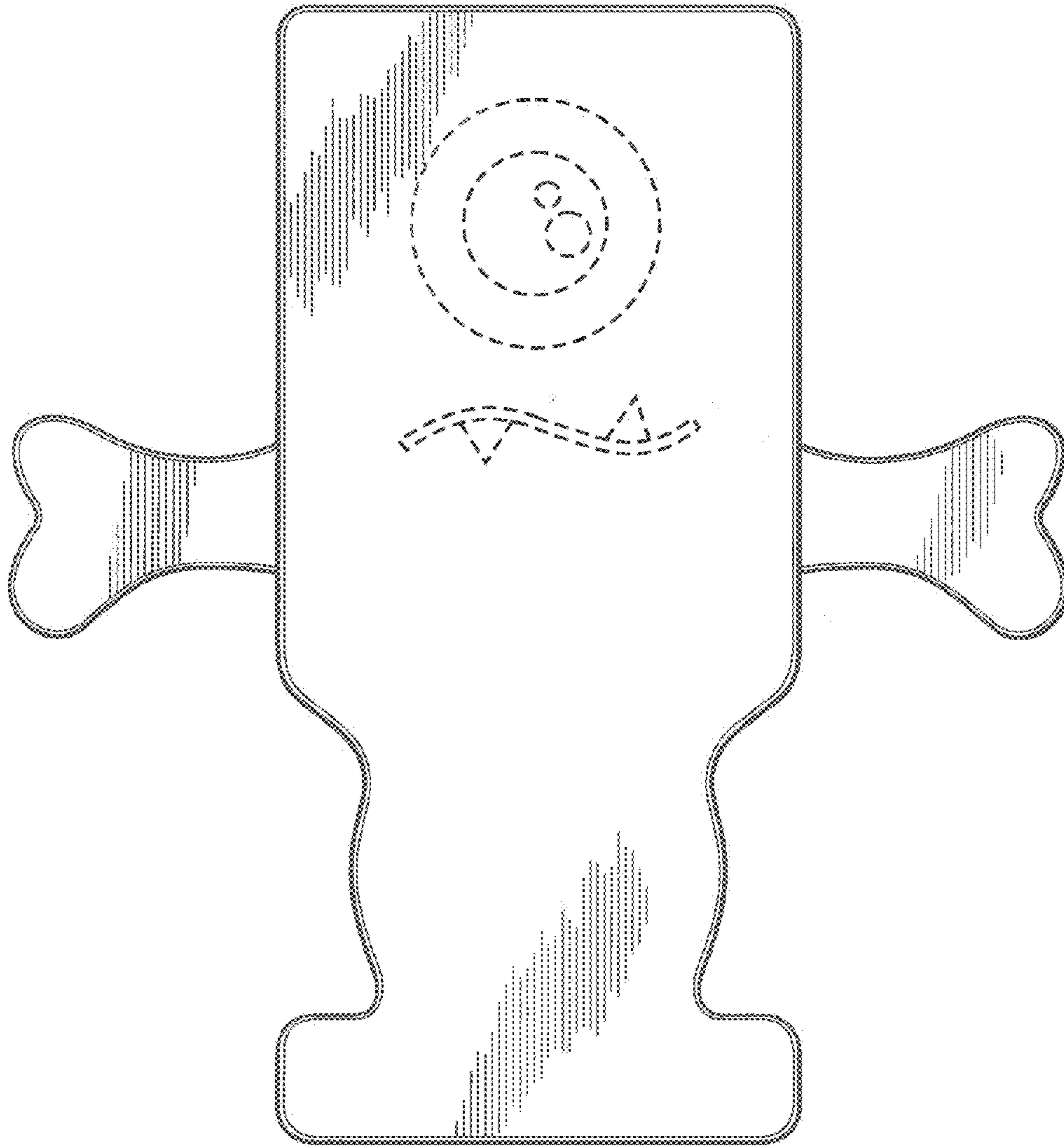

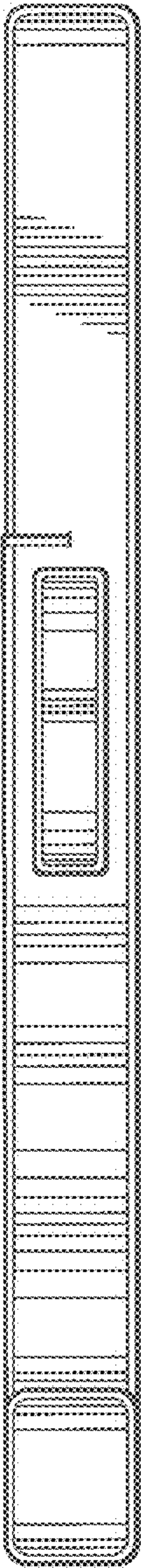

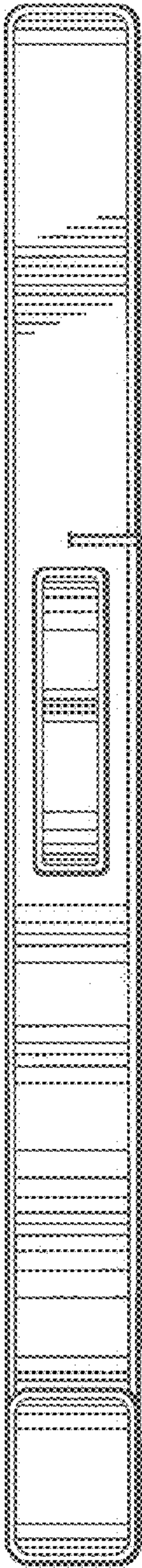

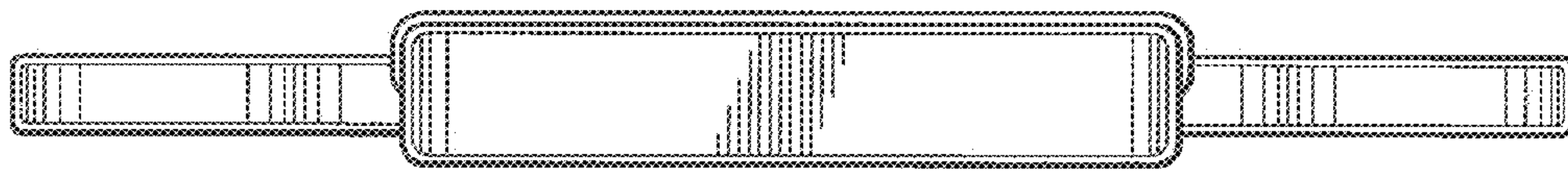

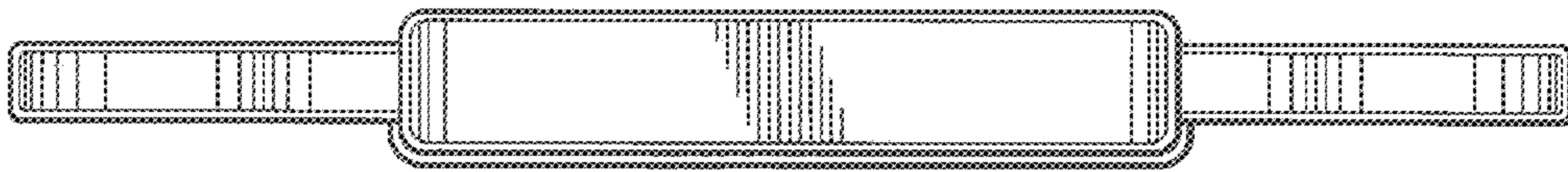

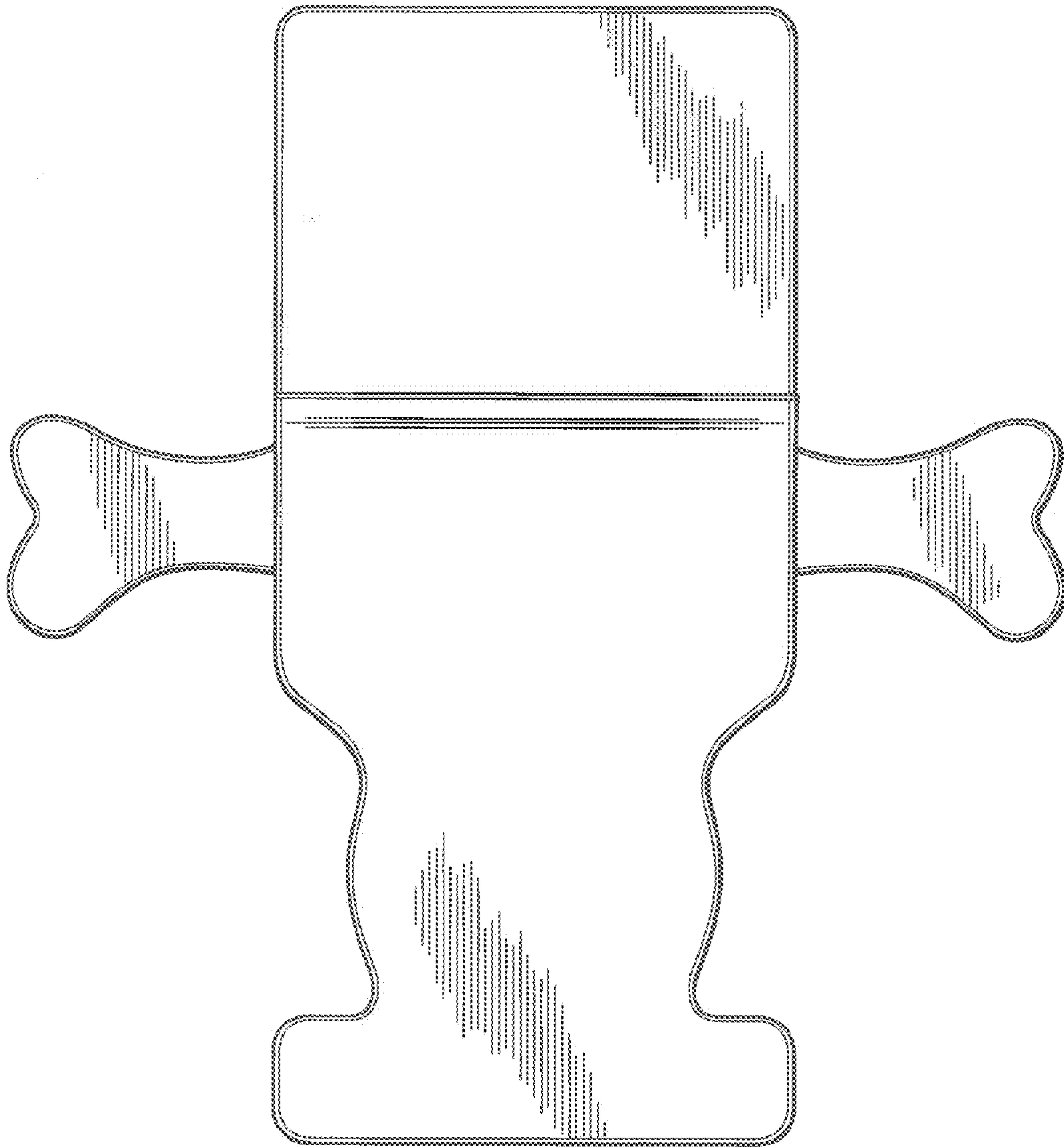

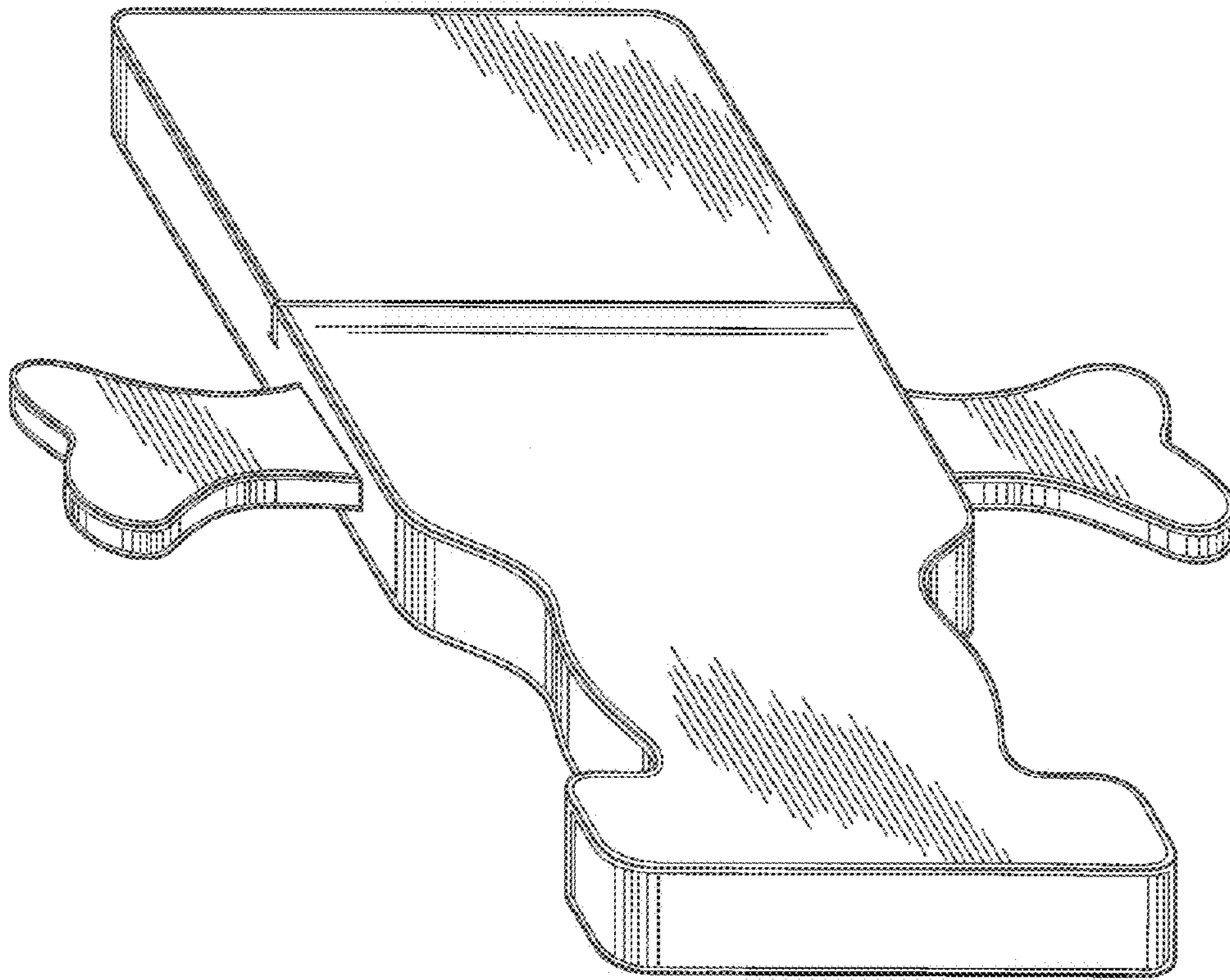

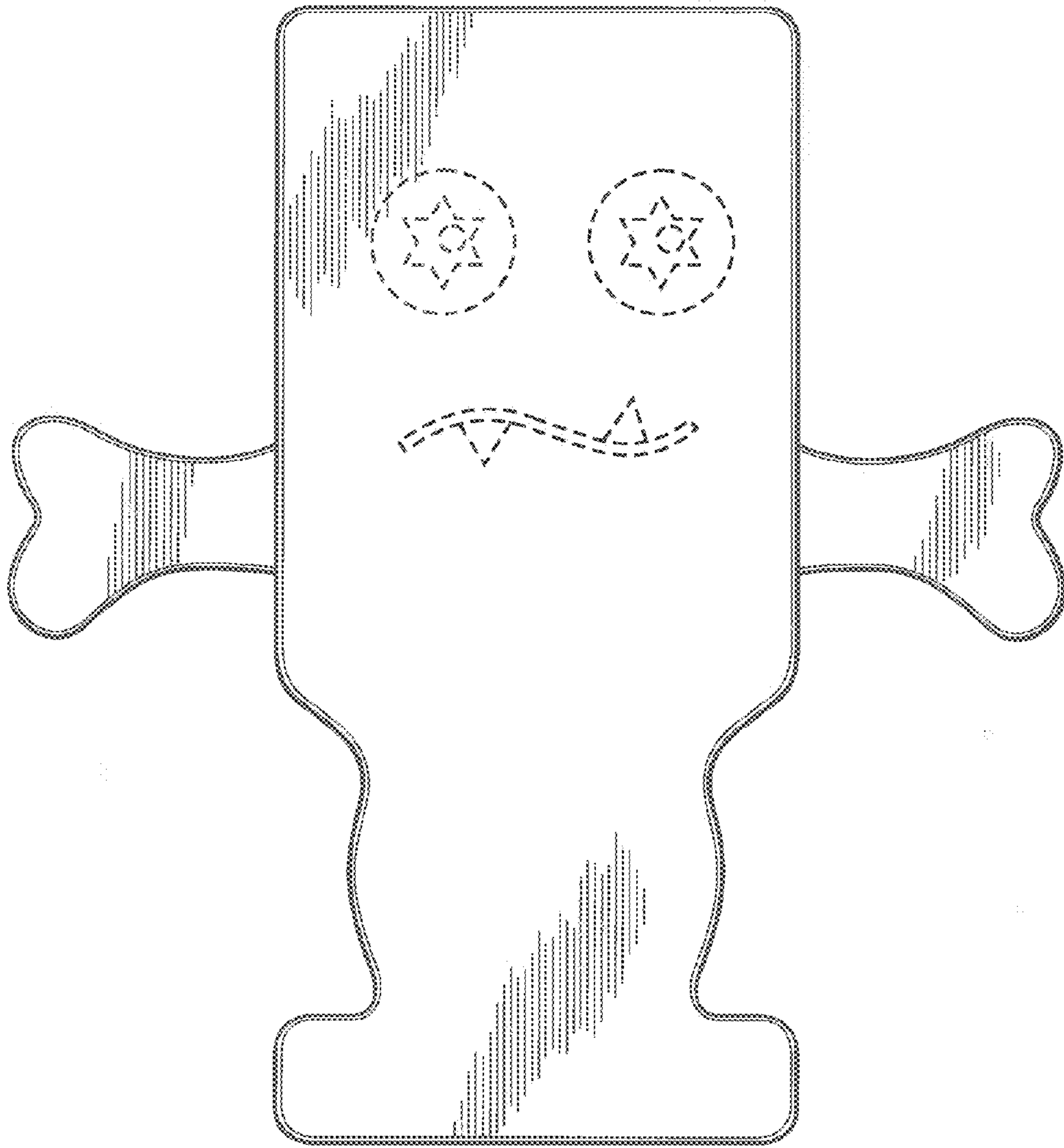

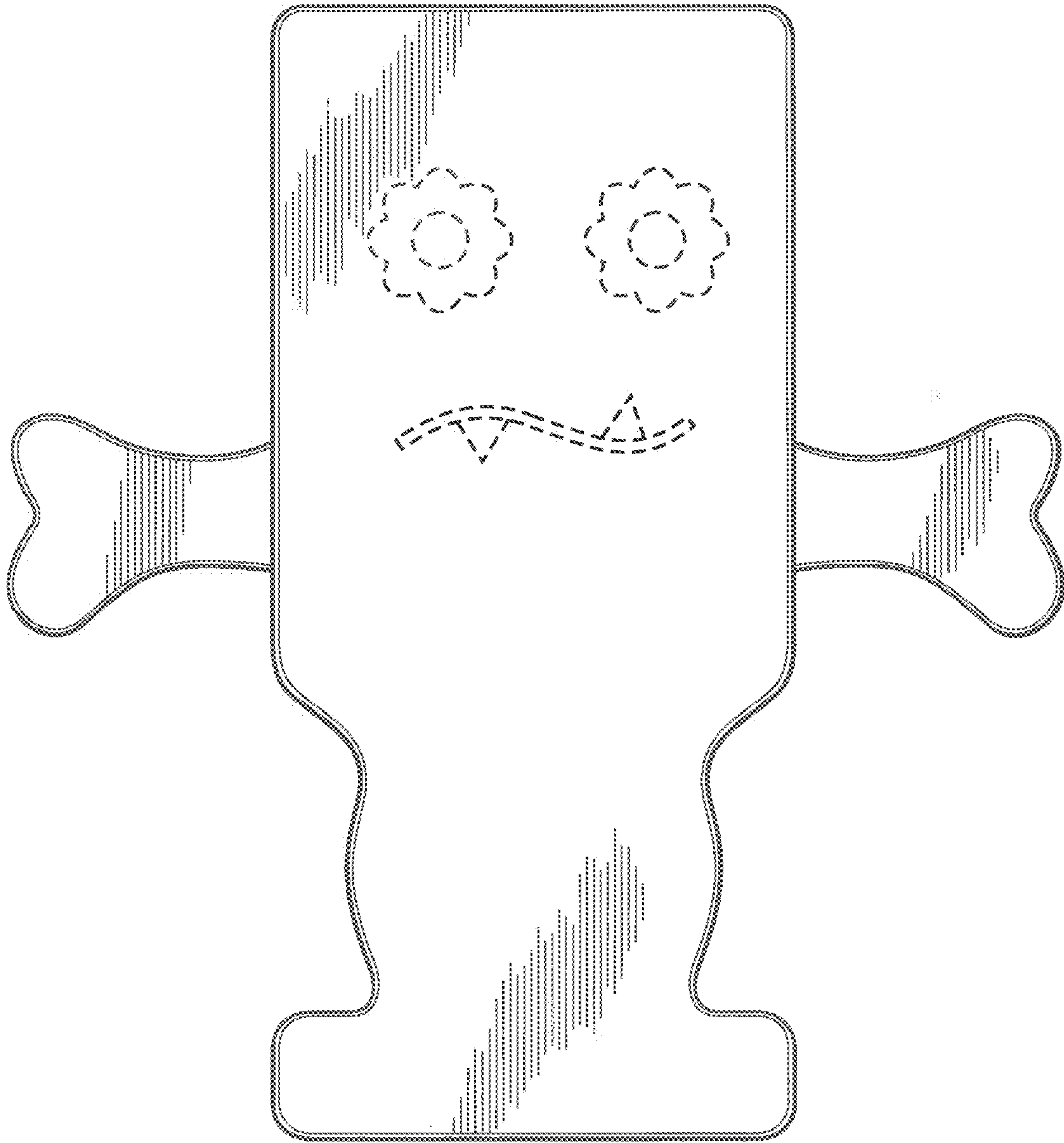

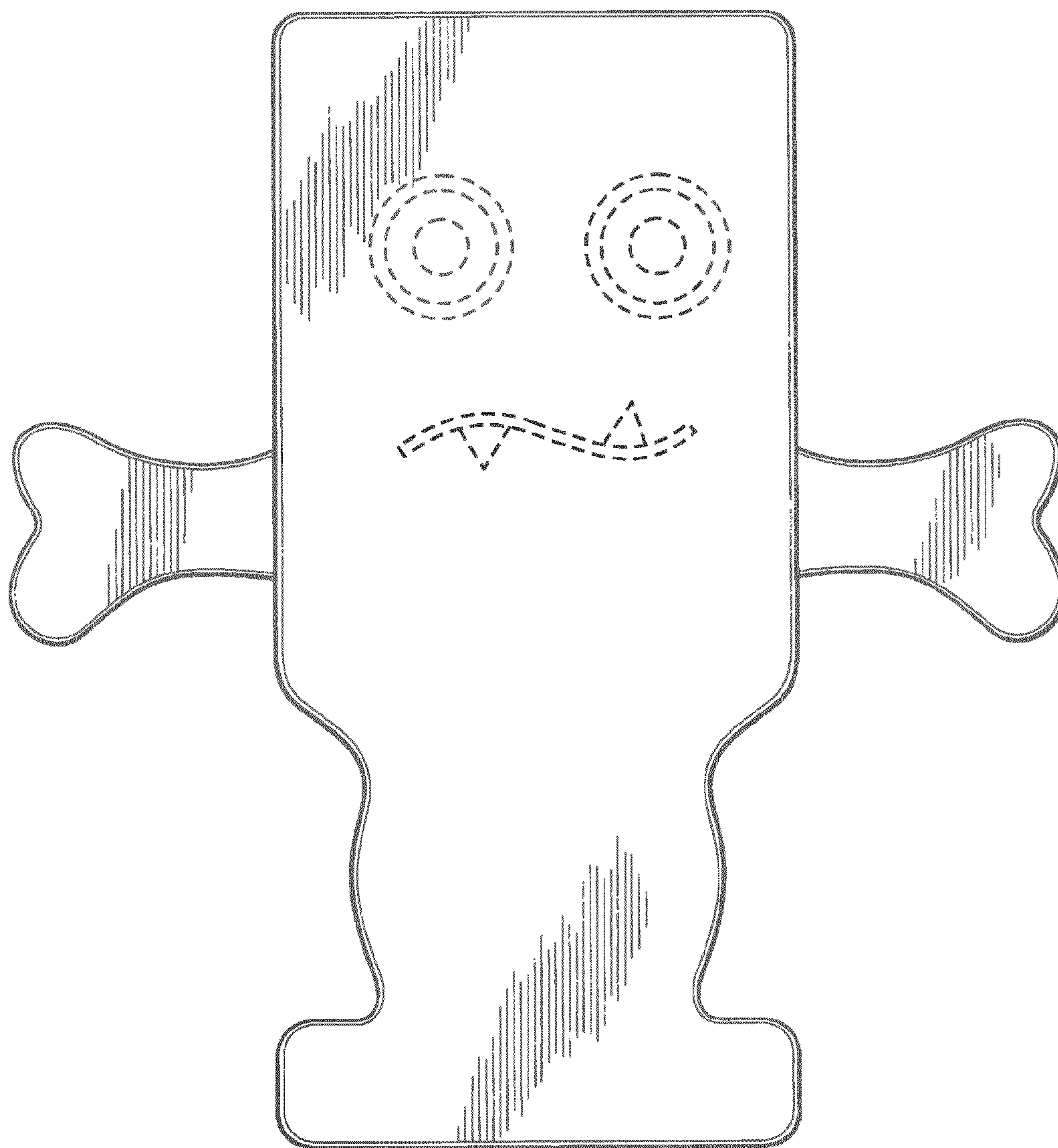

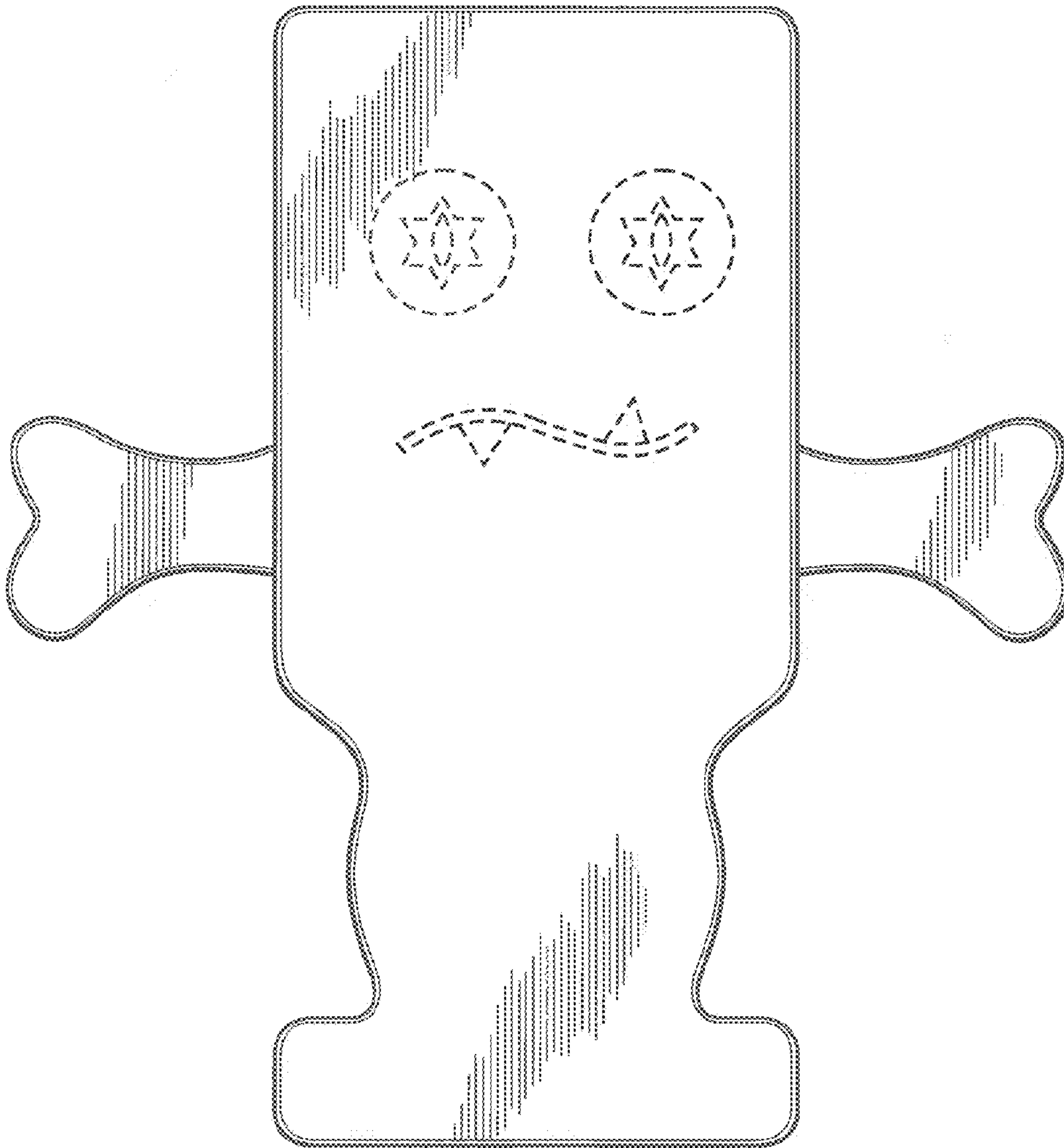

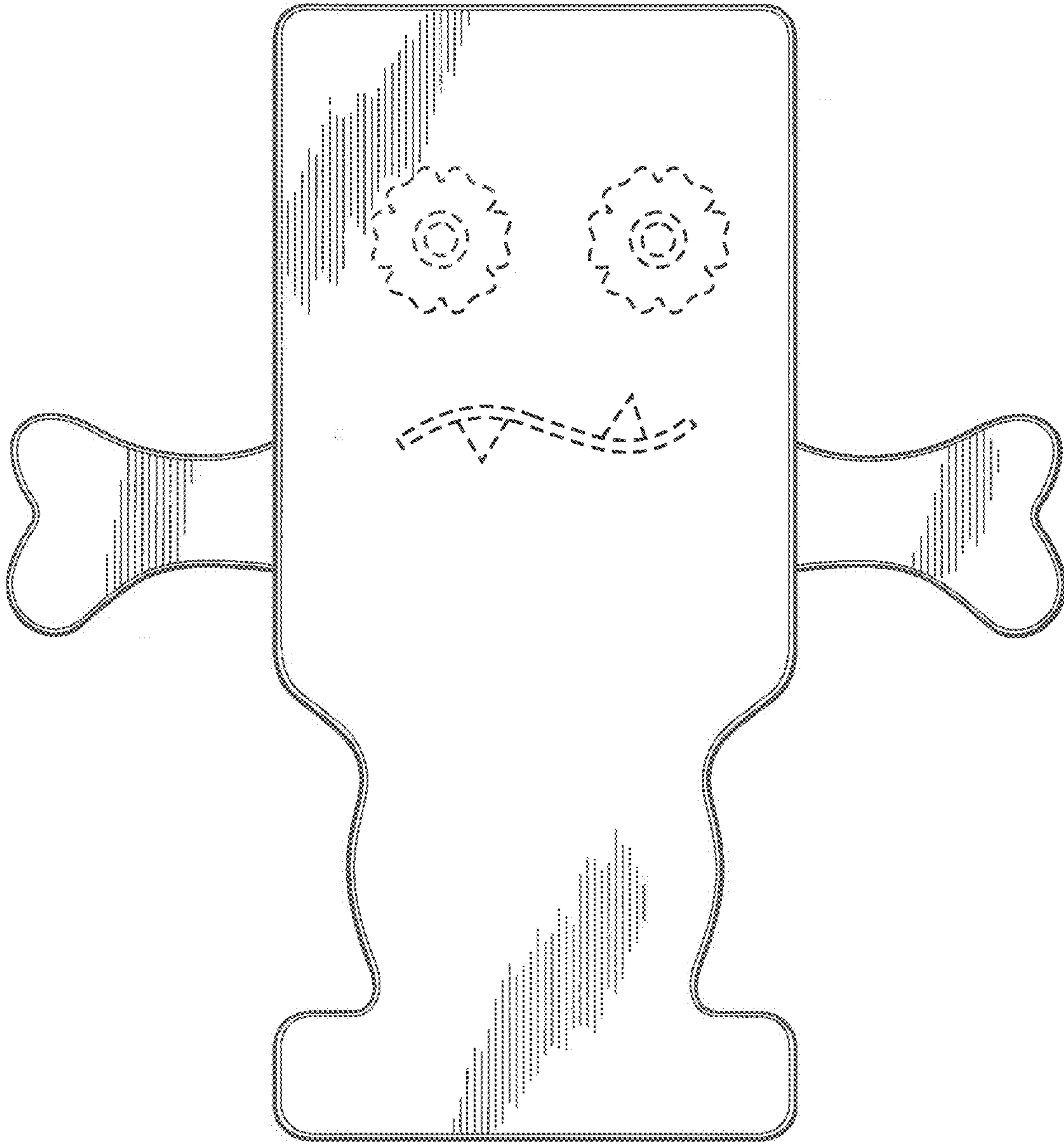
