The ornamental design for a stadium/arena seat cover, as shown and described.

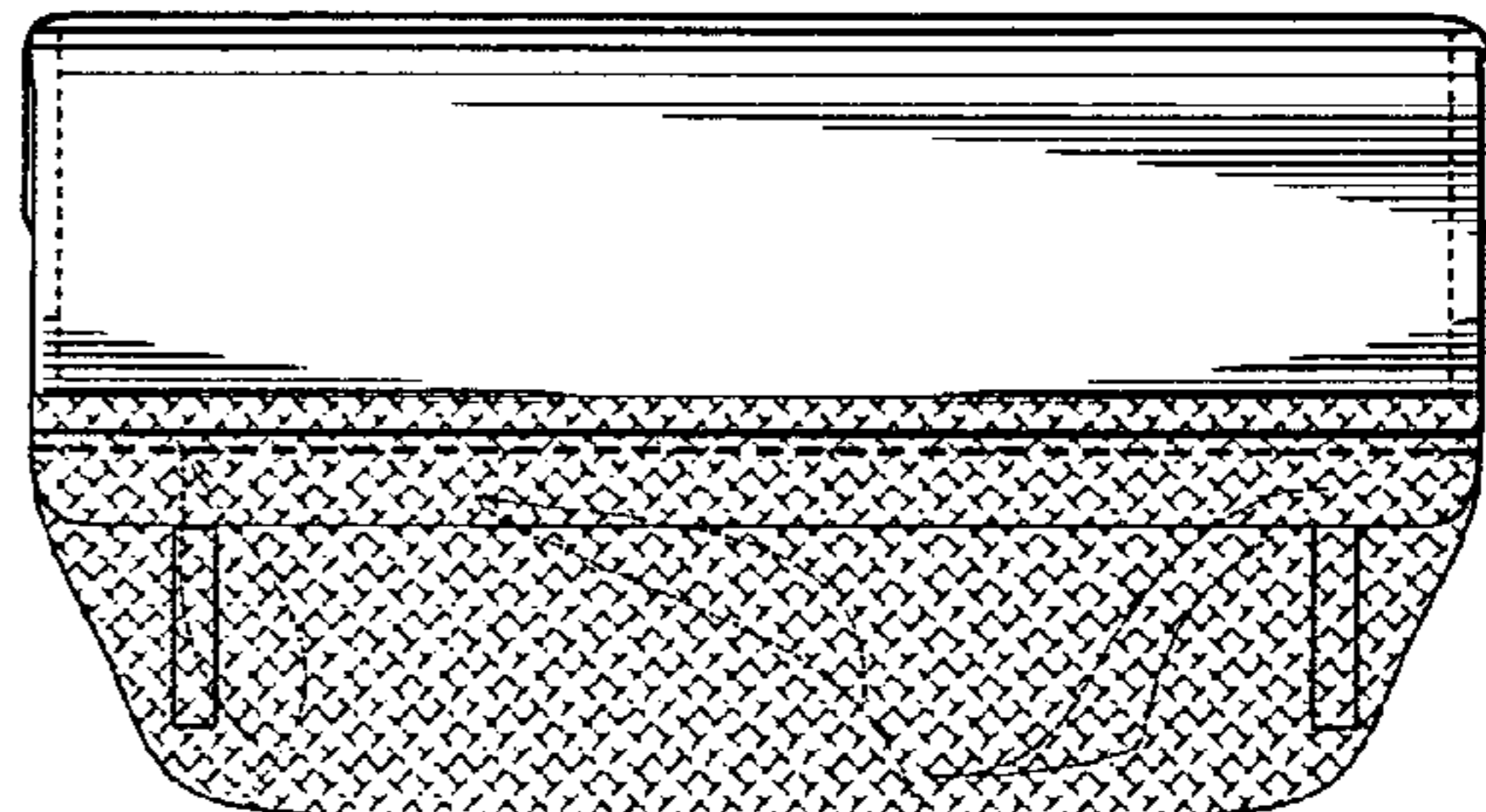
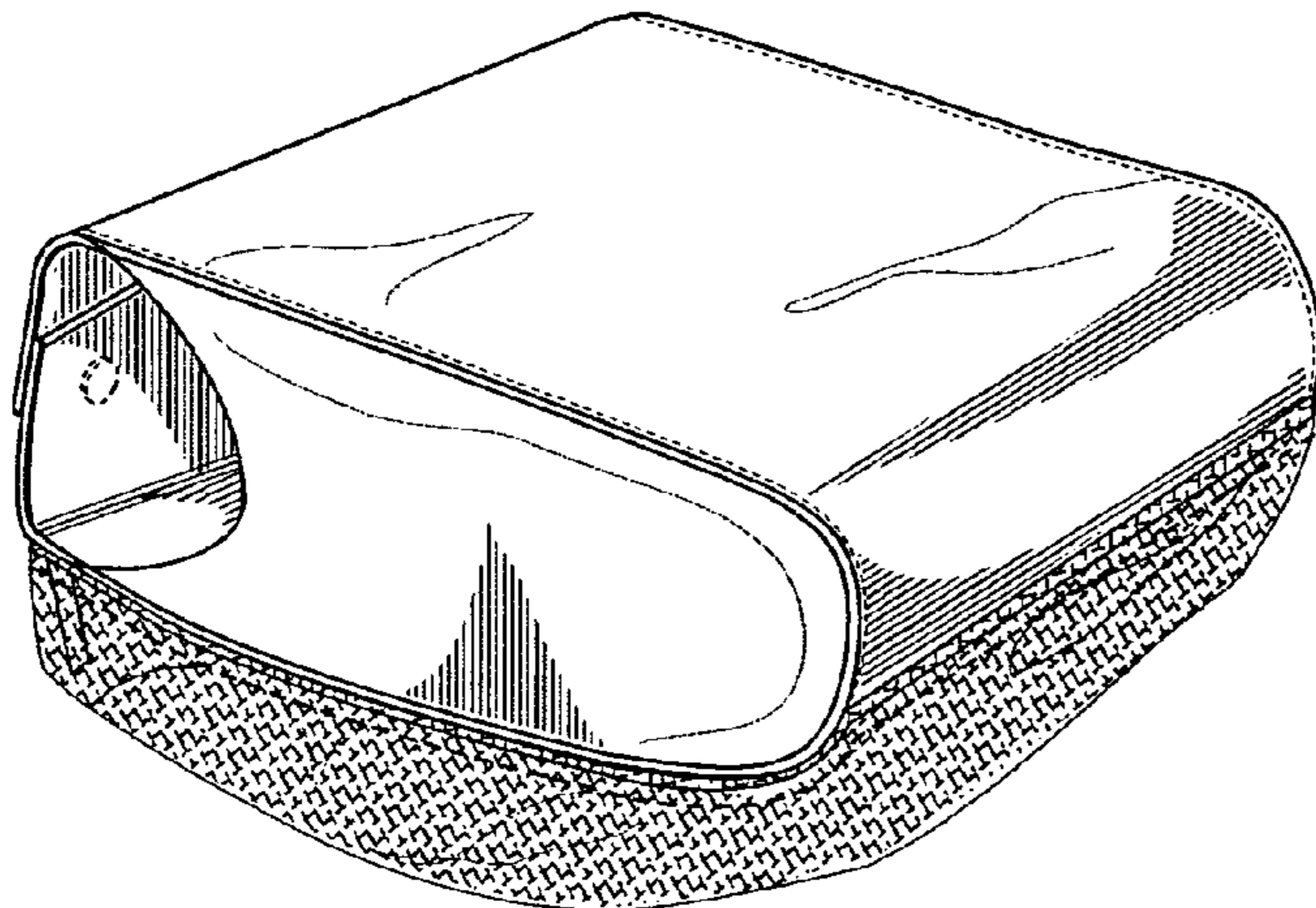
**DESCRIPTION**

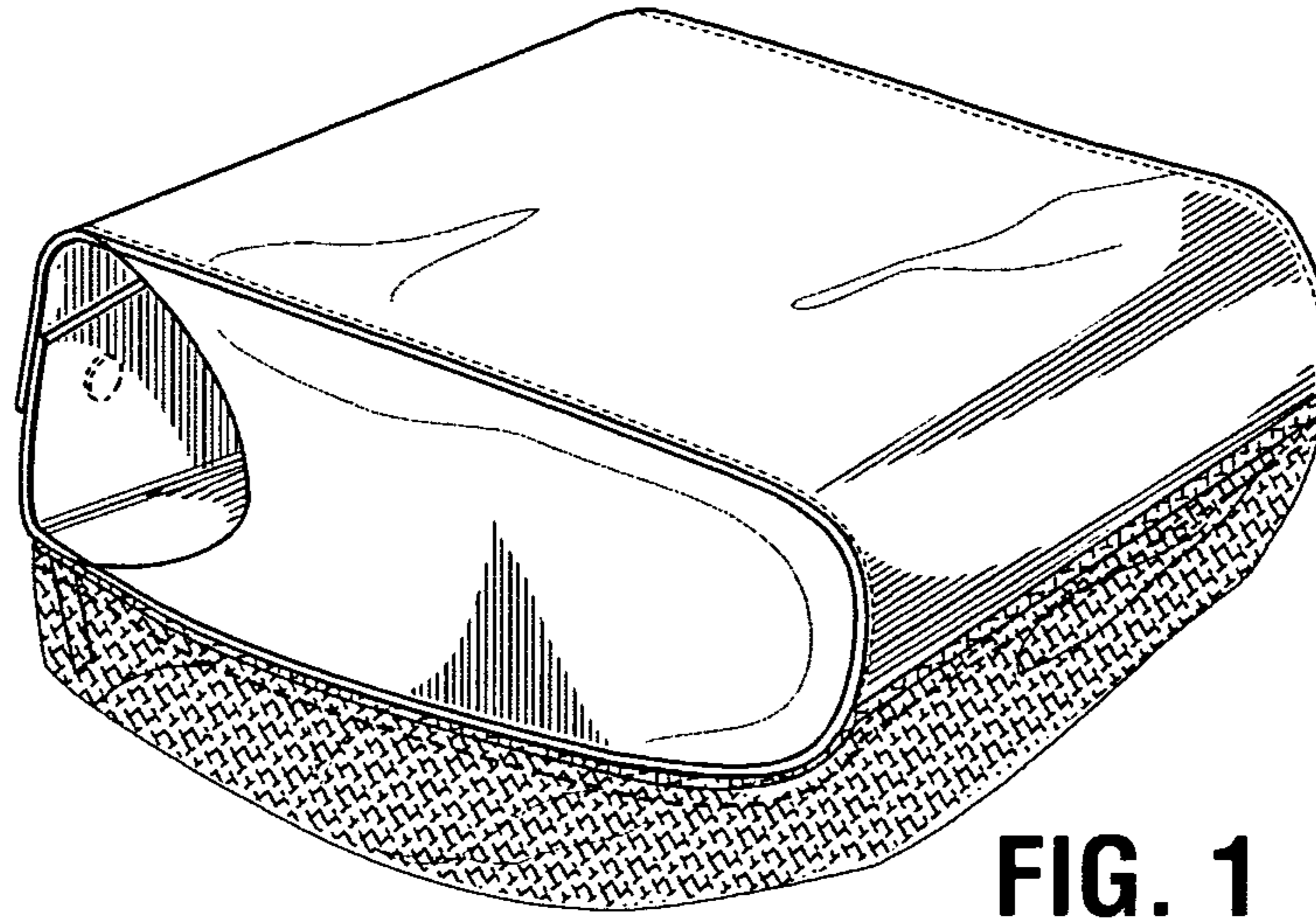
FIG. 1 is a perspective view of the stadium/arena seat cover showing my new design;

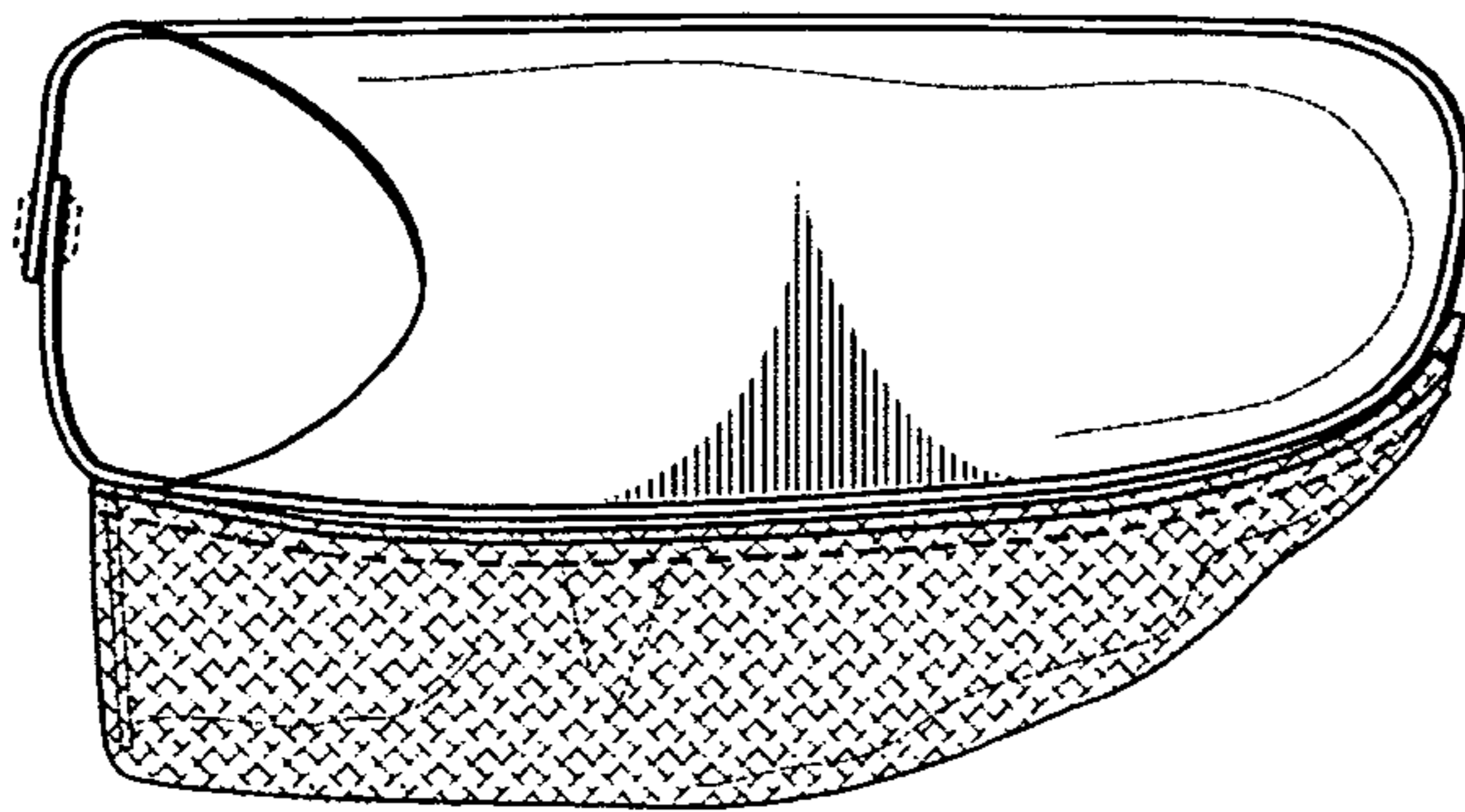

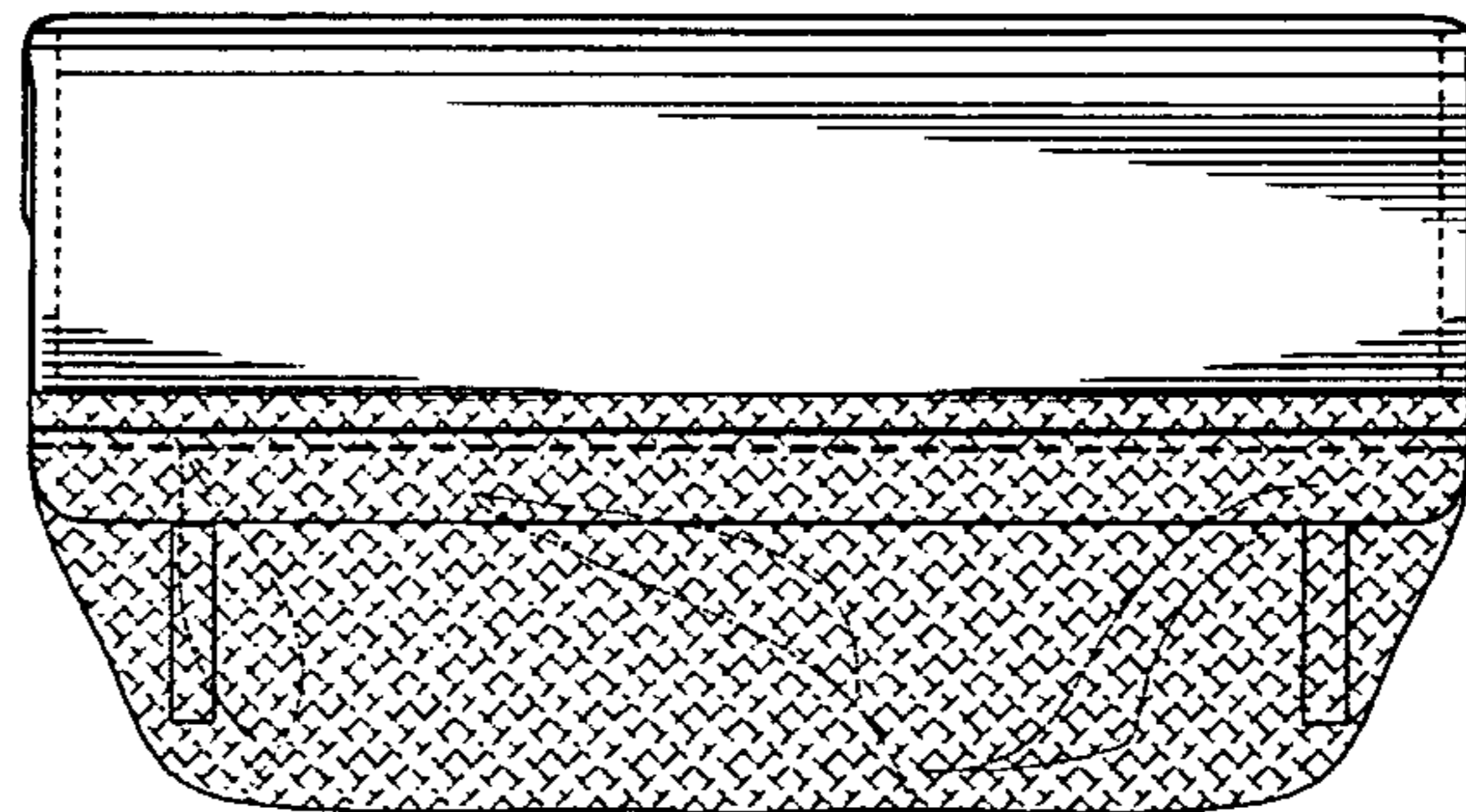




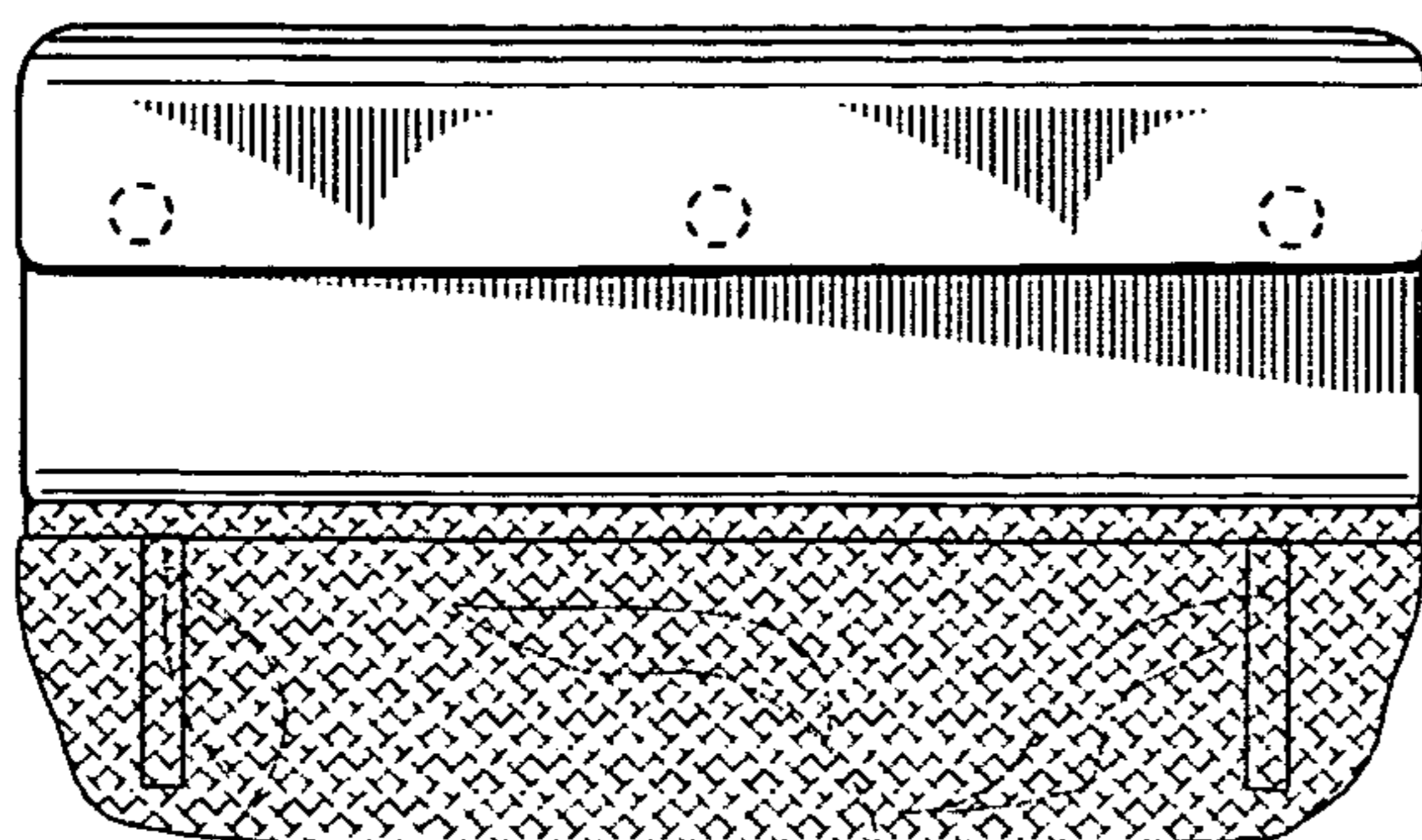

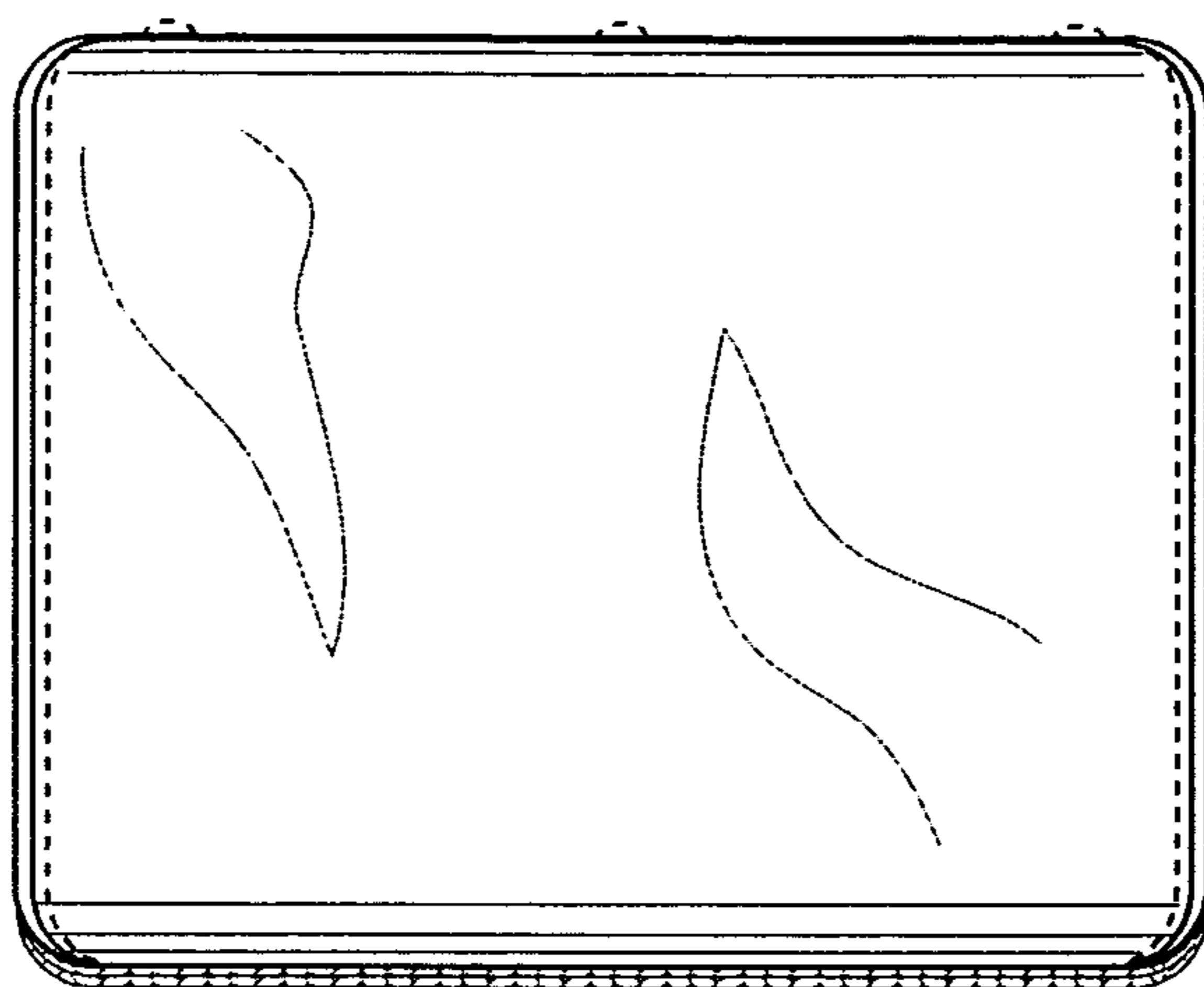

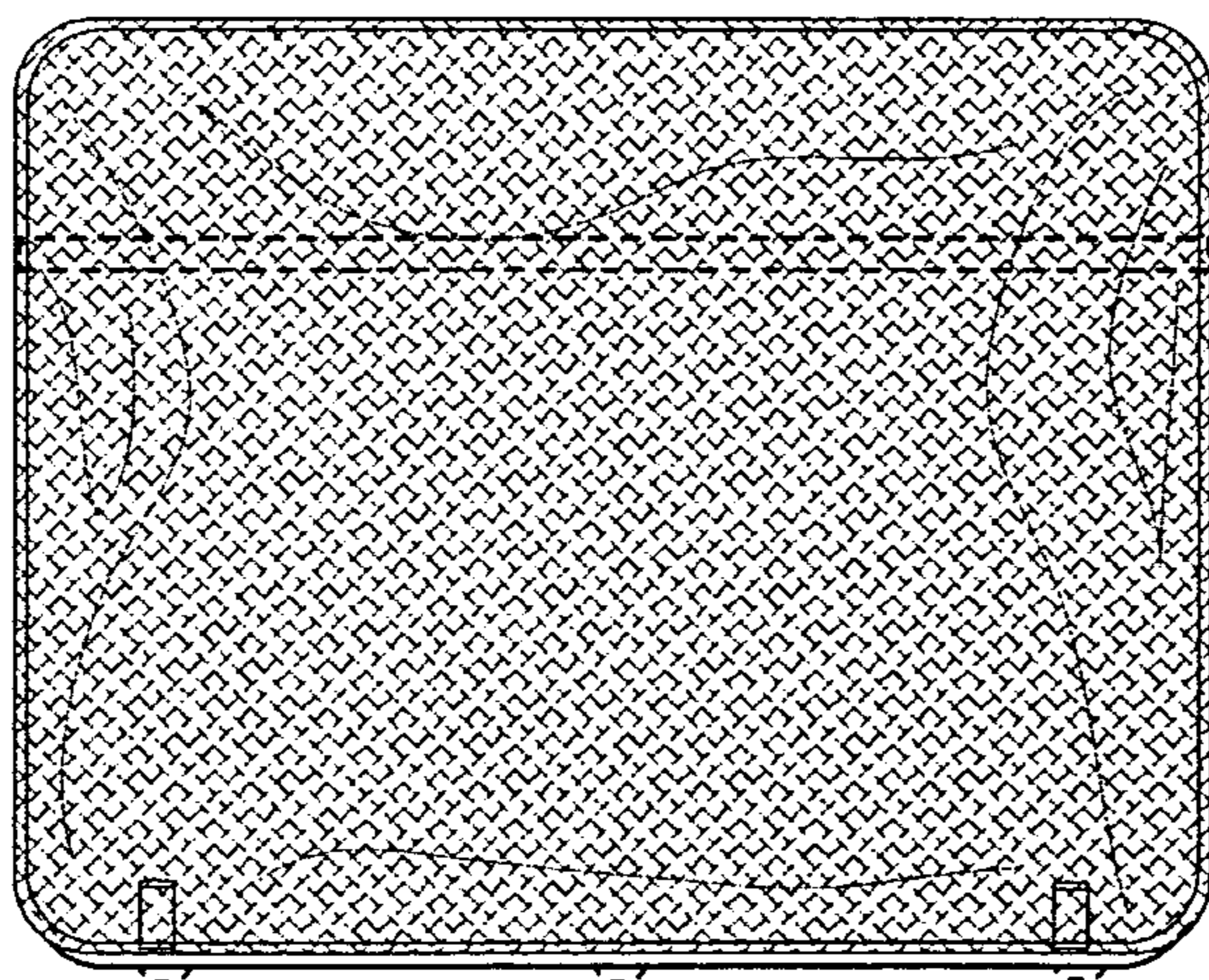

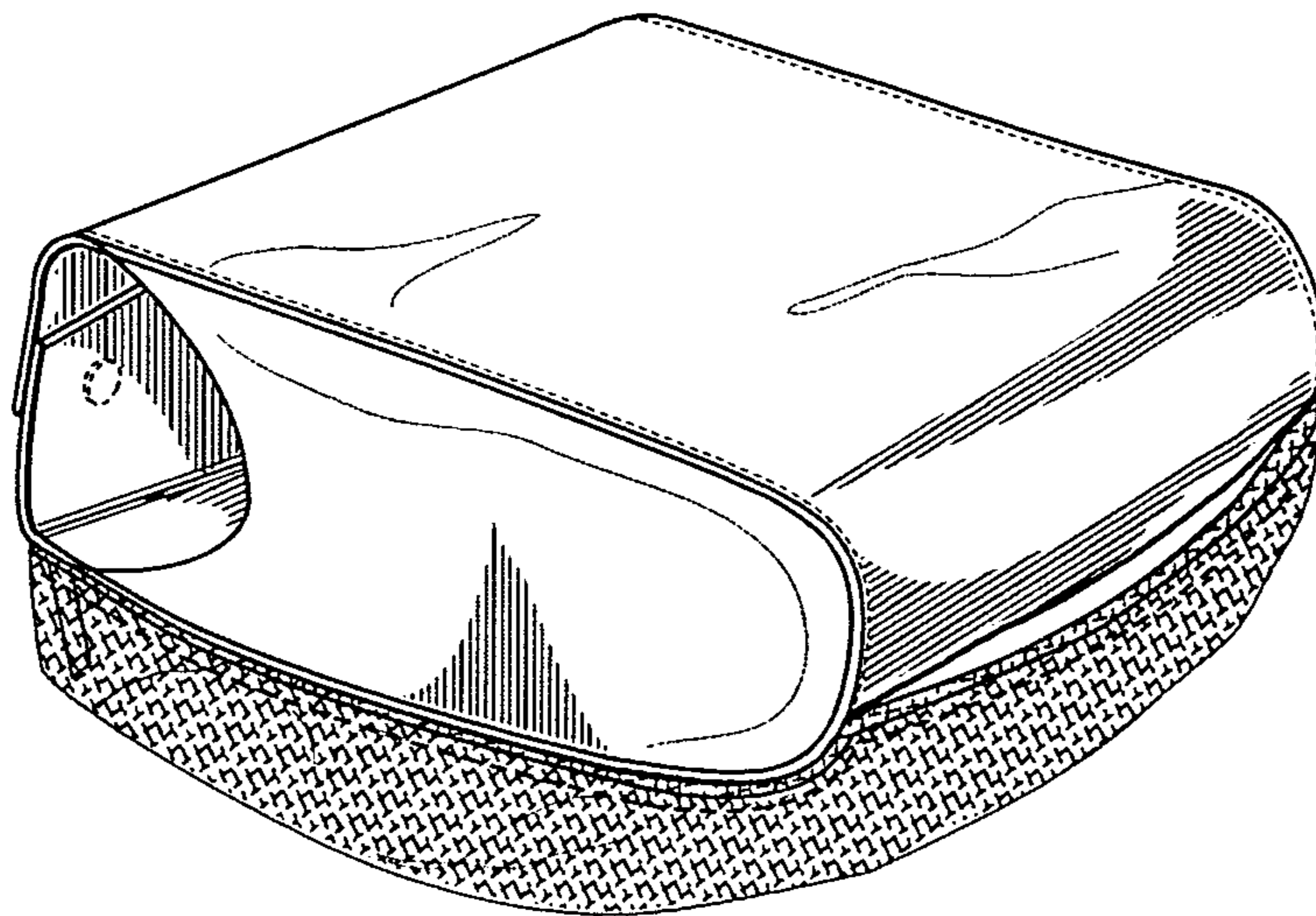
