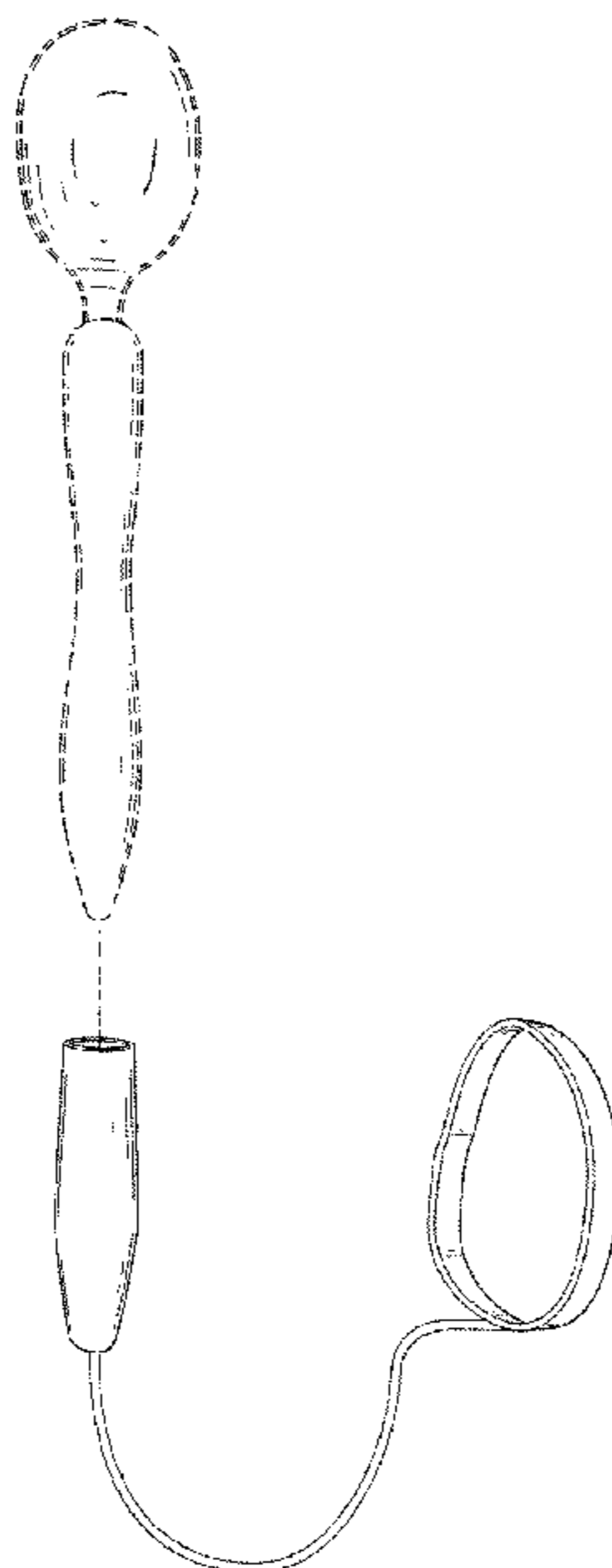

DESCRIPTION

FIG. 1 is a front perspective view illustrating the interchangeable
utensil holder in an unassembled state;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a perspective view illustrating the interchangeable
utensil holder in an assembled state; and,
FIG. 4 is a rear perspective view thereof.

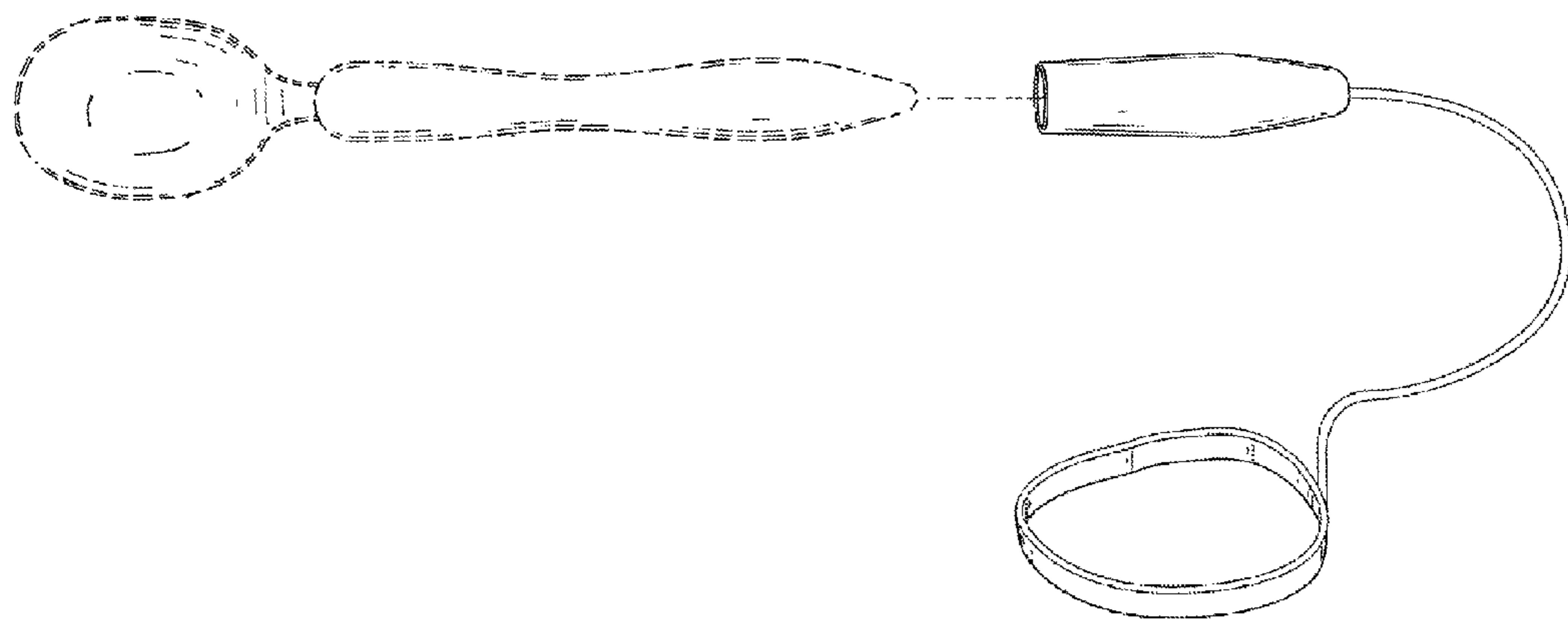

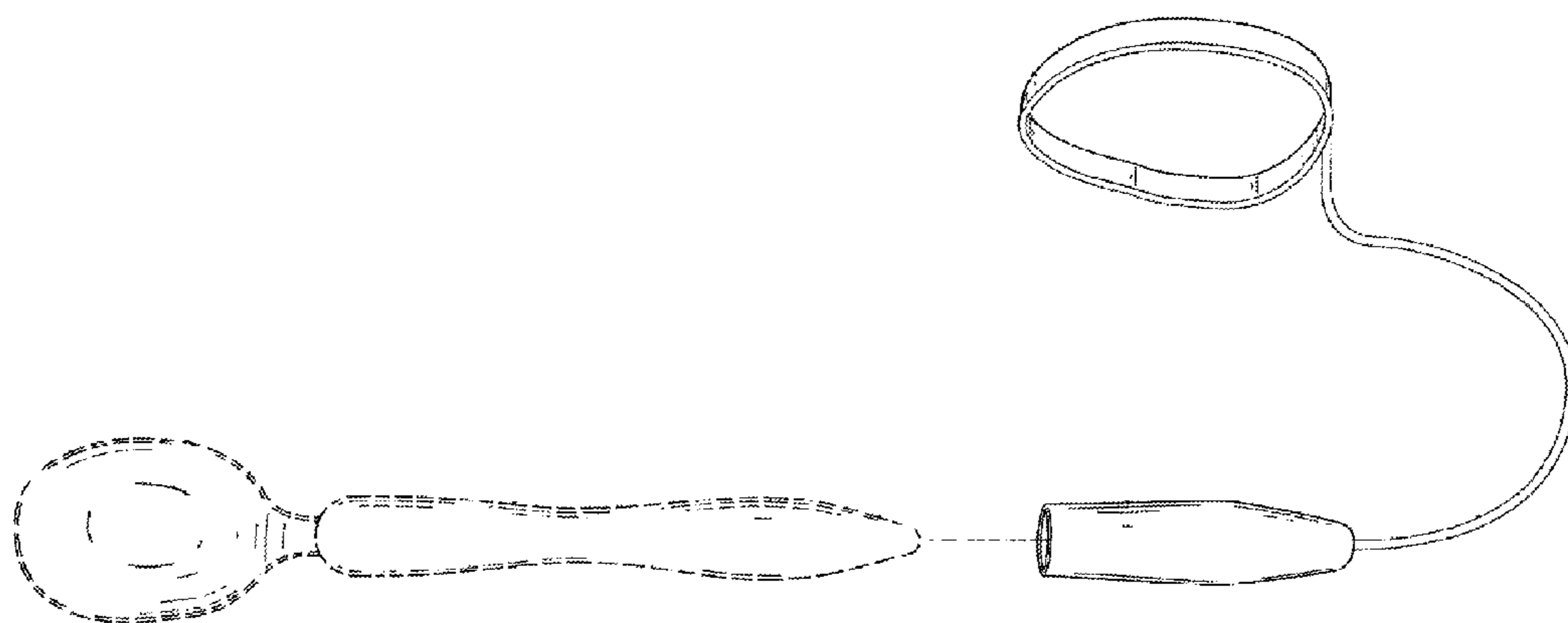

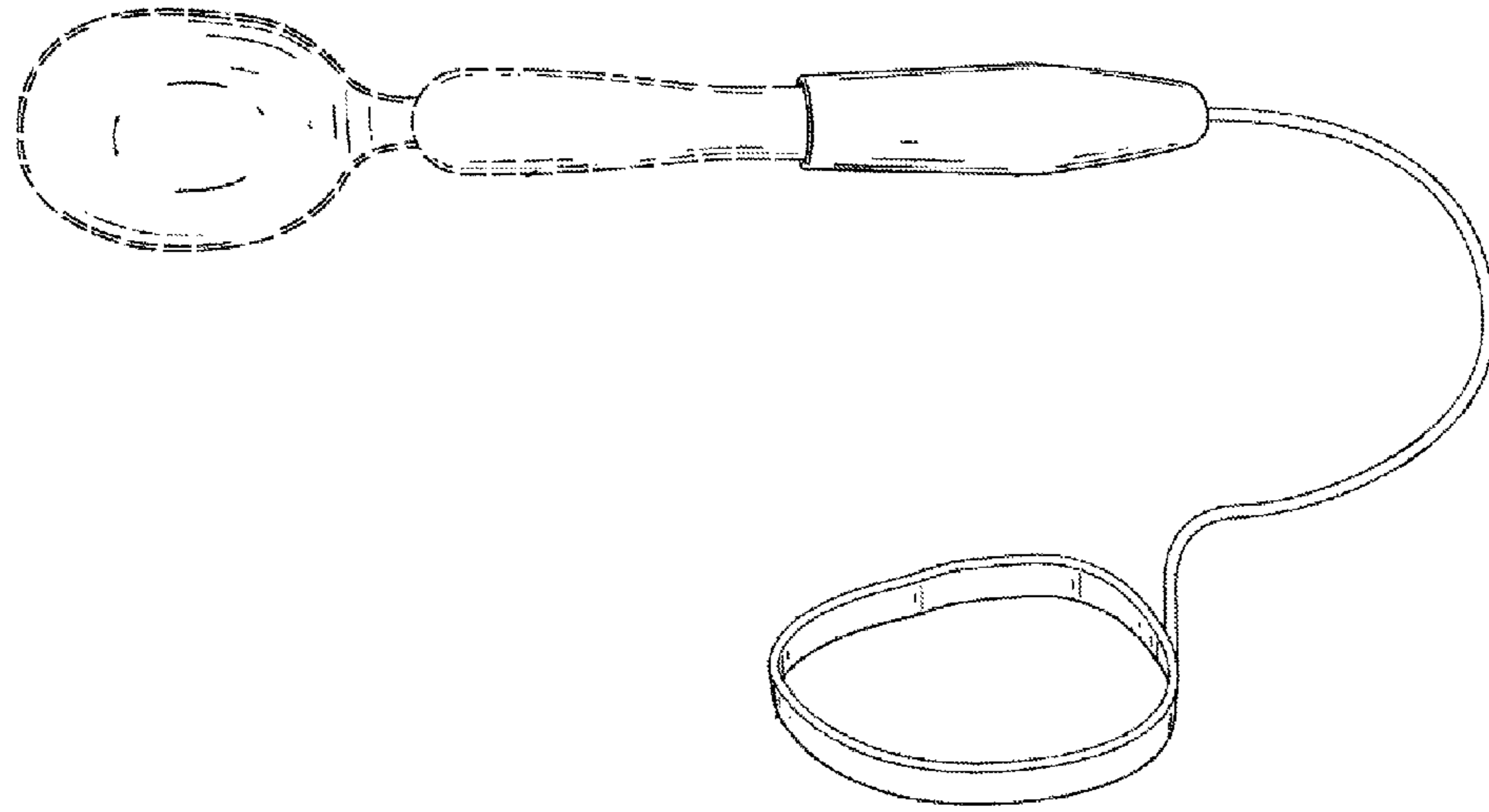

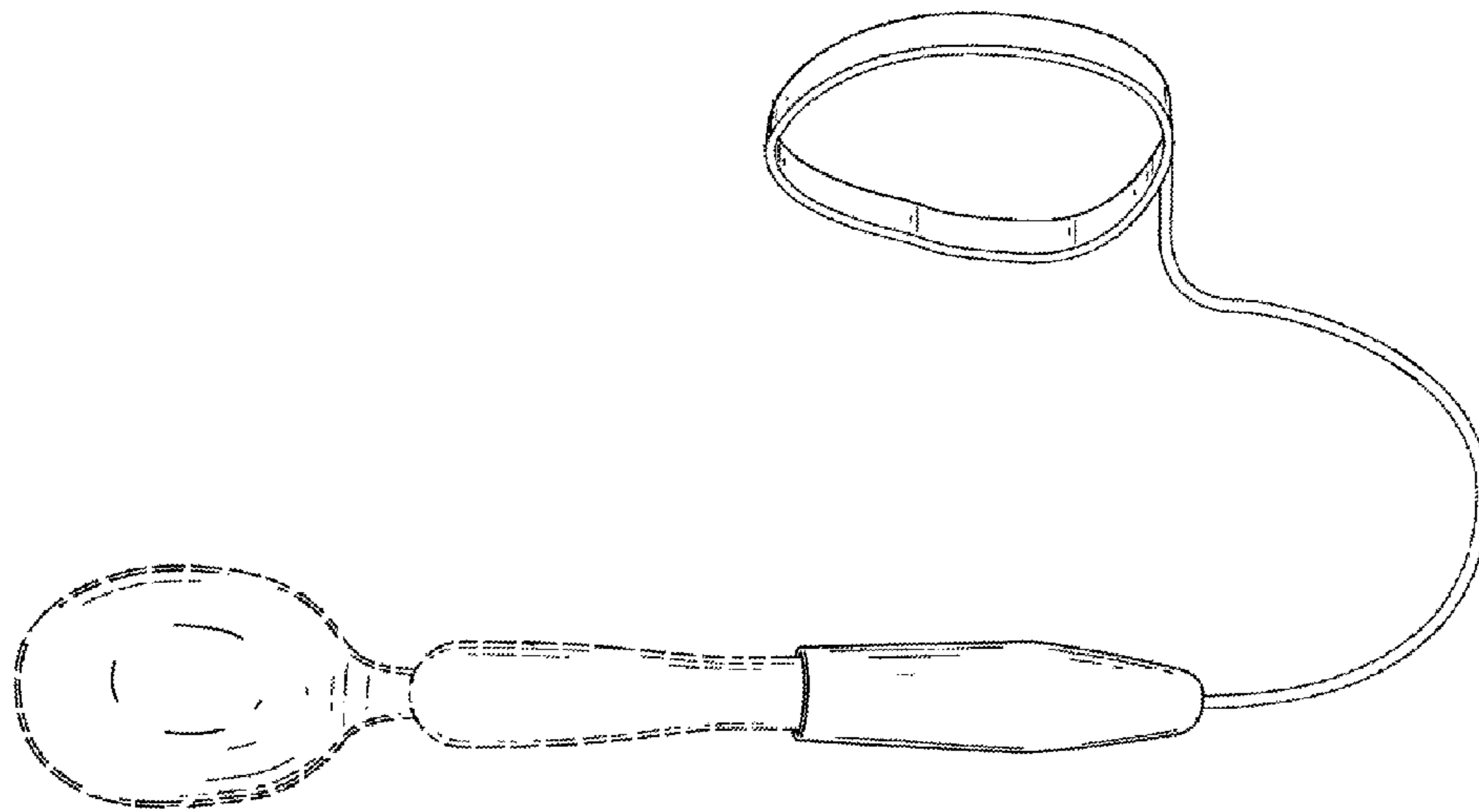
