DESCRIPTION

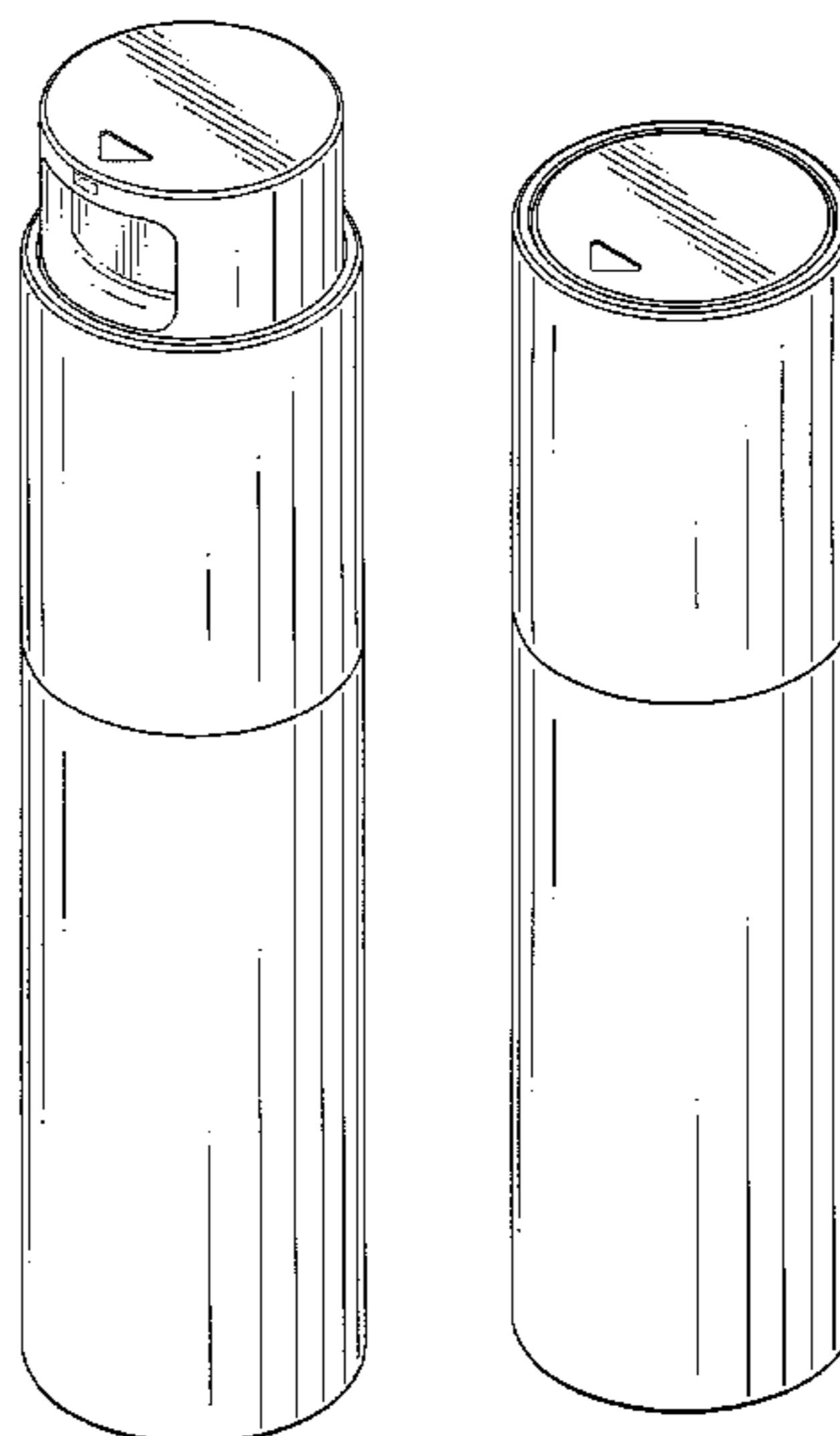
FIG. 1 is a perspective view of a bottle for cosmetics, showing my new design;

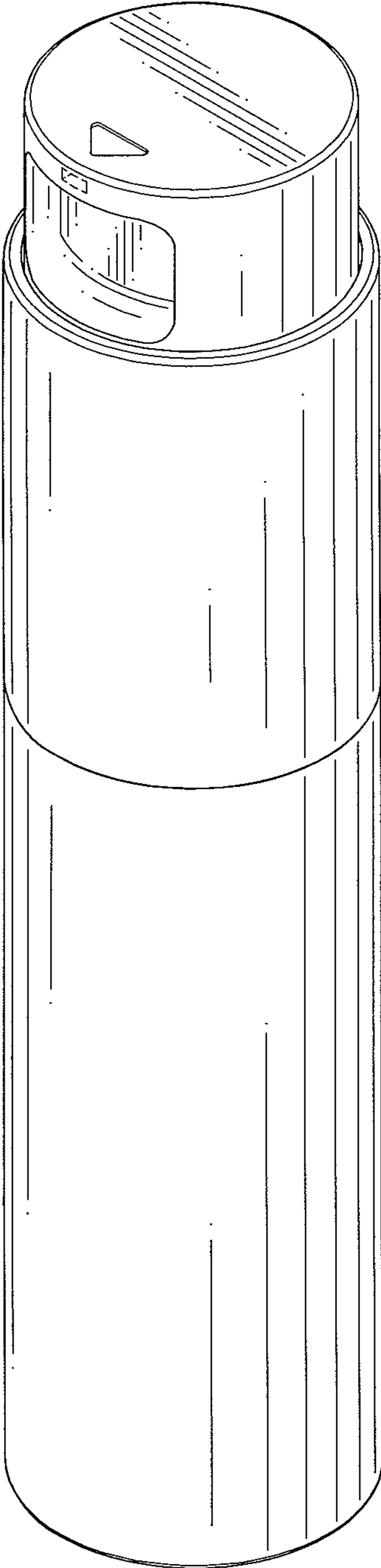

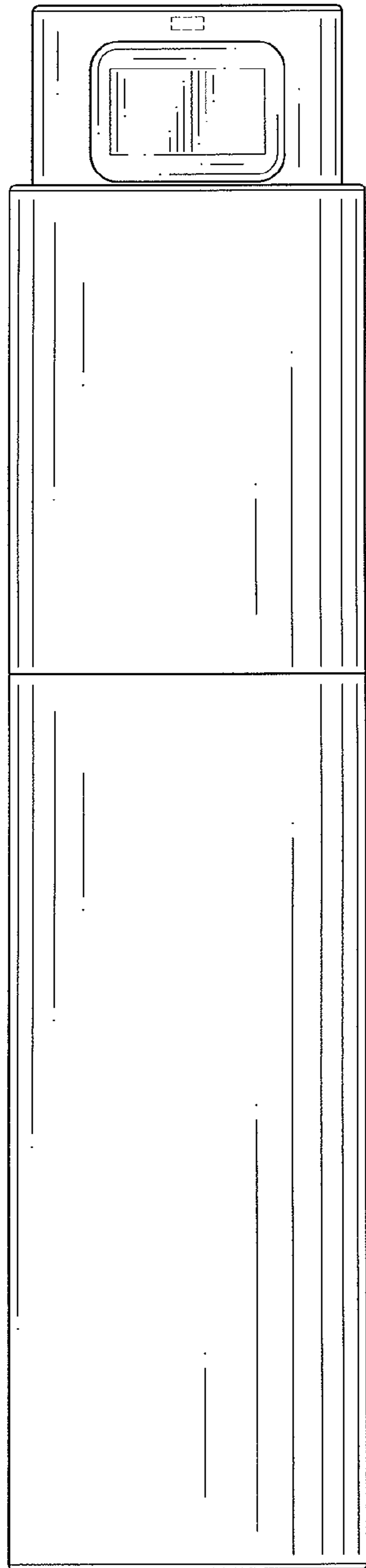

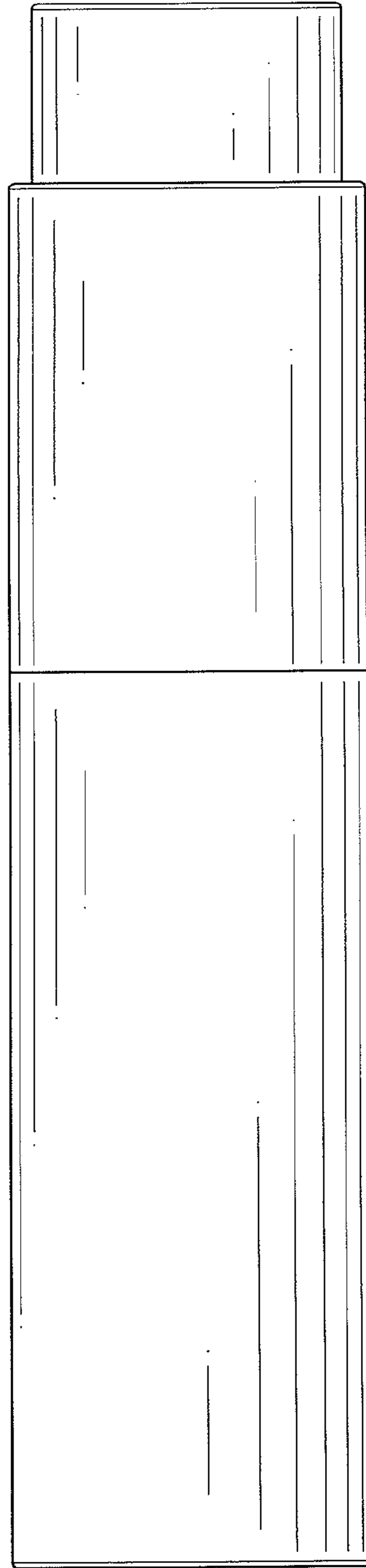

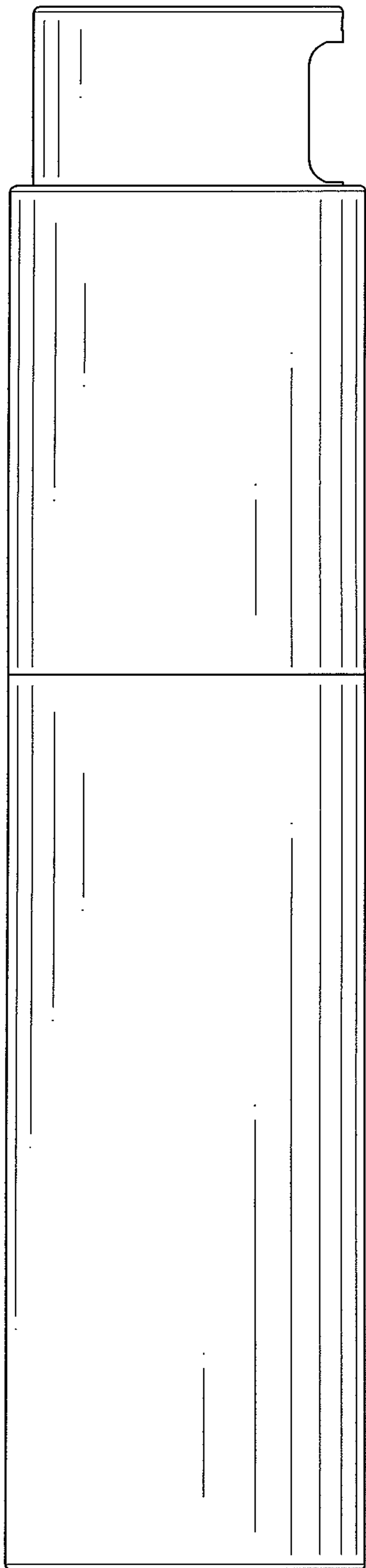

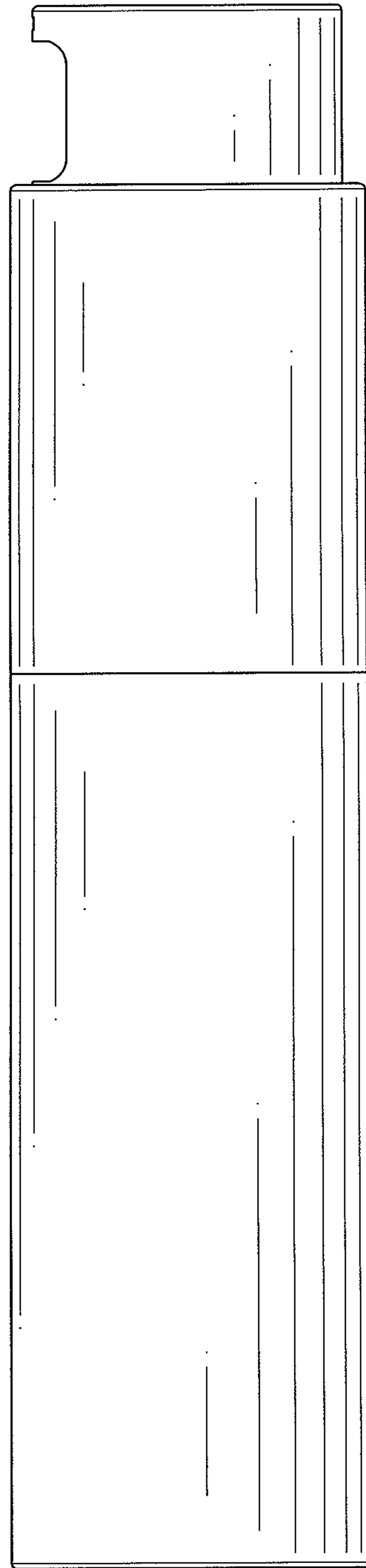

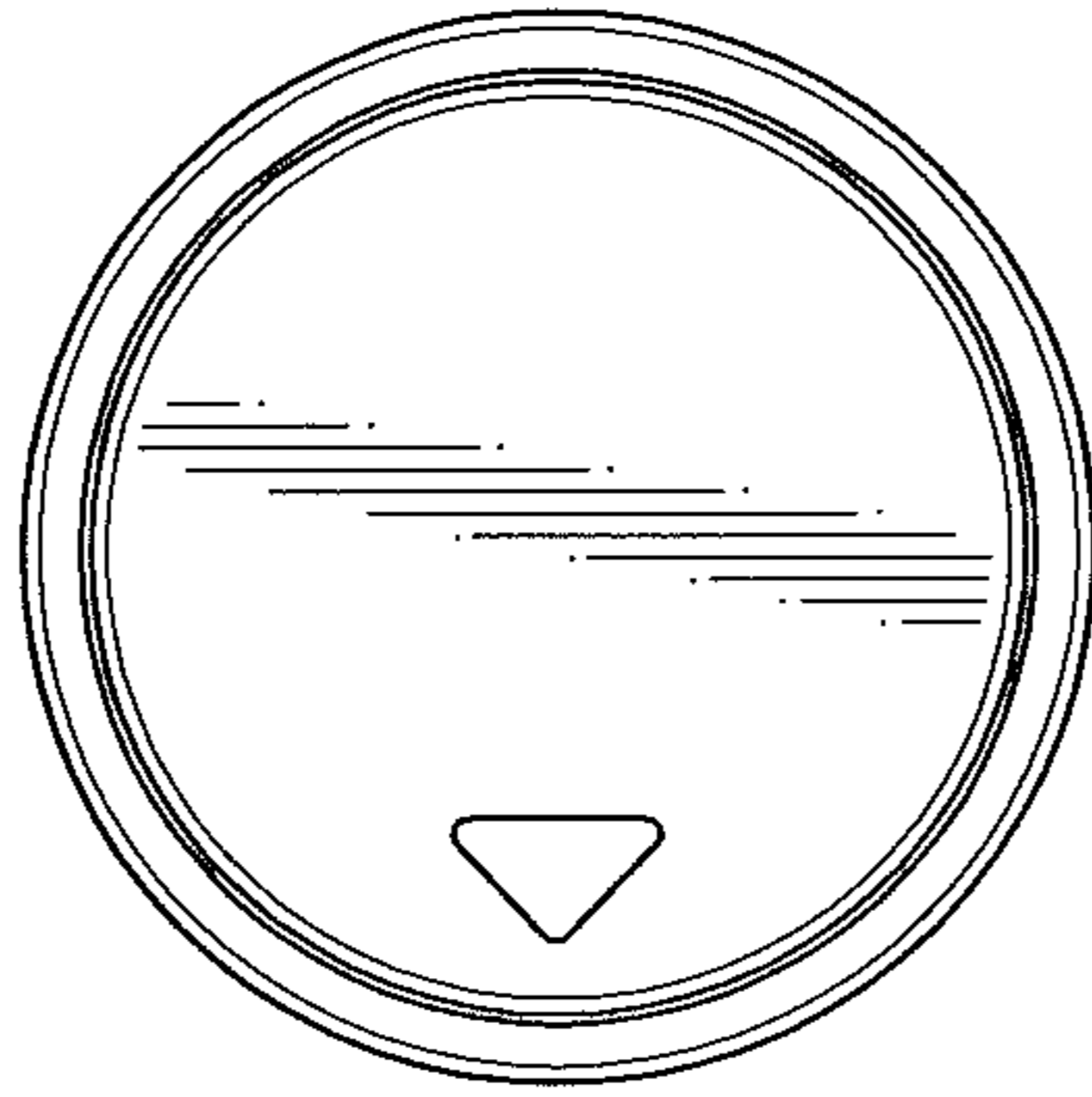

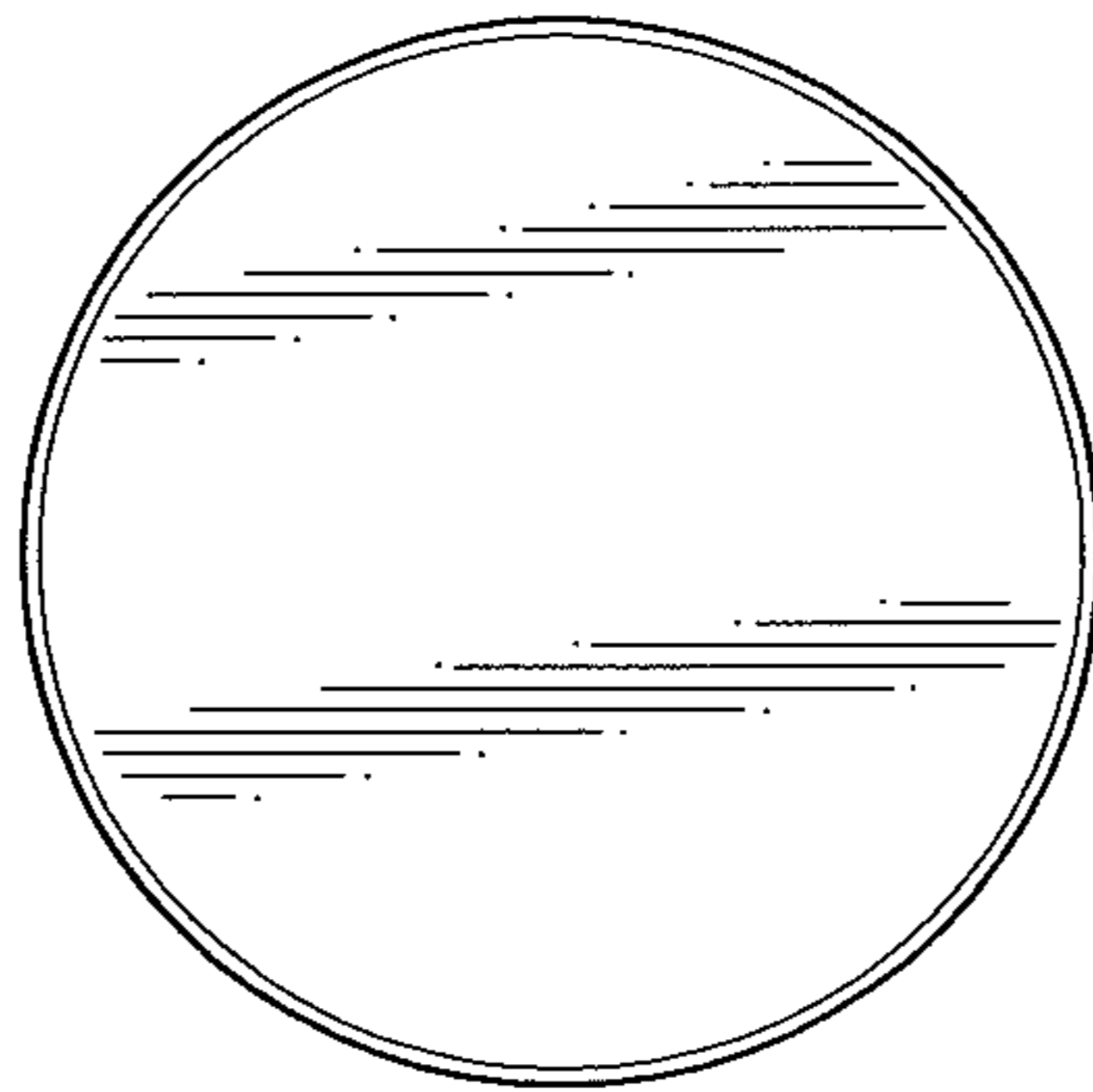

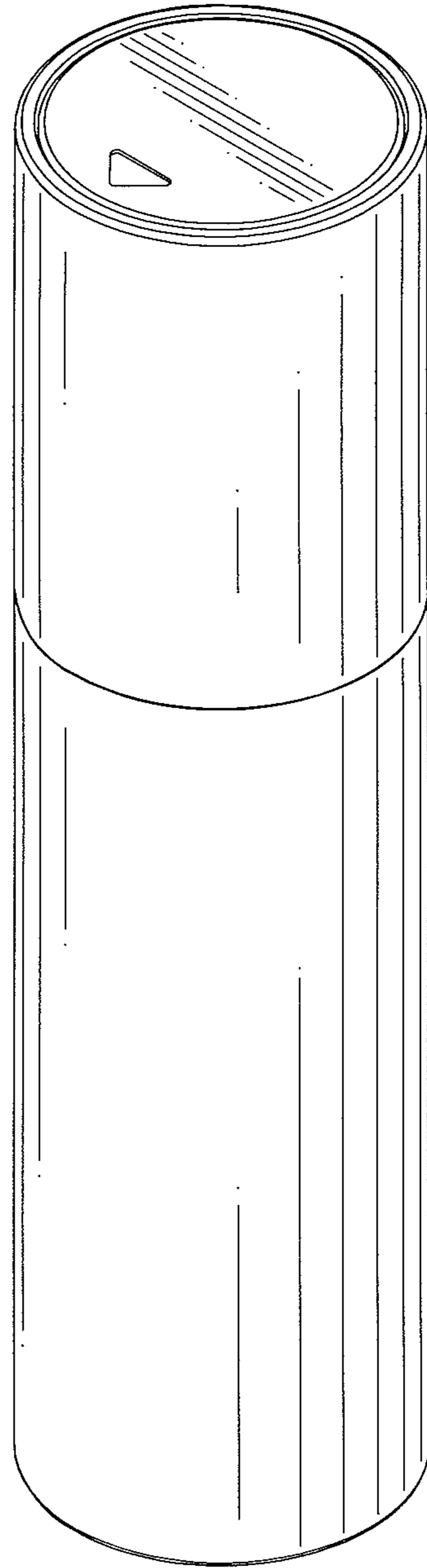

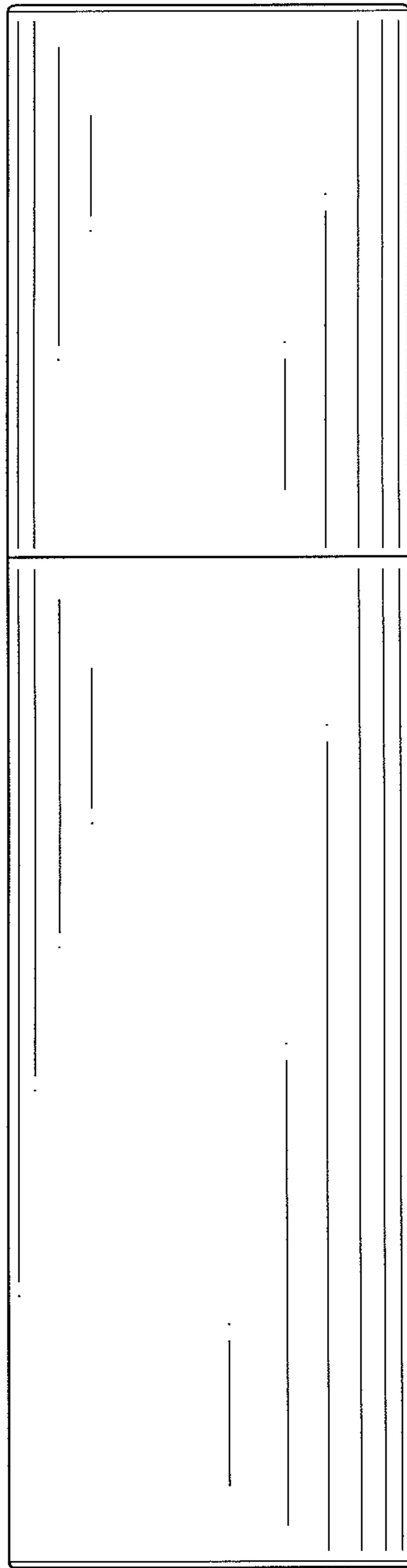
