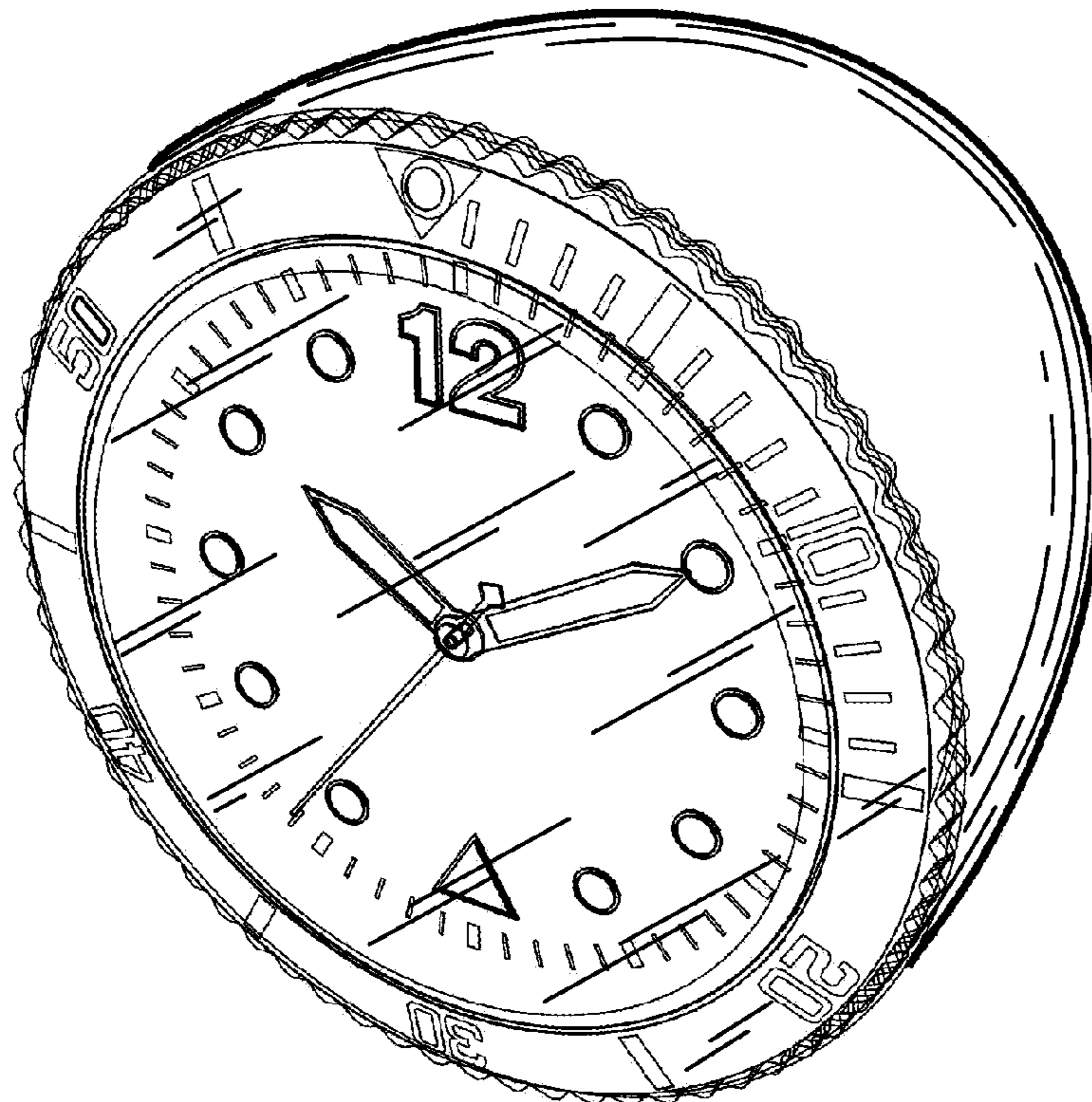

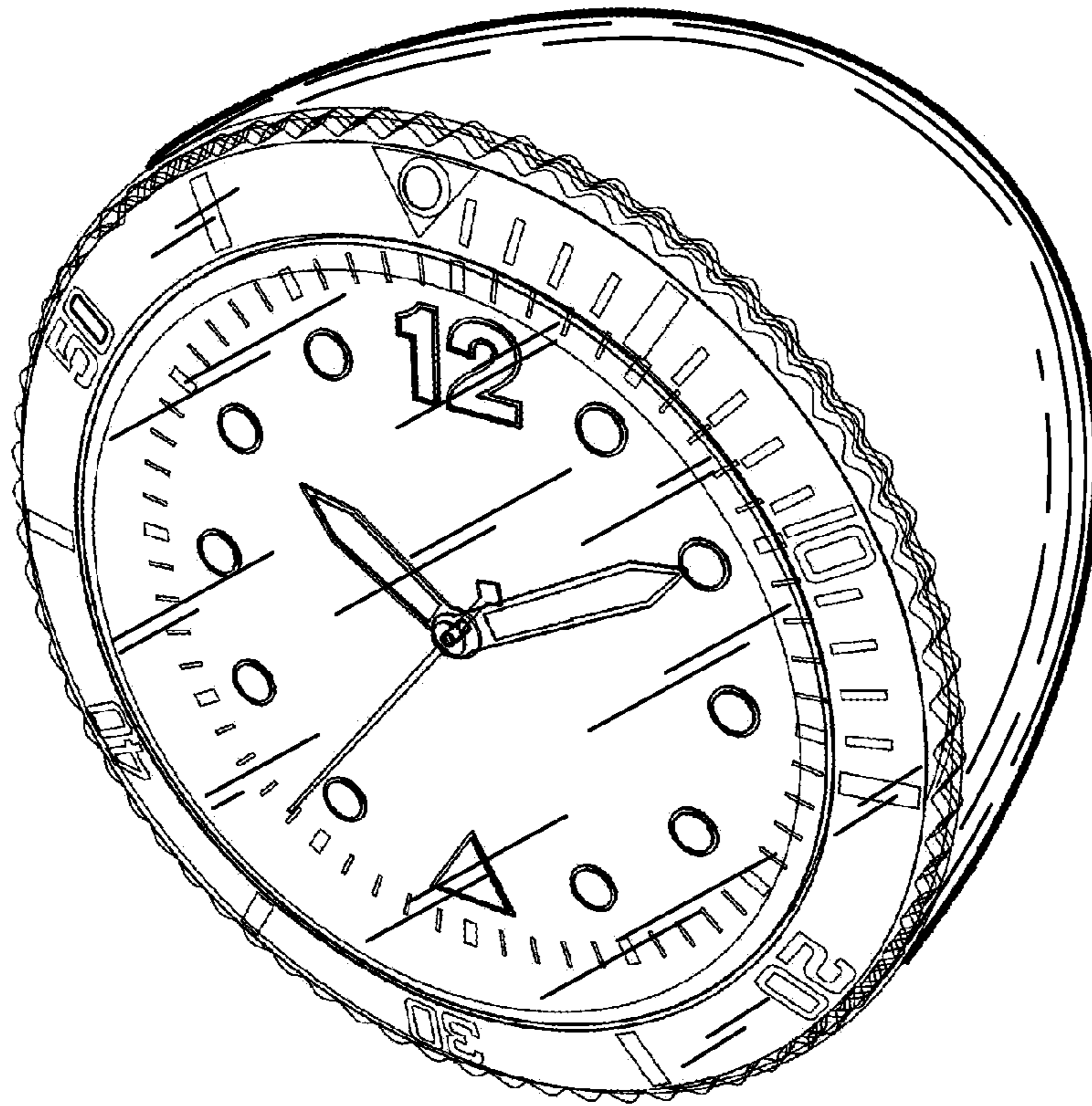
The ornamental design for a table clock, as shown and described.

**DESCRIPTION**

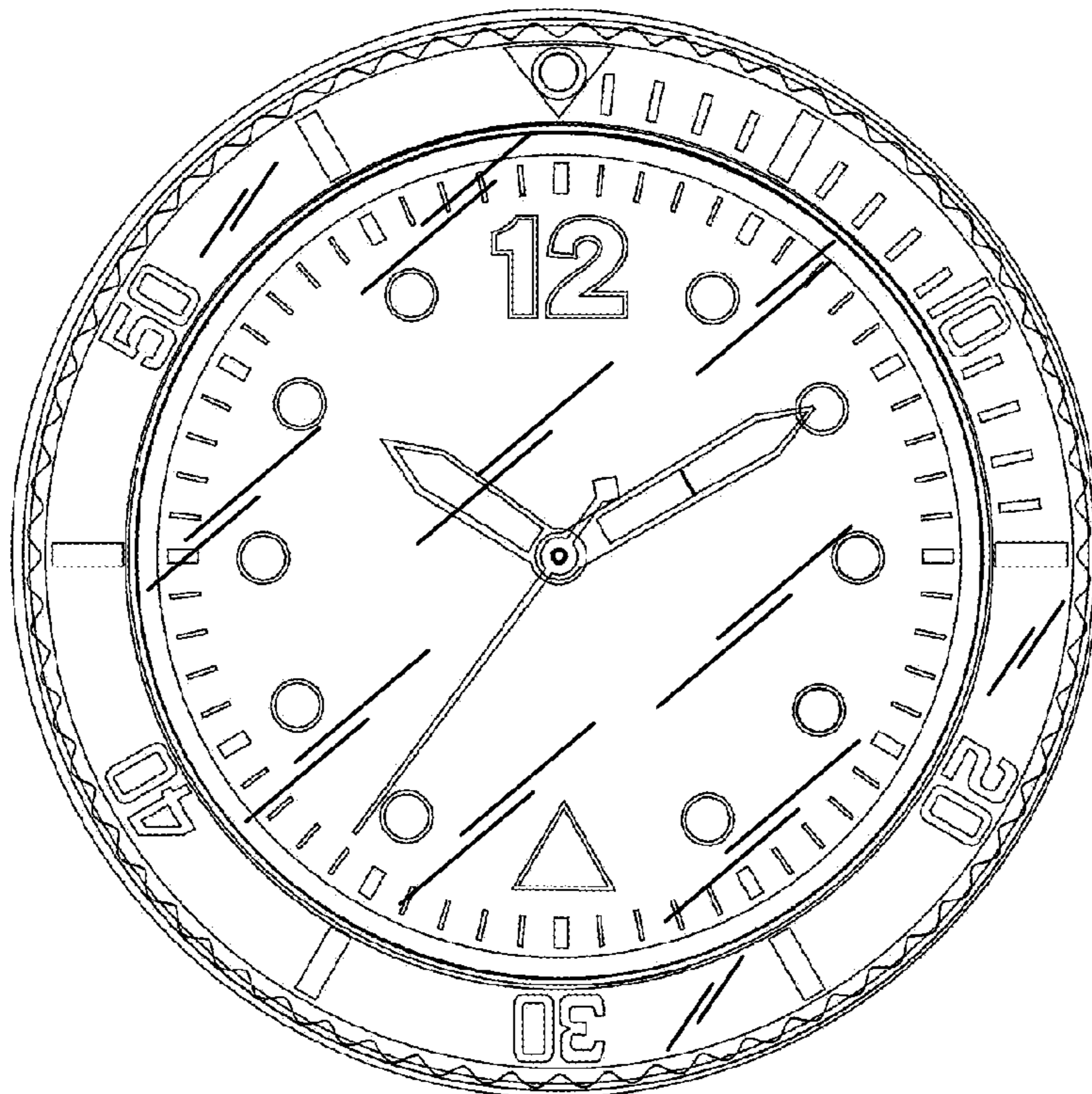

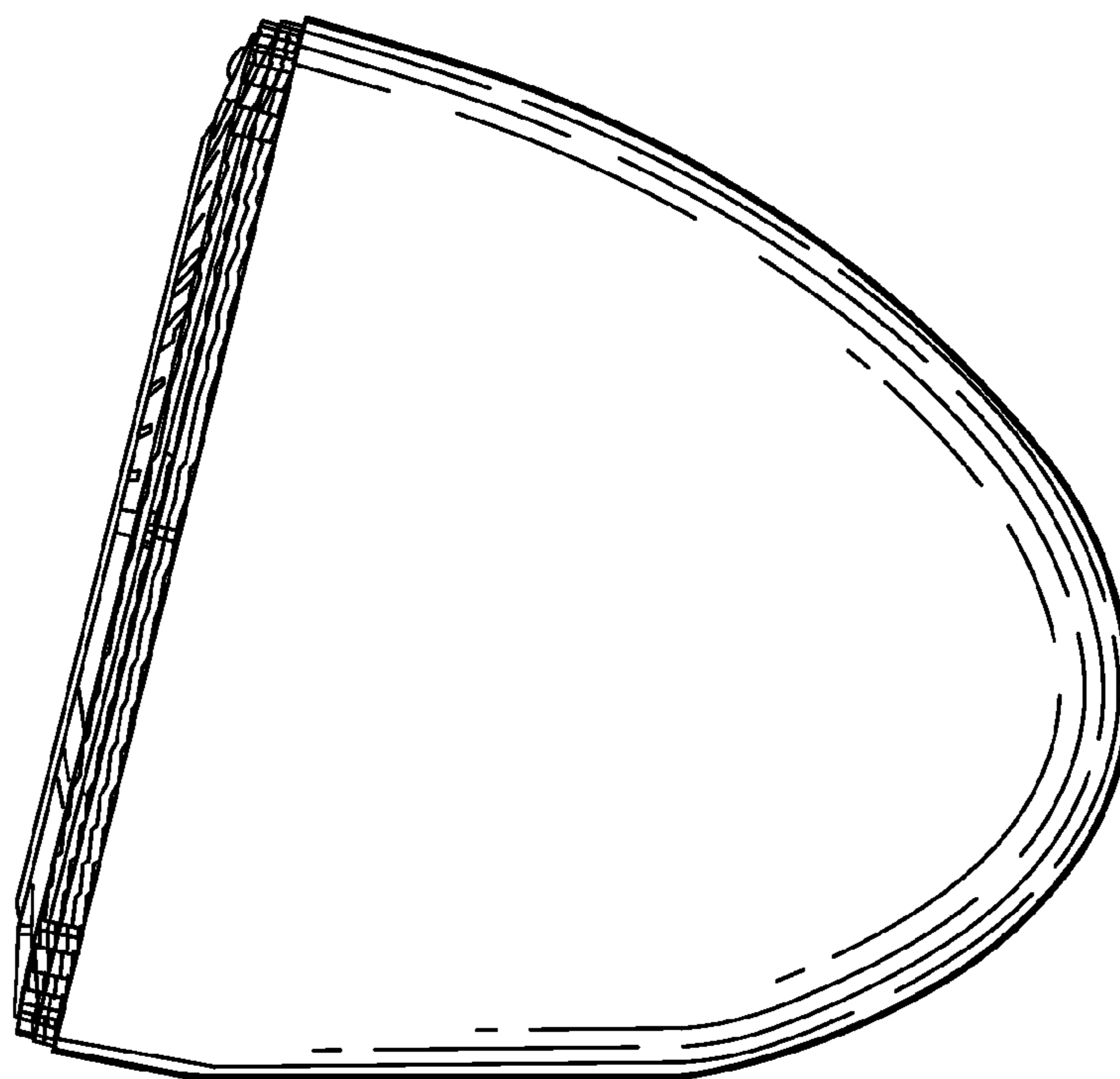

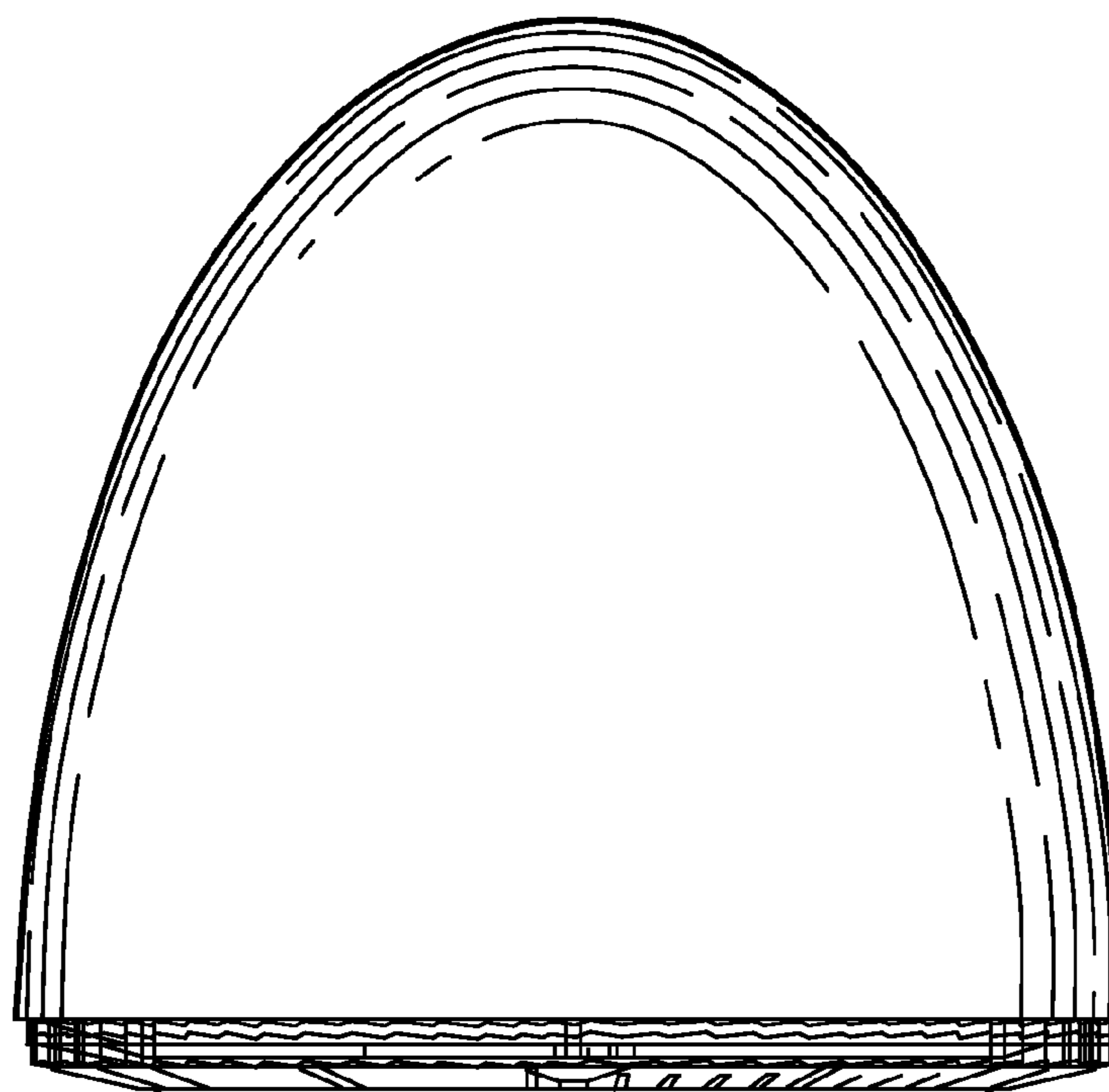

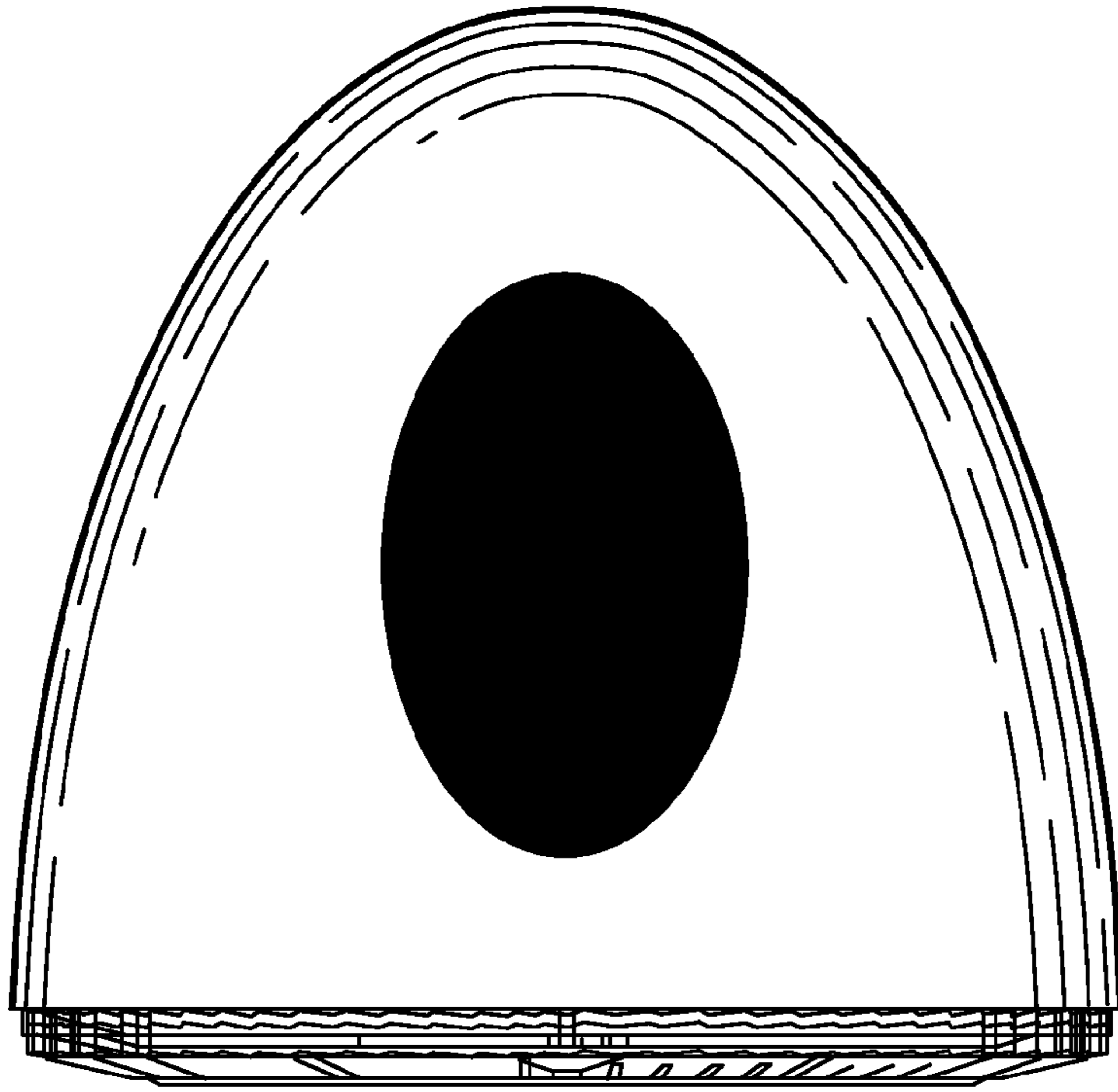




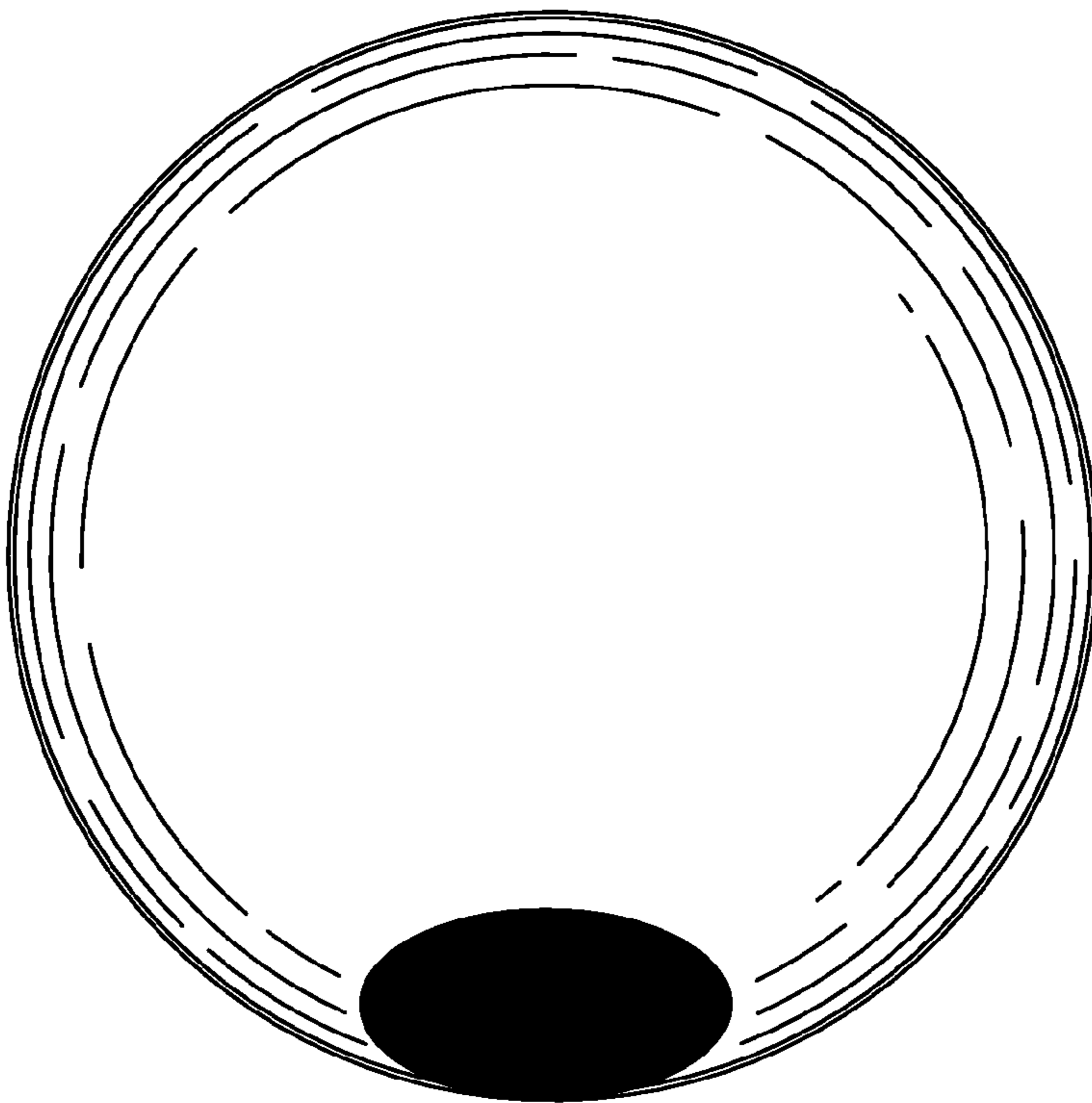
