FIG. 4 is a back end view of the solar pan with inserted form in FIG. 1.

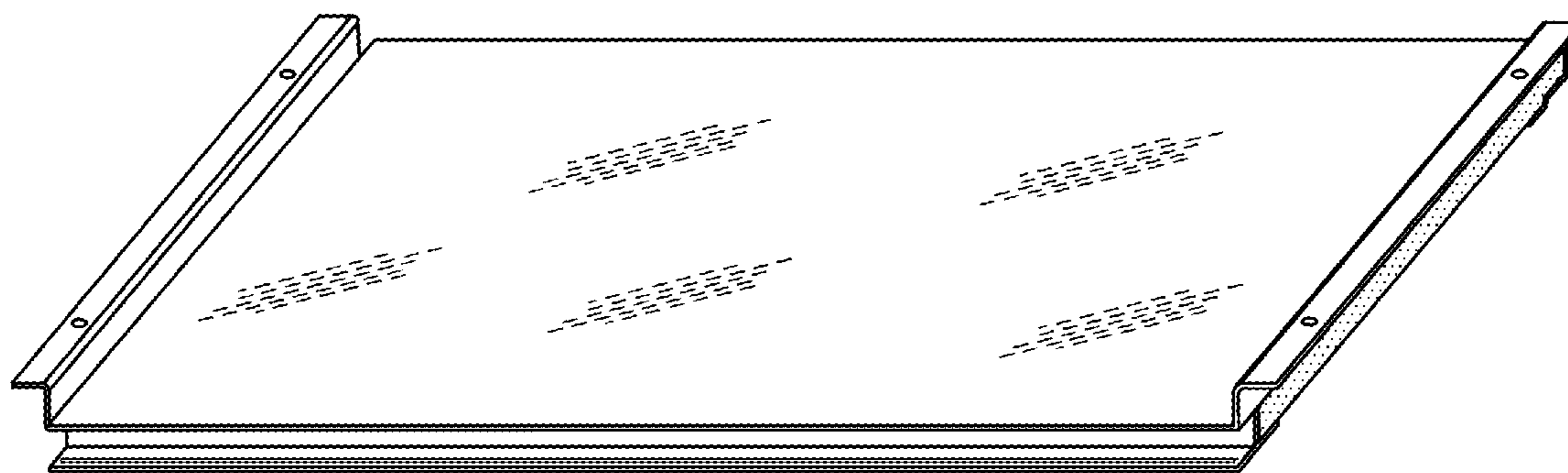
FIG. 5 is a bottom view of the solar pan with inserted form in FIG. 1.

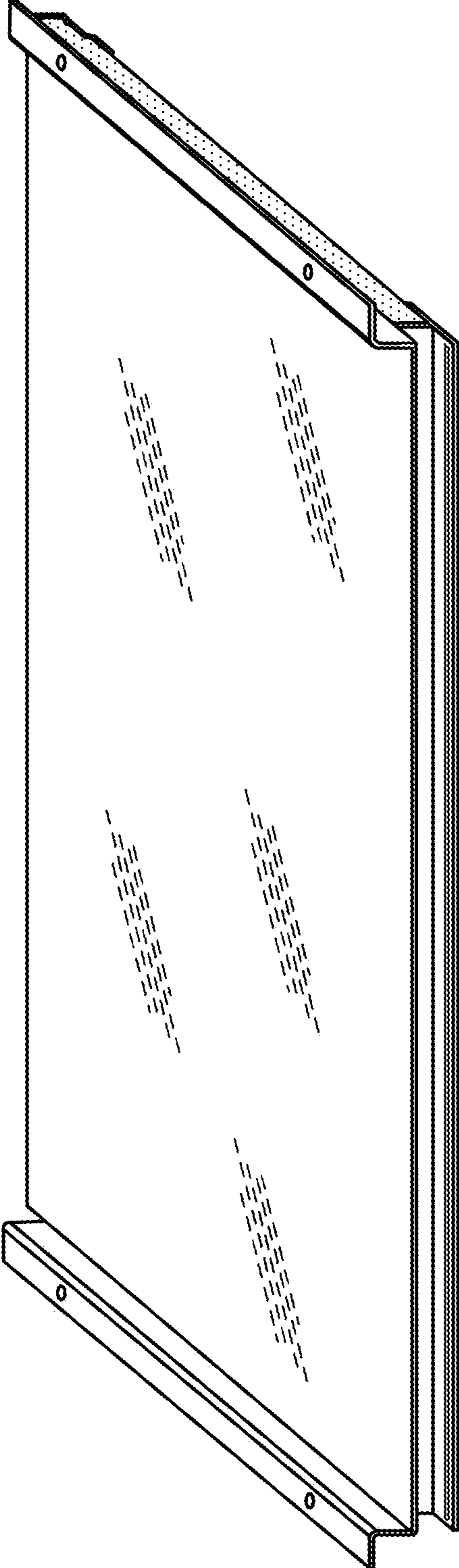

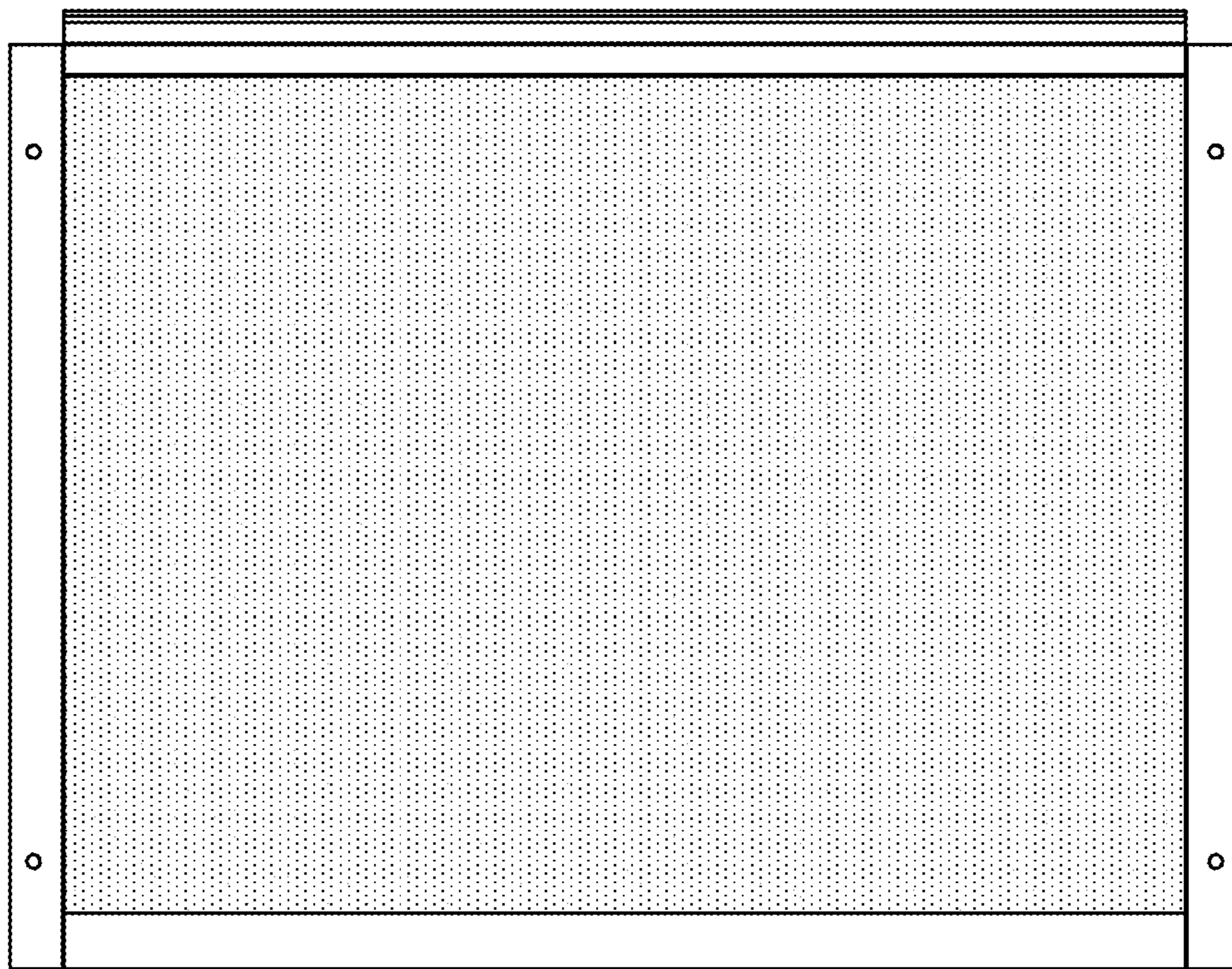

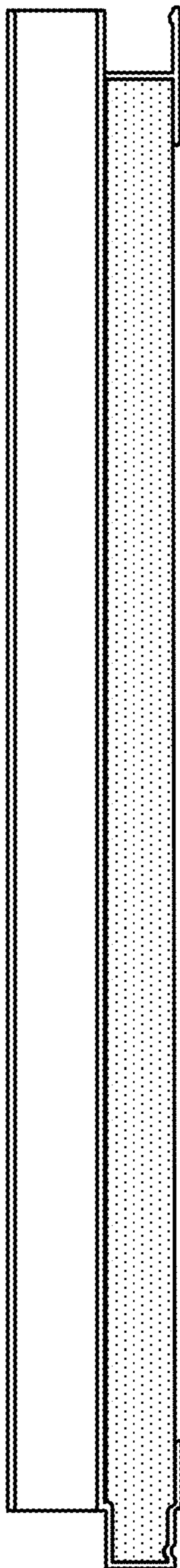

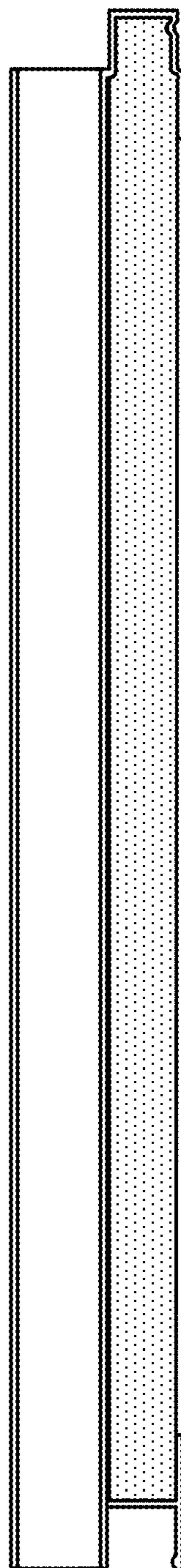
