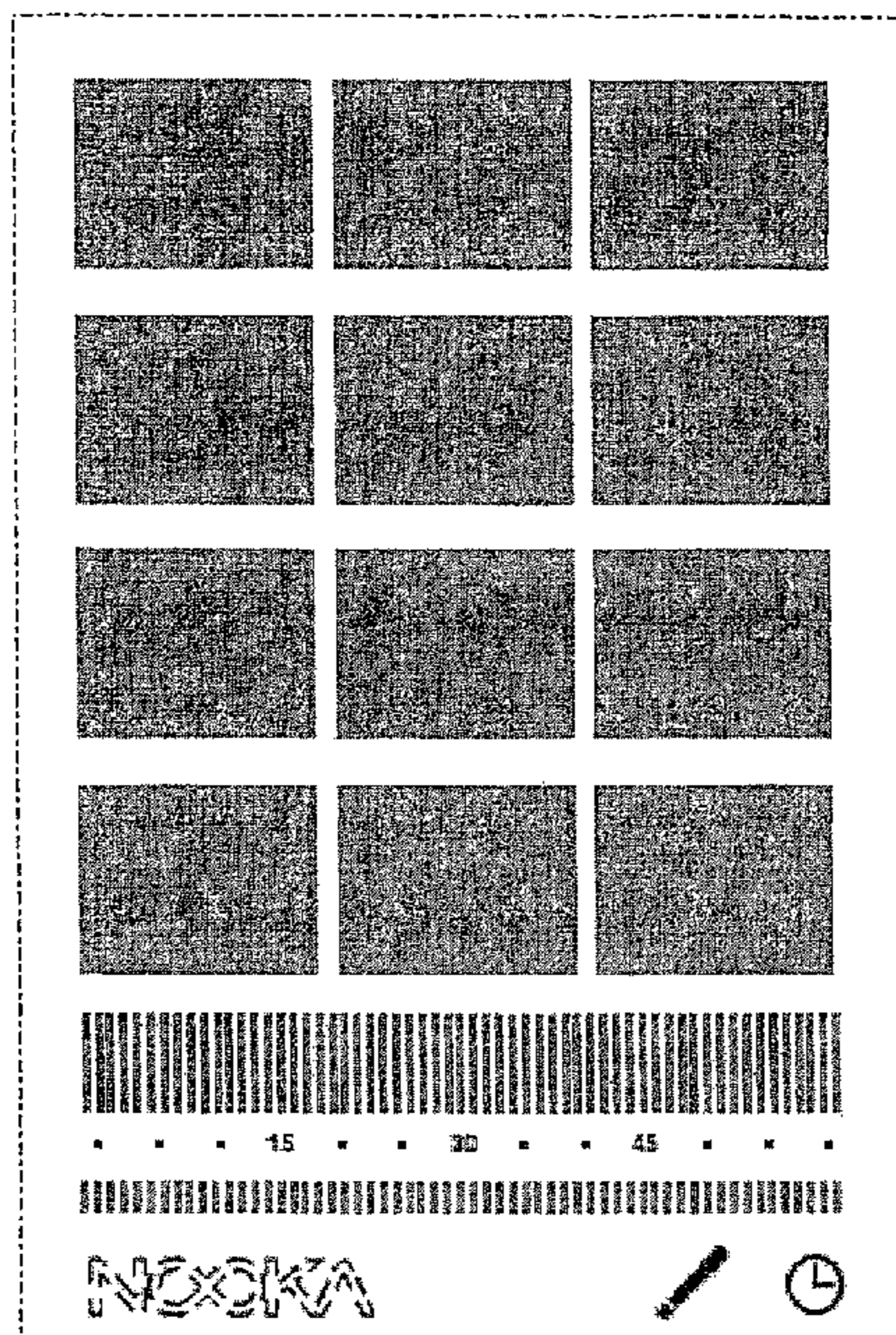
The ornamental design for a display screen with graphical user interface for time keeping, as shown and described.

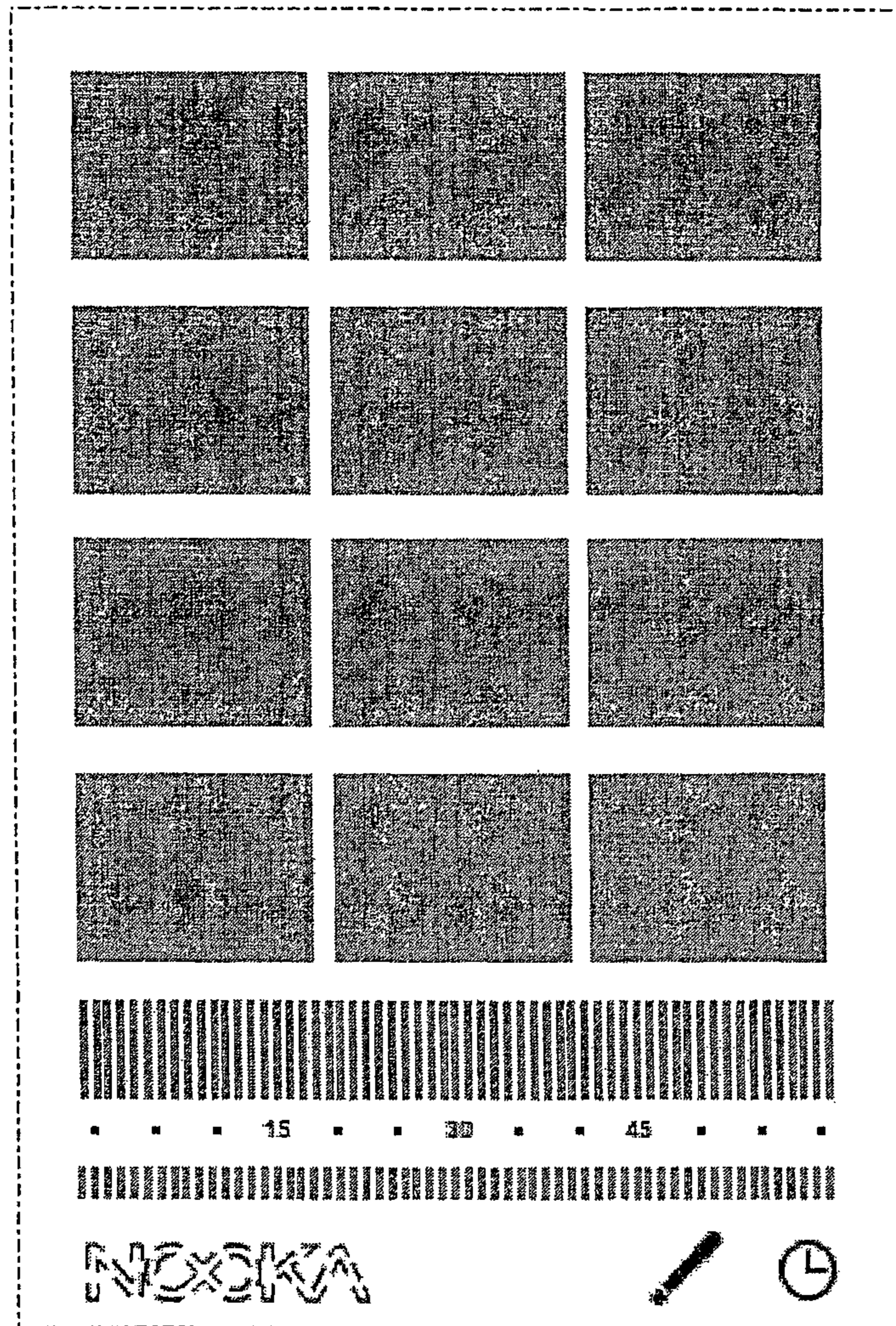

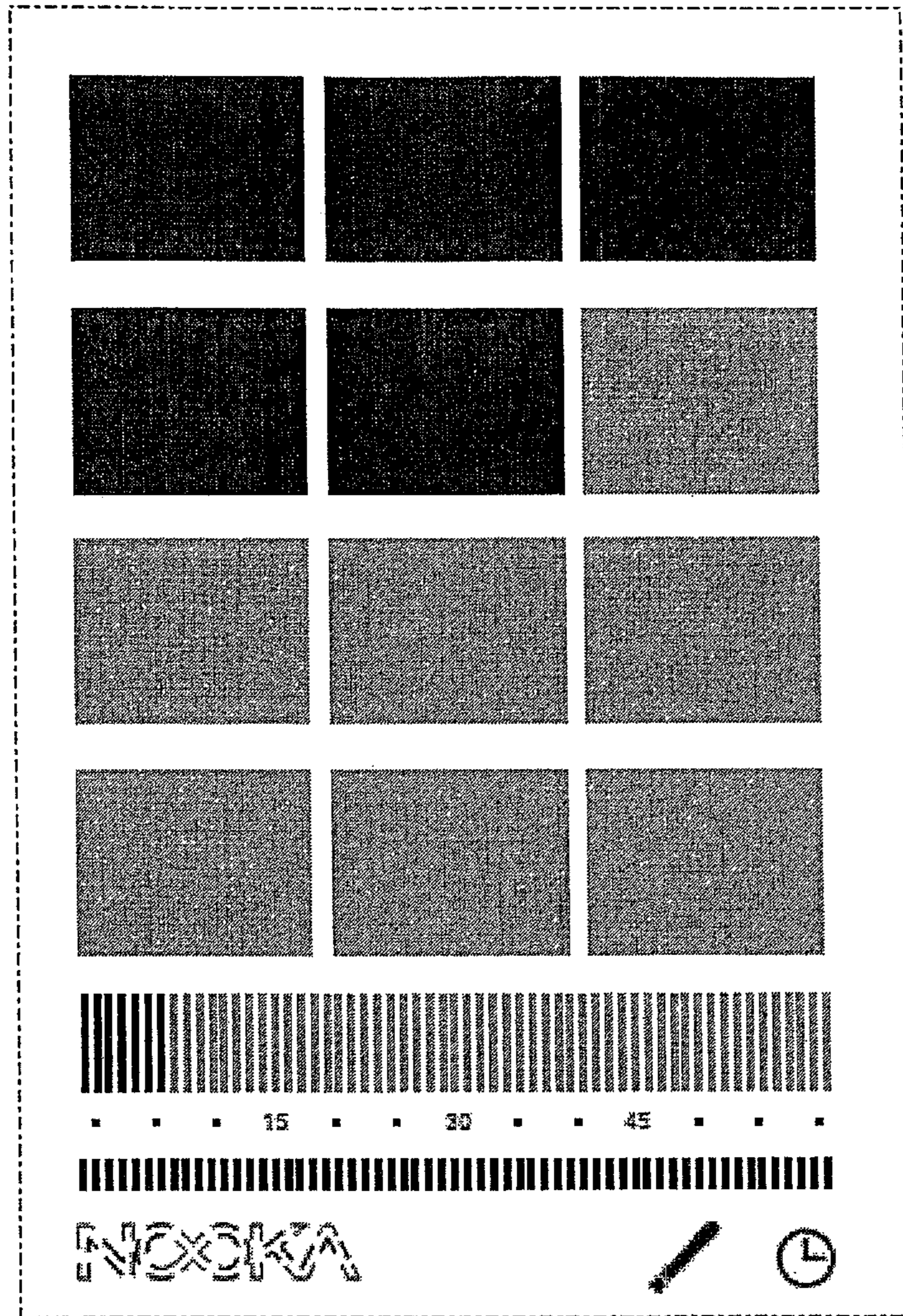
