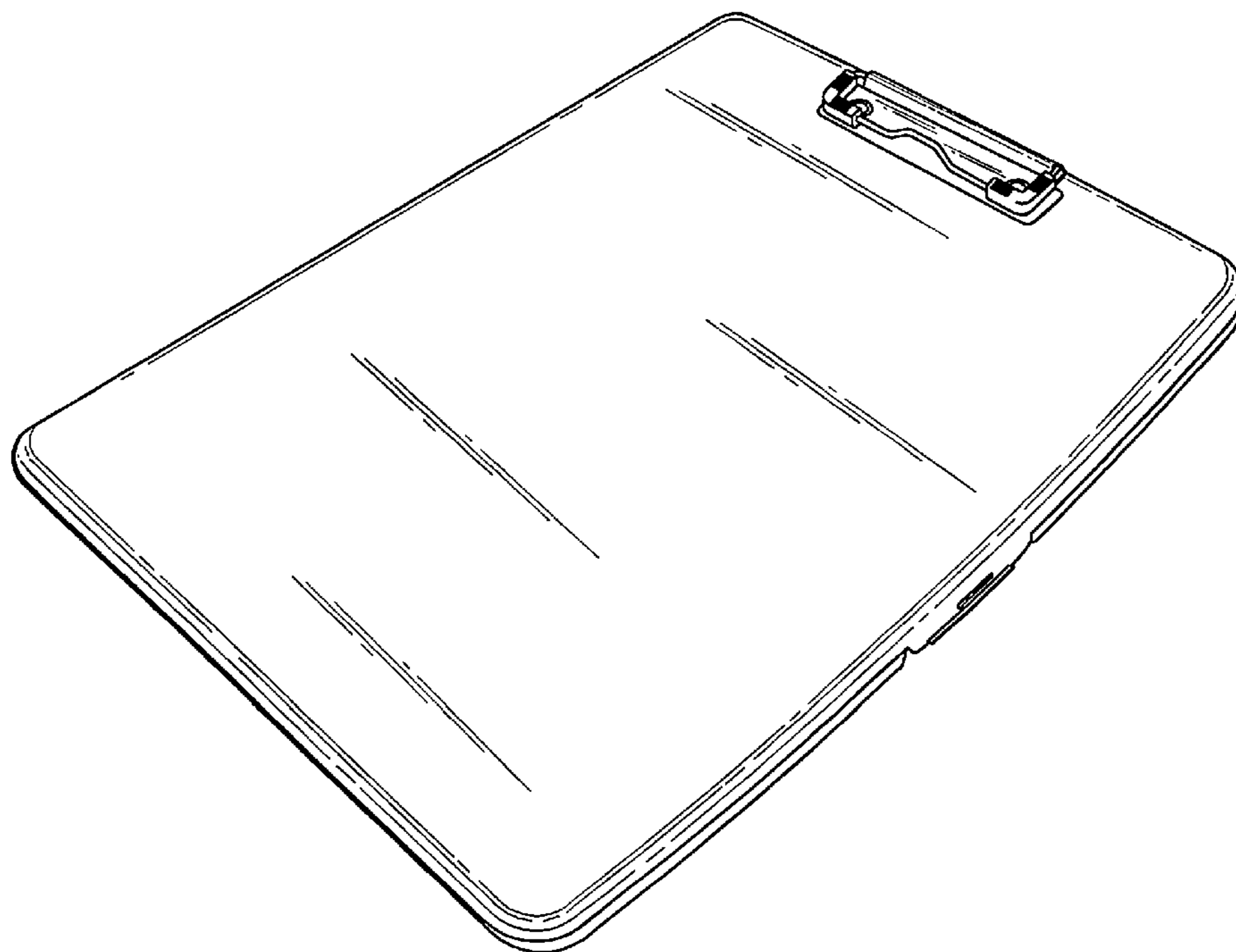
(57) **CLAIM**

The ornamental design for a clipboard case, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clipboard case showing the new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a back view thereof; and,

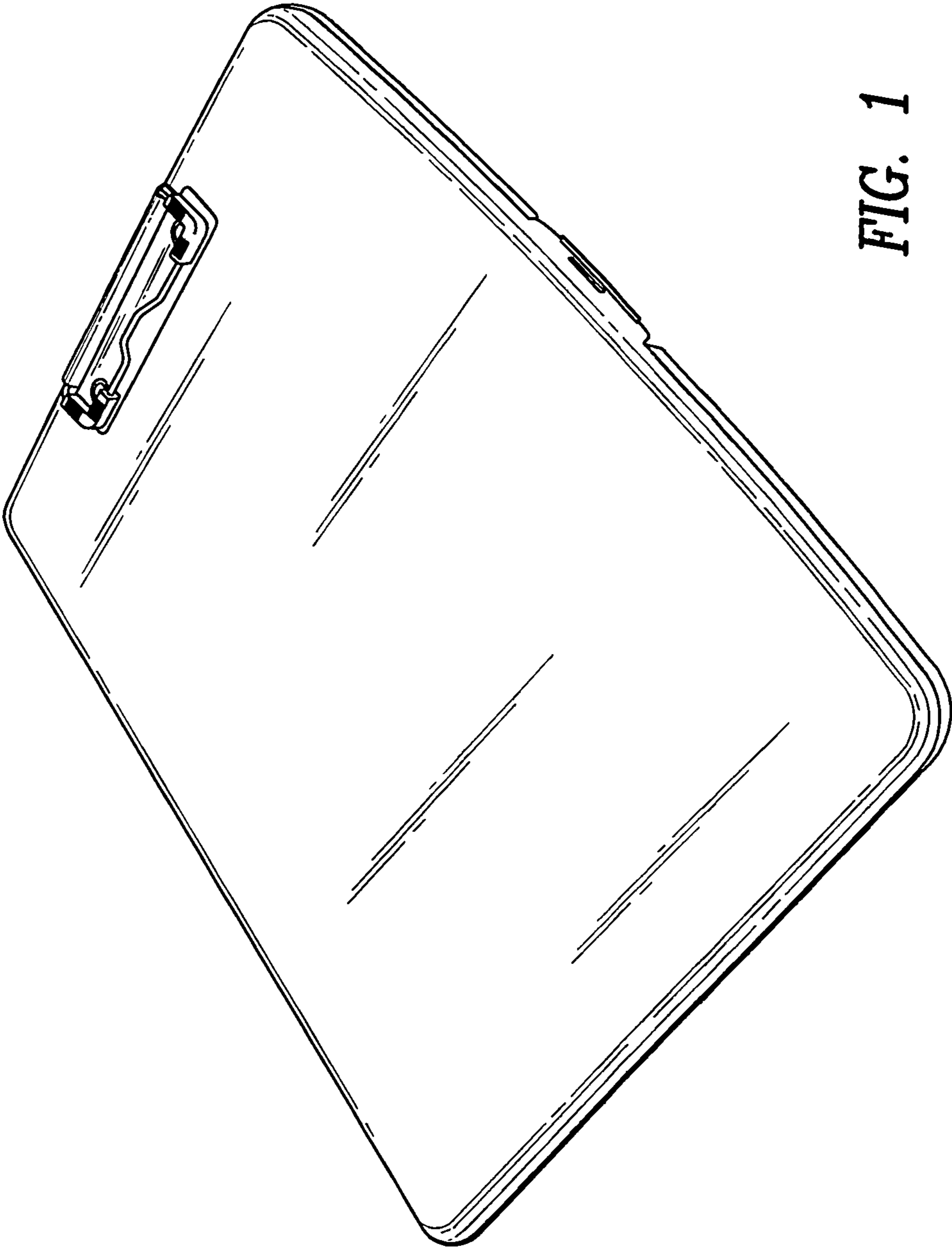

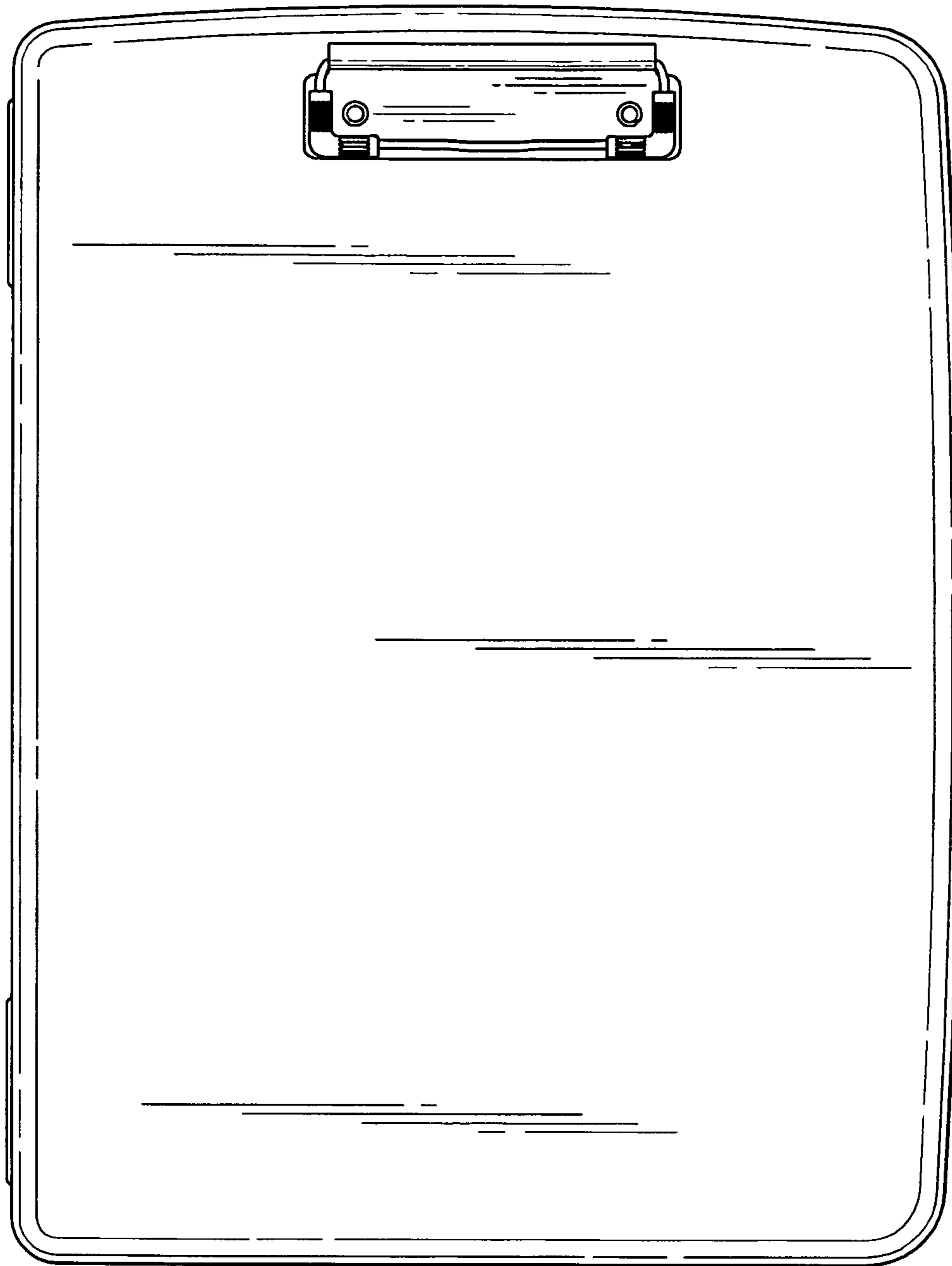

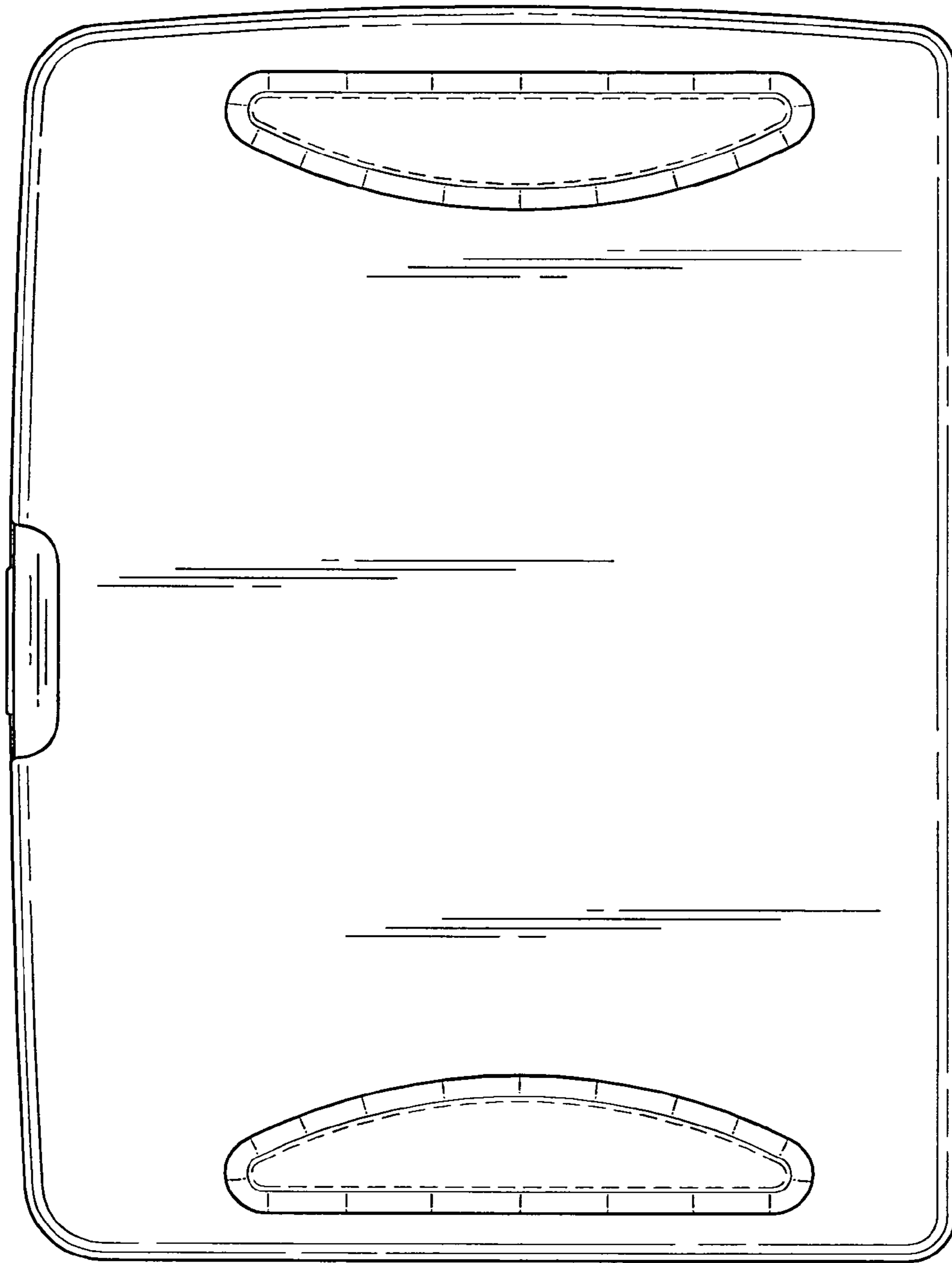

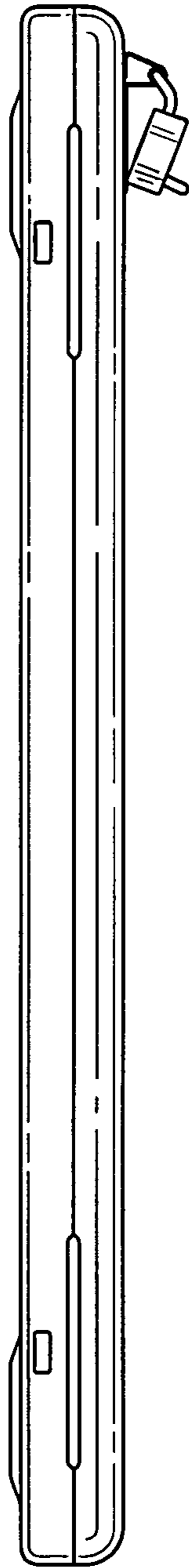

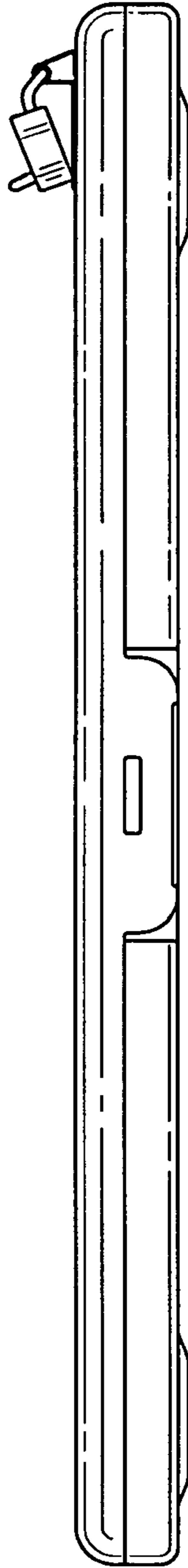

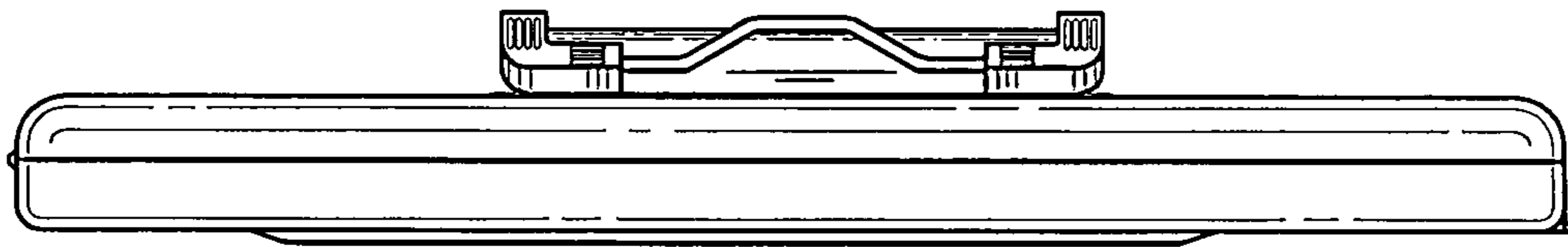

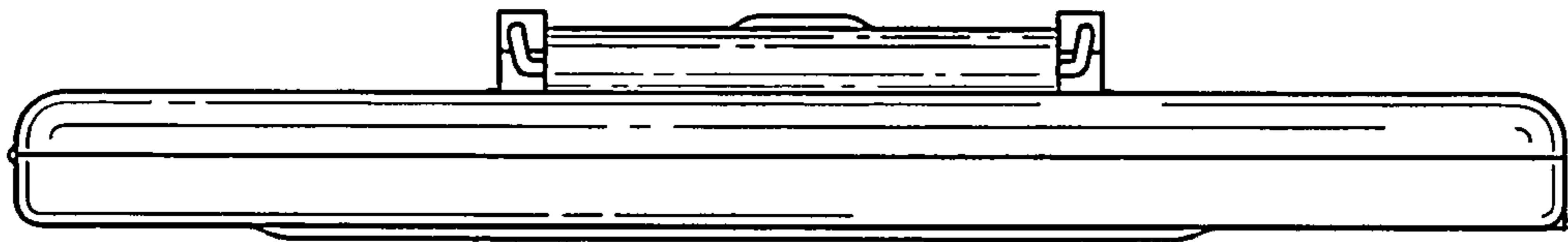

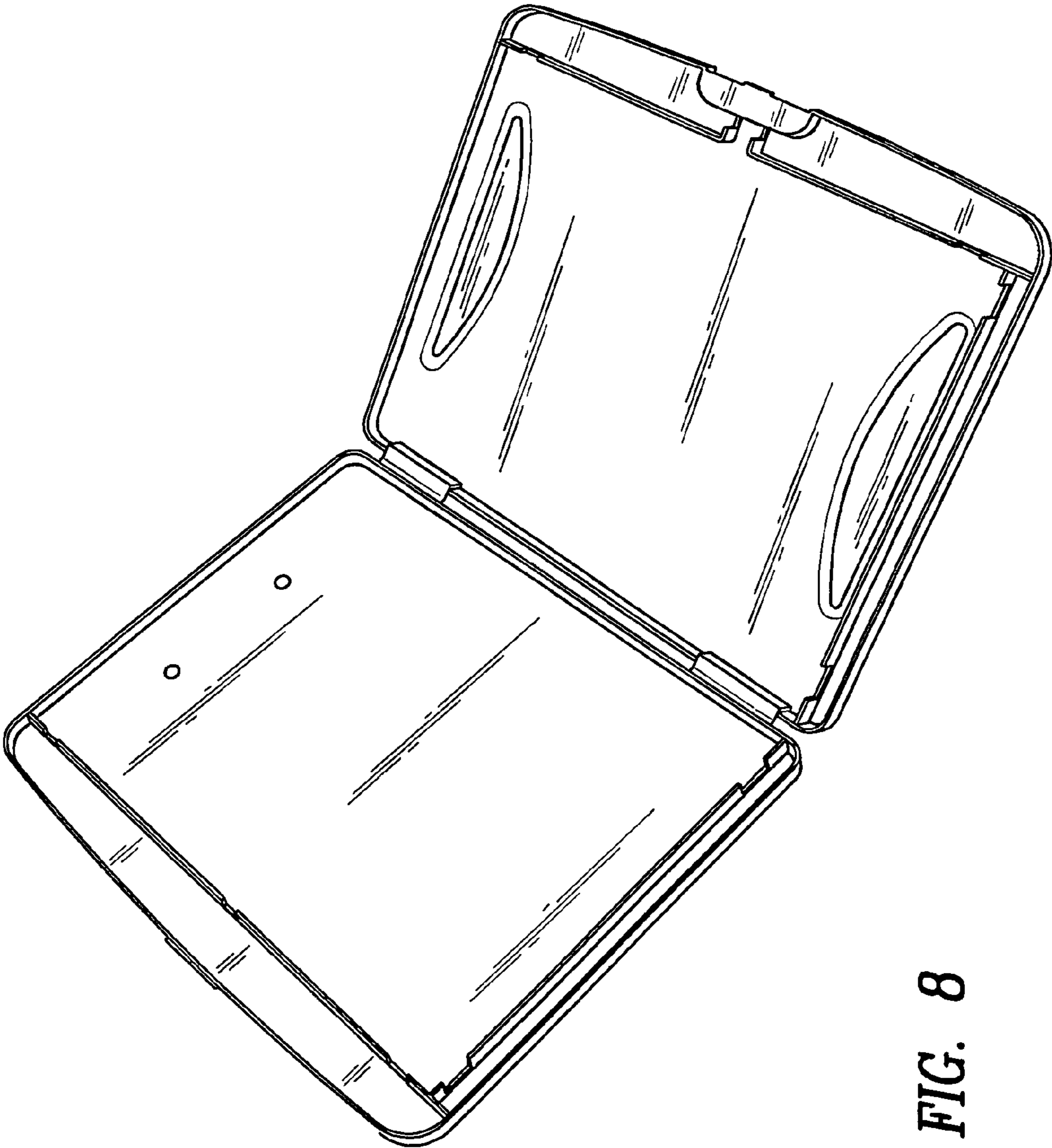
