(57) **CLAIM**

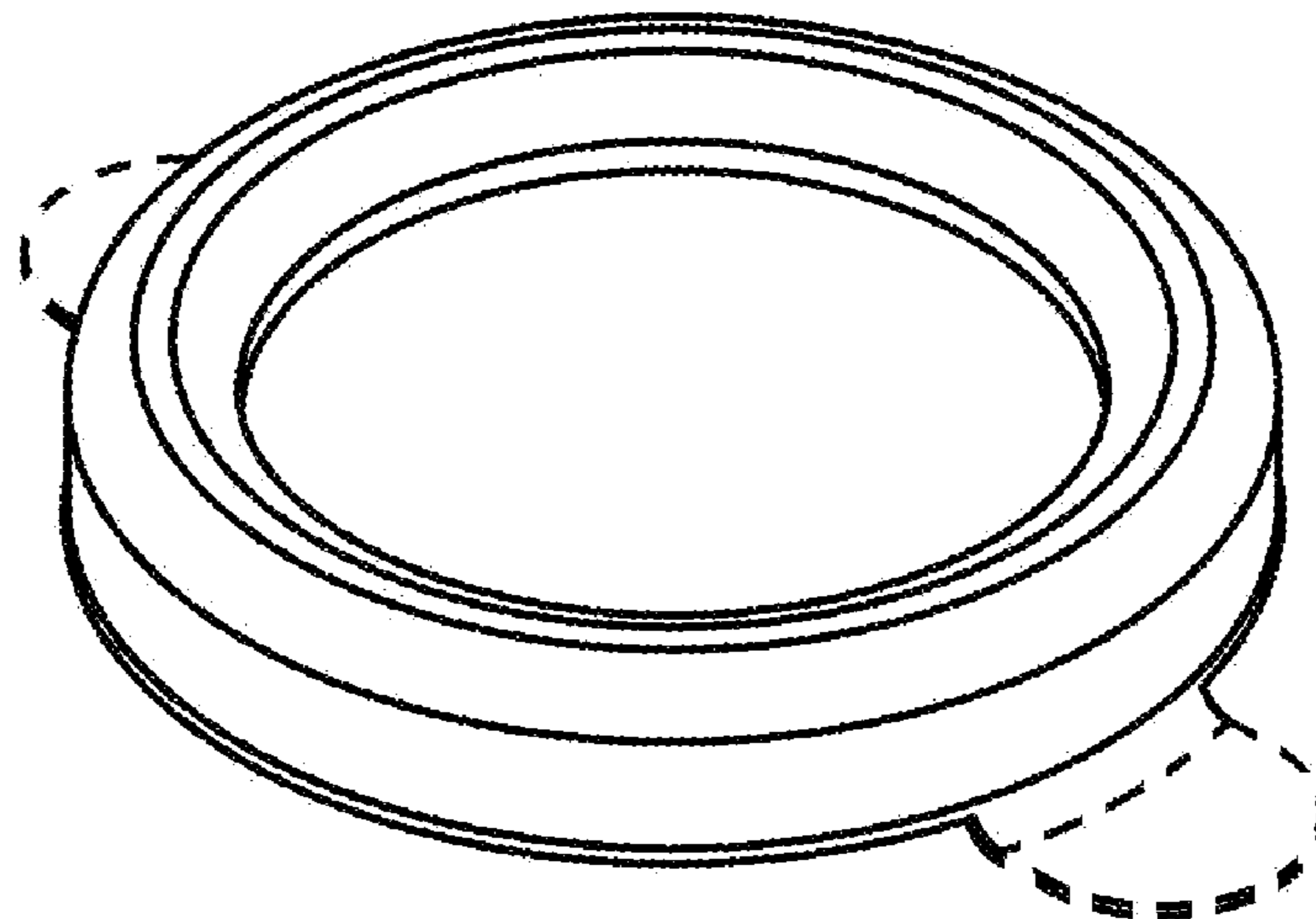
The ornamental design for a secondary seal closure component for reconditioned drums, as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of a secondary seal closure component showing our new design;
FIG. 2 is a bottom, perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a left side view thereof (to which the right side view corresponds);
FIG. 6 is a front view thereof (to which the rear view corresponds); and,
FIG. 7 is a cross-section thereof along the plane of lines 7-7 in FIG. 3.

The broken line showing is included for the purpose of illustrating portions of the article and forms no part of the claimed design.

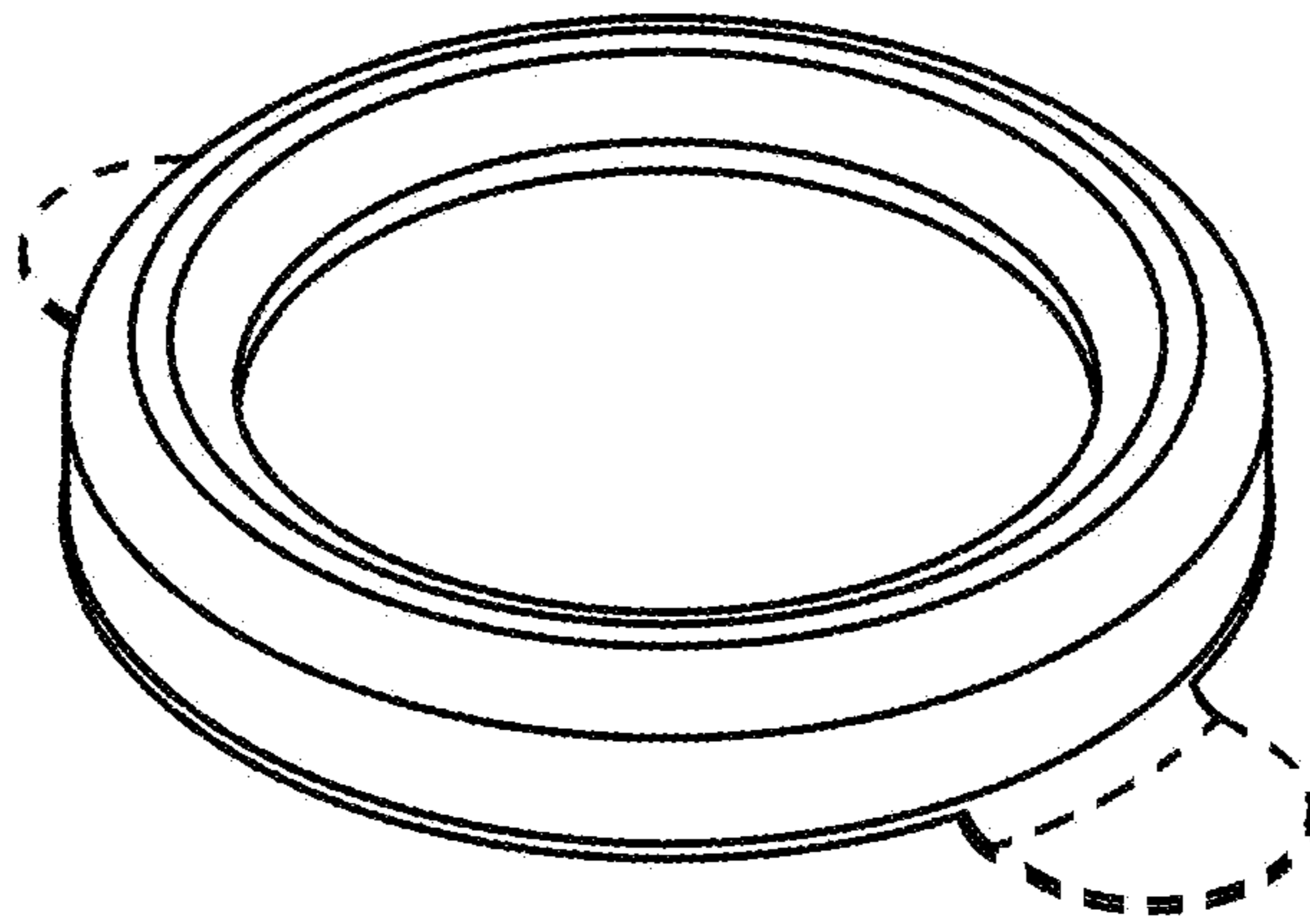

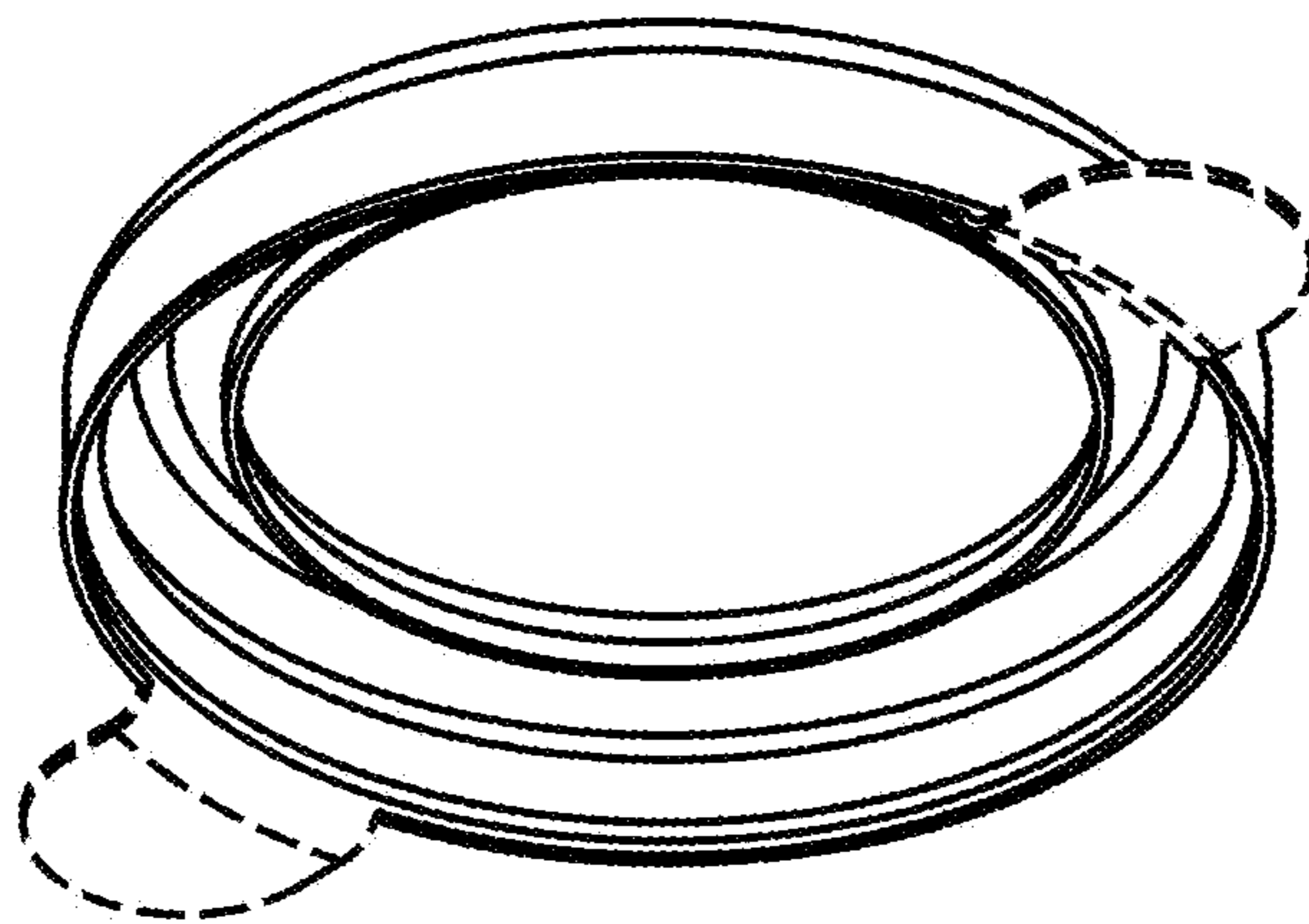

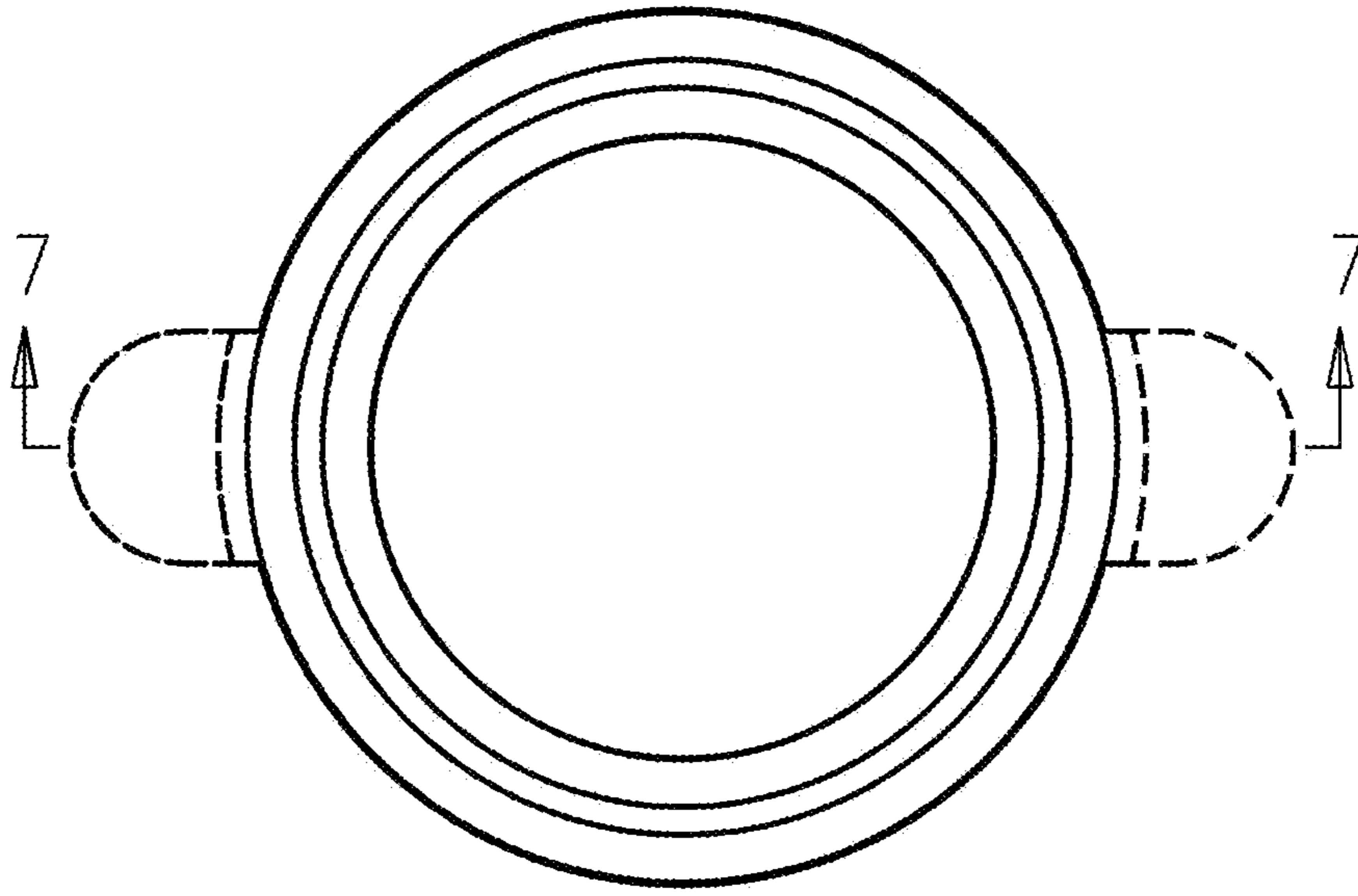

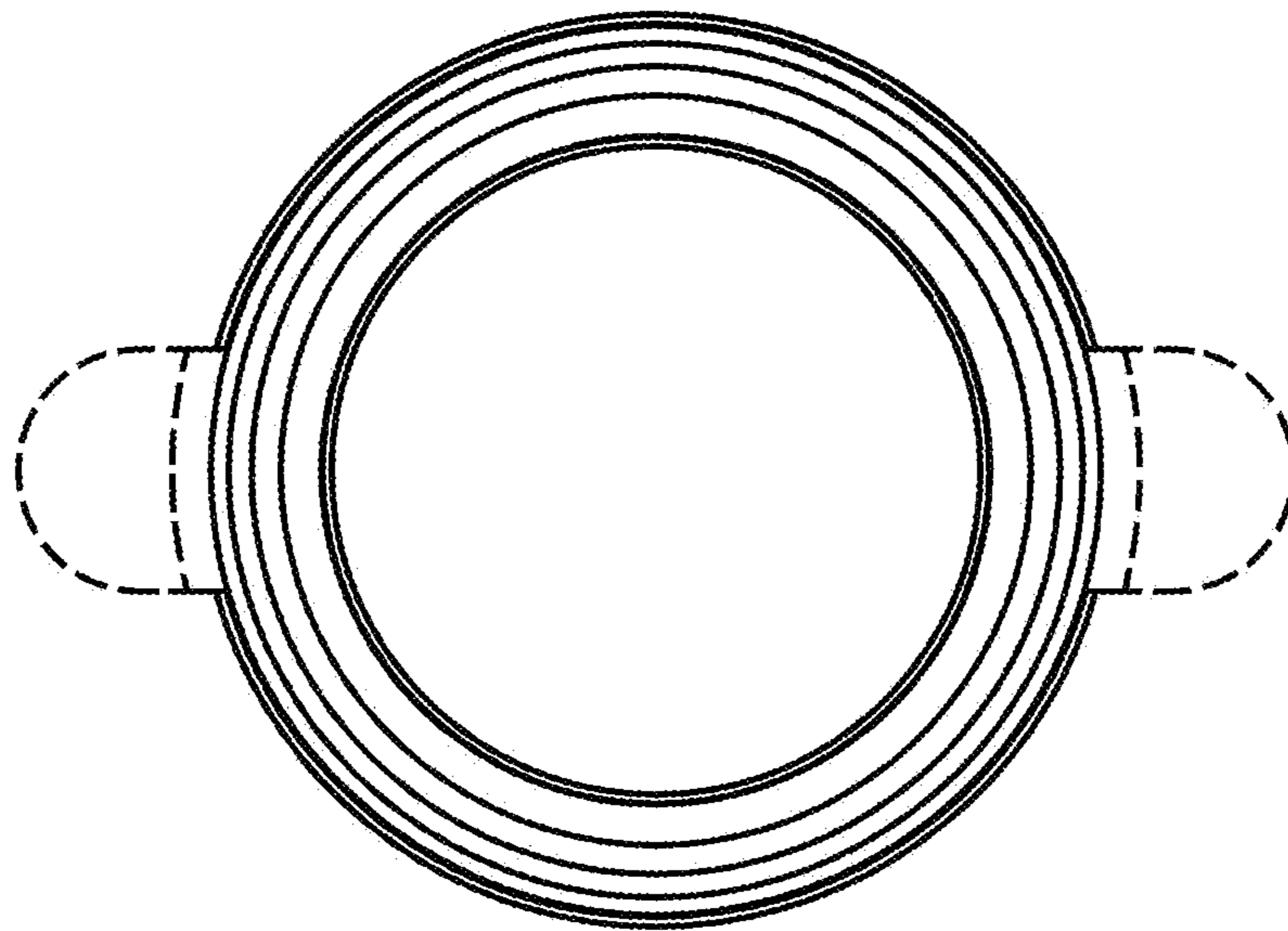

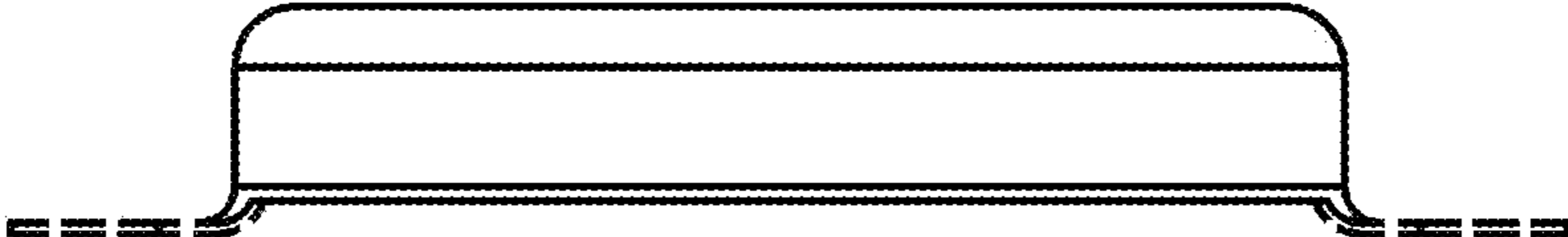
