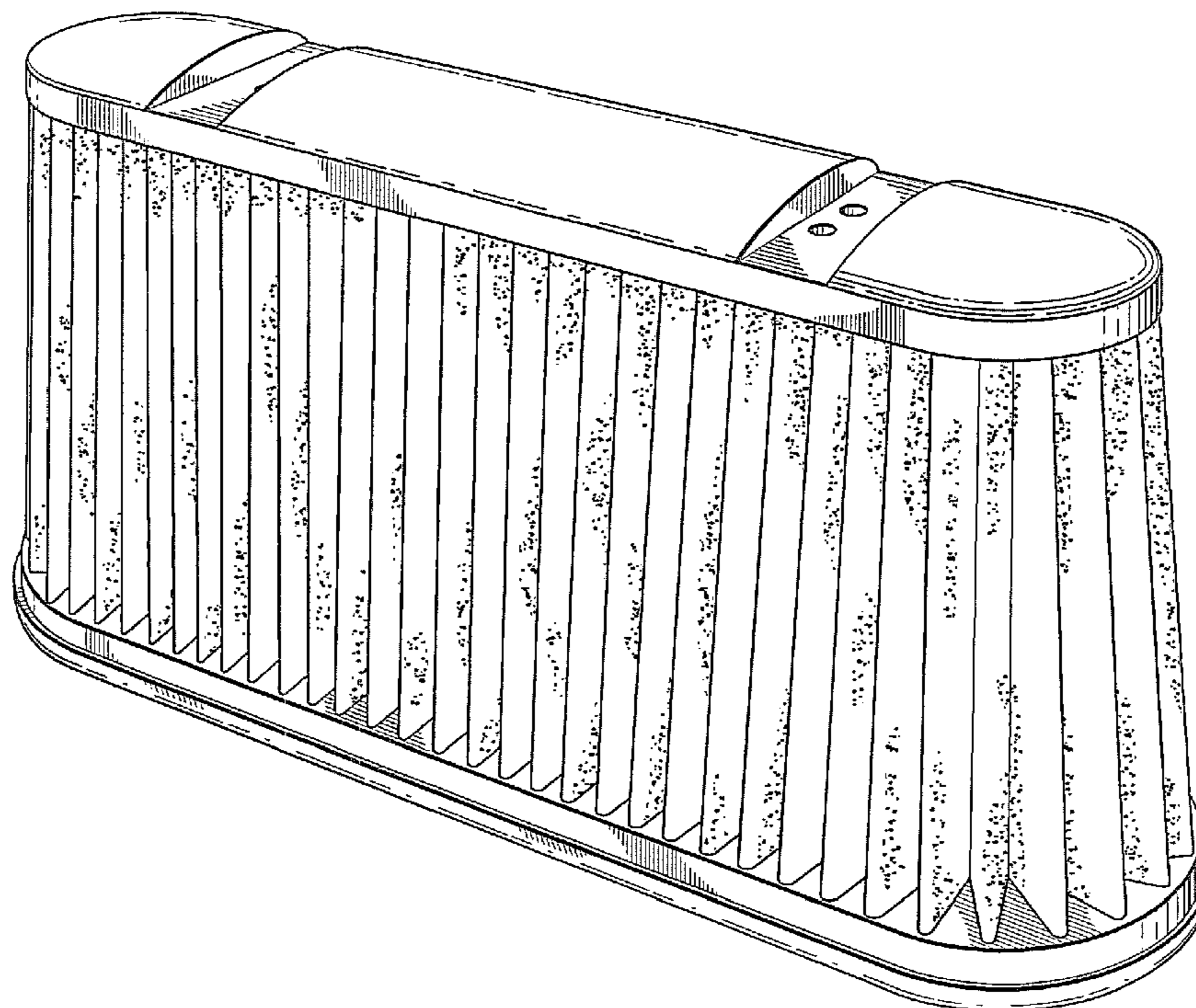
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view in an exemplary embodiment of the present invention;  
FIG. 2 is a bottom, rear, left side perspective view thereof;  
FIG. 3 is a front elevation view thereof, the rear elevation being mirror image;  
FIG. 4 is a top plan view thereof;

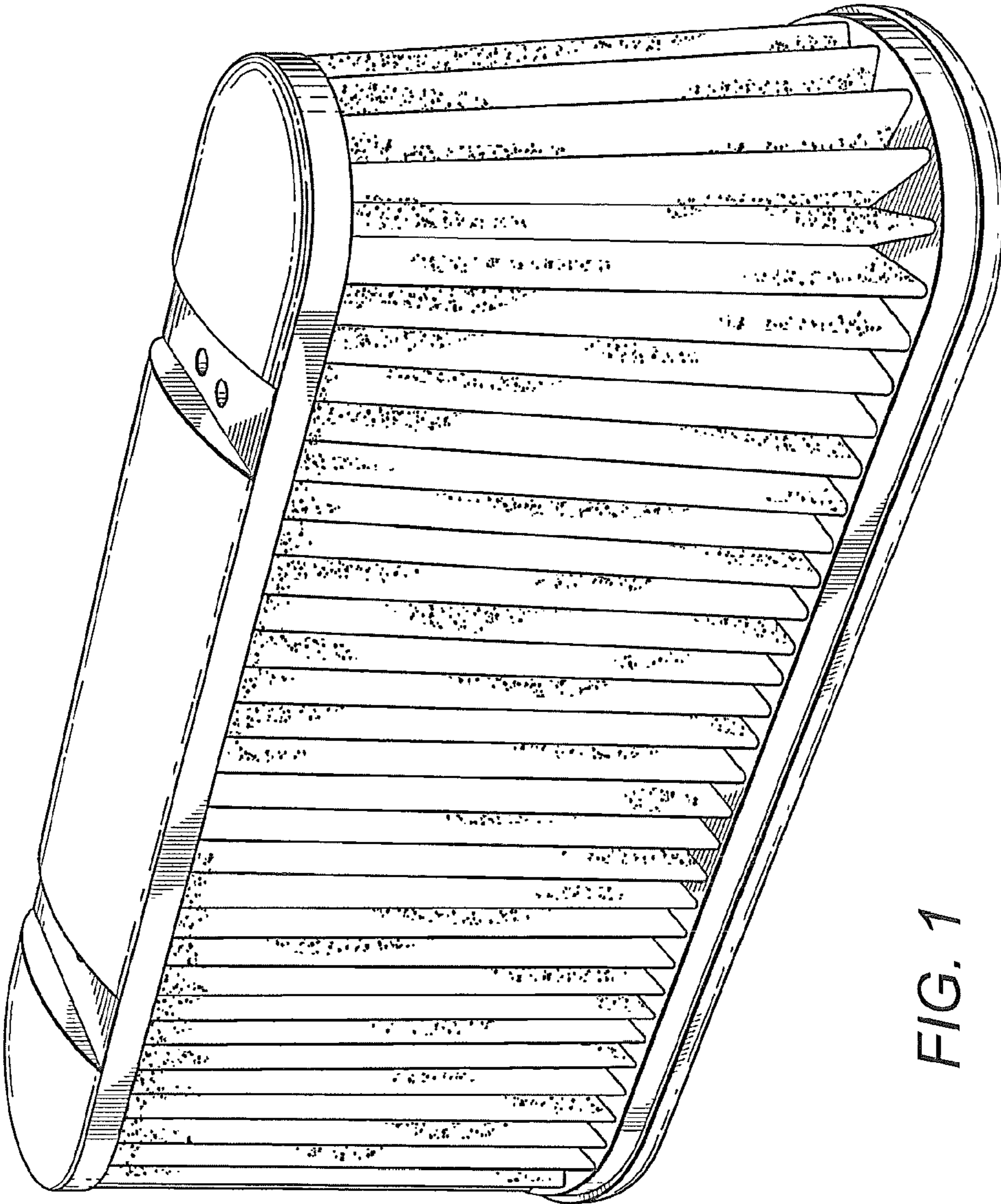

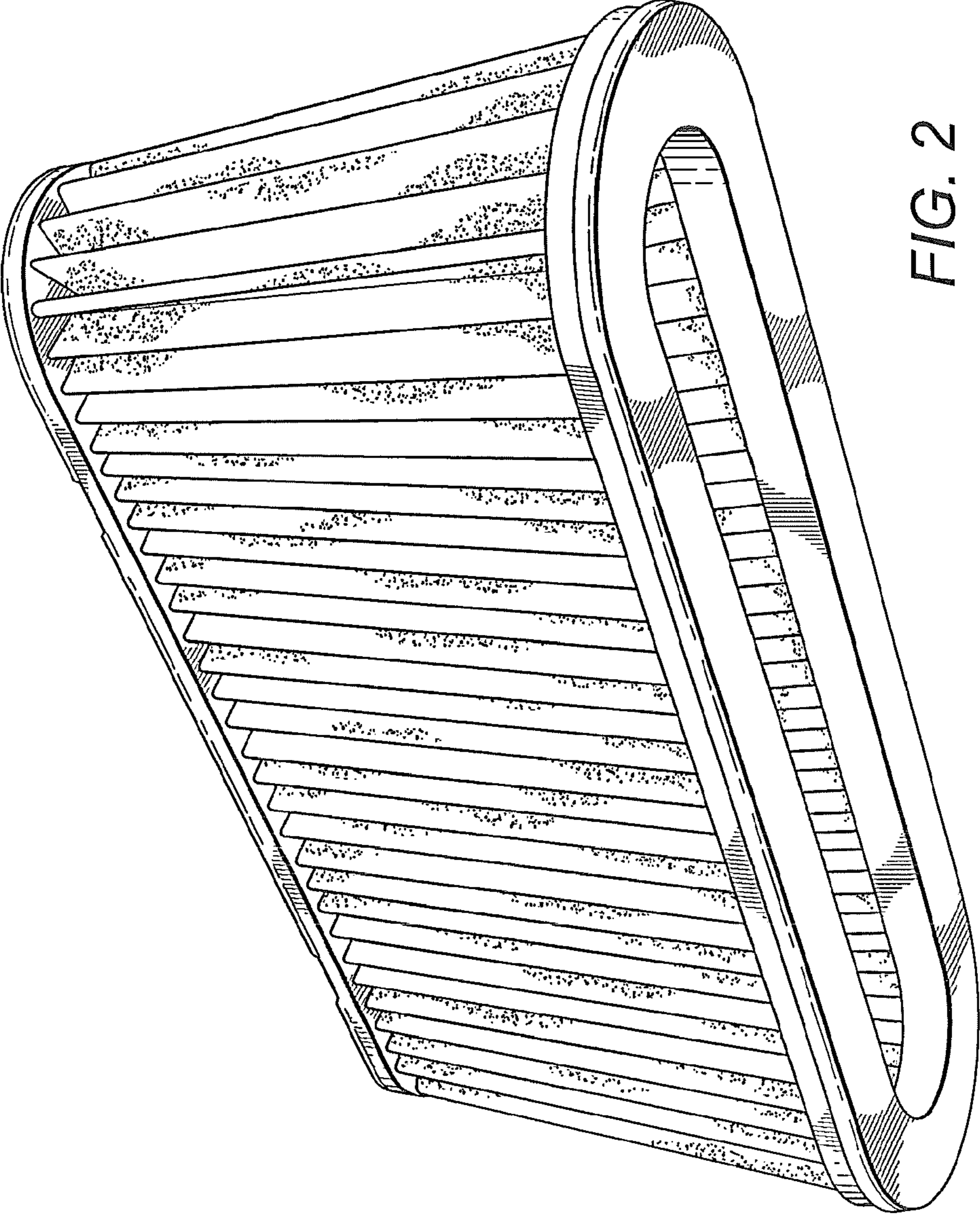

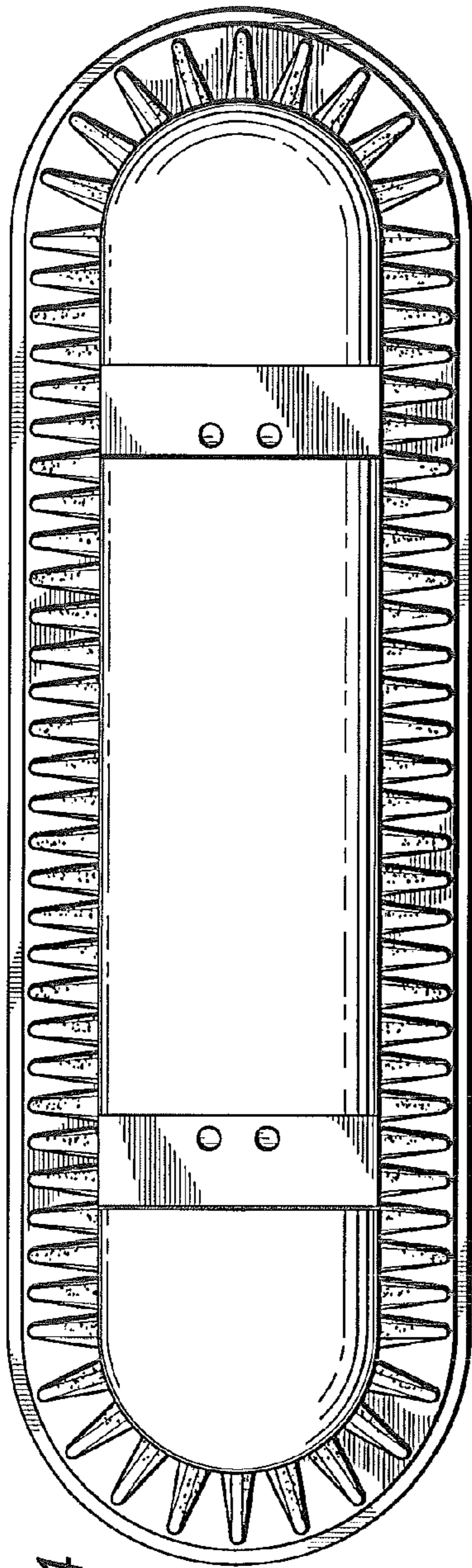

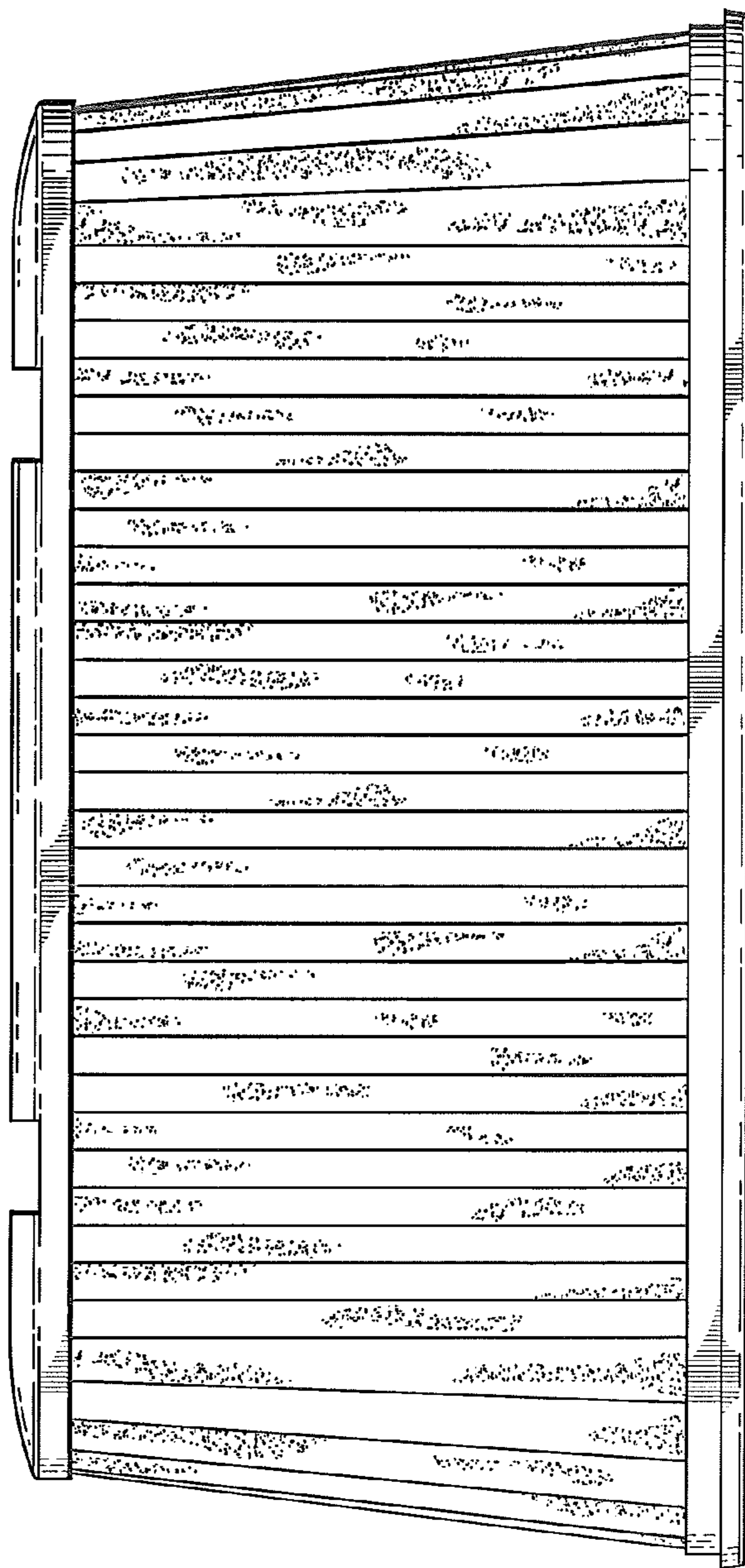

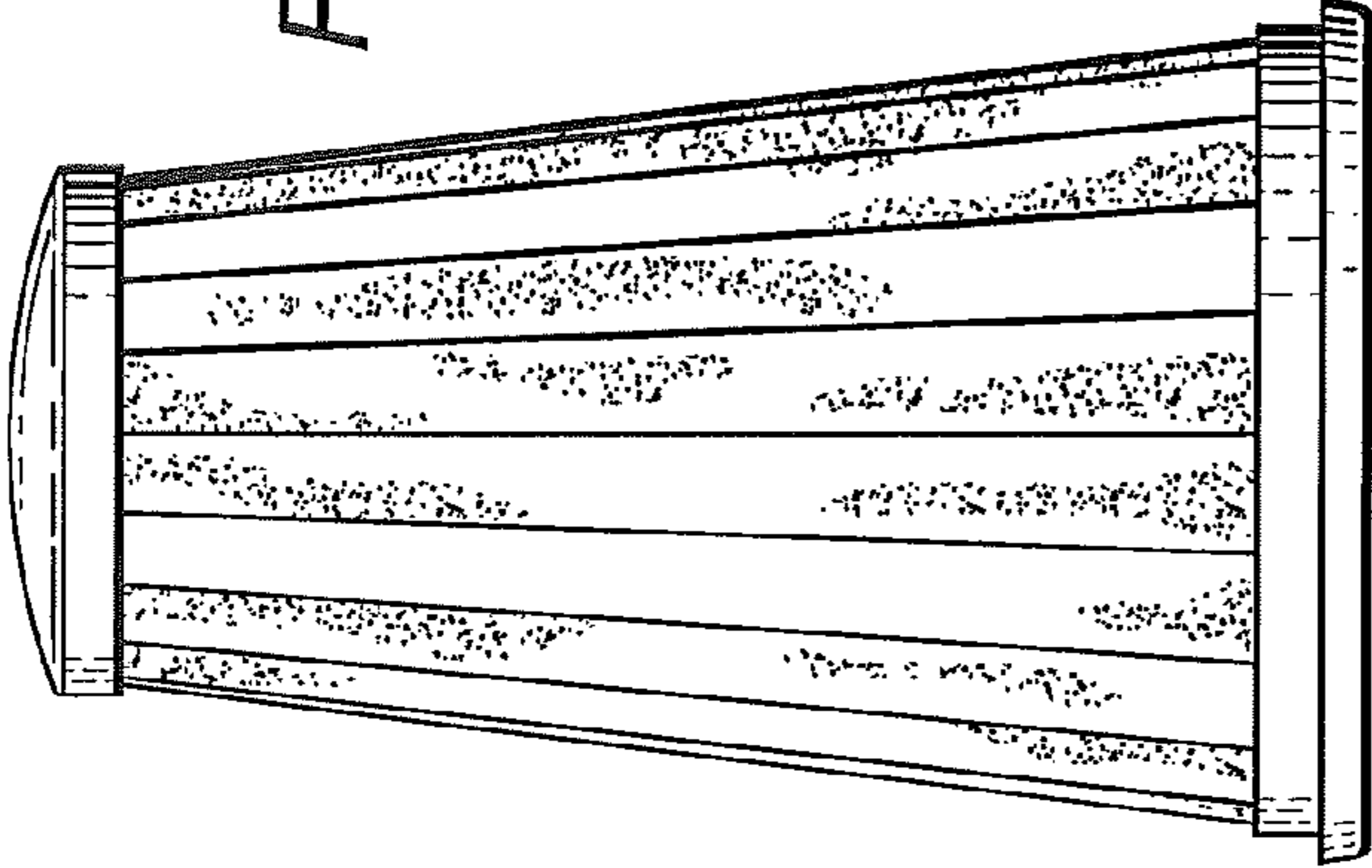

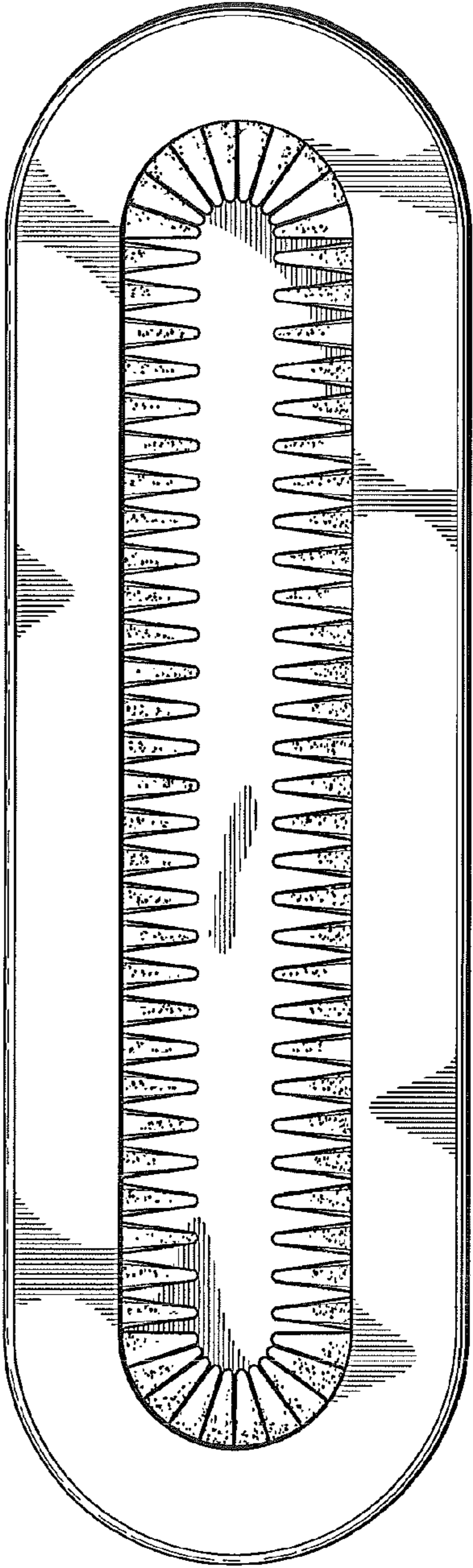
